The ornamental design for an e-hookah mouthpiece, as shown and described.

**DESCRIPTION**

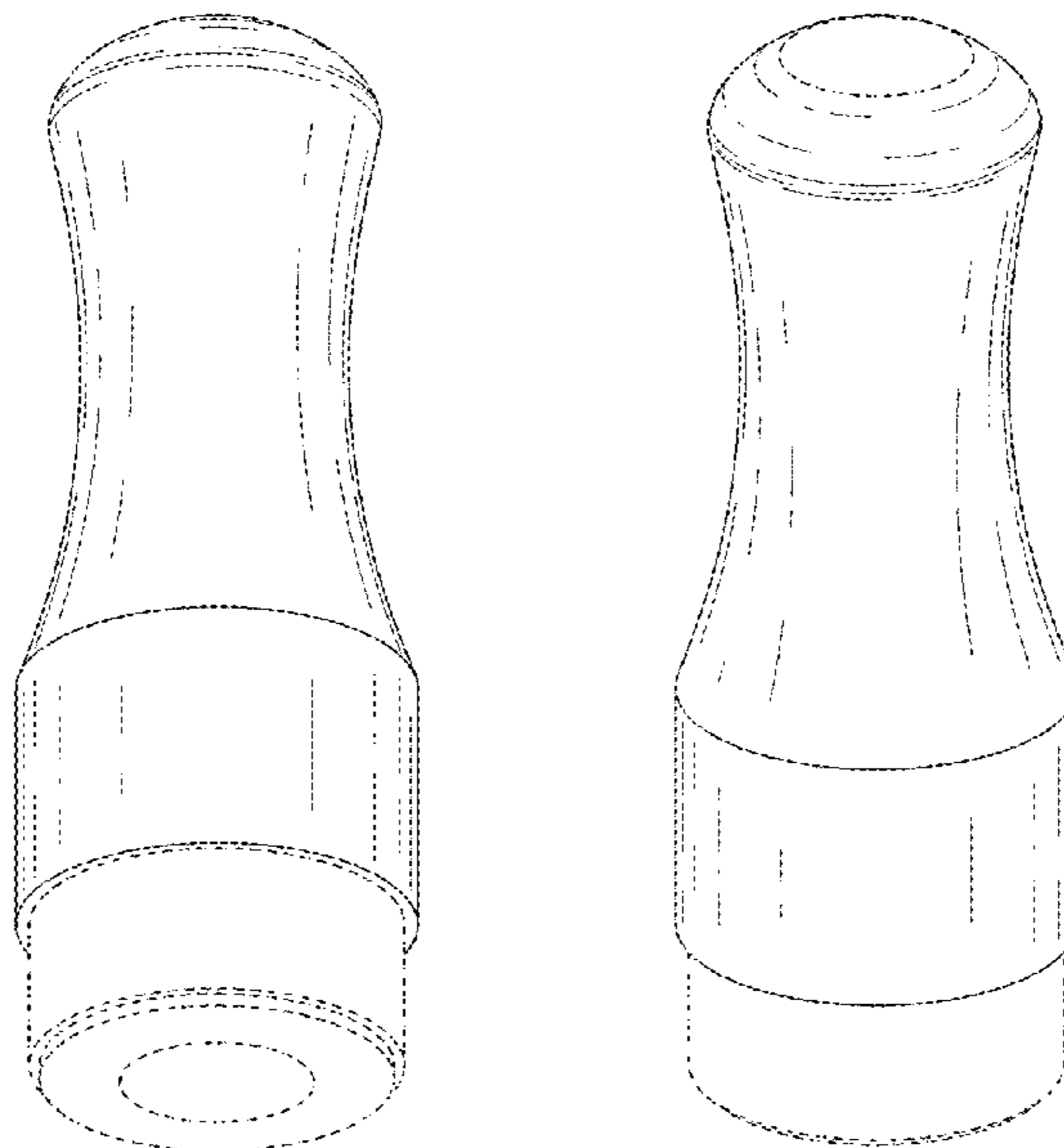
FIG. 1 is a bottom perspective view of an e-hookah mouthpiece showing the new design; FIG. 2 is a top perspective view thereof; FIG. 3 is a front view thereof; FIG. 4 is a back view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a left side view thereof; FIG. 7 is a top view thereof; FIG. 8 is a bottom view thereof; and, FIG. 9 is a top perspective view thereof, showing it attached to a stick portion of an e-hookah.

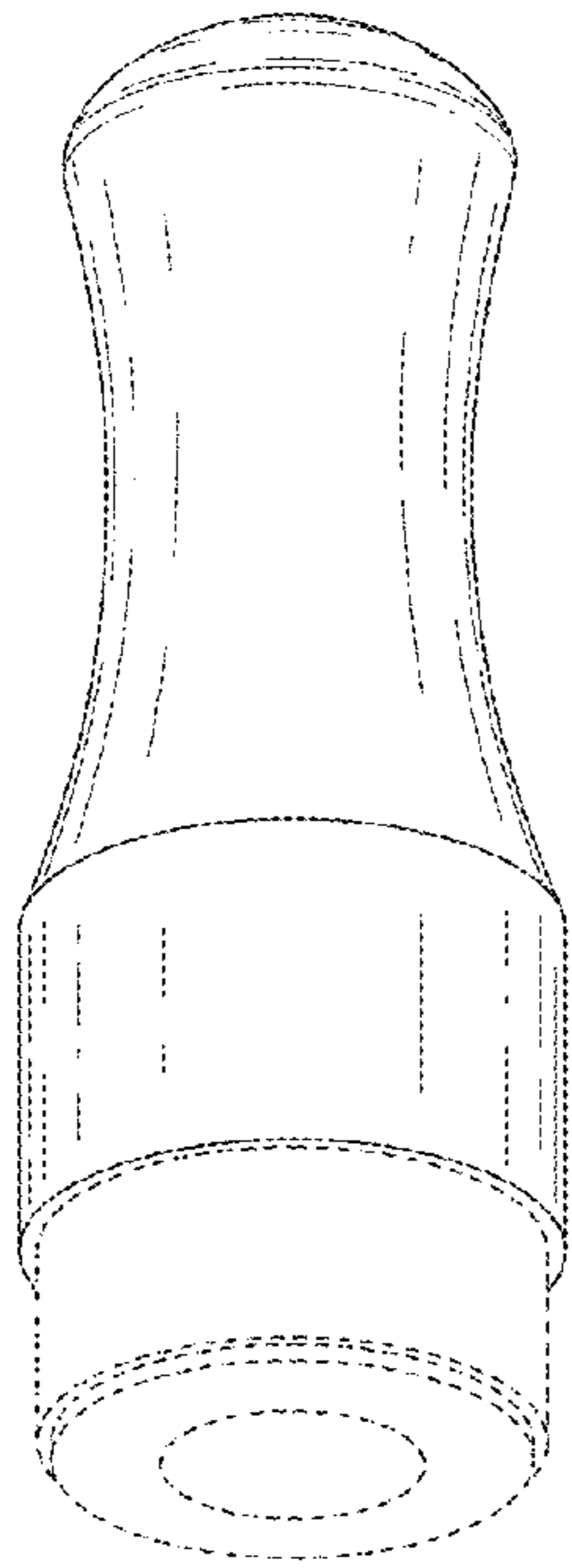
The broken lines showing a bottom portion of the e-hookah mouthpiece for insertion into a stick (FIGS. 1-6, 8) are for the purpose of illustrating portions of the e-hookah mouthpiece, and form no part of the claimed design.

The broken lines showing a hole at the top of the e-hookah mouthpiece (FIGS. 2, 7, 9) are for the purpose of illustrating portions of the e-hookah mouthpiece, and form no part of the claimed design.

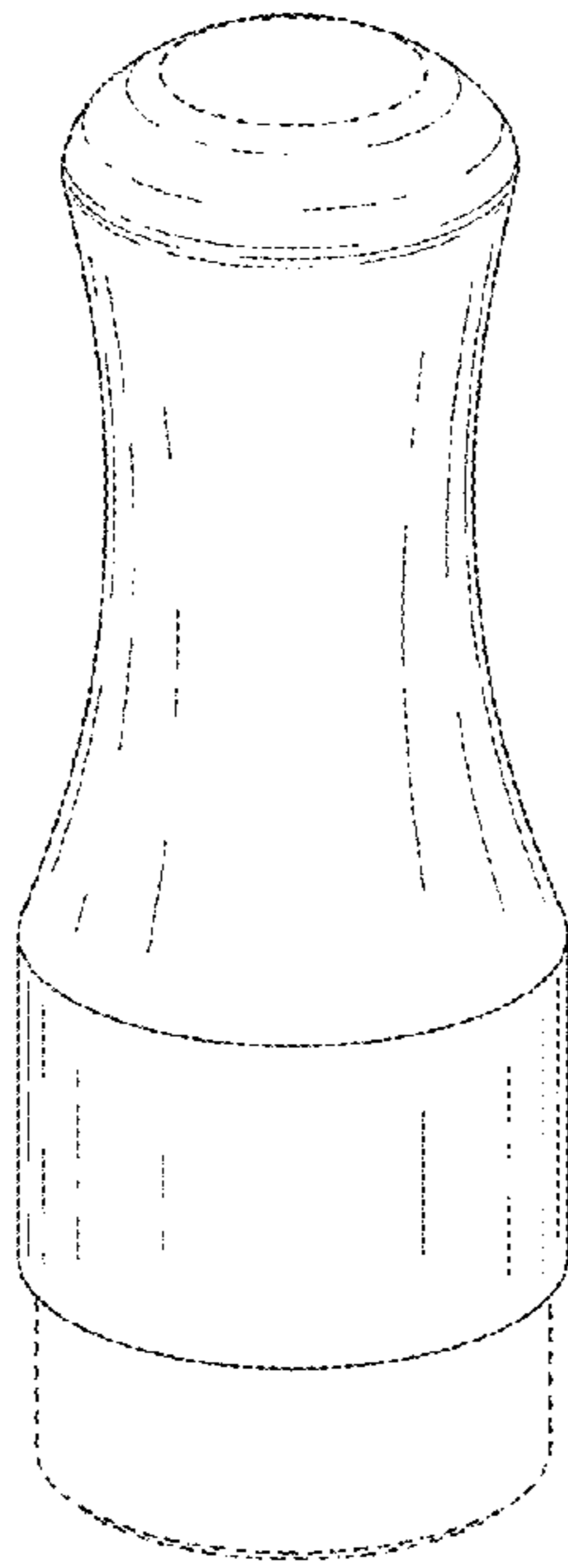
The broken lines showing an e-hookah stick in FIG. 9 are shown to help illustrate an environment in which the claimed design may be used, and form no part of the claimed design.

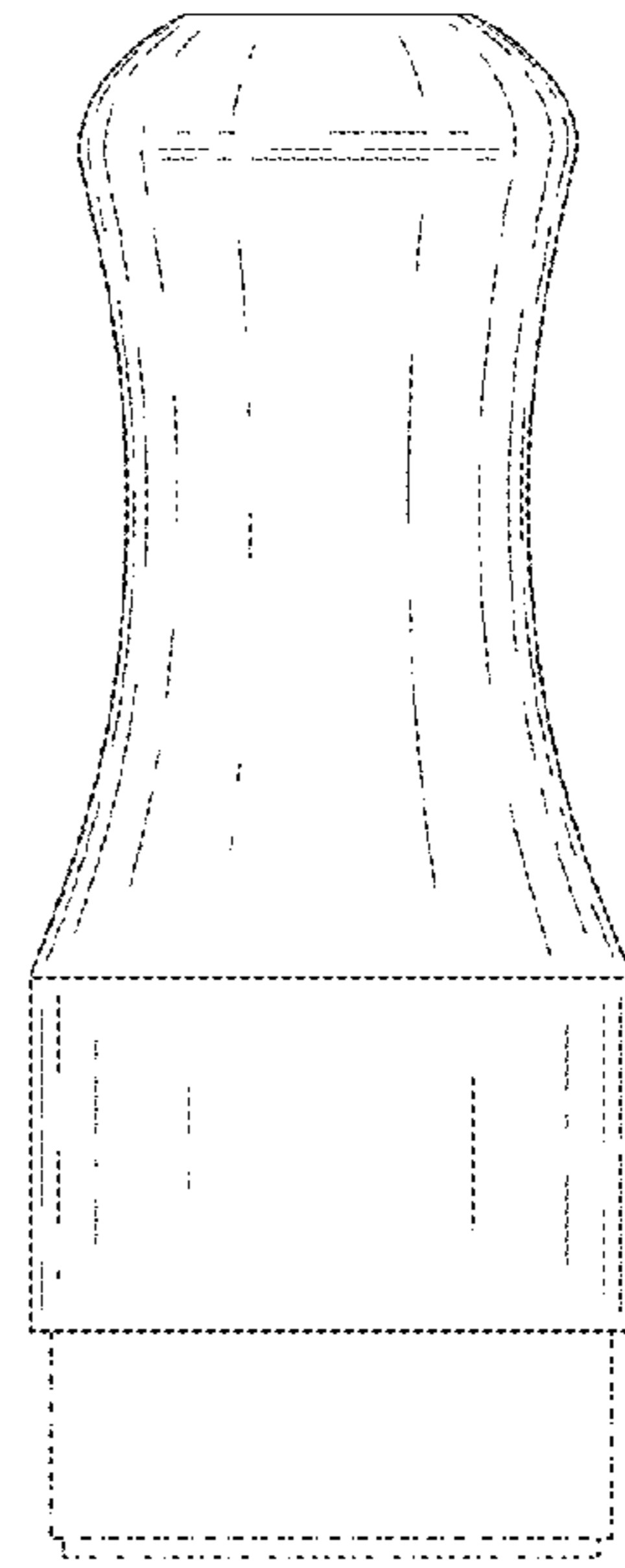




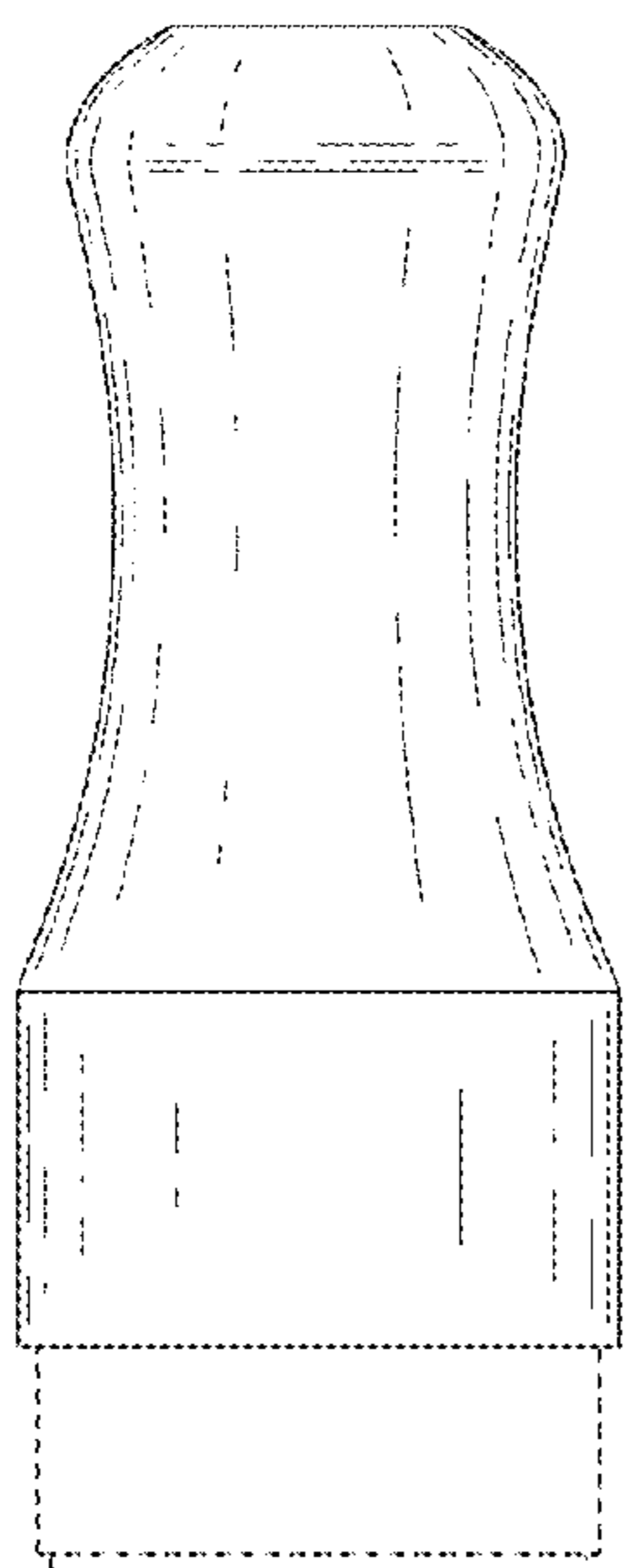

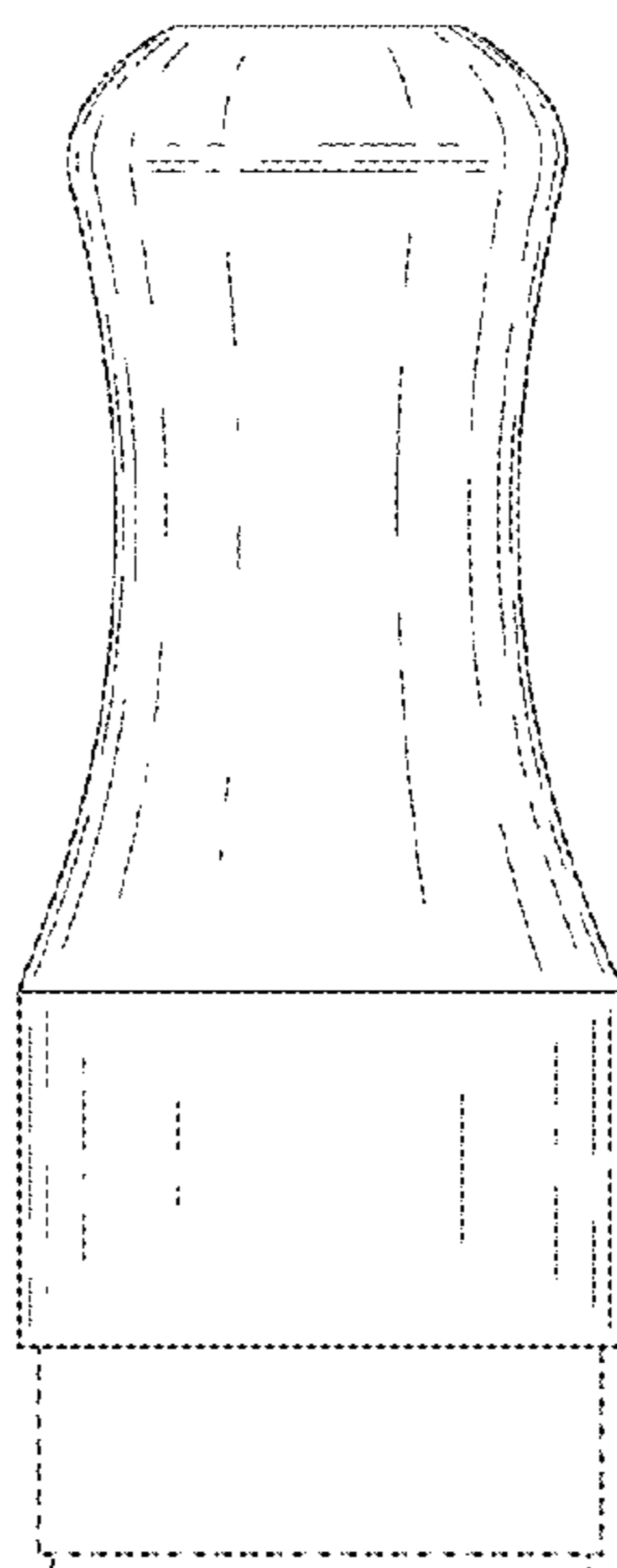

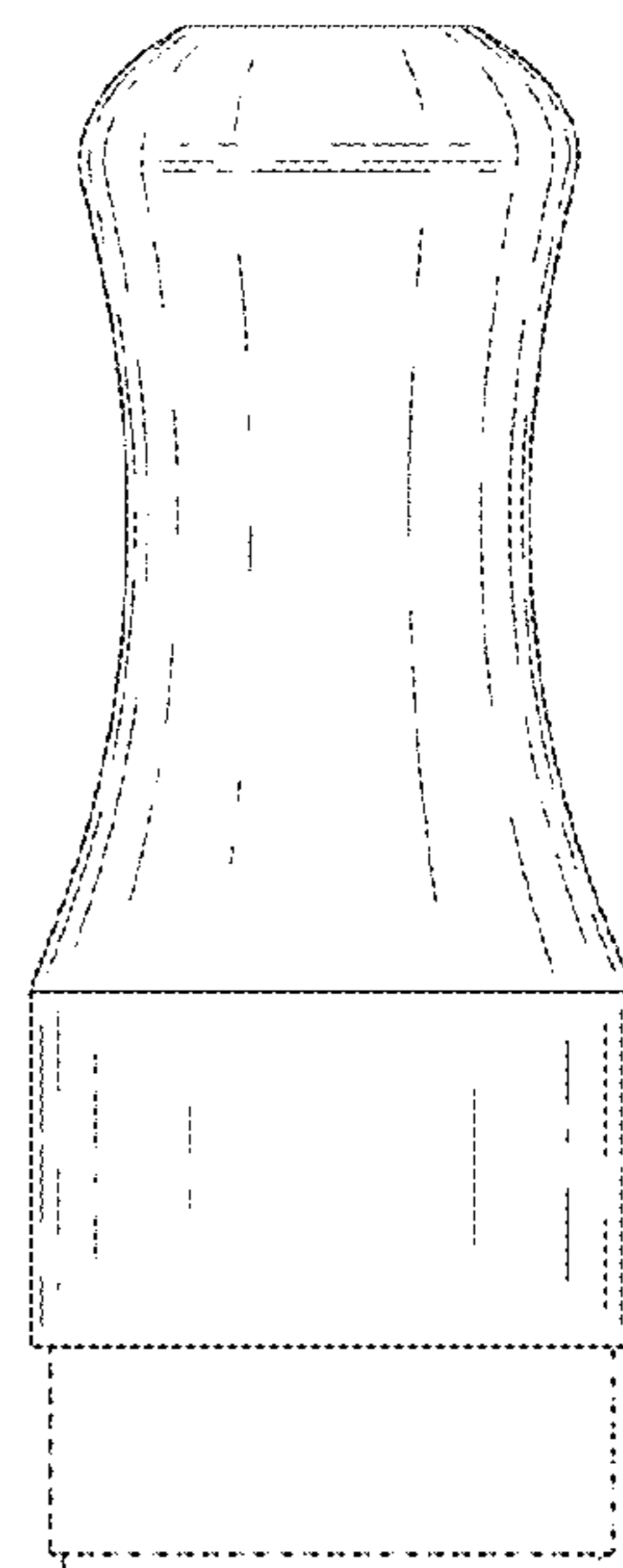

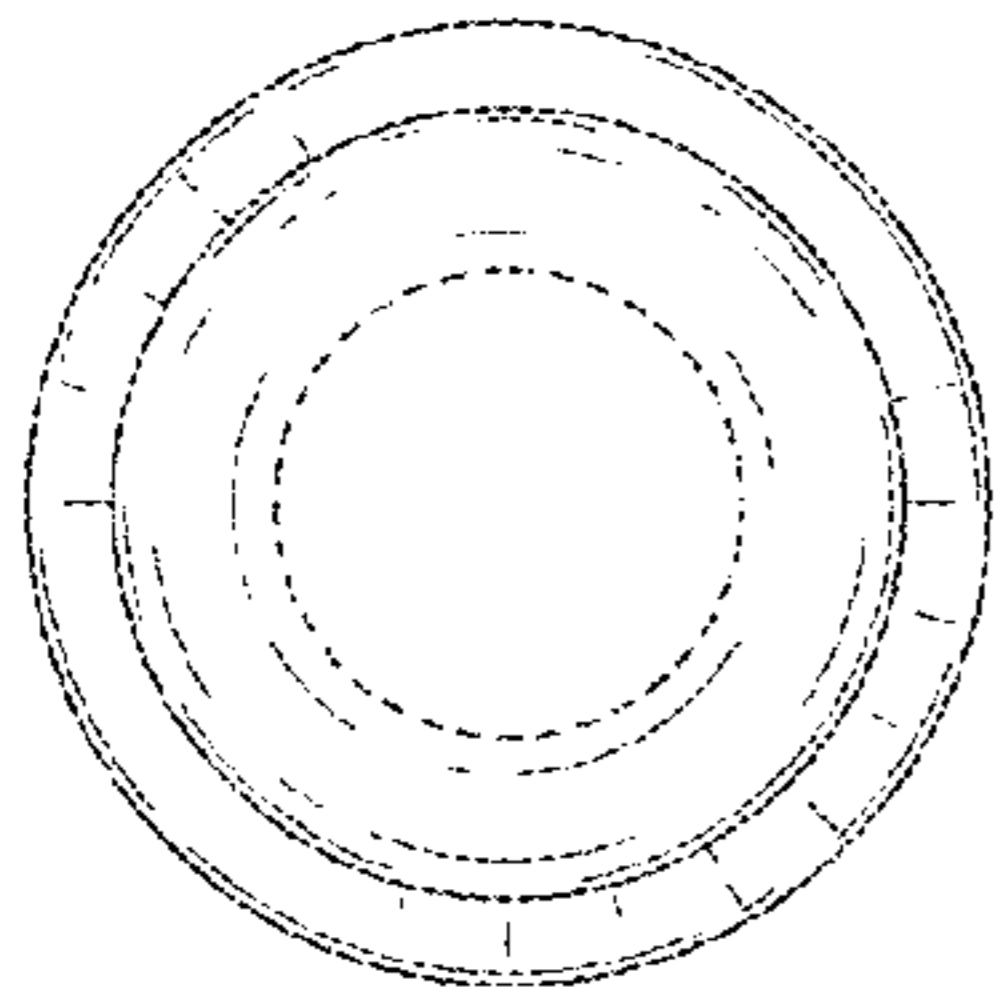

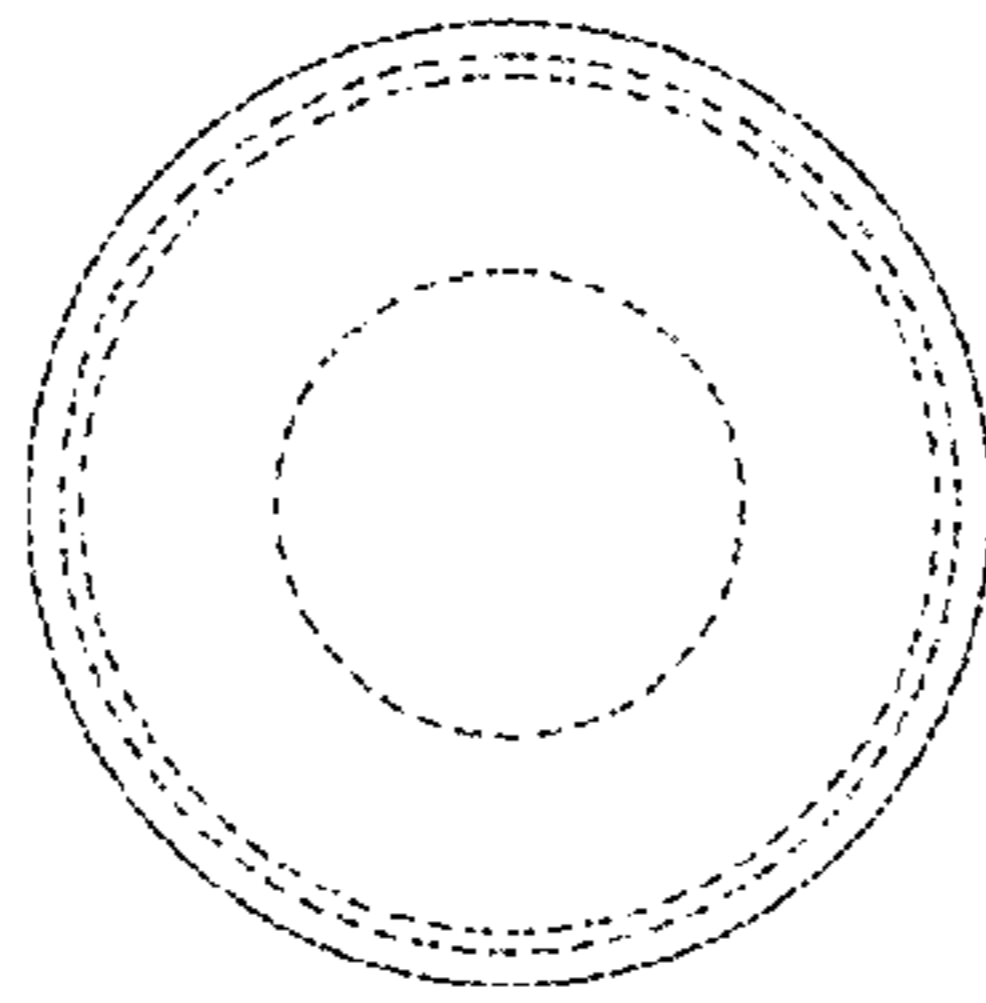

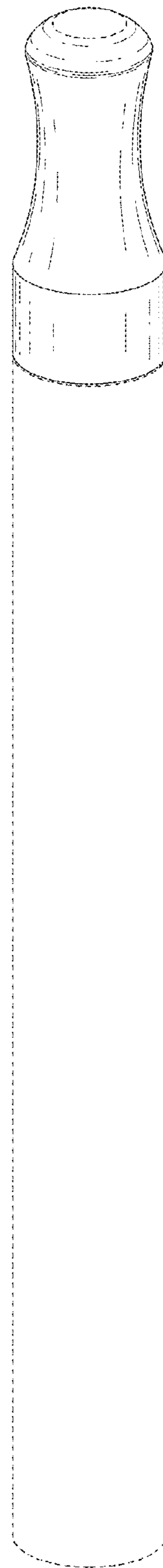
