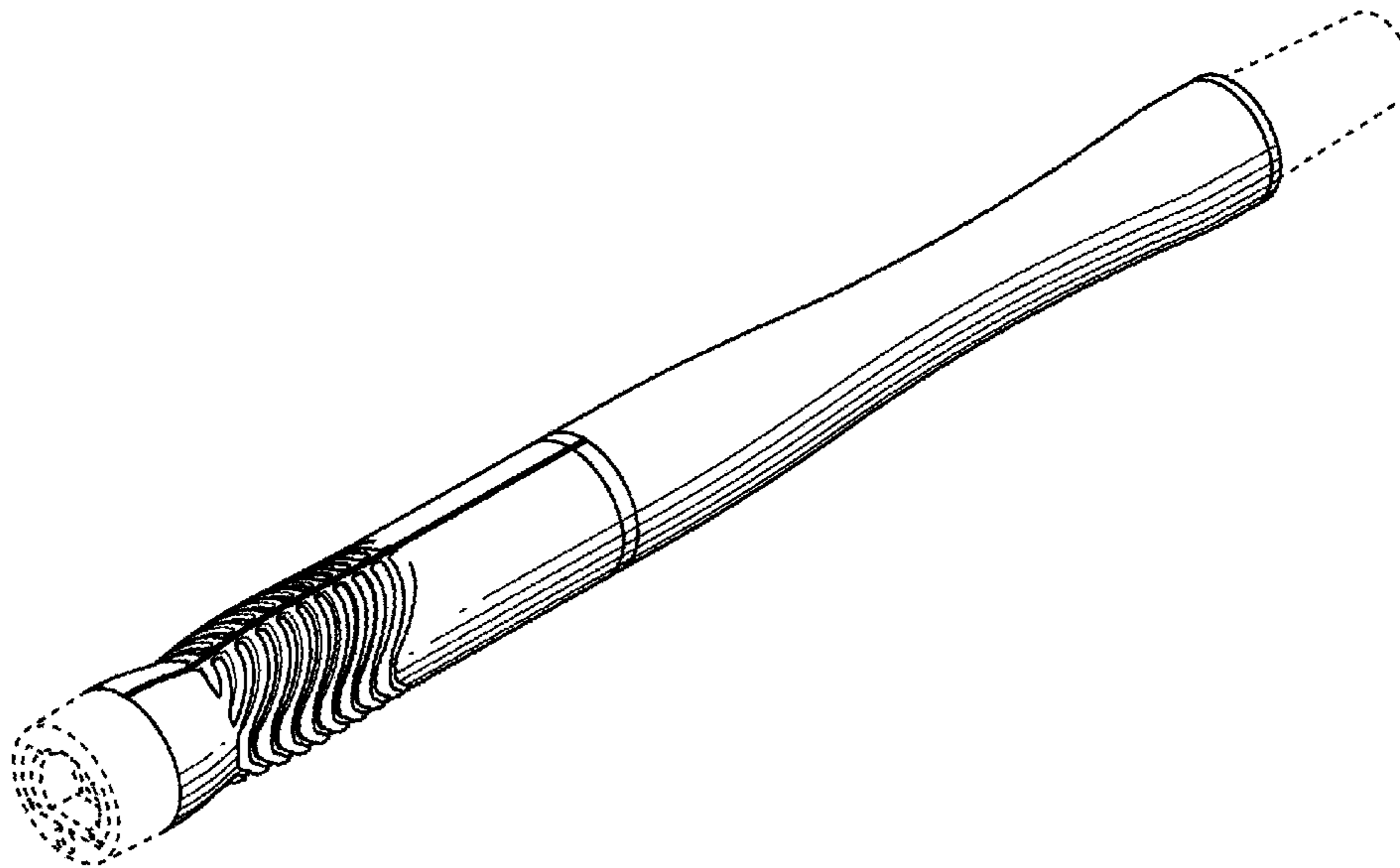
(57) **CLAIM**

The ornamental design for a grip for a soldering iron, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a grip for a soldering iron; FIG. 2 is a front view thereof, the opposite side being a mirror image of the side shown herein; FIG. 3 is a left side view thereof; FIG. 4 is a right side view thereof; and, FIG. 5 is a top view thereof, the opposite side being an identical image of the side shown herein. The broken lines depict portions of the grip for a soldering iron in which the design is embodied that are not considered part of the claimed design.

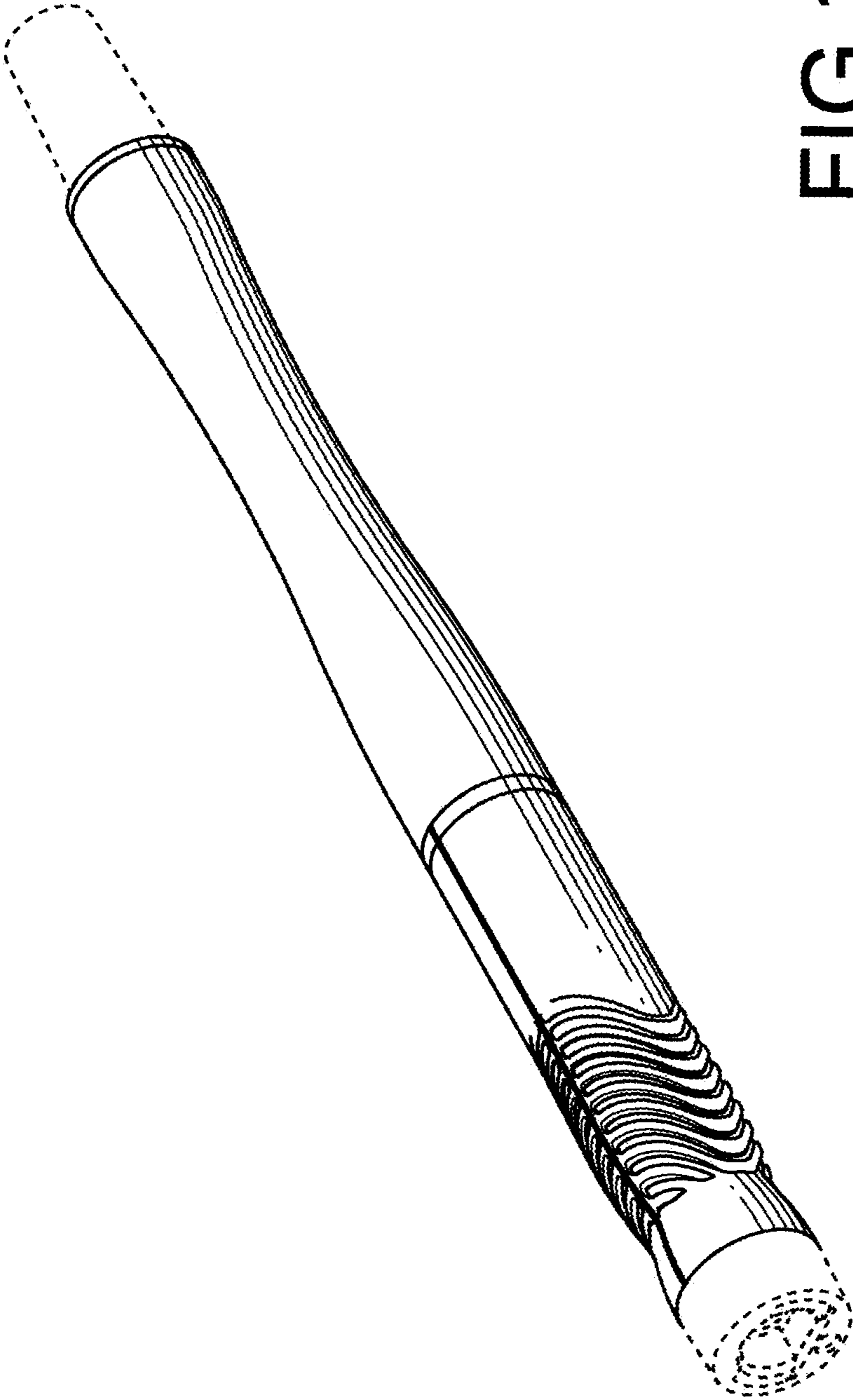

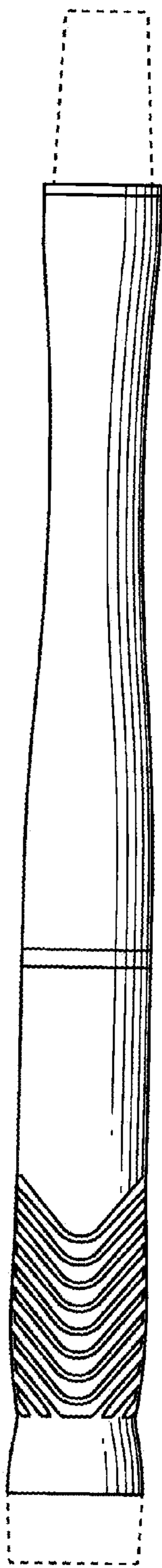

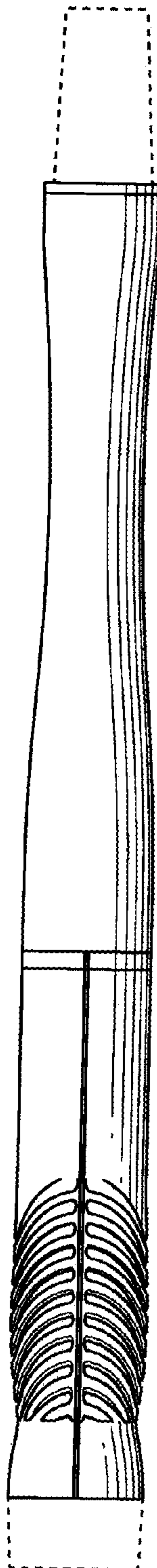
