DESCRIPTION

image thereof;

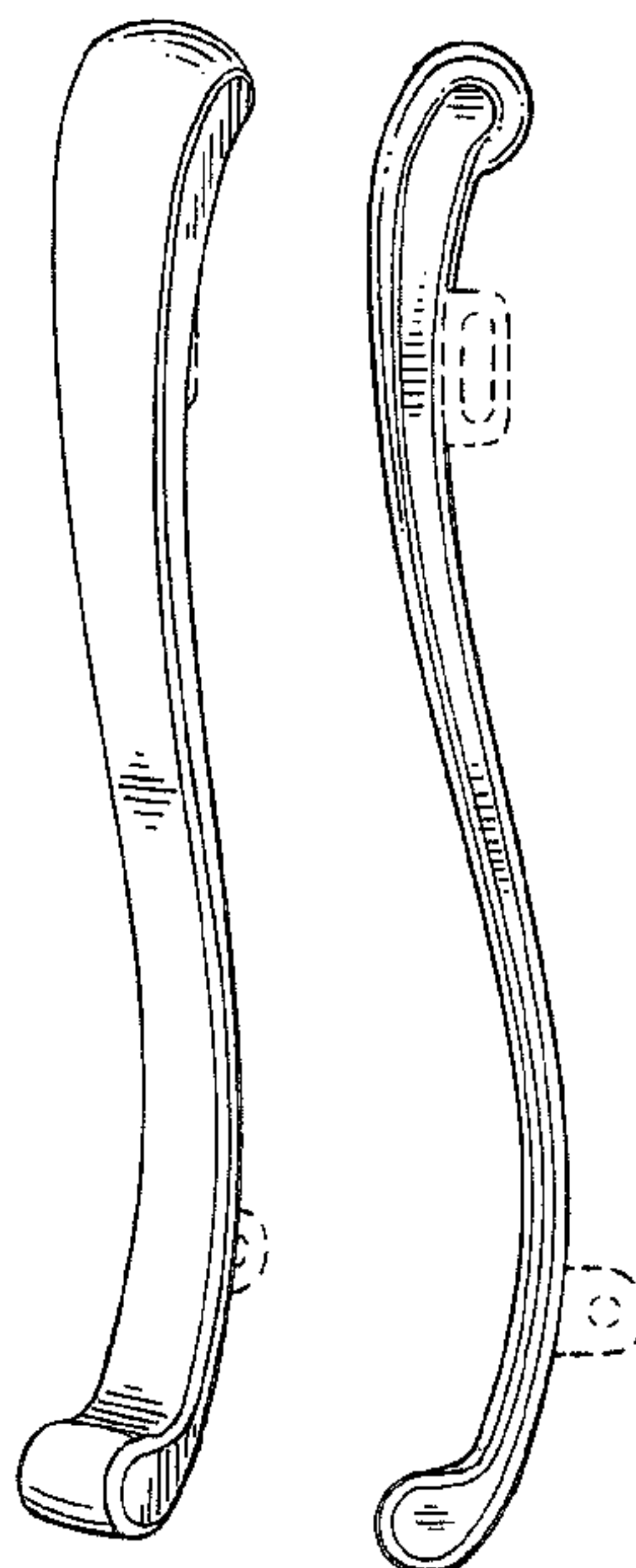
FIG. 5 is a rear elevational view of the door handle shown in

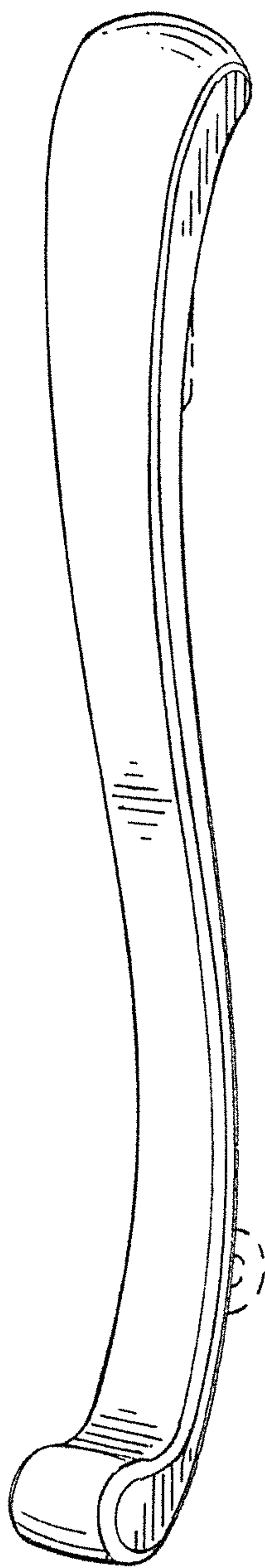

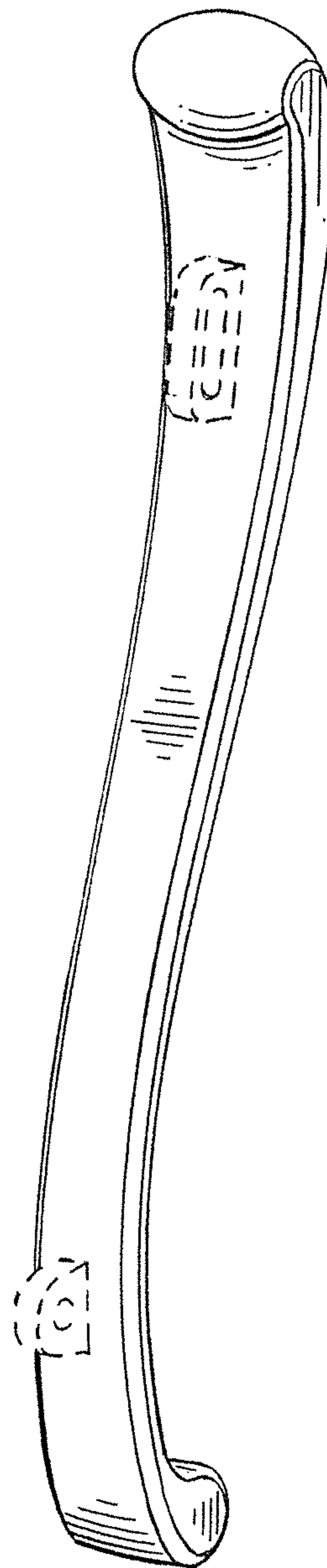

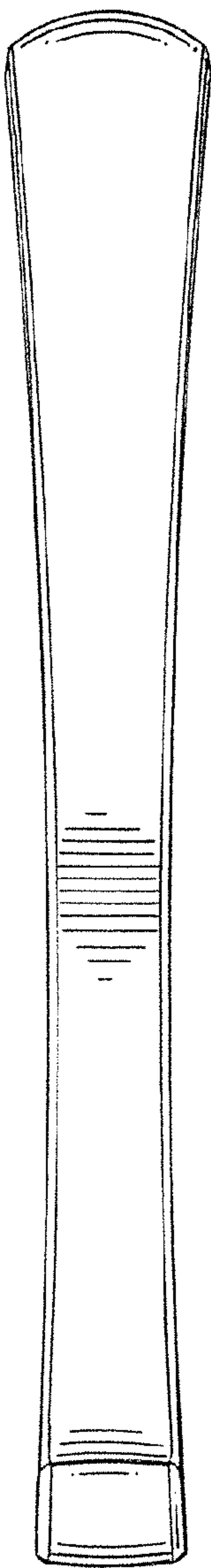

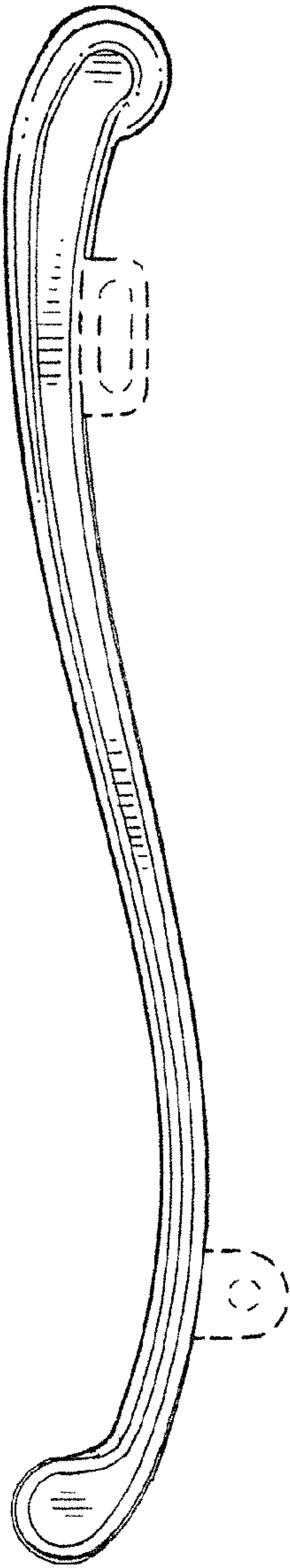

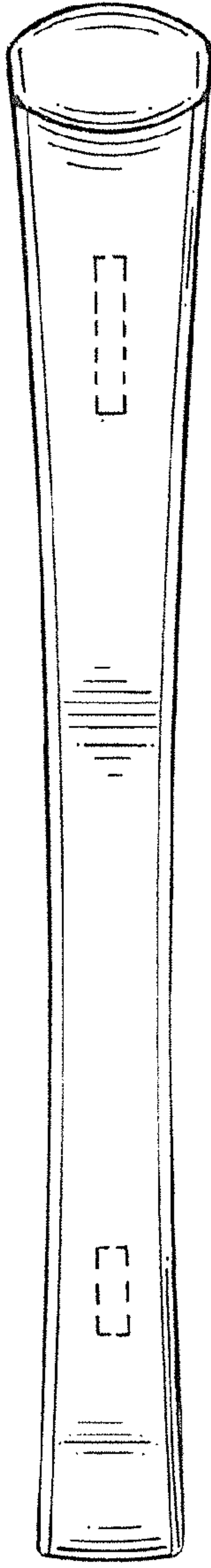

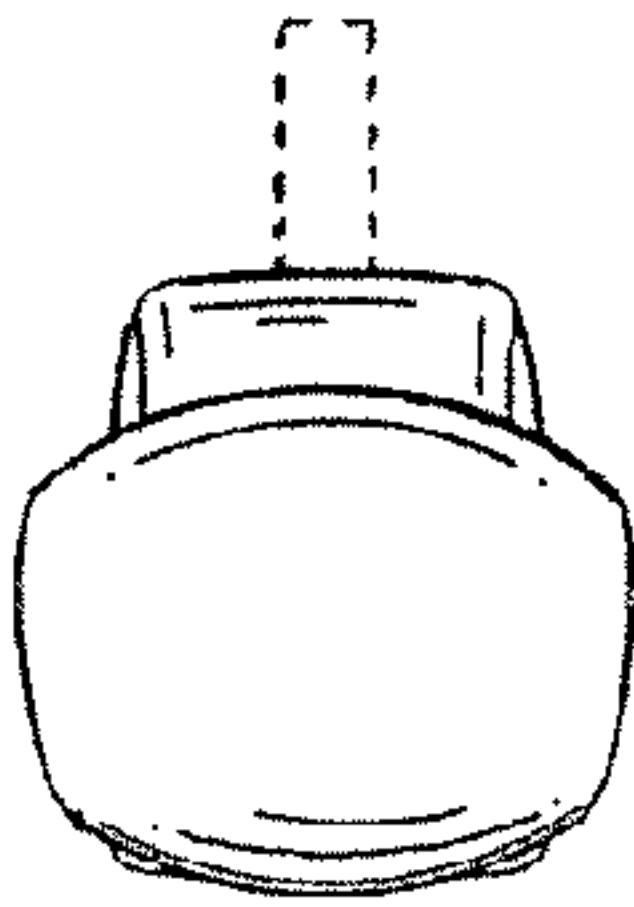

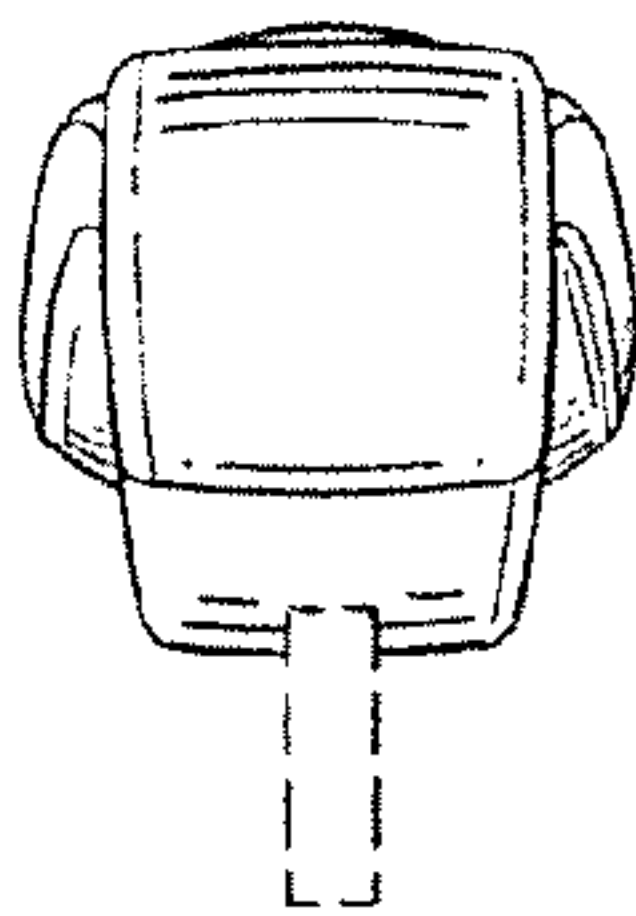
