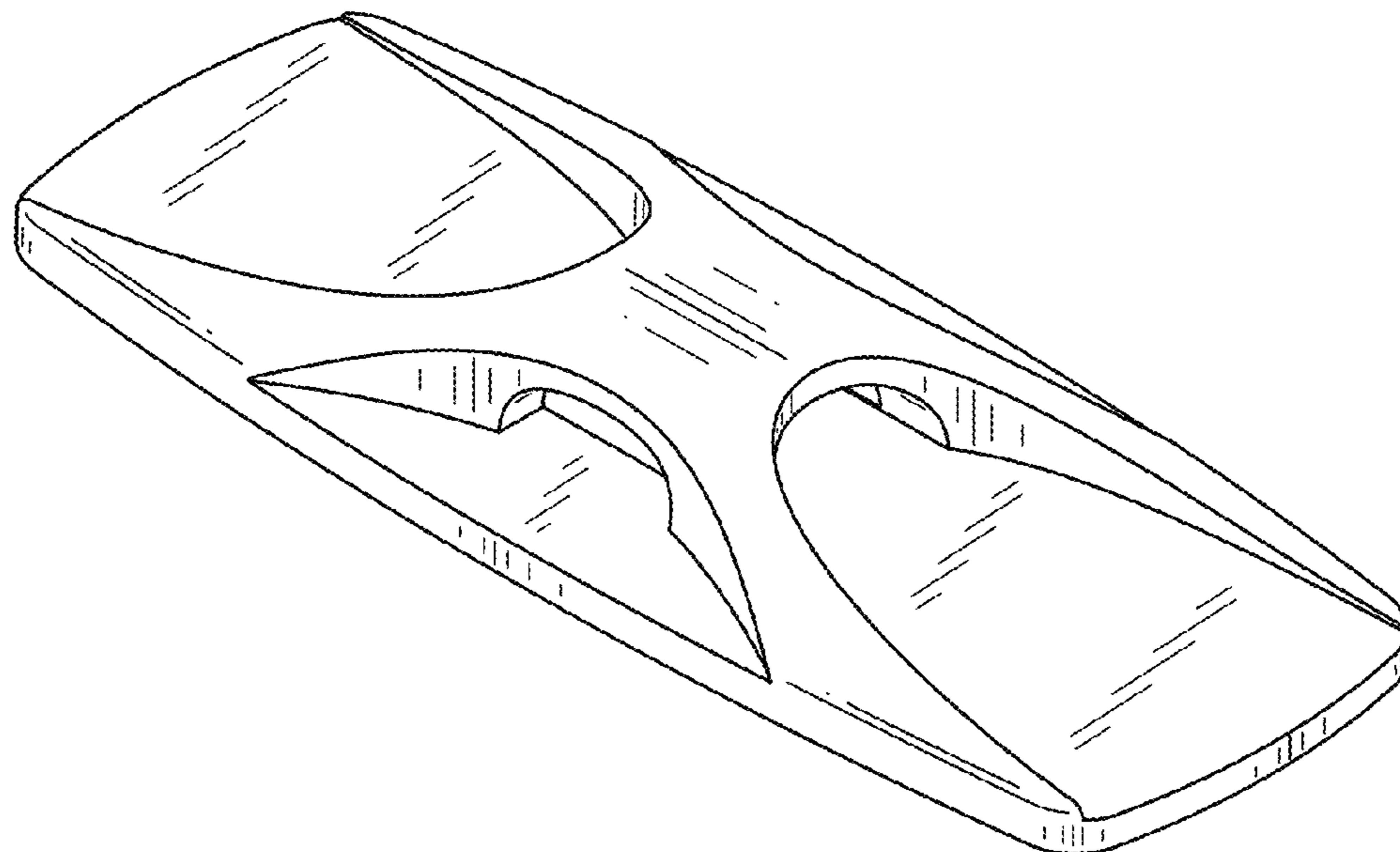

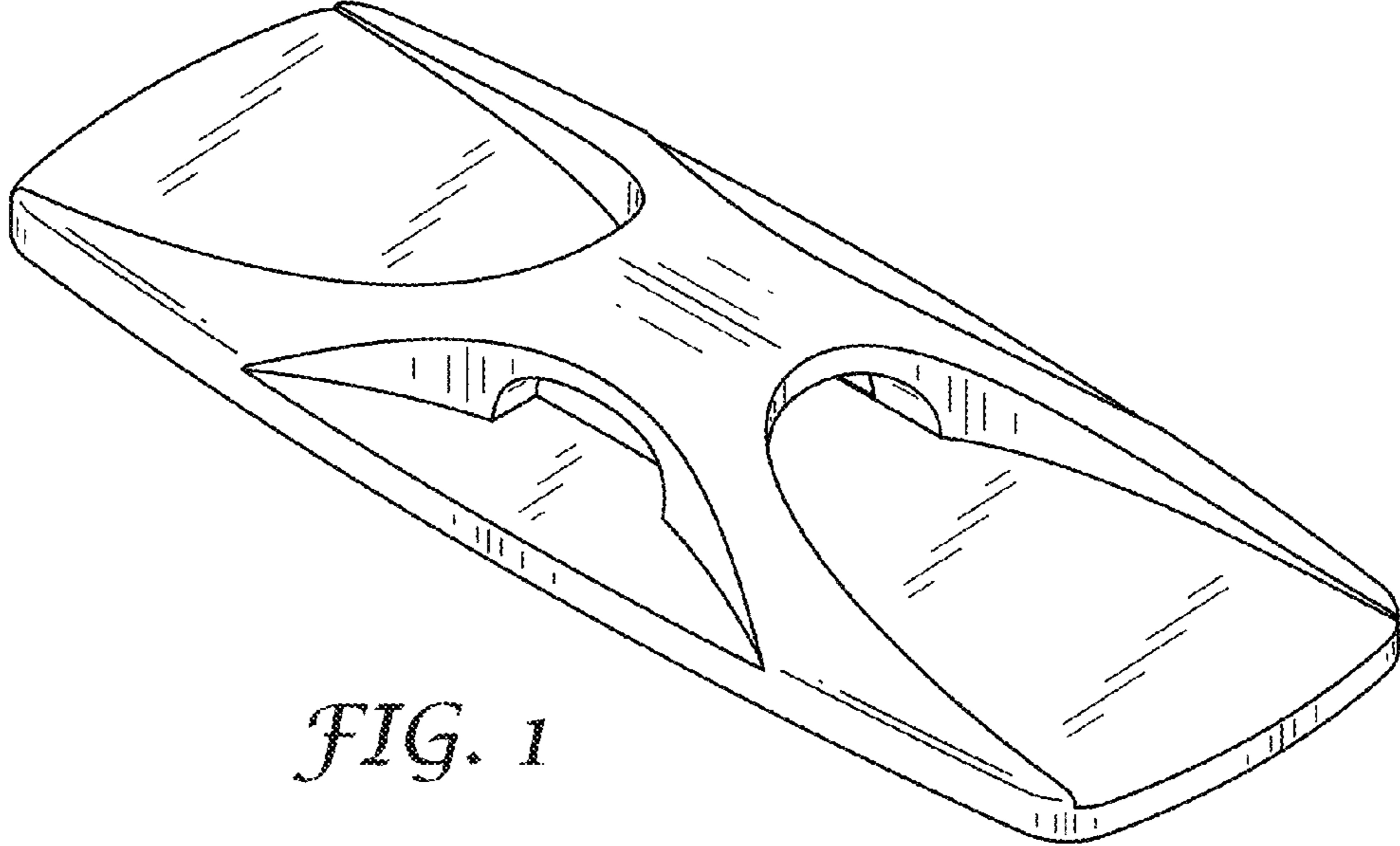
The ornamental design for a holder, as shown and described.

**DESCRIPTION**

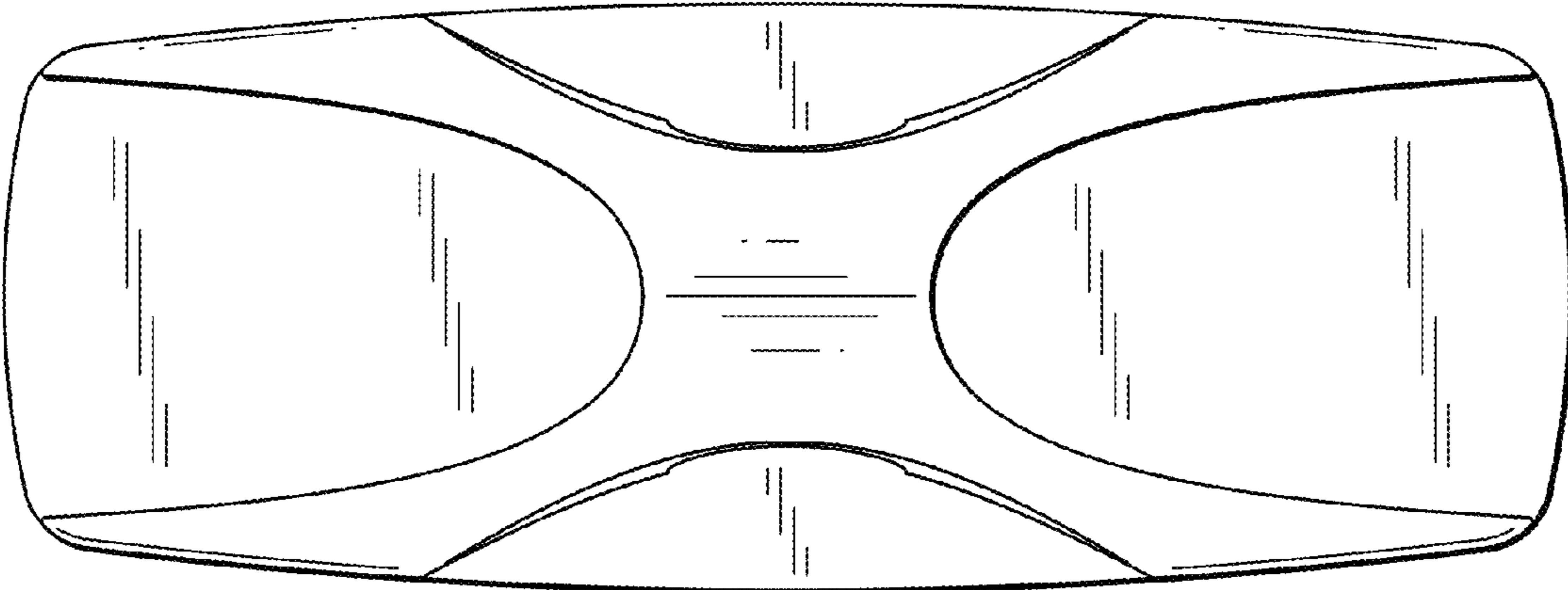
FIG. 1 is a perspective view of a holder showing the new design;

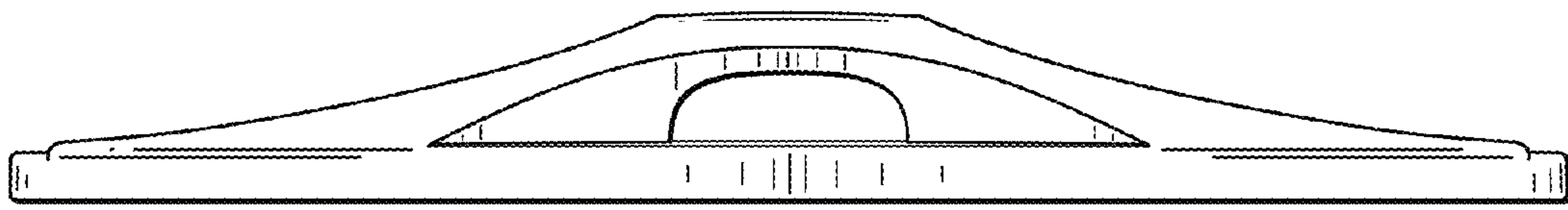




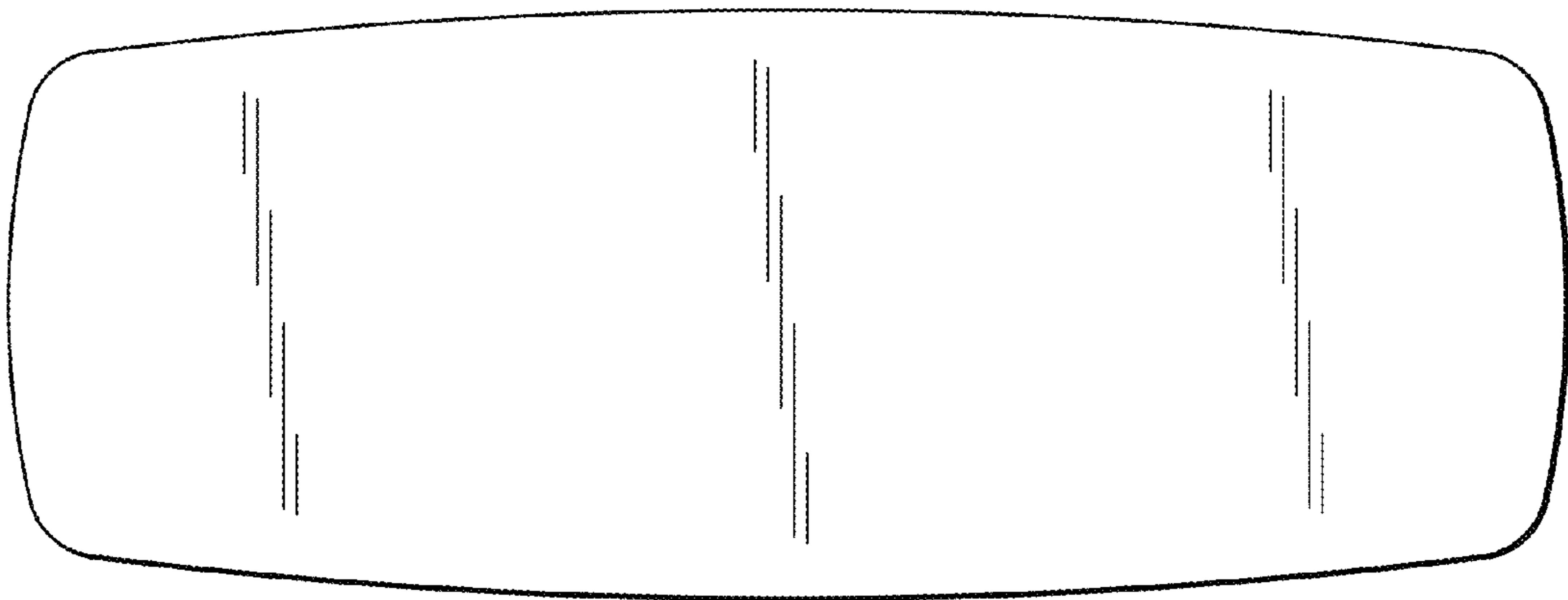

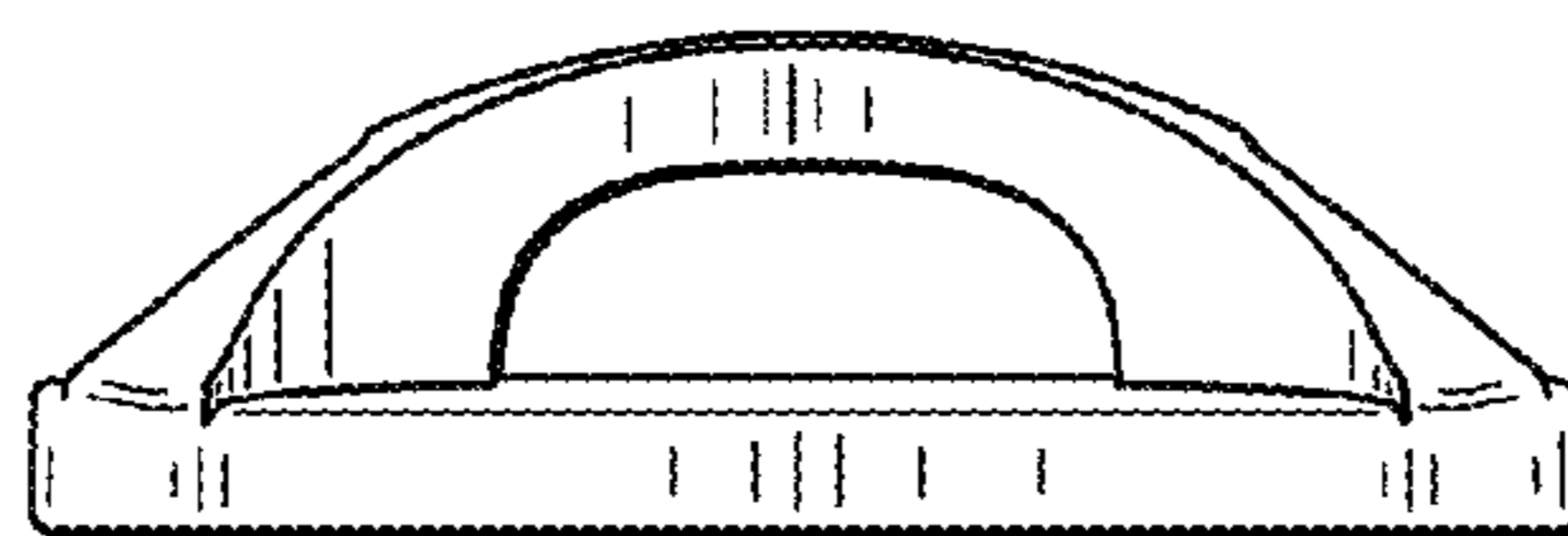
