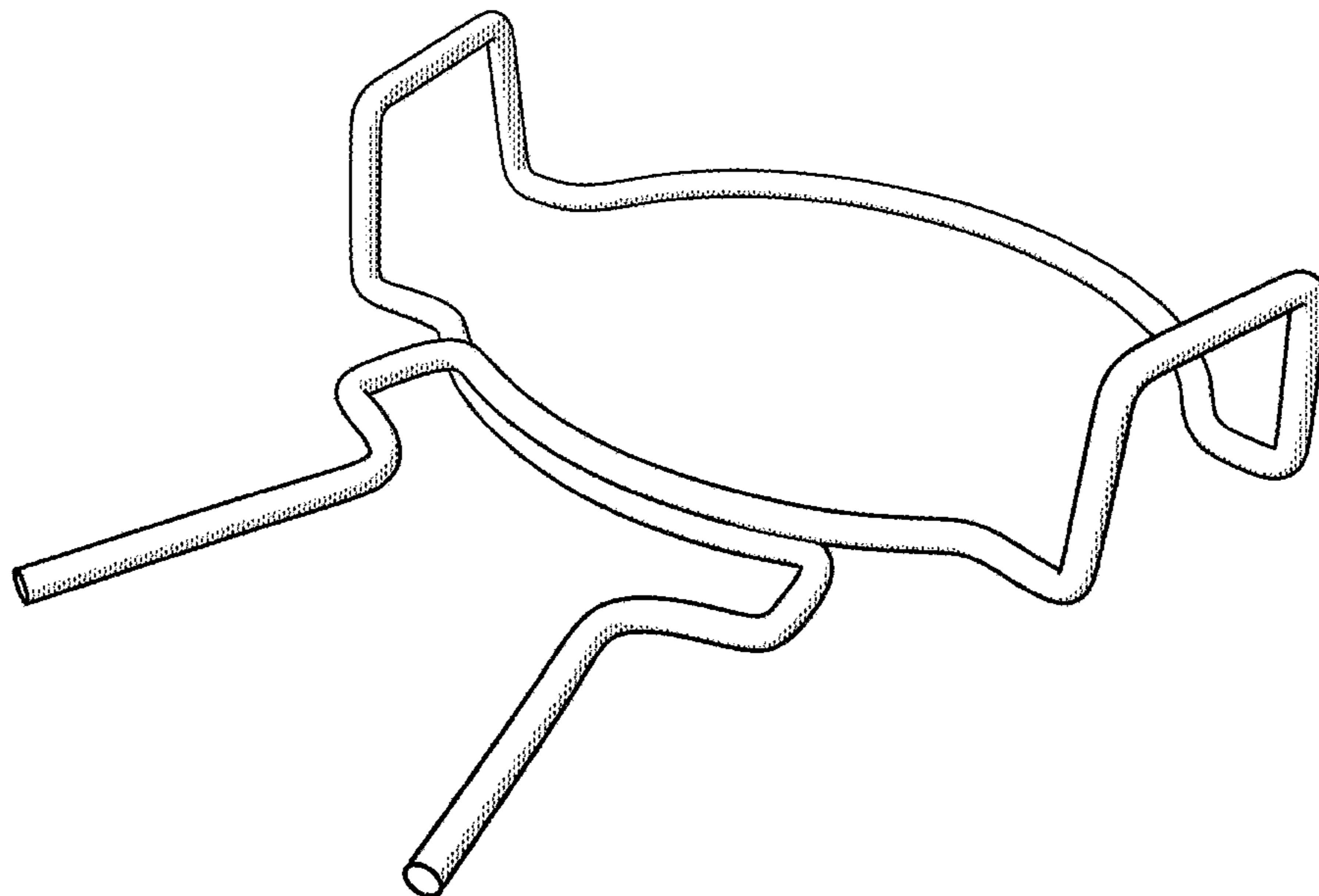
(57) **CLAIM**

The ornamental design for a clamp for a cam lock, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the clamp for a cam lock; FIG. 2 is a top plan view of the clamp for a cam lock; FIG. 3 is a bottom plan view of the clamp for a cam lock; FIG. 4 is a right side elevation view of the clamp for a cam lock; FIG. 5 is a left side elevation view of the clamp for a cam lock; FIG. 6 is a front elevation view of the clamp for a cam lock; and, FIG. 7 is a back elevation view of the clamp for a cam lock.

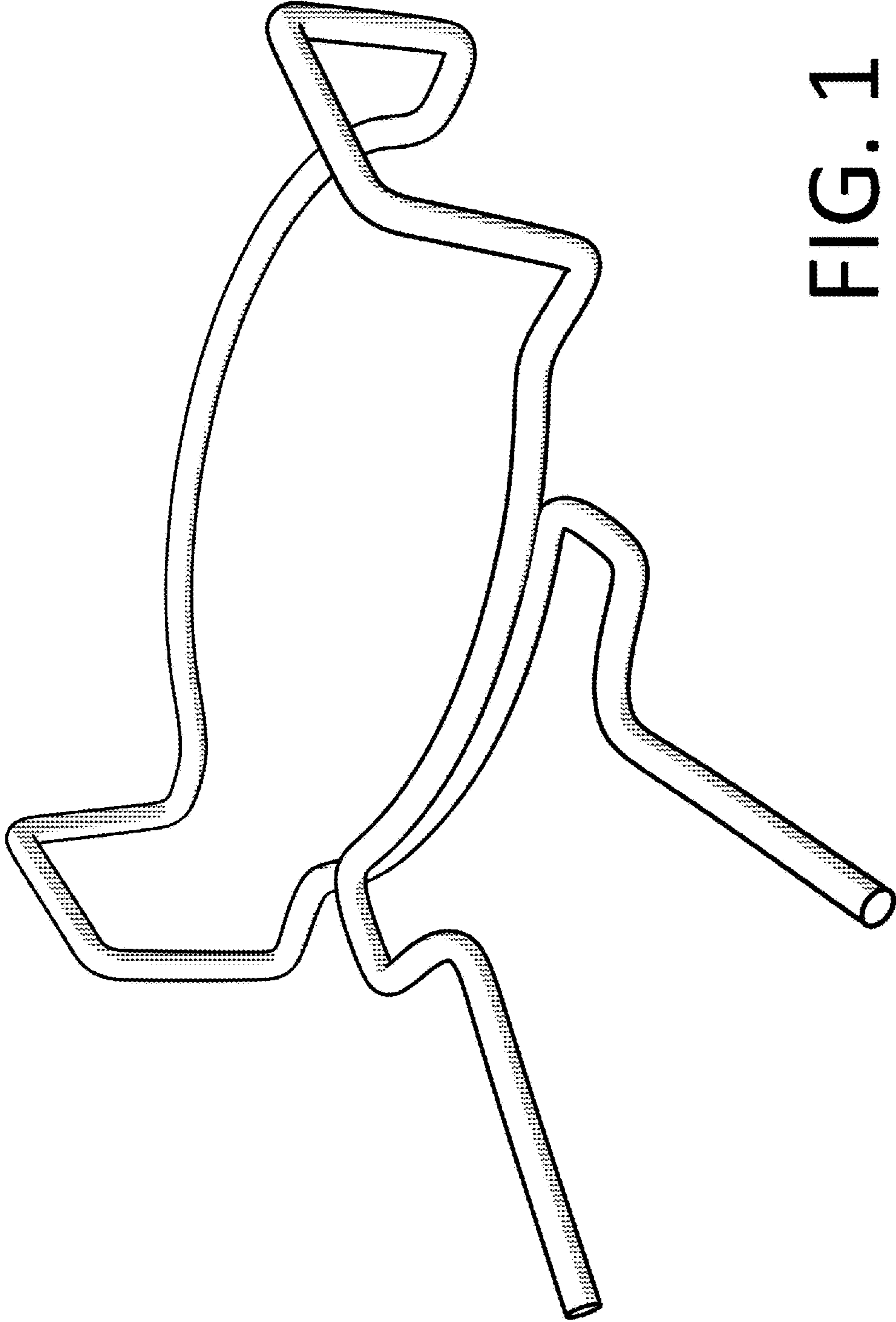

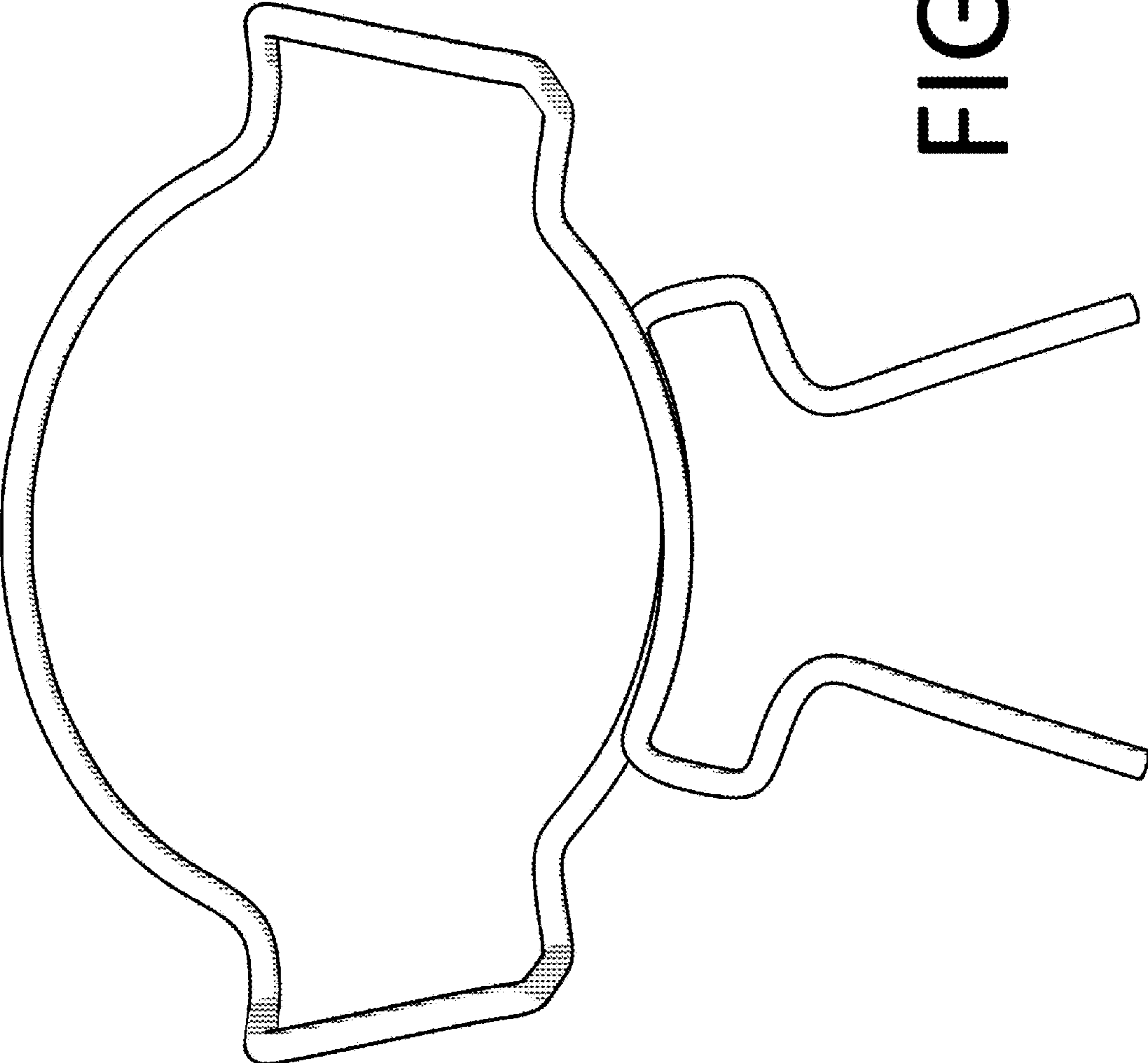

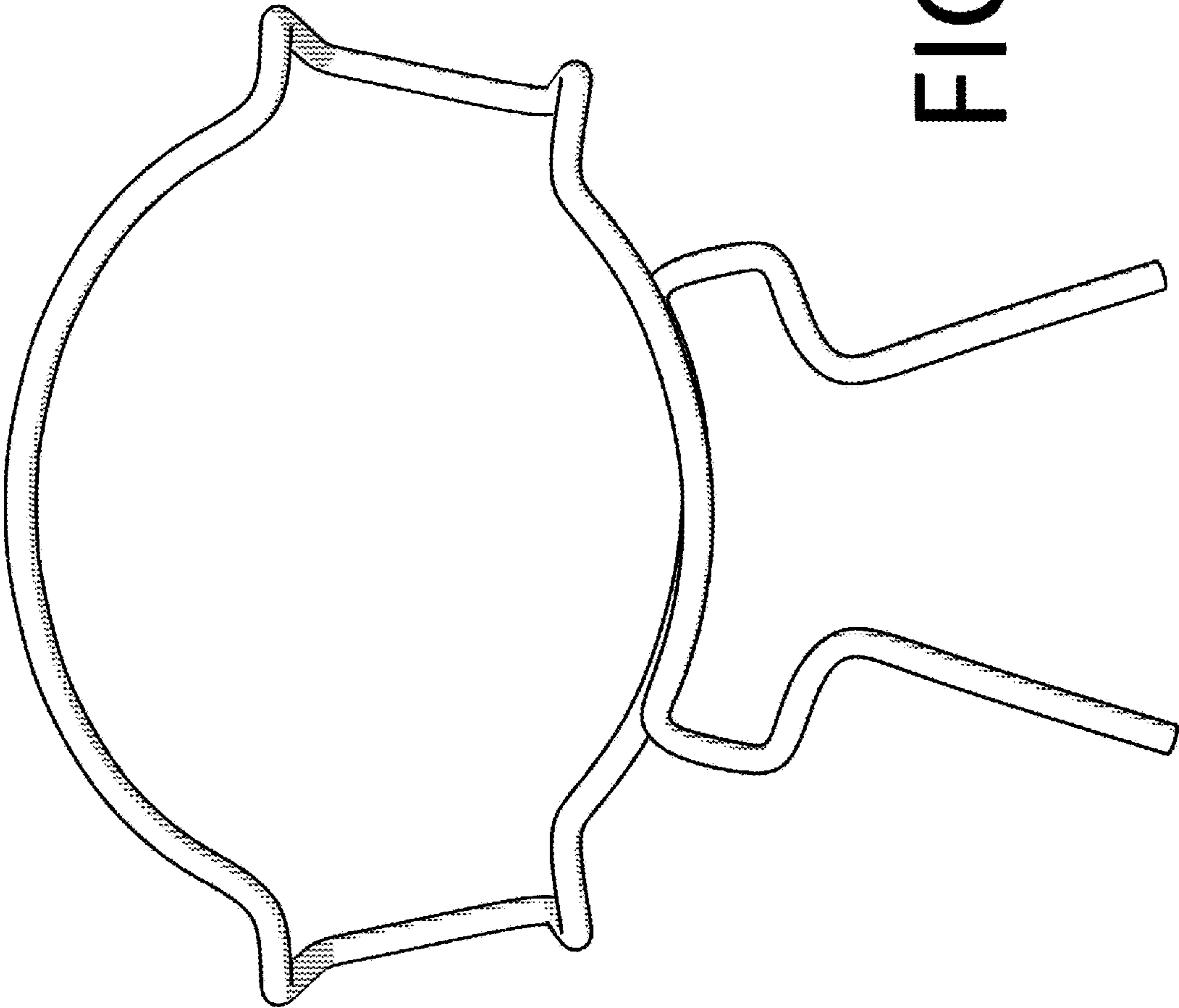

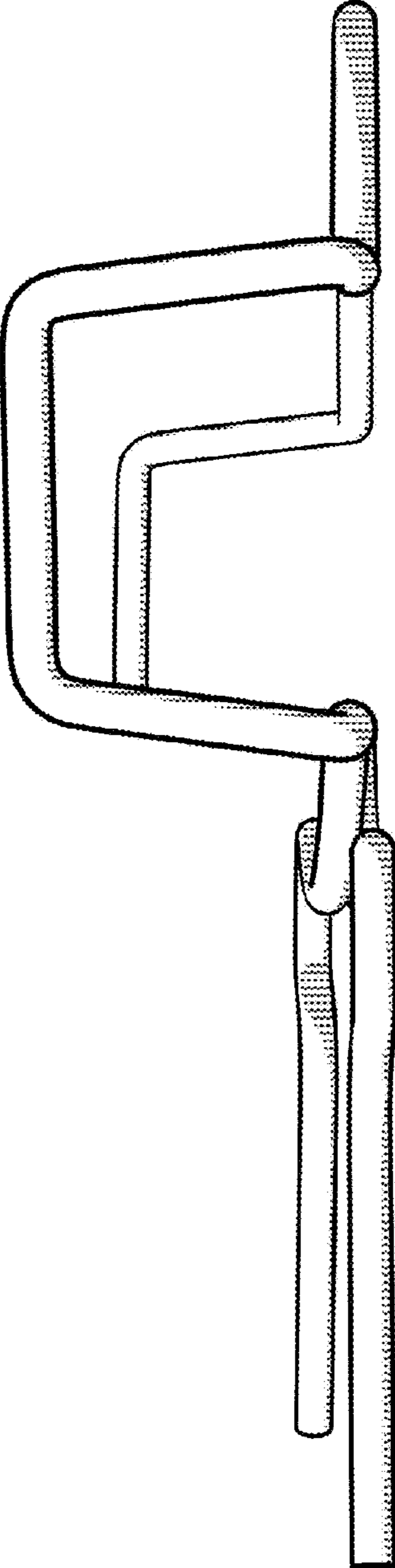

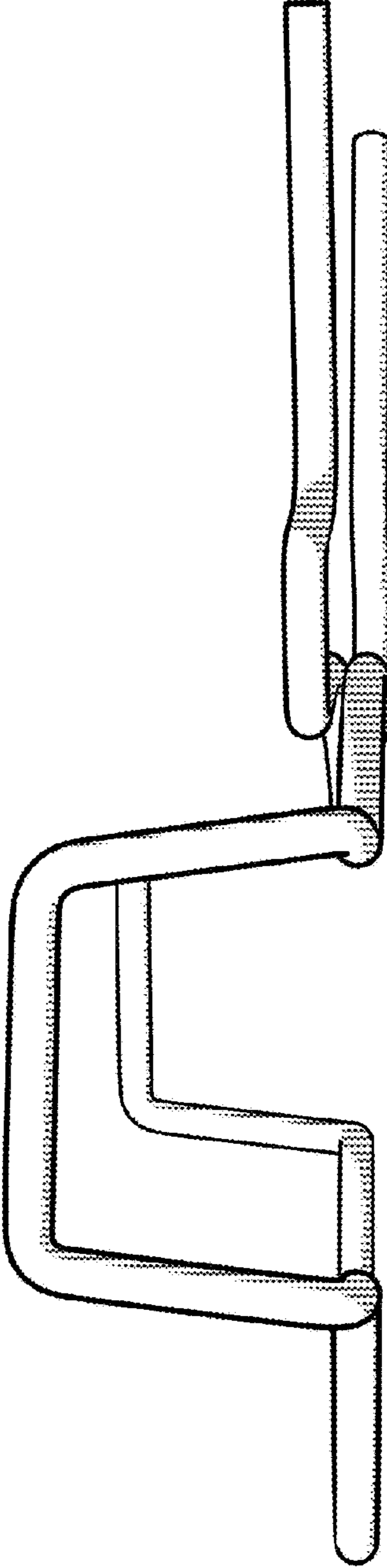

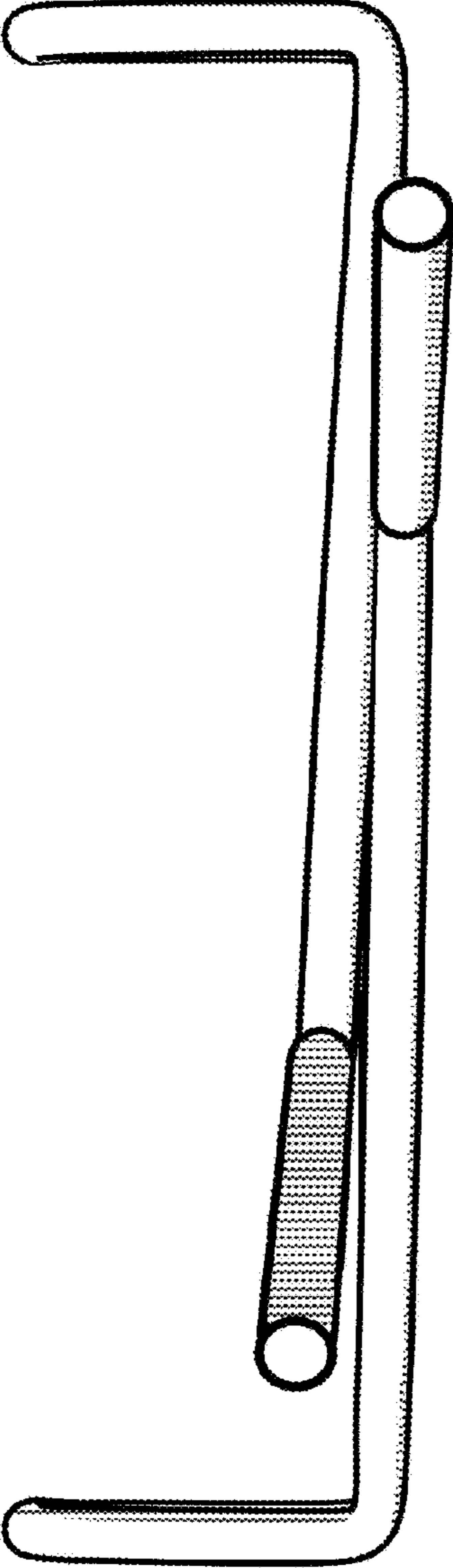

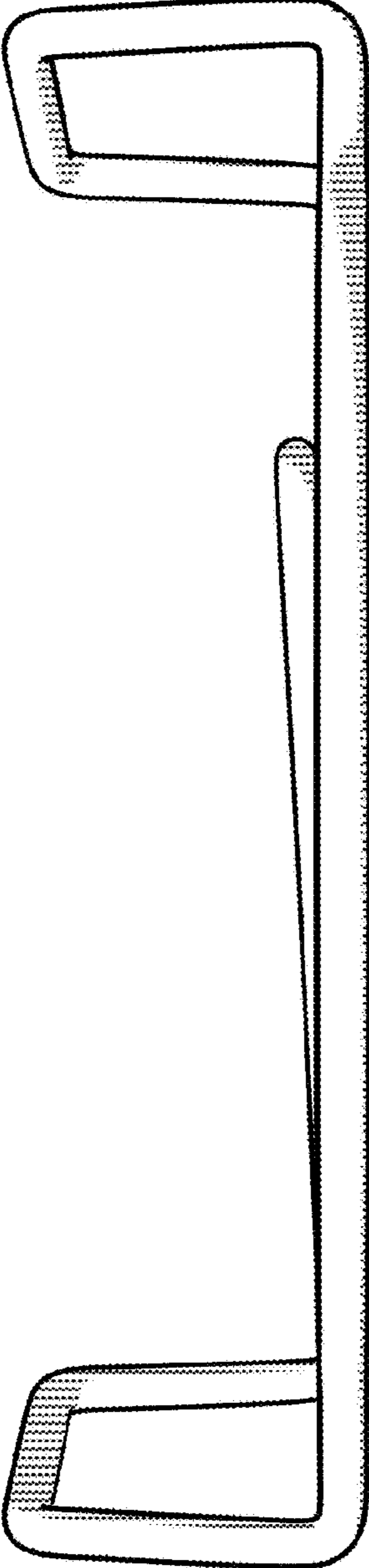
