(57) **CLAIM**

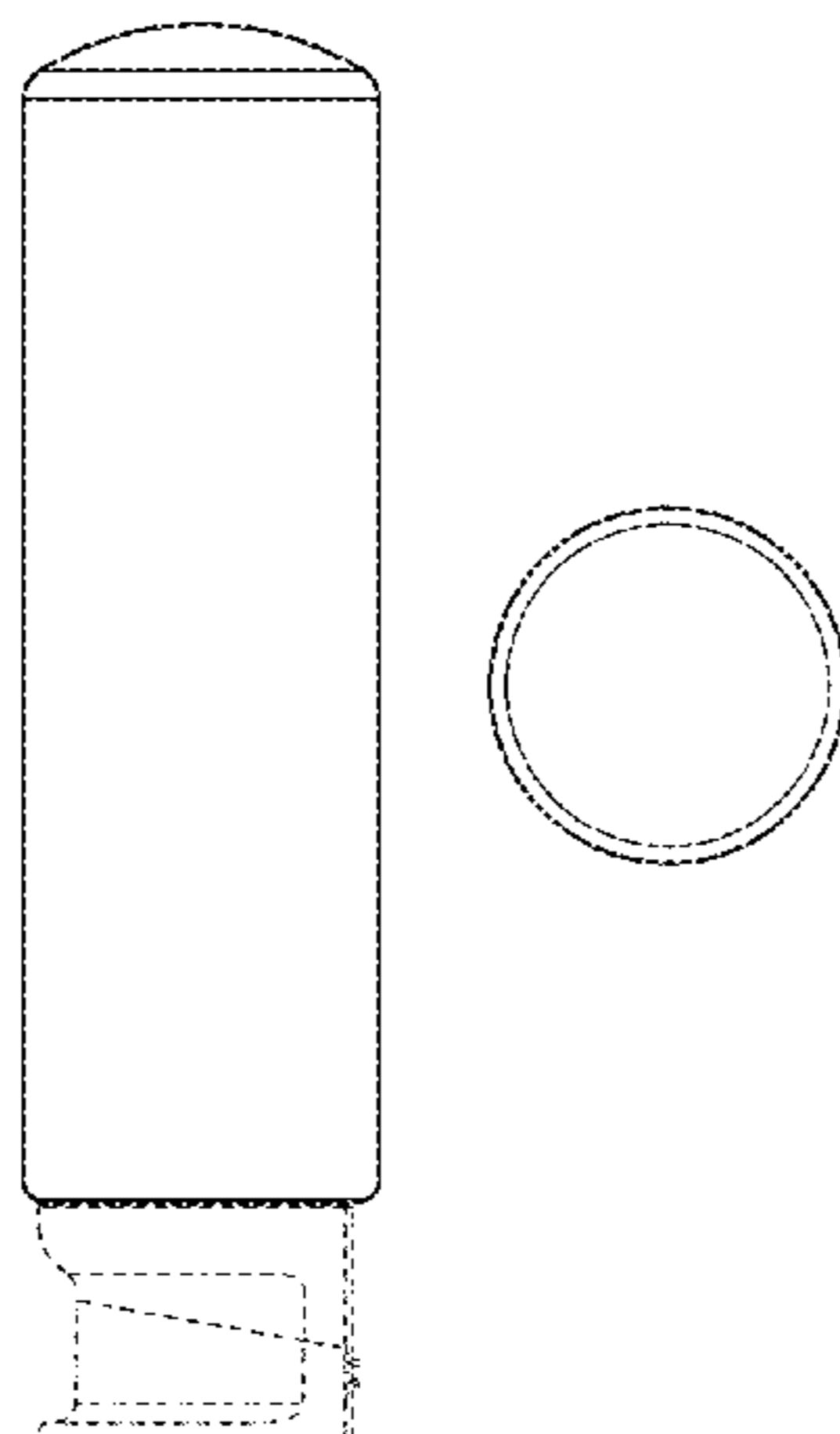
The ornamental design for toothpaste package, as shown and described.

DESCRIPTION

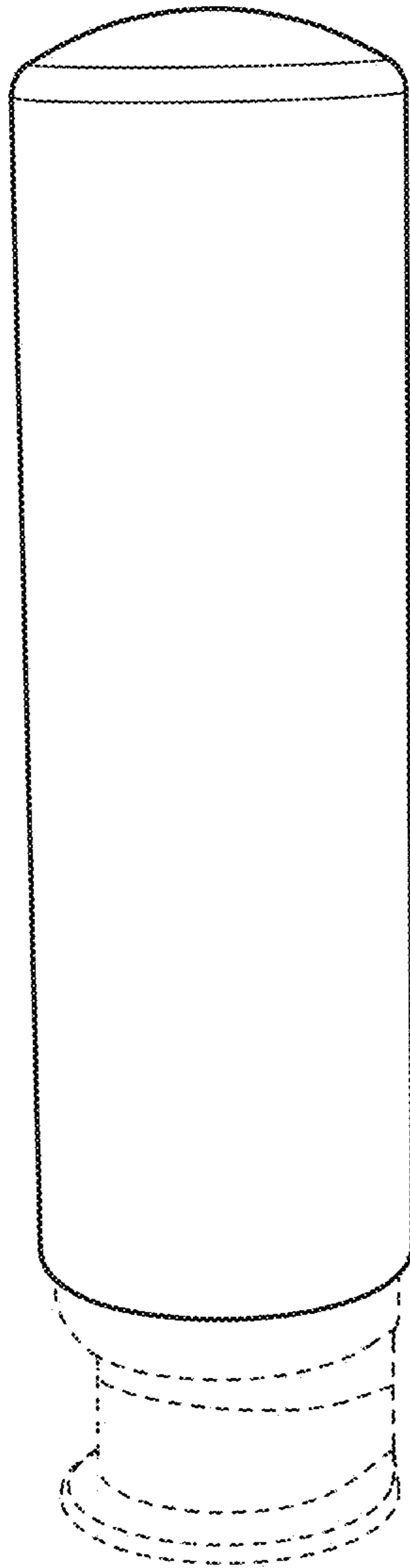

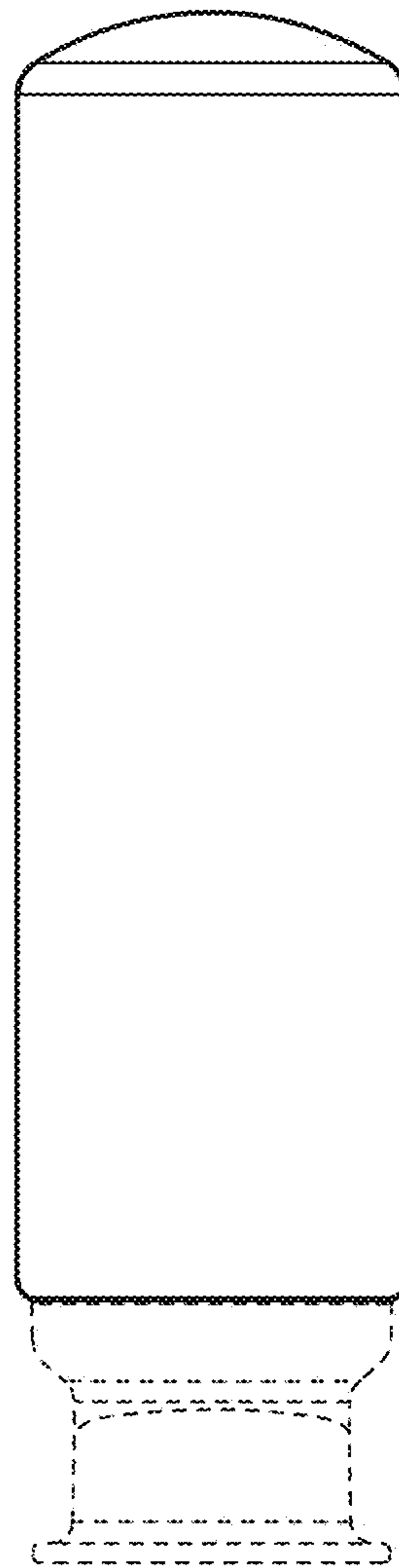

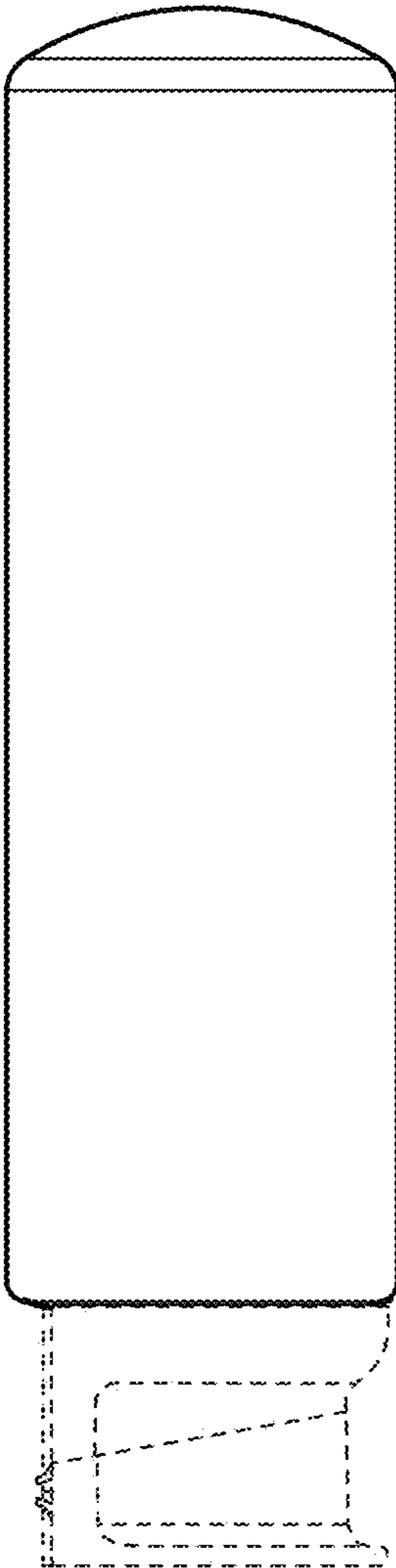

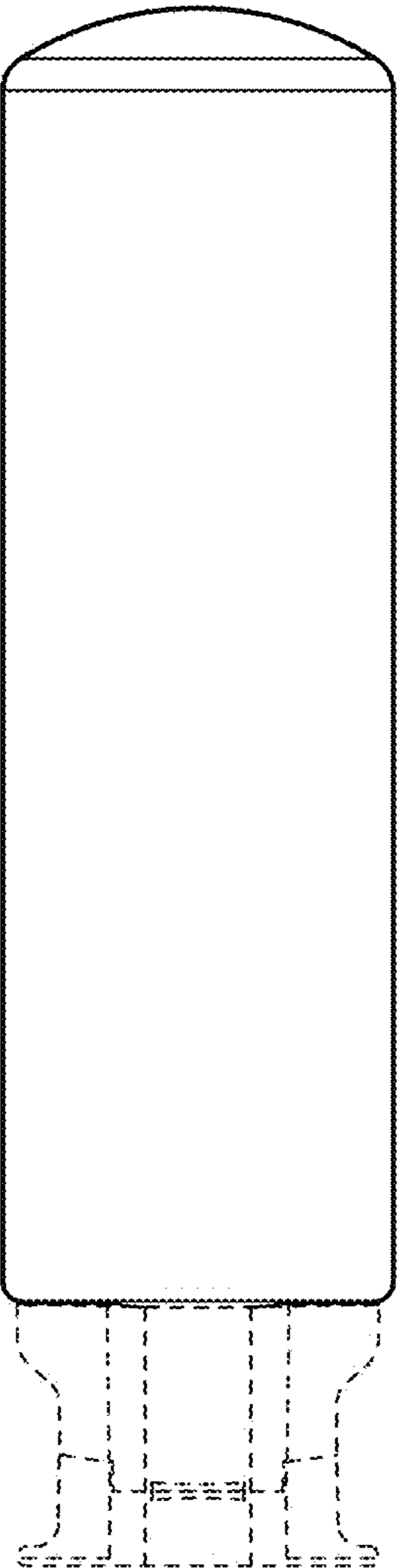

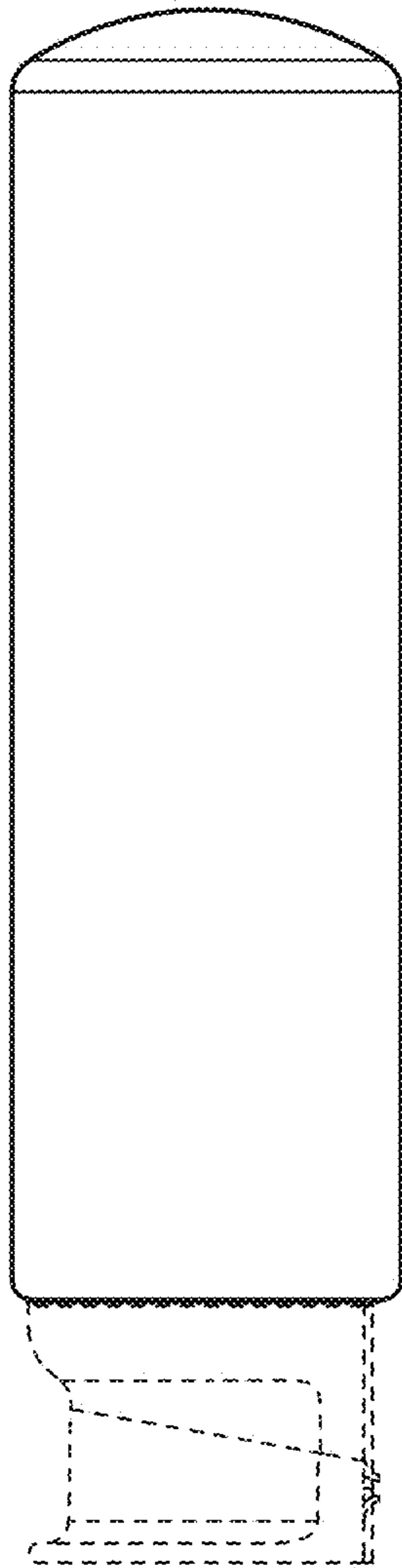

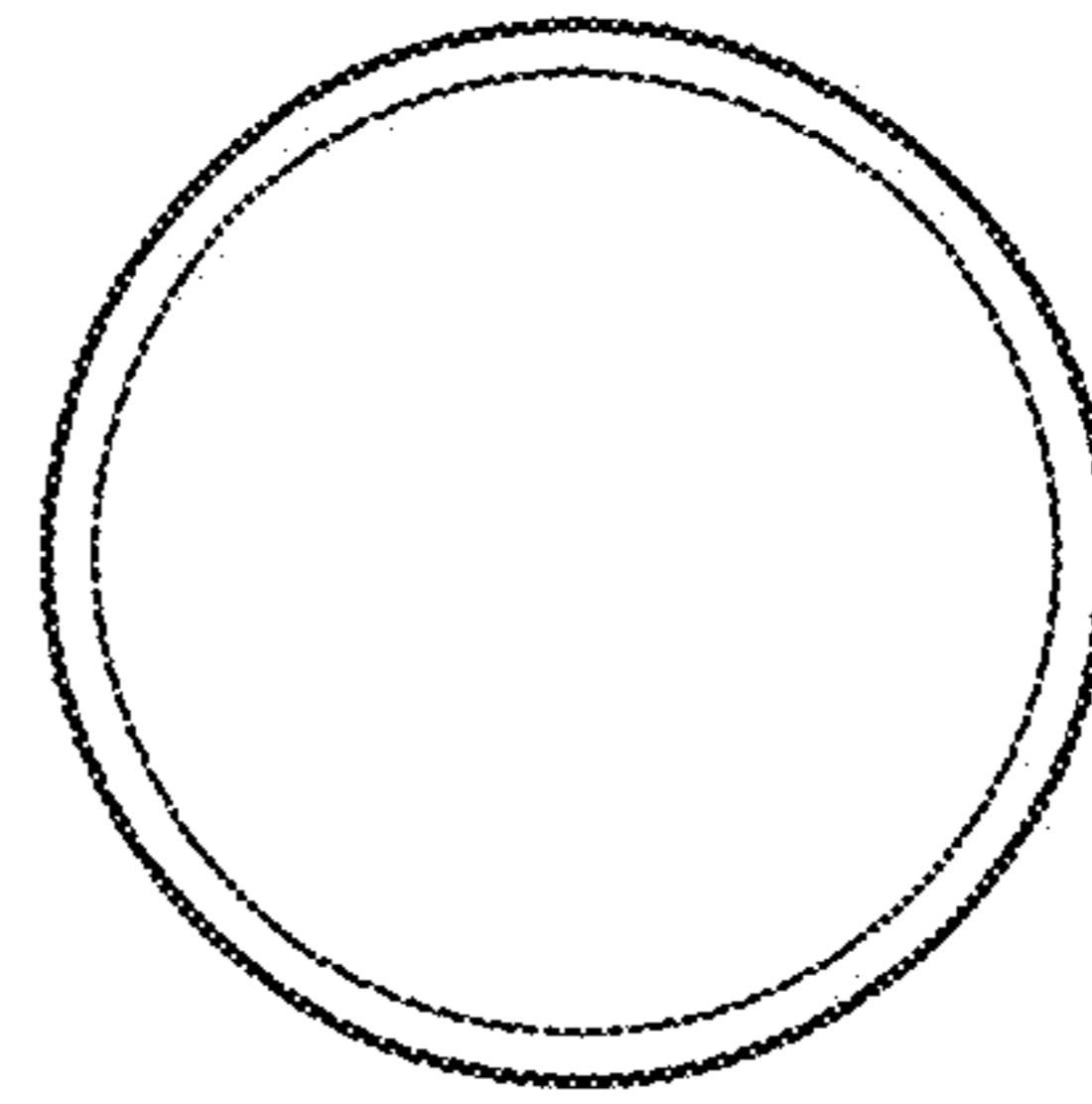

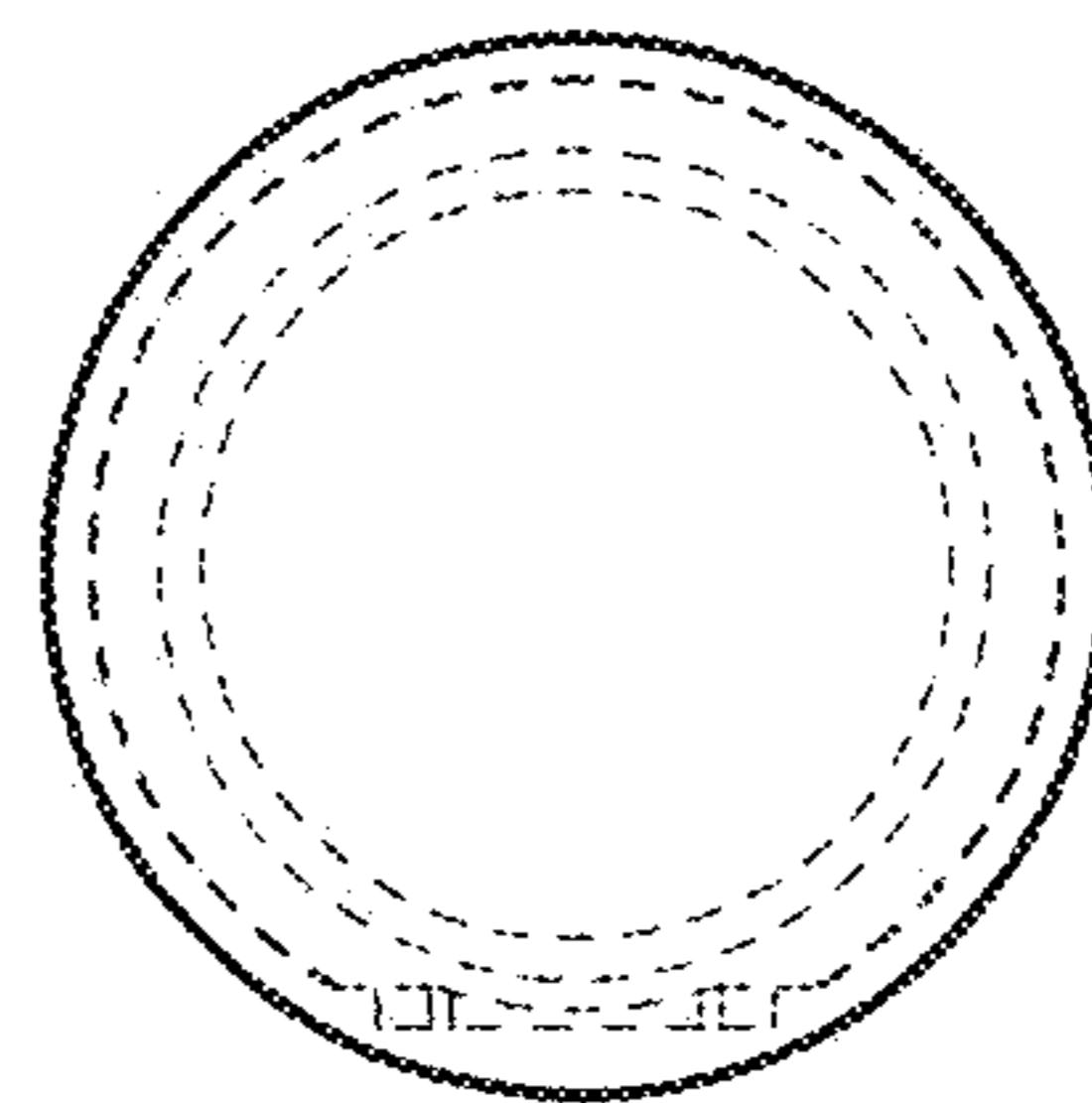

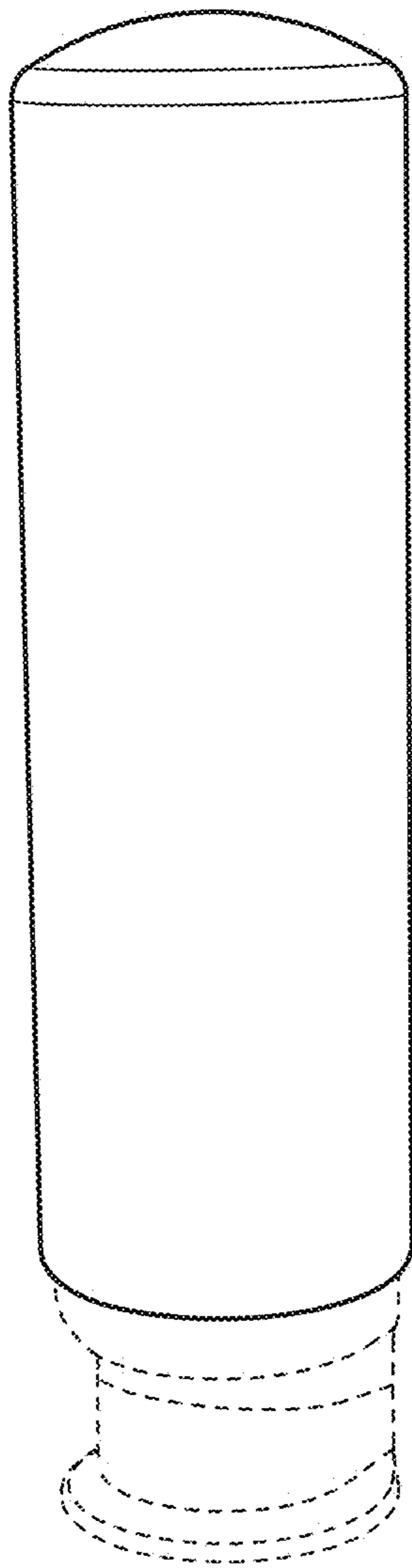

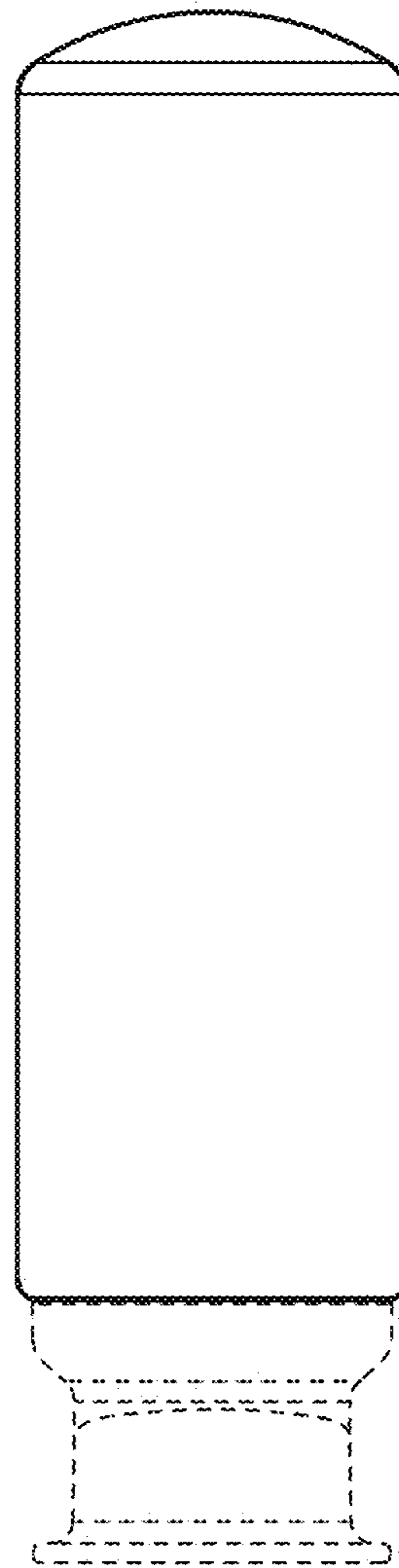

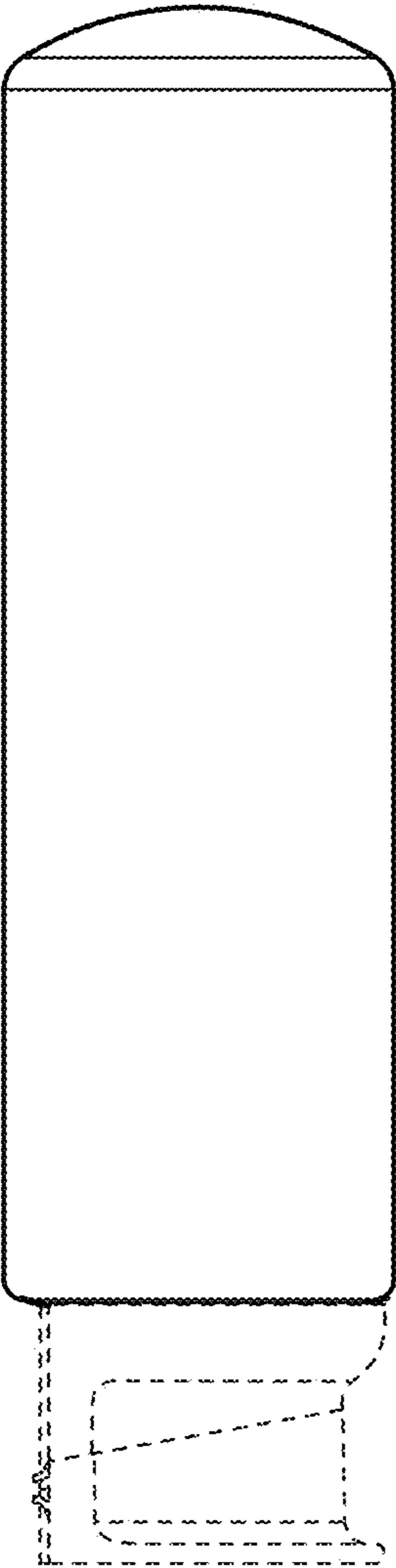

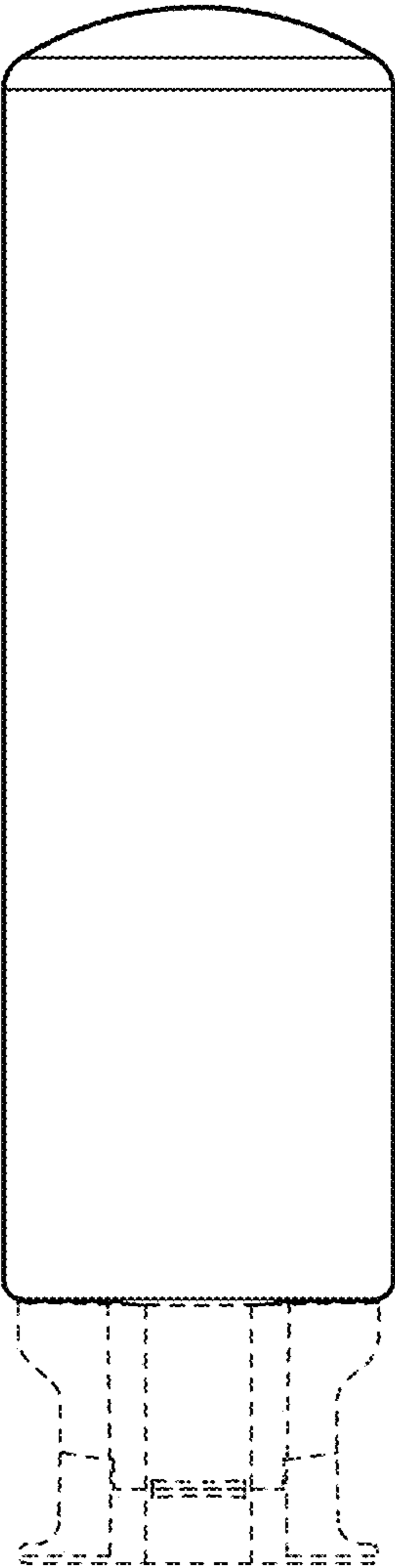

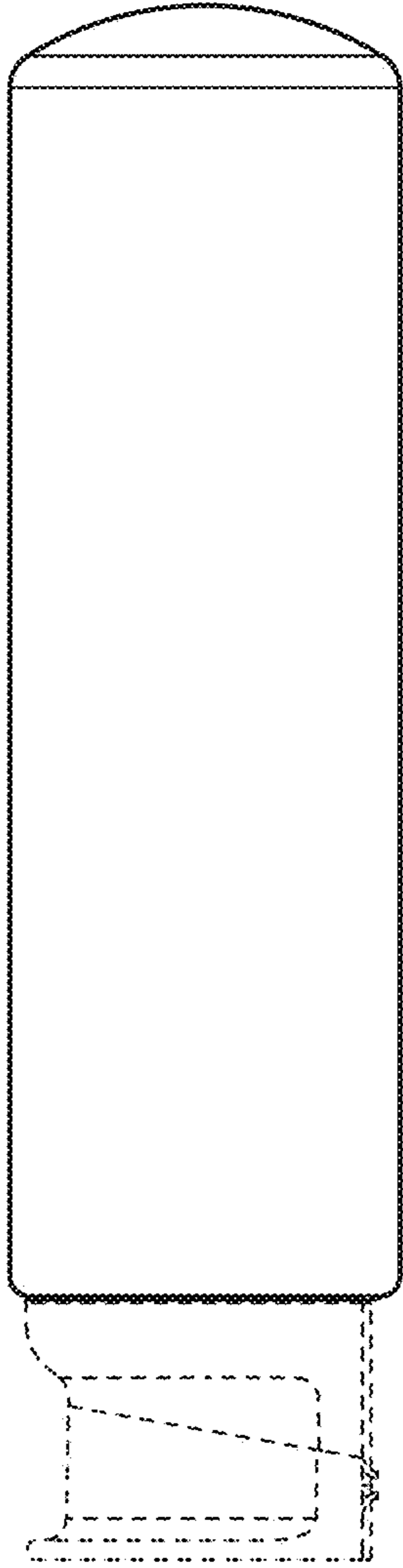

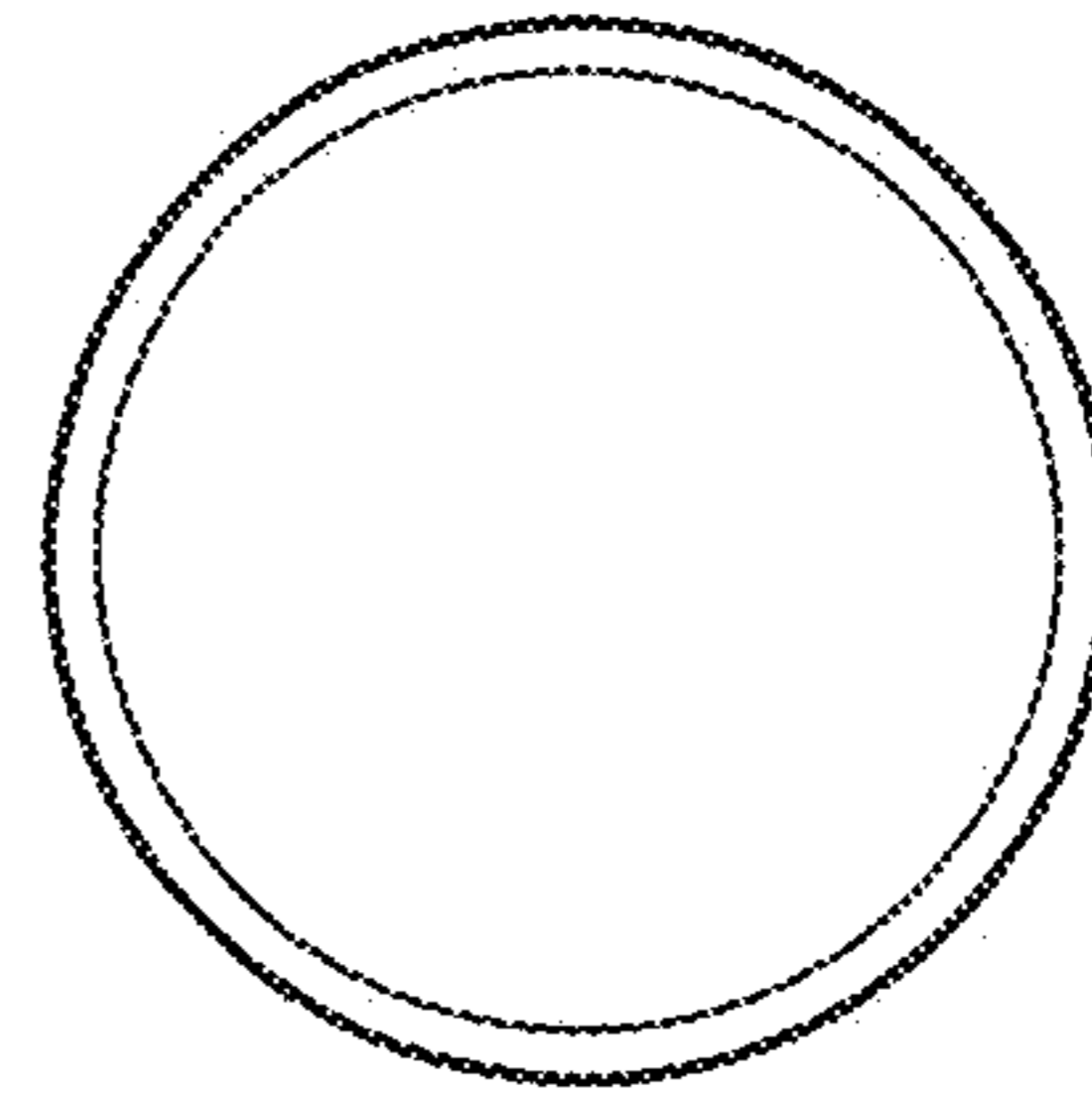

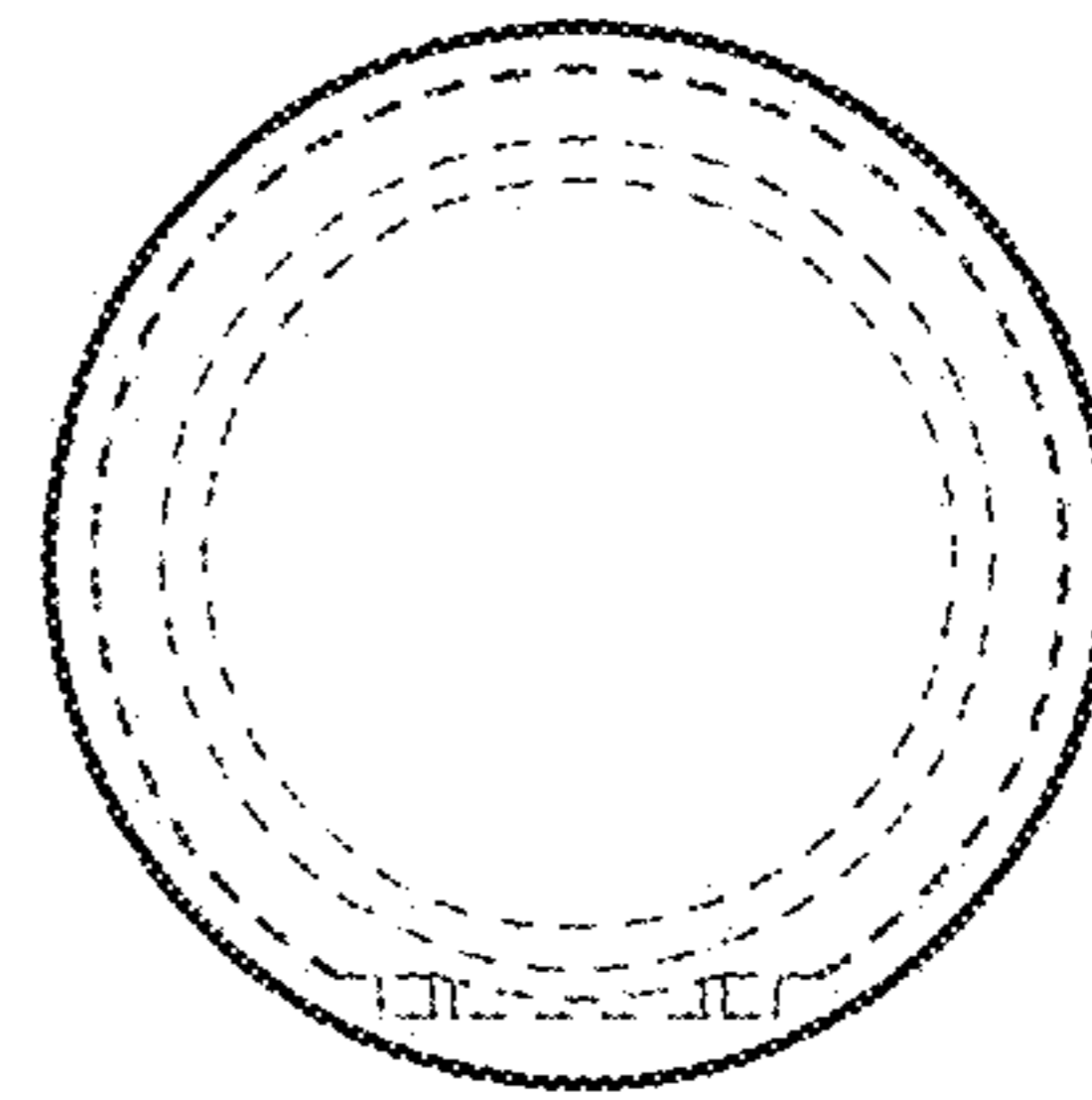
