(57) **CLAIM**

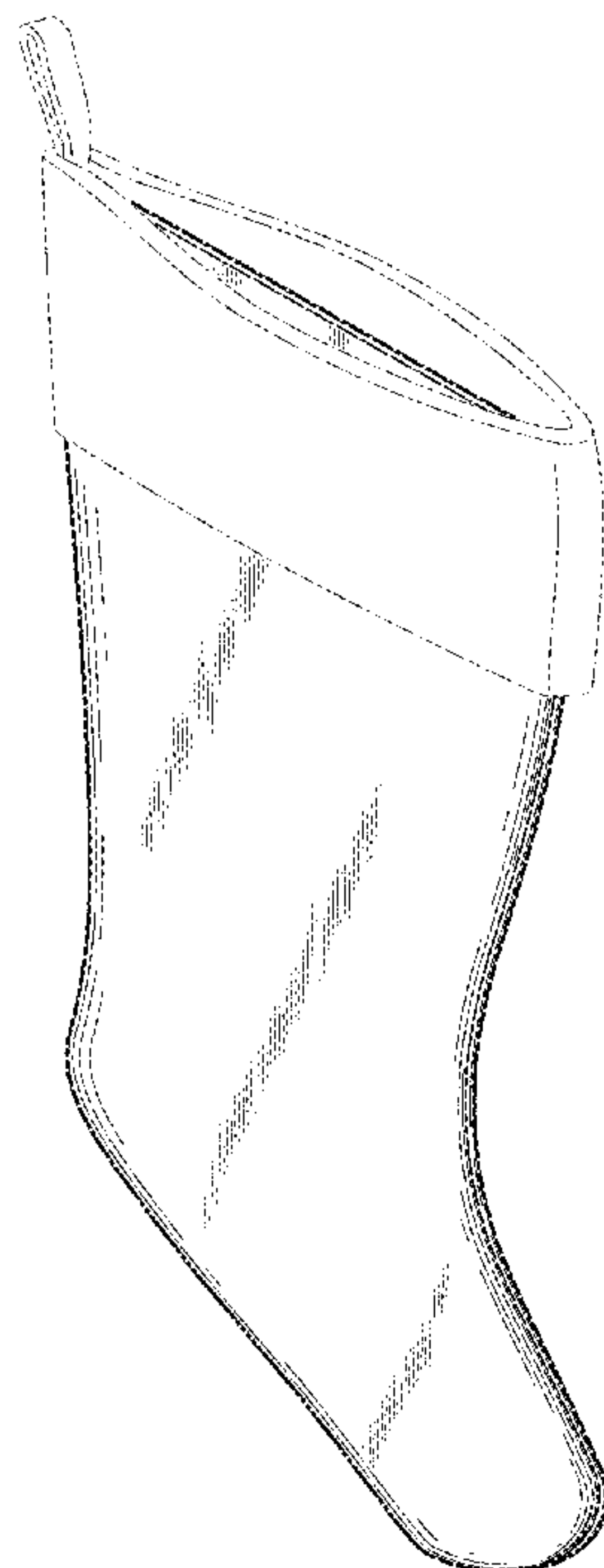
The ornamental design for a novelty gift bag, as shown.

DESCRIPTION

FIG. 1 is a perspective view of the novelty gift bag;
FIG. 2 is back view thereof;
FIG. 3 is a right side view thereof;
FIG. 4 is a front view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom view thereof;
FIG. 8 is a perspective view thereof; and,
FIG. 9 is a vertical cross-section view thereof, the cross-section taken perpendicular to FIG. 3 and depicting the center divider therein.

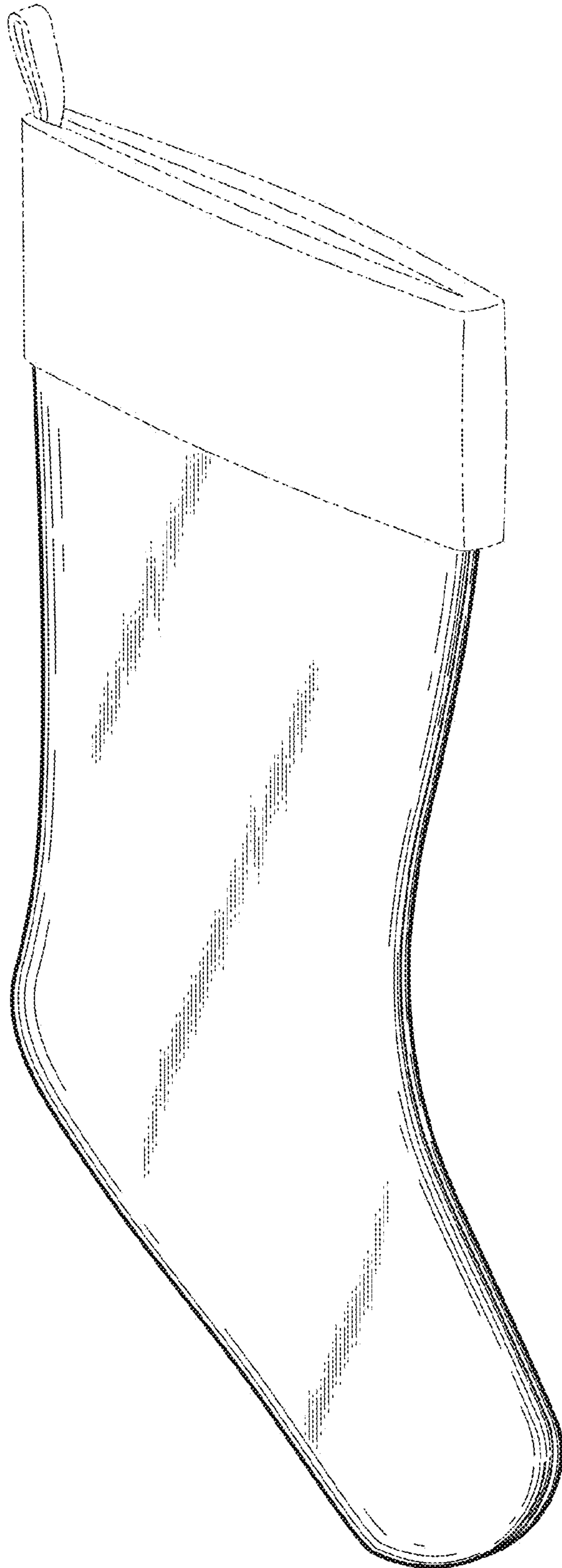

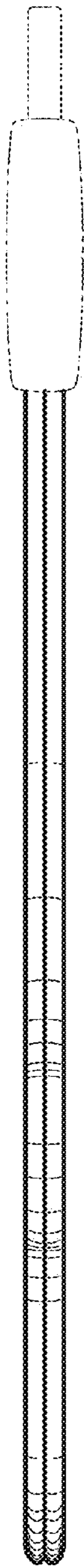

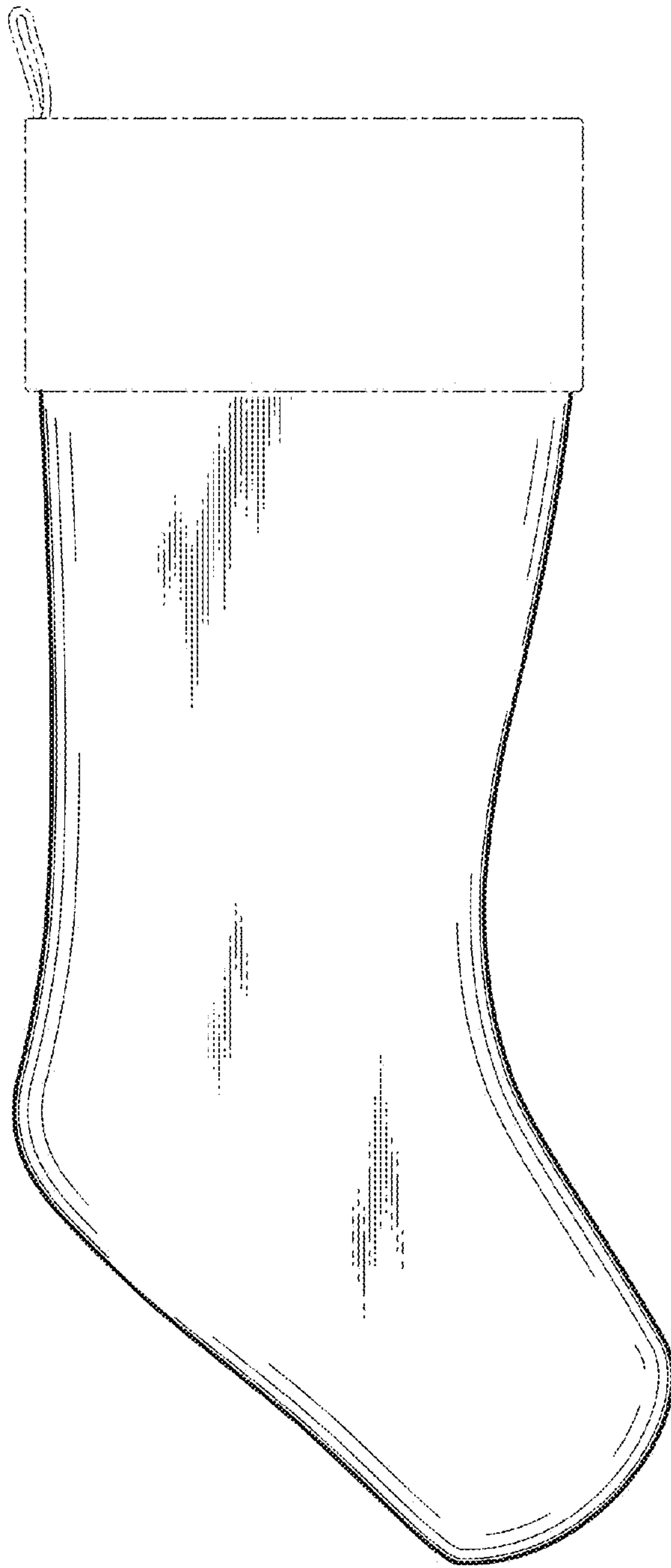

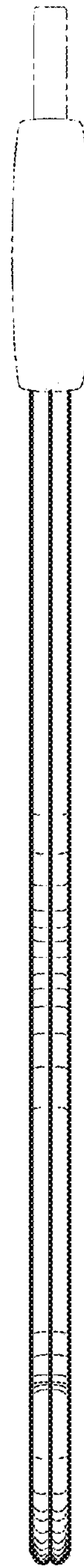

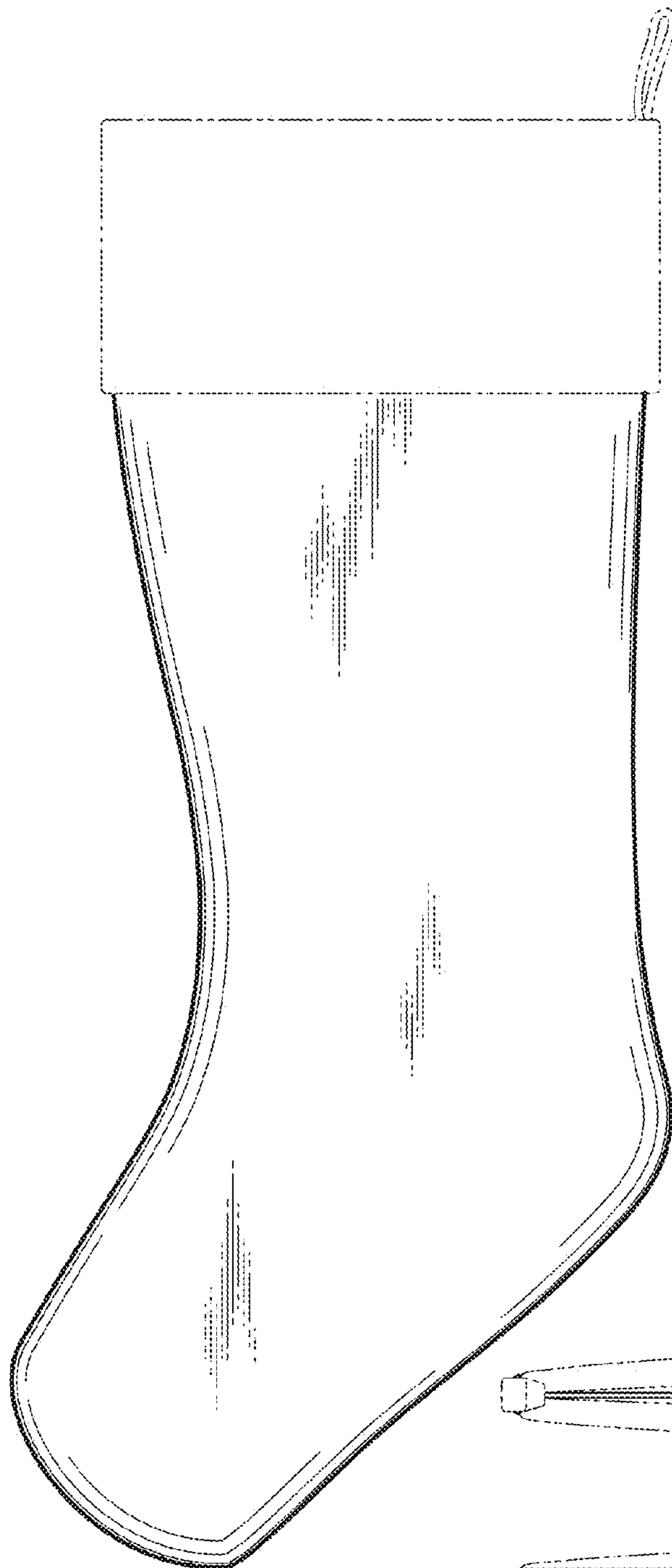

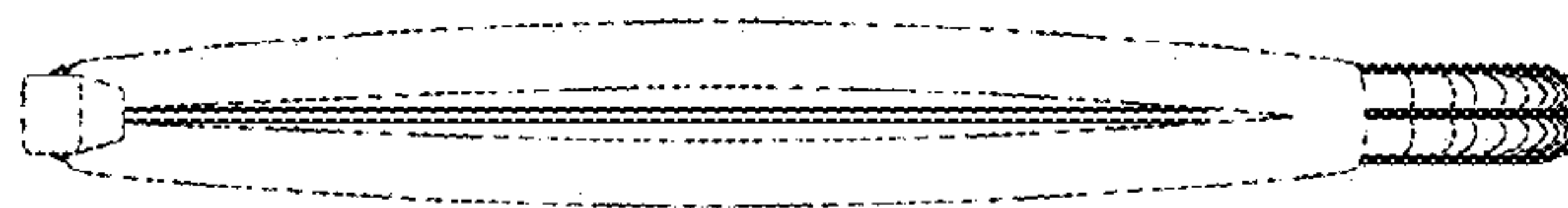

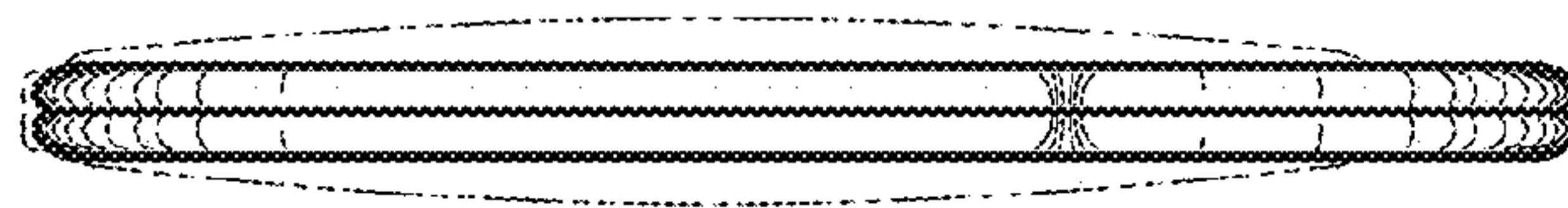

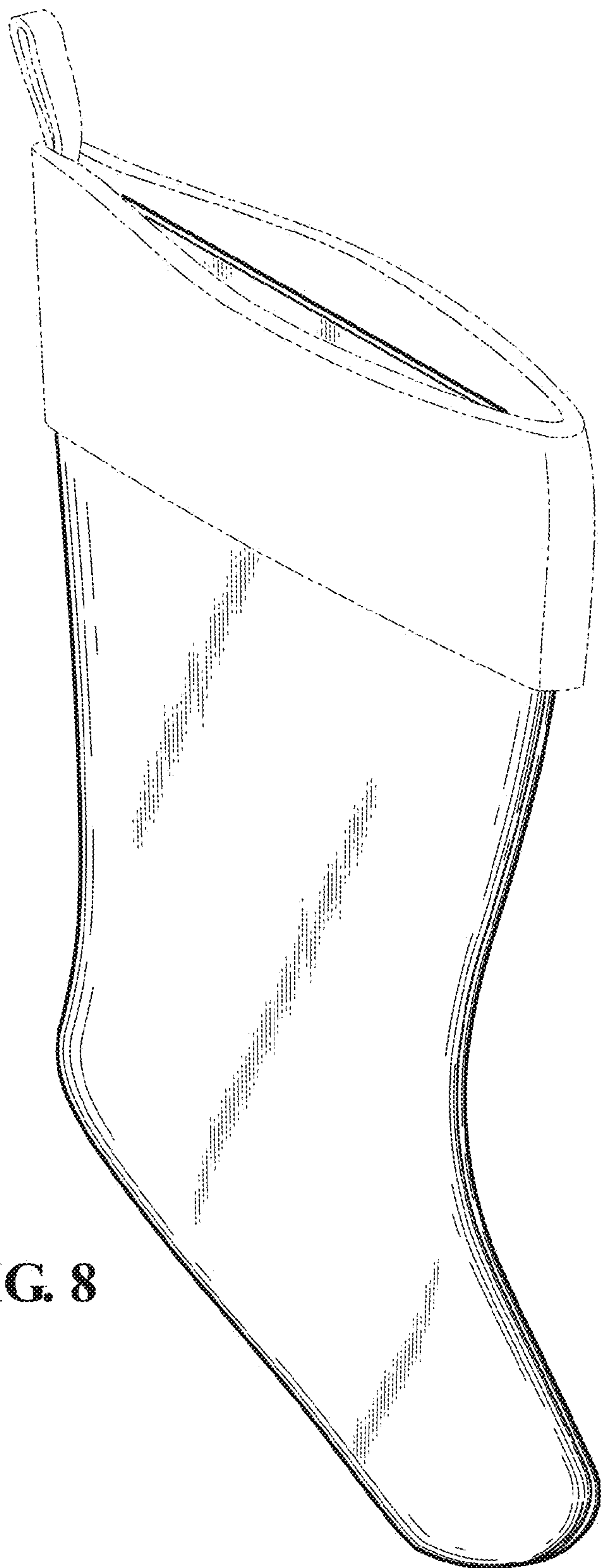

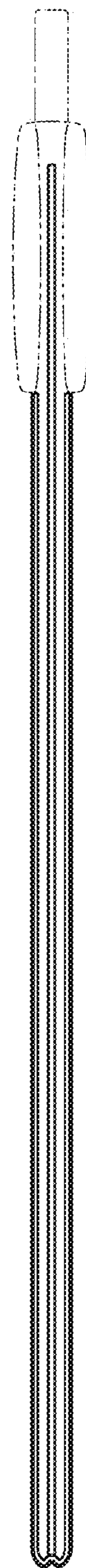
