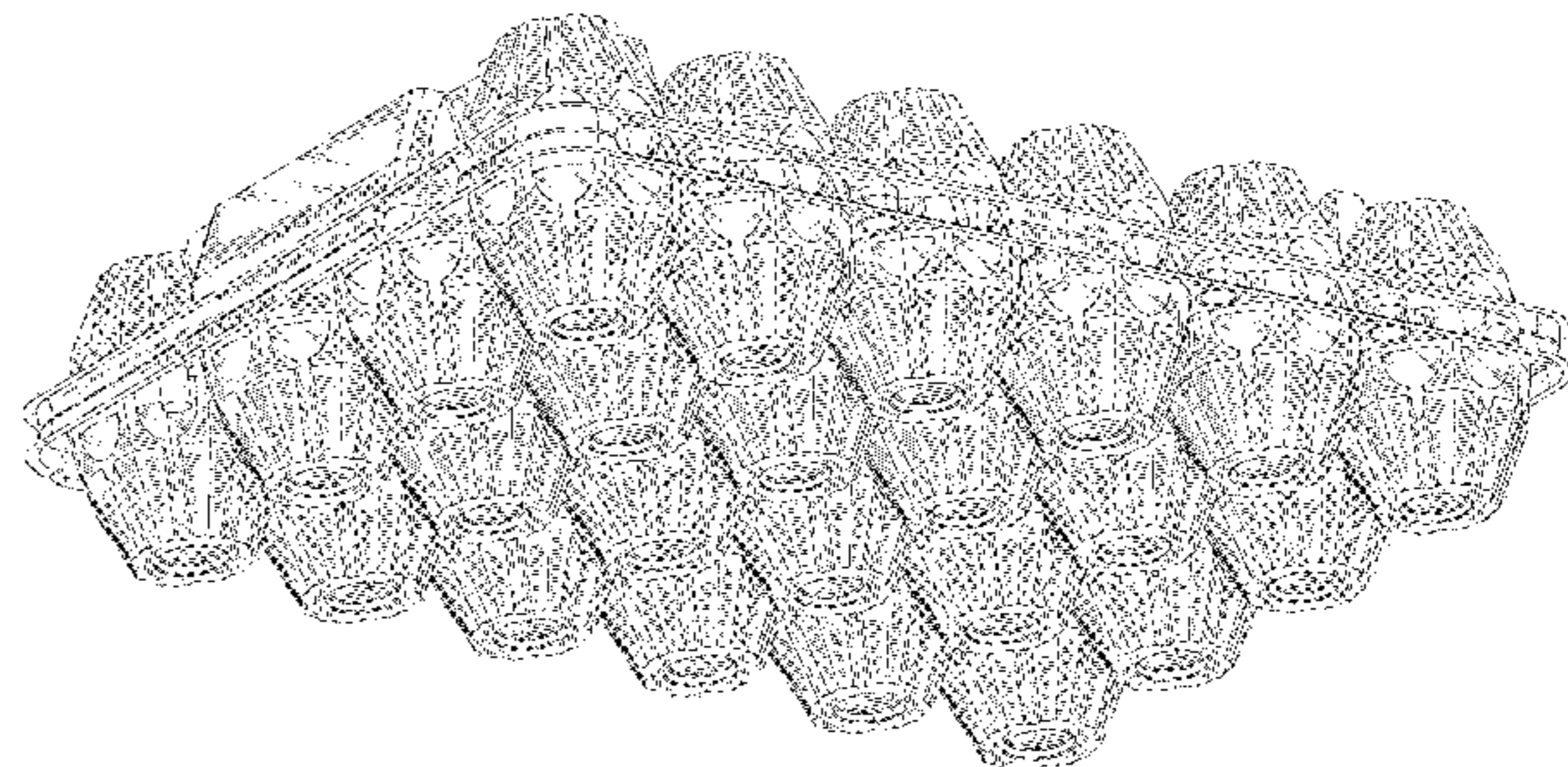
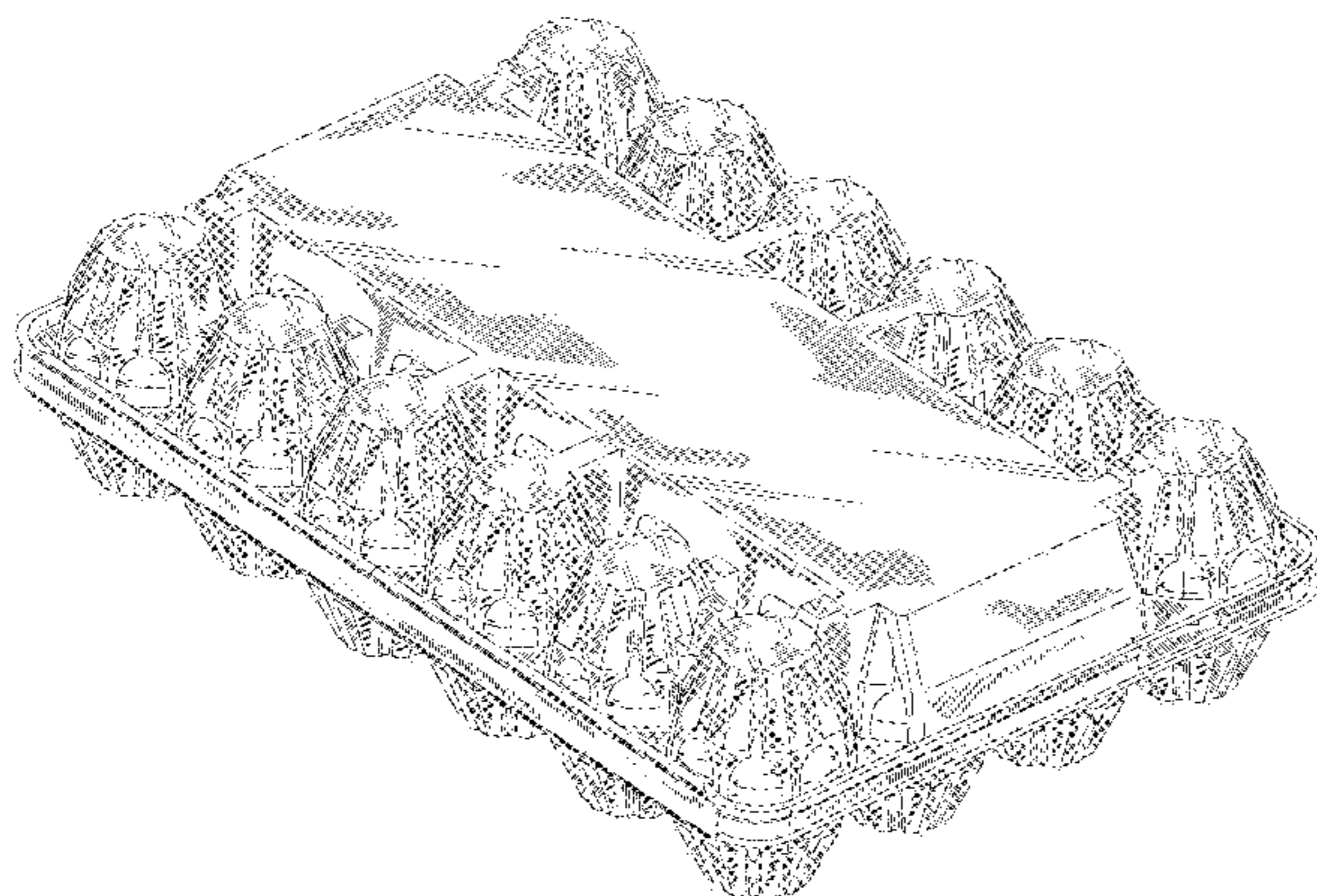
(57) **CLAIM**

The ornamental design for an egg carton, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view from above of the invention;  
FIG. 2 is another perspective from above of the invention;  
FIG. 3 is a perspective view from below of the invention;  
FIG. 4 is a bottom view of the invention;  
FIG. 5 is a top view of the invention;  
FIG. 6 is a side elevational view of the invention, the other side being a mirror image thereof;  
FIG. 7 is a front elevational view of the invention; and,  
FIG. 8 is a rear elevational view of the invention.  
The instant invention is a package molded of clear plastic and intended for shipping and storing fresh eggs.

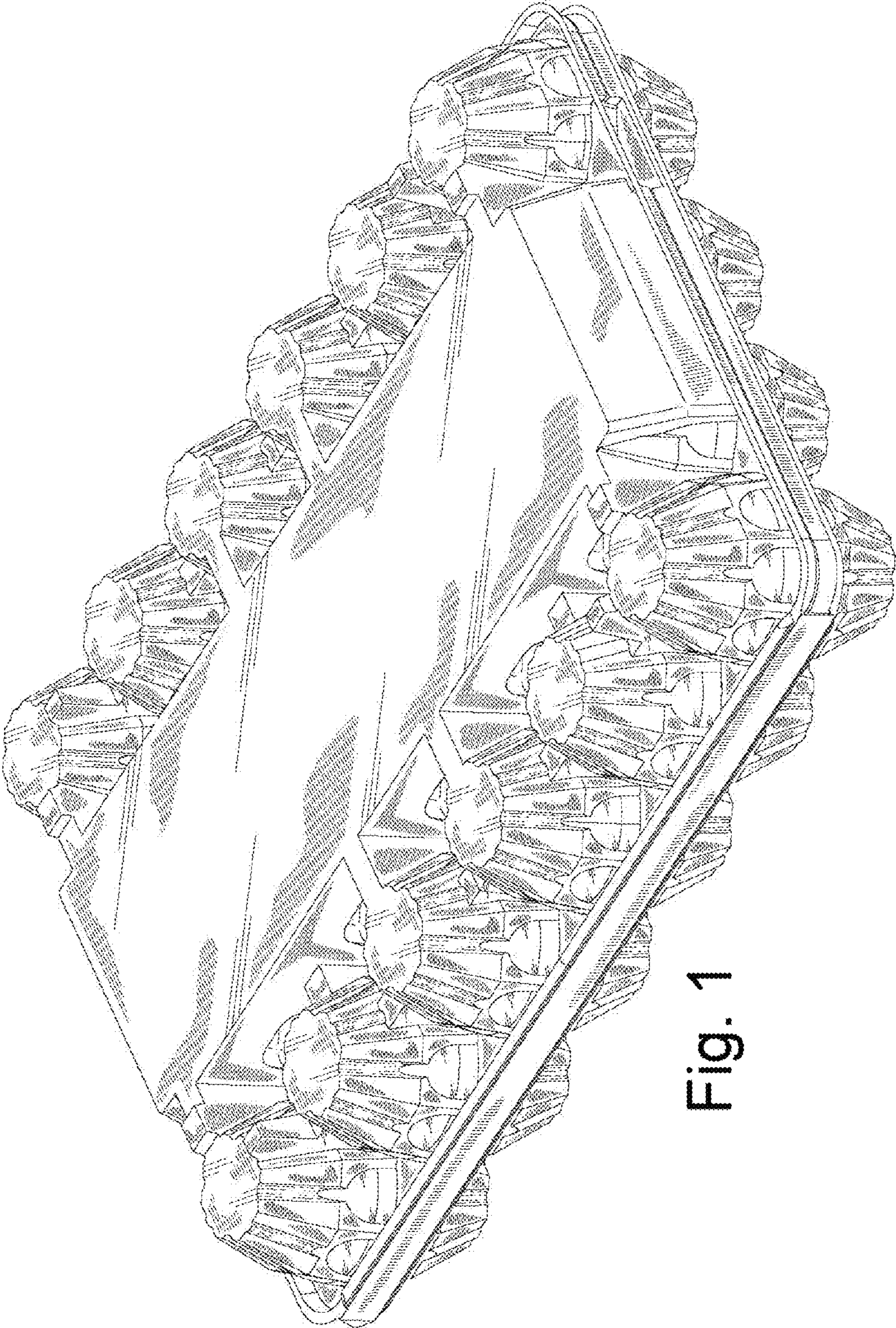

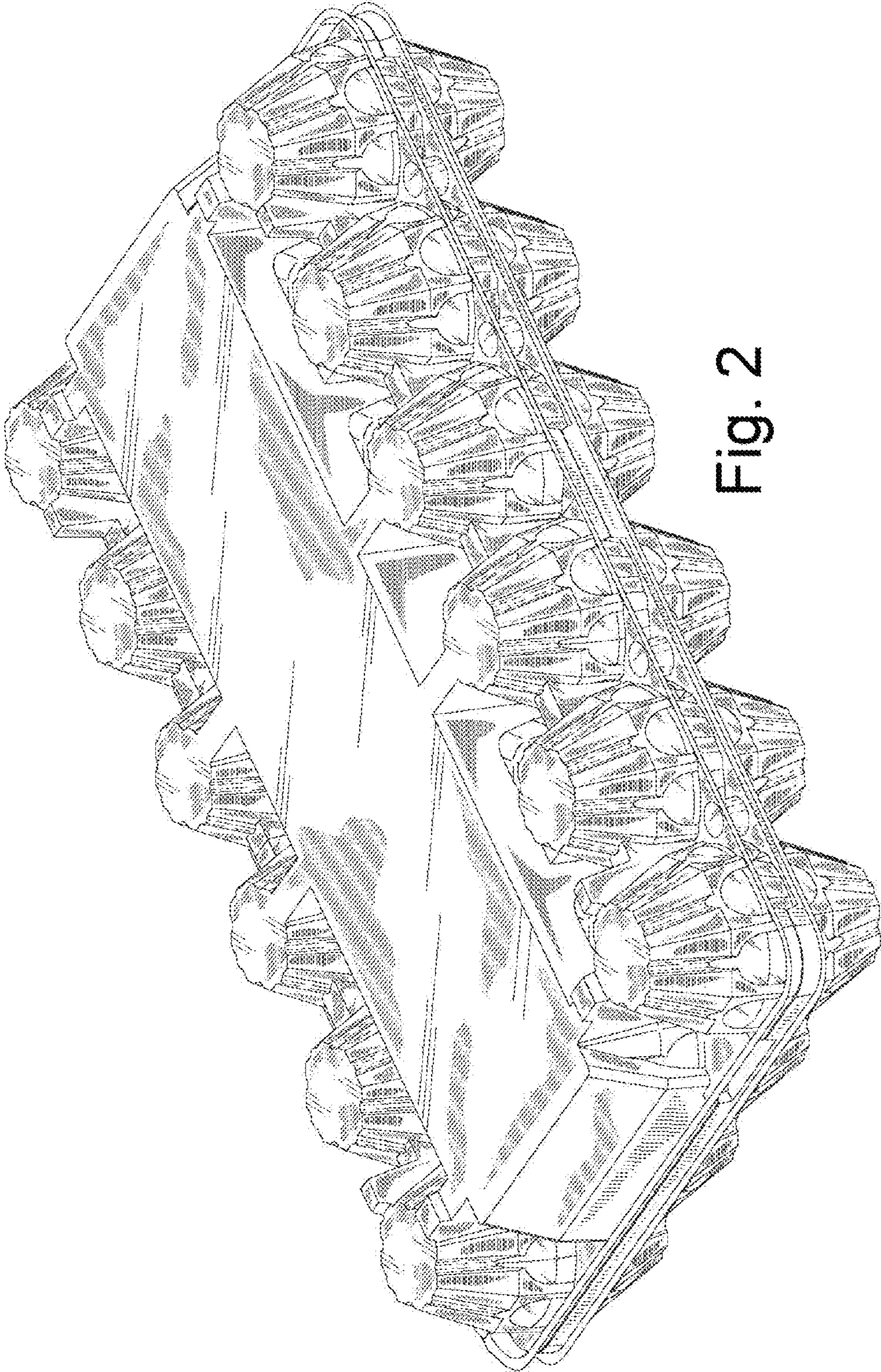

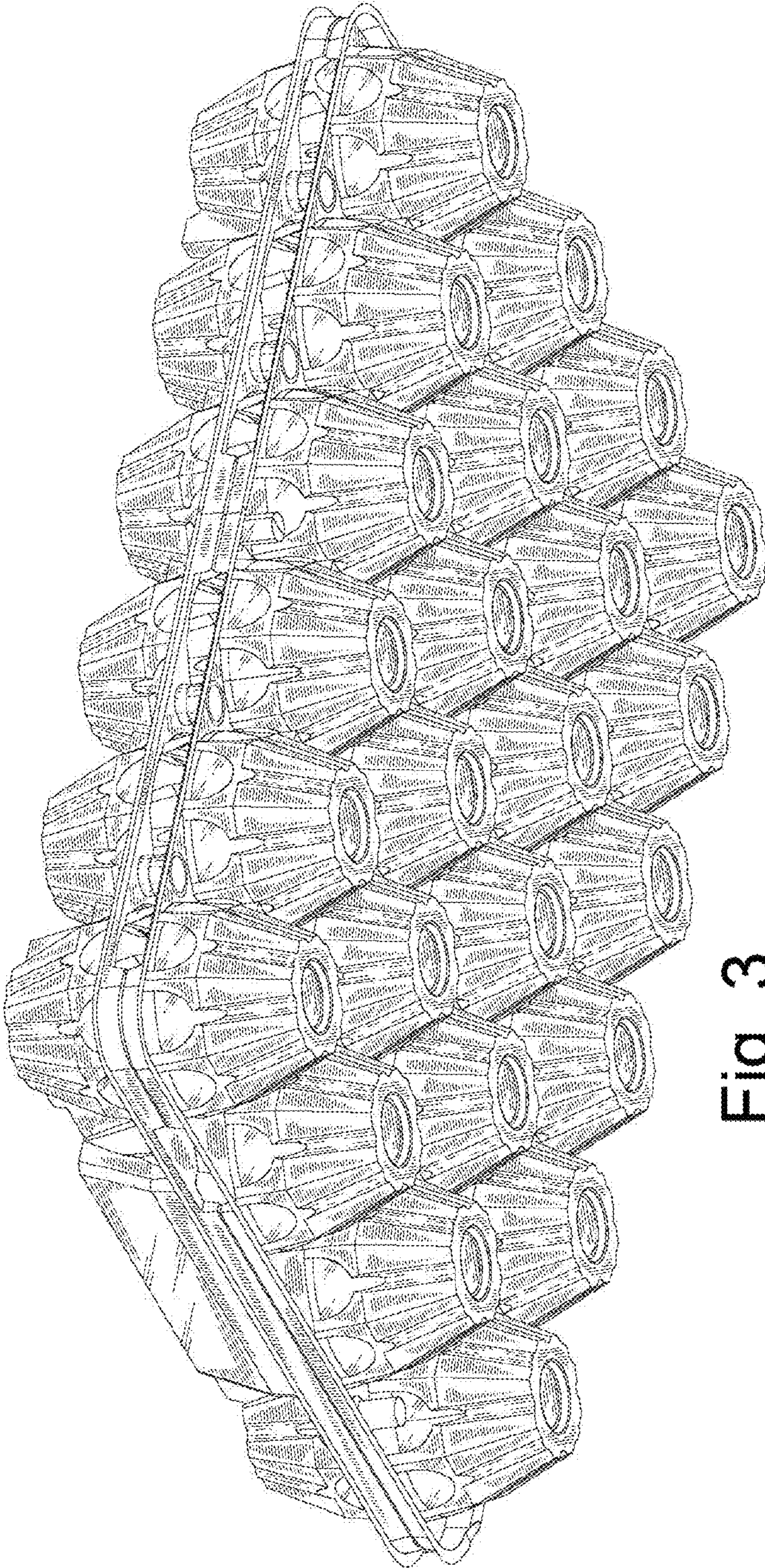

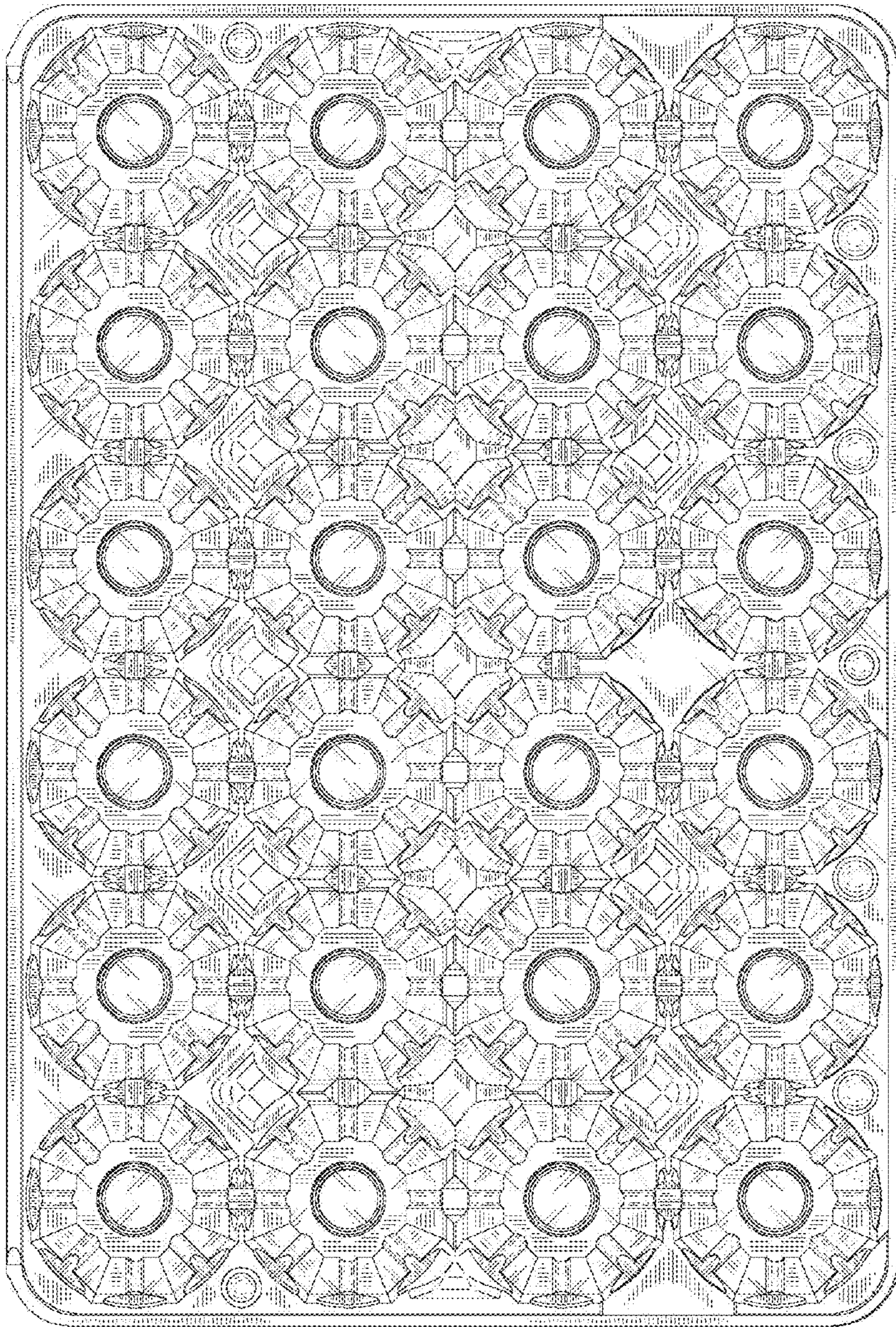

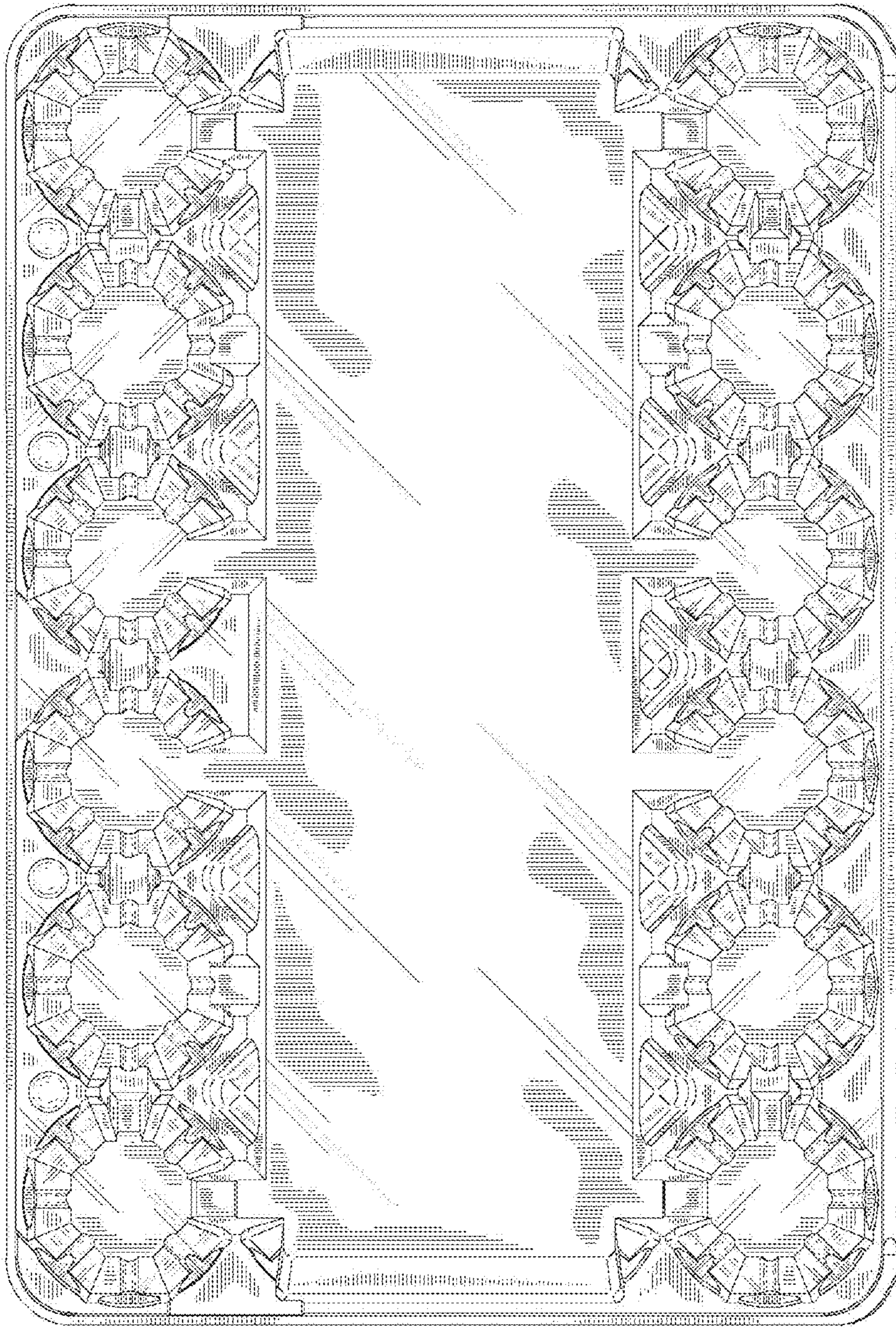

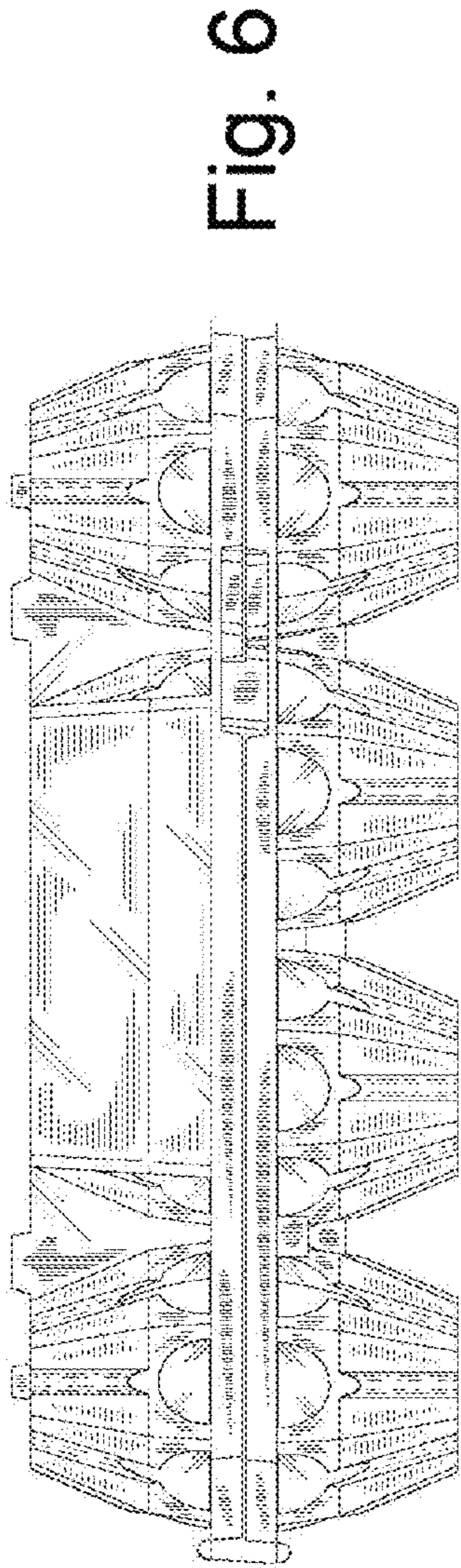

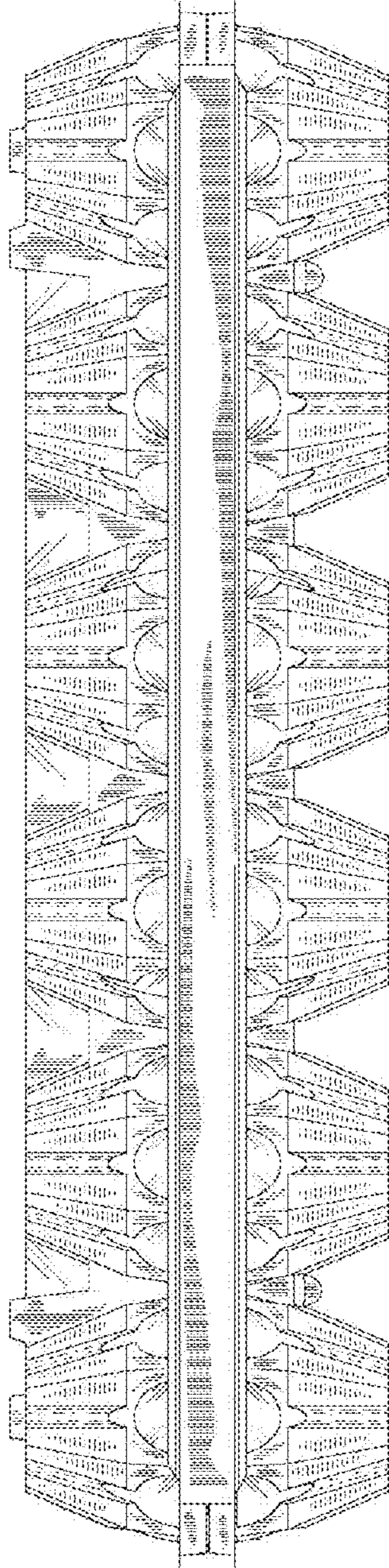

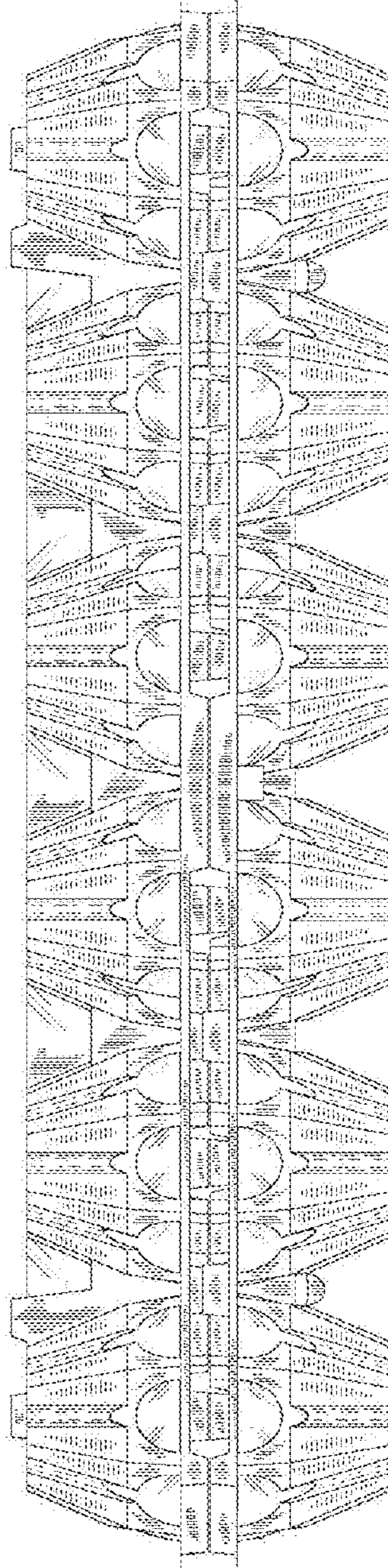
