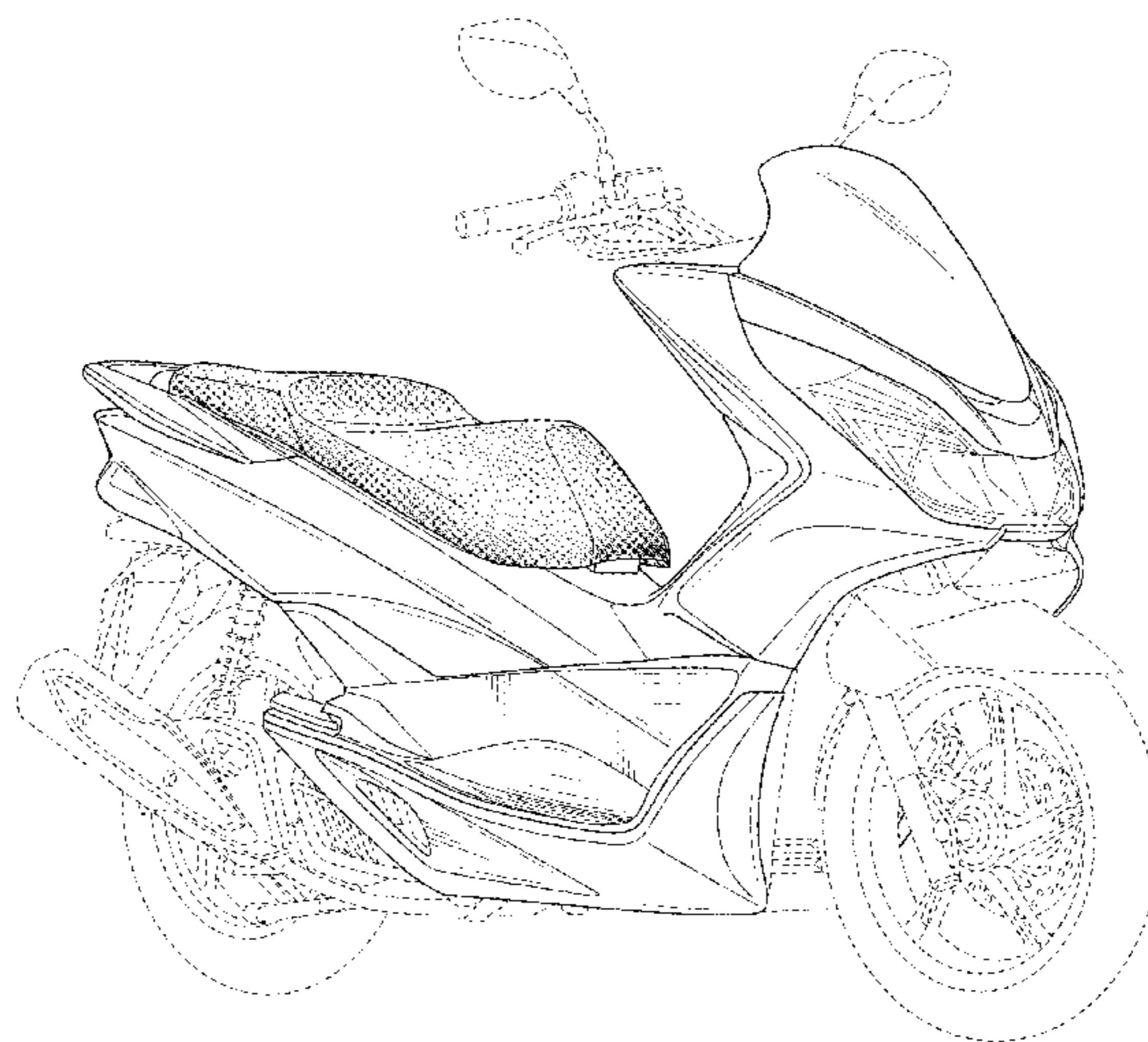
(57) **CLAIM**

The ornamental design for a motor scooter or motor scooter replica, as shown and described.

DESCRIPTION

FIG. 1 is a front and left-side perspective view of a motor scooter or motor scooter replica;
FIG. 2 is a rear and left-side perspective view thereof;
FIG. 3 is a front and right-side perspective view thereof;
FIG. 4 is a rear and right-side perspective view thereof;
FIG. 5 is a left side elevation view thereof;
FIG. 6 is a right side elevation view thereof;
FIG. 7 is a front elevation view thereof;
FIG. 8 is a rear elevation view thereof;
FIG. 9 is top plan view thereof; and,
FIG. 10 is a bottom plan view thereof.
The broken lines shown in the drawings illustrate portions of the motor scooter or motor scooter replica that forms no part of the claimed design.

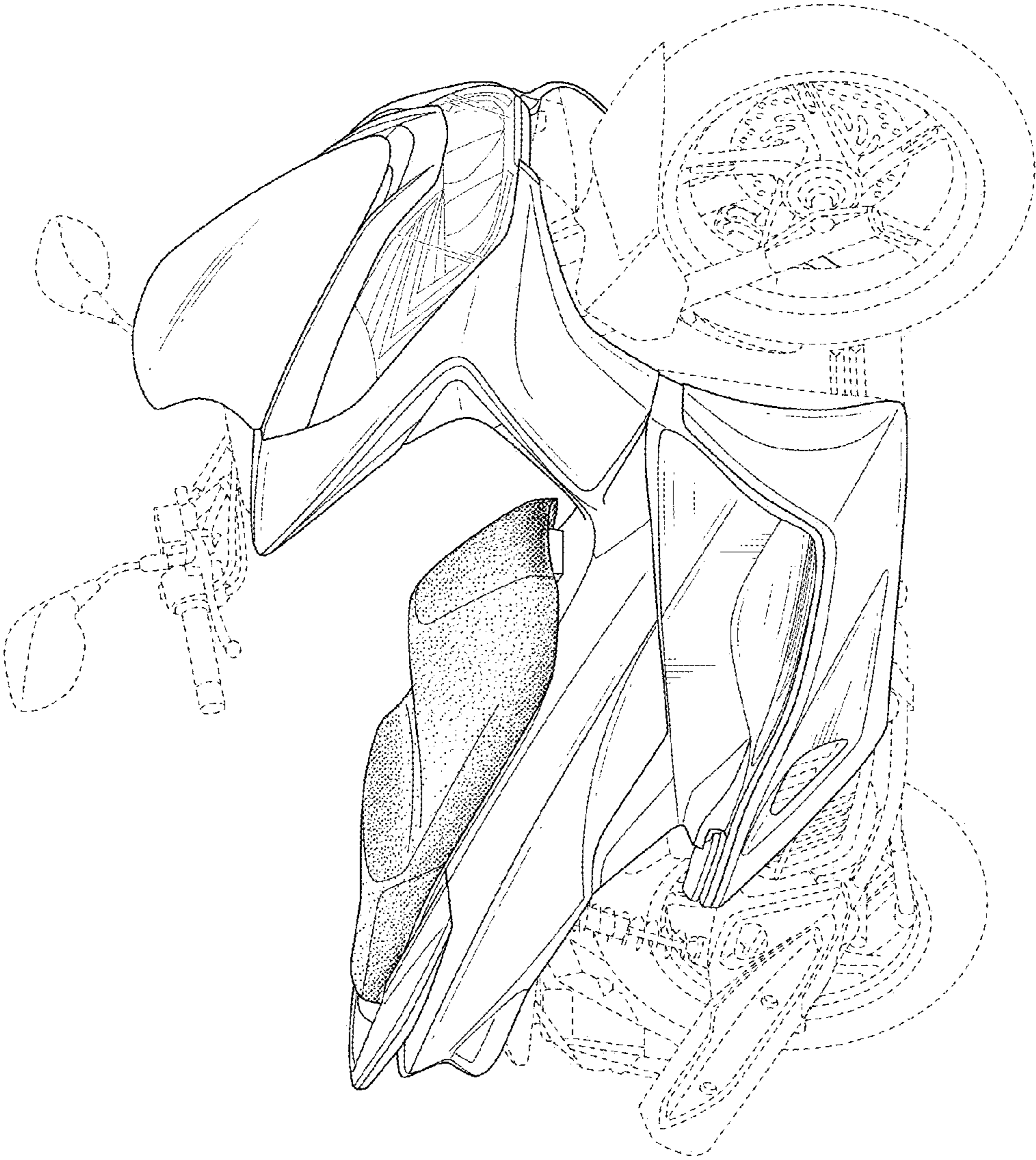

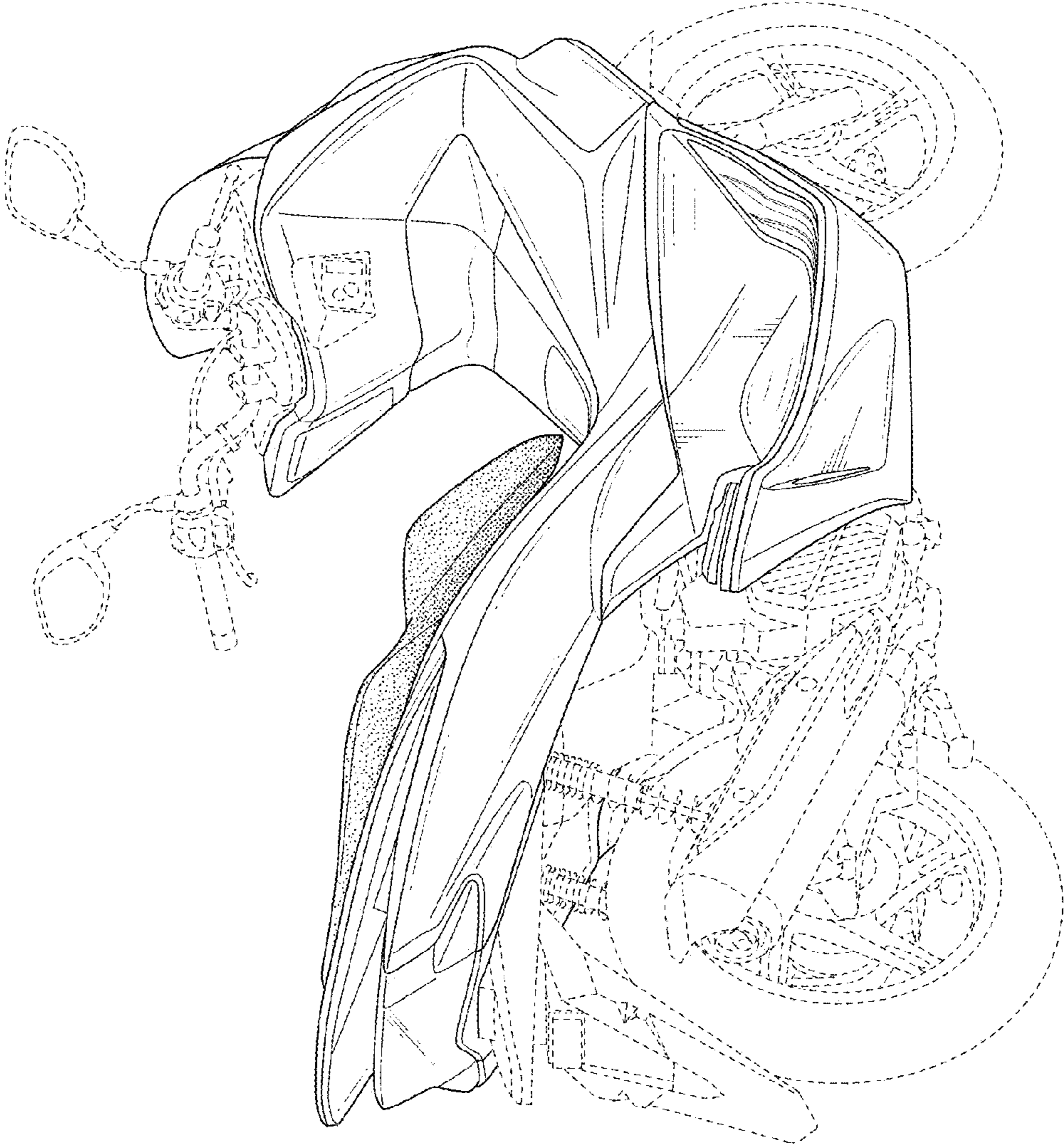

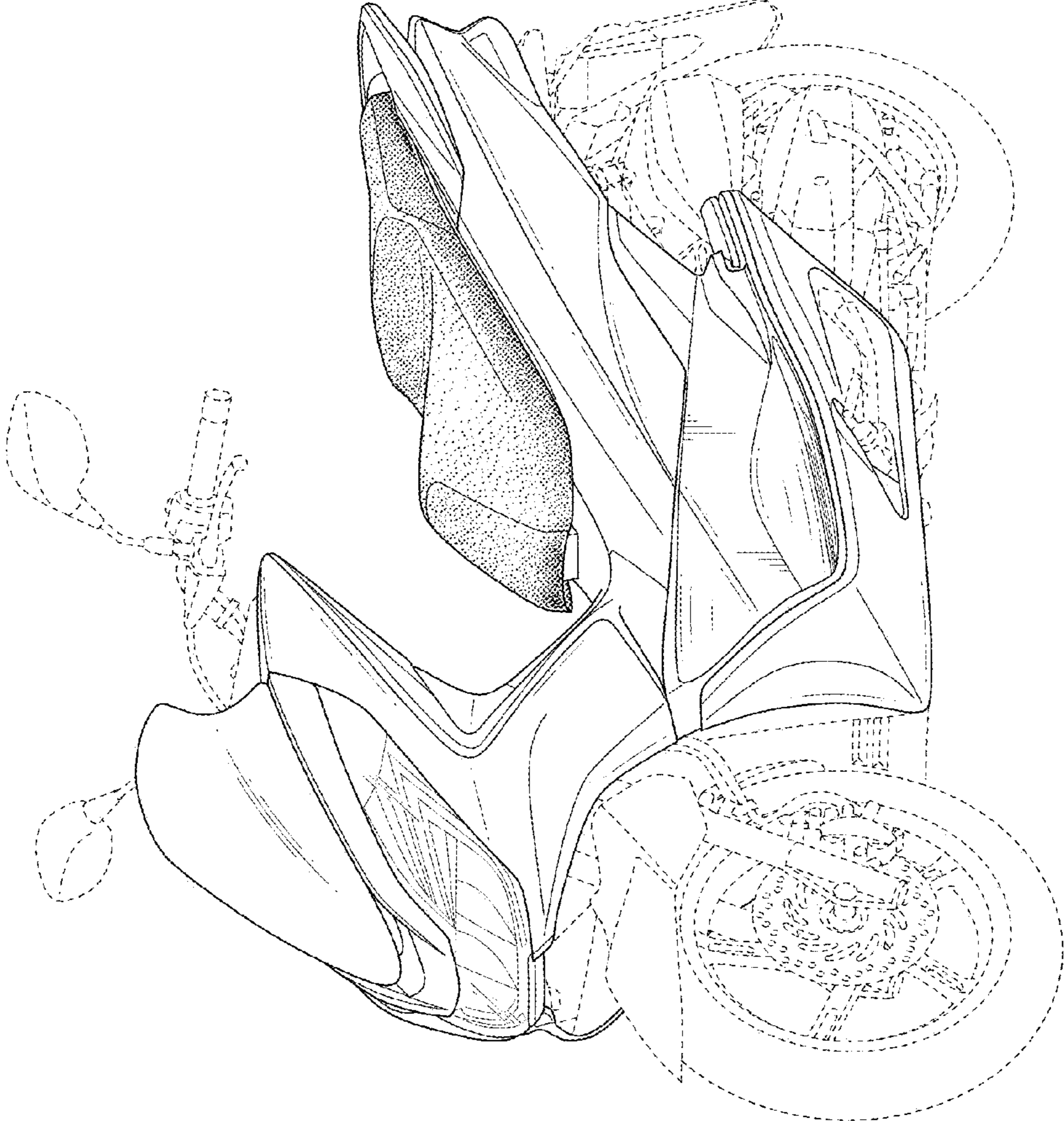

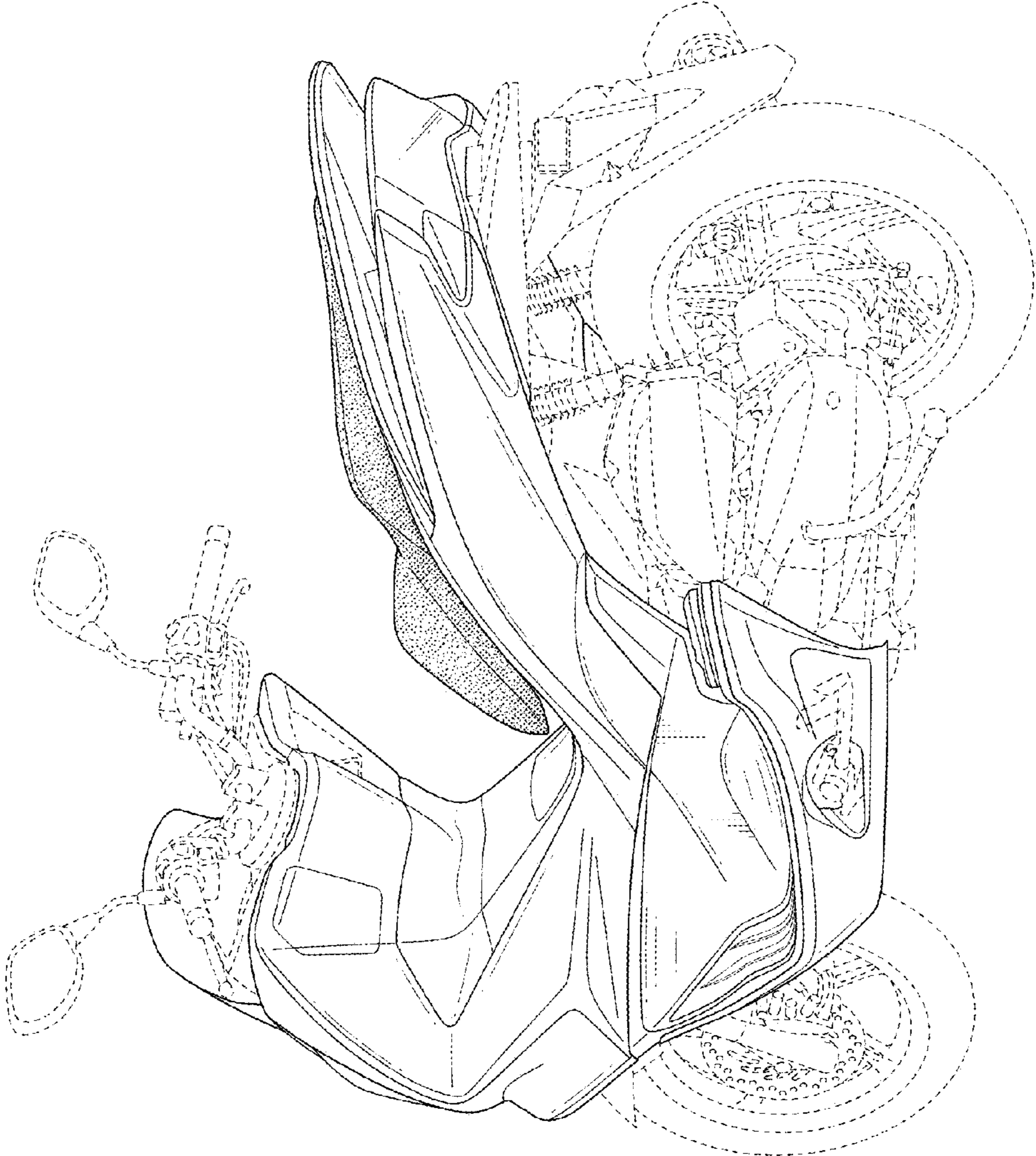

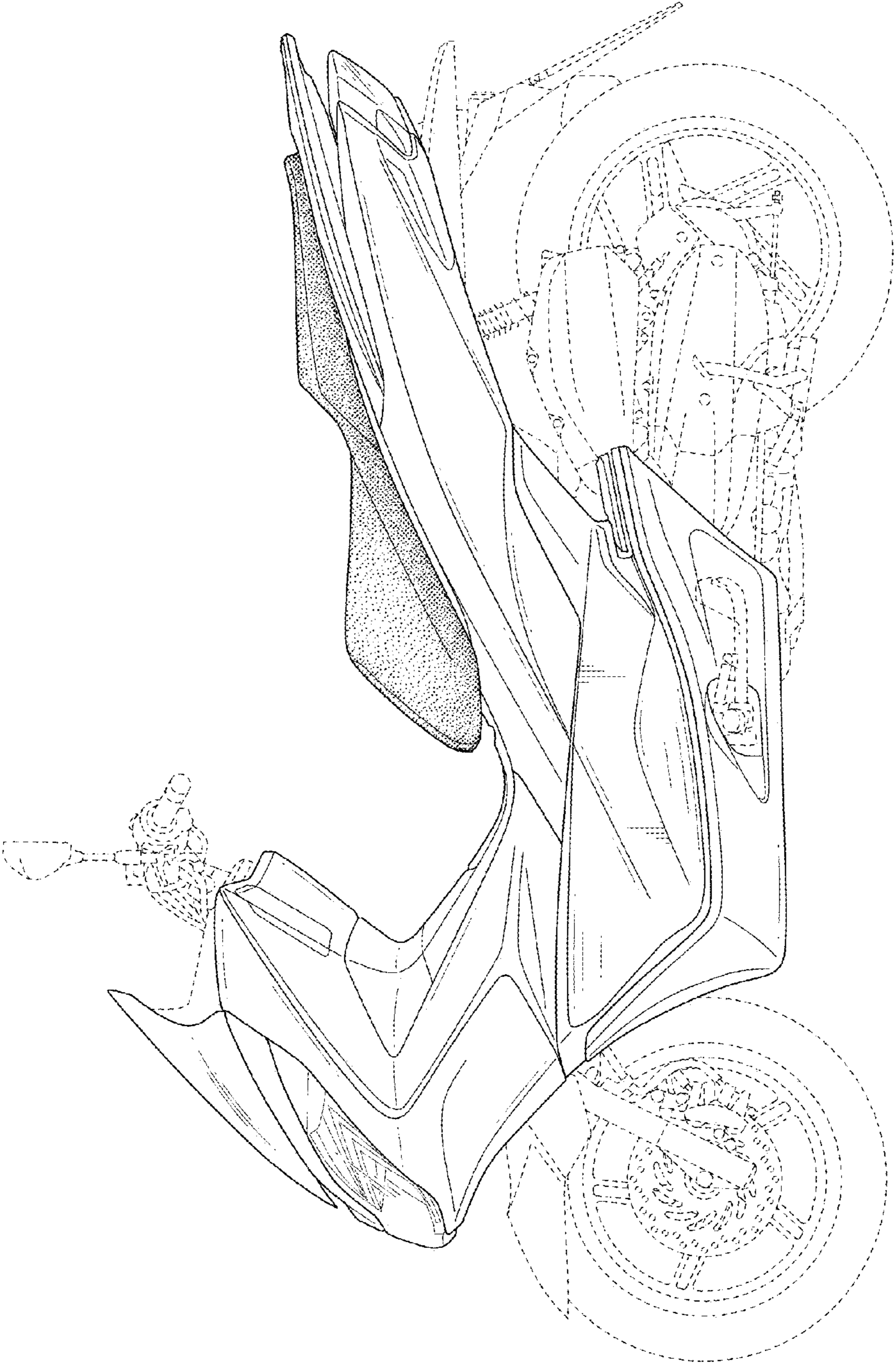

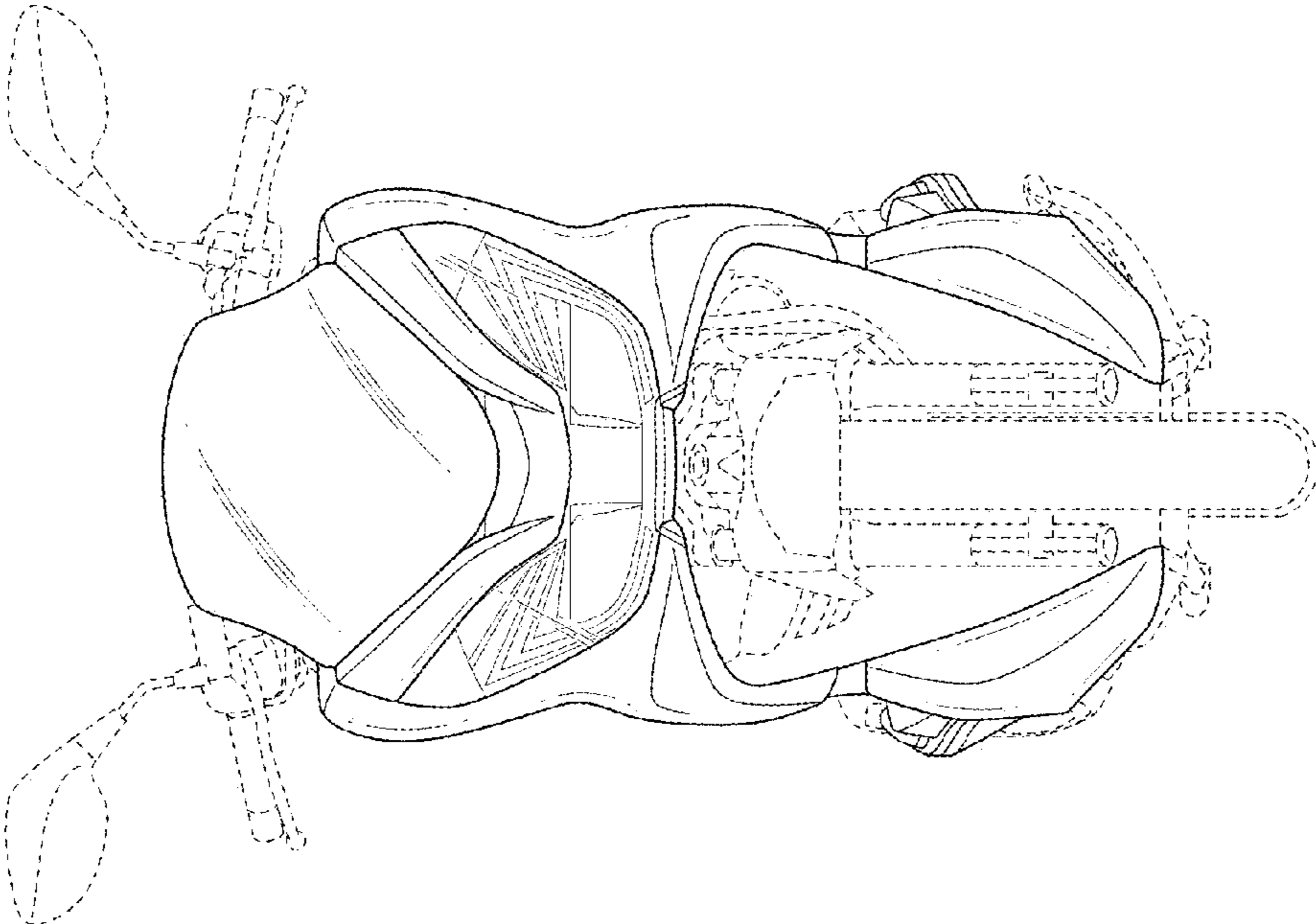

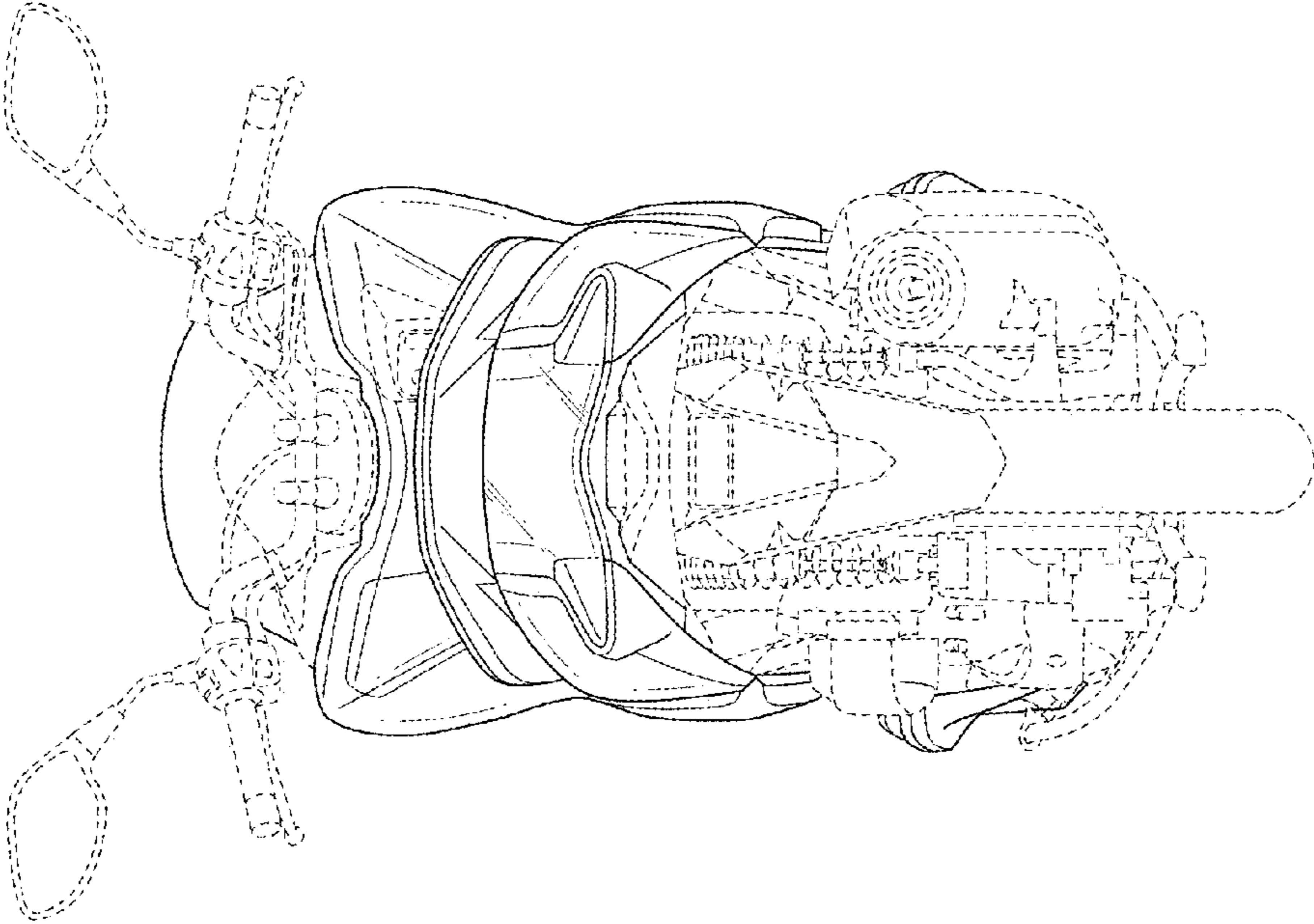

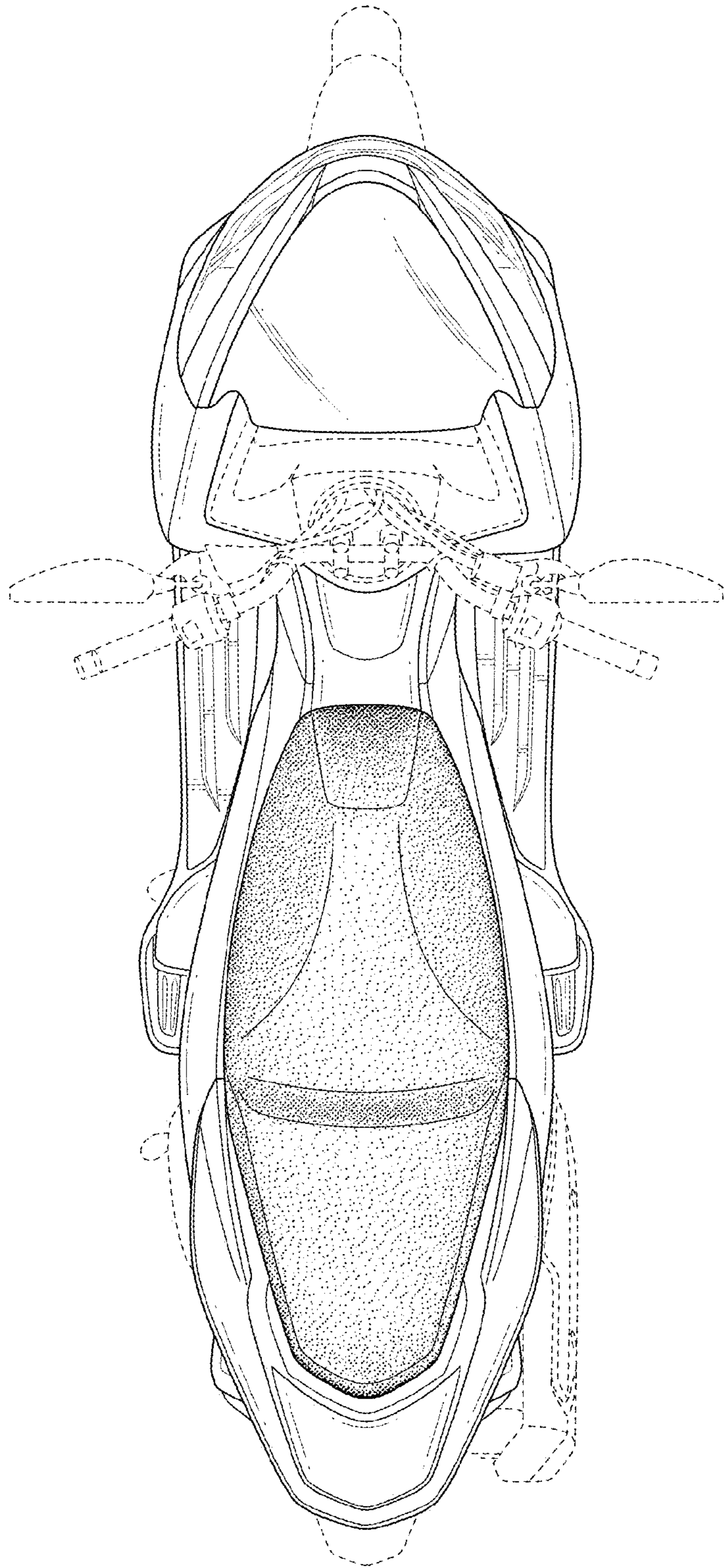
