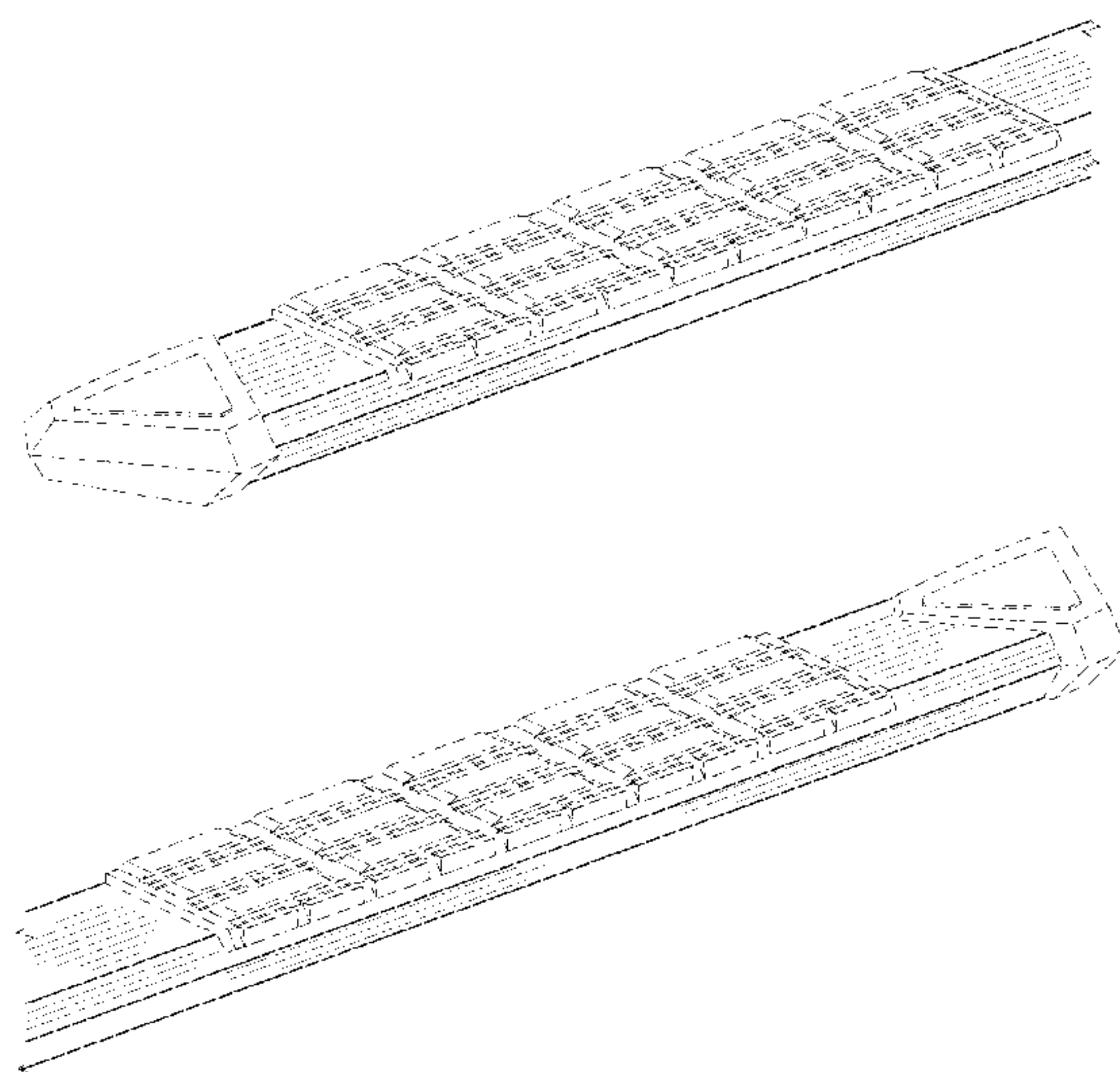

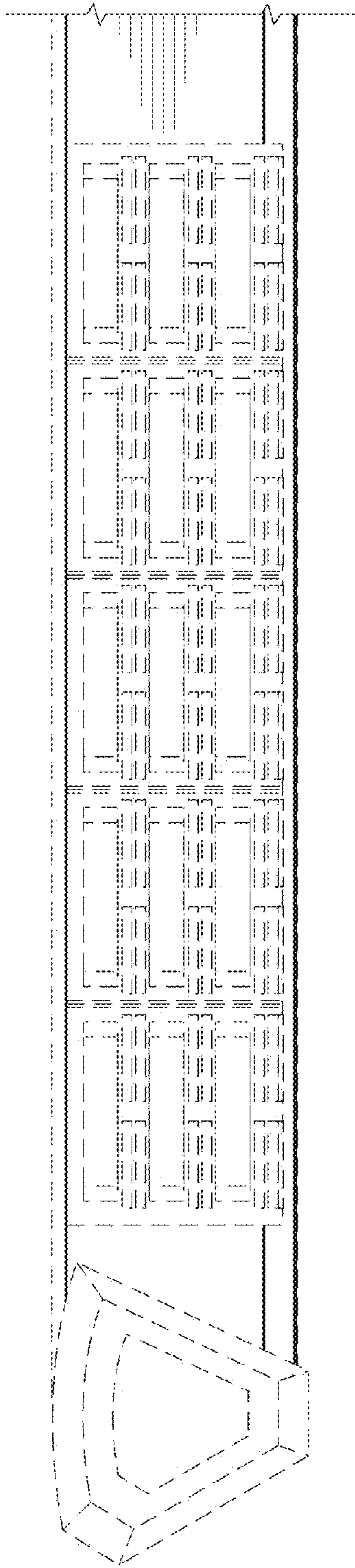
The ornamental design for a vehicle step rail, as shown and described.

**DESCRIPTION**

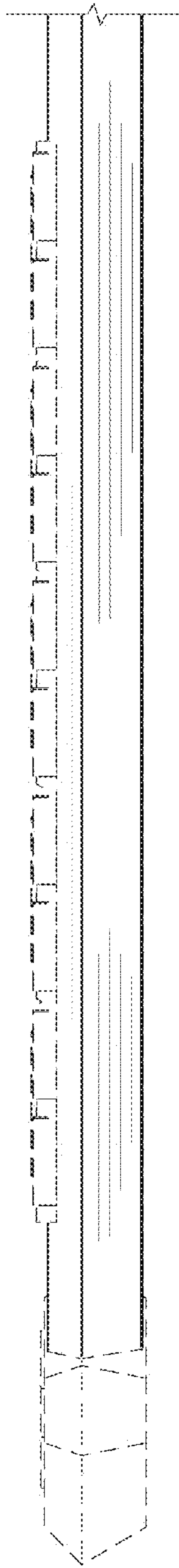
FIG. 1 is a front elevation view of the left side of a vehicle step rail, showing our new design;  
 FIG. 2 is a front elevation view of the right side of the vehicle step rail;  
 FIG. 3 is a top plan view thereof relative to FIG. 1;  
 FIG. 4 is a top plan view thereof relative to FIG. 2;  
 FIG. 5 is a bottom plan view thereof relative to FIG. 1;  
 FIG. 6 is a bottom plan view thereof relative to FIG. 2;  
 FIG. 7 is a left side elevation view thereof, at an enlarged scale, the right side elevation view being the mirror opposite thereto;  
 FIG. 8 is a rear elevation view thereof, at a greatly reduced scale;  
 FIG. 9 is a perspective view thereof, showing the front, top, and left side;  
 FIG. 10 is a perspective view thereof, showing the front, top, and right side; and,  
 FIG. 11 is an end view of the rail portion of the vehicle step rail of FIG. 1.  
 The broken lines shown in the drawing figures represent portions of the vehicle step rail that form no part of the claimed design.

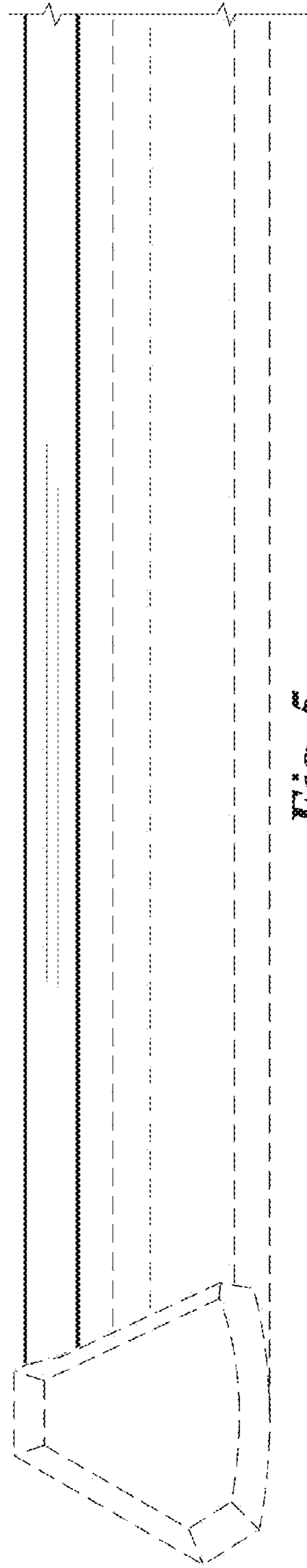




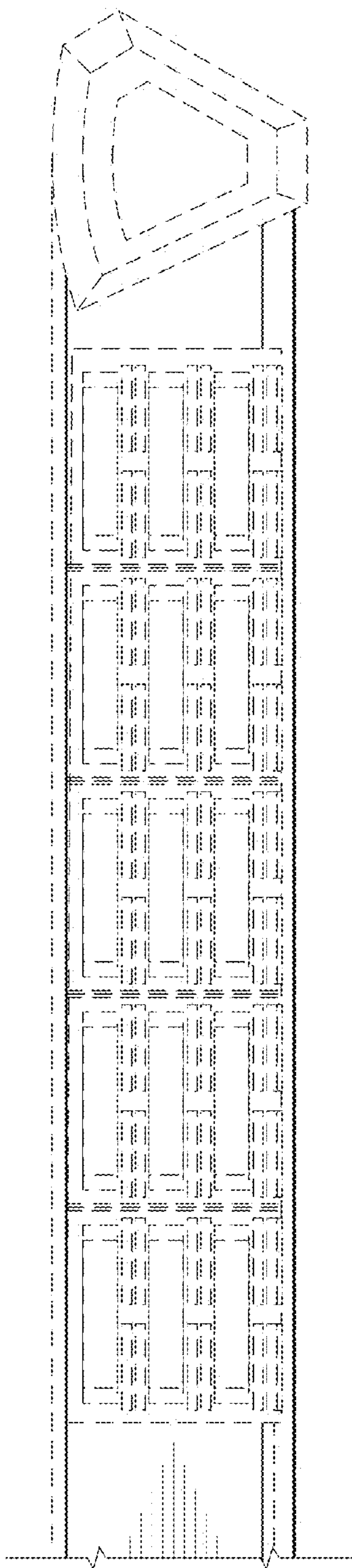

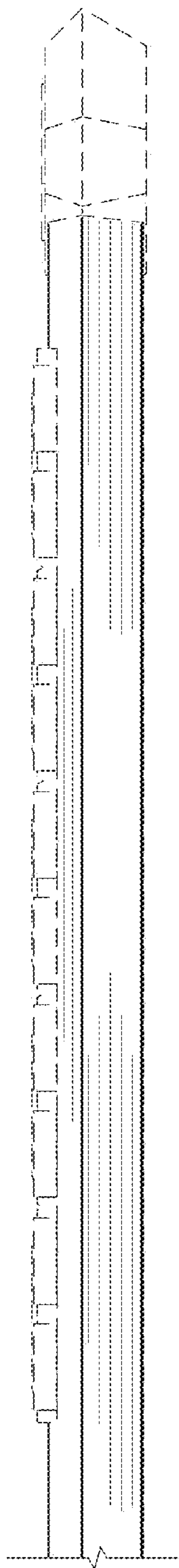

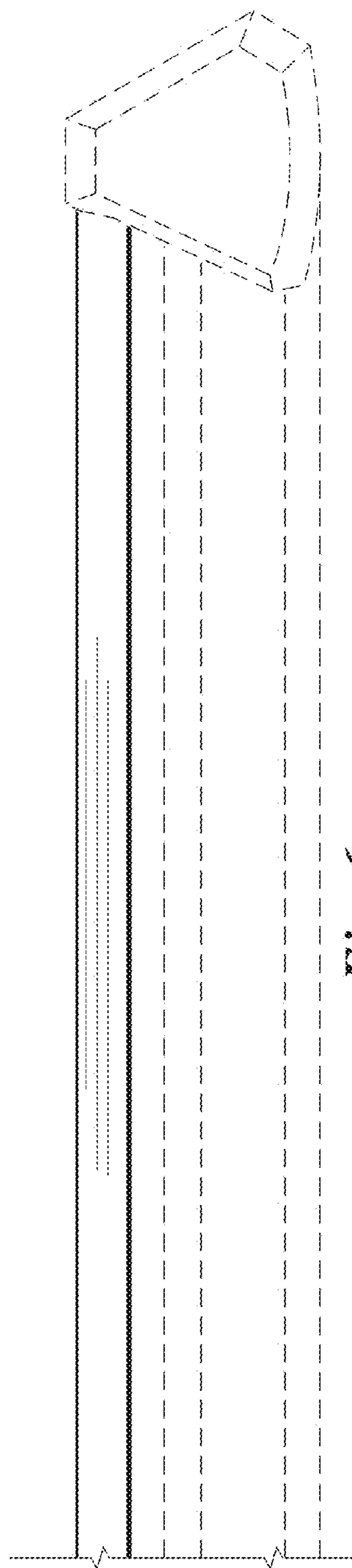

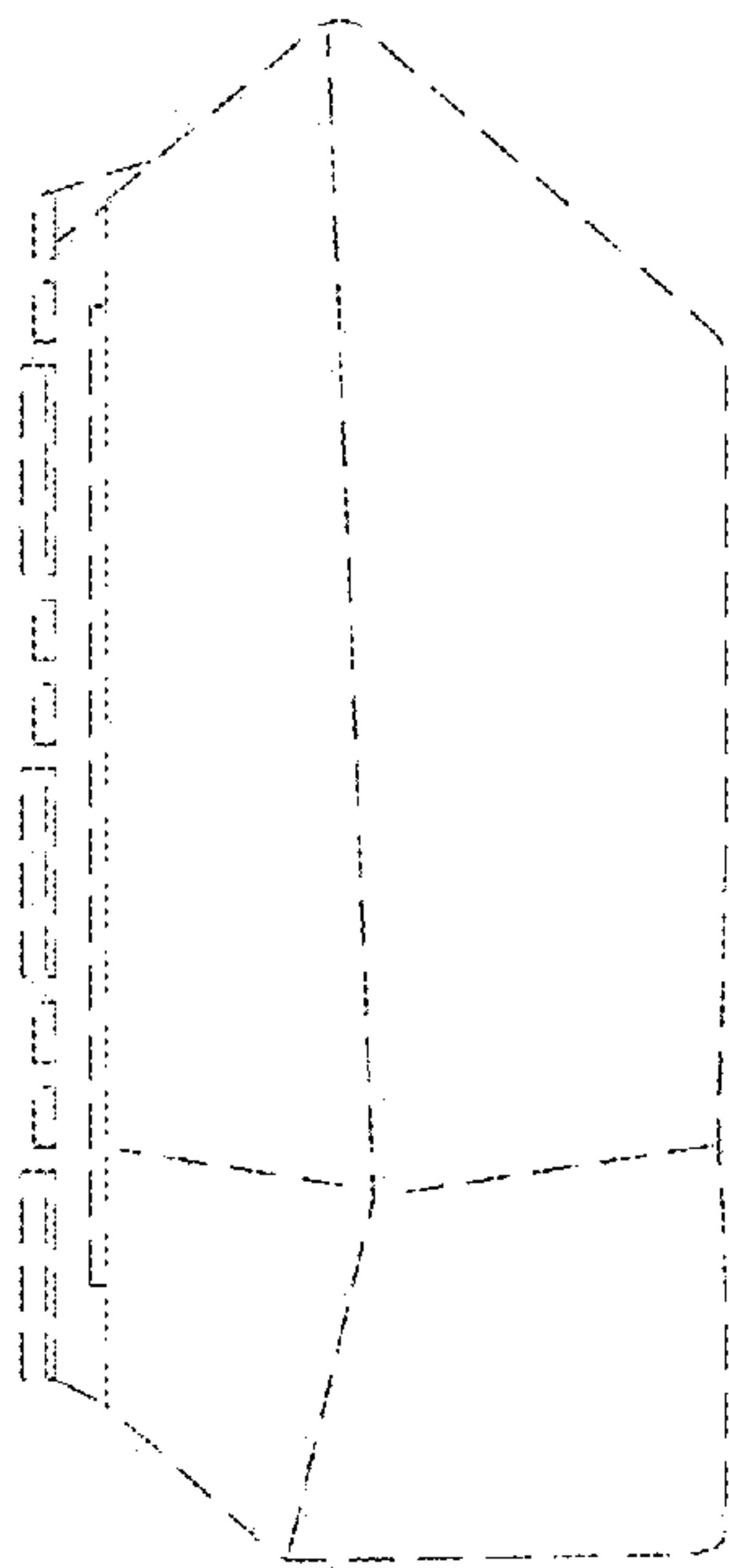

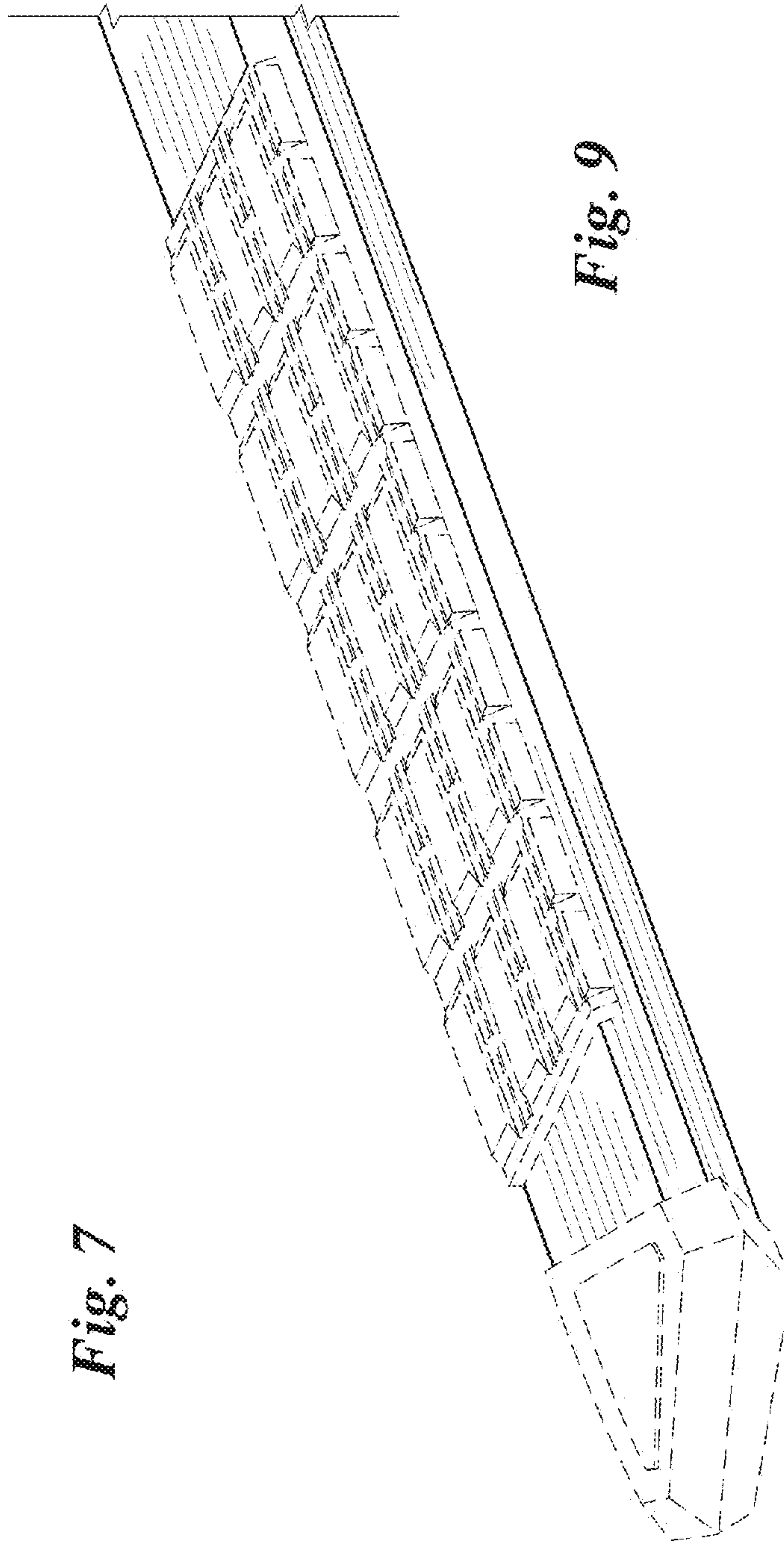

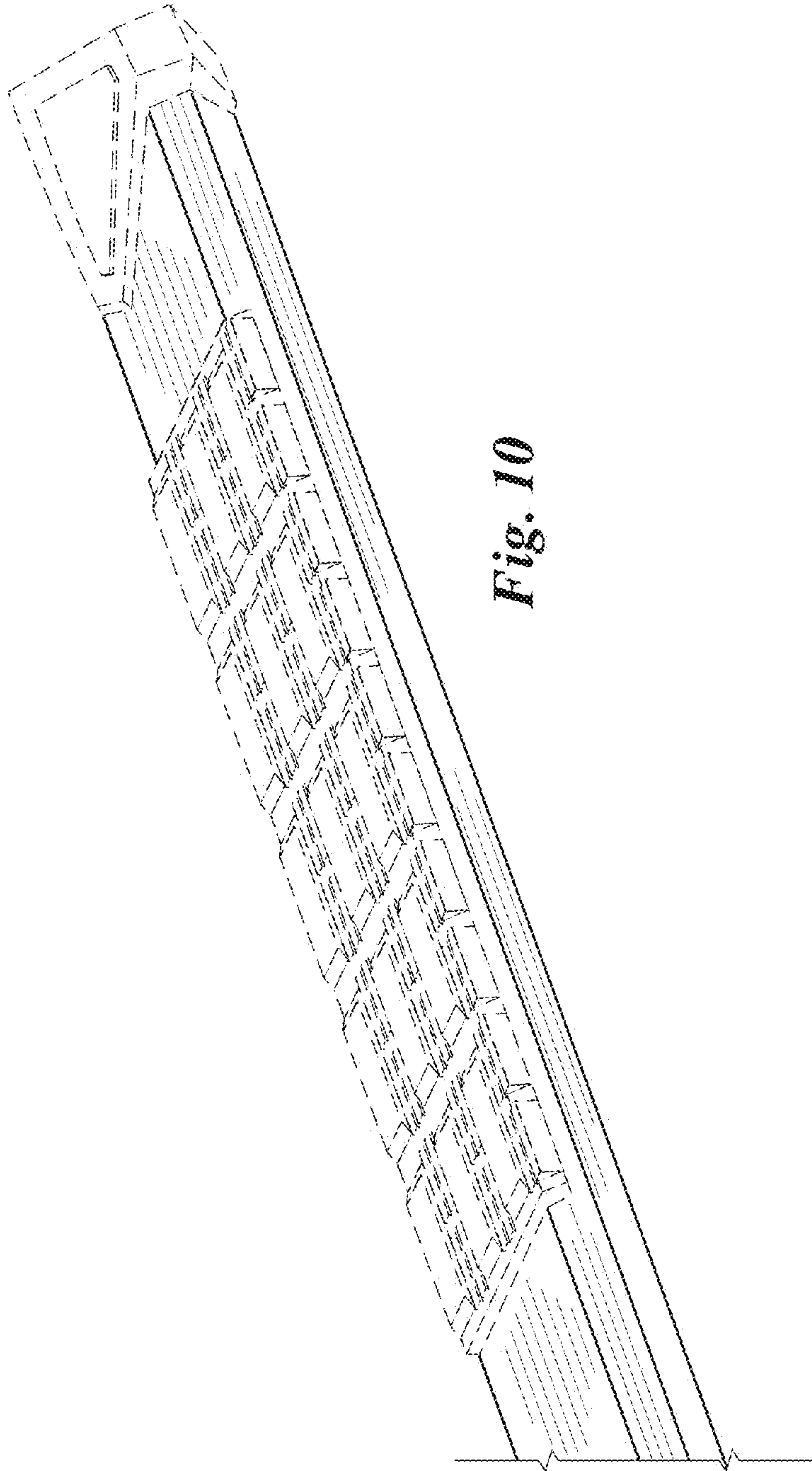




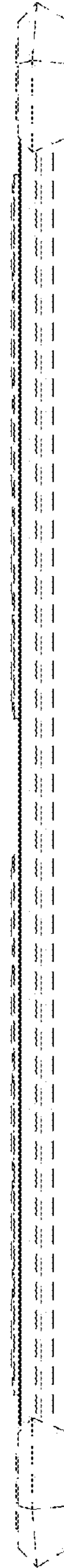

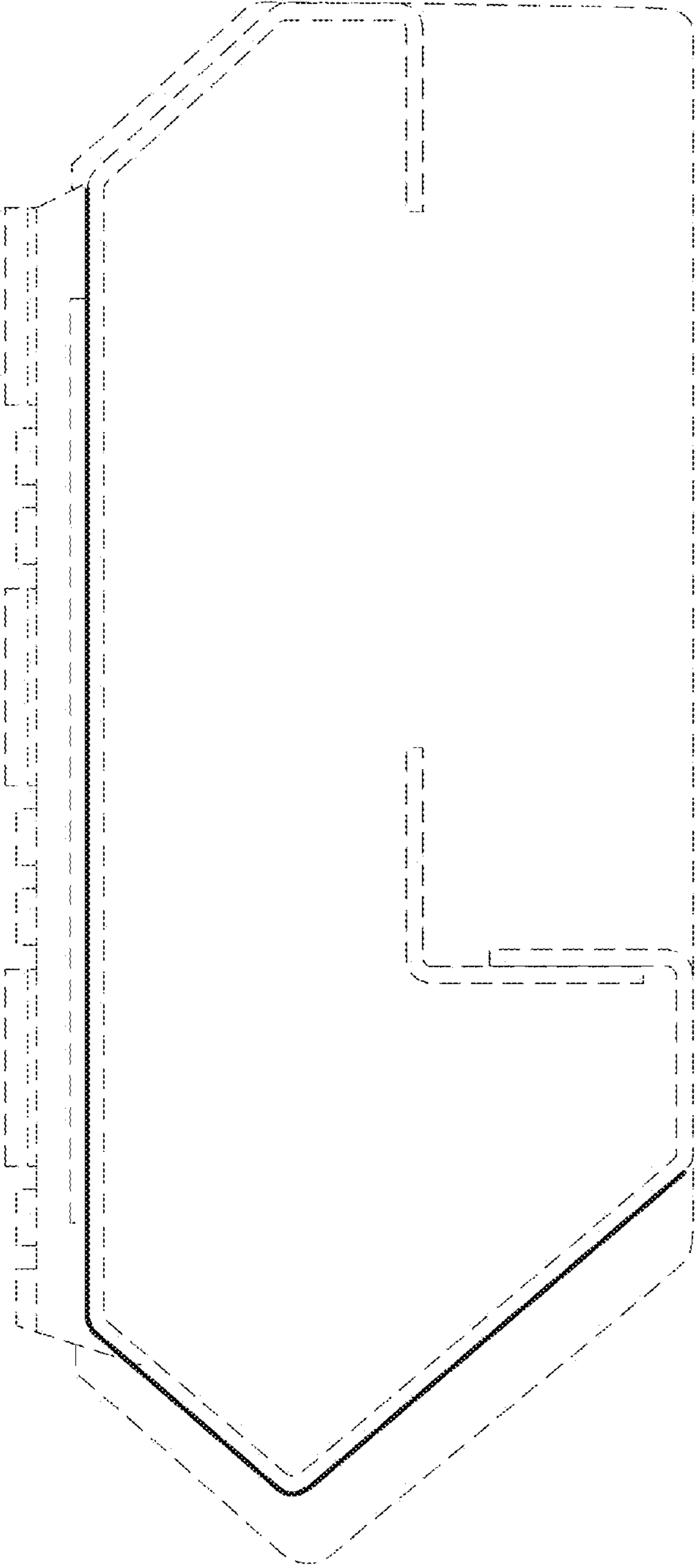
