(57) **CLAIM** The ornamental design for a "wheel with flame design," as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a wheel with flame design, showing my new design, illustrating a wheel having a pair of decorative outer support structures and a decorative inner structure positioned between the decorative outer support structures; FIG. 2 is a front elevational view thereof, illustrating the decorative inner structure locked in a position behind one of the decorative outer support structures; FIG. 3 is a perspective view of one of the decorative outer support structures, the outer support structure being shown apart from the entire wheel for ease of illustration; FIG. 4 is a perspective view of the decorative inner structure, the decorative inner structure being shown apart from the entire wheel for ease of illustration; FIG. 5 is a left side elevational view thereof, with the right side elevational view, the top plan view, and the bottom plan view being mirror images thereof; FIG. 6 is a rear elevational view thereof; FIG. 7 is a front elevational view of the wheel, illustrating the decorative inner structure locked in a first position with respect to the decorative outer support structures; FIG. 8 is a front elevational view of the wheel, illustrating the decorative inner structure locked in a second position with respect to the decorative outer support structures; FIG. 9 is a front elevational view of the wheel, illustrating the decorative inner structure locked in a third position with respect to the decorative outer support structures; FIG. 10 is a front elevational view of the wheel, illustrating the decorative inner structure locked in a fourth position with respect to the decorative outer support structures; FIG. 11 is a front elevational view of the wheel, illustrating the decorative inner structure locked in a fifth position with respect to the decorative outer support structures; FIG. 12 is a front elevational view of the wheel, illustrating the decorative inner structure locked in a sixth position with respect to the decorative outer support structures;

FIG. 13 is a front elevational view of the wheel, illustrating the decorative inner structure locked in a seventh position with respect to the decorative outer support structures; FIG. 14 is a front elevational view of the wheel, illustrating the decorative inner structure locked in an eighth position with respect to the decorative outer support structures; FIG. 15 is a front elevational view of the wheel, illustrating the decorative inner structure locked in a ninth position with respect to the decorative outer support structures; FIG. 16 is a front elevational view of the wheel, illustrating the decorative inner structure locked in a tenth position with respect to the decorative outer support structures; FIG. 17 is a front elevational view of the wheel, illustrating the decorative inner structure locked in an eleventh position with respect to the decorative outer support structures; FIG. 18 is a front elevational view of the wheel, illustrating the decorative inner structure locked in a twelfth position with respect to the decorative outer support structures;

FIG. **19** is a front elevational view of the wheel, illustrating the decorative inner structure locked in a thirteenth position with respect to the decorative outer support structures; FIG. **20** is a front elevational view of the wheel, illustrating the decorative inner structure locked in a fourteenth position with respect to the decorative outer support structures; and, FIG. **21** is a front elevational view of the wheel, illustrating the decorative inner structure locked in a fifteenth position with respect to the decorative outer support structures. As illustrated in FIGS. **1-21**, by locking the decorative inner structure in different positions relative to the decorative outer

support structures, a different ornamental appearance is achieved.
