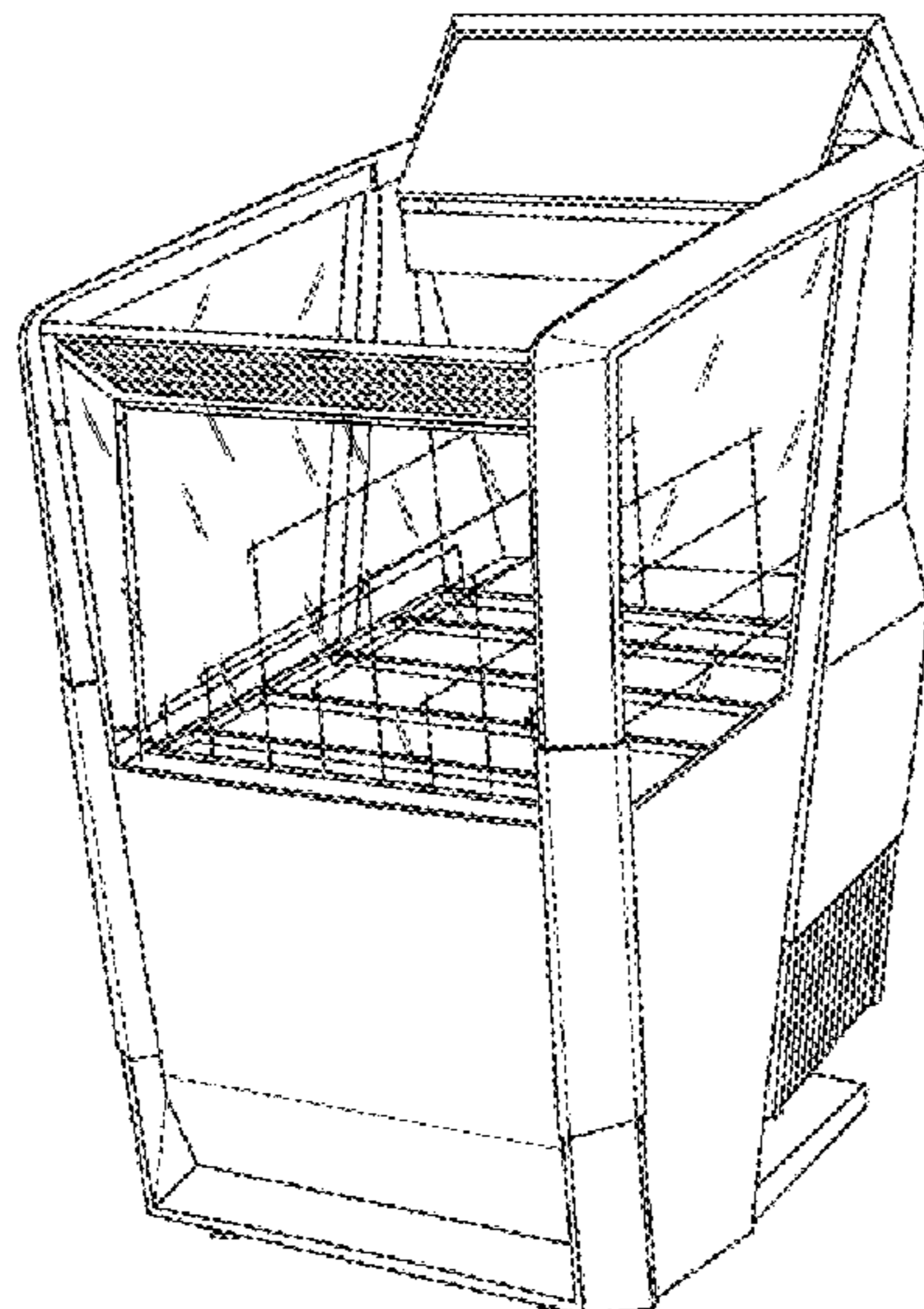
(57) **CLAIM**

The ornamental design for a refrigerated cooler, as shown and described.

DESCRIPTION

FIG. 1 is the front right side perspective view of the refrigerated cooler according to the present invention; FIG. 2 is a right side view of the refrigerated cooler as shown in FIG. 1; The left side view of the refrigerated cooler is a mirror image of the right side view, and therefore omitted; FIG. 3 is a top view of the refrigerated cooler as shown in FIG. 1; and, FIG. 4 is a front view of the refrigerated cooler as shown in FIG. 1. The bottom and back views of the refrigerated cooler form no part of the claimed design and are omitted. Applicant disclaims any reflections shown on the surfaces of the refrigerated cooler.

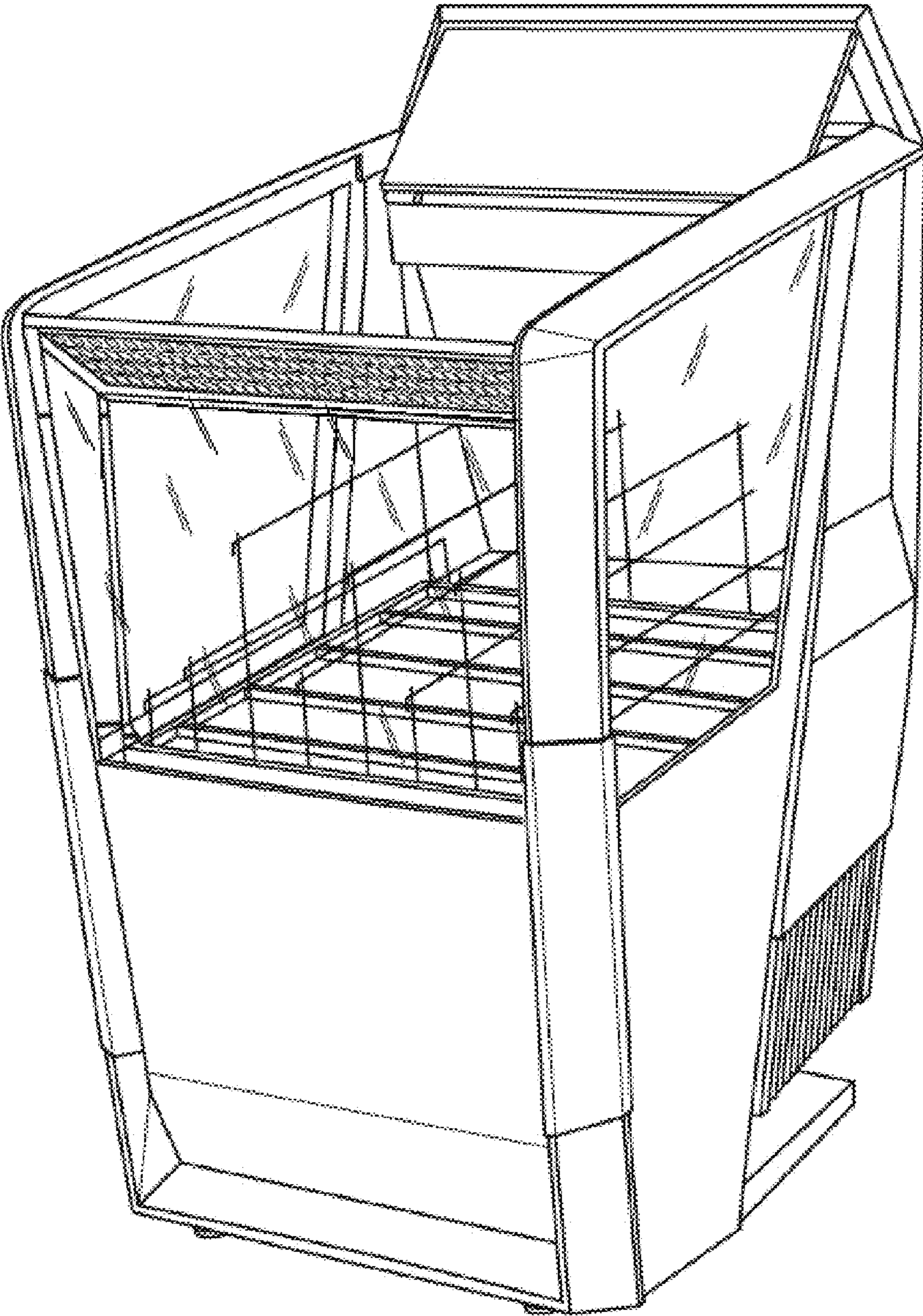

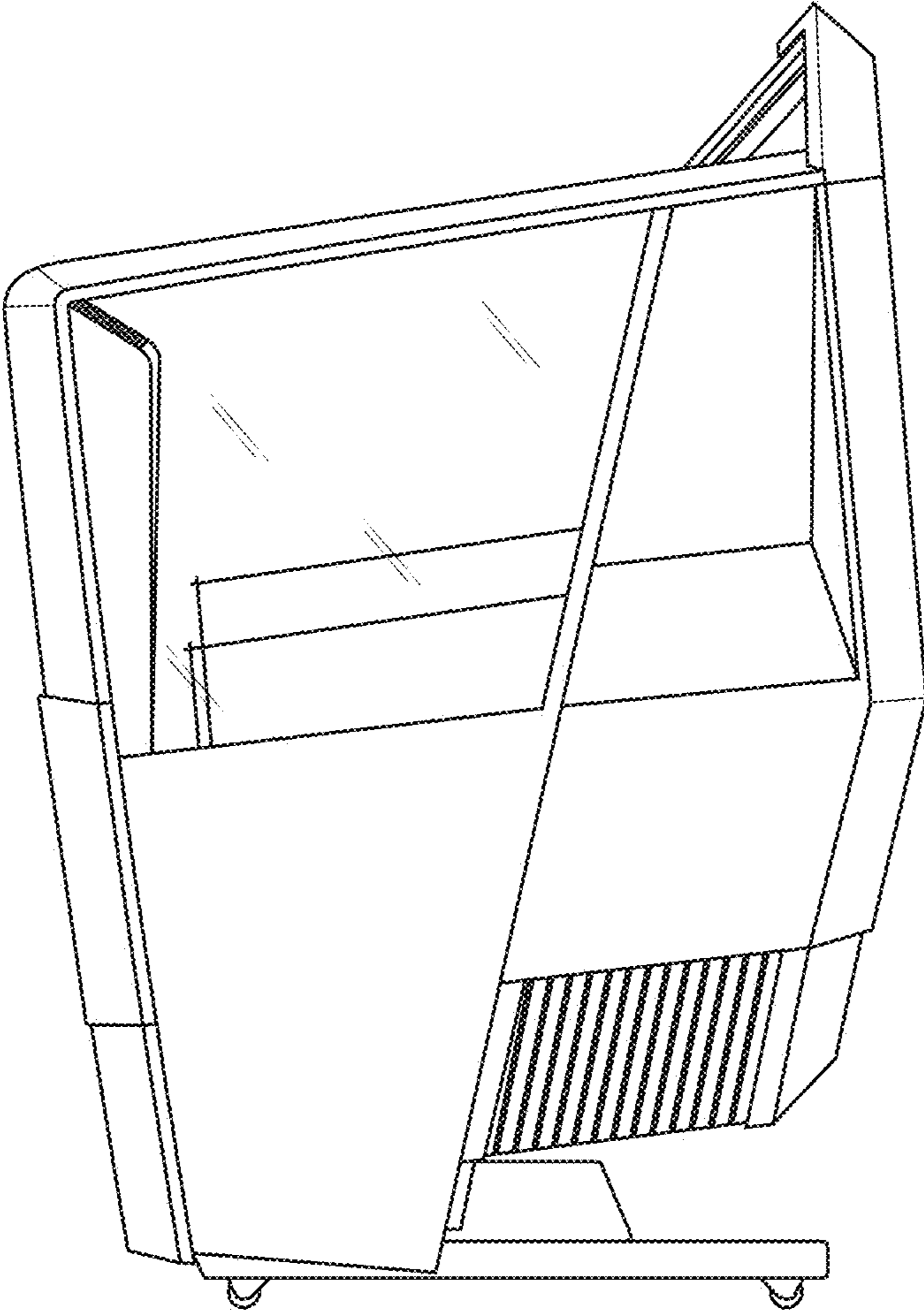

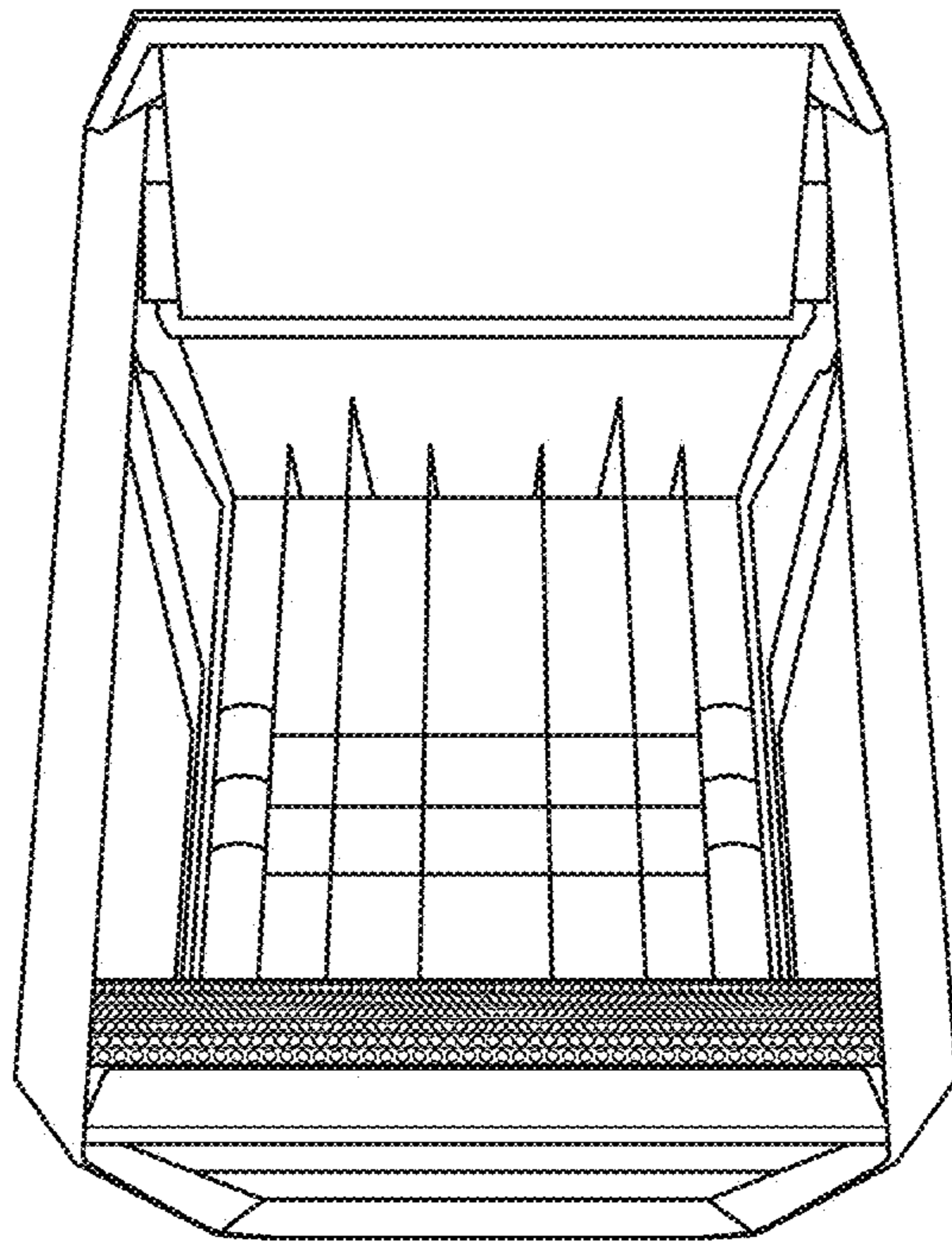

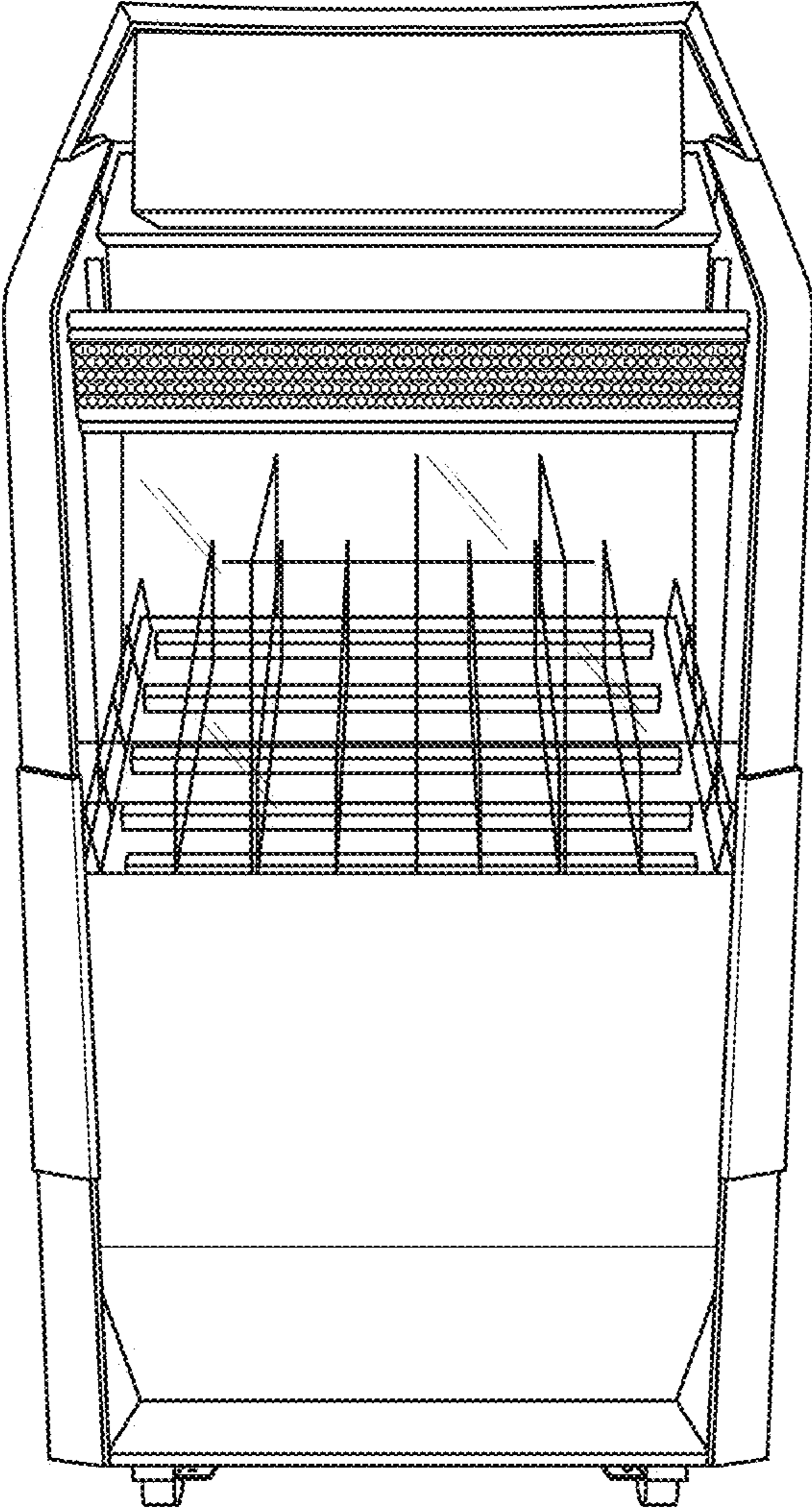
