(57) **CLAIM**

We claim the ornamental design for pad of file folders, as shown and described.

DESCRIPTION

FIG. 1 is a front/right/top perspective view of a first embodiment of a pad of file folders;

FIG. 2 is a front/left/top perspective view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a left side elevational view thereof;

FIG. 7 is a top plan view thereof; and,

FIG. 8 is a bottom plan view thereof.

FIG. 9 is a front/left/top perspective view of the first embodiment, with a corner slightly curled to expose the file folder beneath;

FIG. 10 is a front/right/top perspective view of the second embodiment showing a ruled file folder from the pad of file folders;

FIG. 11 is a front/left/top perspective view thereof;

FIG. 12 is a front elevational view thereof;

FIG. 13 is a rear elevational view thereof;

FIG. 14 is a top plan view thereof;

FIG. 15 is a bottom plan view thereof;

FIG. 16 is a right side elevational view thereof; and

FIG. 17 is a left side elevational view thereof.

FIG. 18 is a front/left/top perspective view of the second embodiment, with a corner curled down to expose the interior of the ruled file folder;

FIG. 19 is a front/right/top perspective view of the third embodiment showing a ruled file folder from the pad of file folders;

FIG. 20 is a front/left/top perspective view thereof;

FIG. 21 is a front elevational view thereof;

FIG. 22 is a rear elevational view thereof;

FIG. 23 is a top plan view thereof;

FIG. 24 is a bottom plan view thereof;

FIG. 25 is a right side elevational view thereof; and

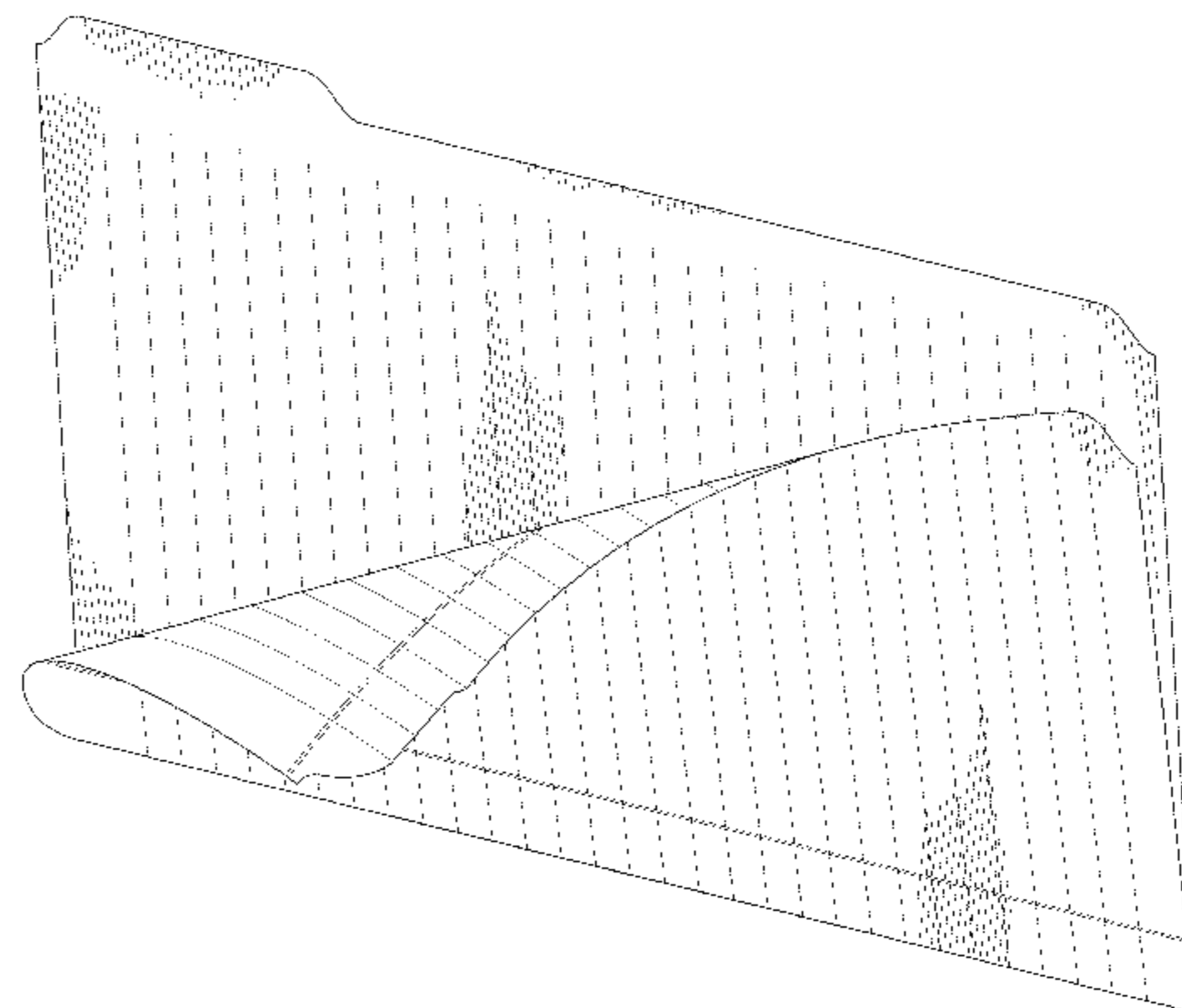
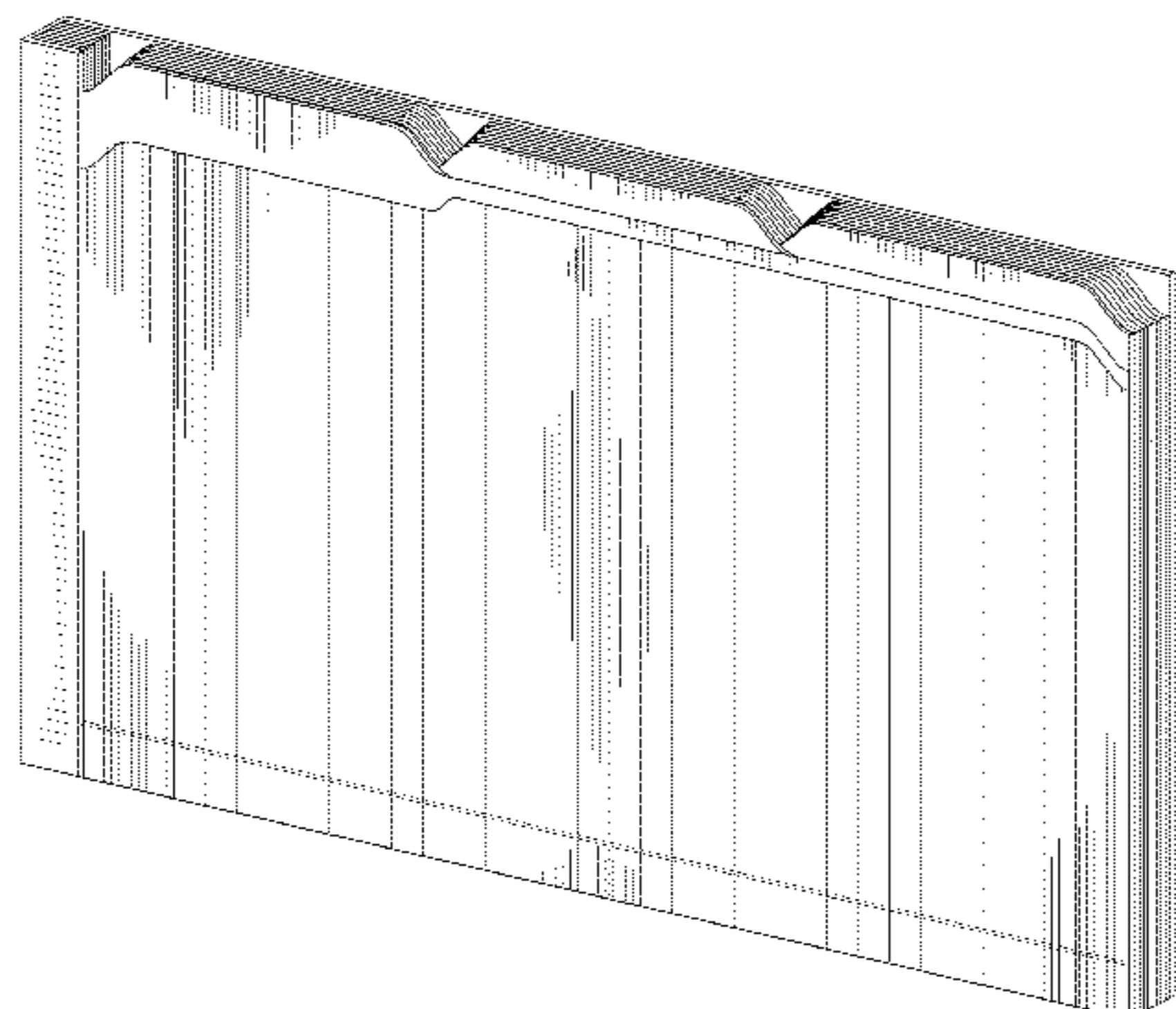


FIG. 26 is a front/left/top perspective view of the third embodiment, with a corner curled down to expose the interior of the ruled file folder;

FIG. 27 is a front/left/top perspective view of a fourth embodiment of a ruled file folder, that is identical to the third embodiment as shown and also having ruled lines on the inside of the file folder. In FIG. 27, a corner of one file folder is curled up a little to show the inside ruling of the file folder.

FIG. 28 is a front/right/top perspective view of the fourth embodiment showing a ruled file folder from the pad of file folders;

FIG. 29 is a front/left/top perspective view thereof;

FIG. 30 is a front elevational view thereof;

FIG. 31 is a rear elevational view thereof;

FIG. 32 is a top plan view thereof;

FIG. 33 is a bottom plan view thereof;

FIG. 34 is a right side elevational view thereof; and

FIG. 35 is a left side elevational view thereof; and,

FIG. 36 is a front/left/top perspective view of the fourth embodiment, with a corner curled down to expose the interior of the ruled file folder.

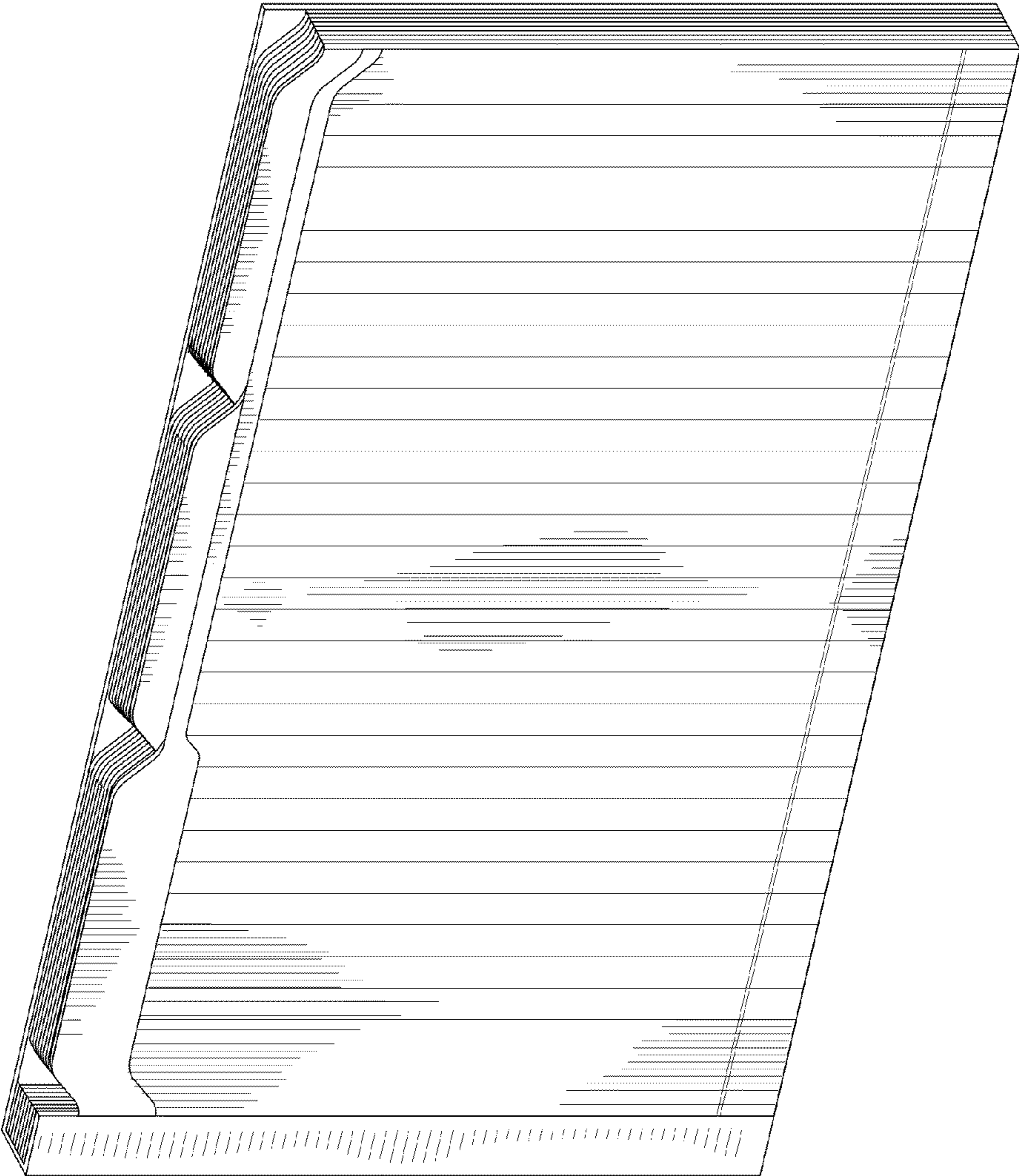

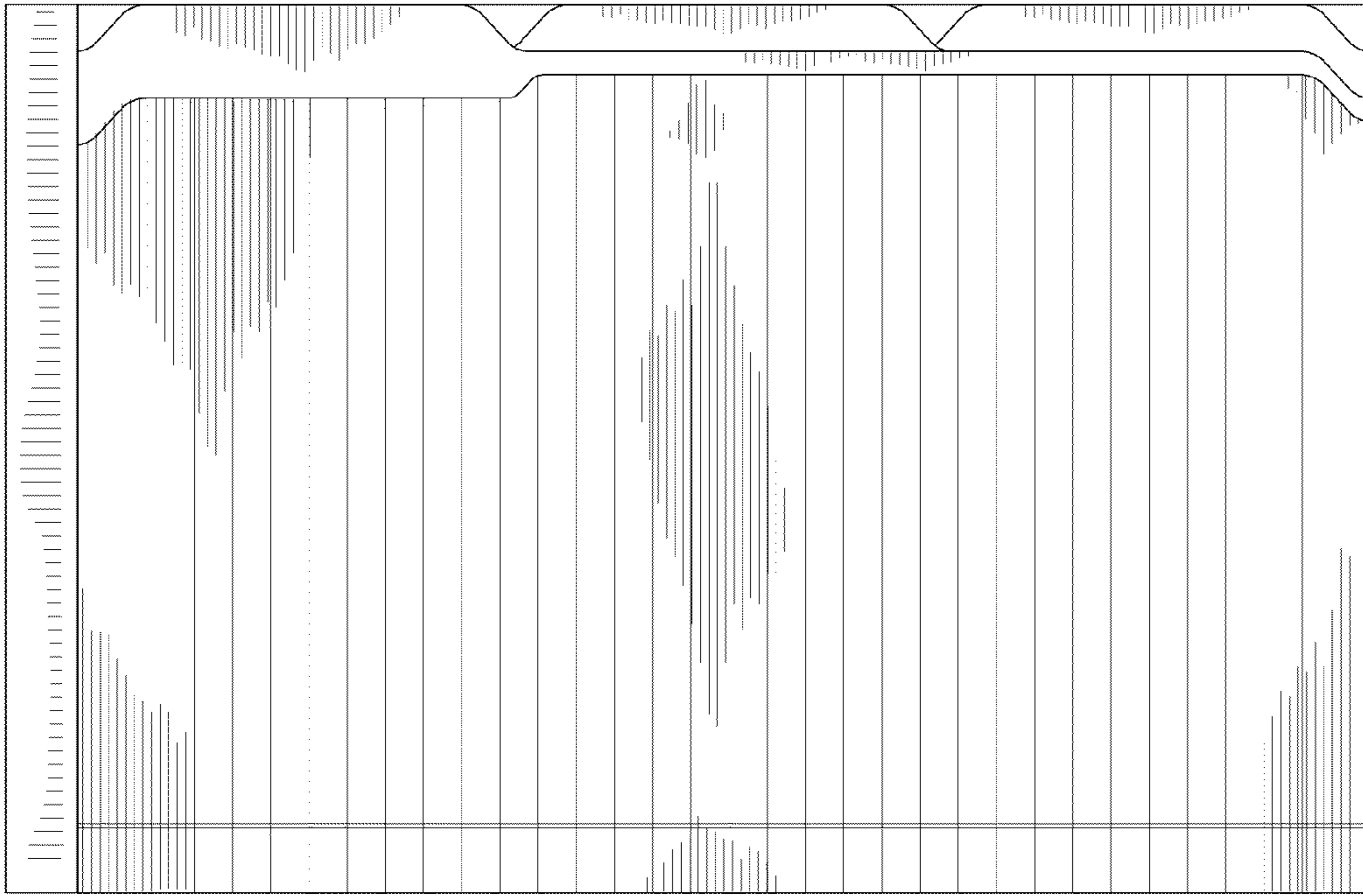

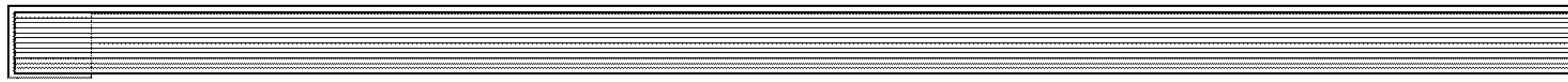

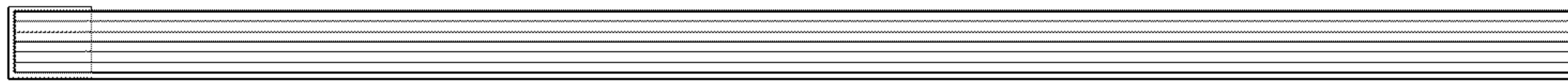

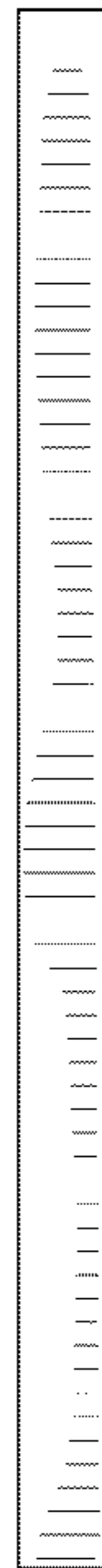

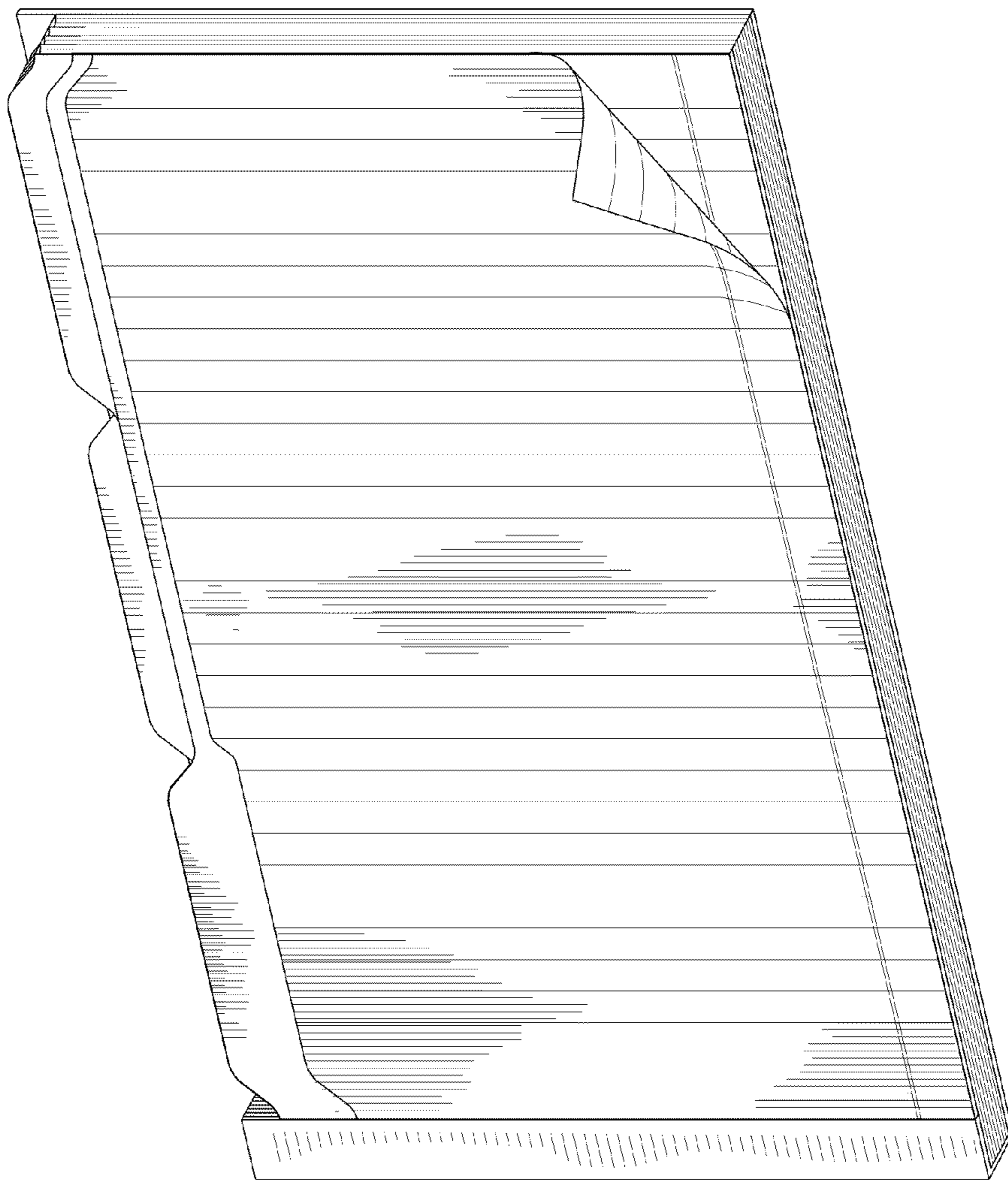

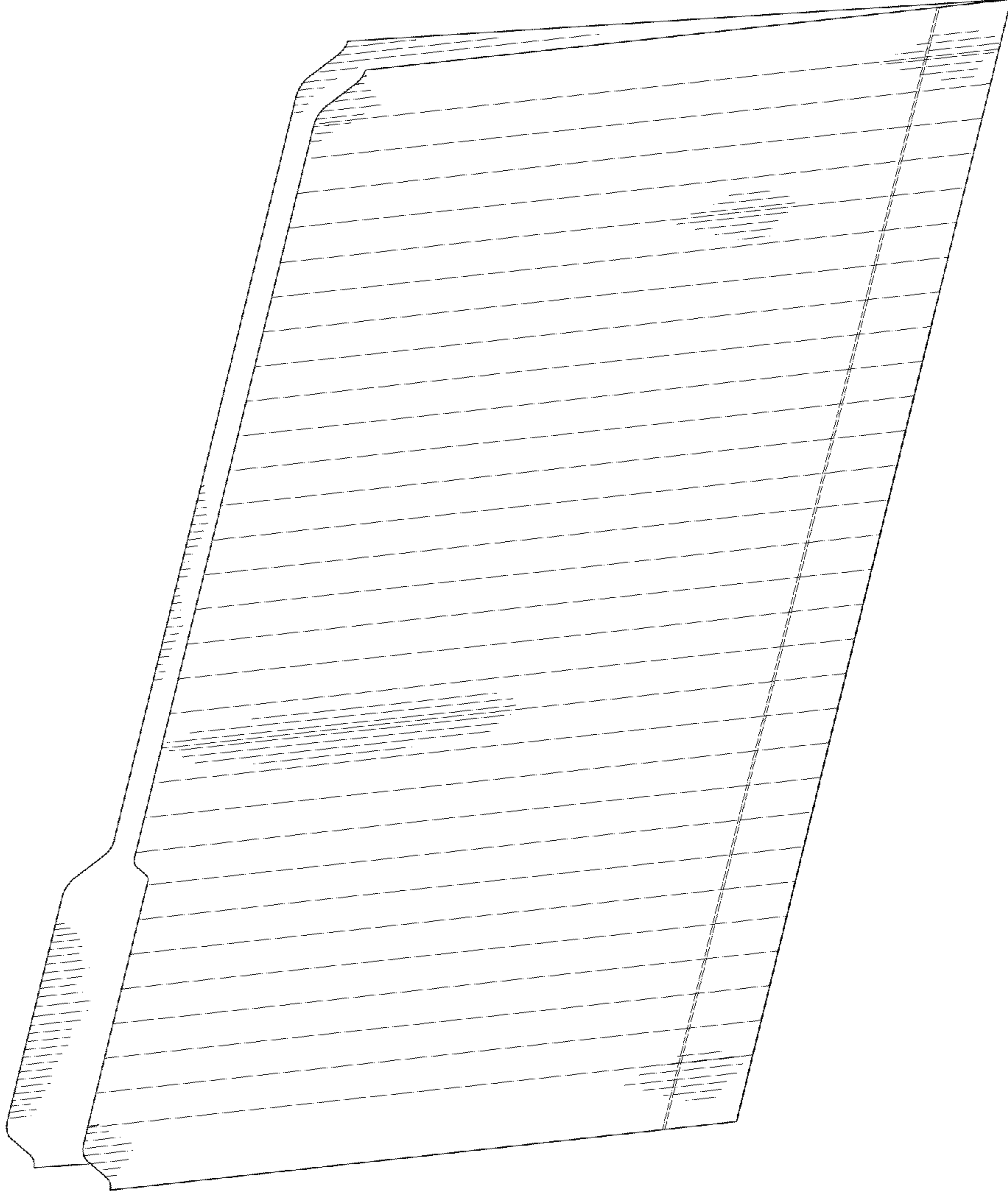

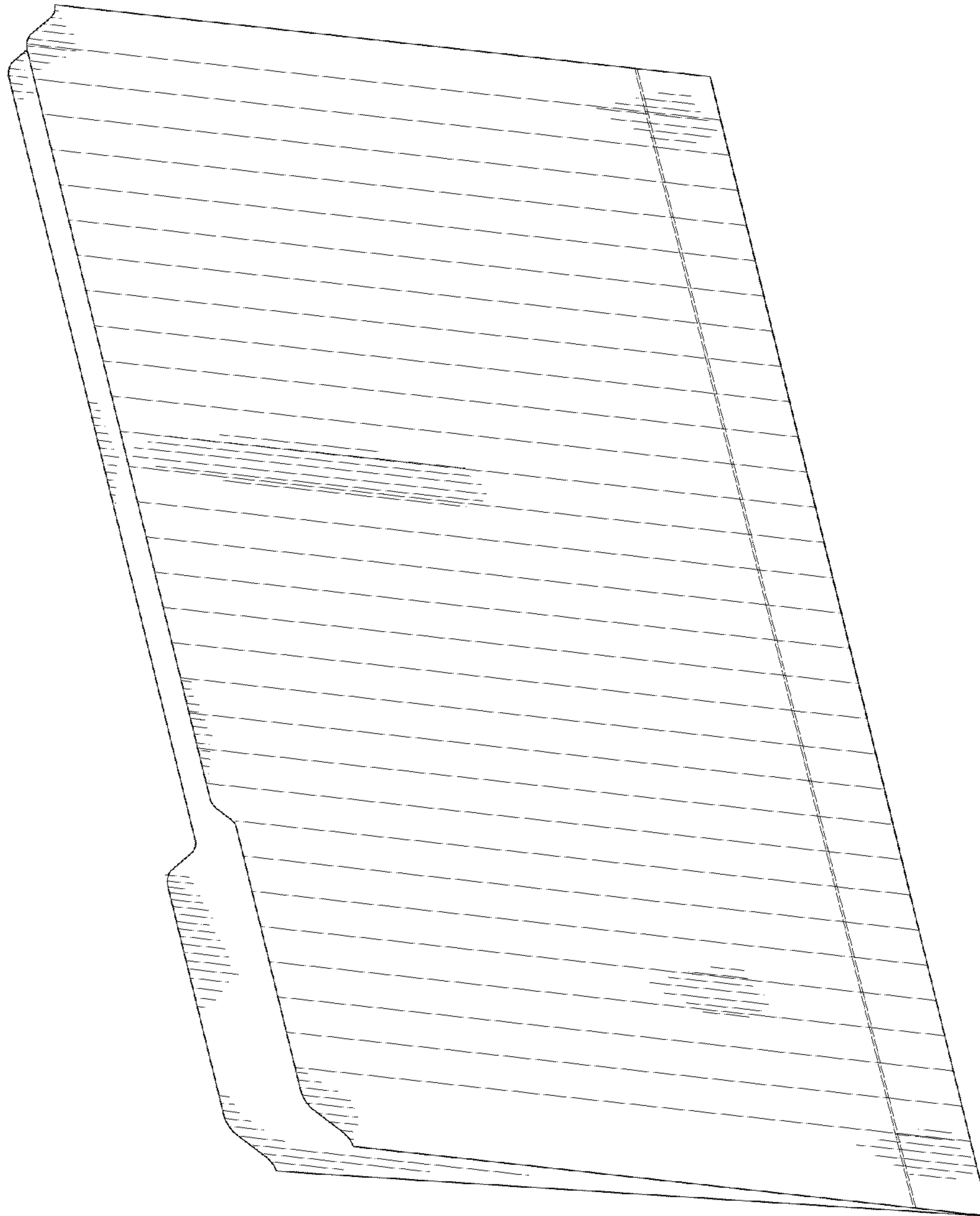

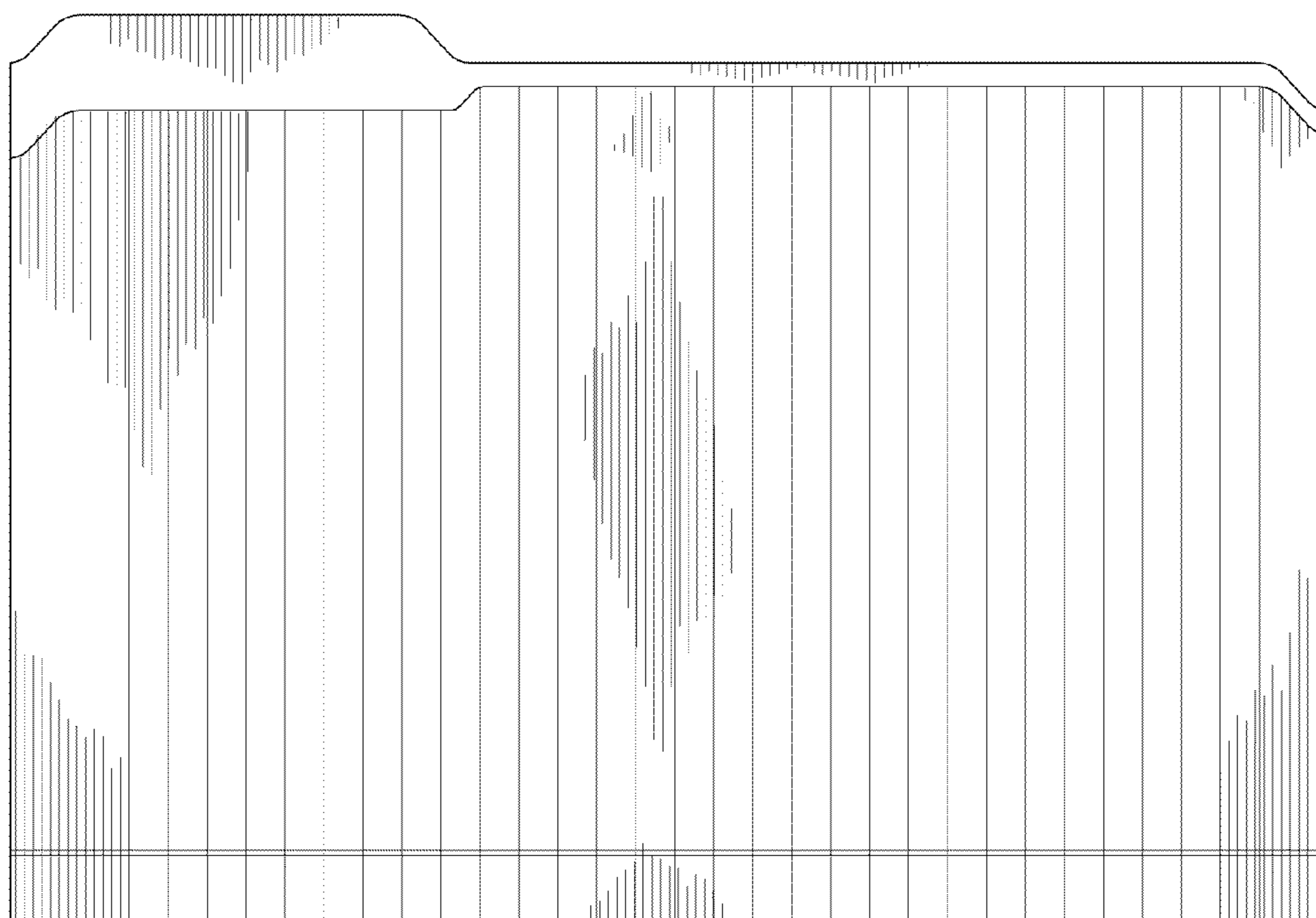

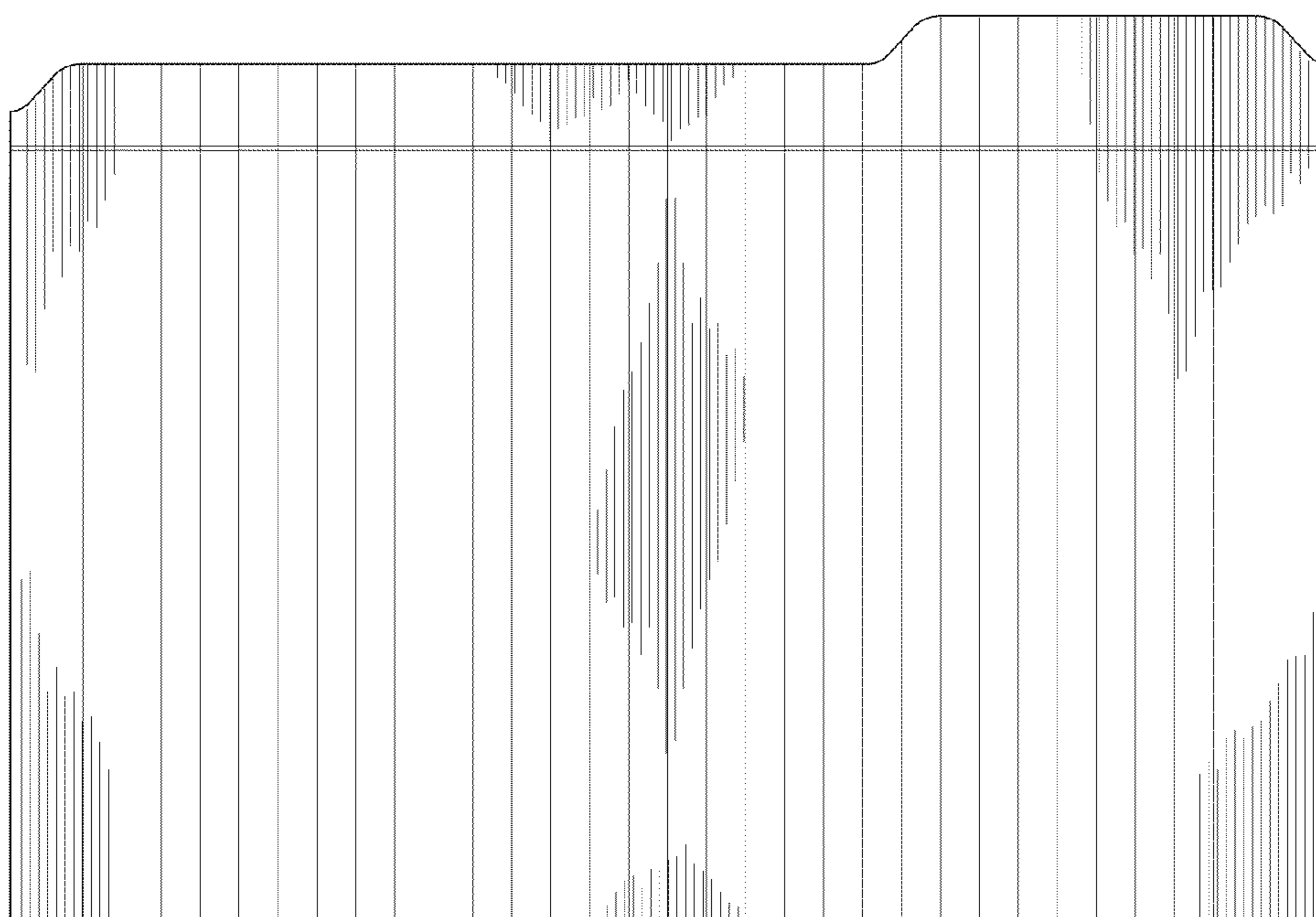

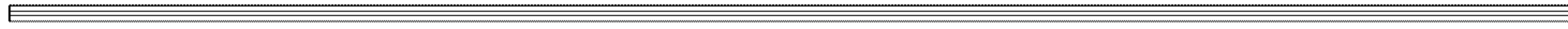

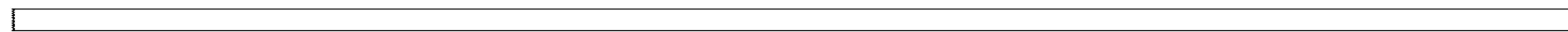

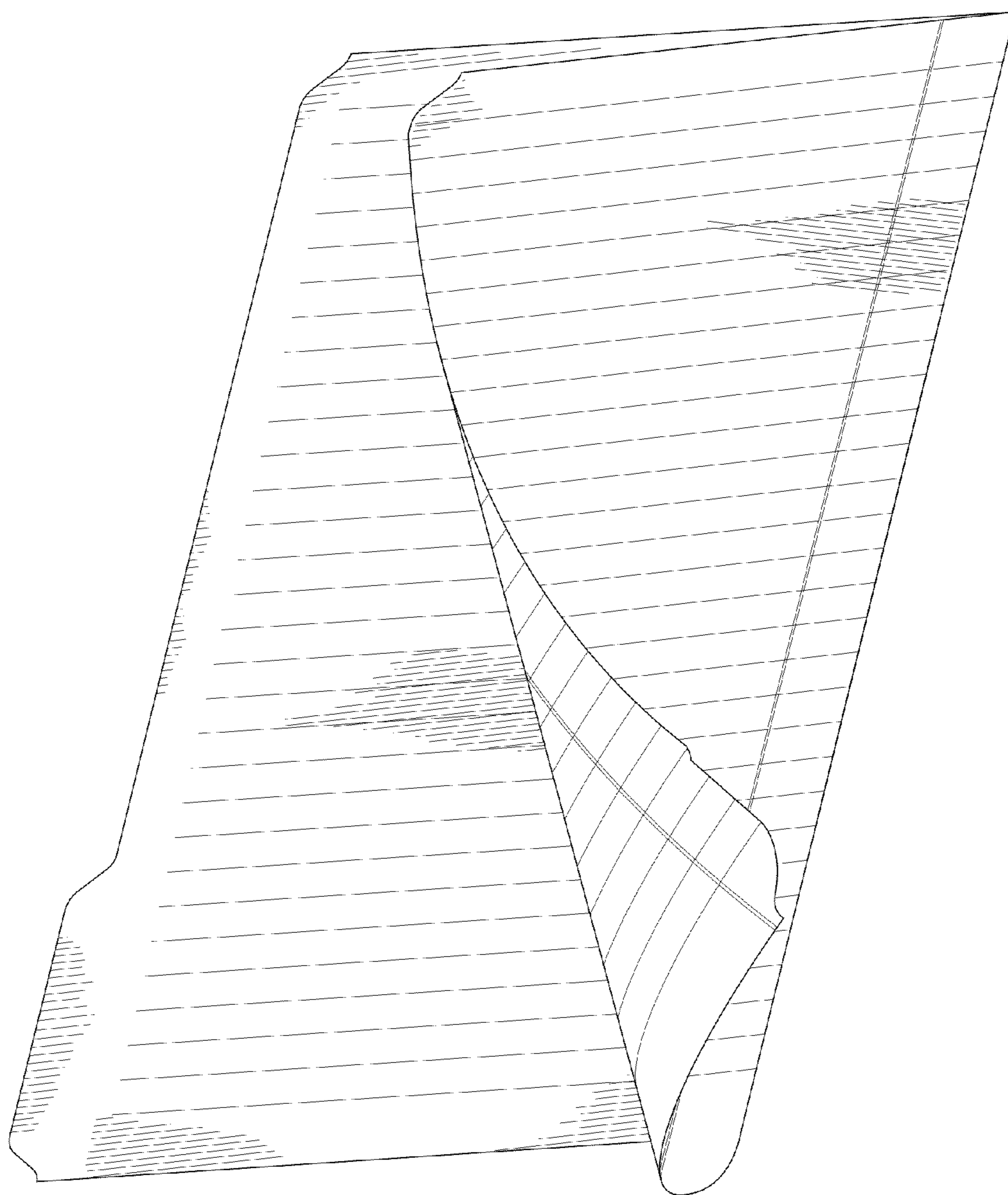

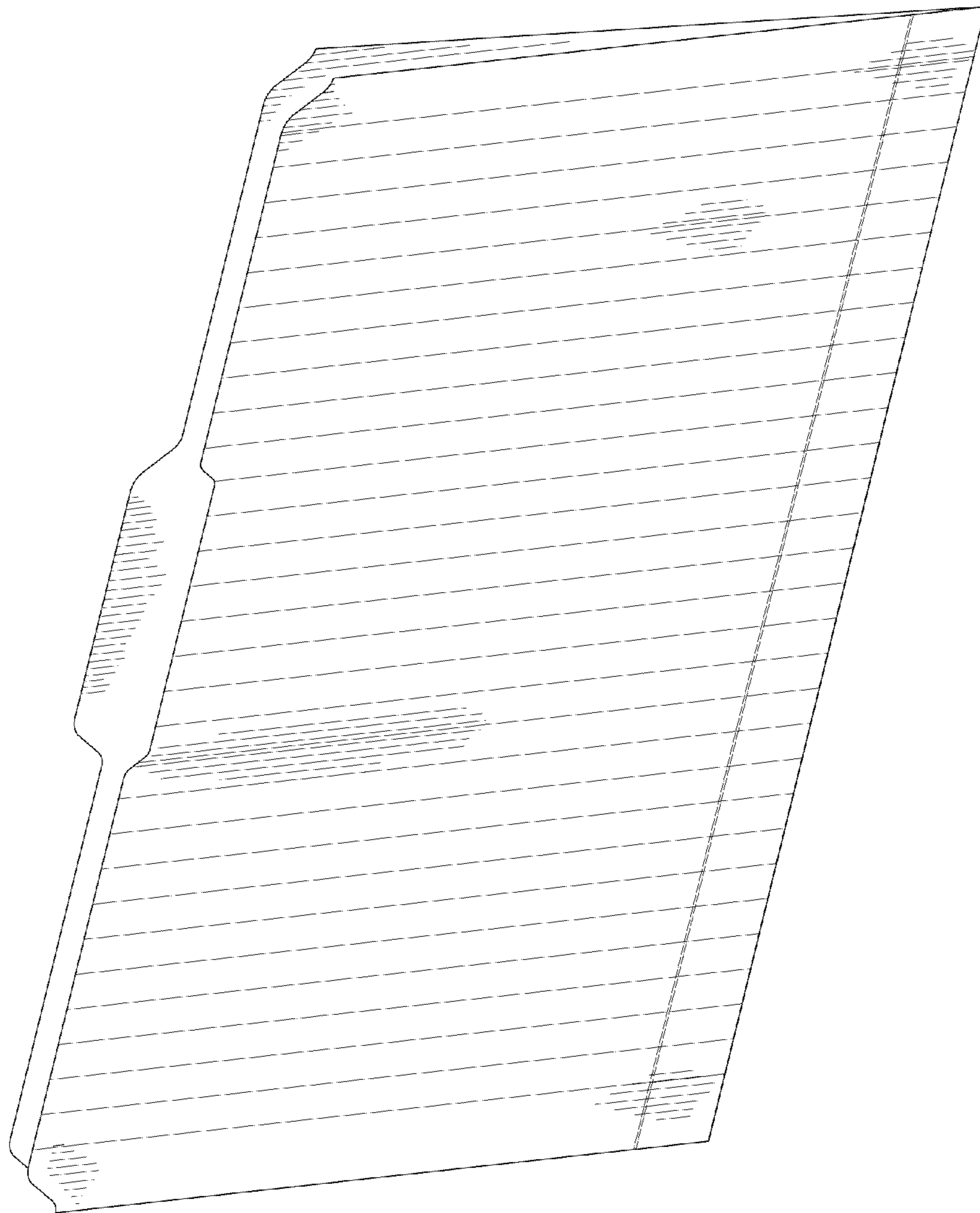

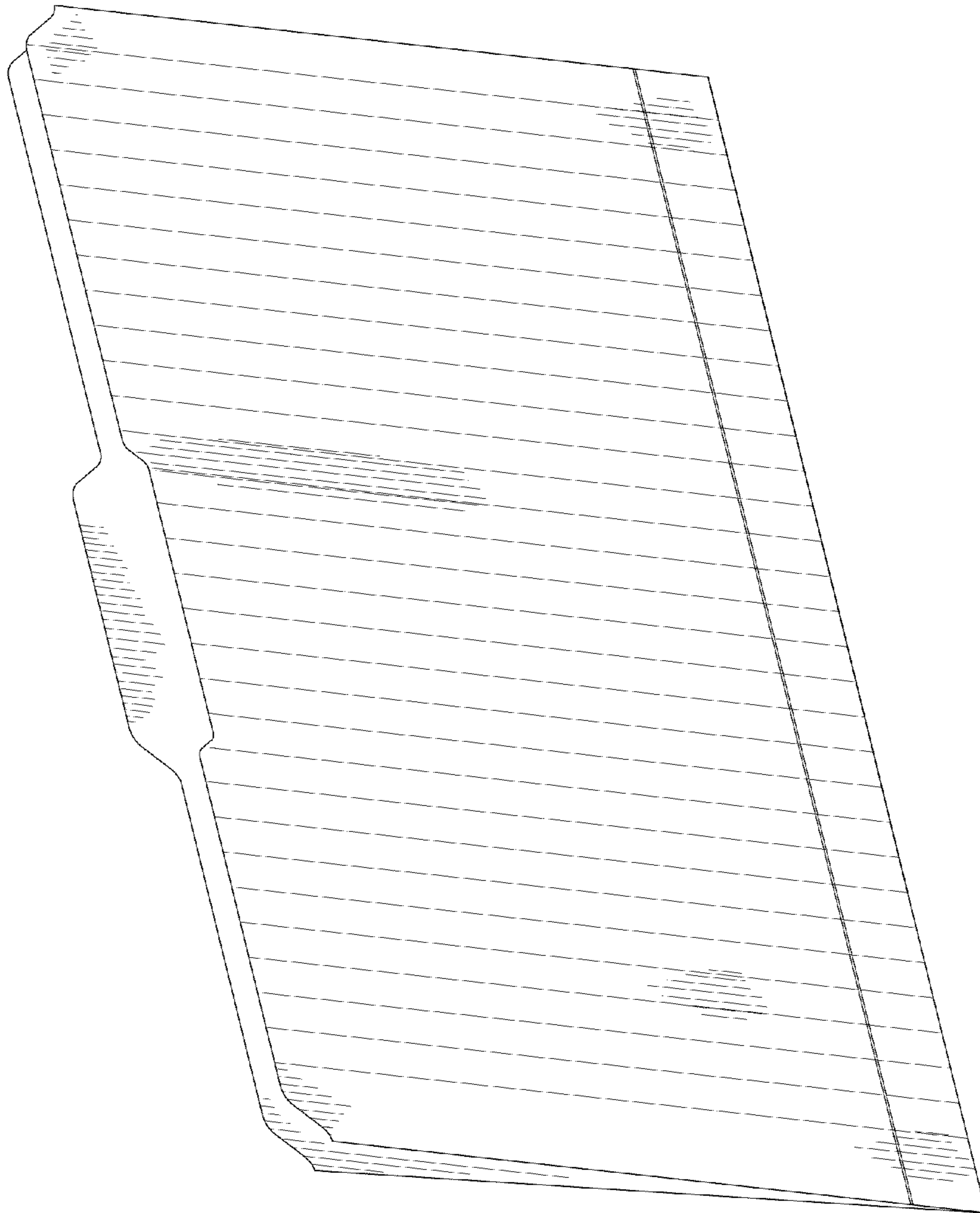

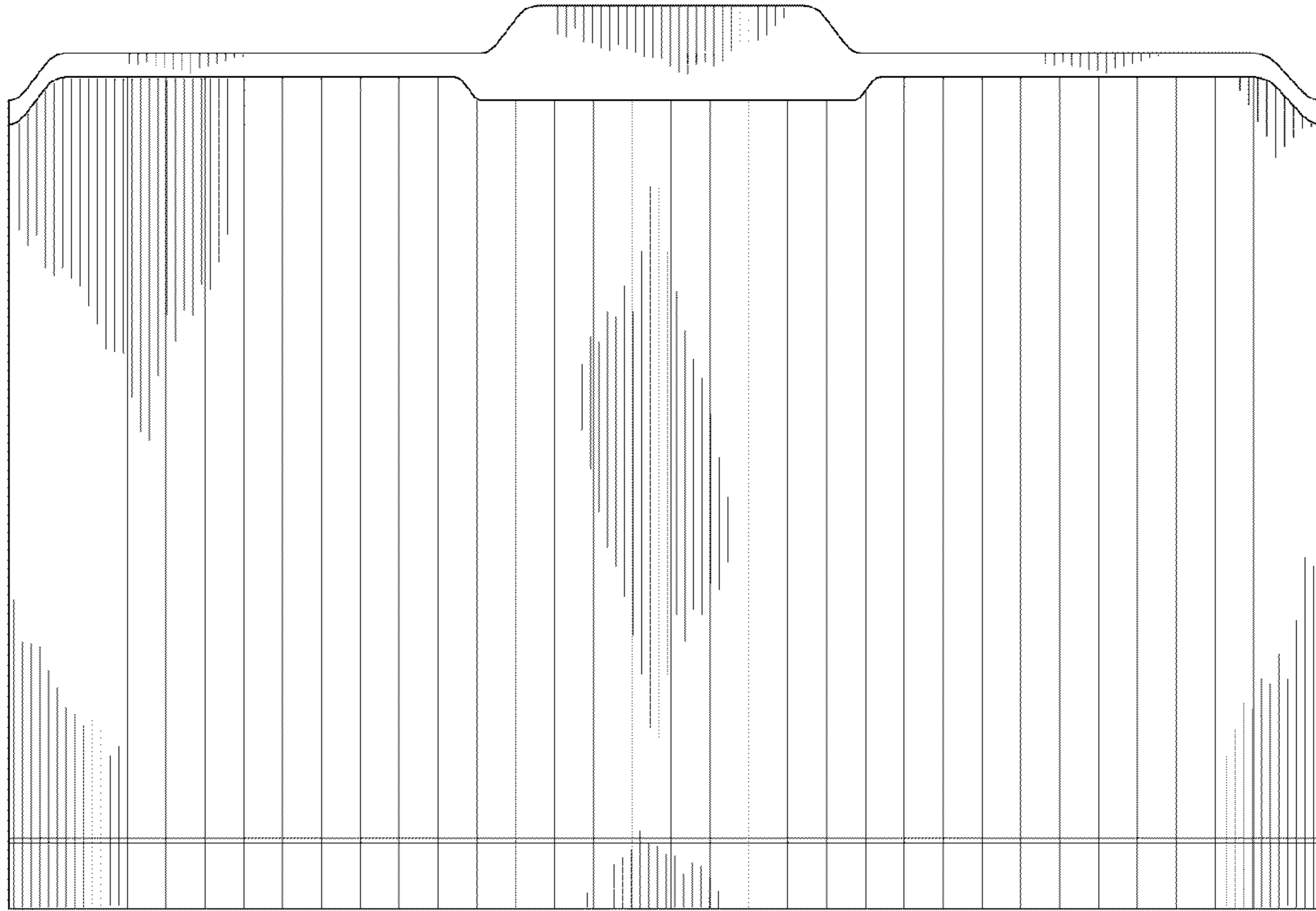

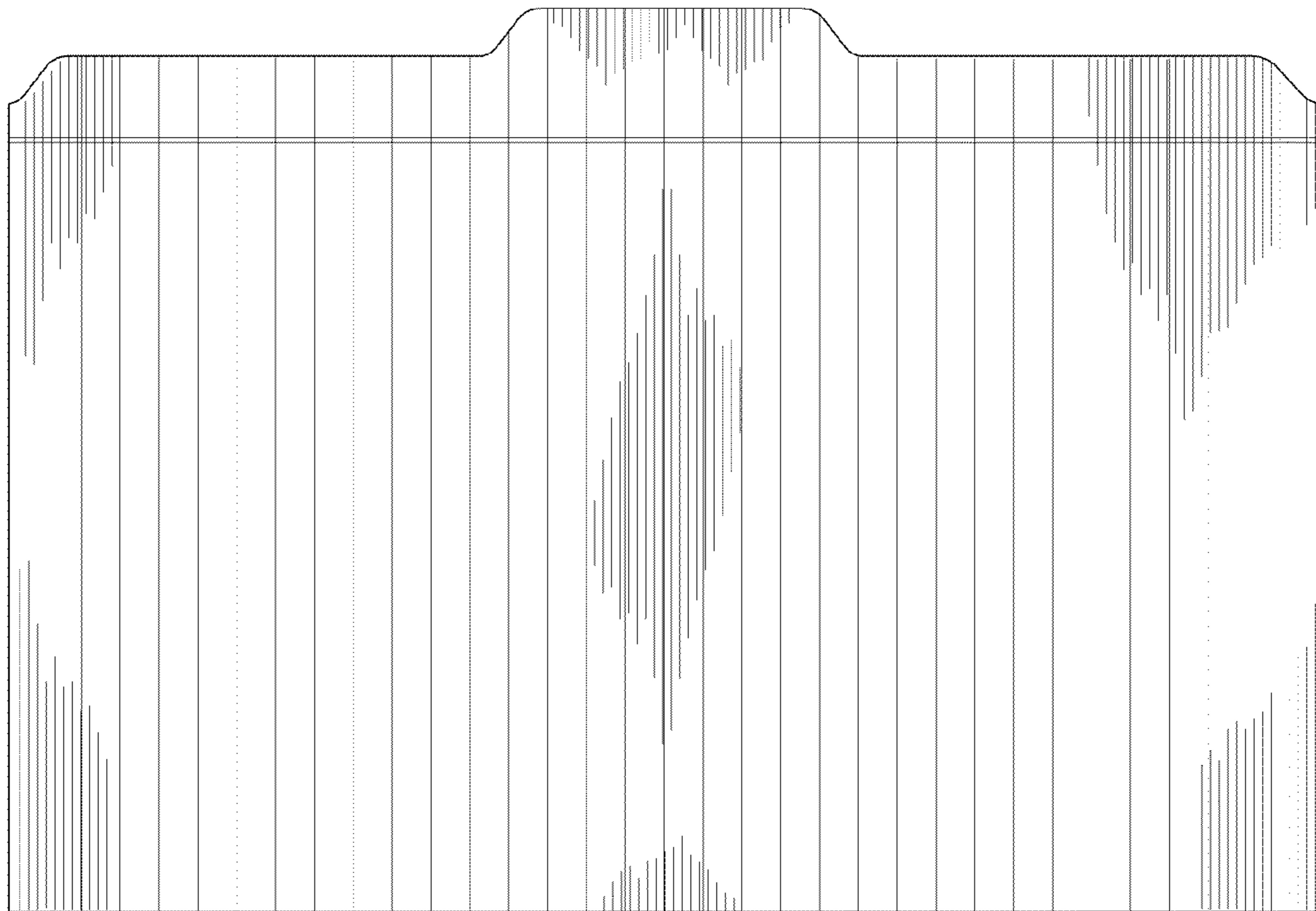

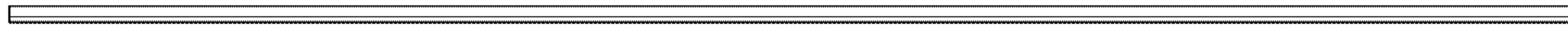

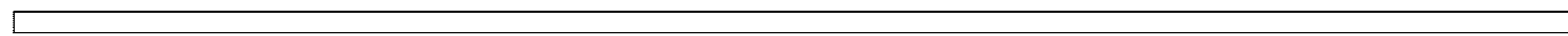

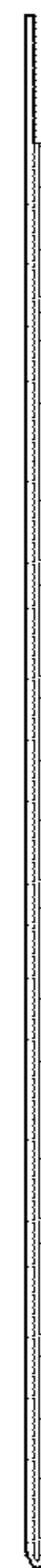

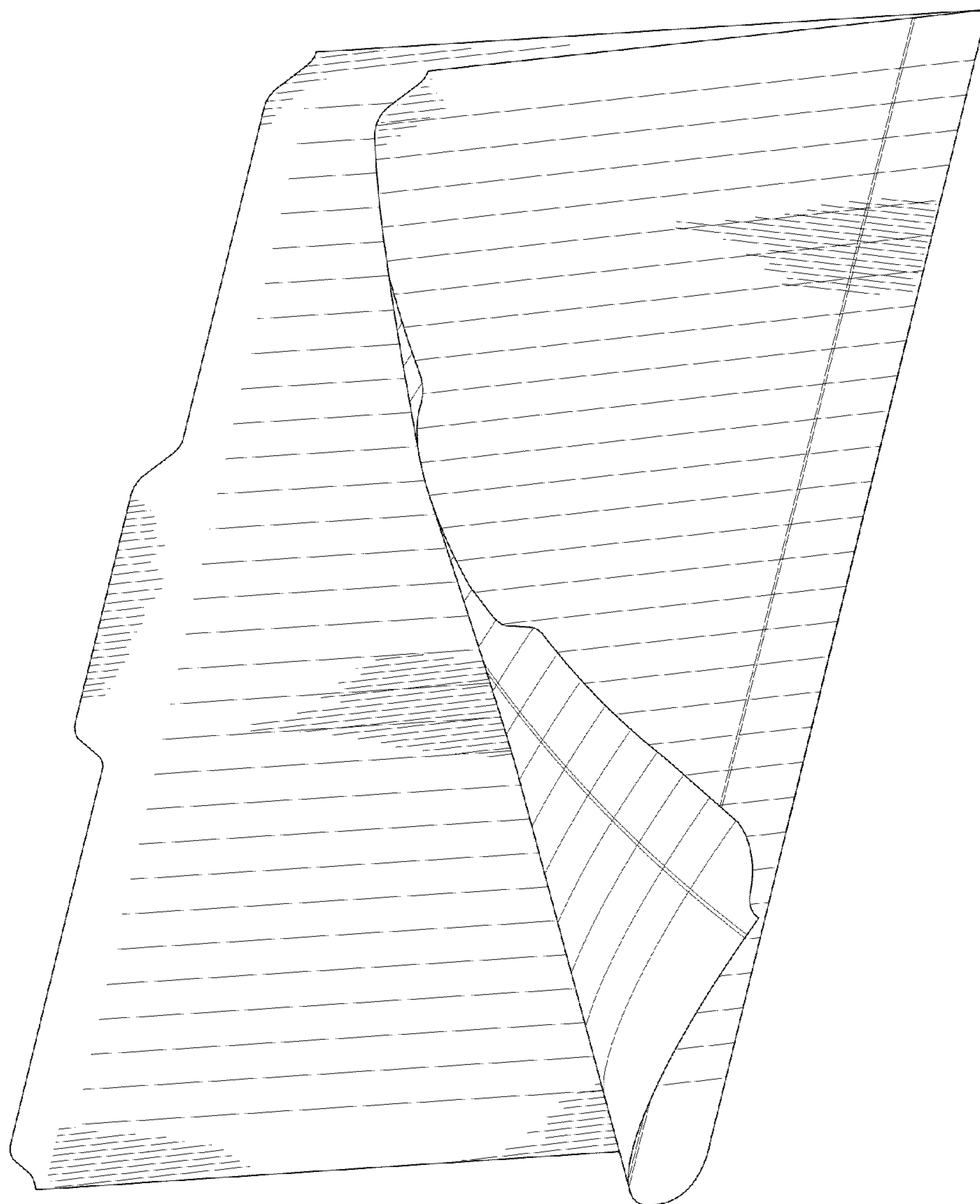

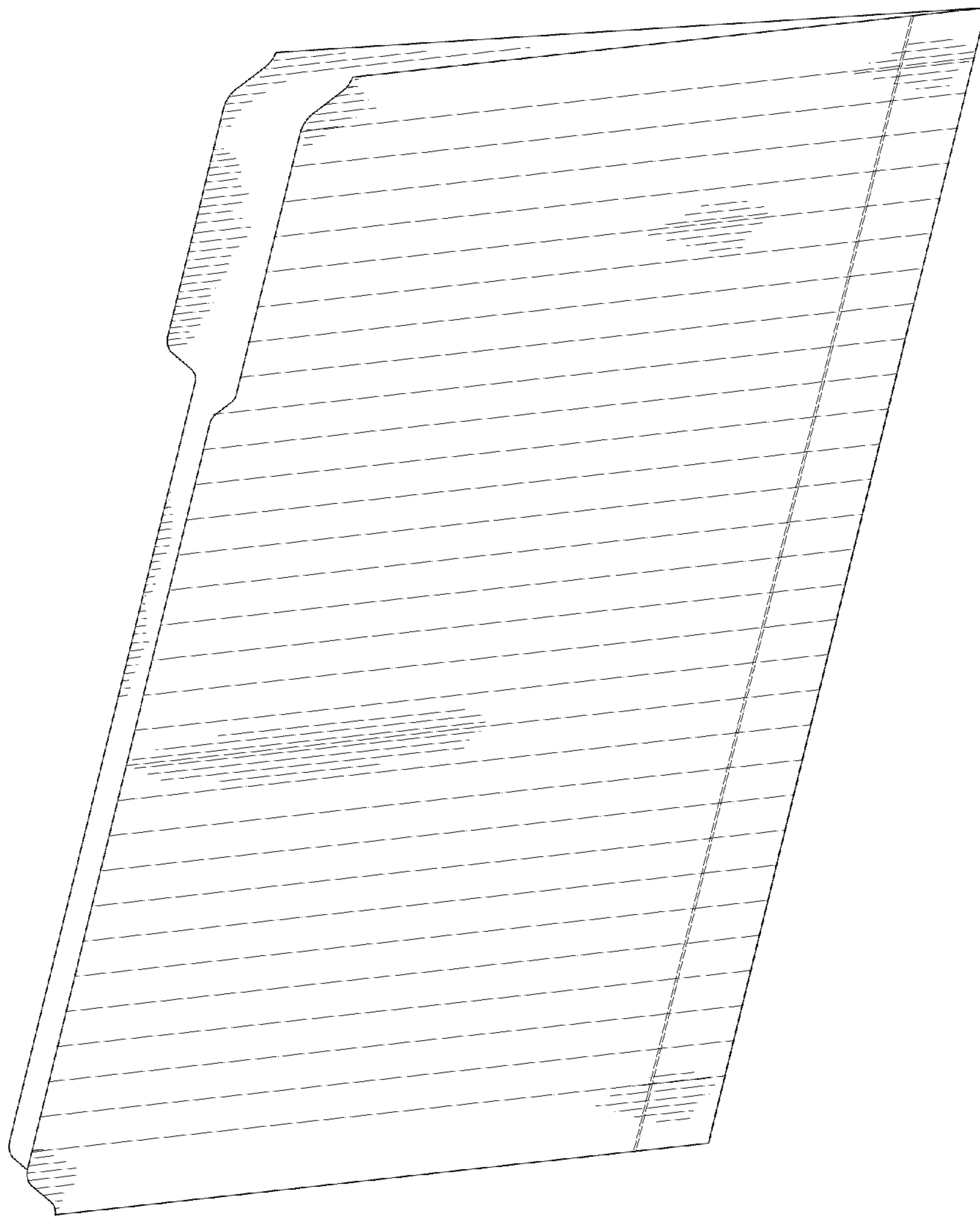

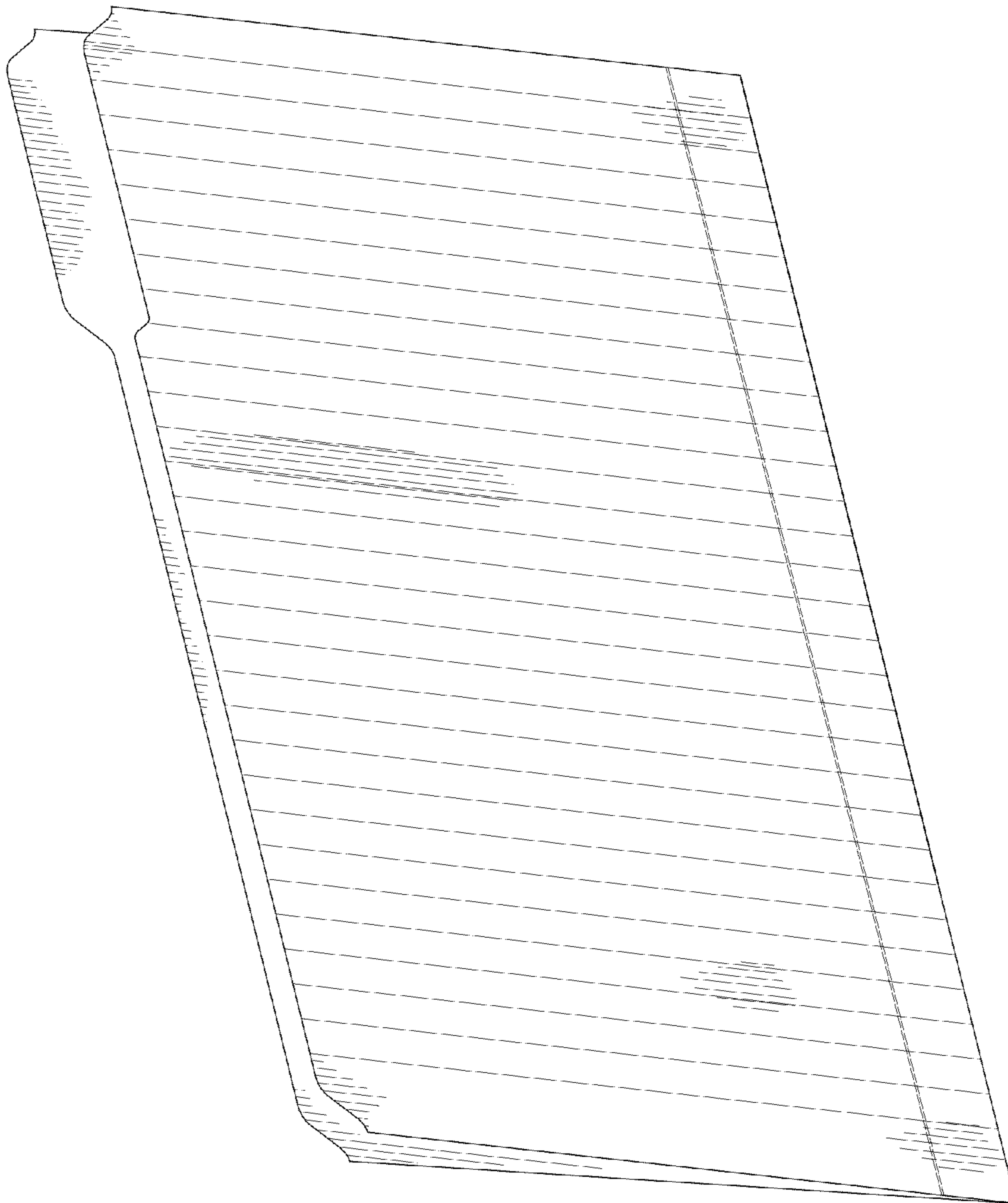

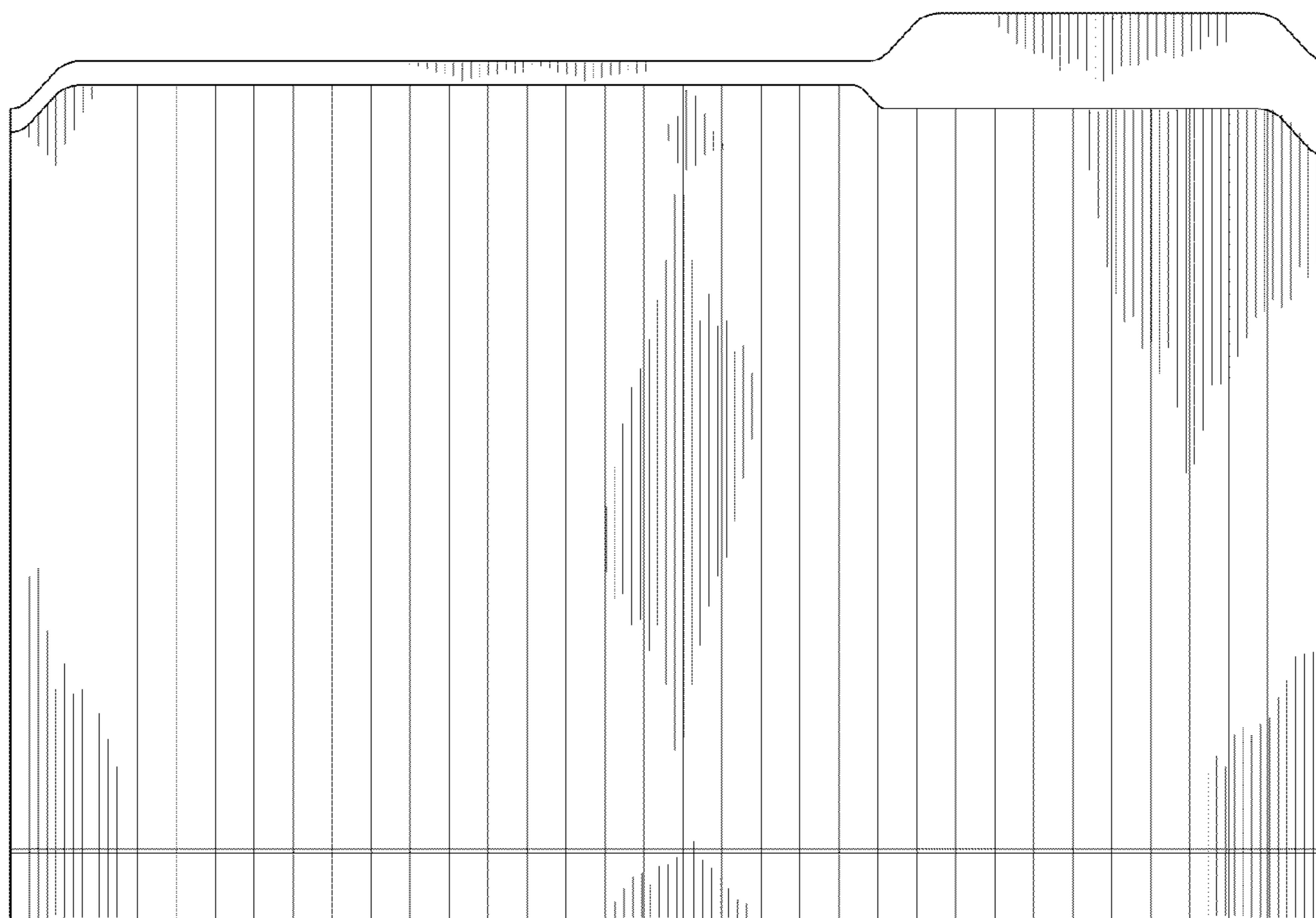

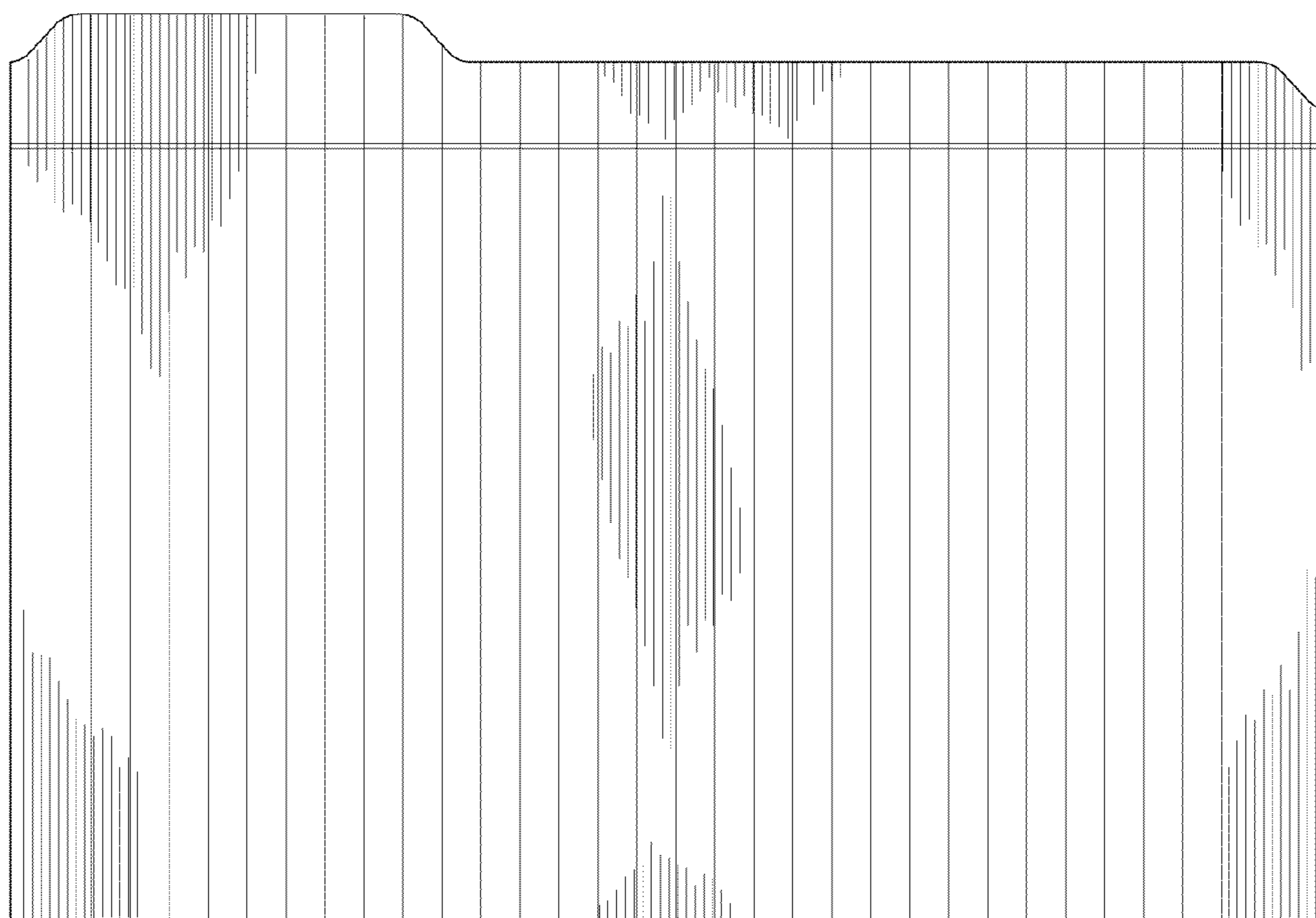

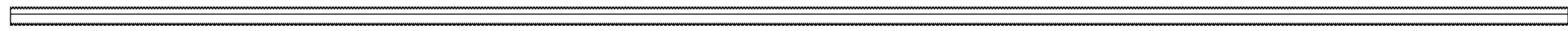

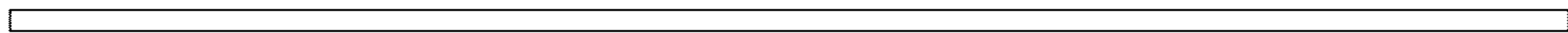

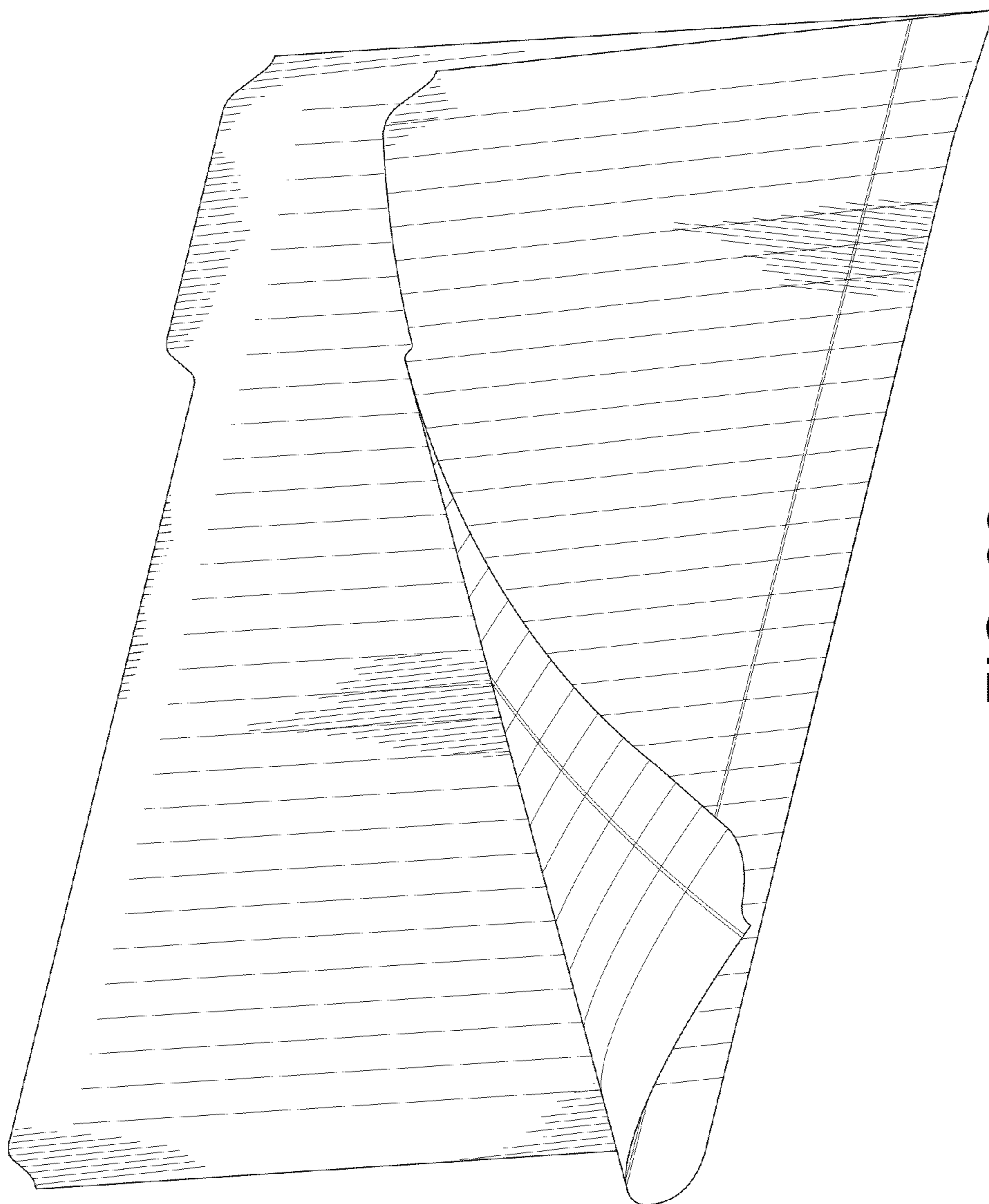
