(57) **CLAIM**

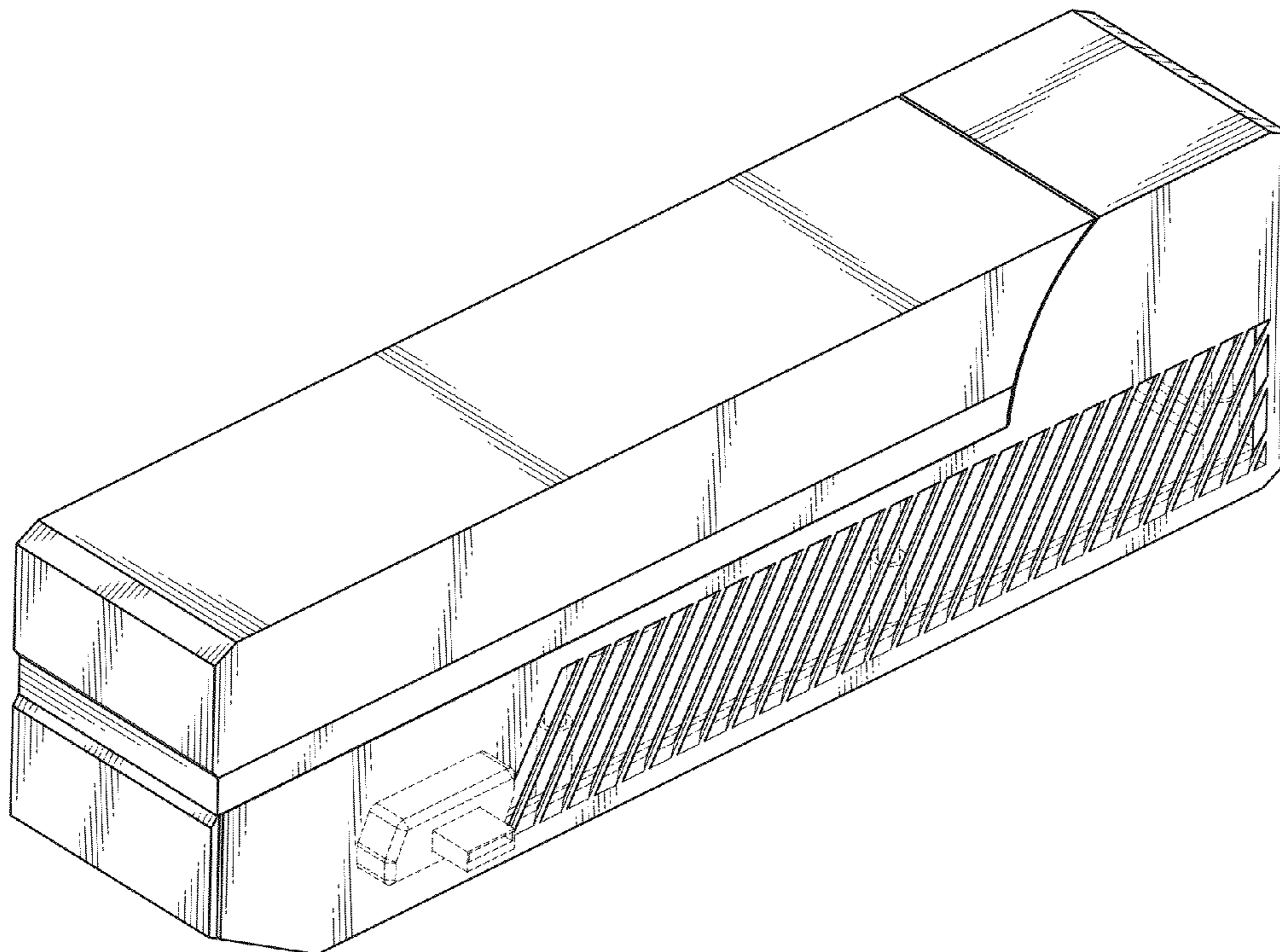
The ornamental design for an auxiliary accessory for a gaming console, as shown and described.

DESCRIPTION

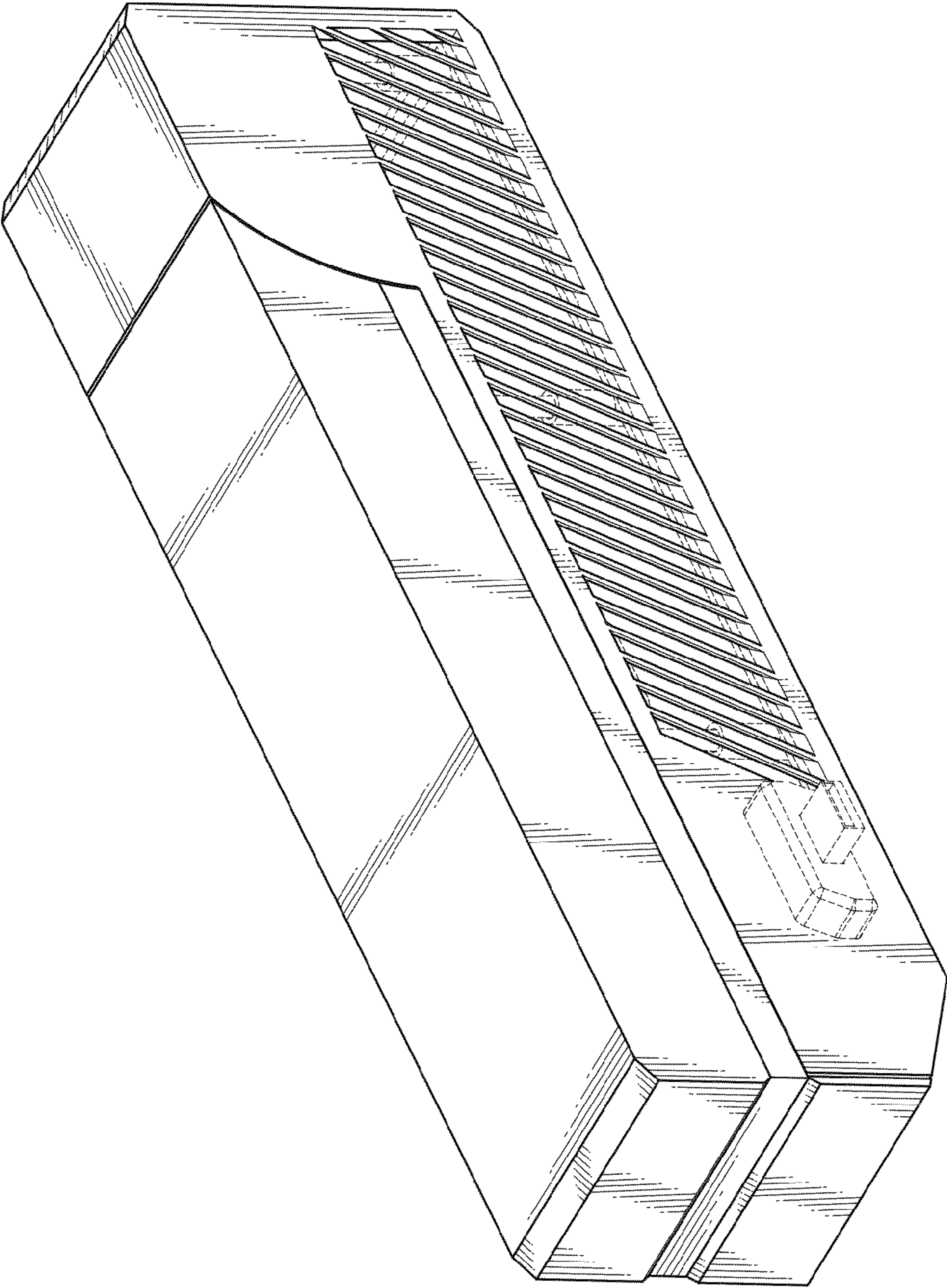

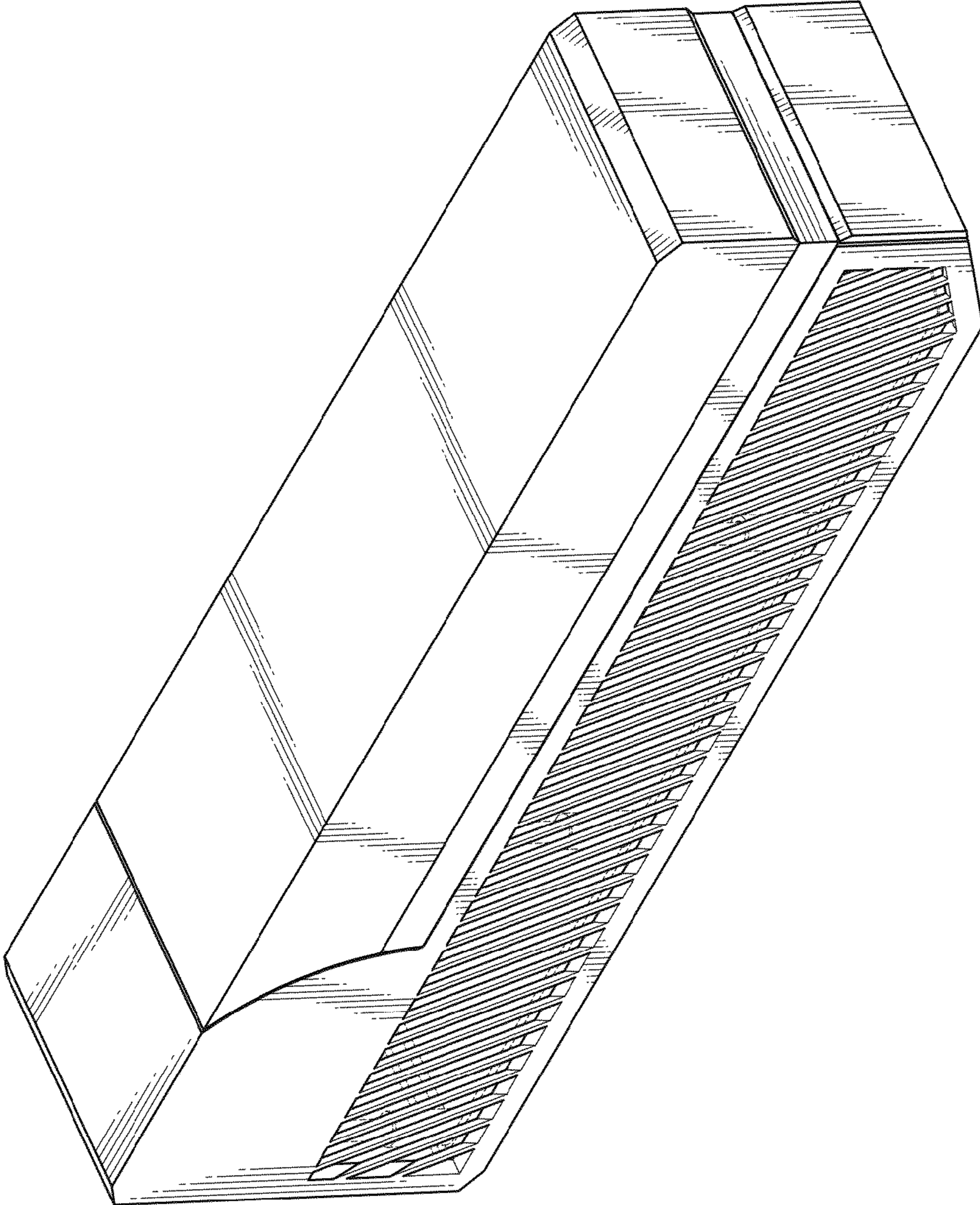

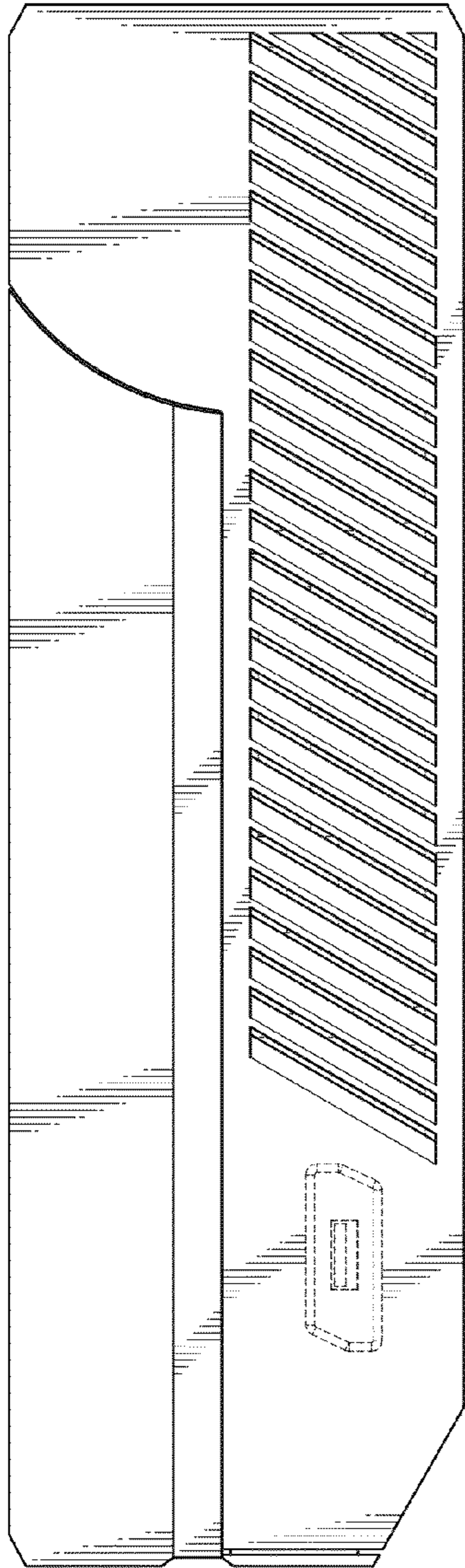

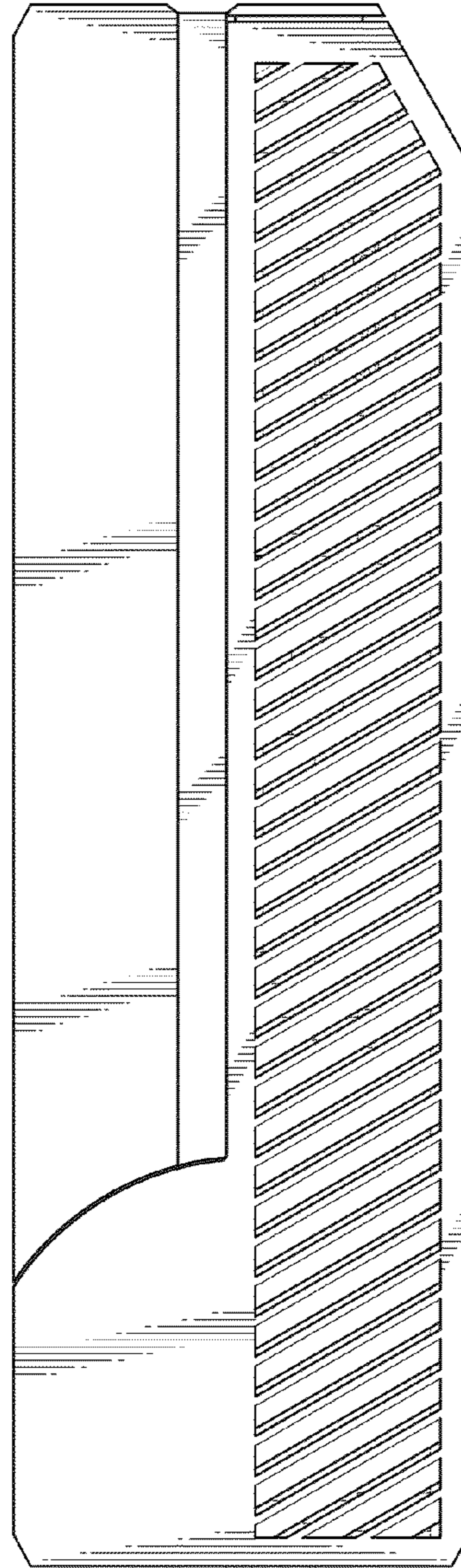

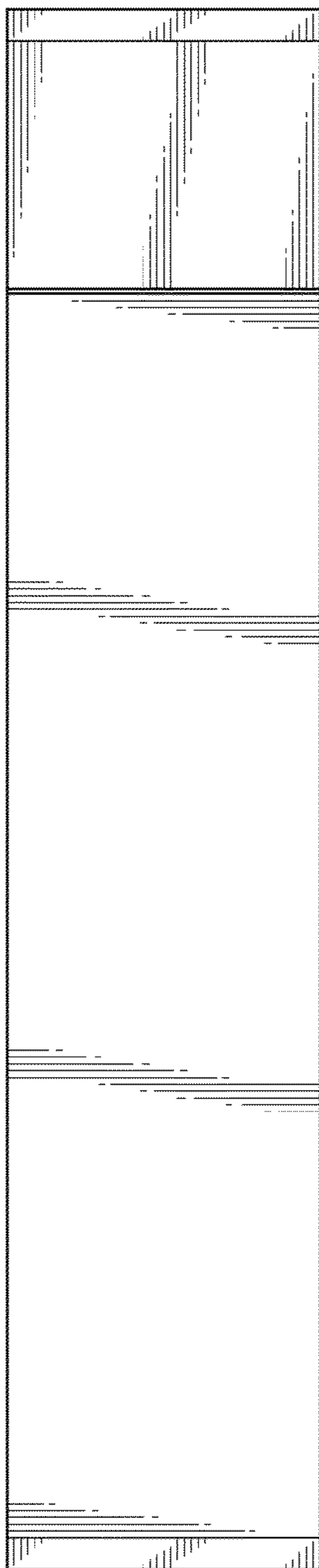

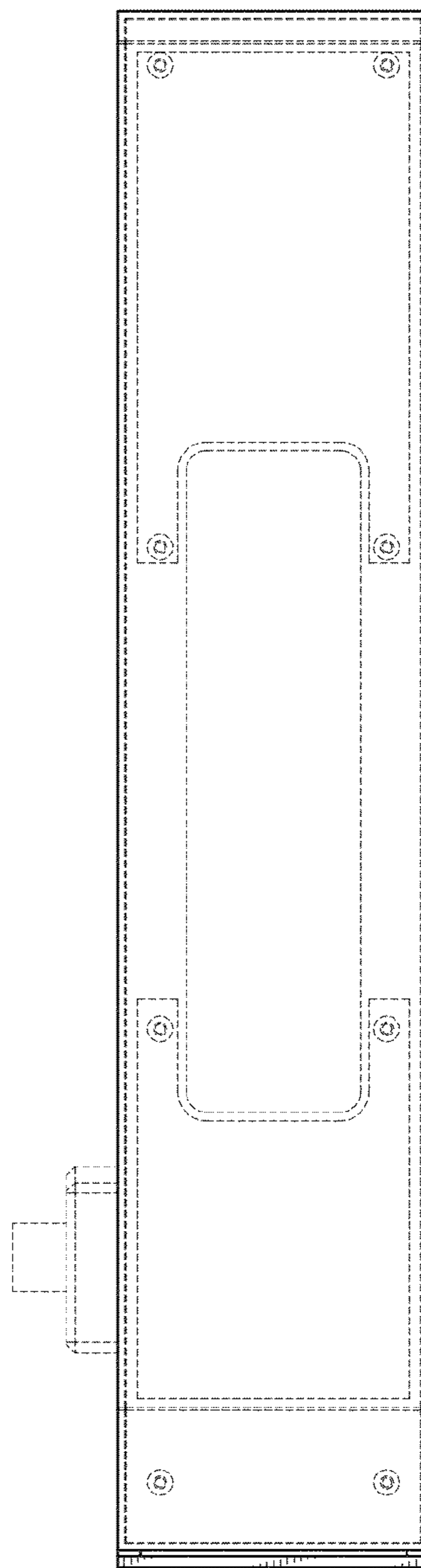

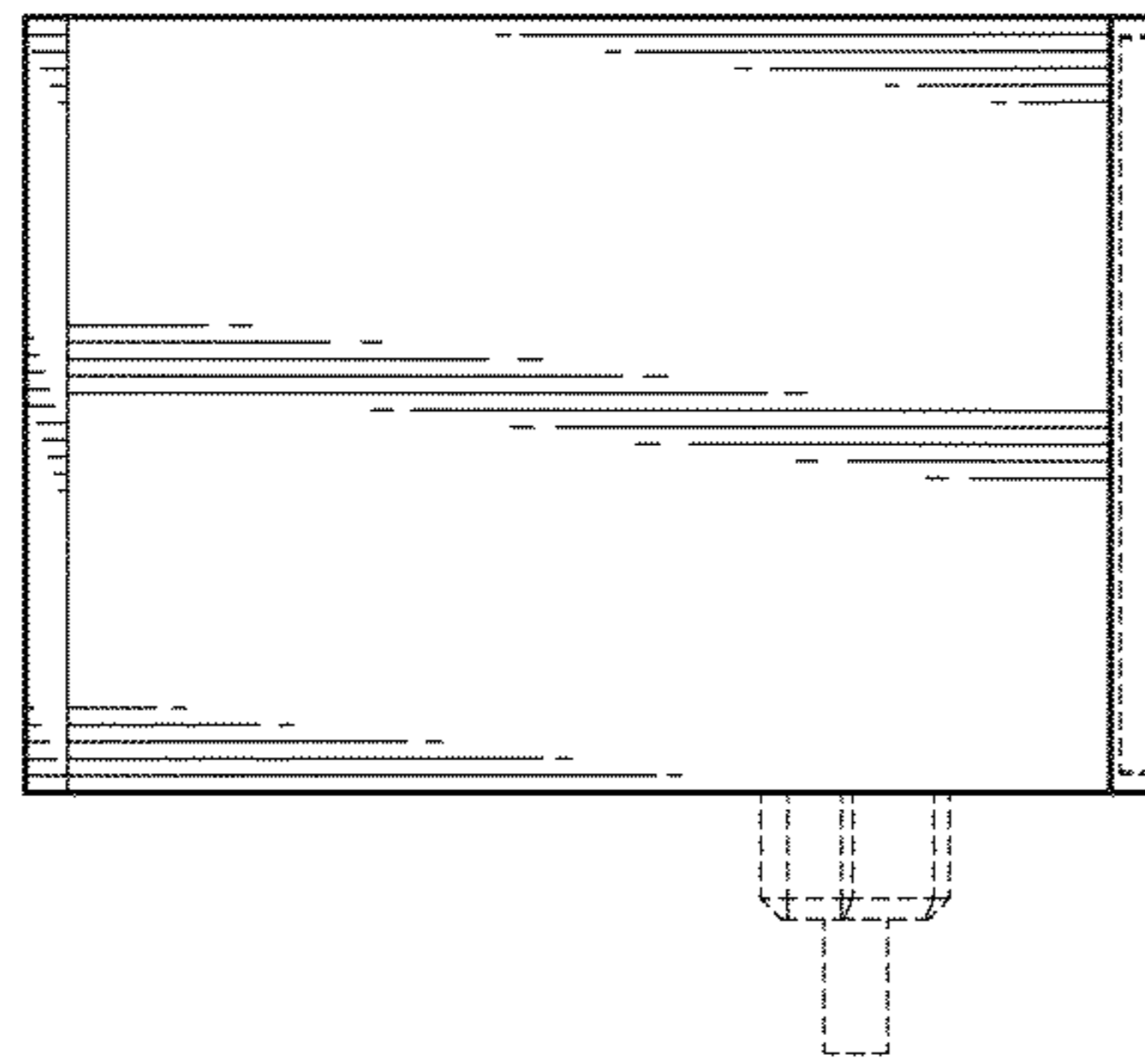

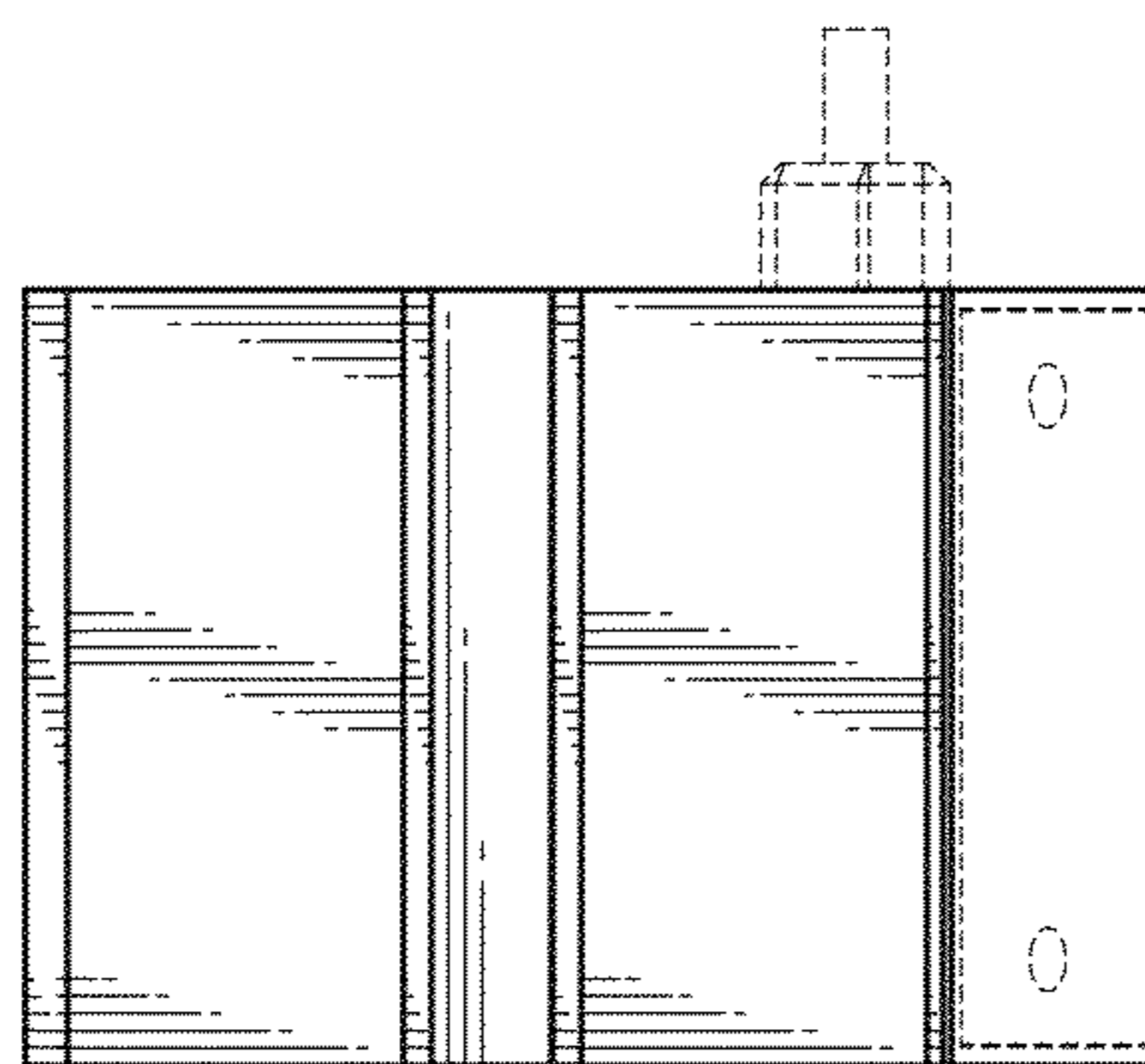
