(57) **CLAIM**

The ornamental design for a crane machine, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of the crane machine shown in the design;

FIG. 2 is a front side plan view of the crane machine of the present design;

FIG. 3 is a back side plan view of the crane machine of the present design;

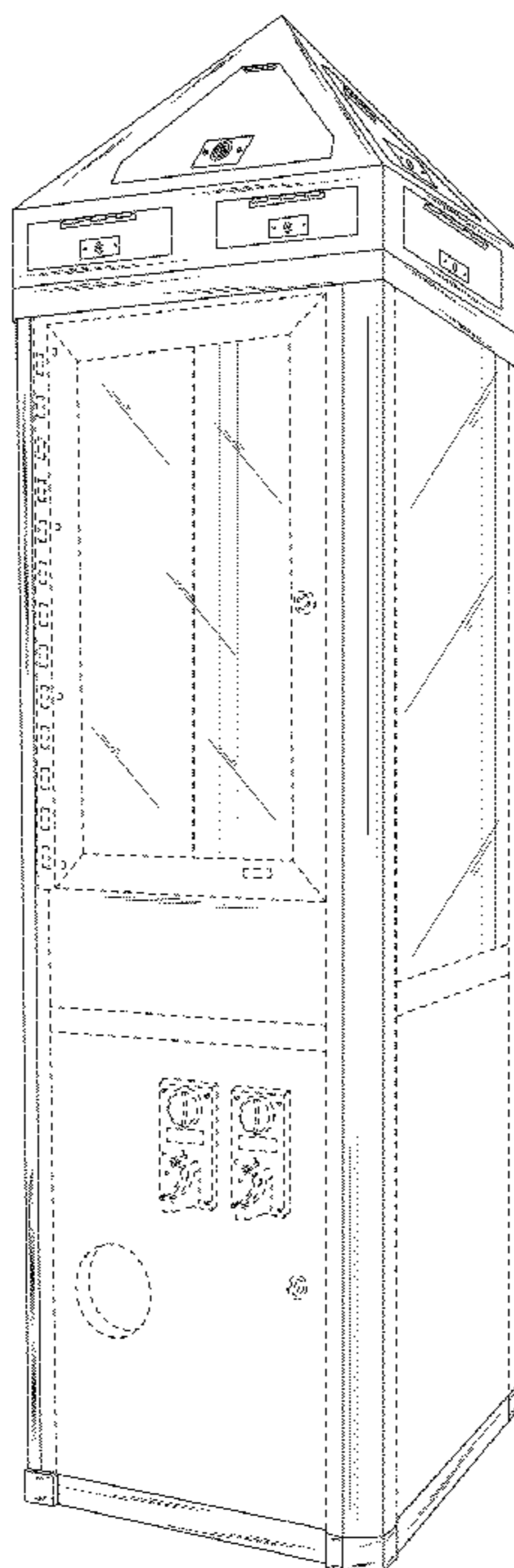
FIG. 4 is a top planar view of the crane machine showing the design;

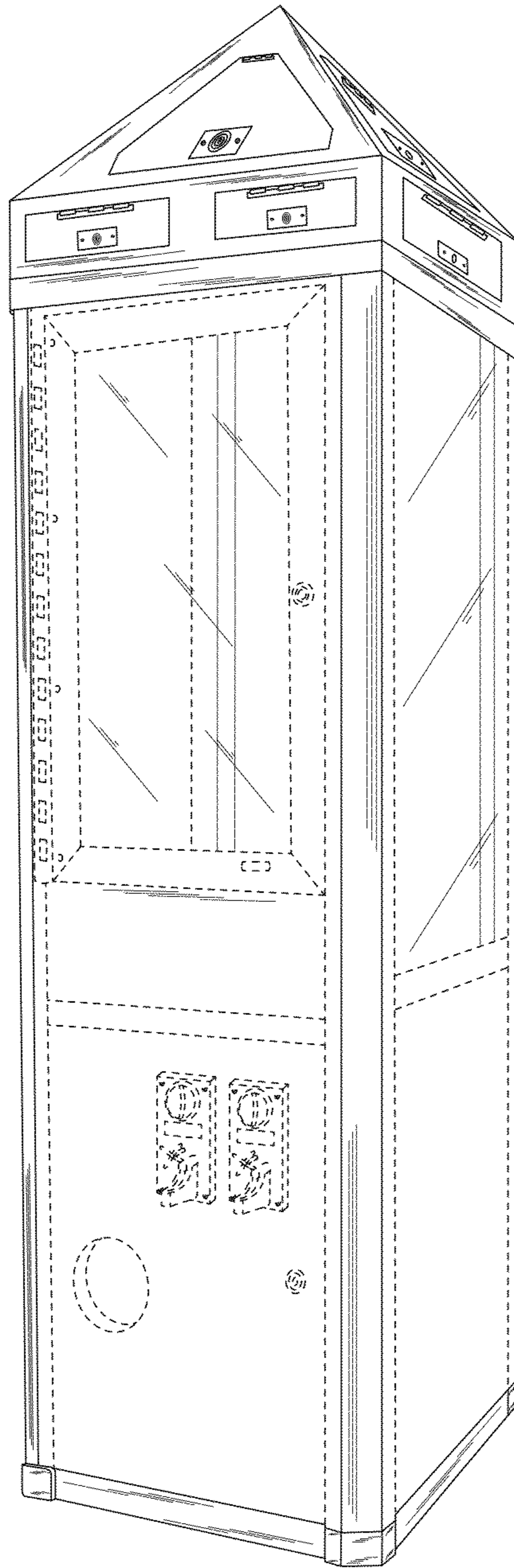

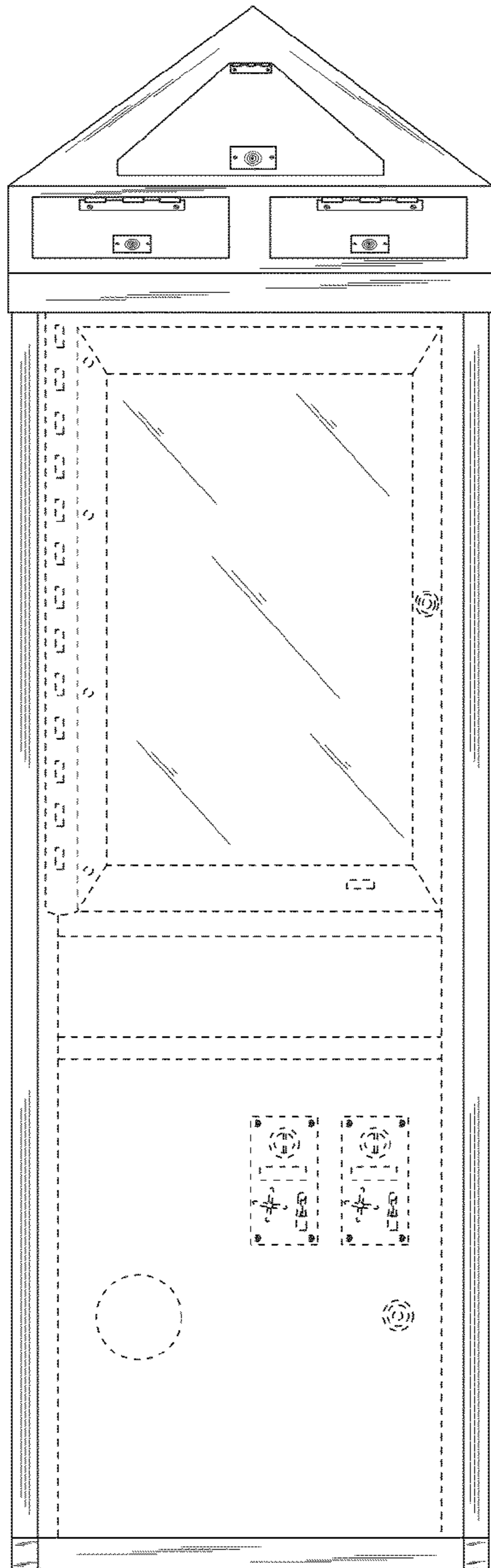

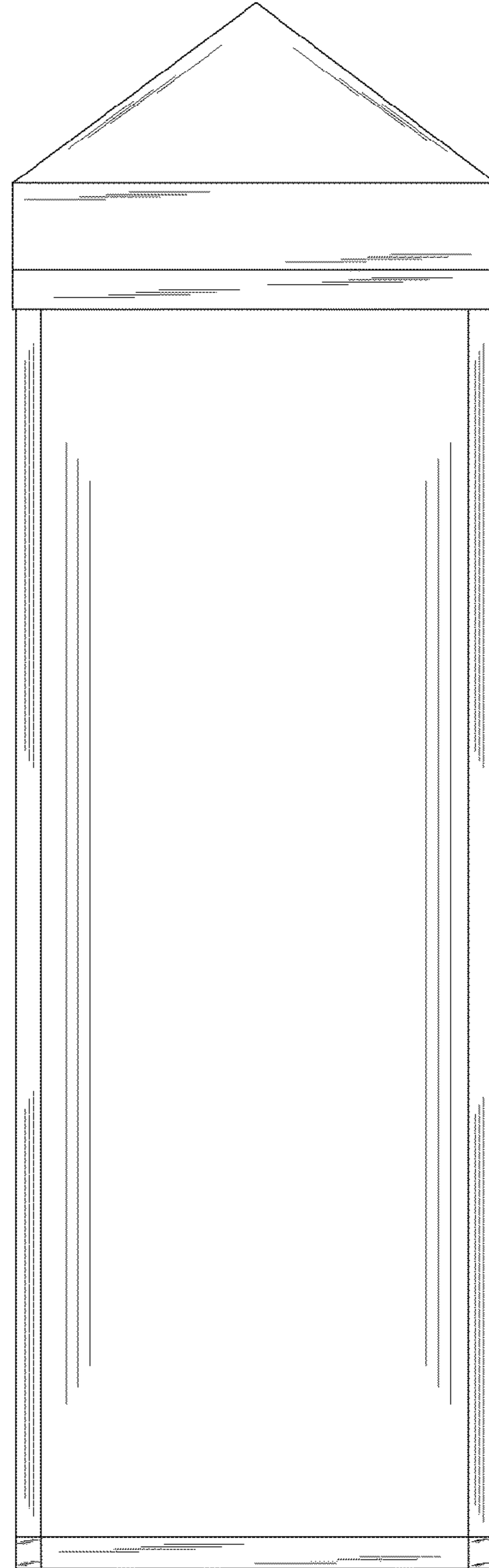

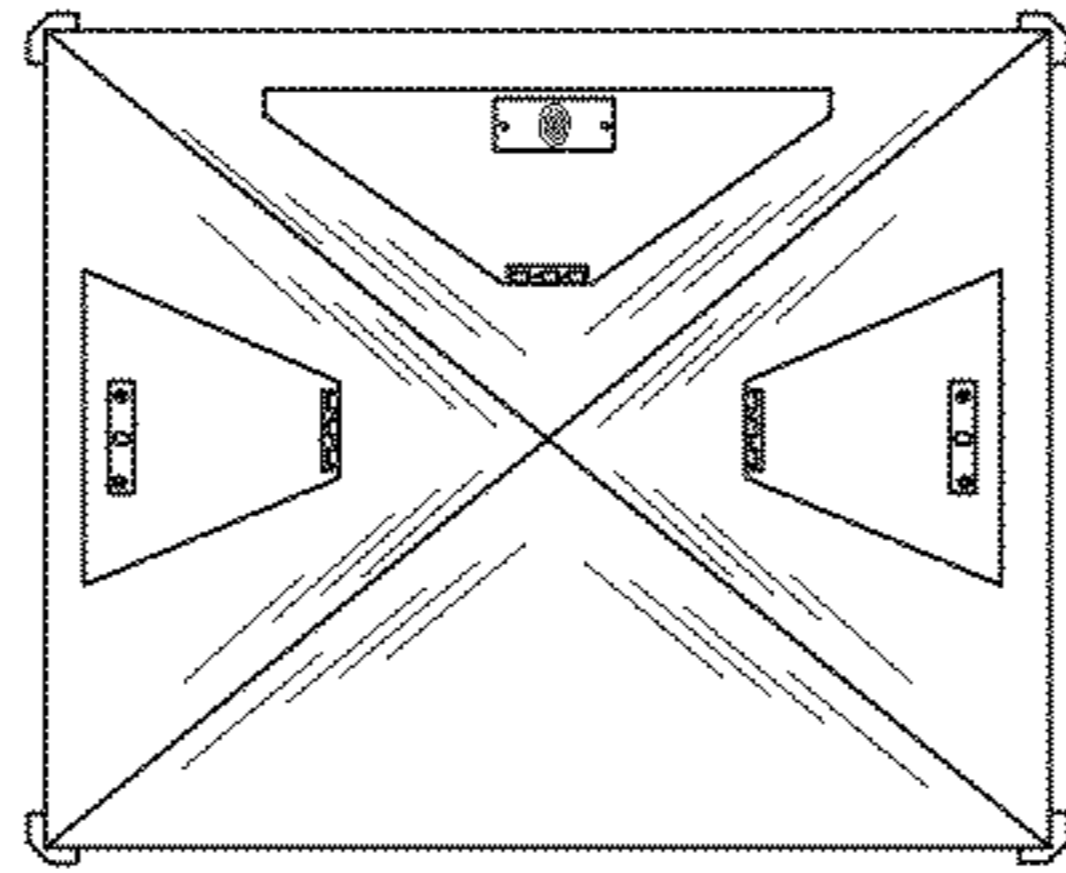

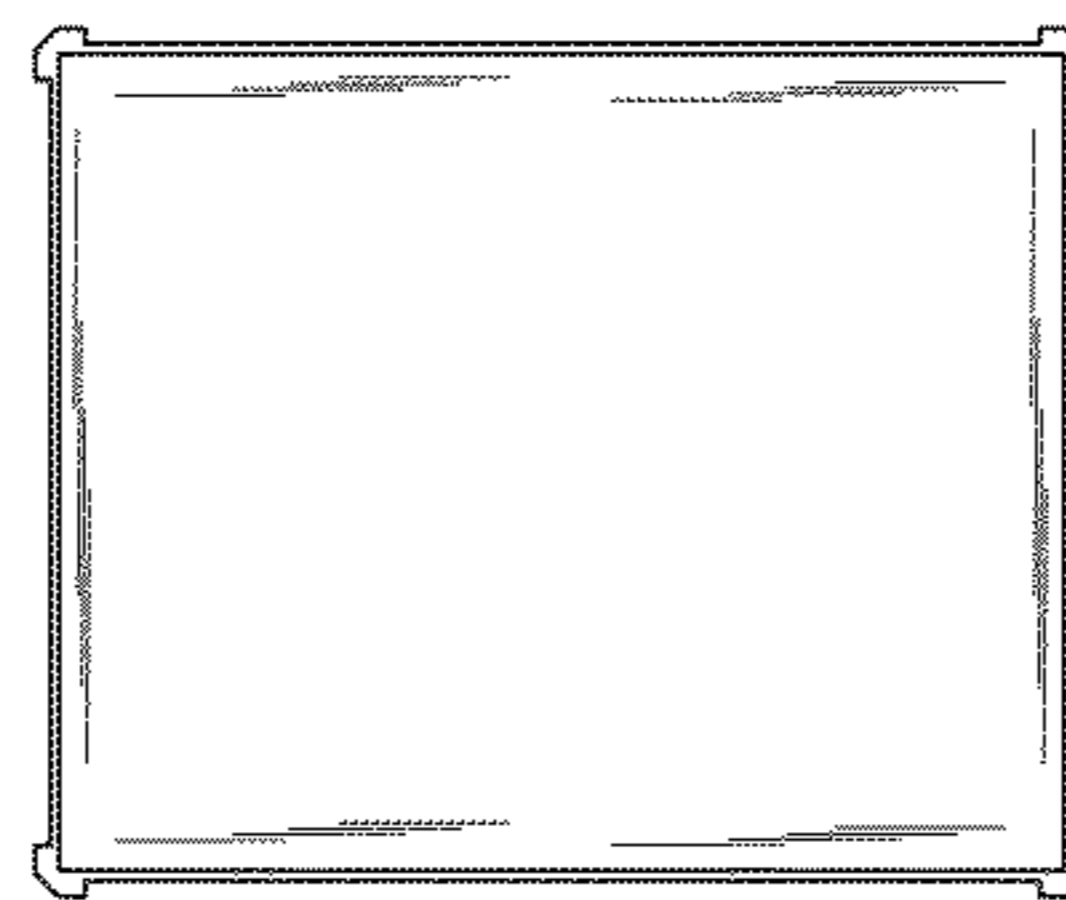

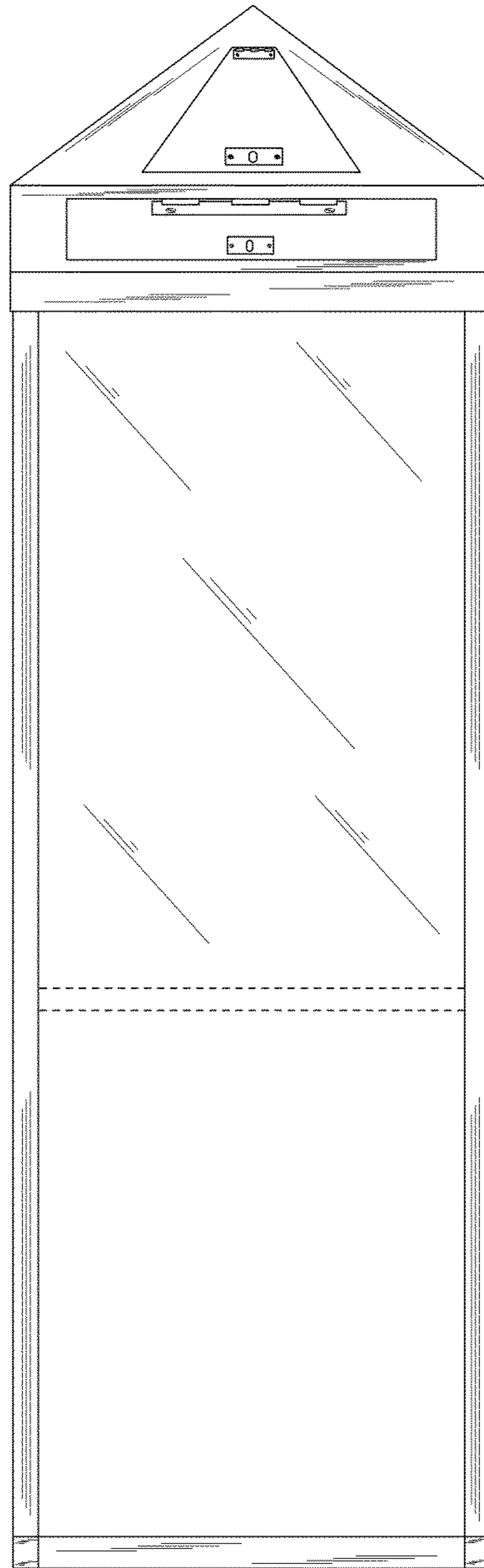
