(57) **CLAIM**

The ornamental design for a ten sided fin-style LED corn-cob light bulb, as shown and described.

DESCRIPTION

FIG. 1 is a plan front view of a ten sided fin-style LED corn-cob light bulb showing my new design; the plan back view being a mirror image;

FIG. 2 is a right side view thereof the left side view being a mirror image;

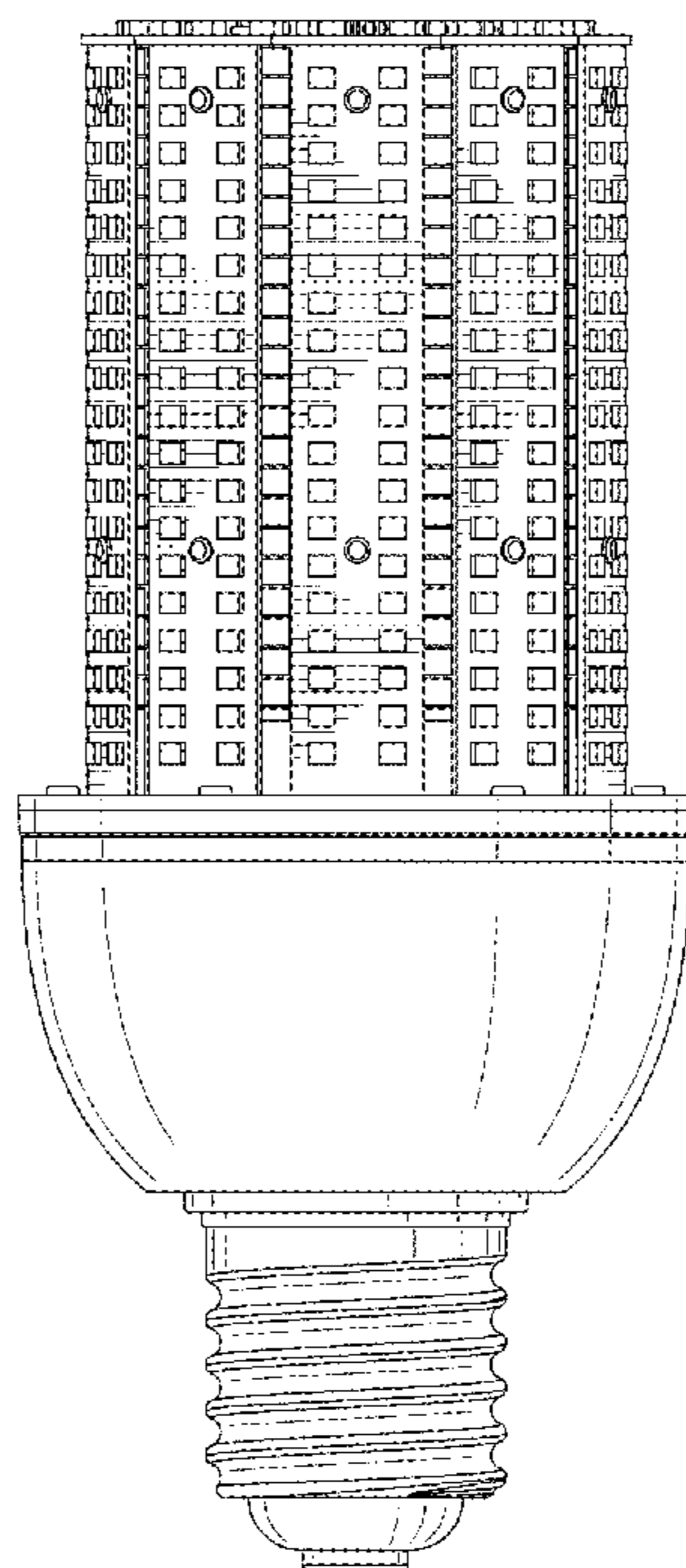
FIG. 3 is a bottom view thereof;

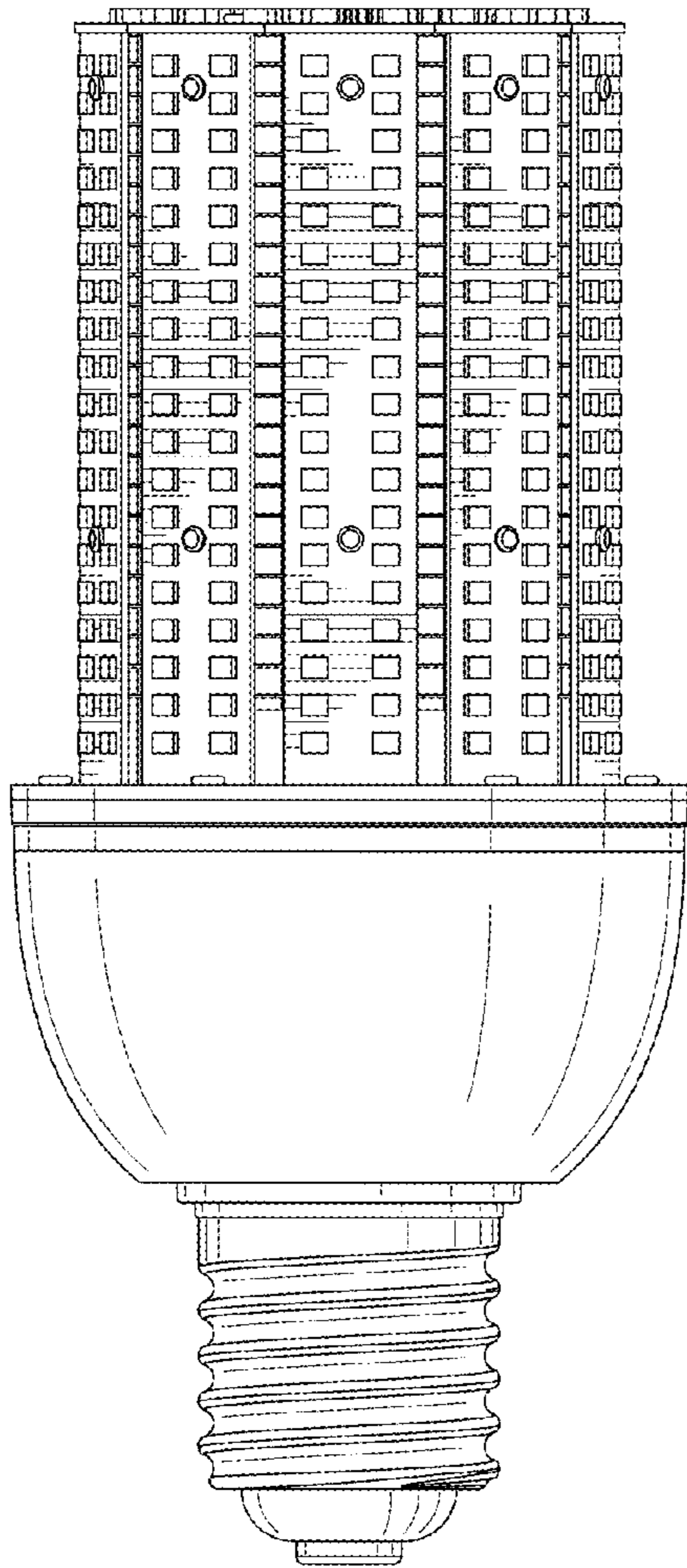
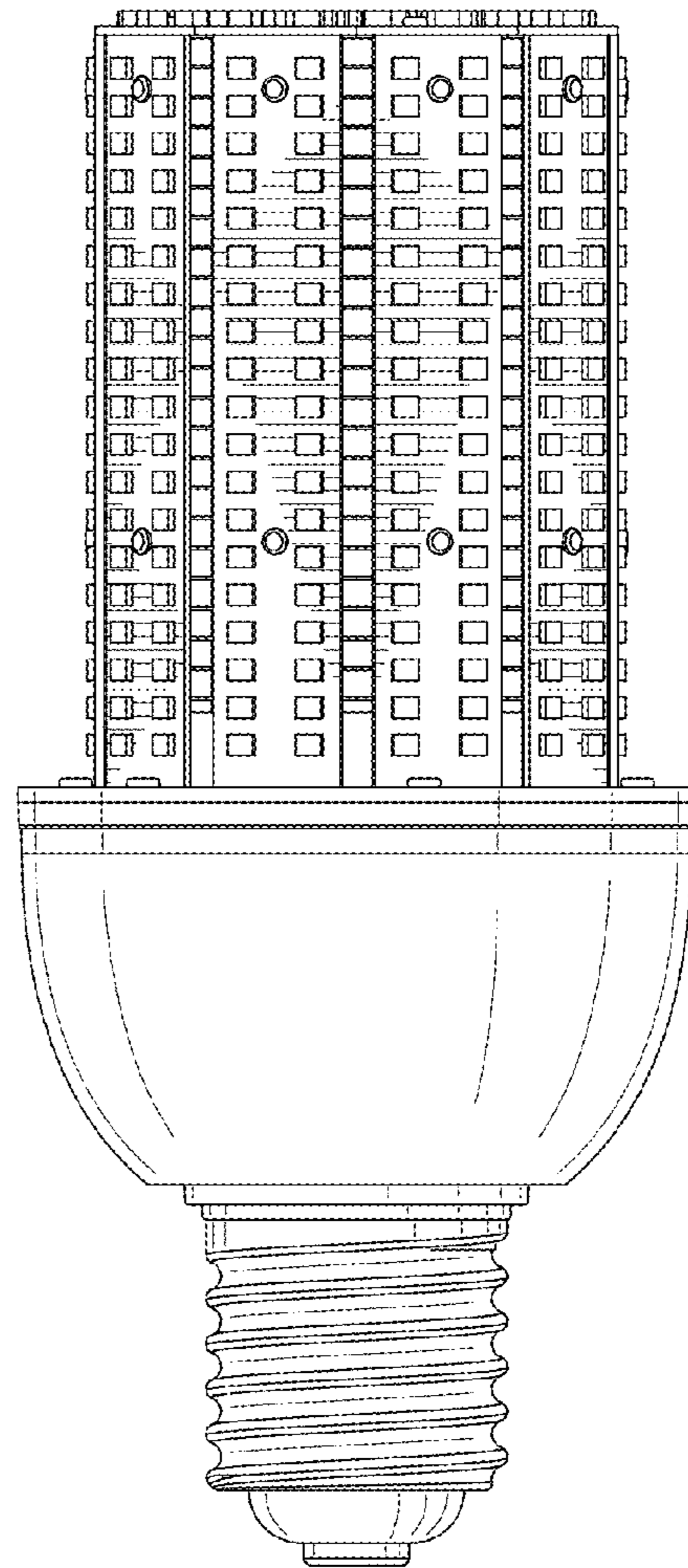

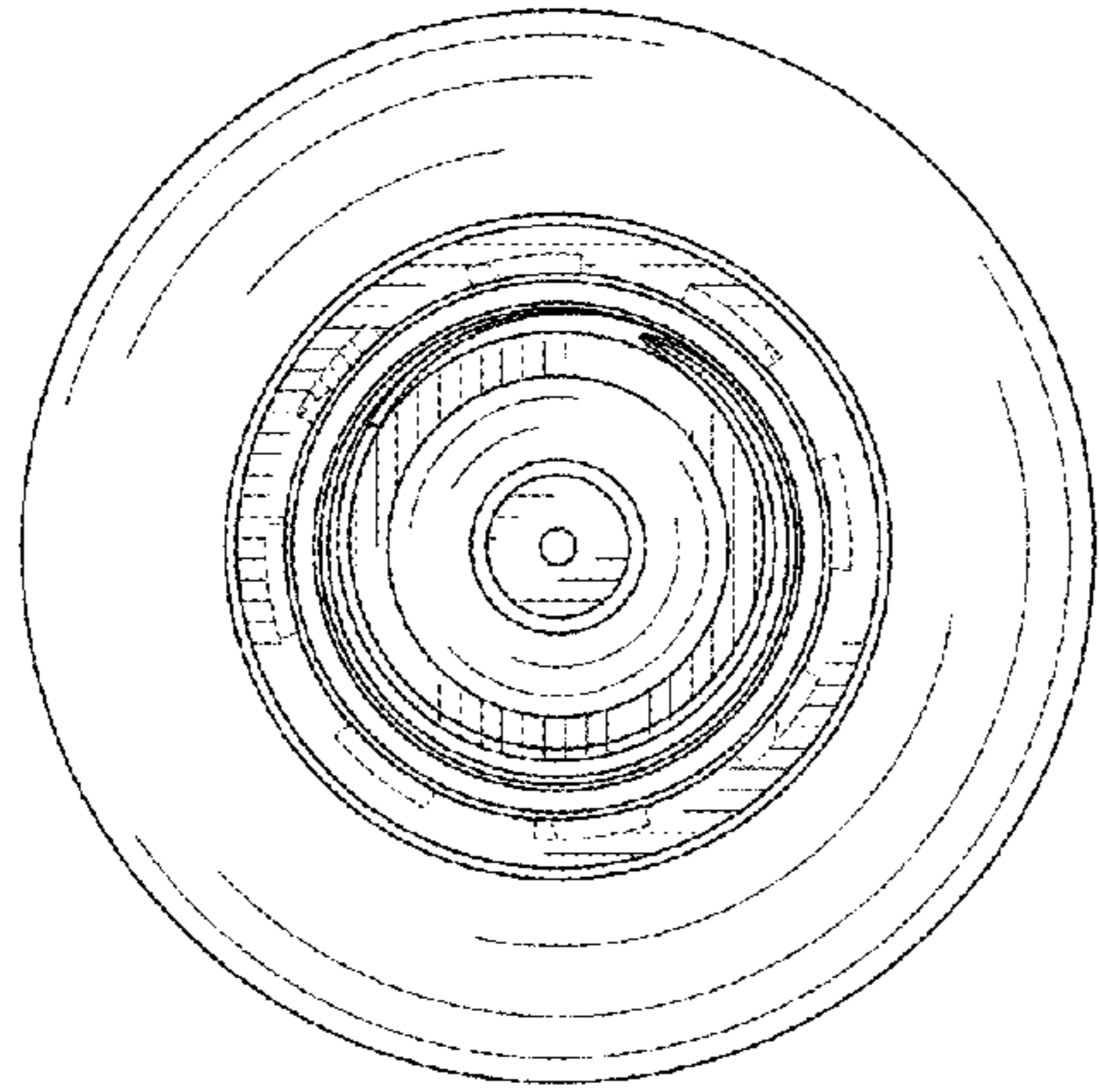

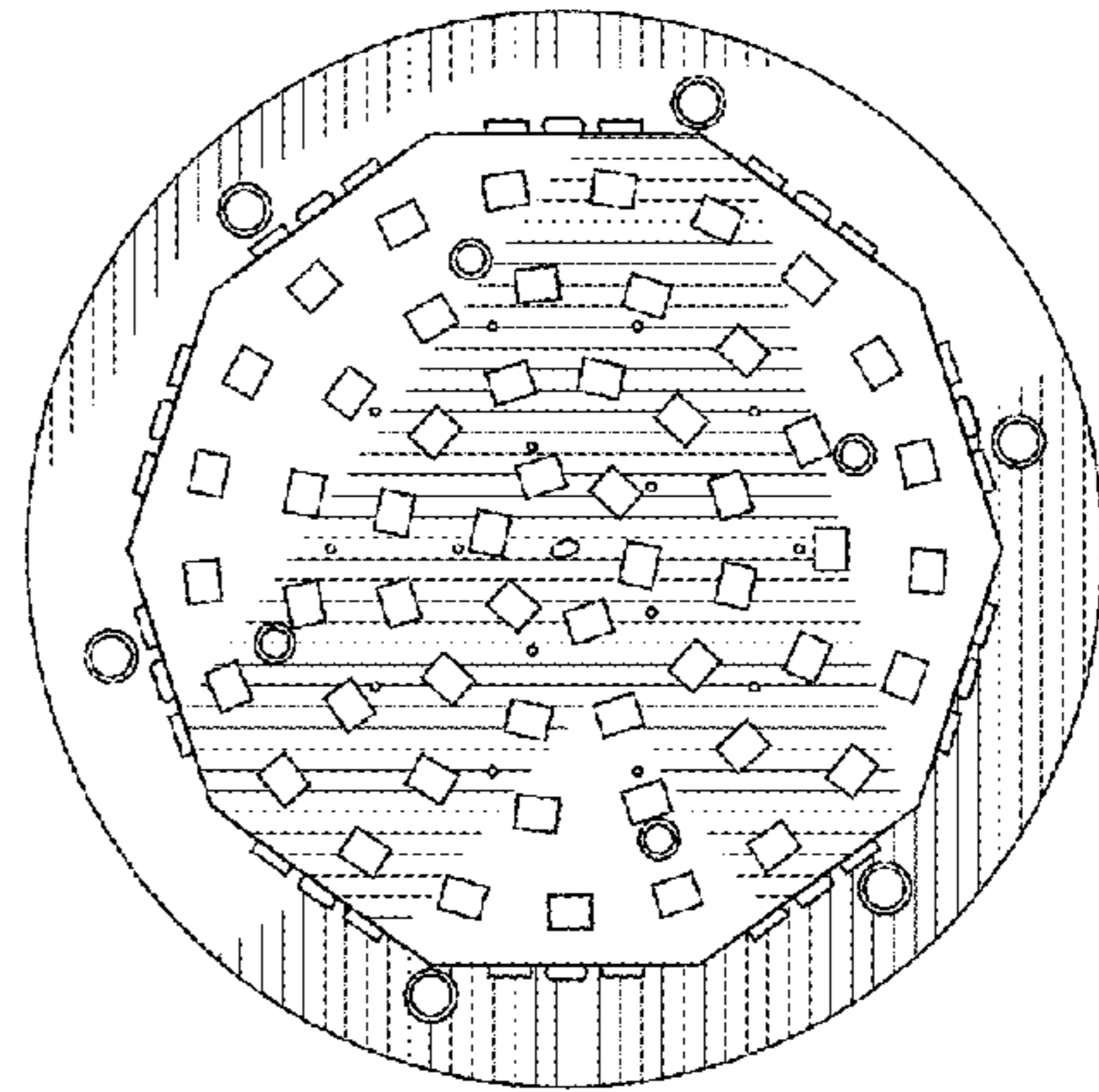

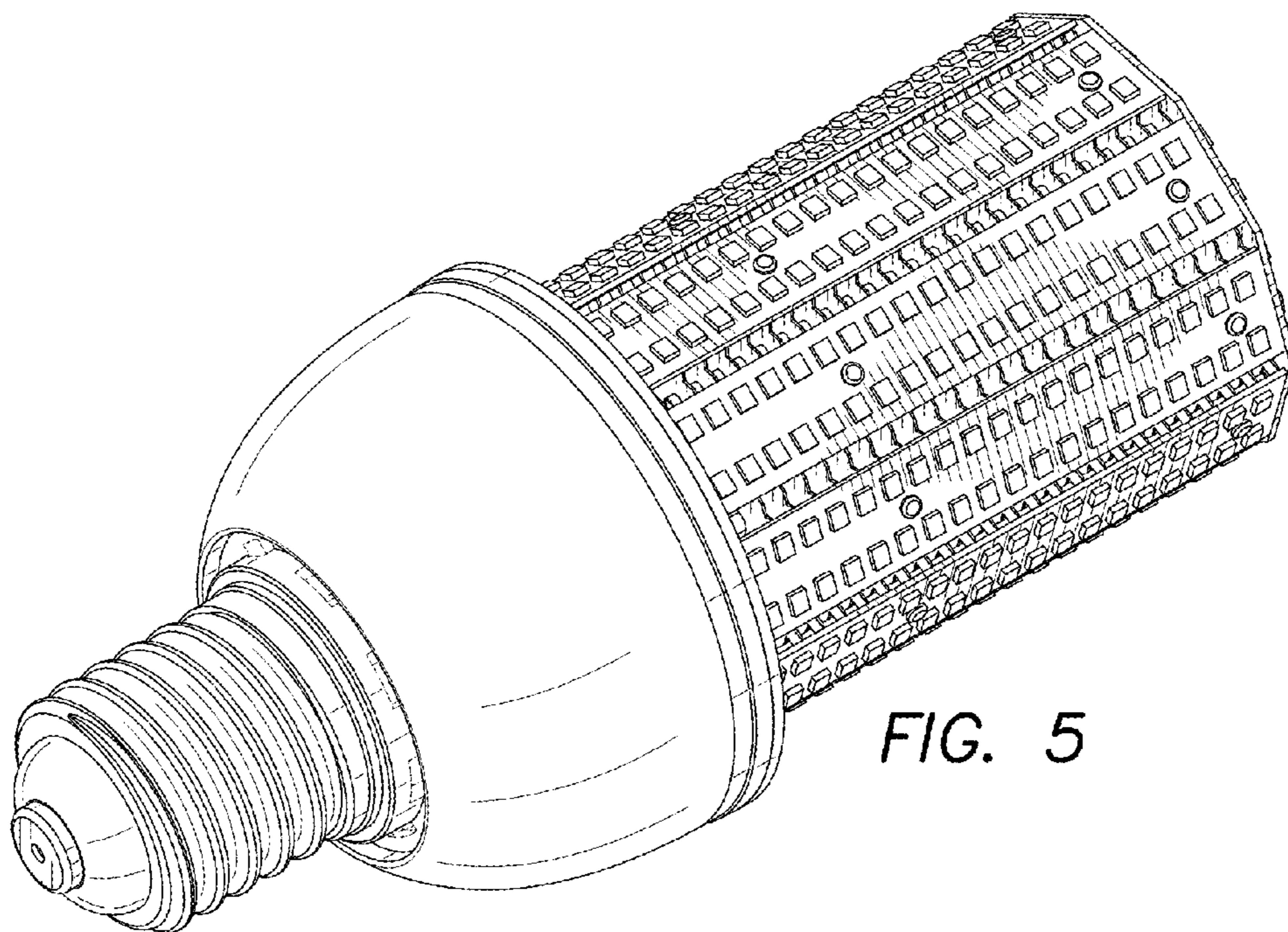
