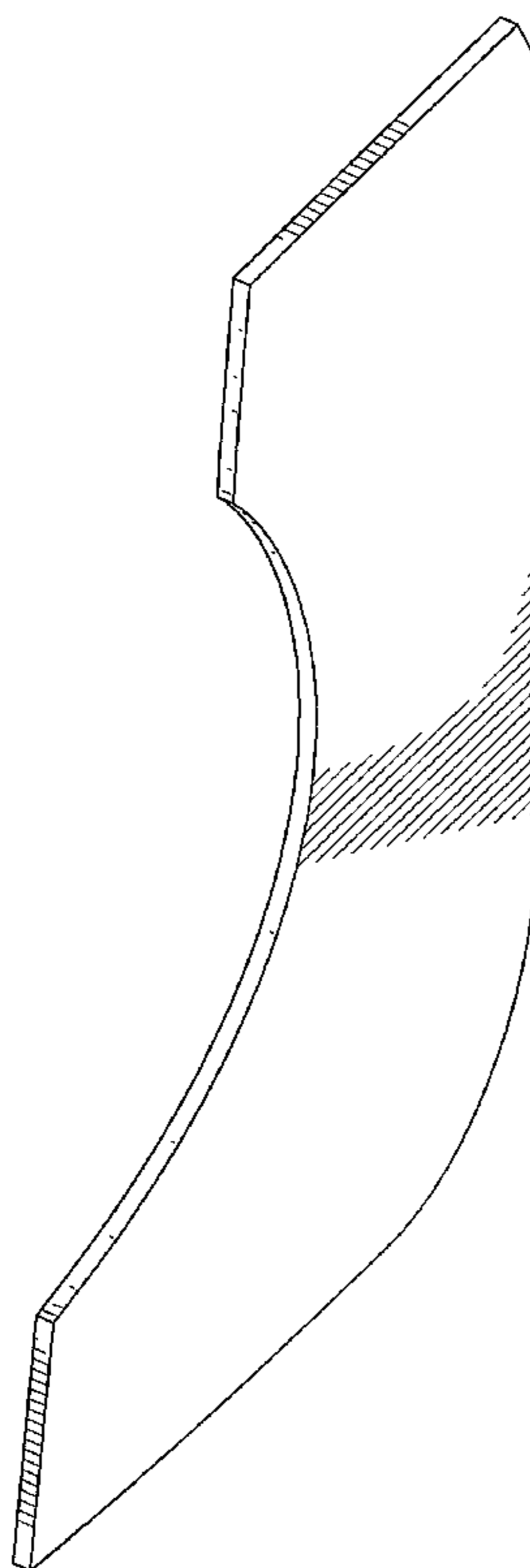
(57) **CLAIM**

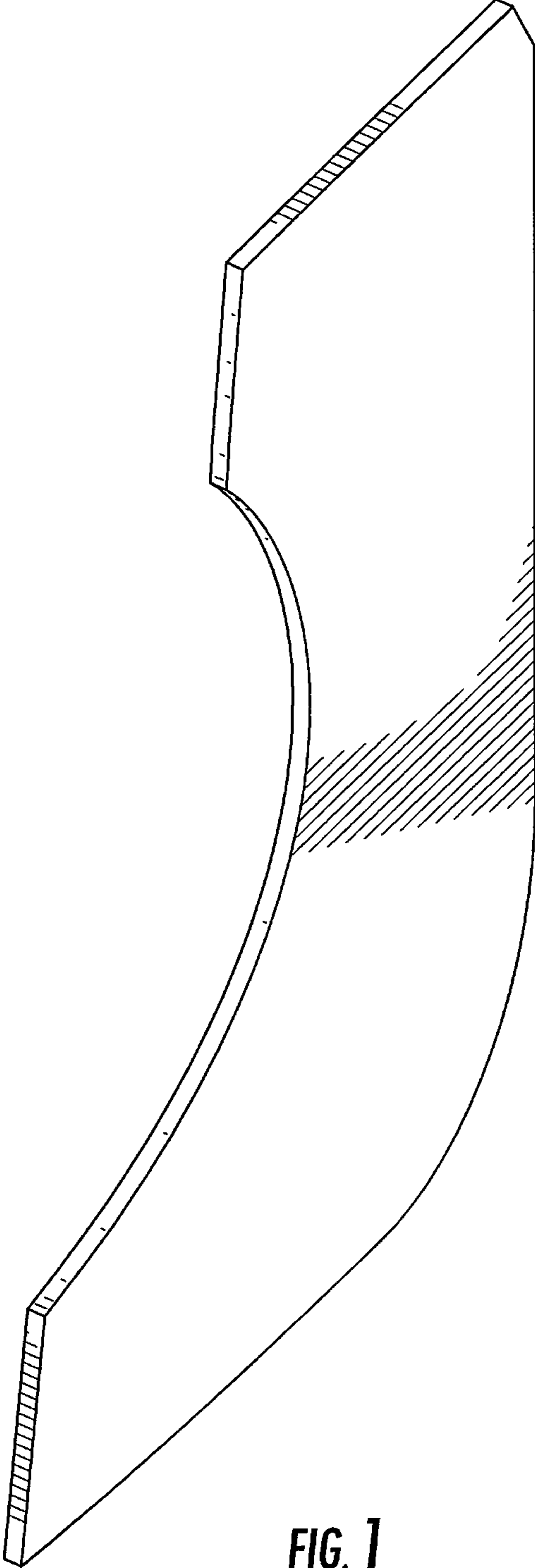
The ornamental design for a recoil pad for shooting apparel, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the recoil pad for shooting apparel of the present invention; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a top view thereof; FIG. 7 is a bottom view thereof; FIG. 8 is an illustrative view of the recoil pad for shooting apparel in combination with a piece of apparel; and, FIG. 9 is an illustrative view of the recoil pad for shooting apparel in combination with a piece of apparel. The broken lines shown in FIGS. 8 and 9 show unclaimed environmental matter only and form no part of the claimed design.

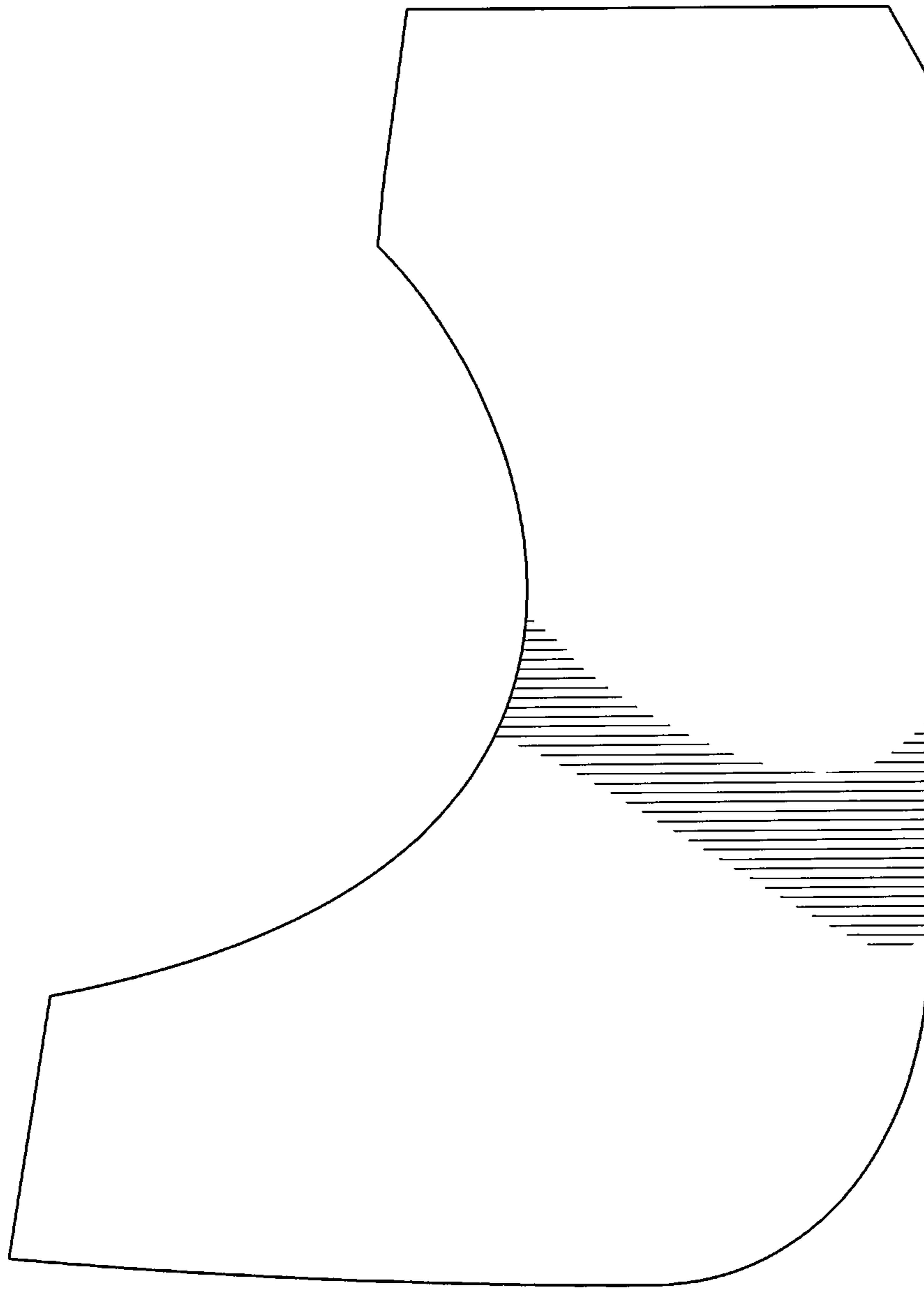

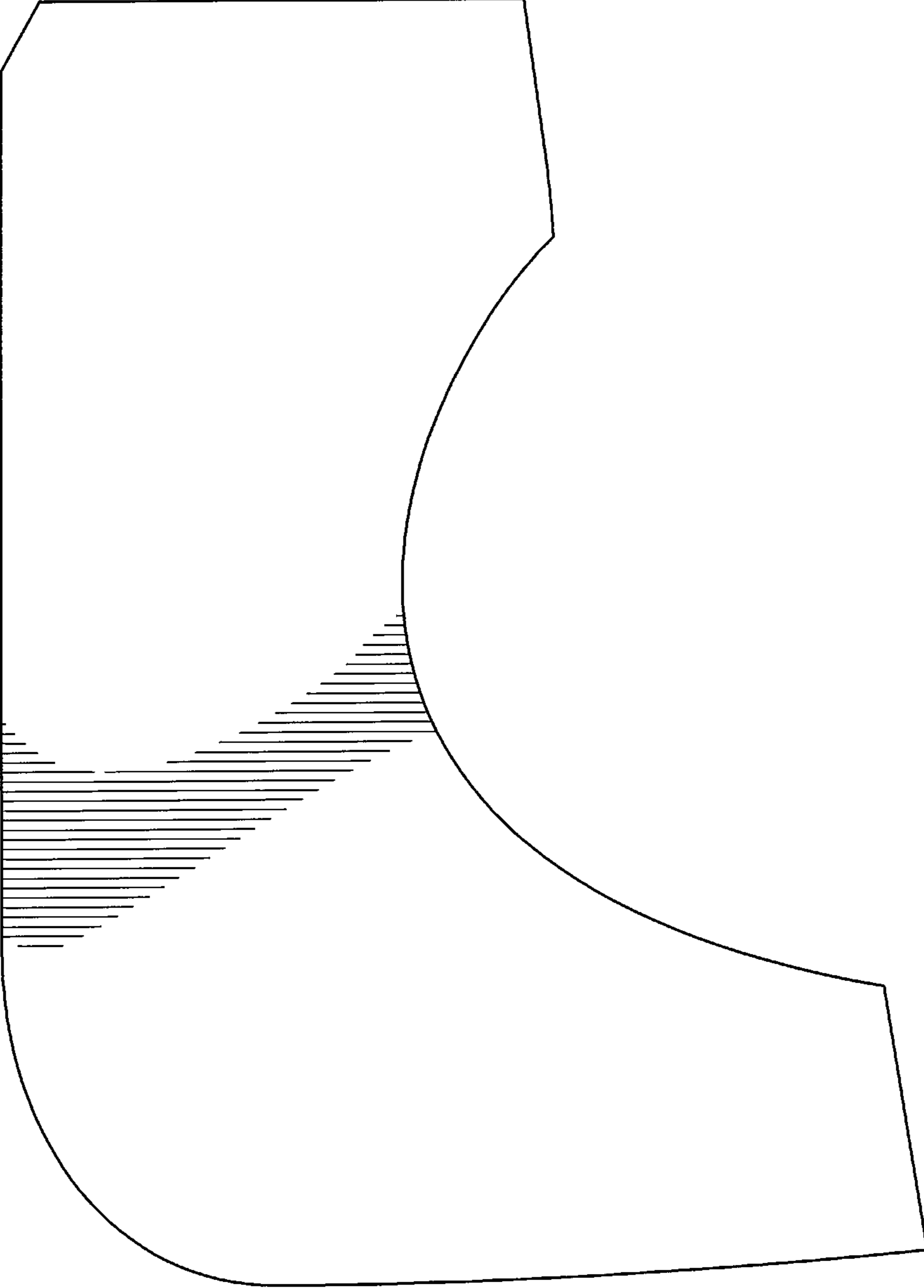

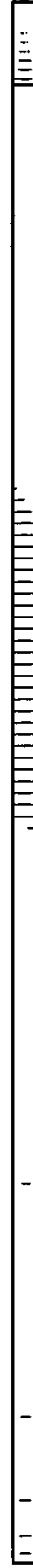

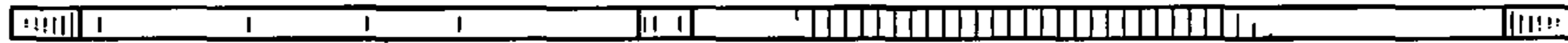

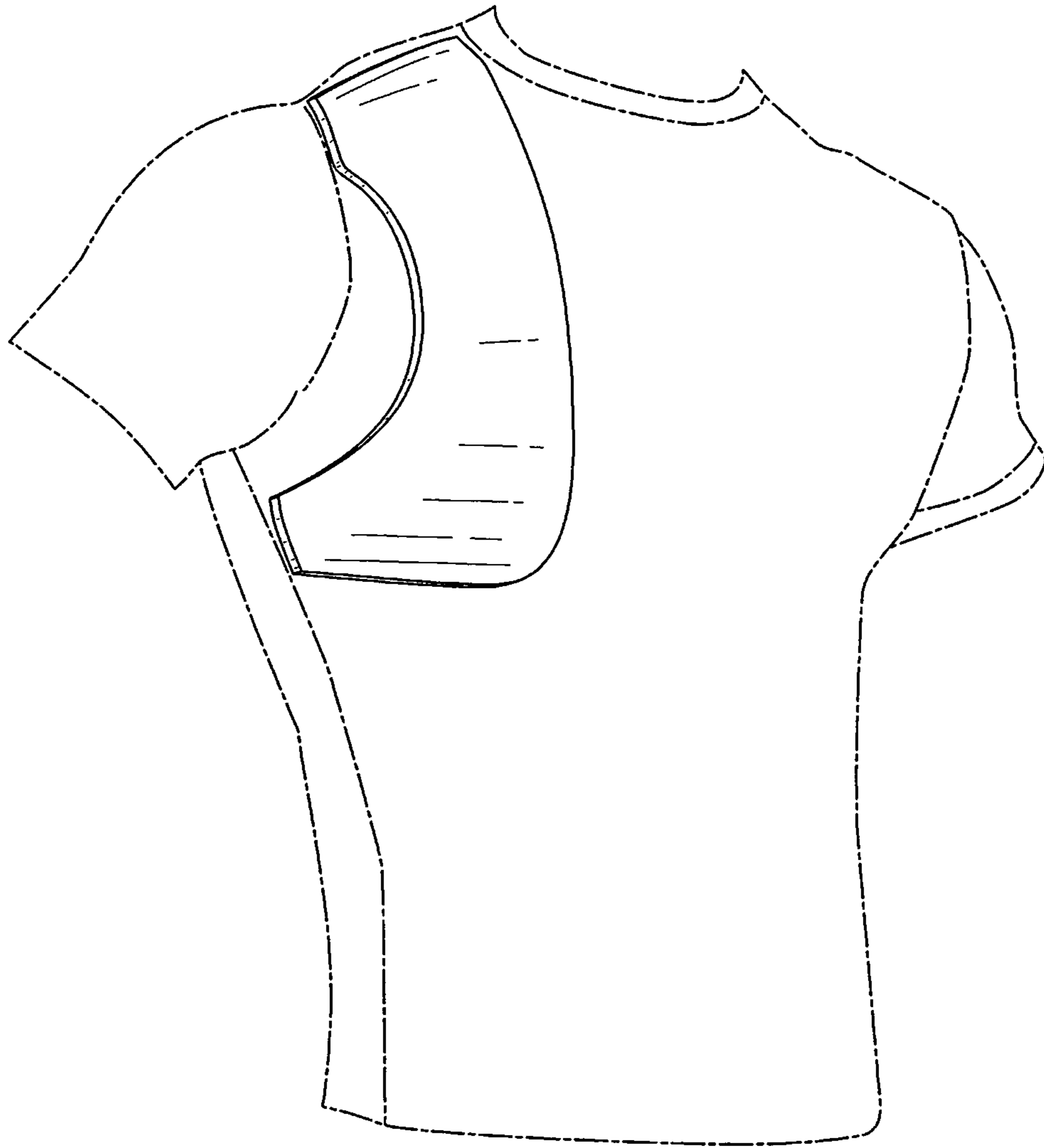

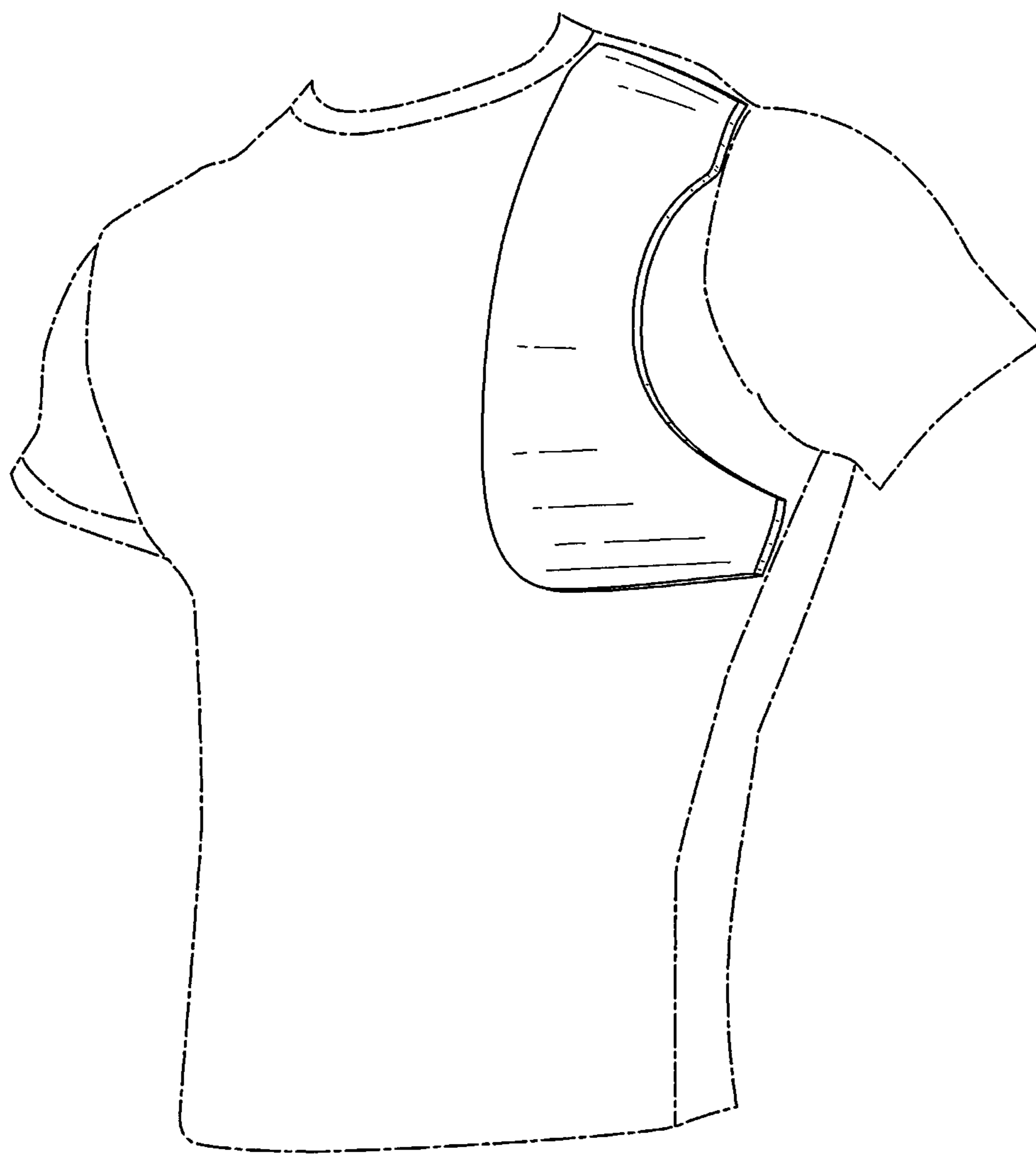
