DESCRIPTION

FIG. 1 is a perspective view of the football player transforming device in full lines.

FIG. 12 is a rear elevational view thereof.

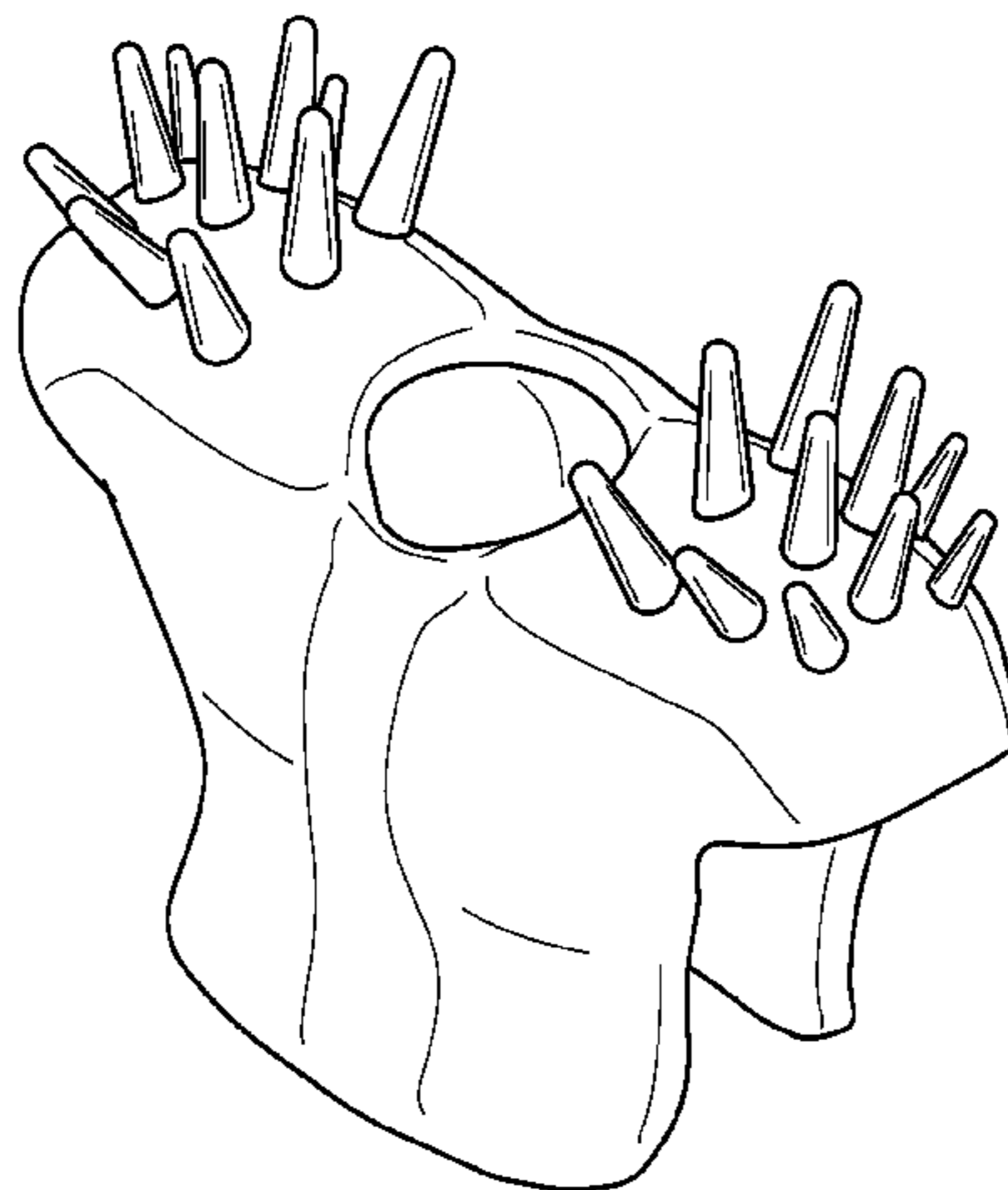
FIG. 13 is a top plan view thereof.

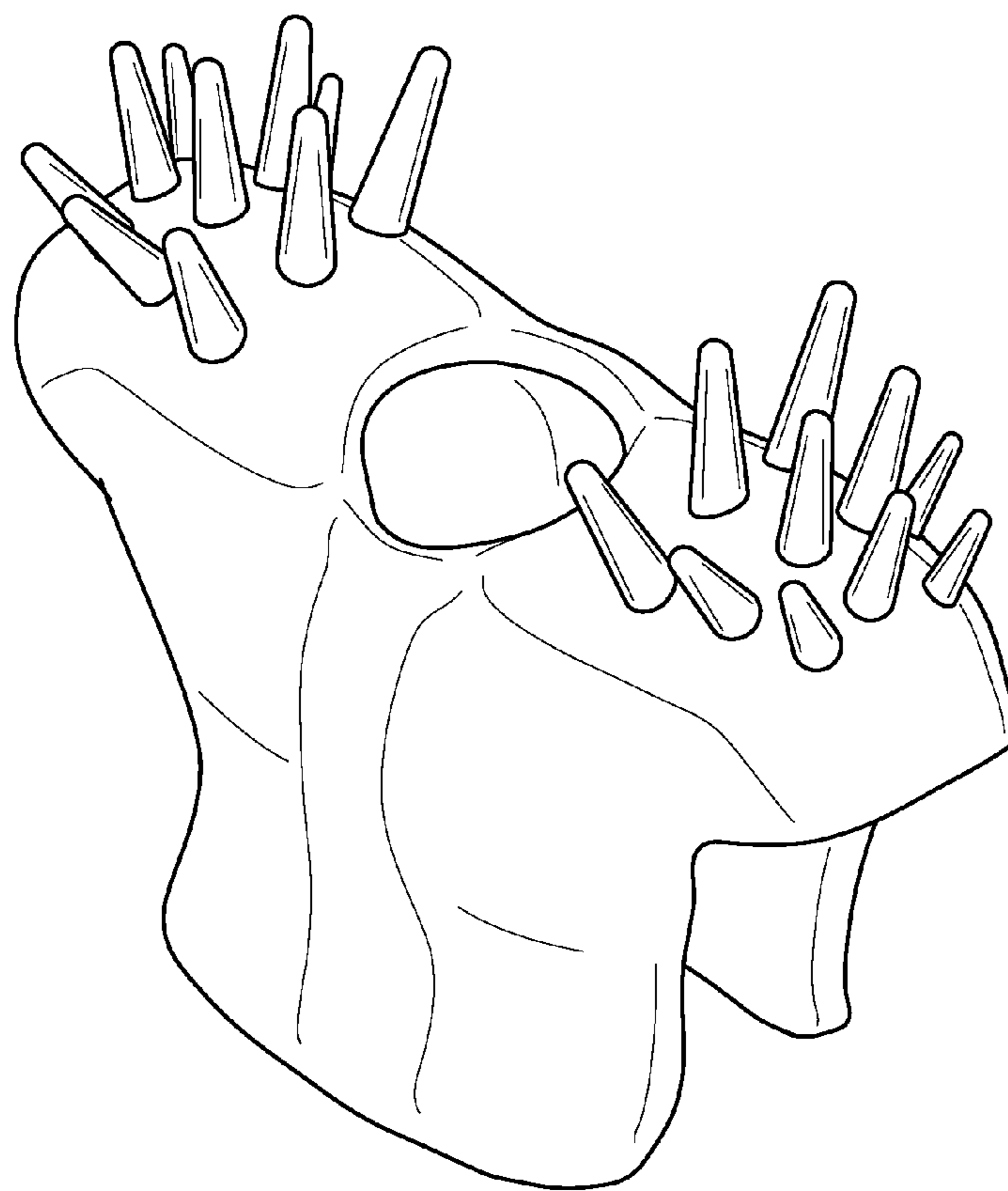

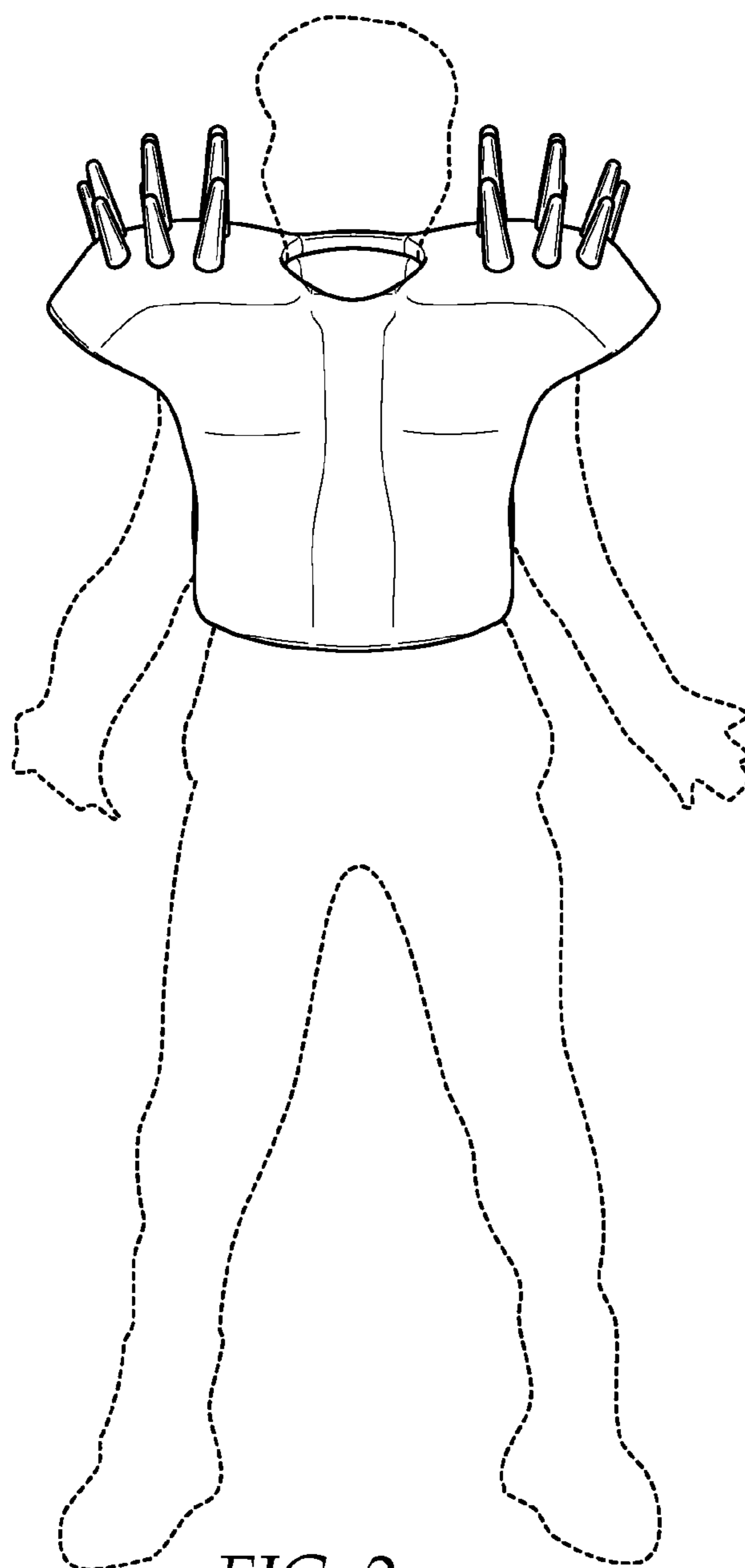

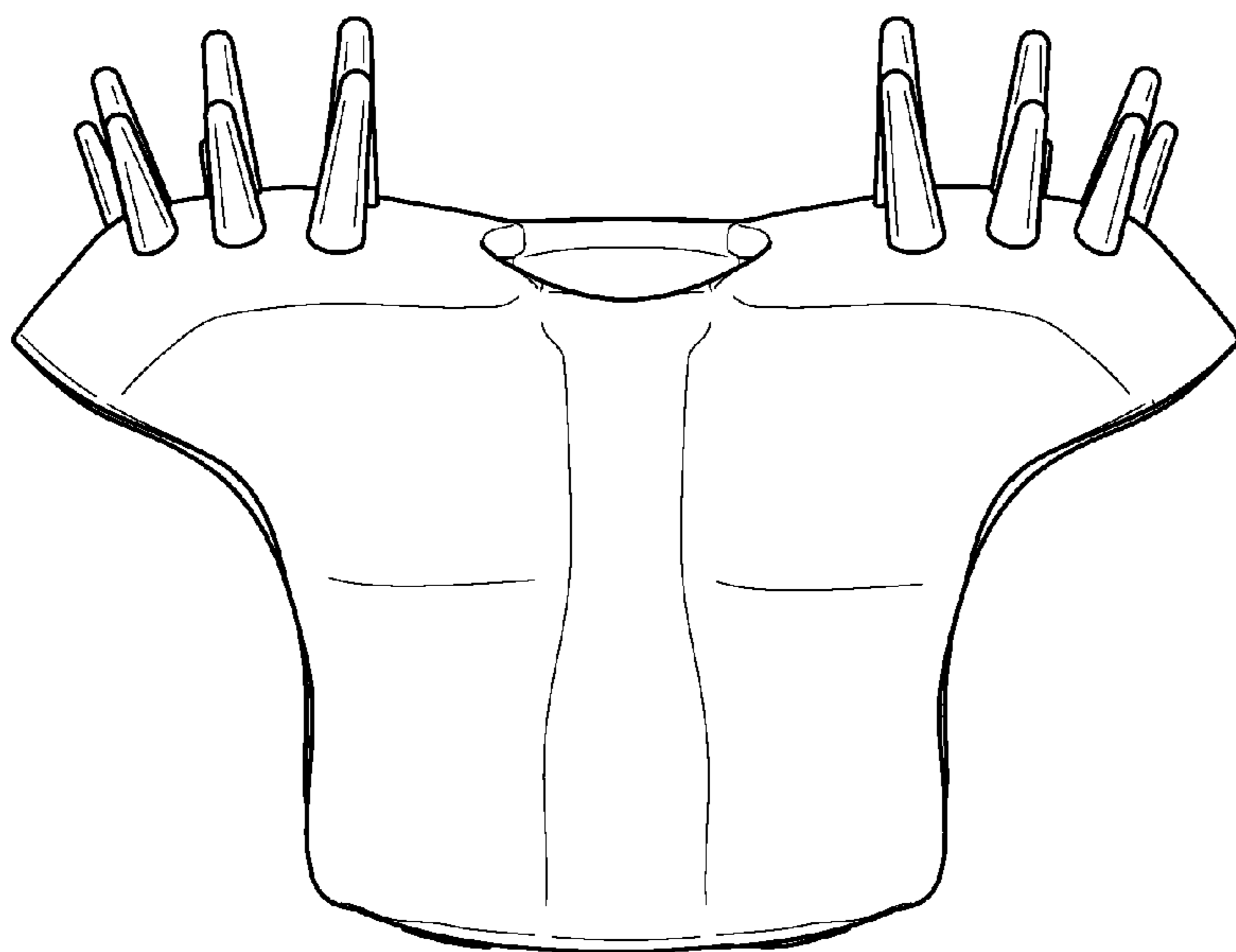

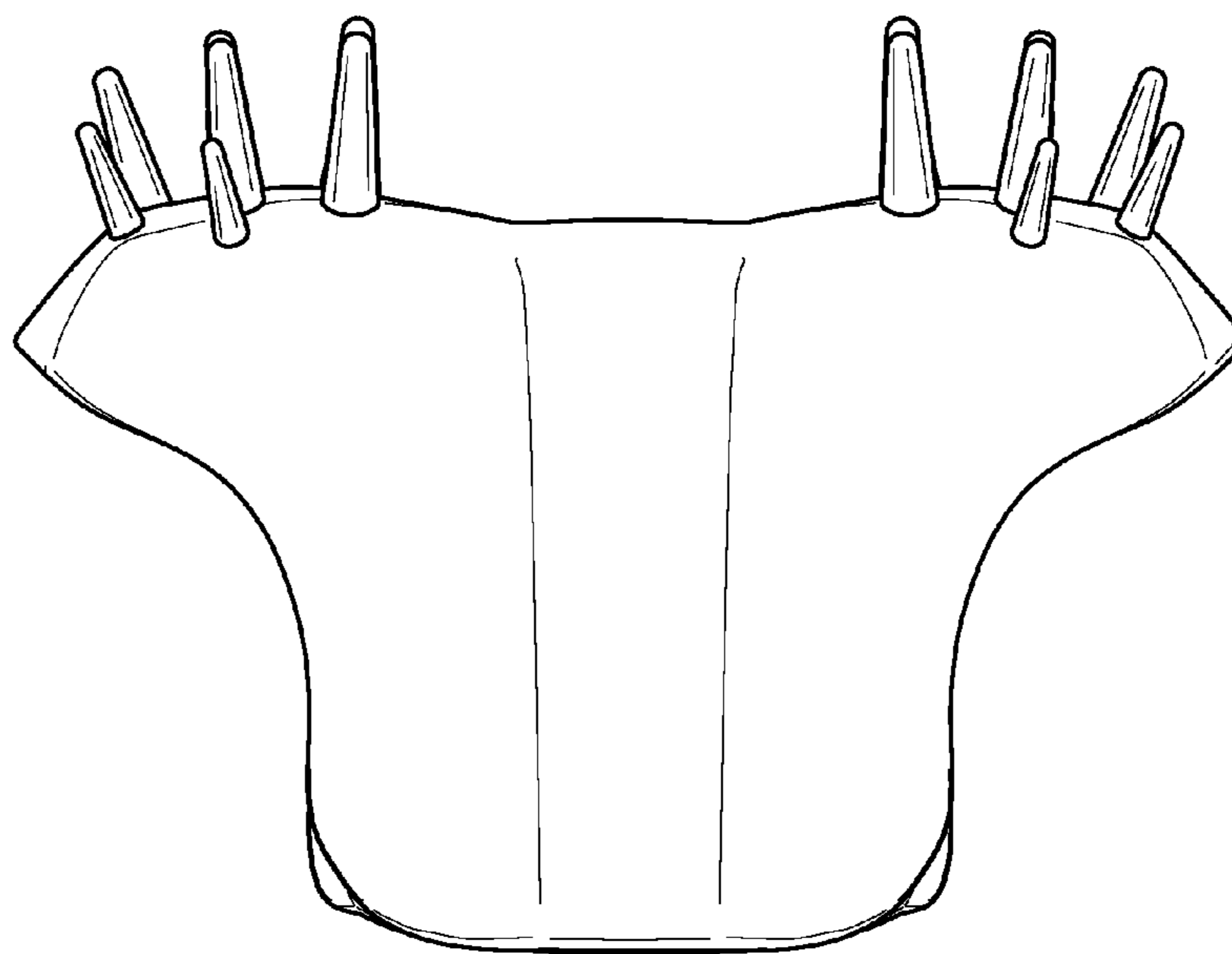

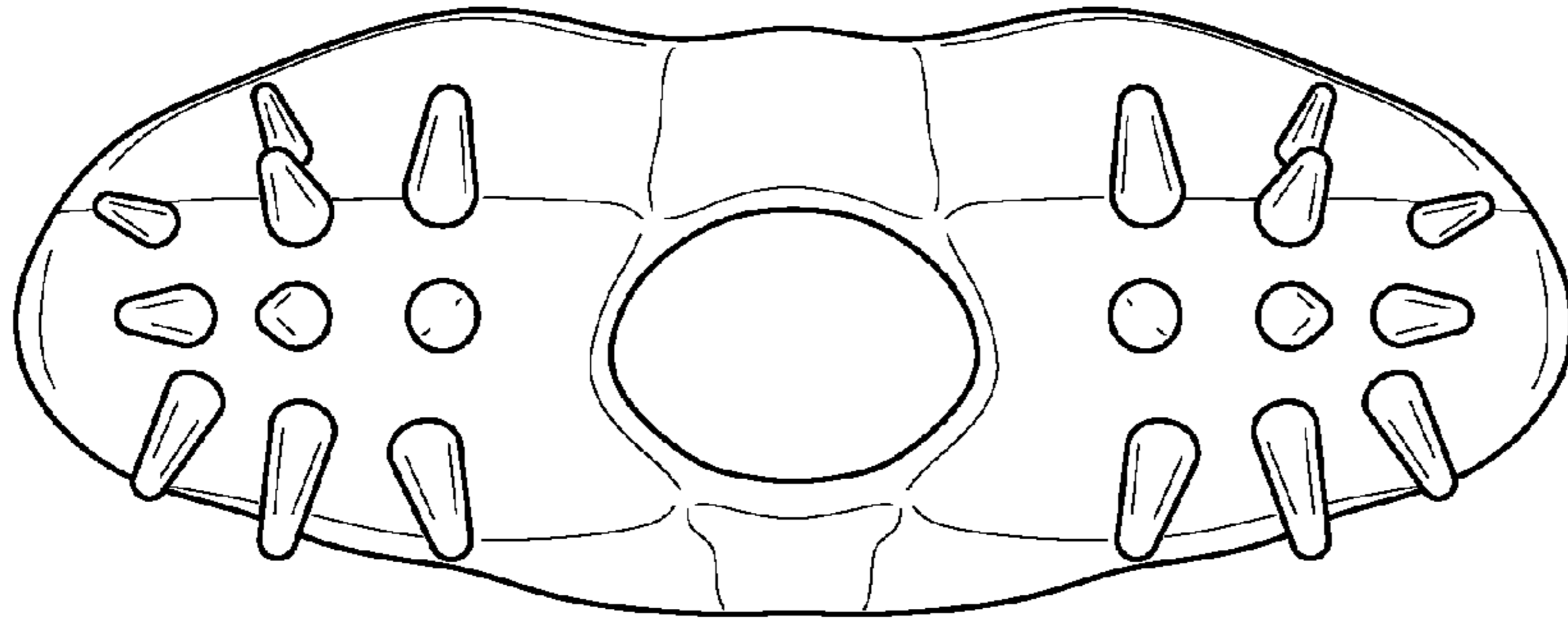

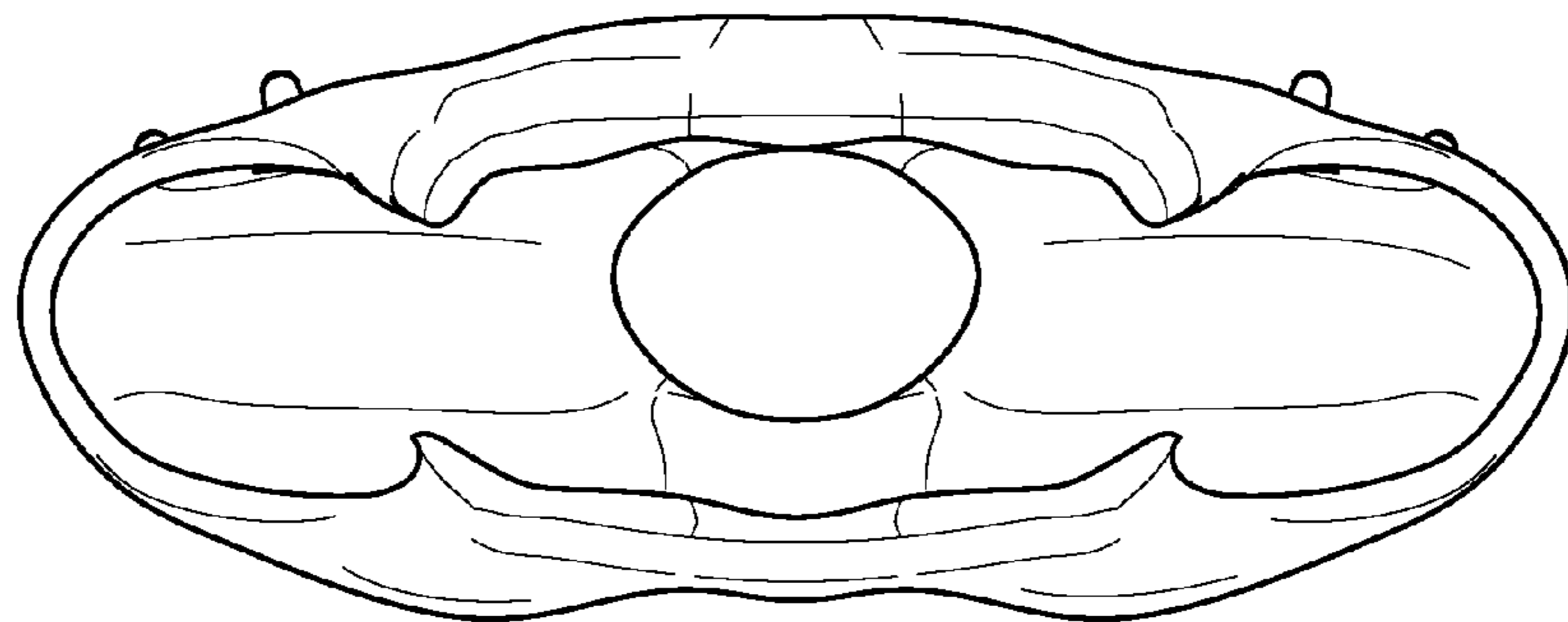

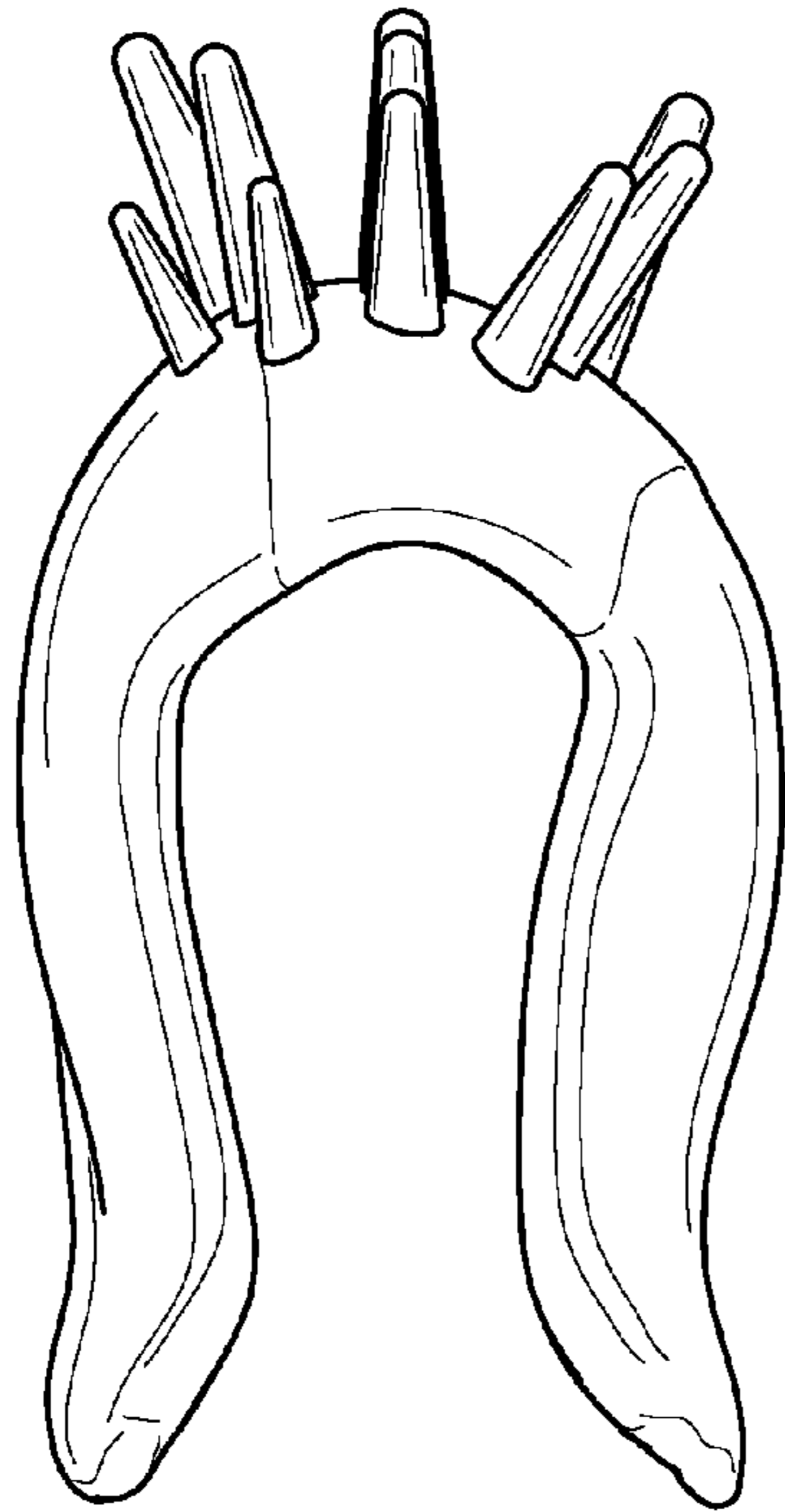

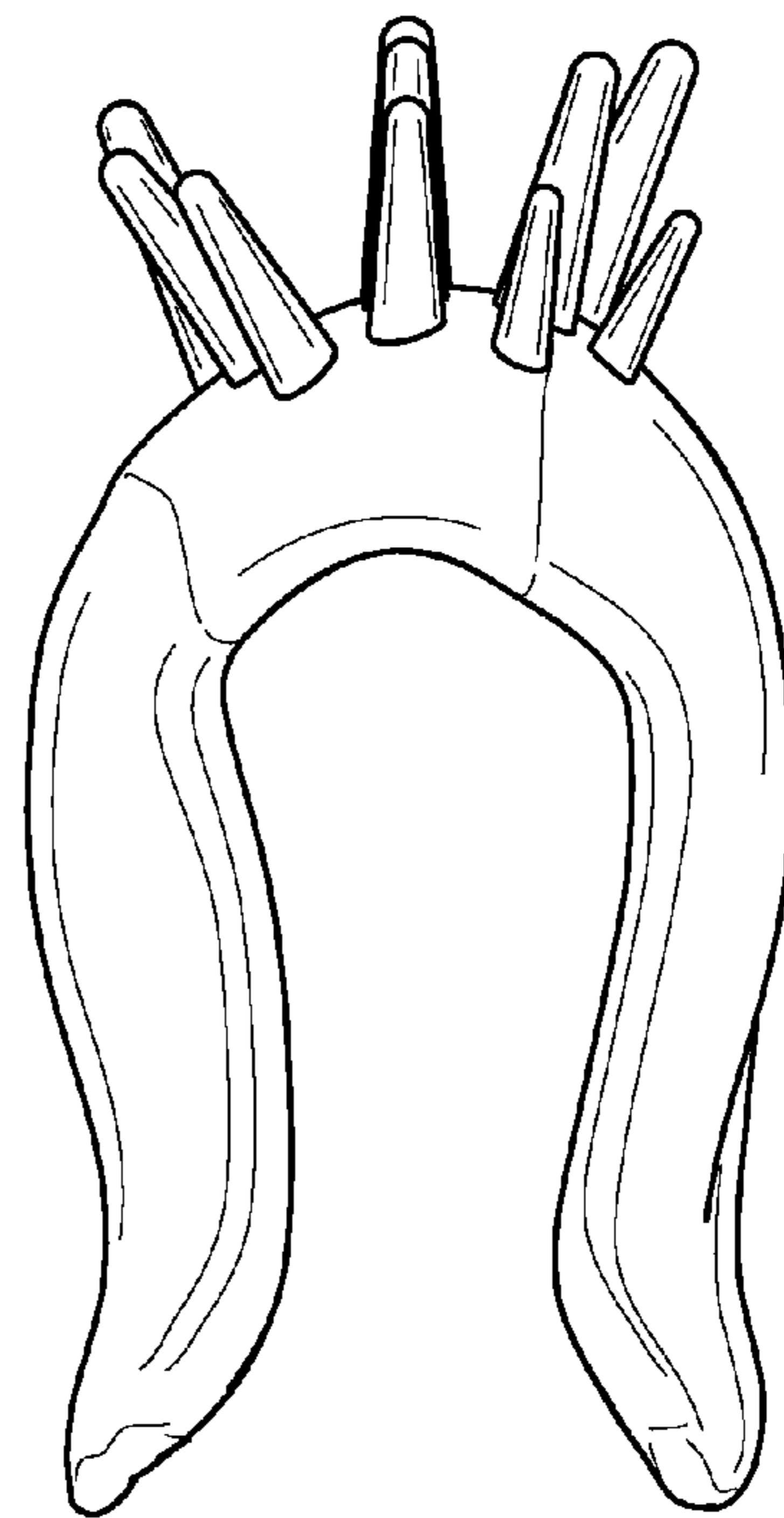

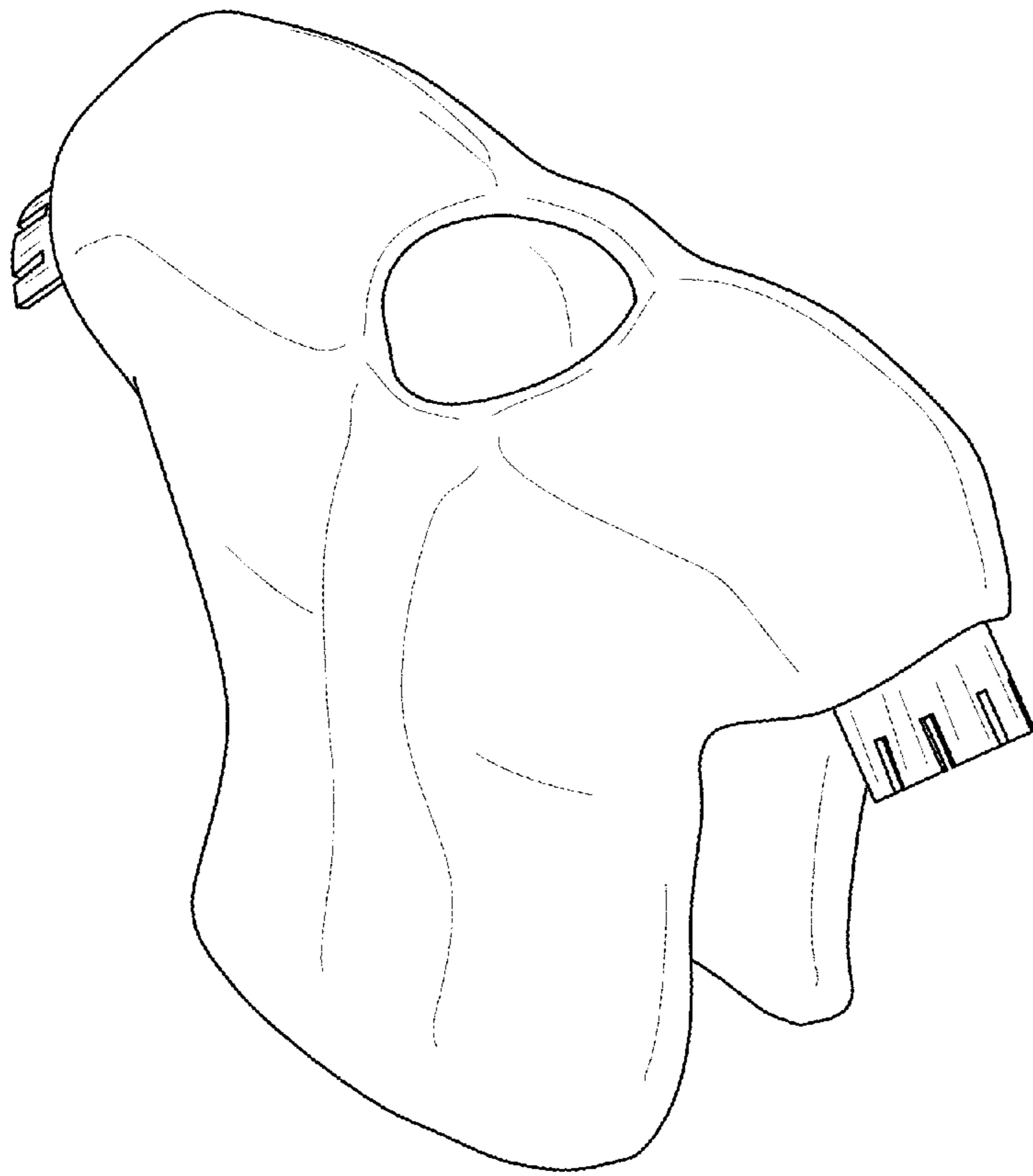

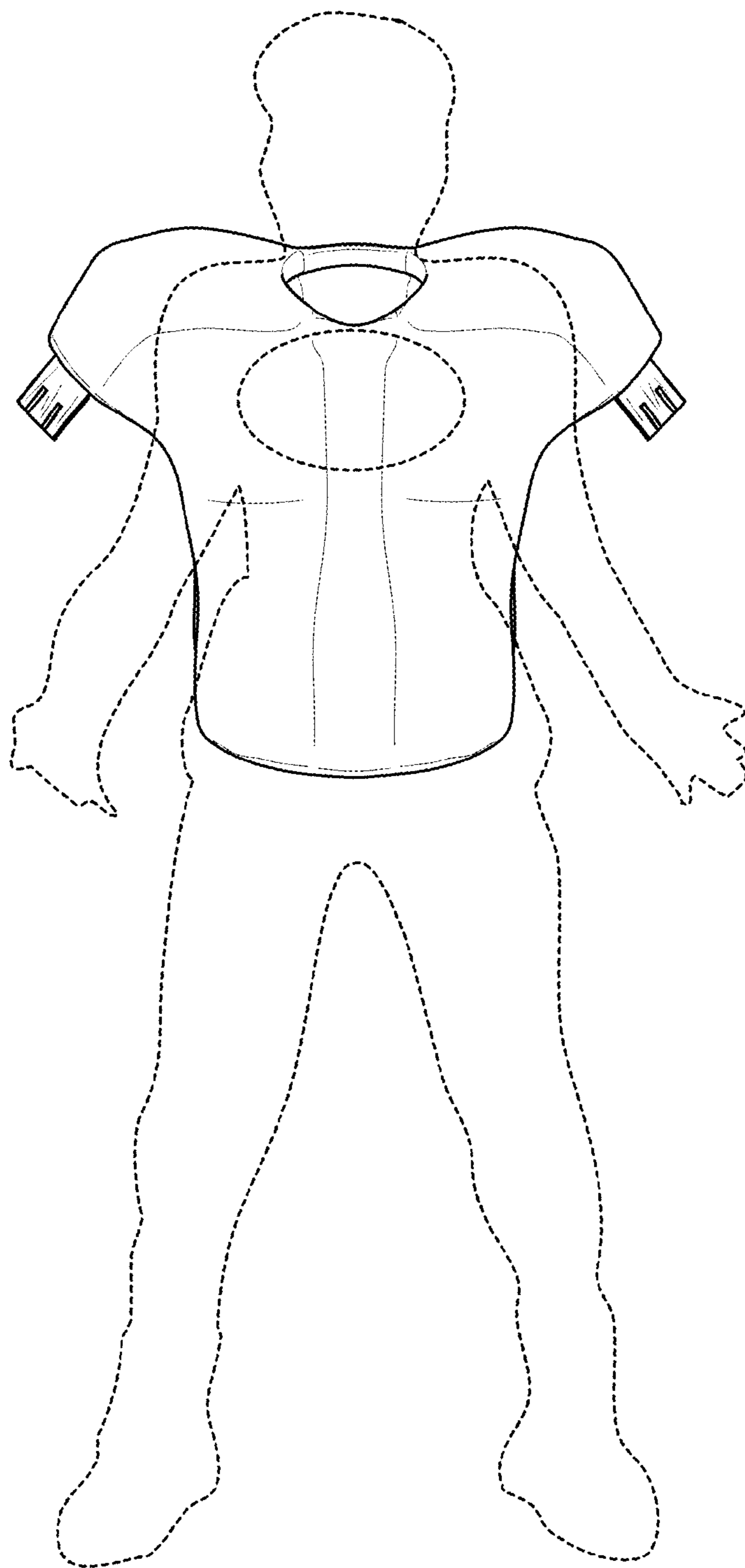

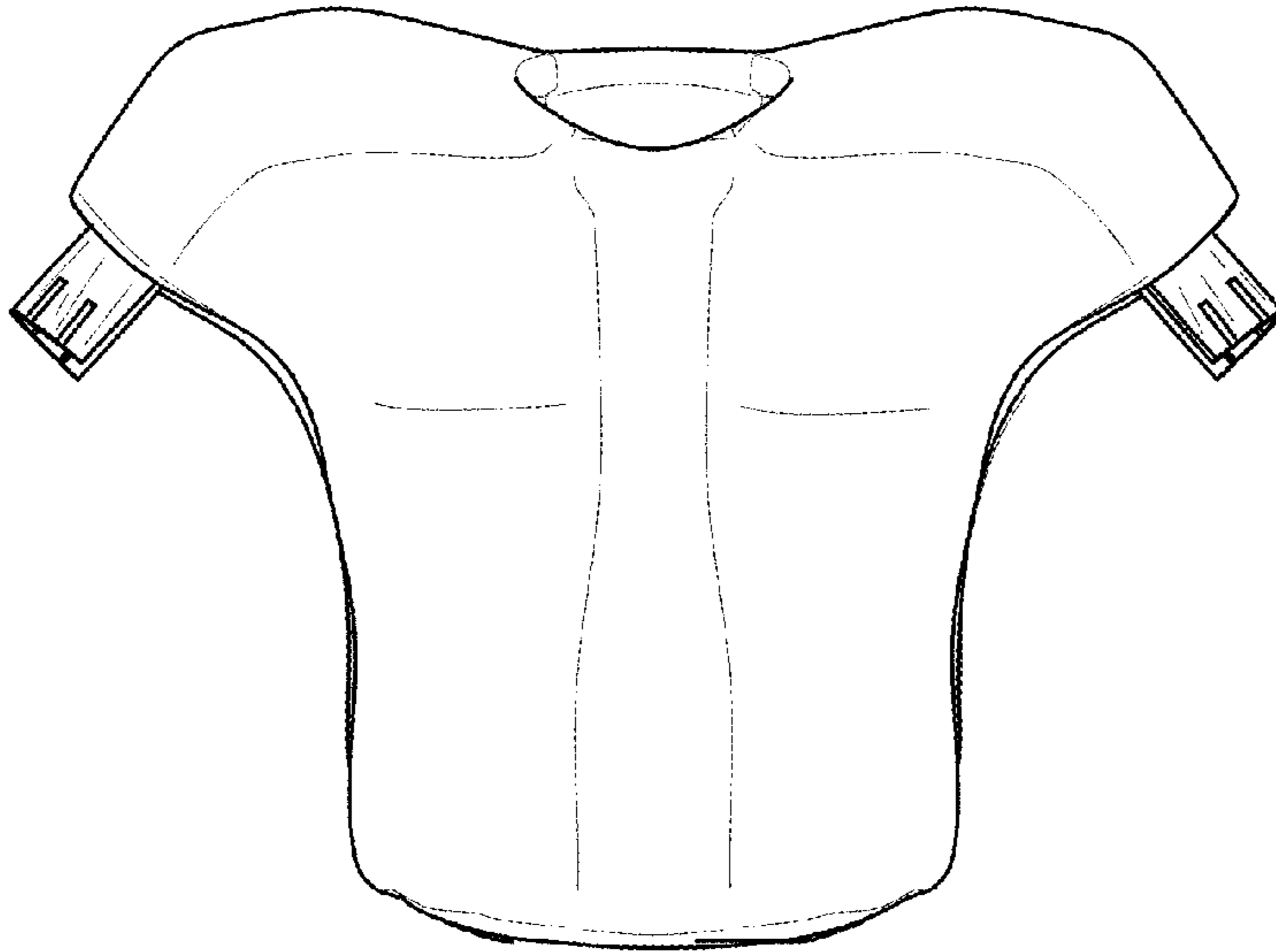

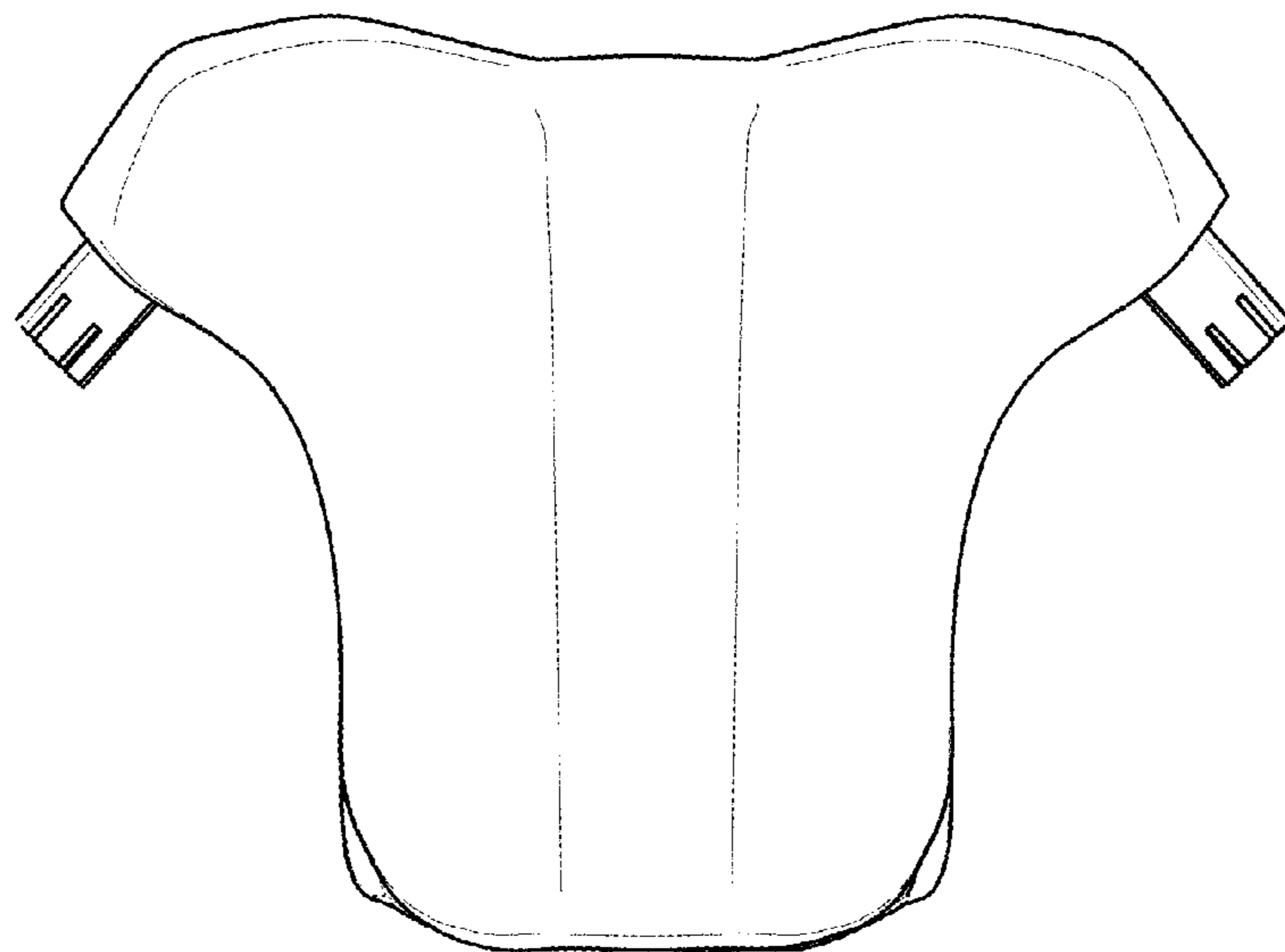

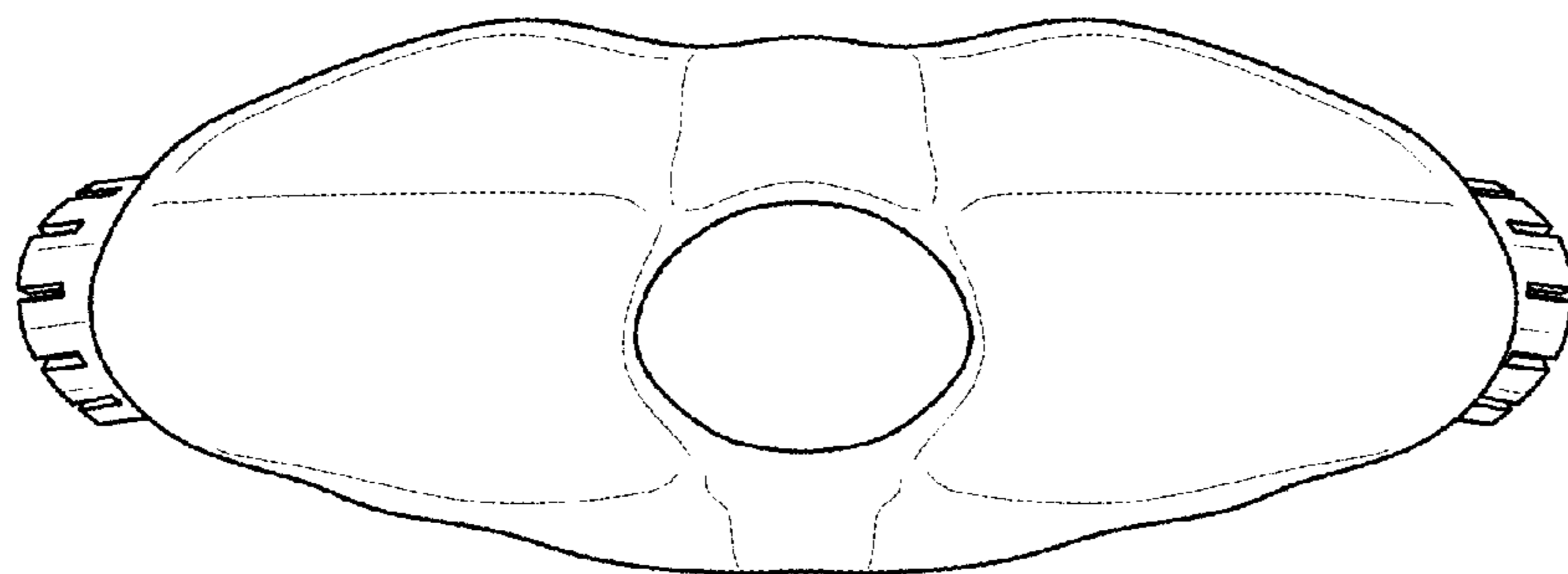

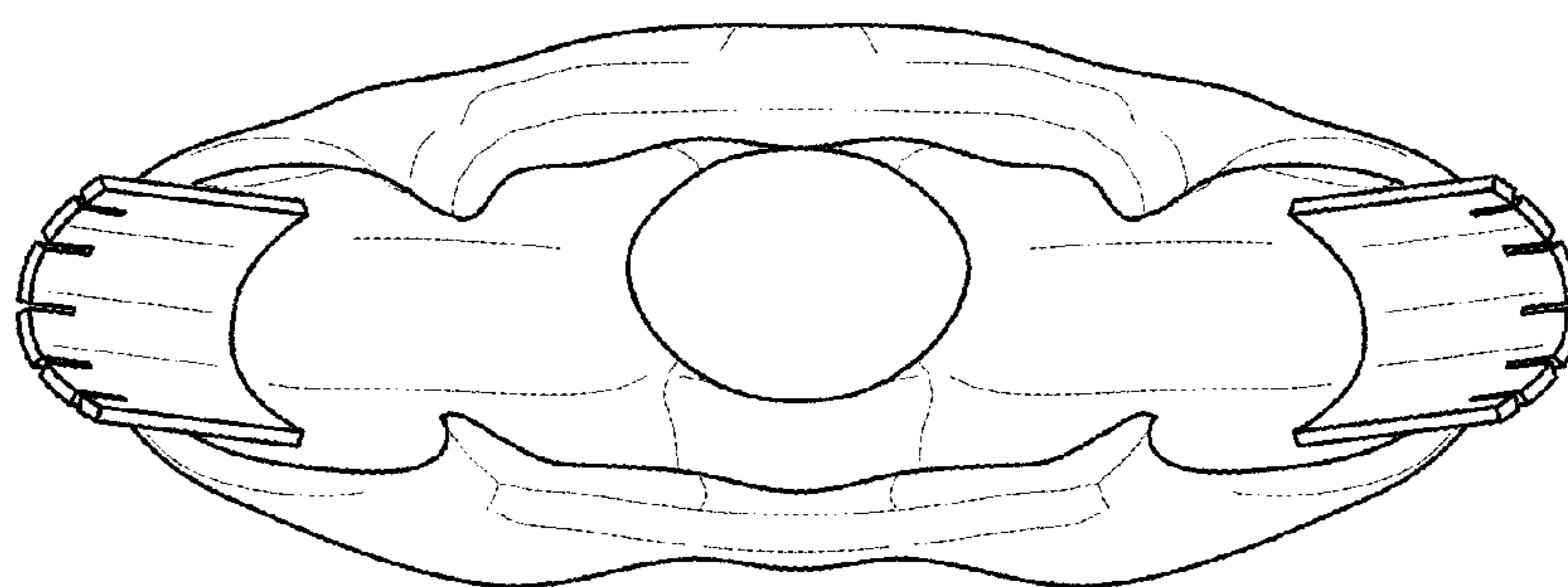

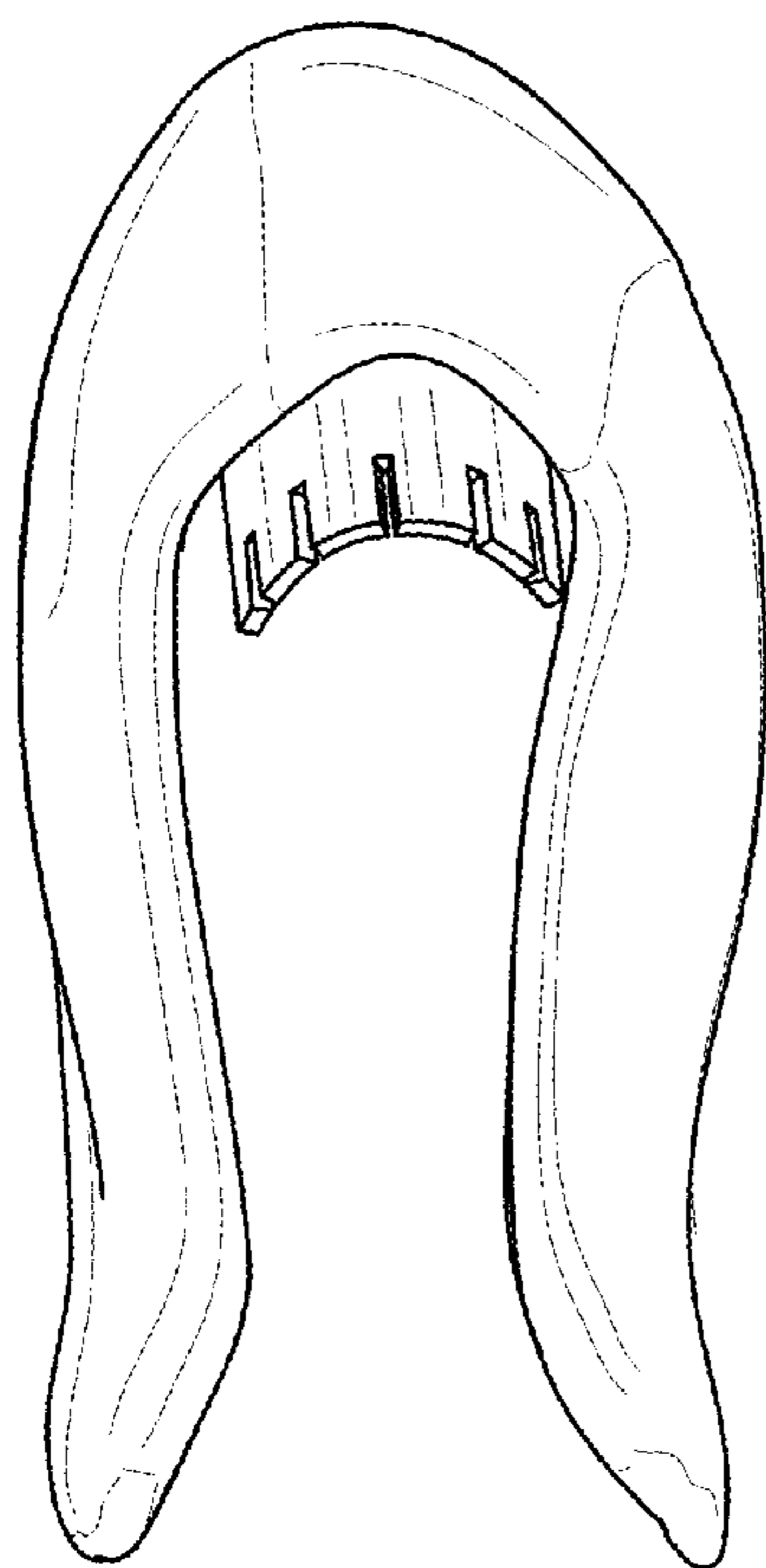

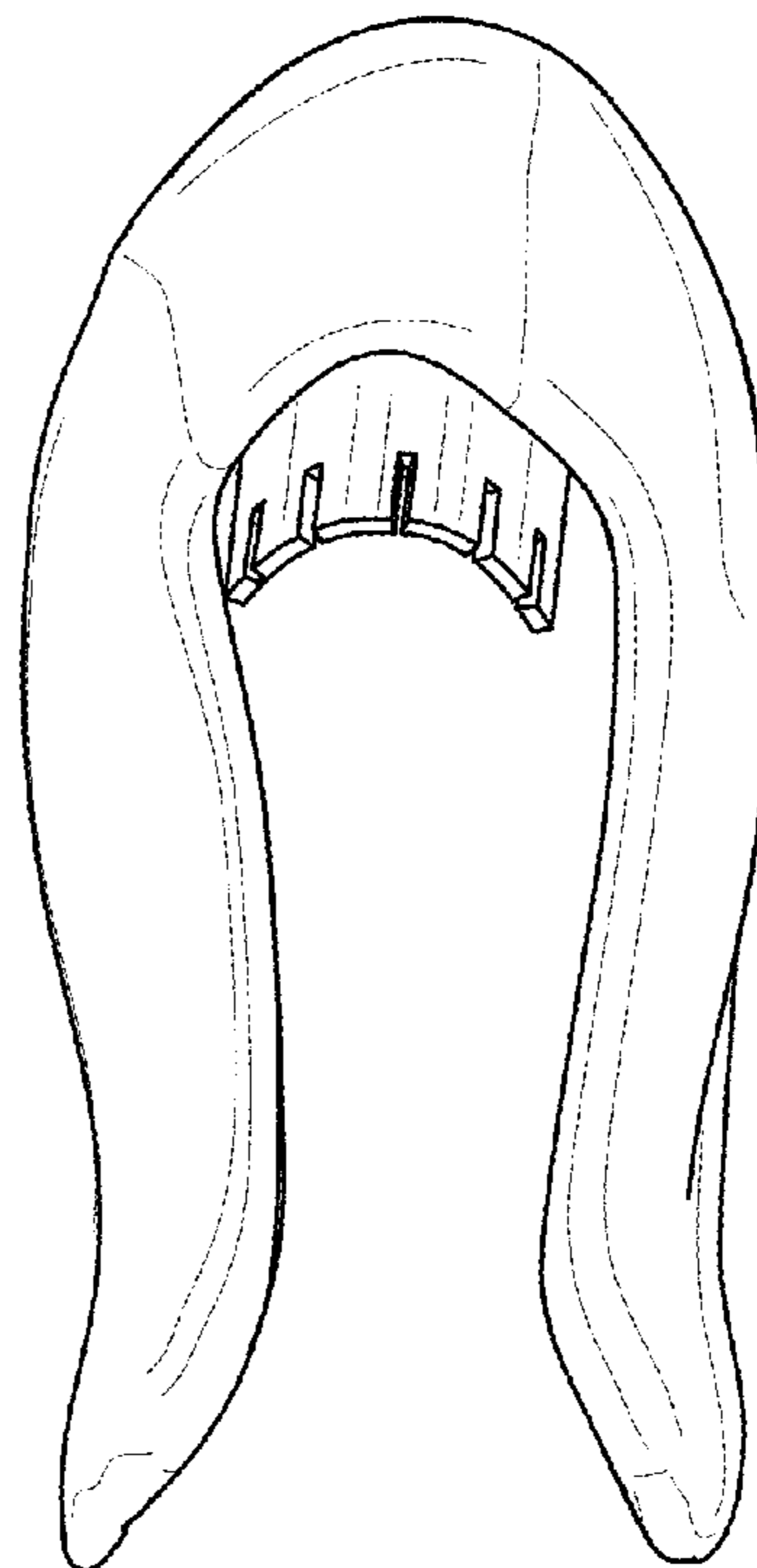
