The broken lines showing stitching are part of the claimed design.

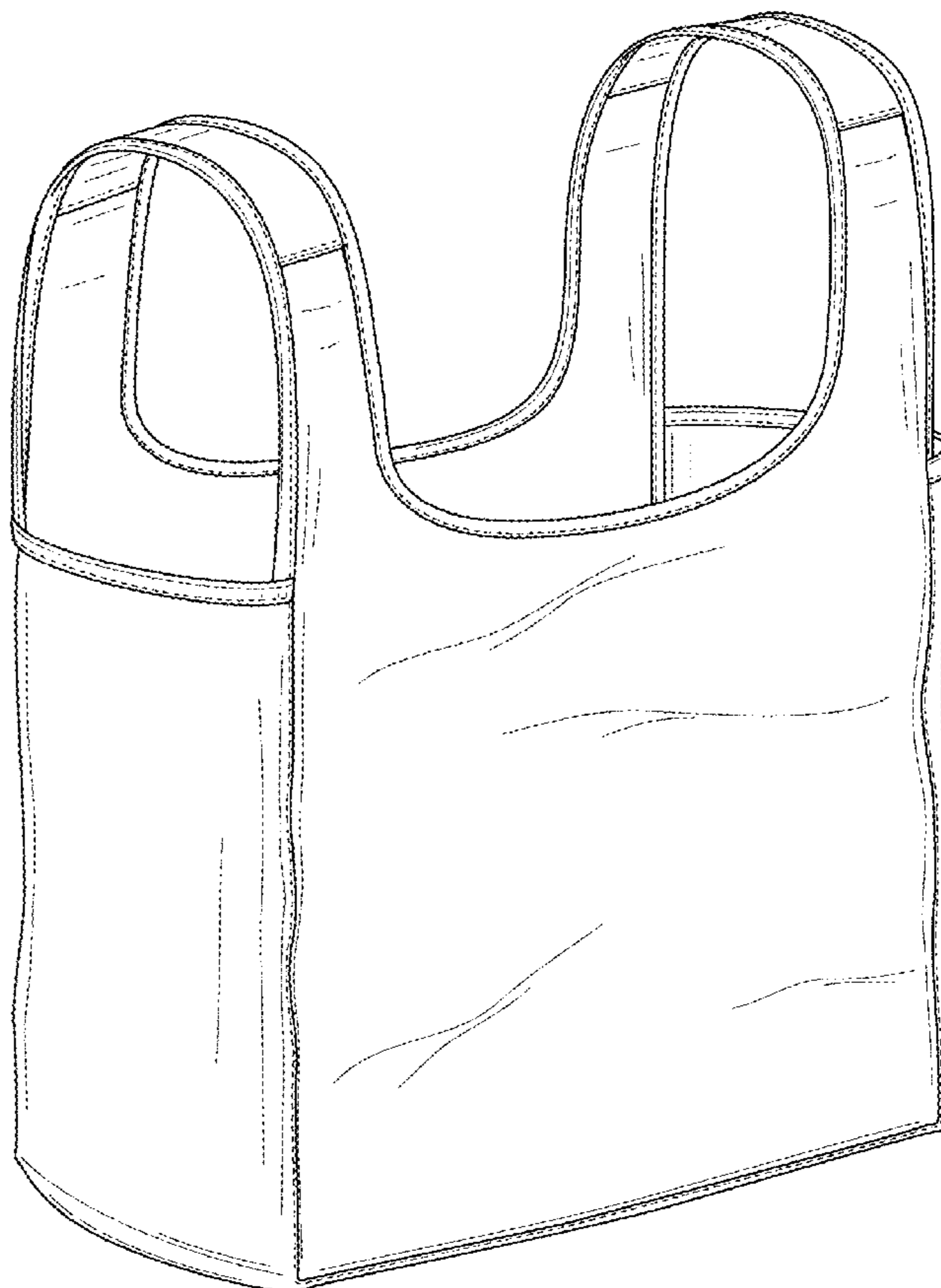
The handle is shown fragmented in the view of FIG. 8 for ease and clarity of illustration.

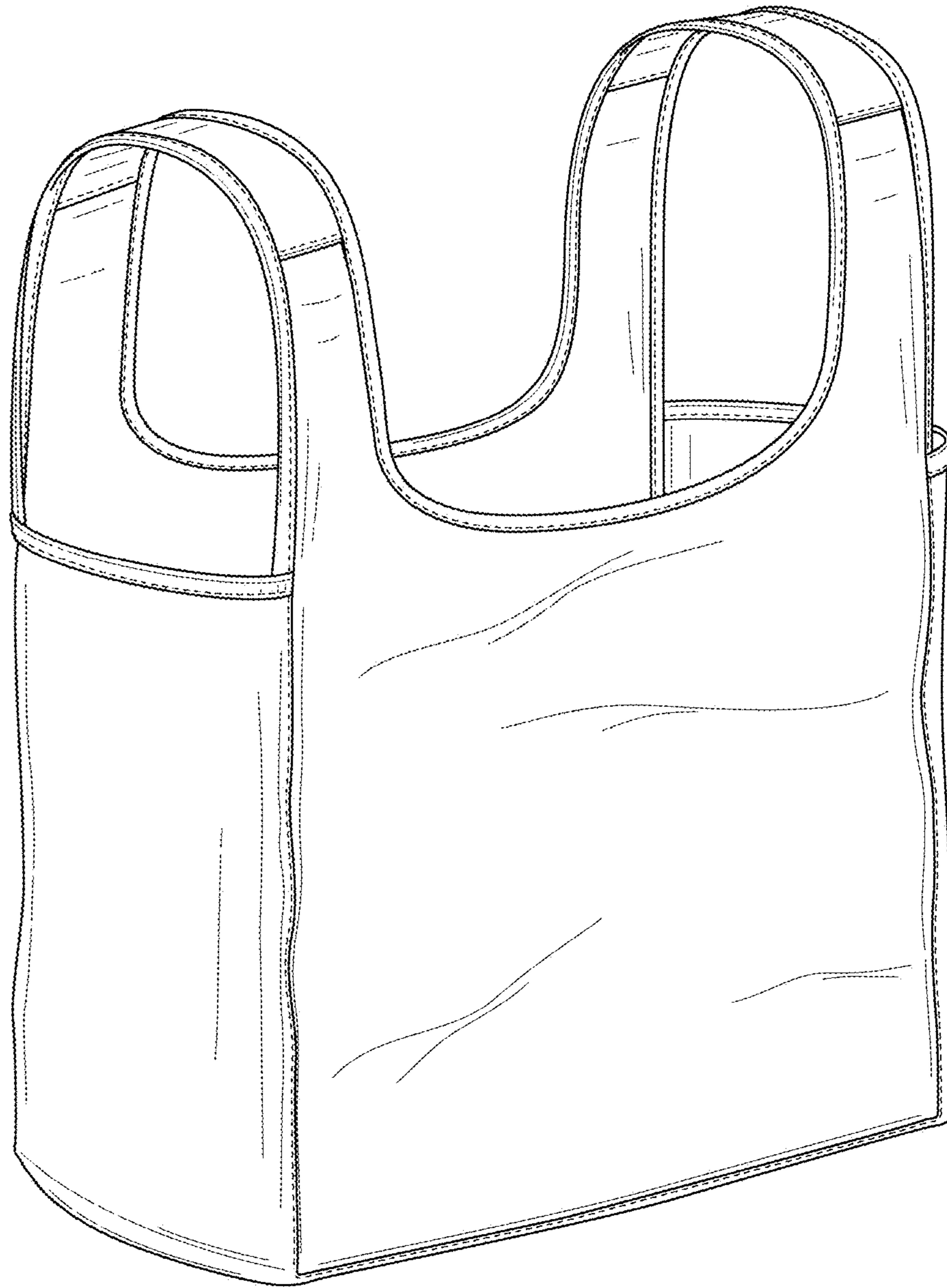

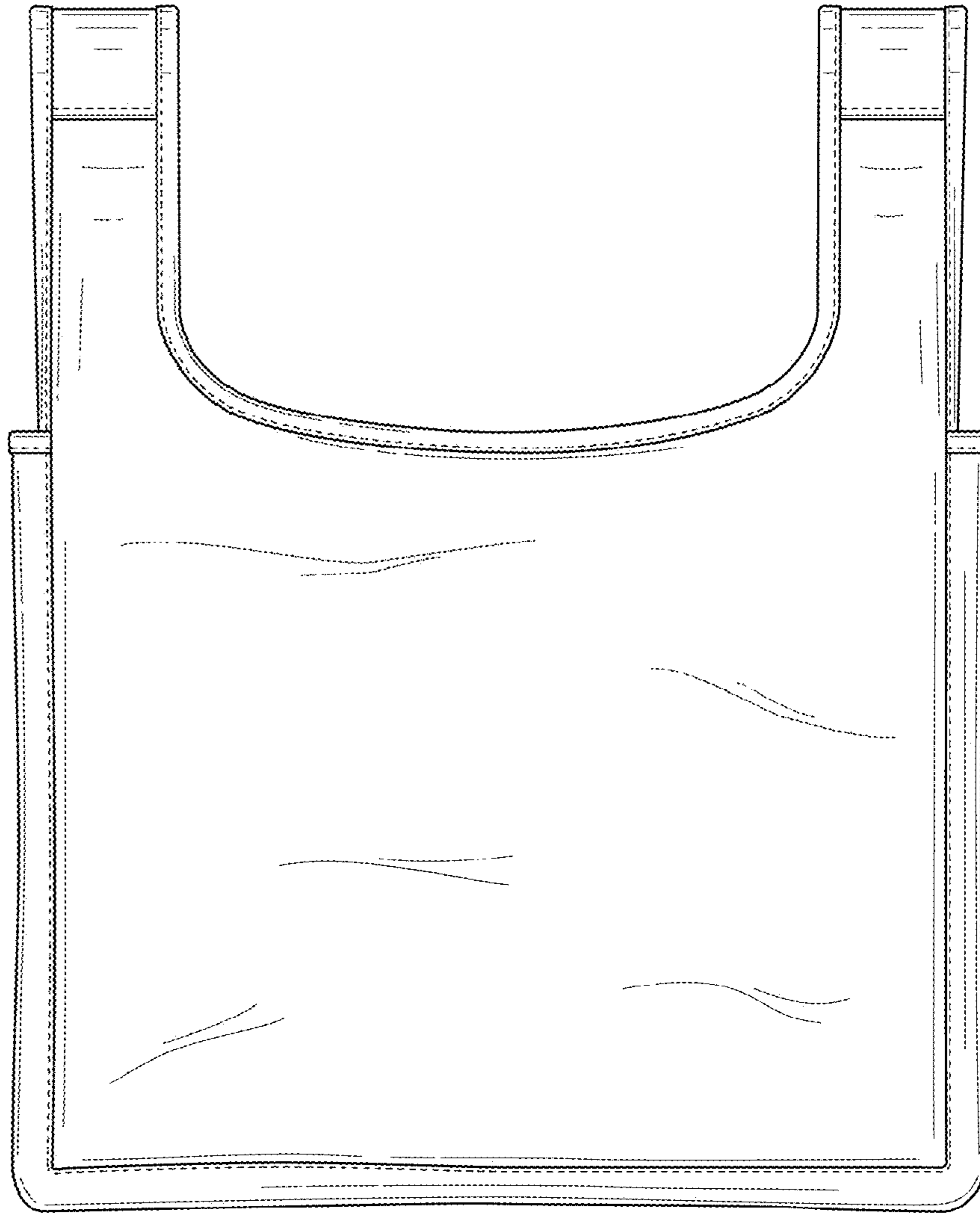

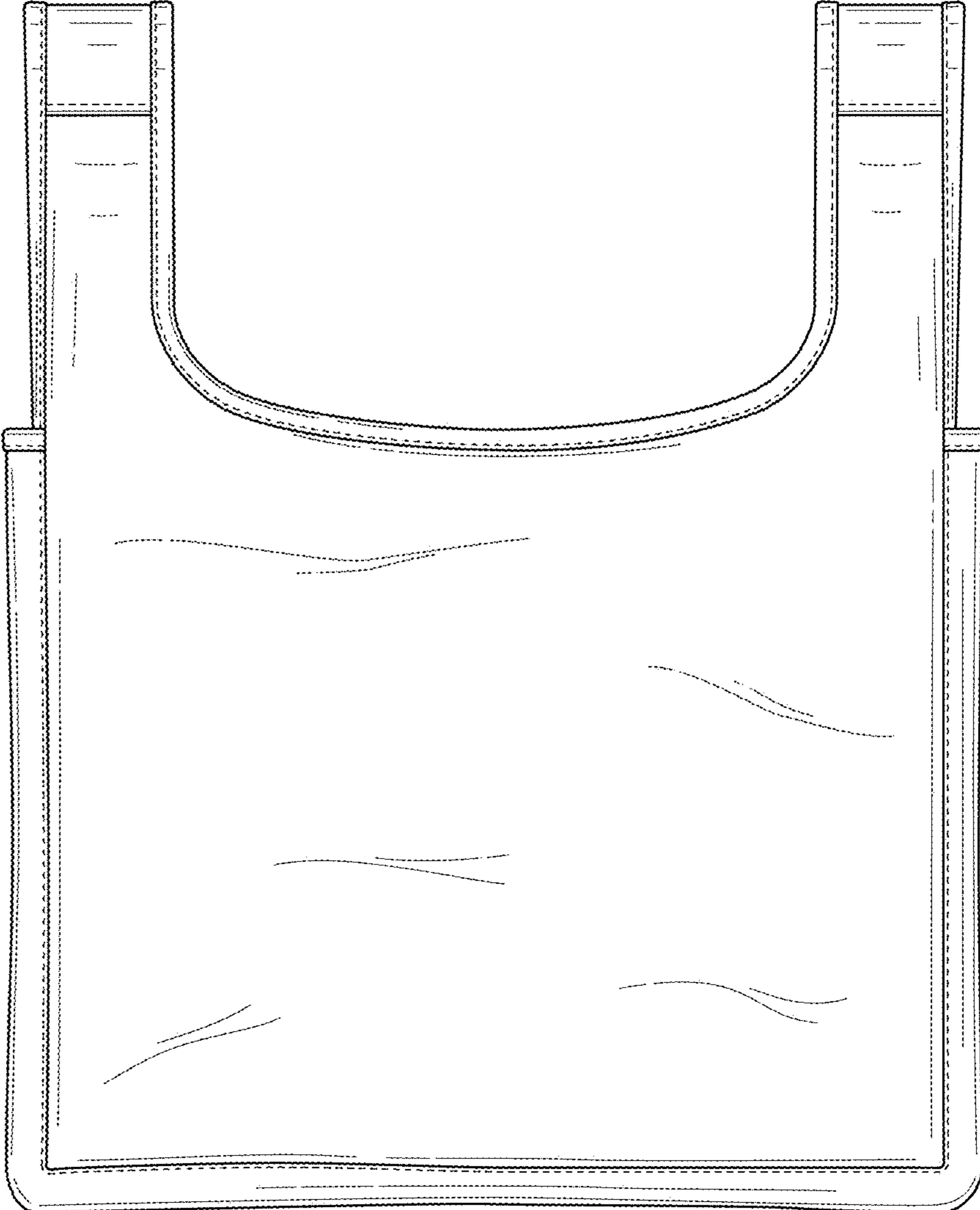

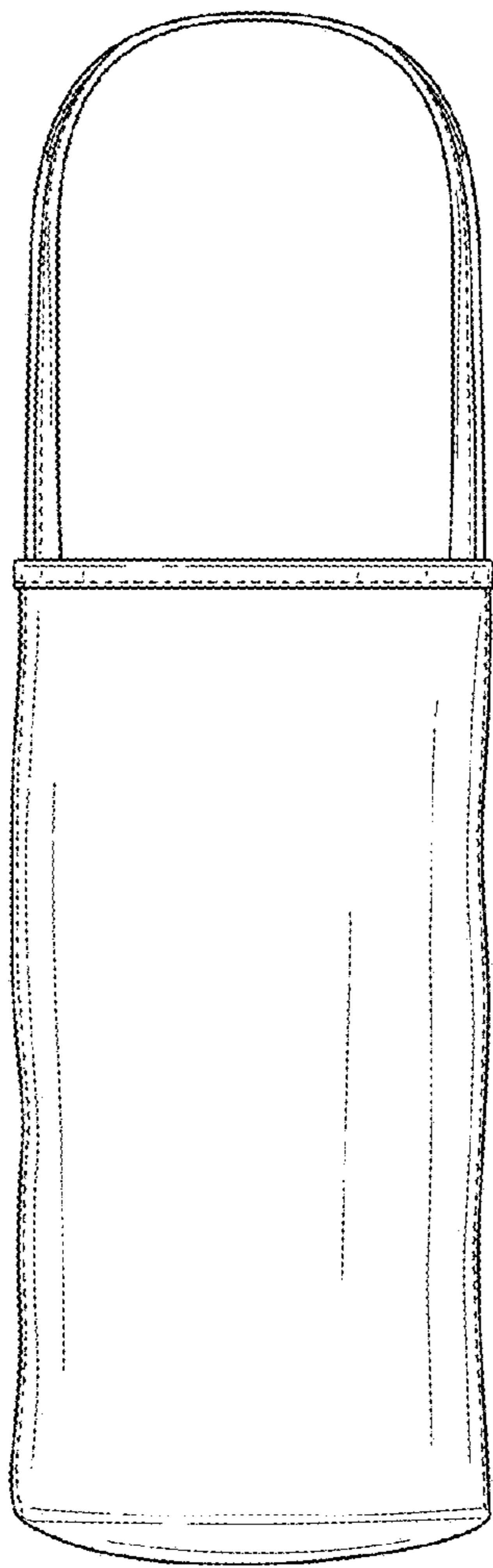

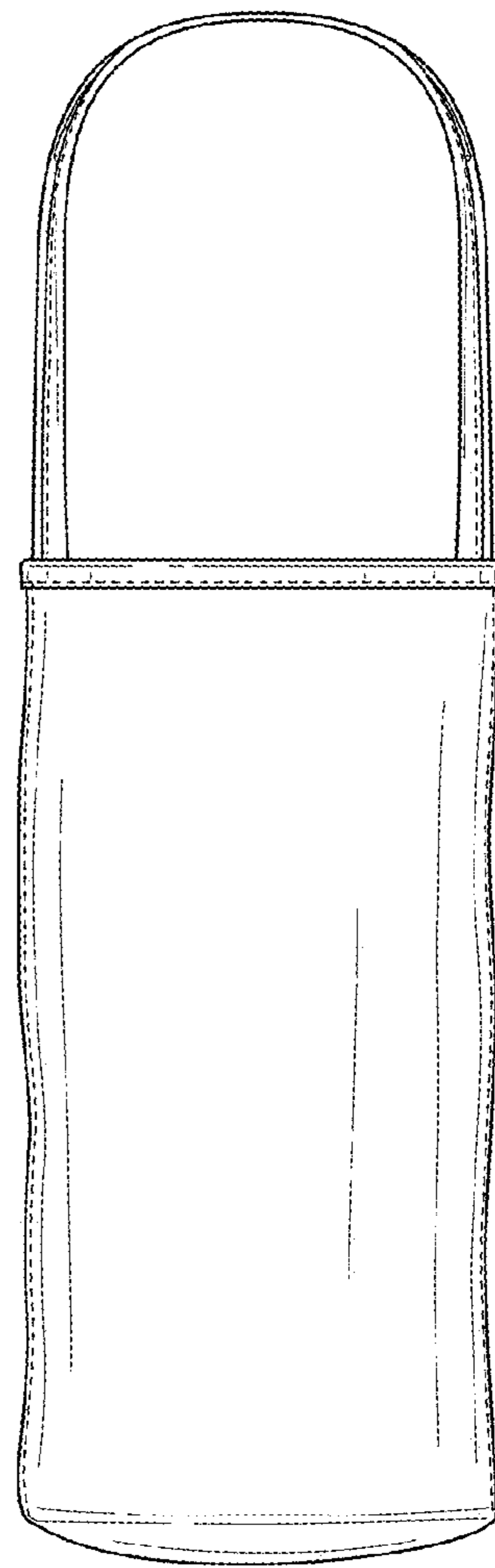
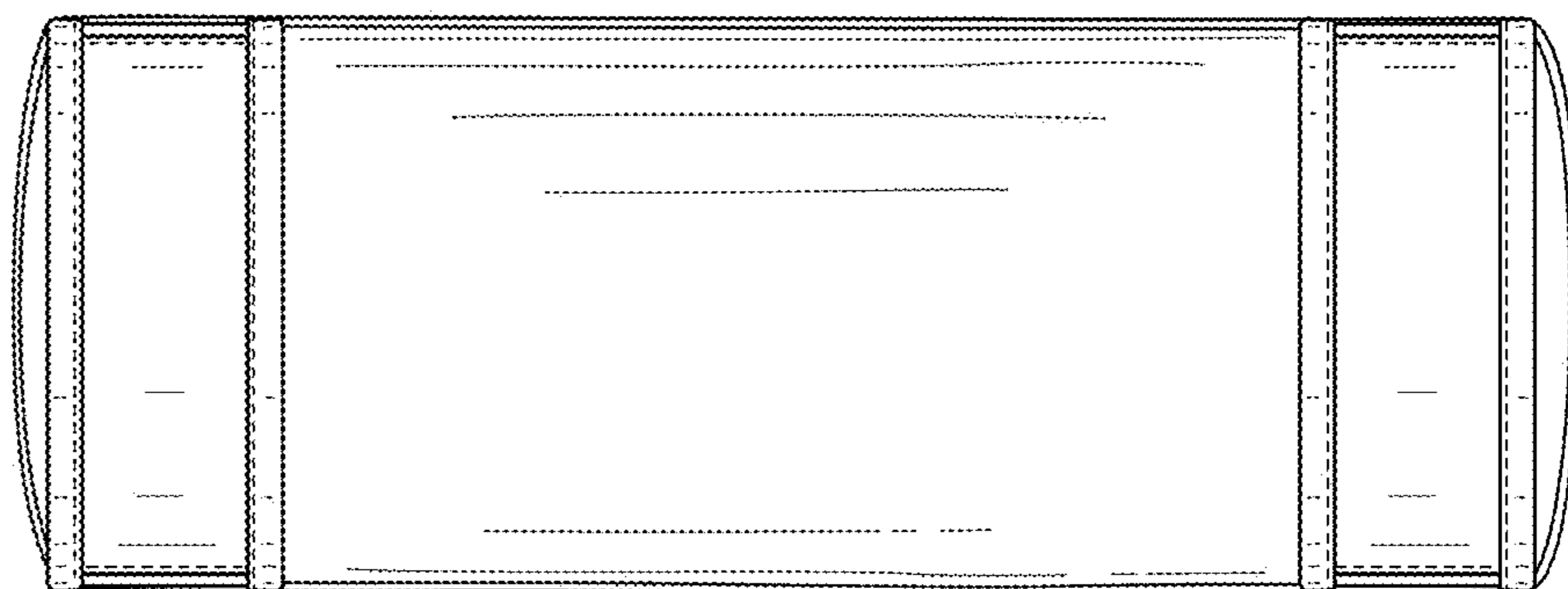
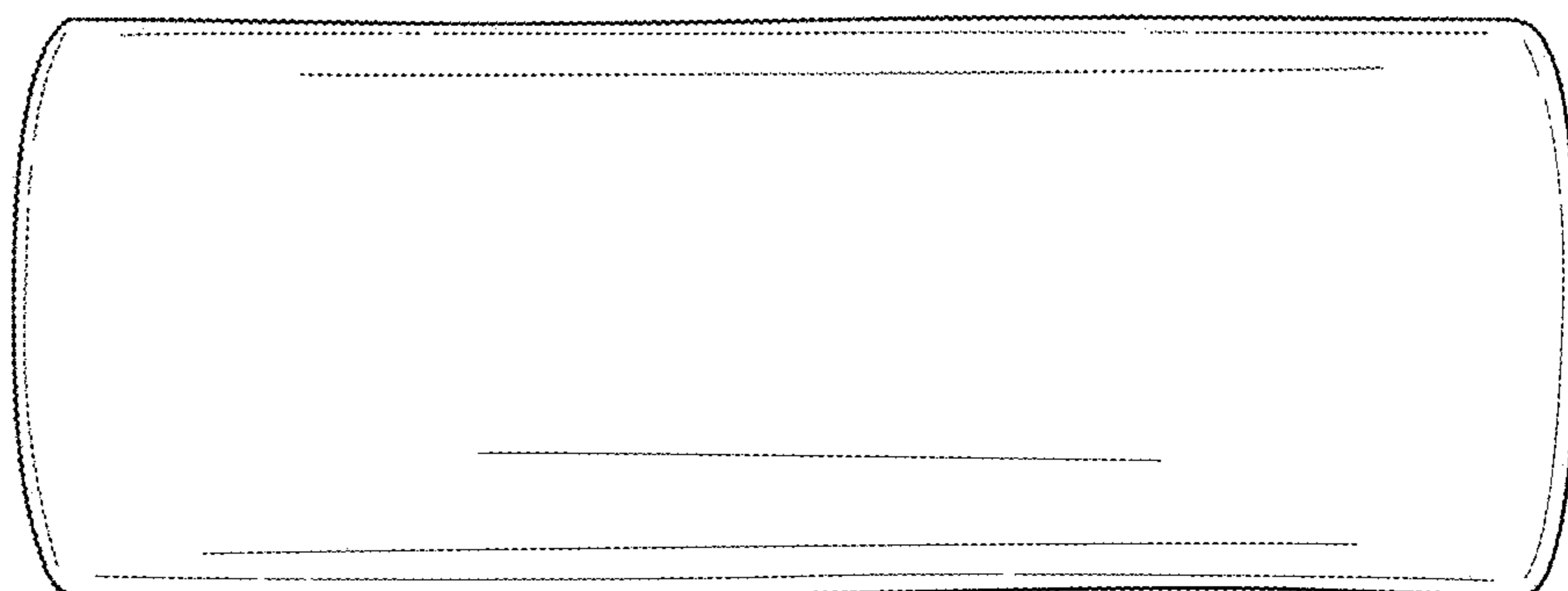

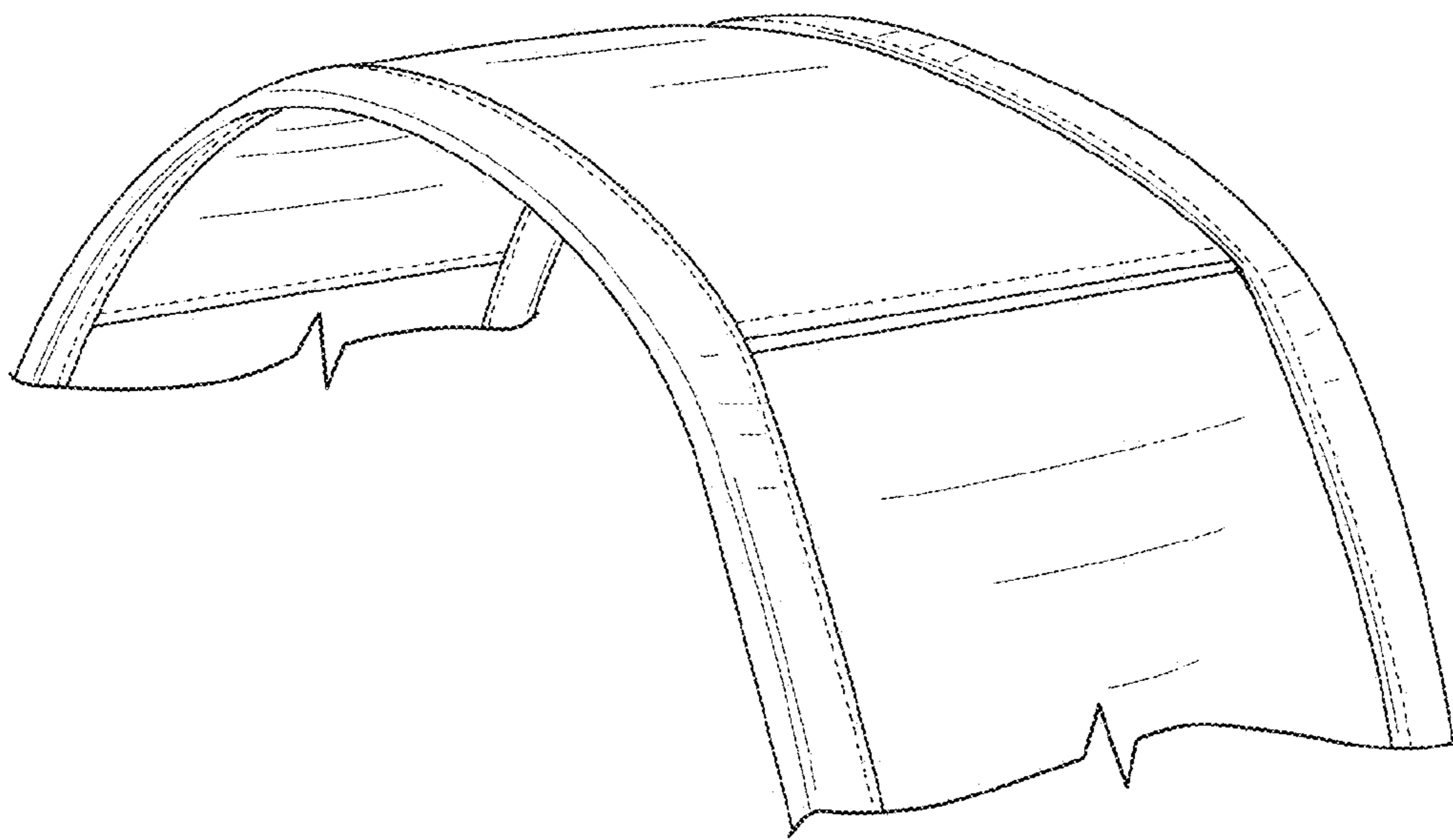
