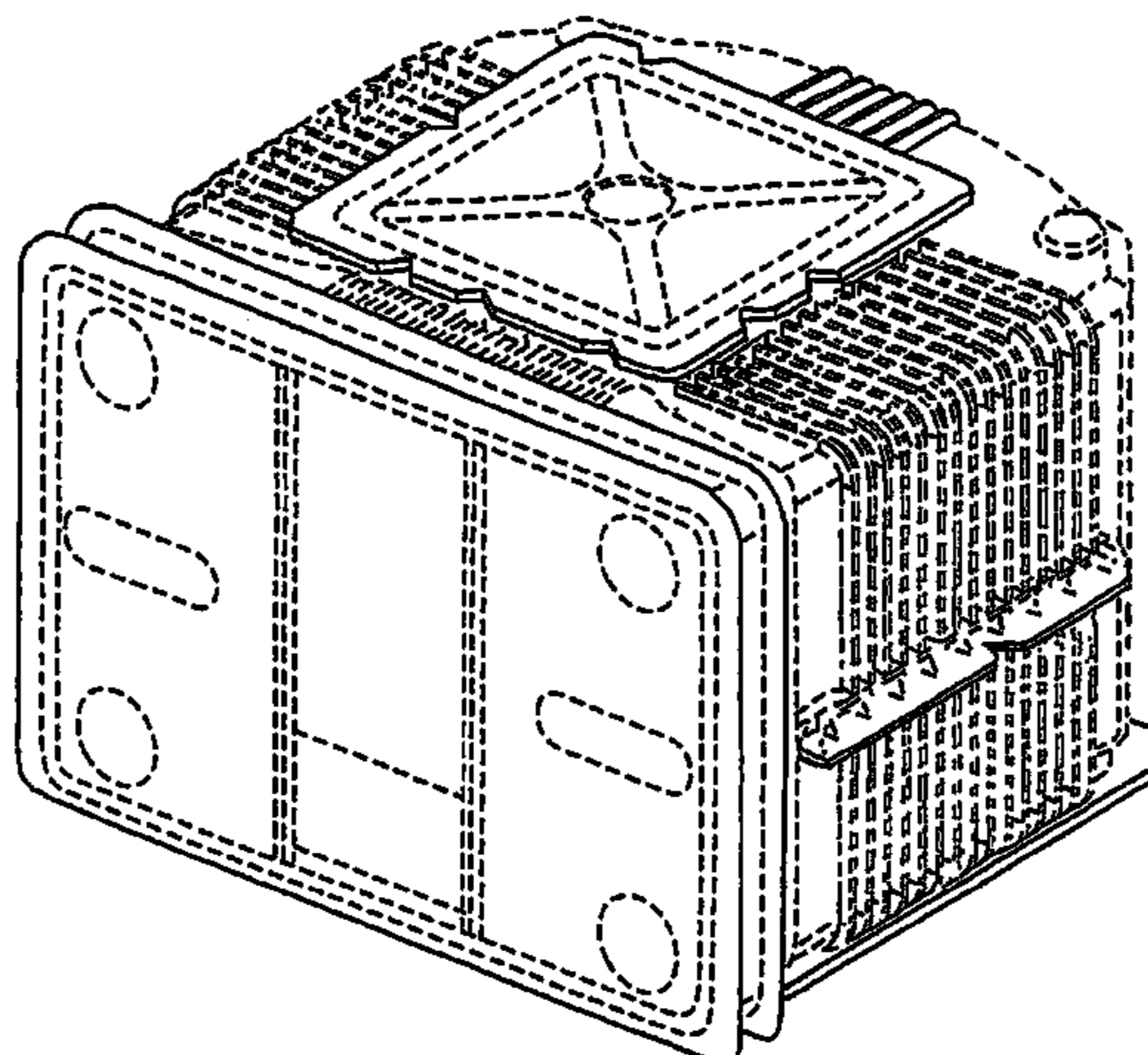
(57) **CLAIM**

I claim the ornamental design for substrate container, as shown and described.

DESCRIPTION

FIG. 1 is a front corner perspective view of a substrate container according to an embodiment of the invention. The view from the adjacent front corner being a mirror image thereto. FIG. 2 is back corner perspective view of a substrate container according to an embodiment of the invention. The view from the adjacent back corner being a mirror image thereto; and, FIG. 3 is right side view of a substrate container according to an embodiment of the invention. The view from the opposite side being a mirror image thereto. The broken lines illustrate unclaimed portions of the article. The bottom side of the substrate container is not illustrated and forms no part of the claimed invention.

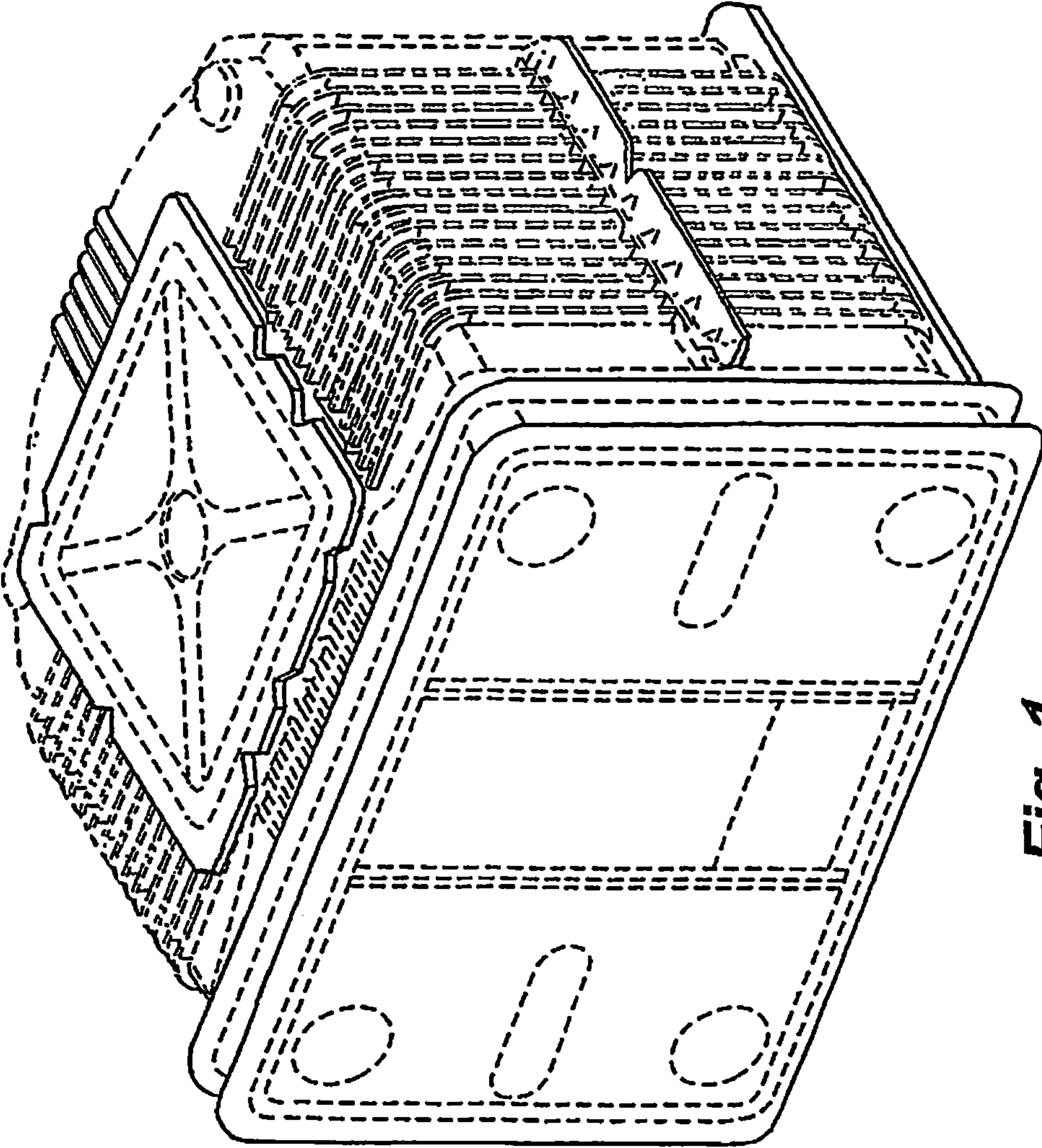

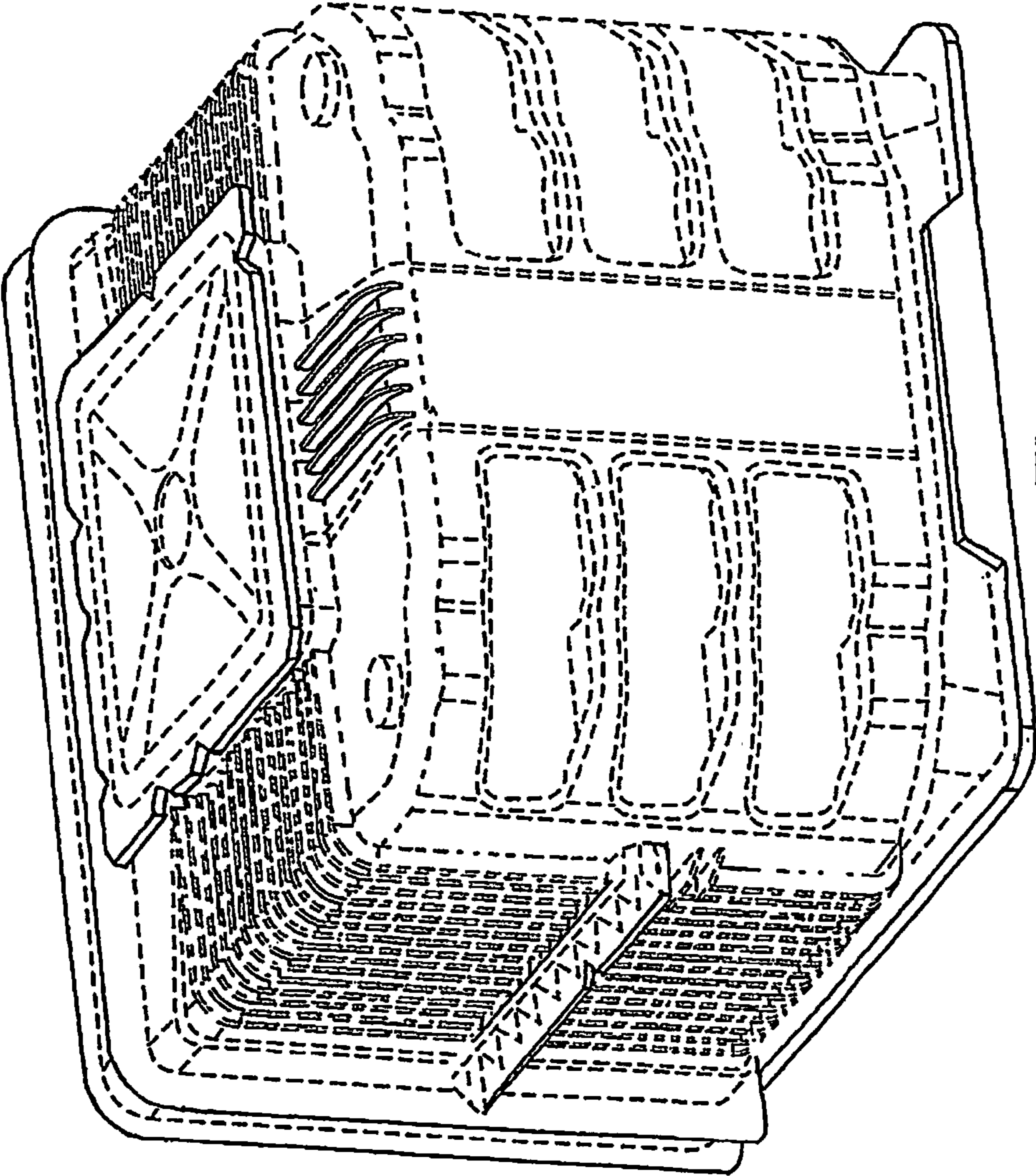

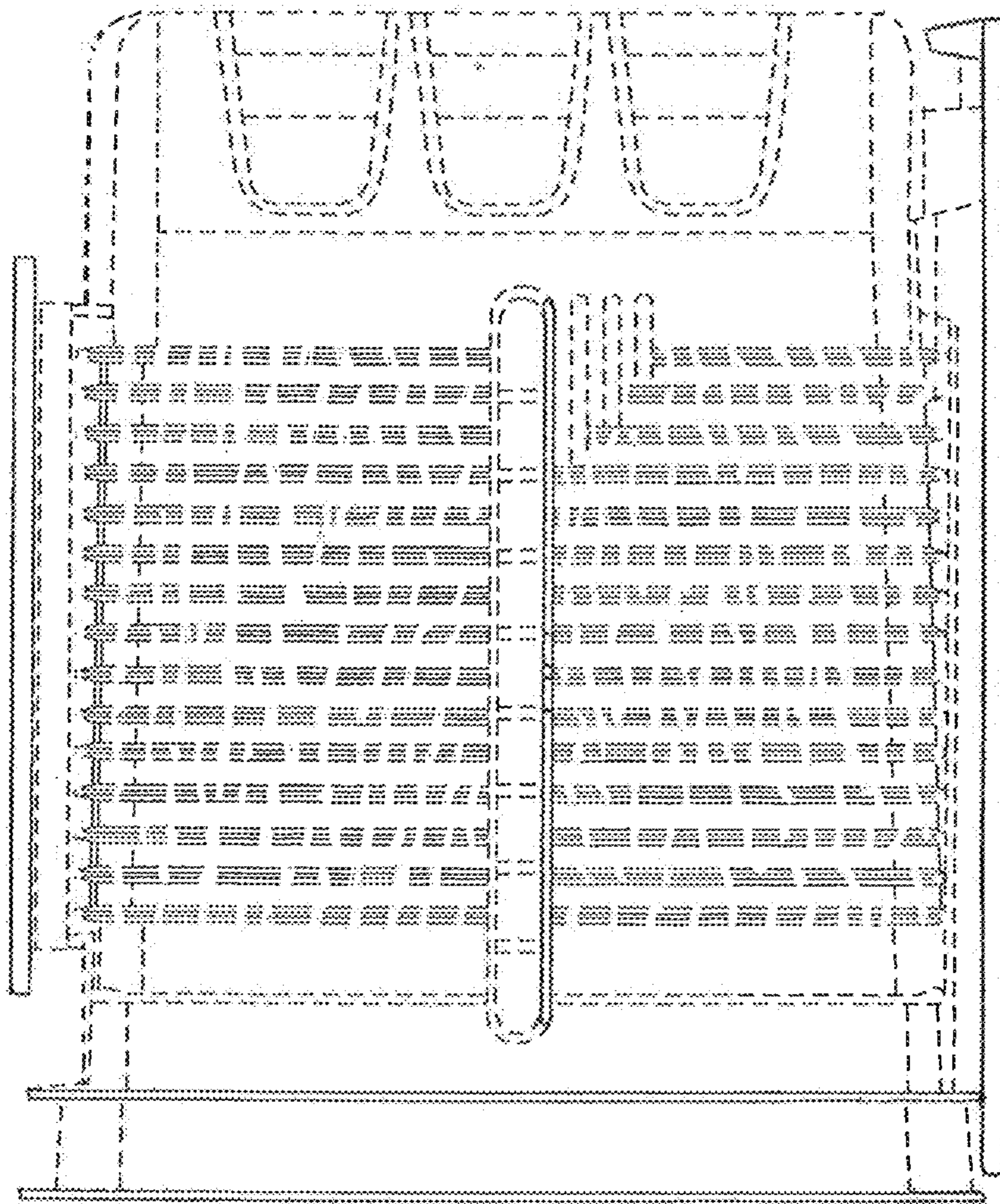
