(57) **CLAIM**

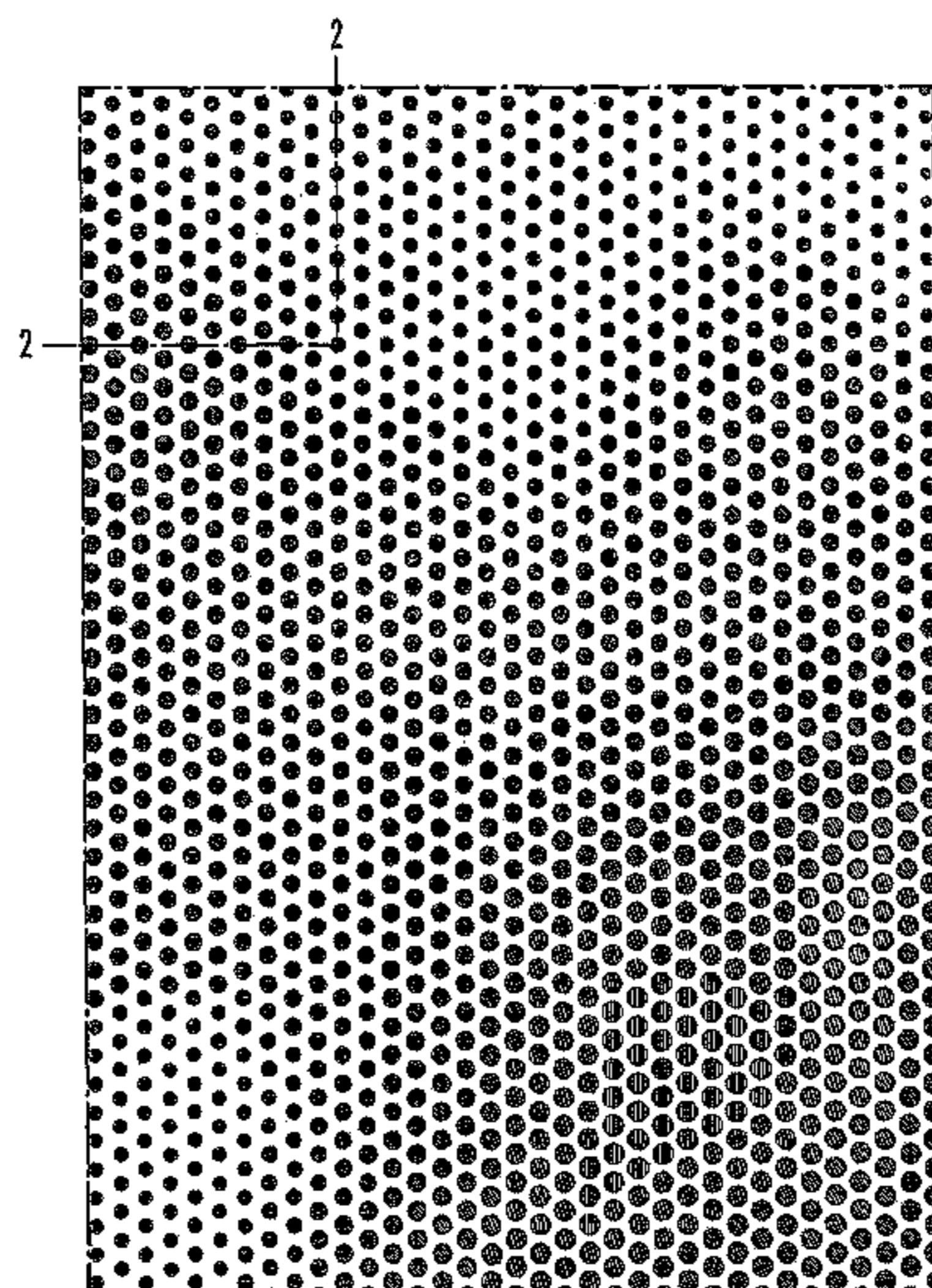
The ornamental design for a floor covering with dot pattern,
as shown and described.

DESCRIPTION

FIG. 1 is a plan view of a floor covering with dot pattern;
FIG. 2 is an enlarged detail view of area 2 circumscribed
within FIG. 1;
FIG. 3 is an enlarged detail view of area 3 circumscribed
within FIG. 2; and,
FIG. 4 is an enlarged detail view of area 4 circumscribed
within FIG. 3.

The dot dash dot broken line perimeter around FIG. 1 depicts
the boundaries of the claim and forms no part thereof. The dot
dash dot broken lines within FIG. 1, around FIG. 2; within
FIG. 2, around FIG. 3; and forming circles around detail areas
in FIGS. 3 and 4 indicate the boundaries of the details, and
form no part of the claimed design. All other dot dash dot
broken lines in FIGS. 3 and 4 depict portions of the article that
form no part of the claimed design.

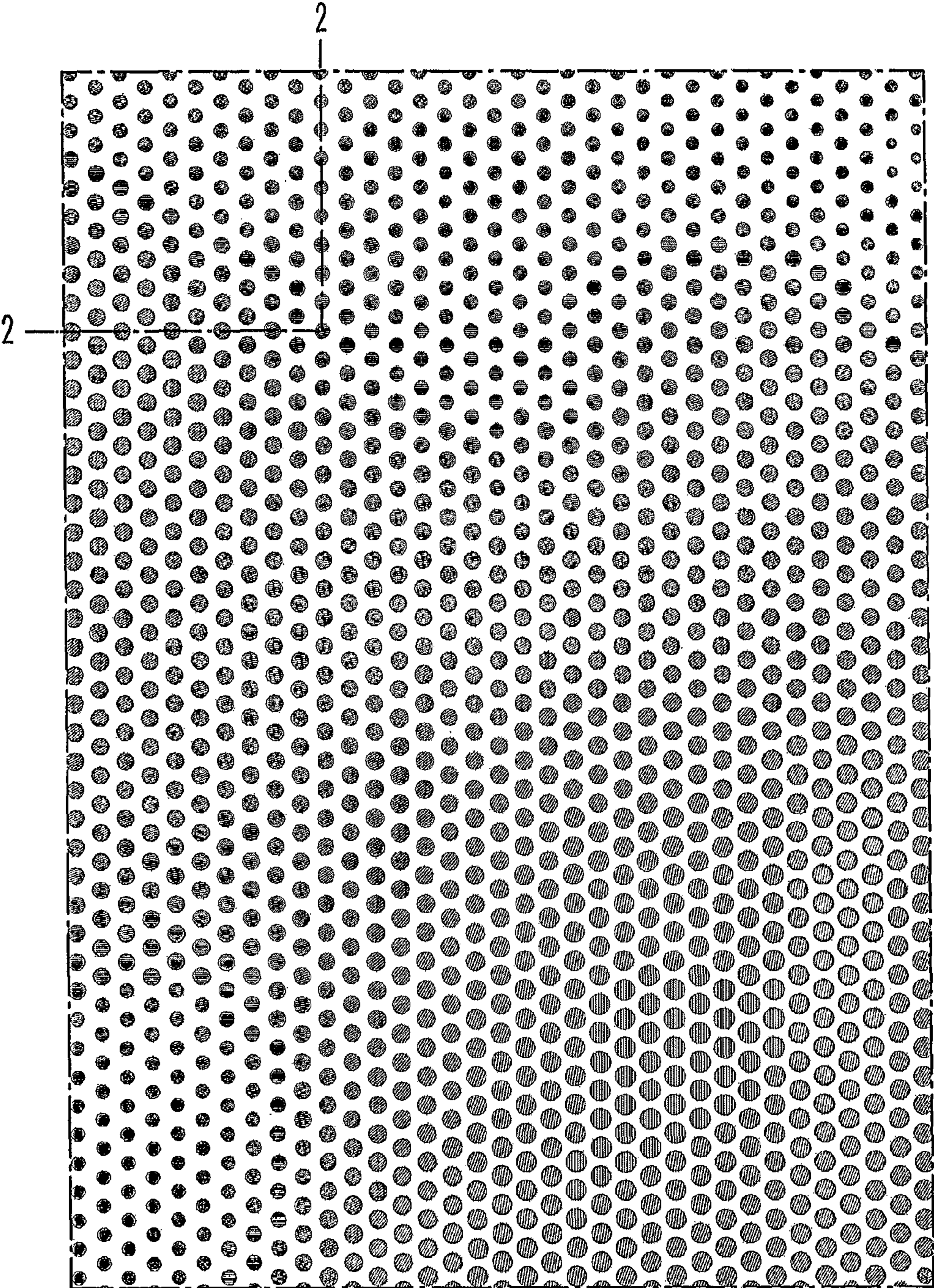

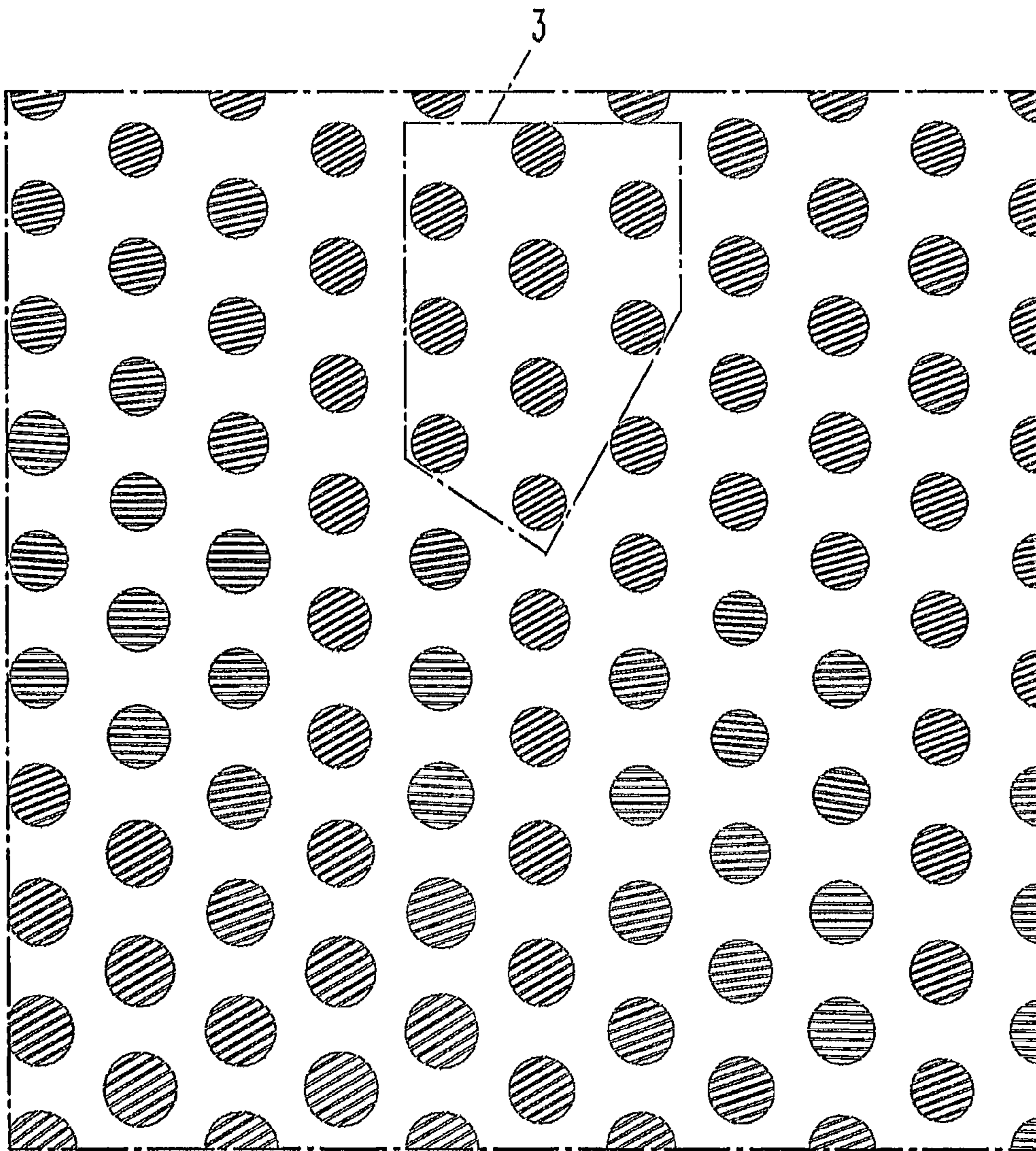

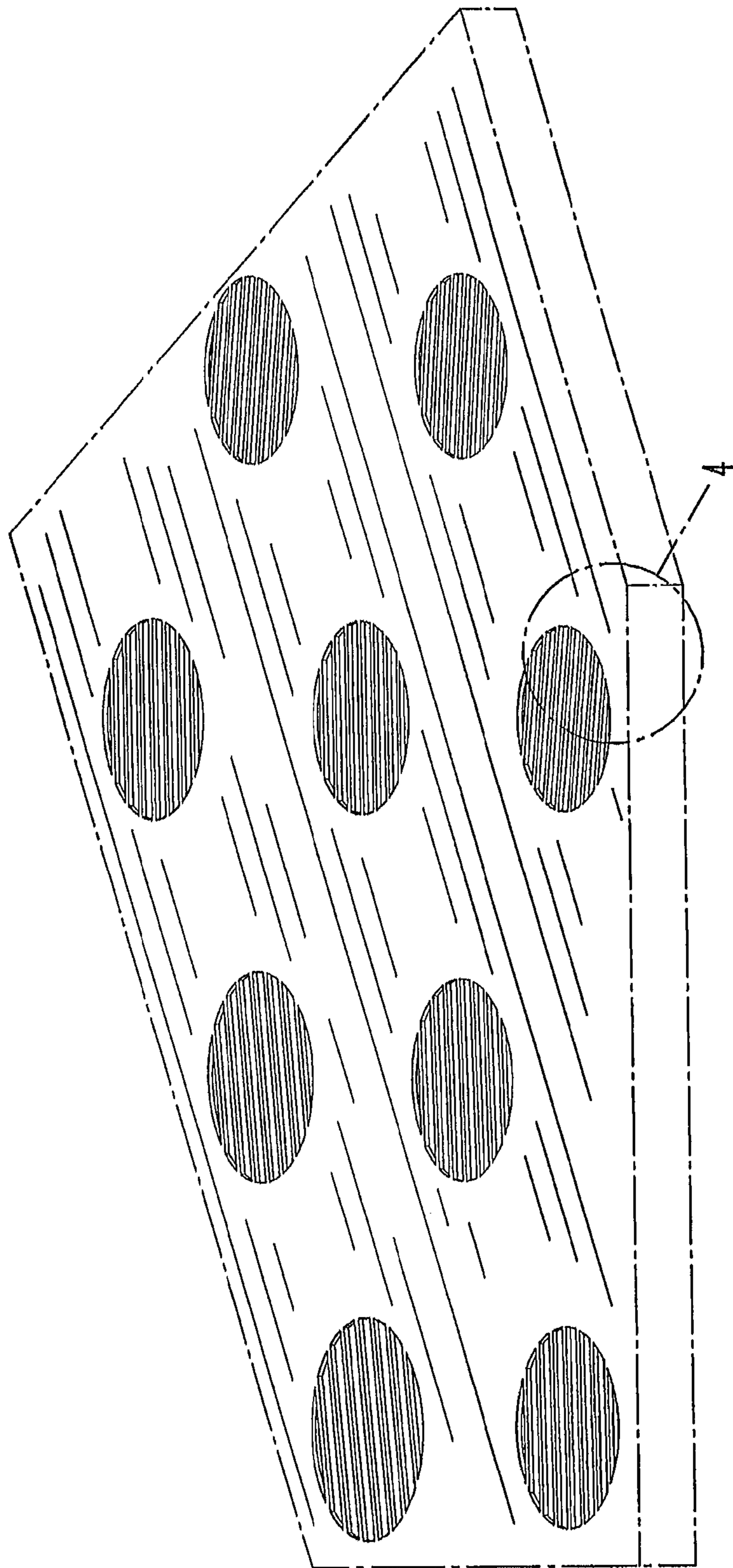
