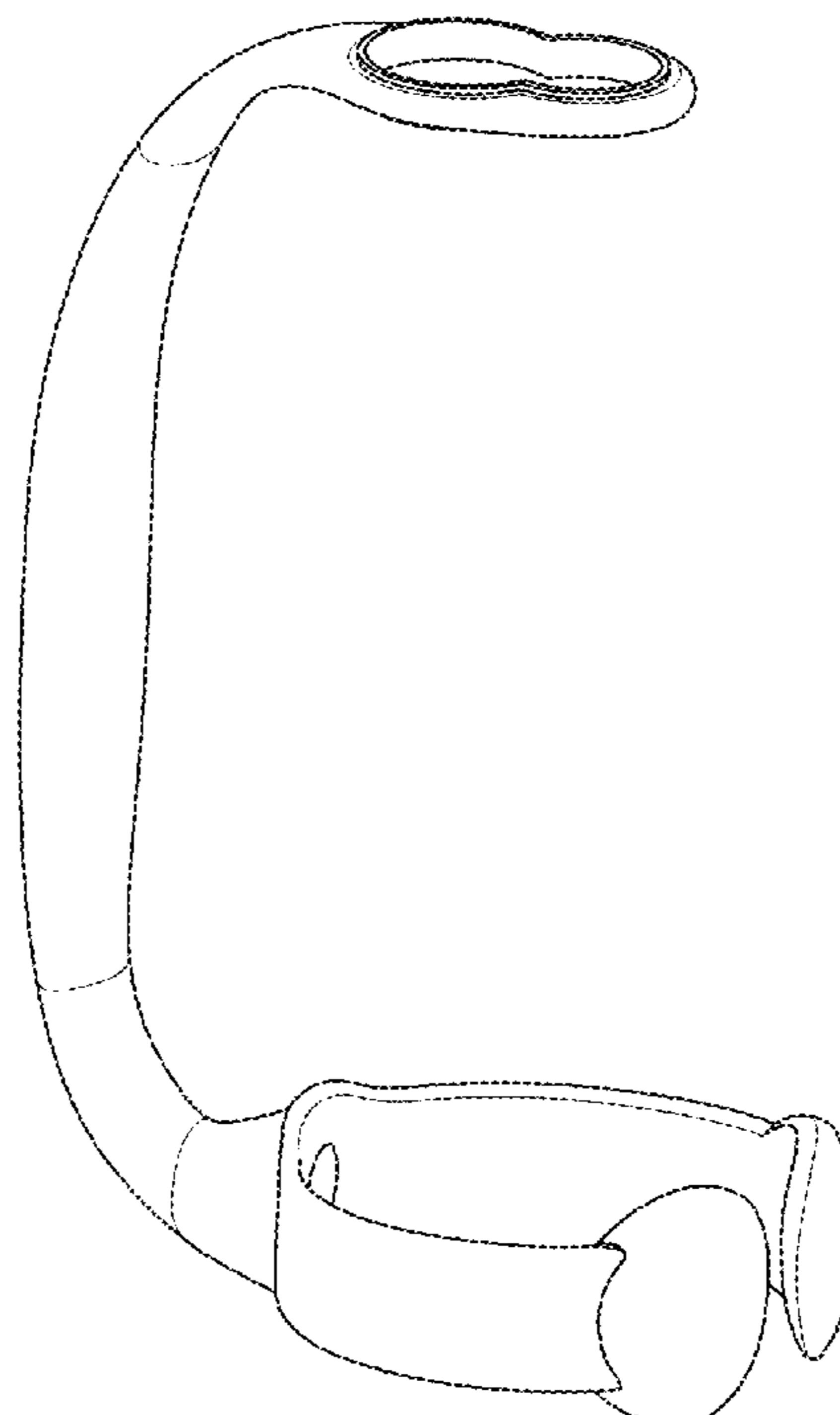
(57) **CLAIM**

The ornamental design for a handle for bottles, as shown and described.

DESCRIPTION

FIG. 1 is a front, right side, and top perspective view of a handle for bottles showing the new design;
FIG. 2 is a front, right side, and top perspective view thereof without the unclaimed bottle shown;
FIG. 3 is an enlarged left side elevation view thereof;
FIG. 4 is an enlarged top plan view thereof; FIG. 5 is an enlarged front elevation view thereof; and,
FIG. 6 is an enlarged rear elevation view thereof.
The portions of the design shown in broken lines show unclaimed subject matter.

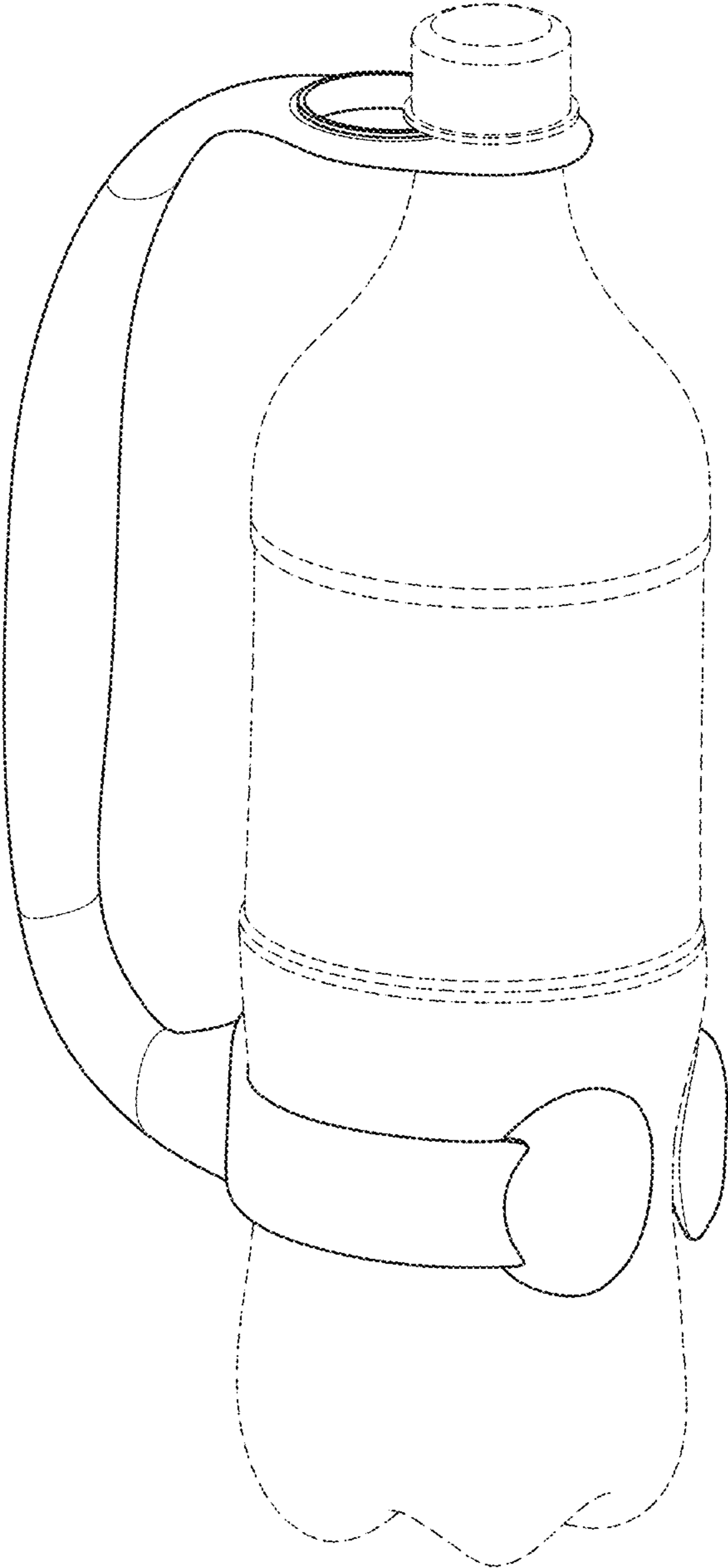

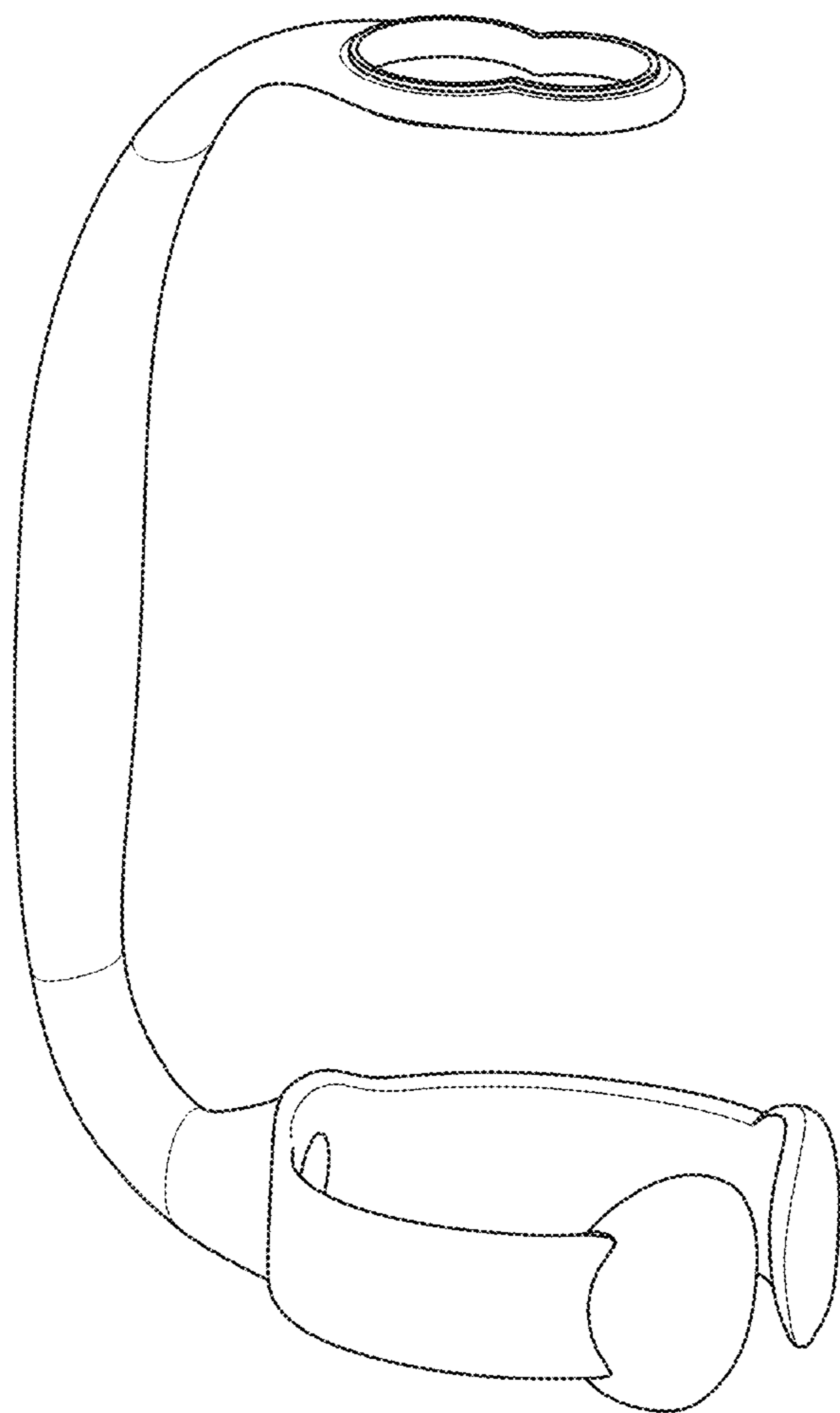

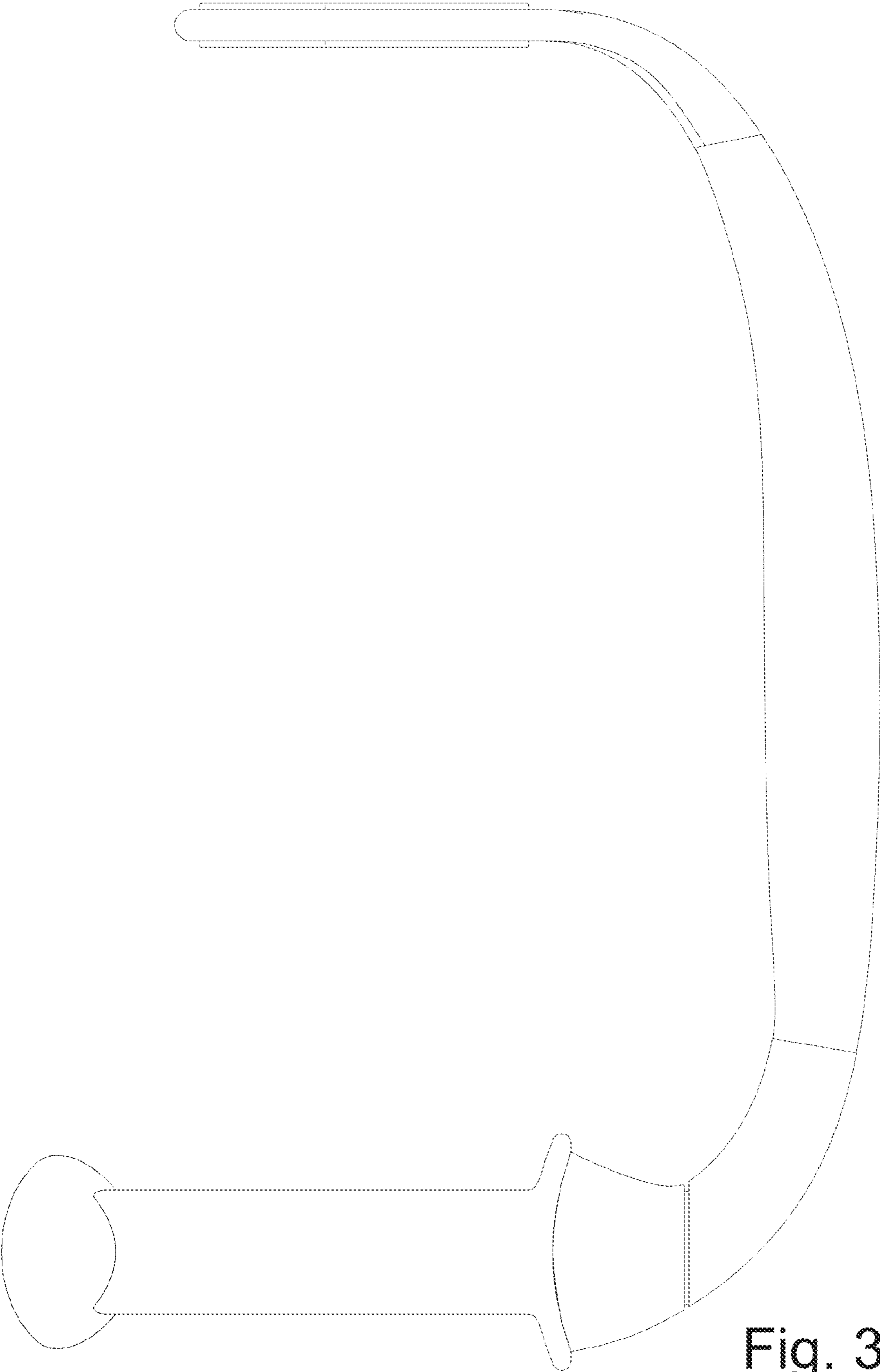

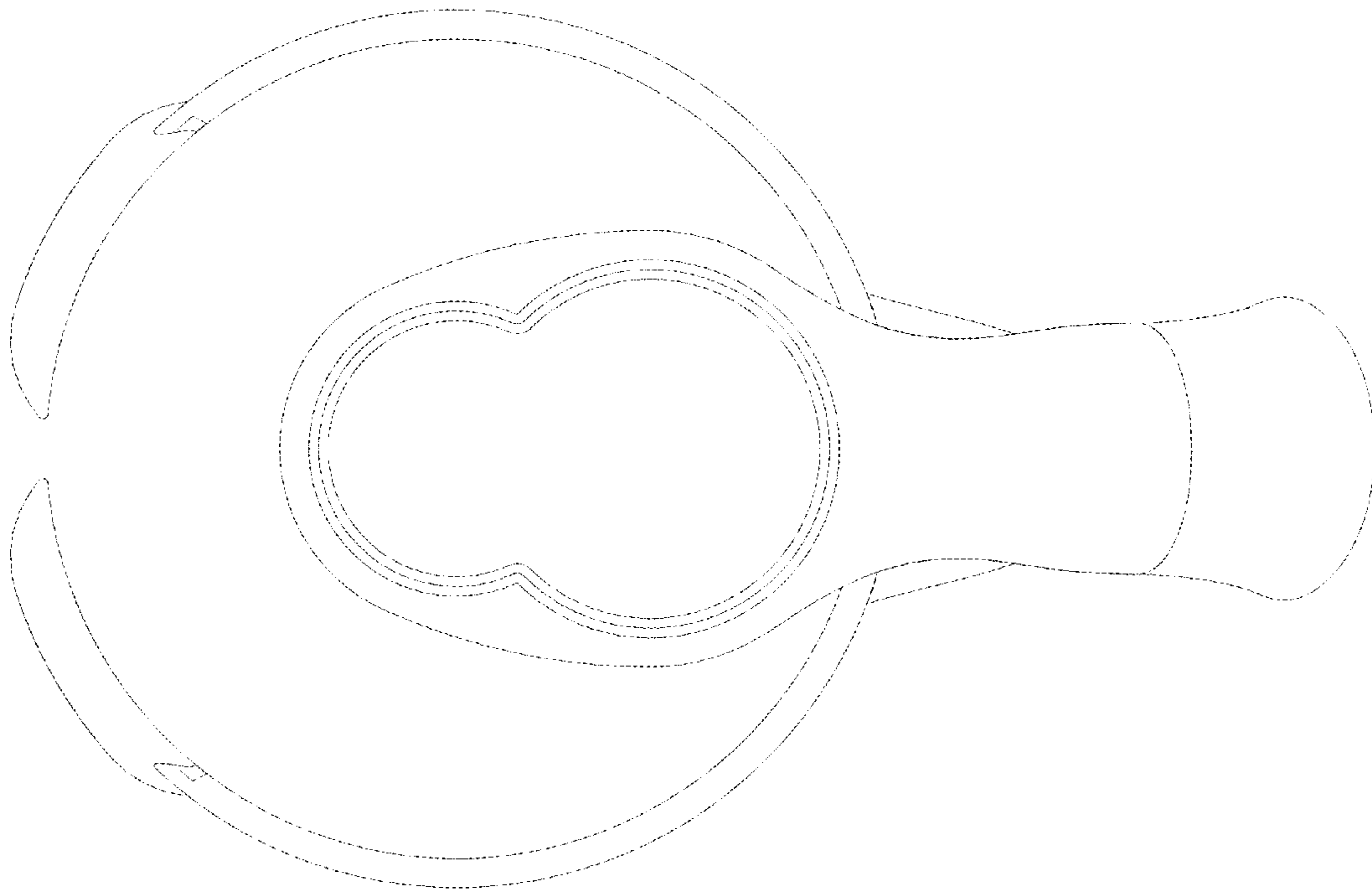

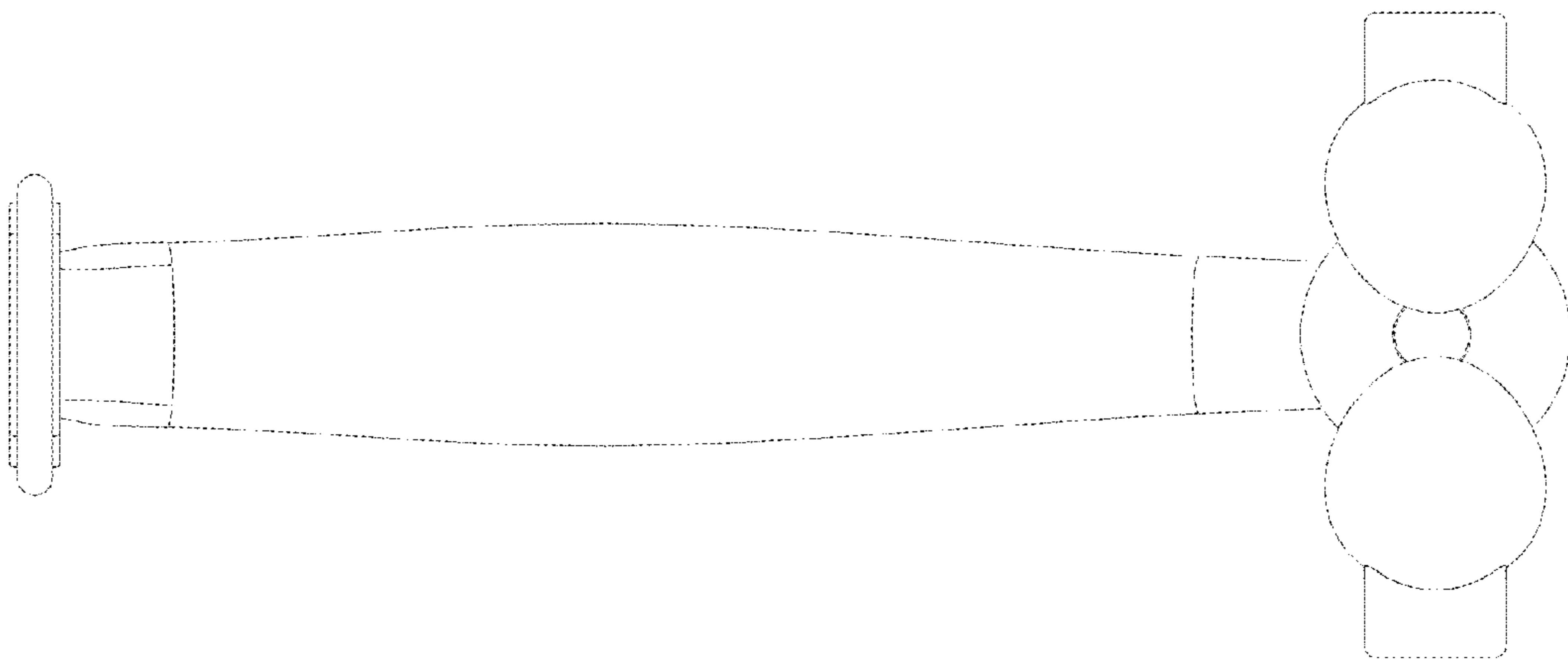

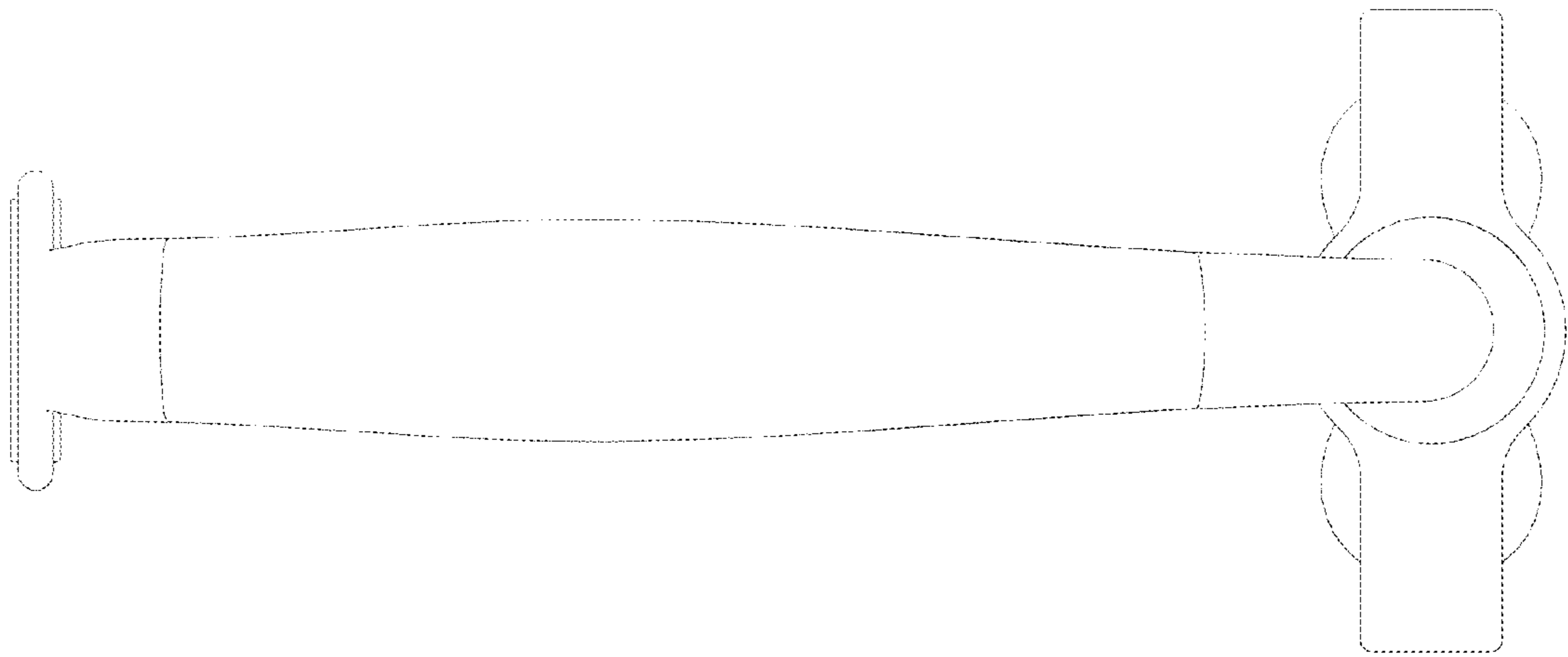
