DESCRIPTION

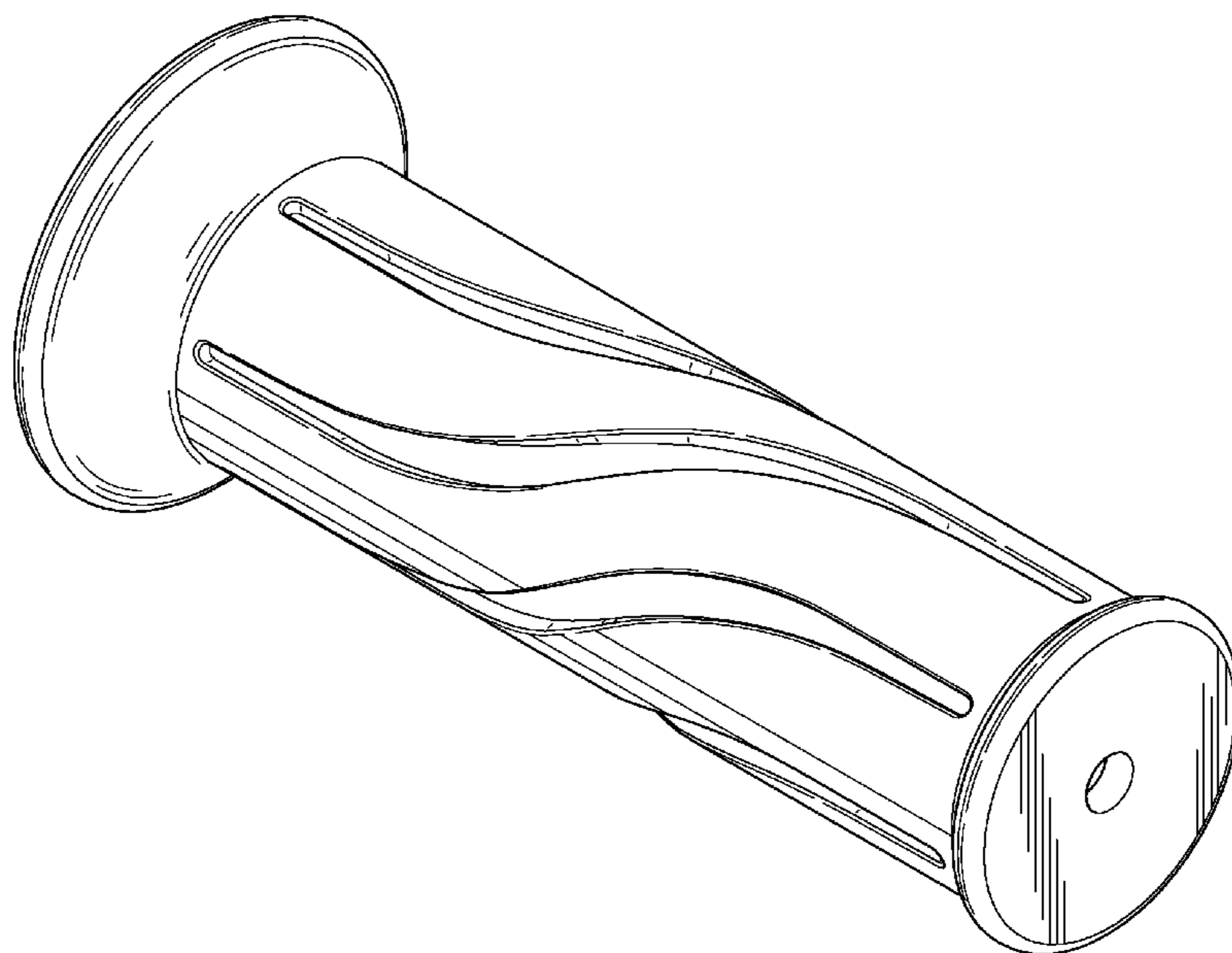
FIG. 1 is a perspective view of a vehicular handle showing my new design;

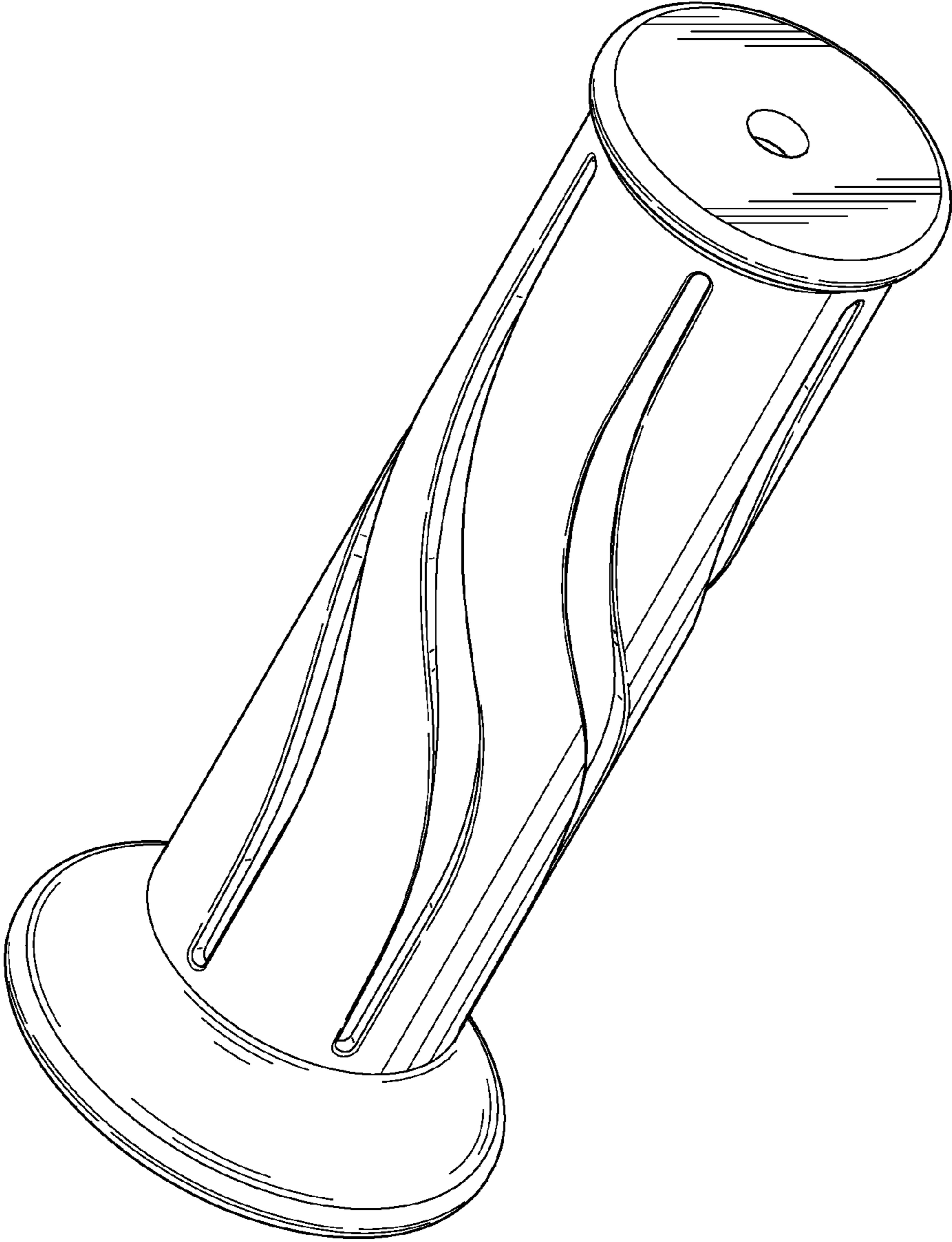

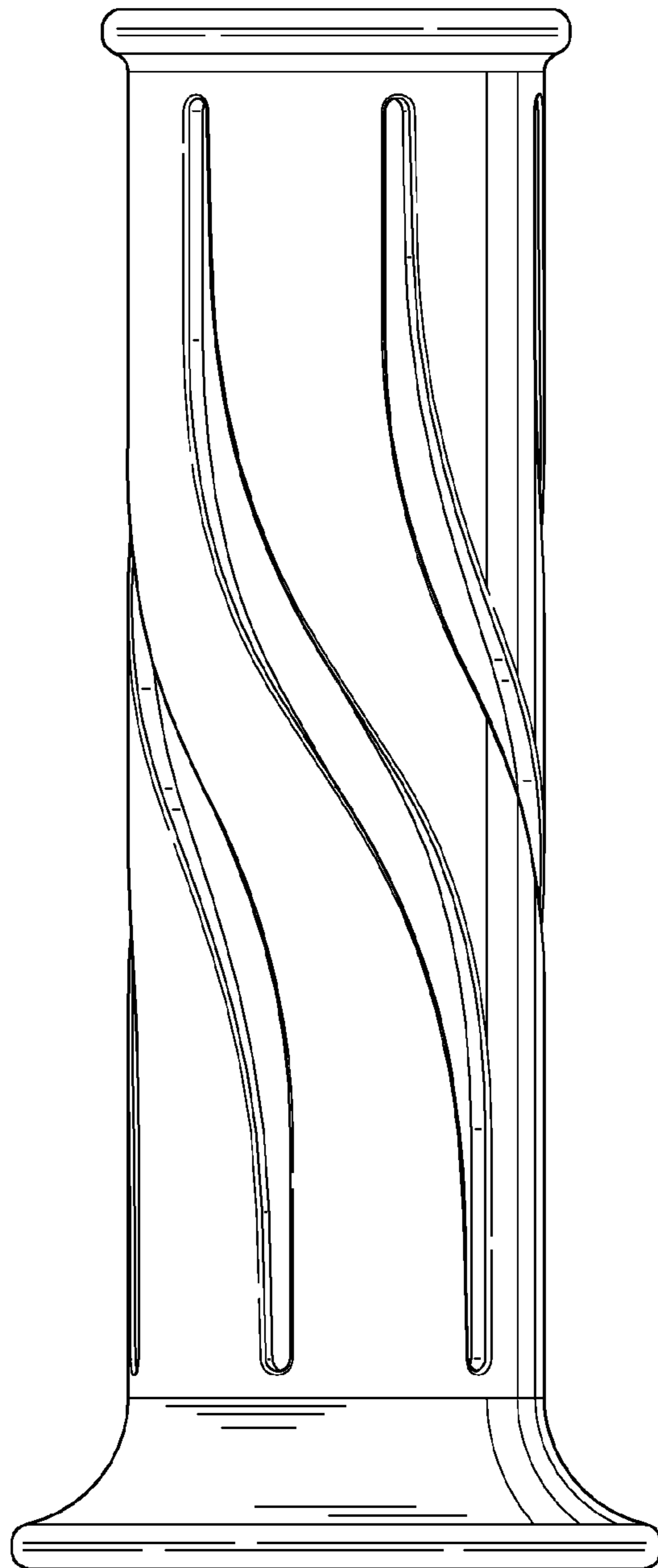

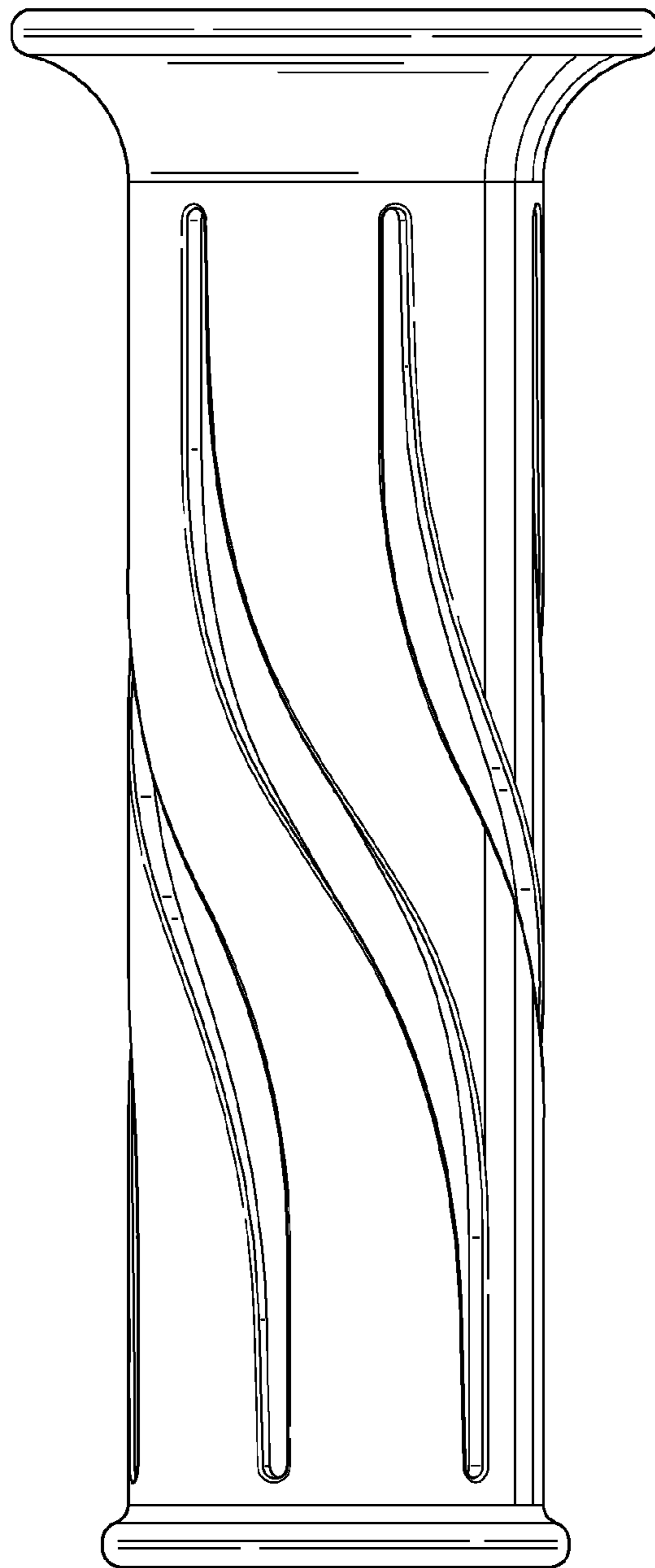

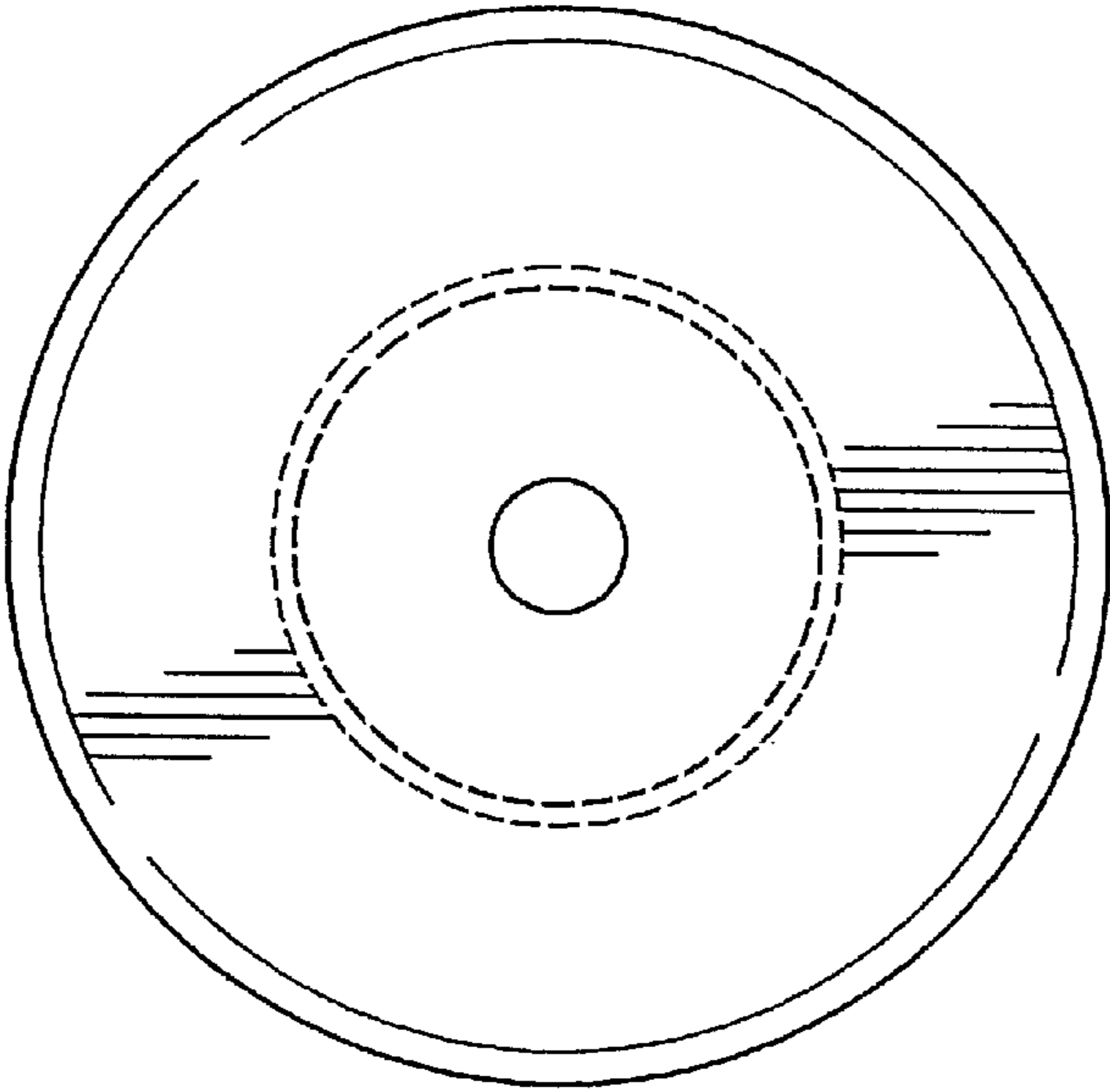

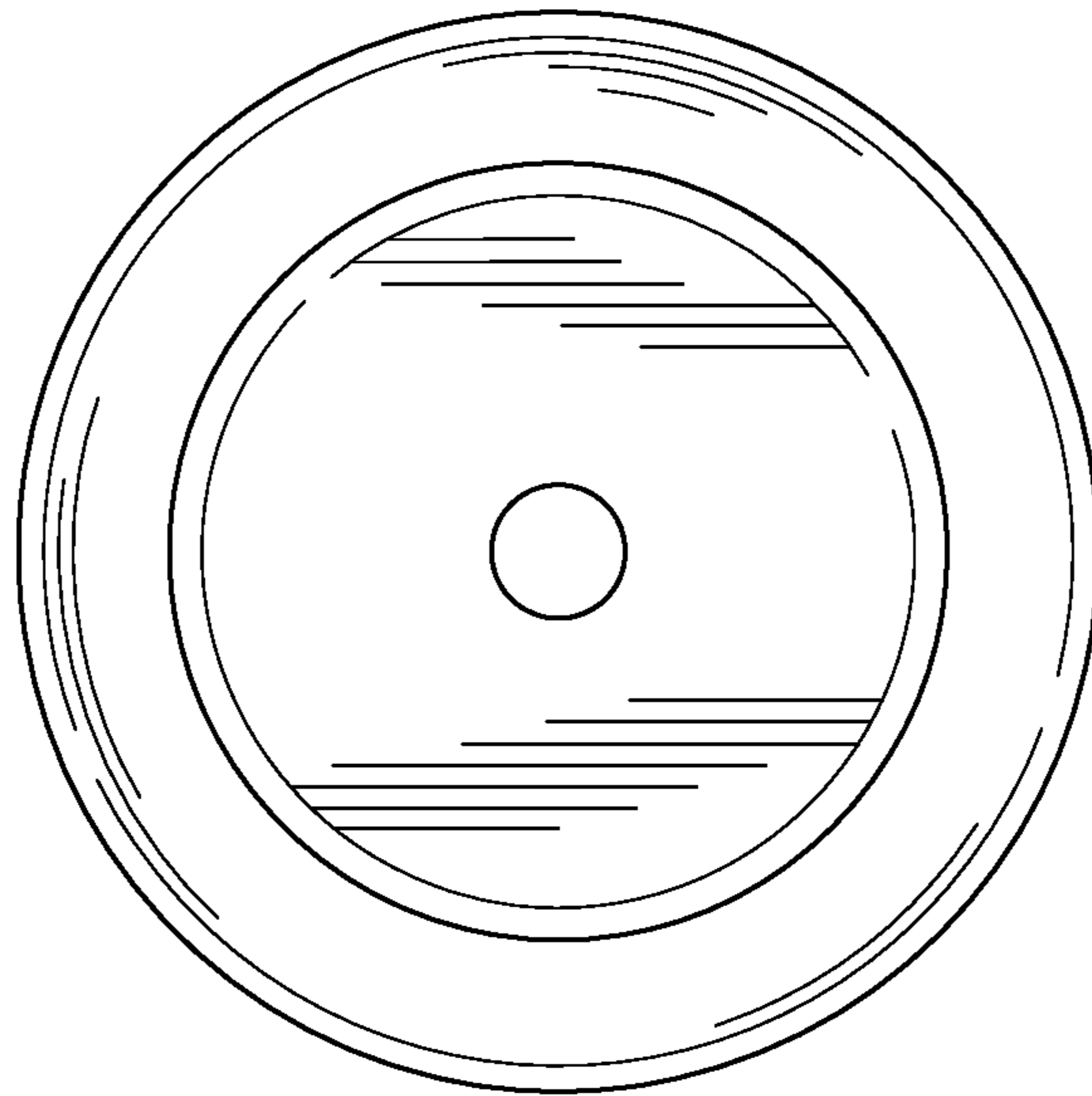

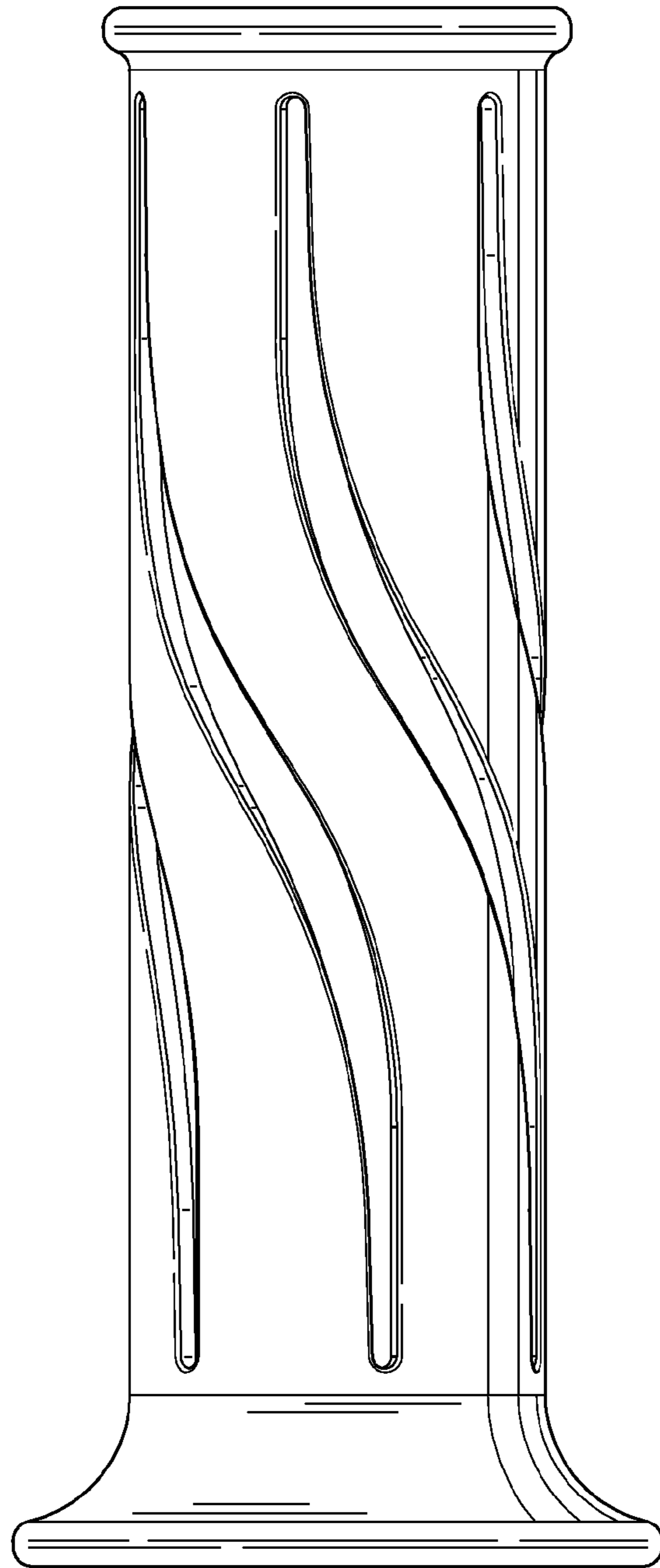

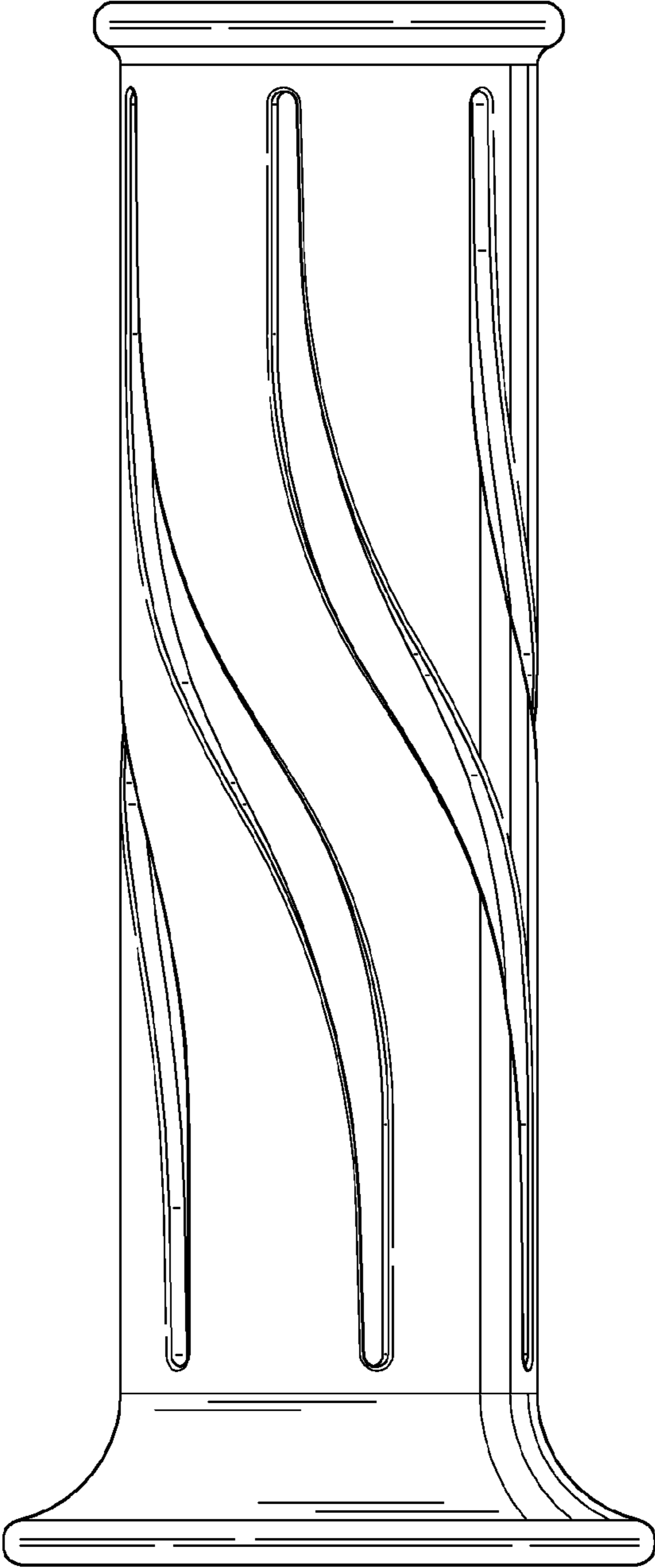
