(57) **CLAIM**

The ornamental design for a packaging pot, as shown.

**DESCRIPTION**

FIG. 1 is a bottom/front/left side perspective view of a packaging pot showing our new design;

FIG. 2 is a bottom/right side perspective view thereof;

FIG. 3 is a front/bottom/right side perspective view thereof in an upside down position;

FIG. 4 is a front/top/left side perspective view thereof;

FIG. 5 is a side perspective view thereof;

FIG. 6 is a front/right side perspective view thereof; and,

FIG. 7 is a top plan view thereof.

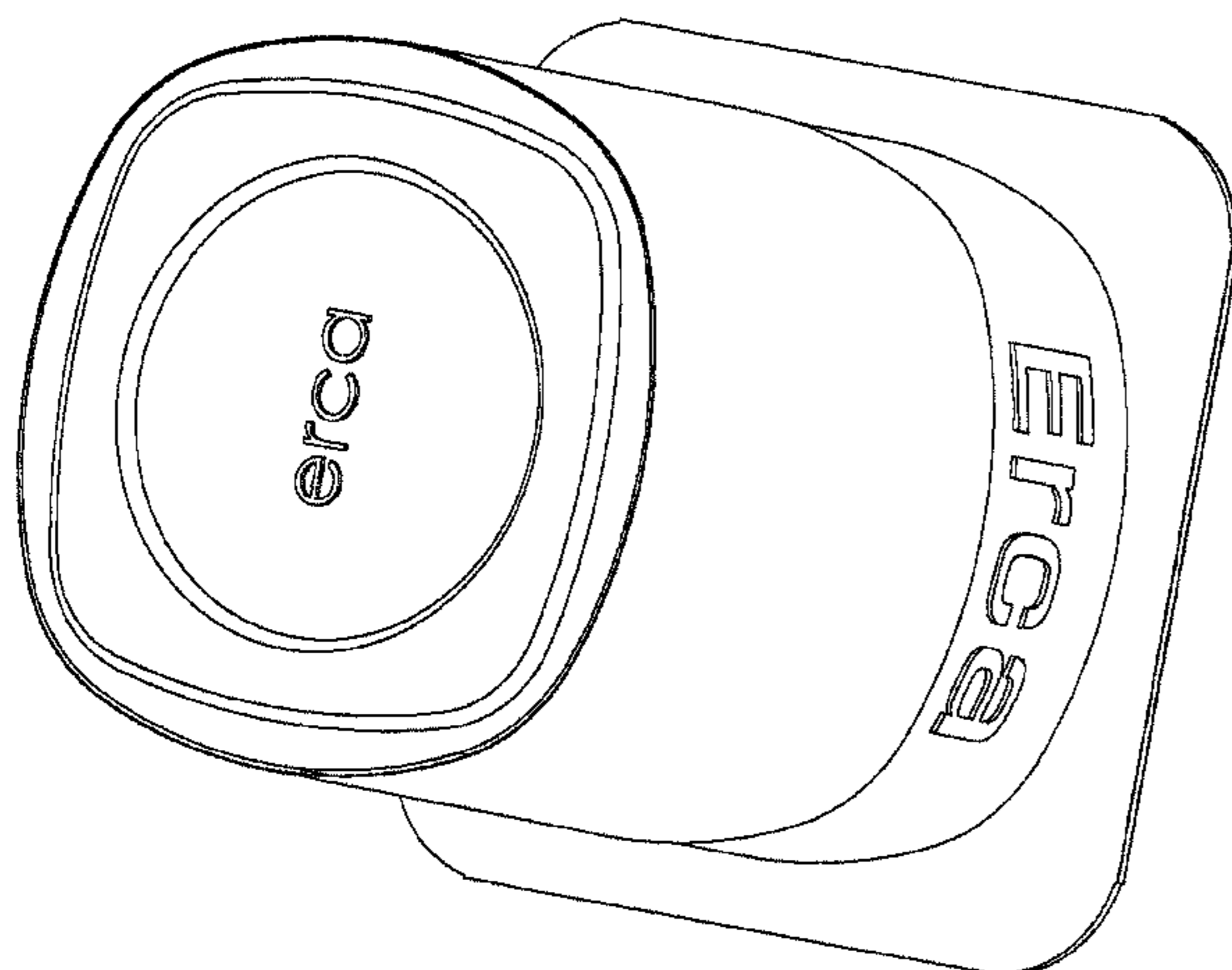

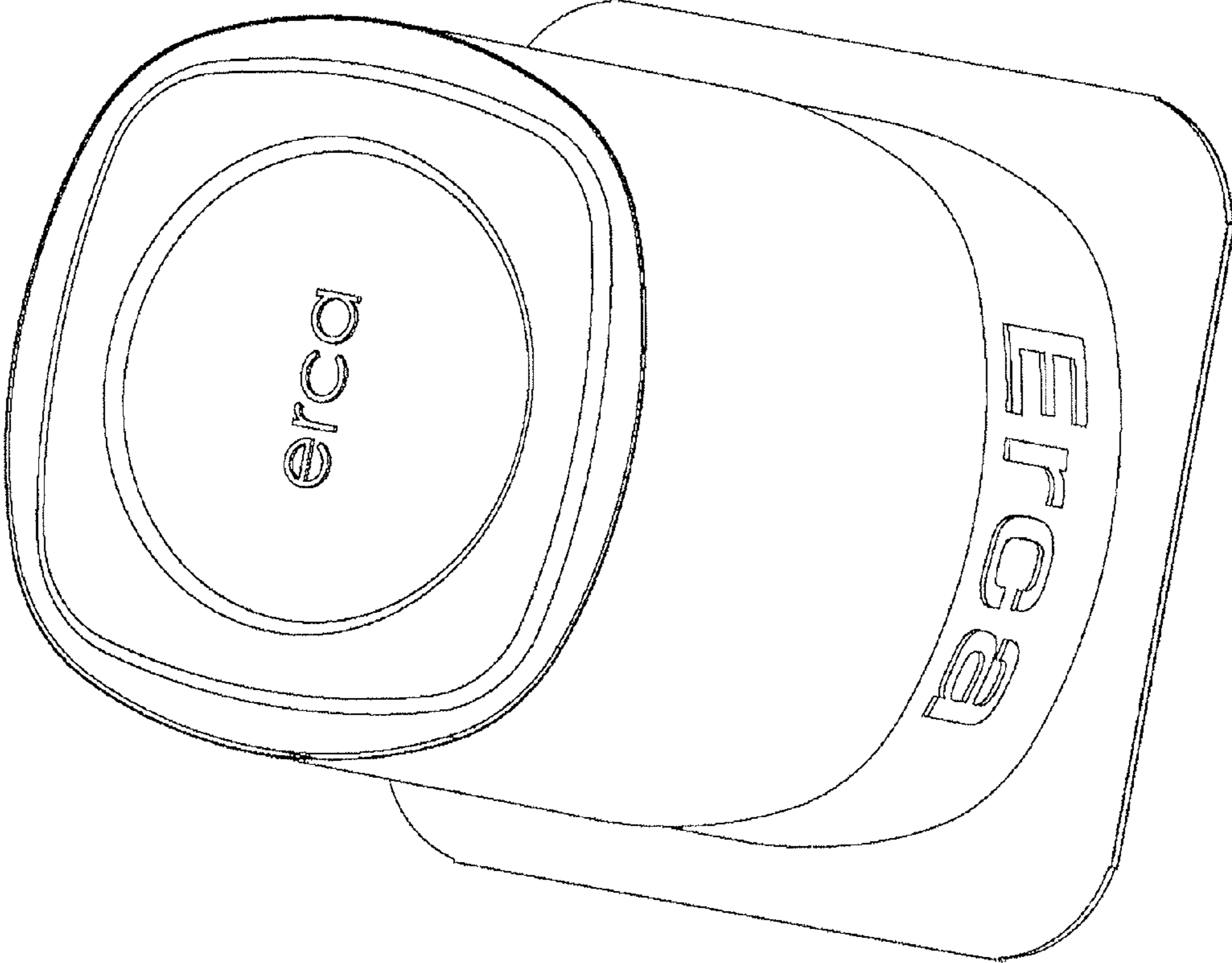

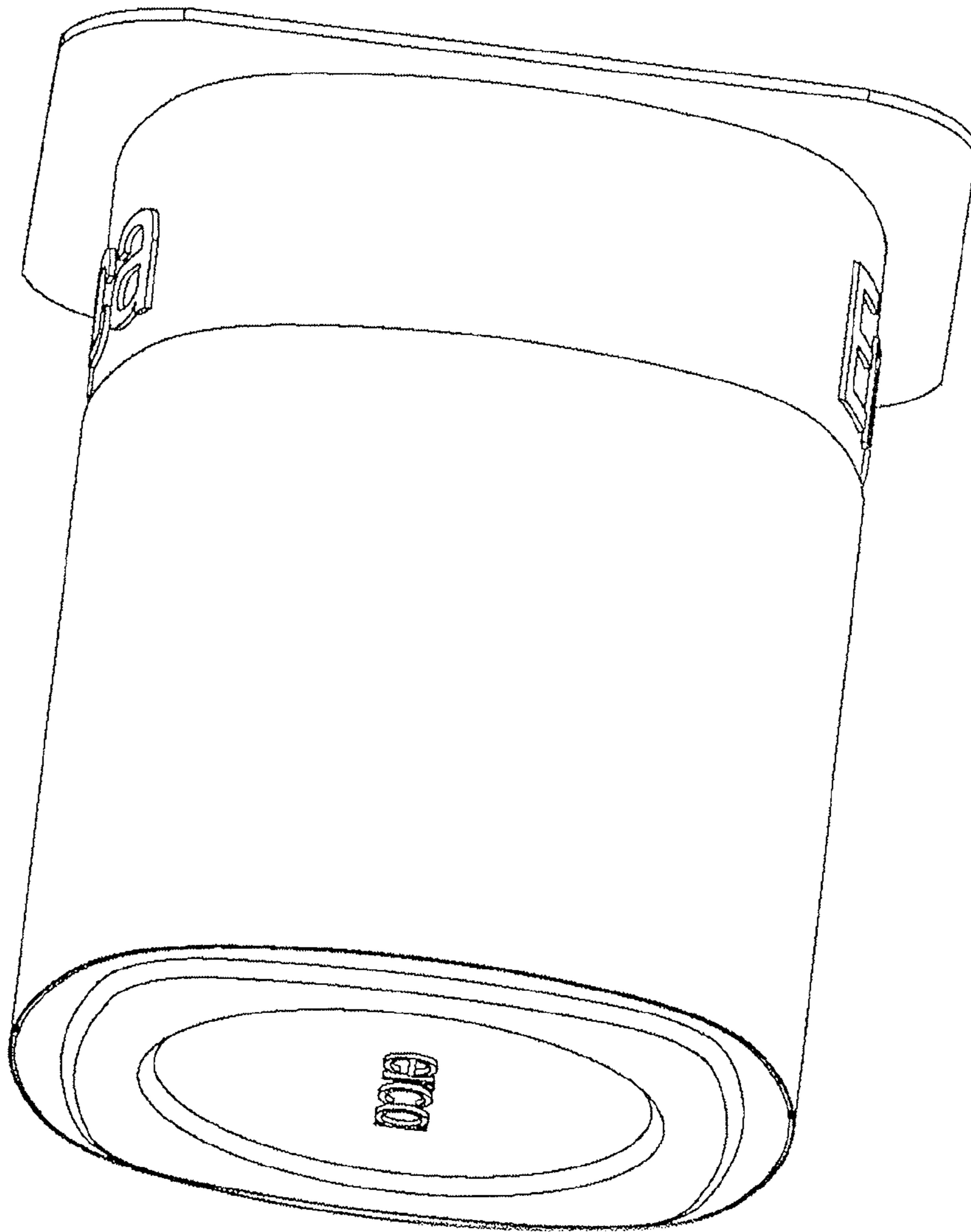

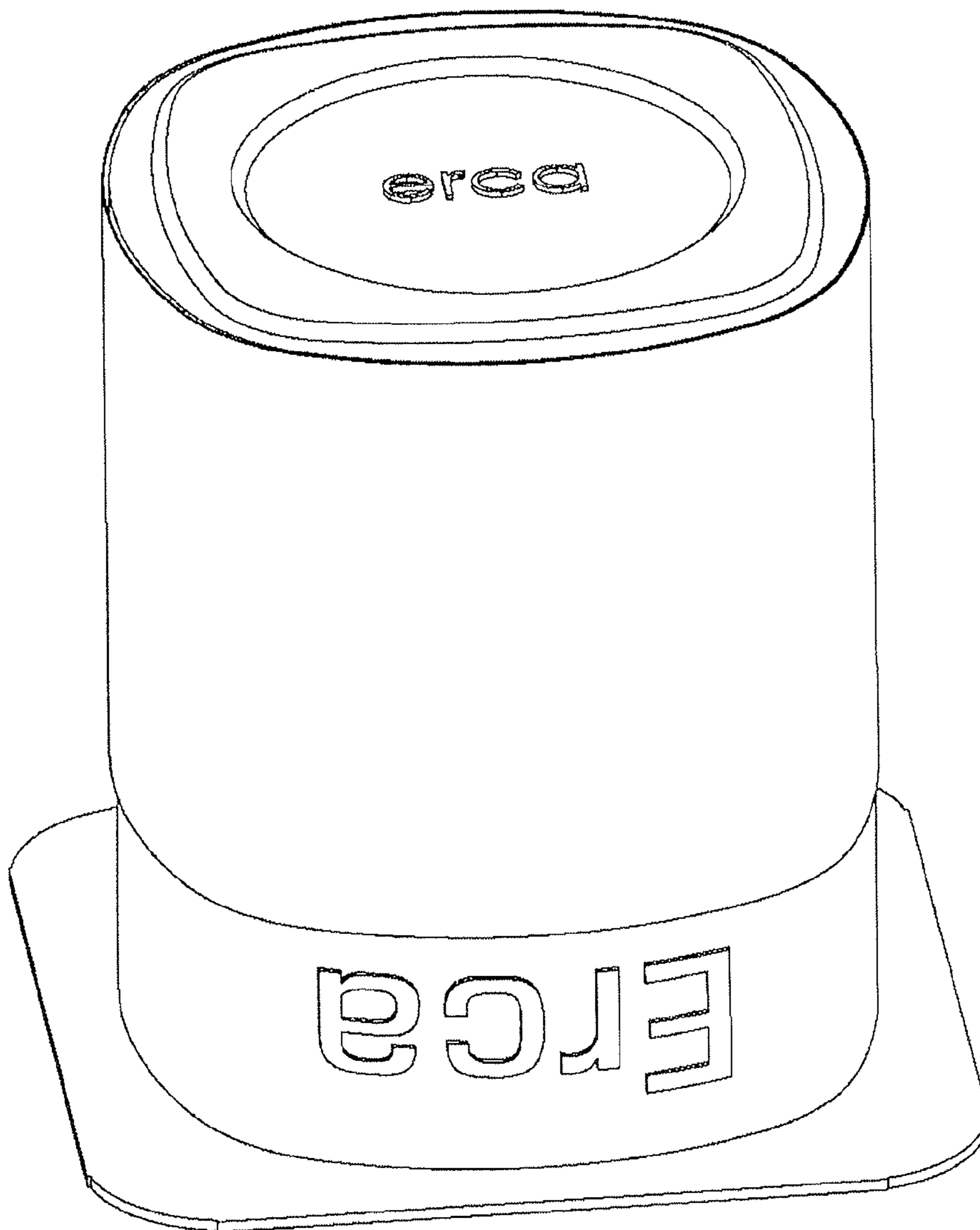

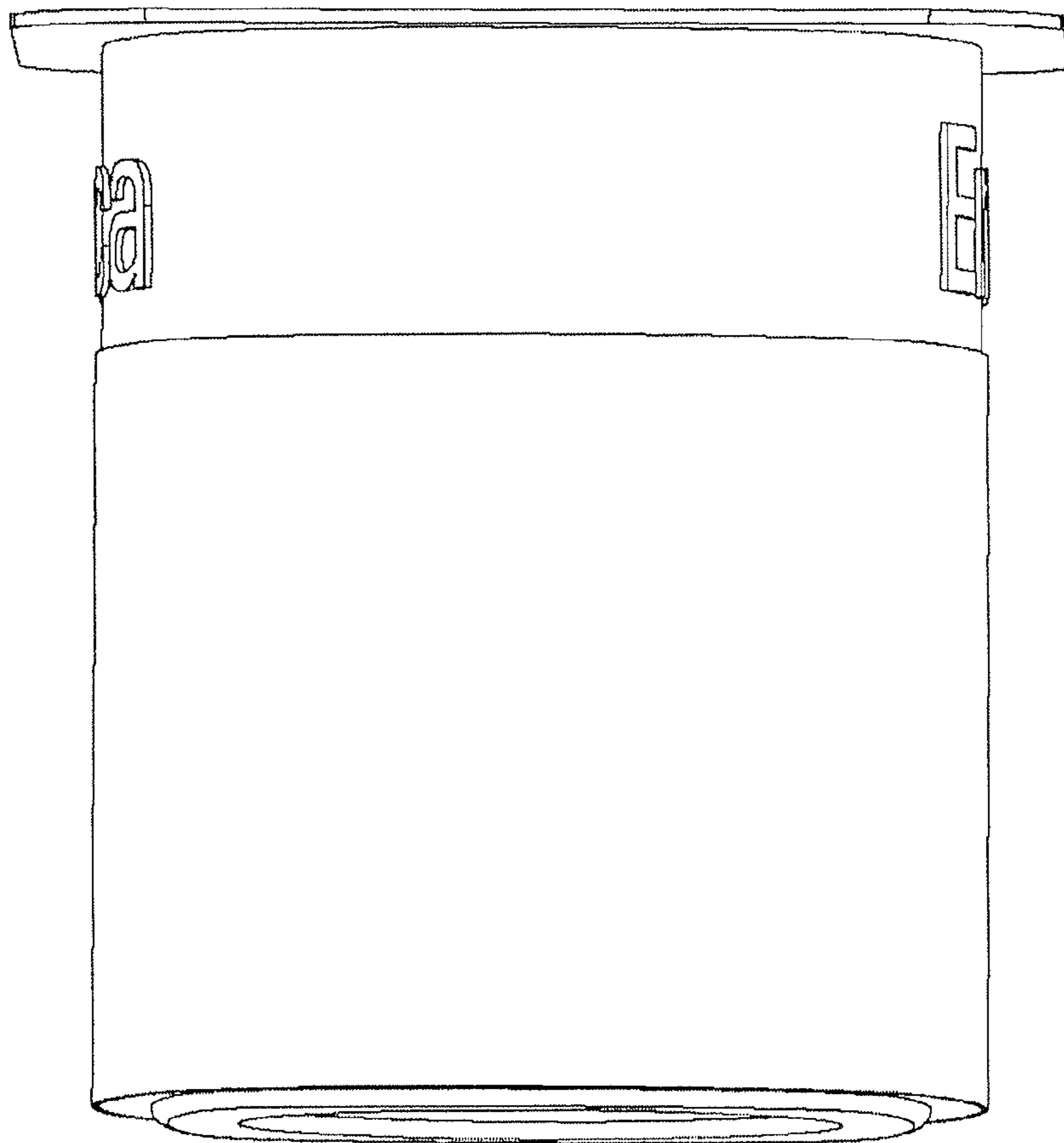
