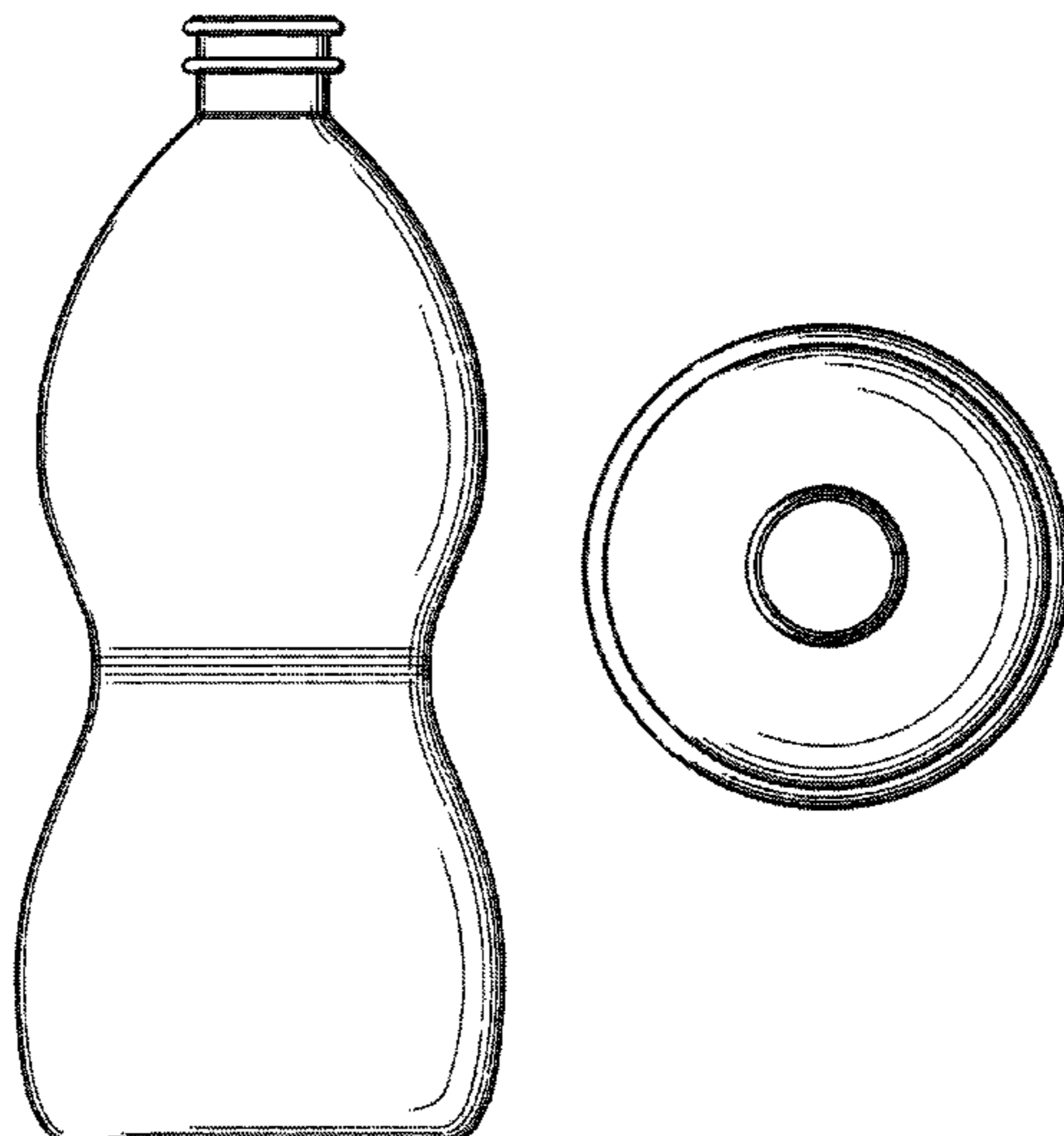
(57) **CLAIM**

The ornamental design for bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a bottle.  
FIG. 2 is a front side elevation view of the bottle. The back side elevation view, the left side elevation view, and the right side elevation view of the bottle are identical to the front side elevation view of FIG. 2; and,  
FIG. 3 is a top plan view of the bottle shown at an enlarged scale.

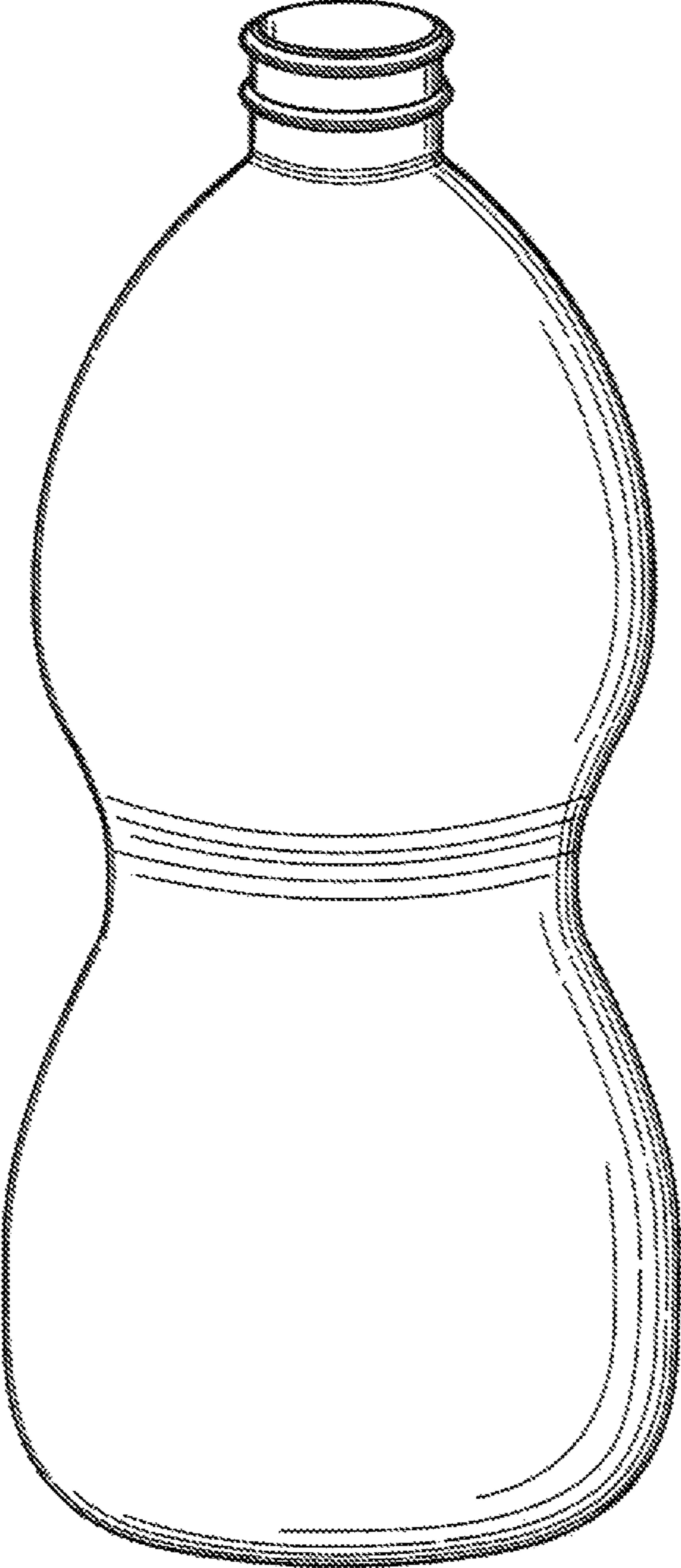

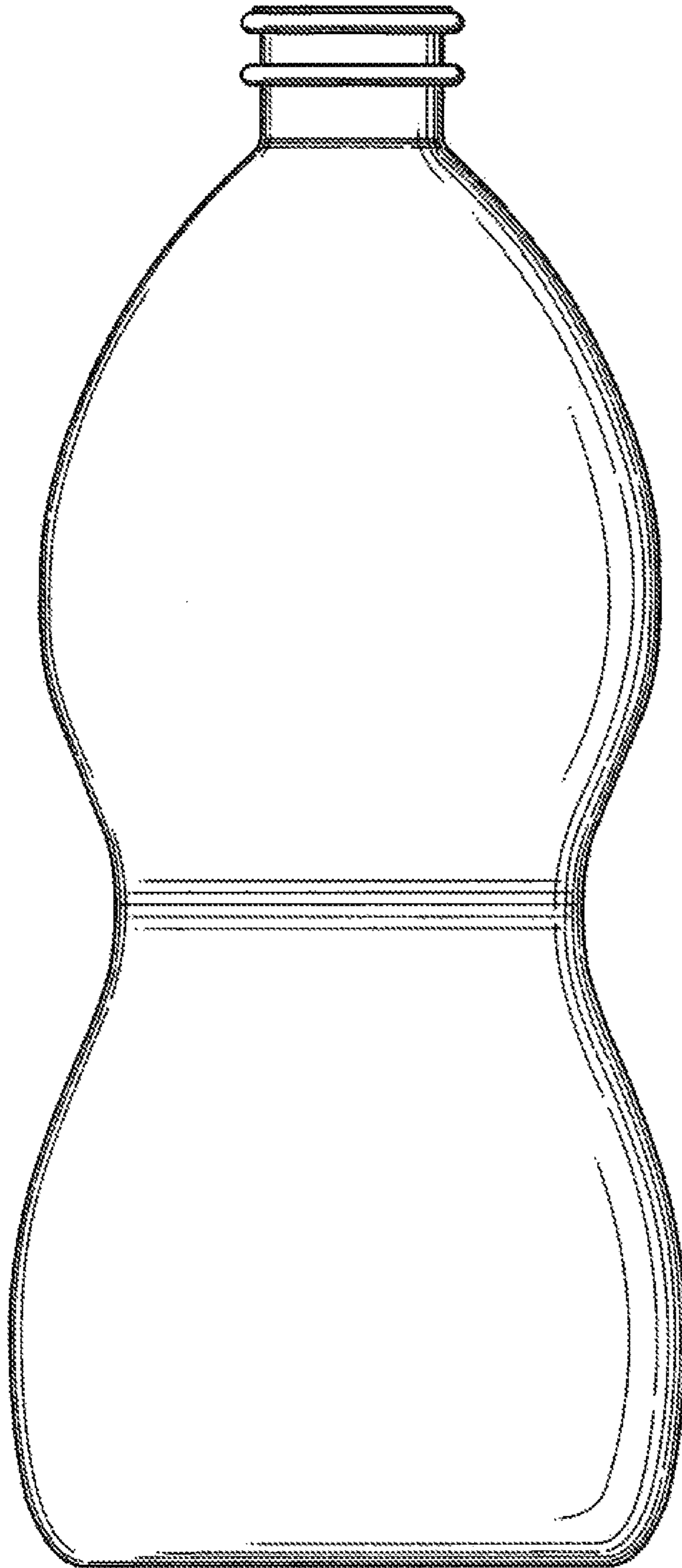

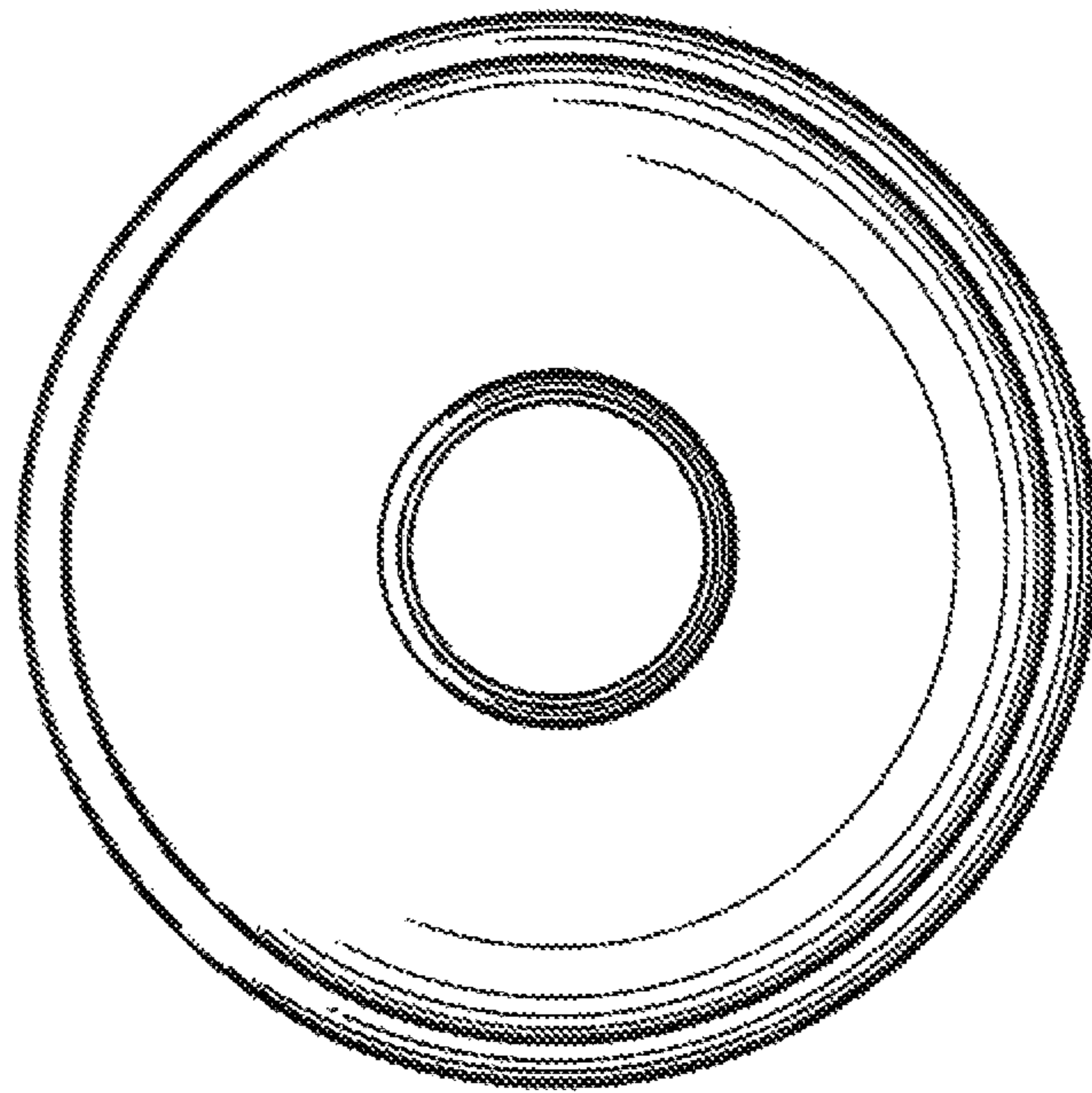
