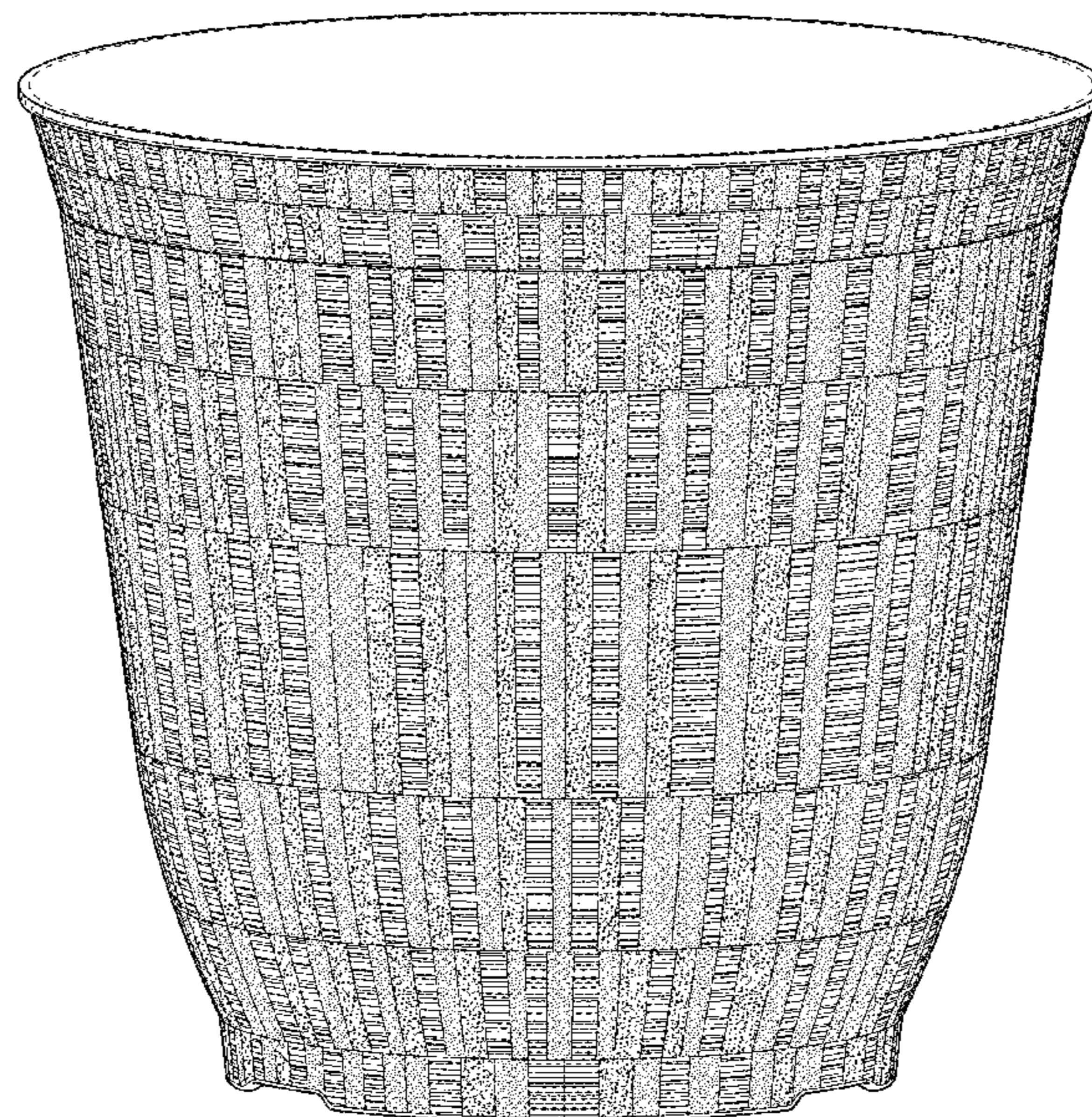
(57) **CLAIM**

What is claimed is the ornamental design for a planter, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a planter showing a new design;
FIG. 2 is a front view of the planter of FIG. 1;
FIG. 3 is a rear view of the planter of FIG. 1;
FIG. 4 is a right side view of the planter of FIG. 1;
FIG. 5 is a left side view of the planter of FIG. 1;
FIG. 6 is a top view of the planter of FIG. 1; and,
FIG. 7 is a bottom view of the planter of FIG. 1.
The portions shown in broken lines are included for the purpose of showing features that form no part of the claimed design.

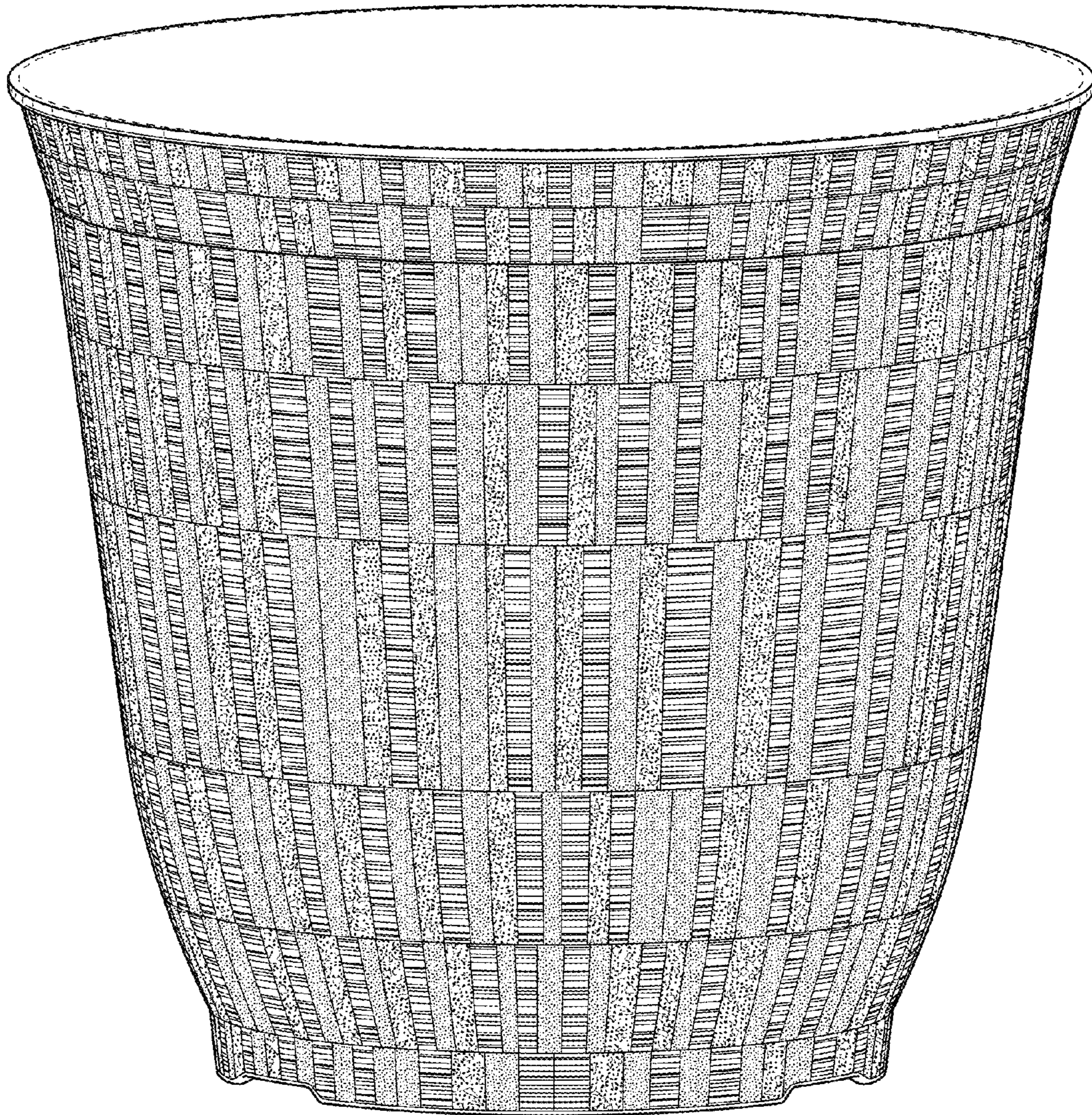

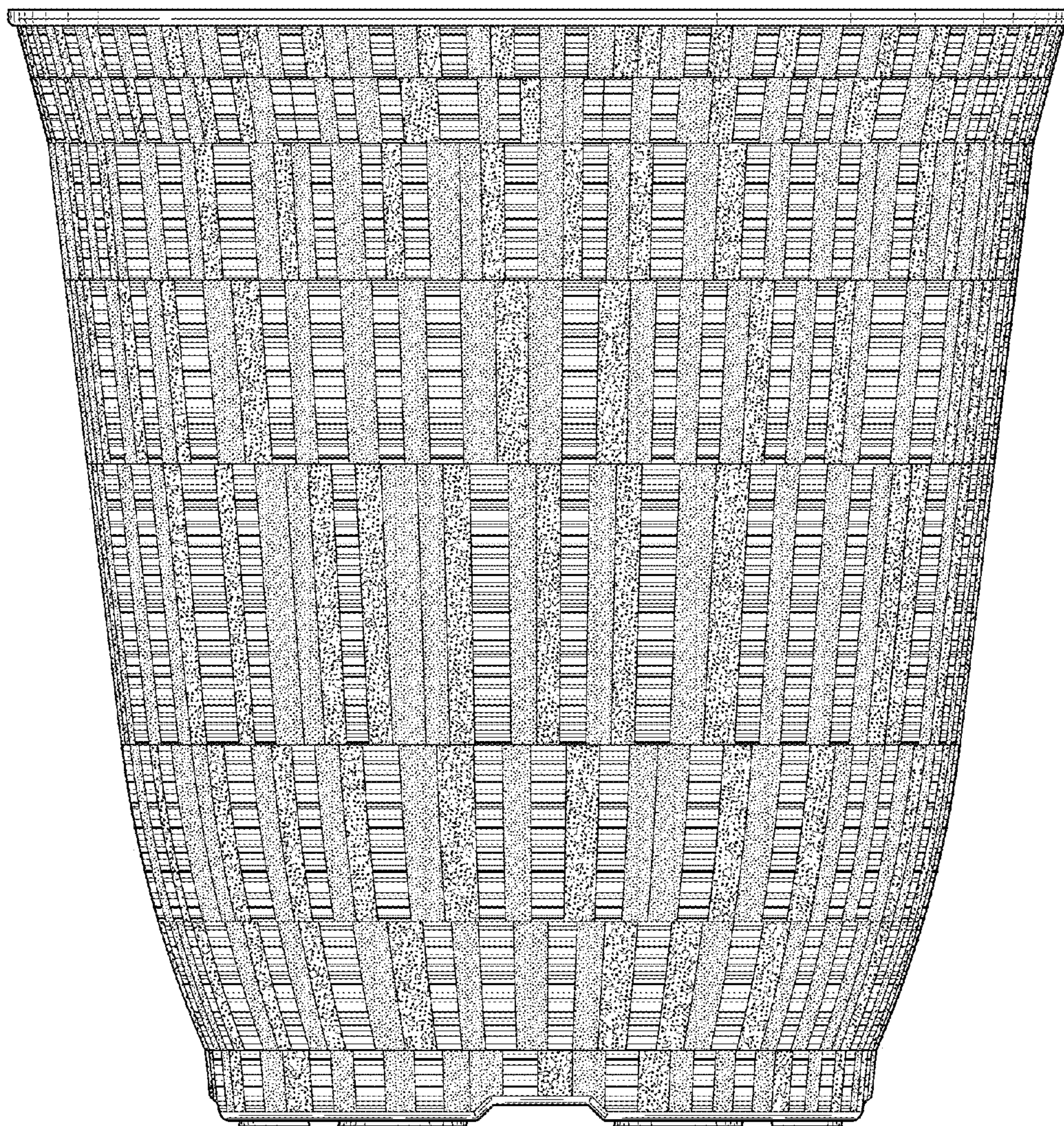

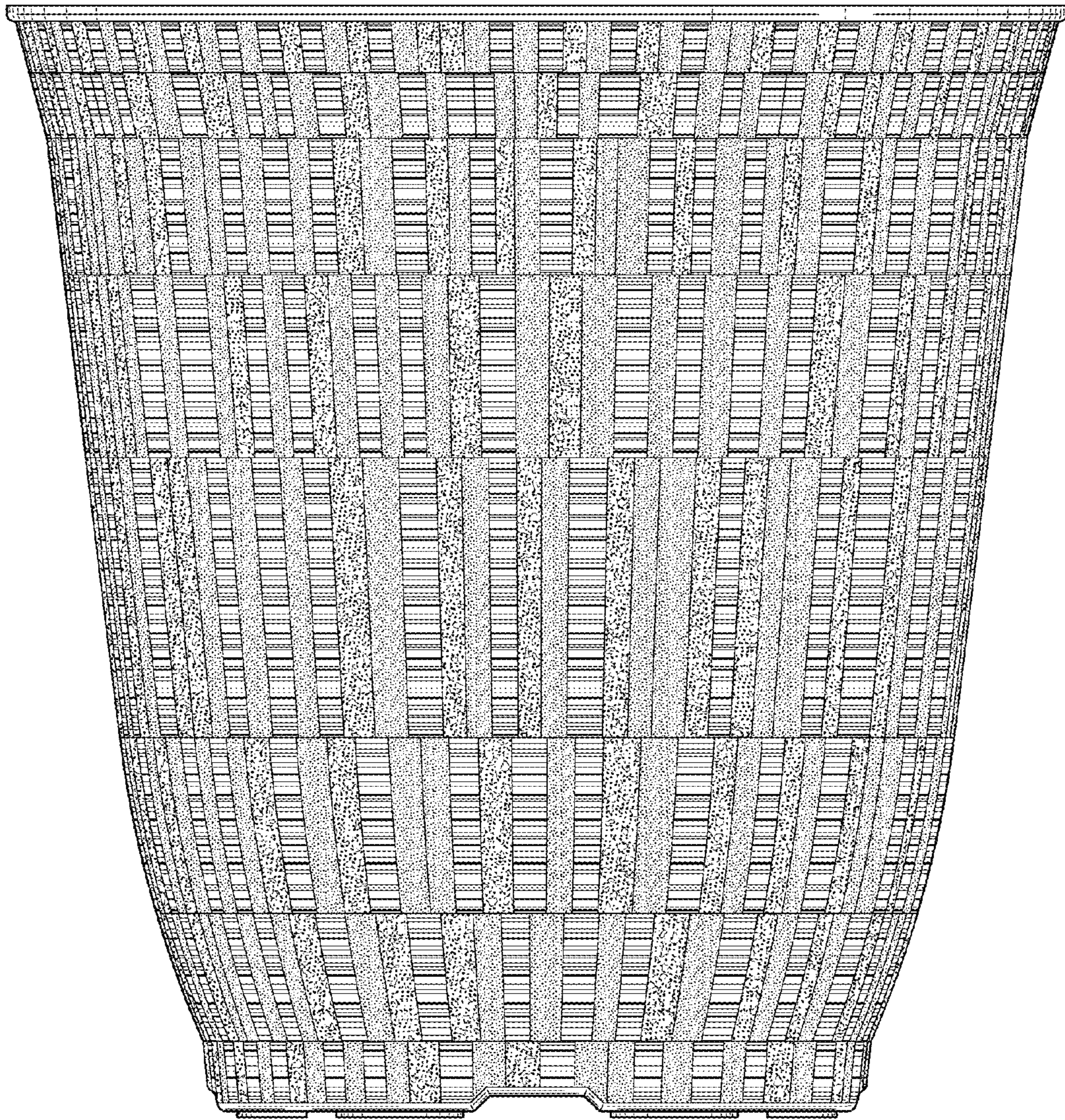

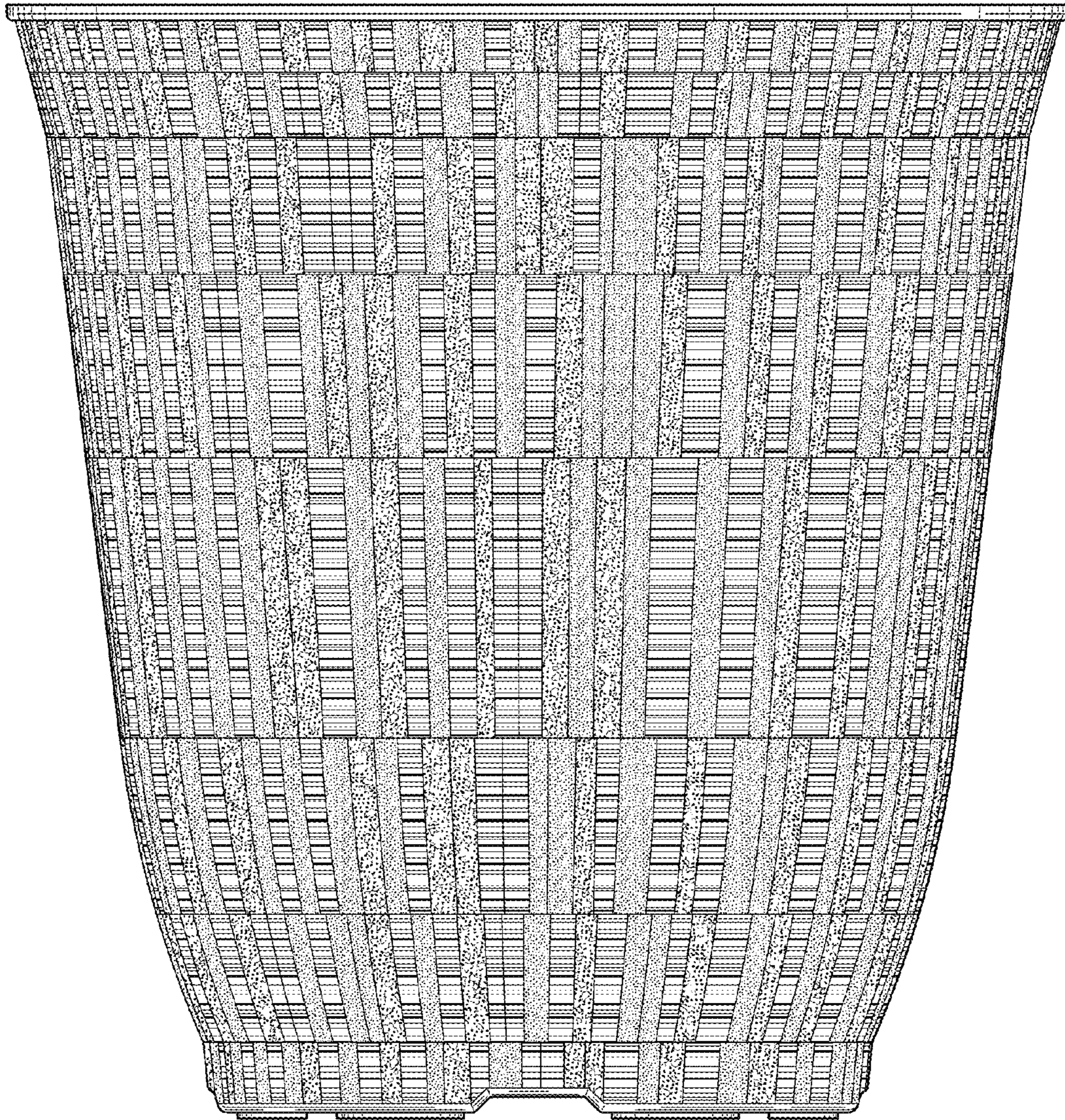

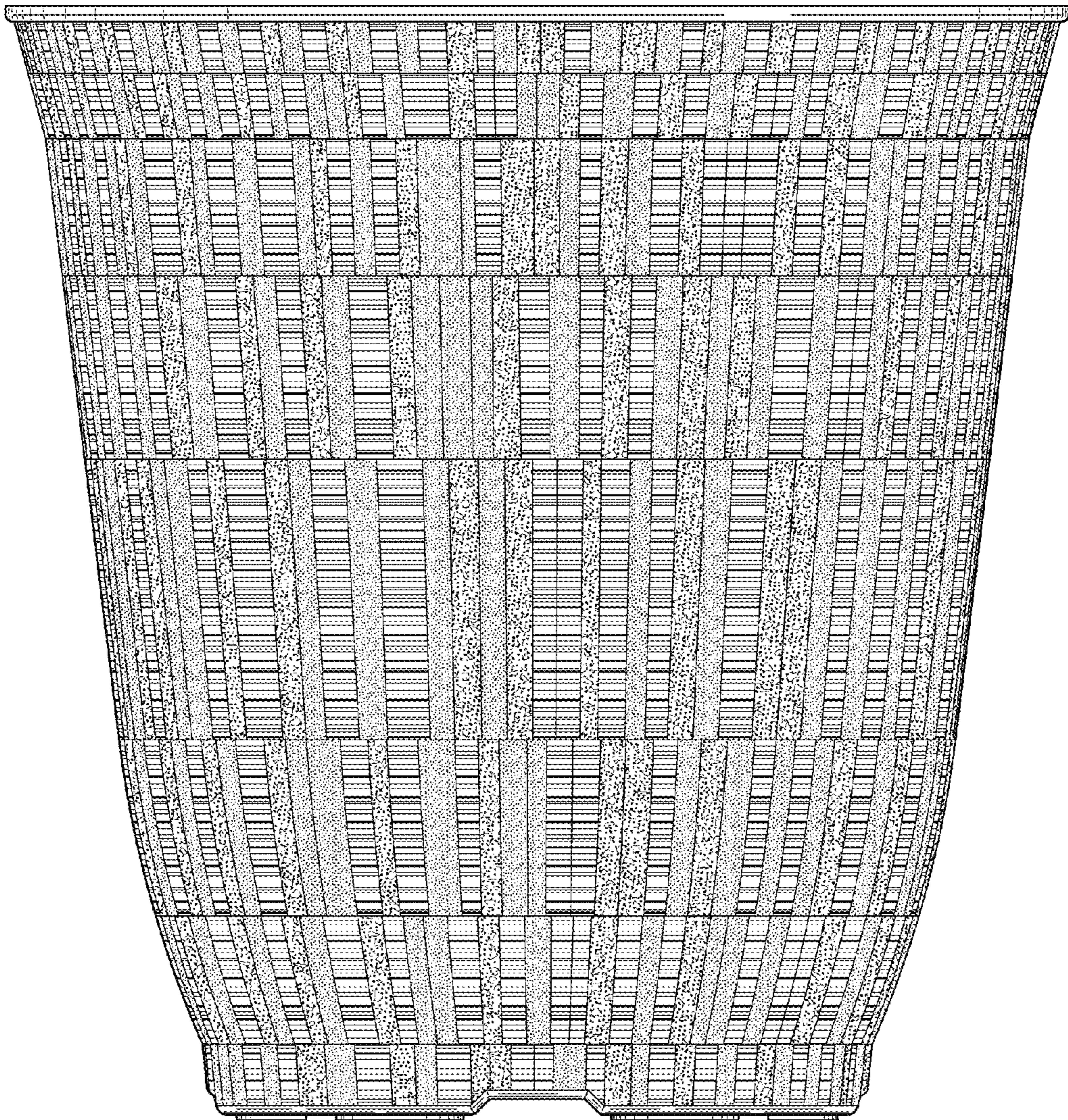

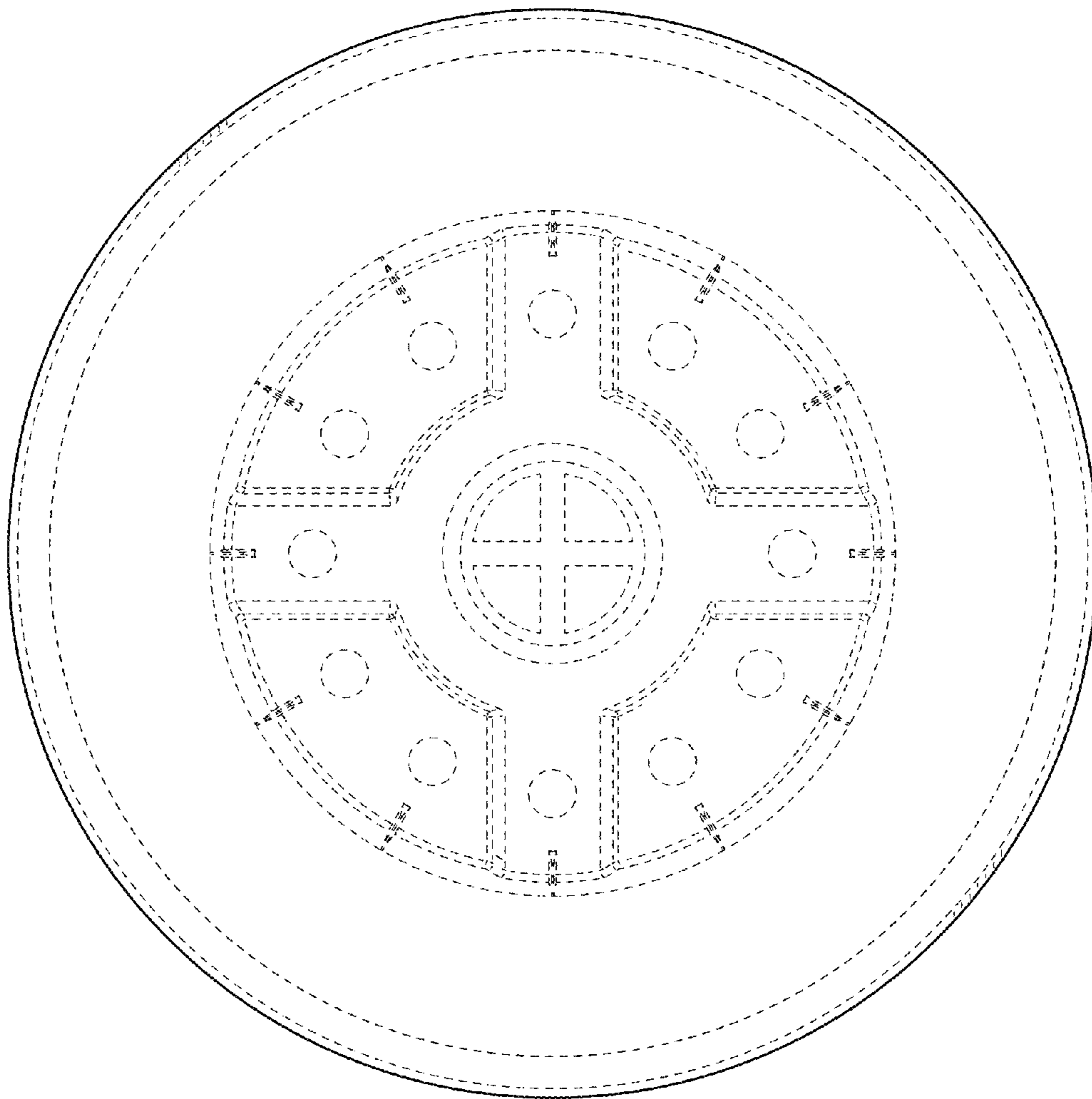

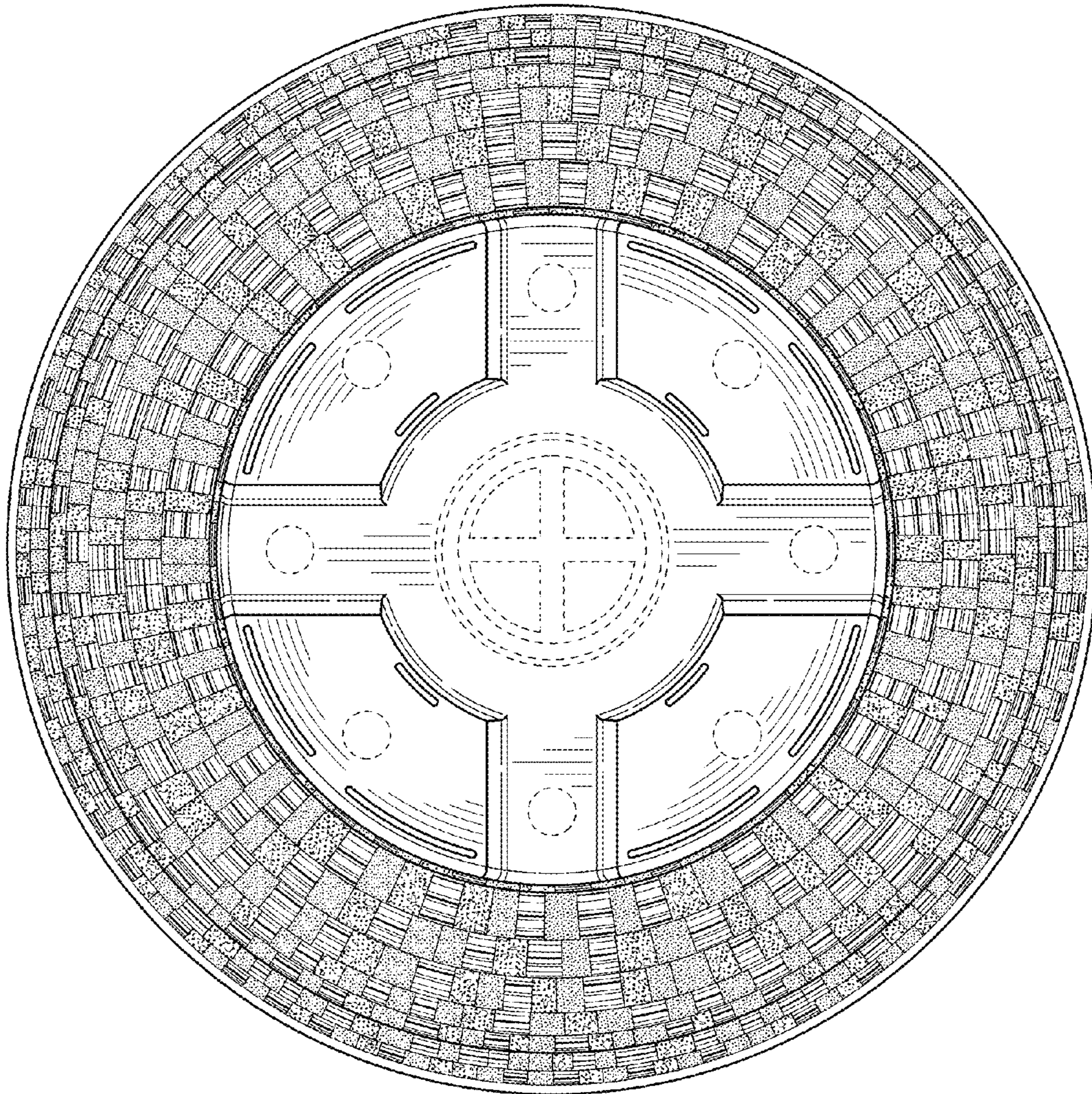
