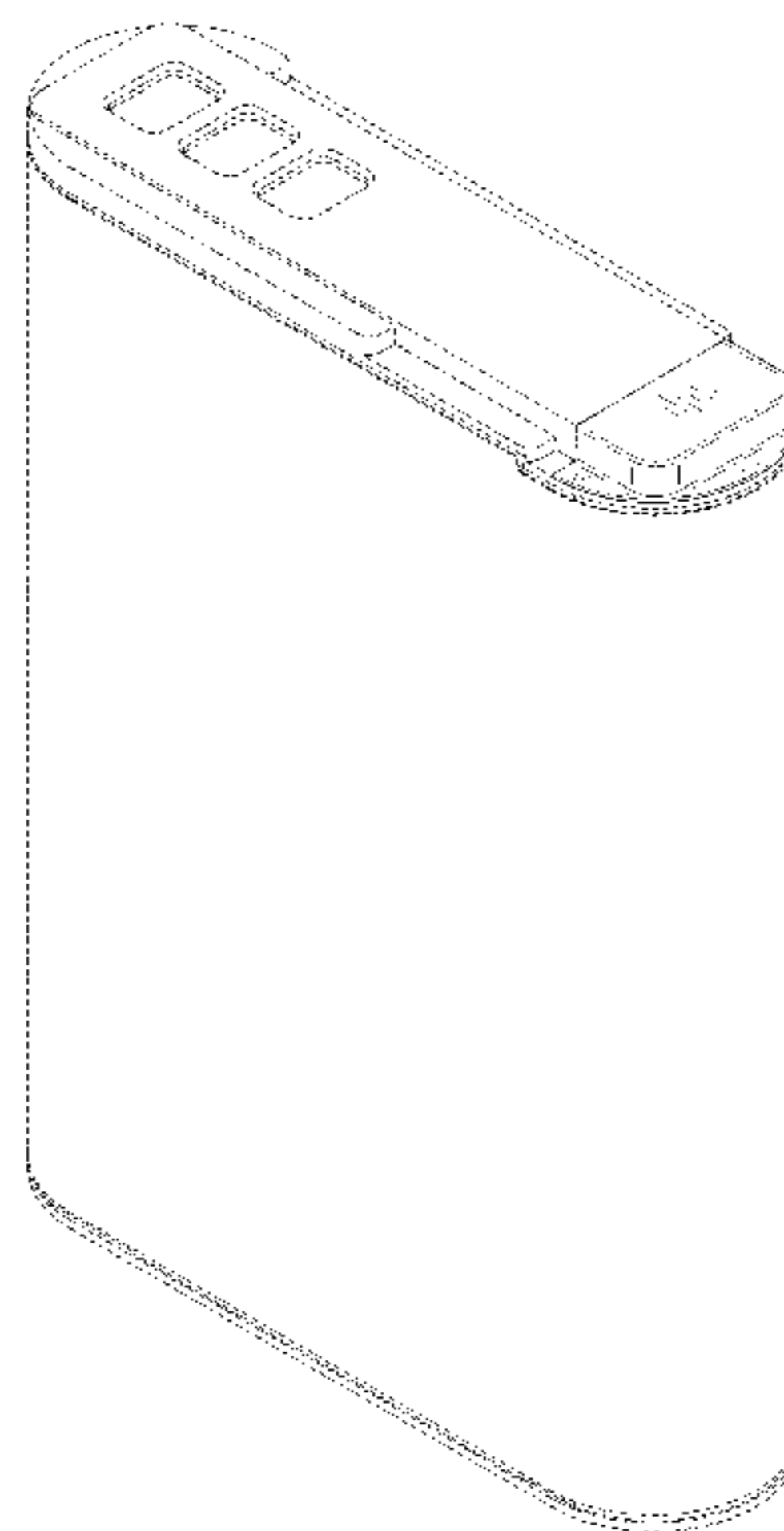
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, top and right side perspective view of a battery showing our new design;
FIG. 2 is a rear, top and left side perspective view thereof;

FIG. 4 is a rear view thereof;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a right side view thereof.

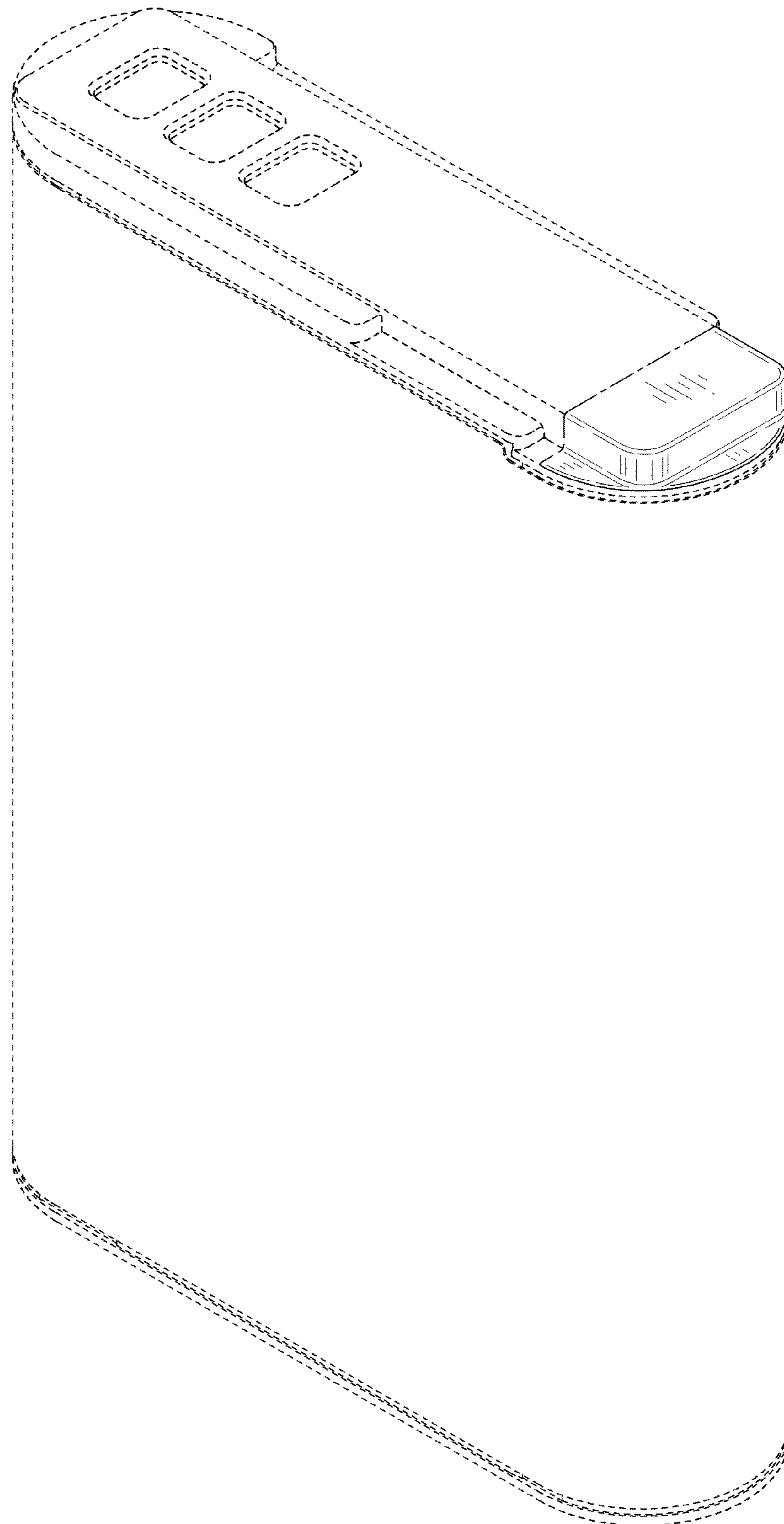

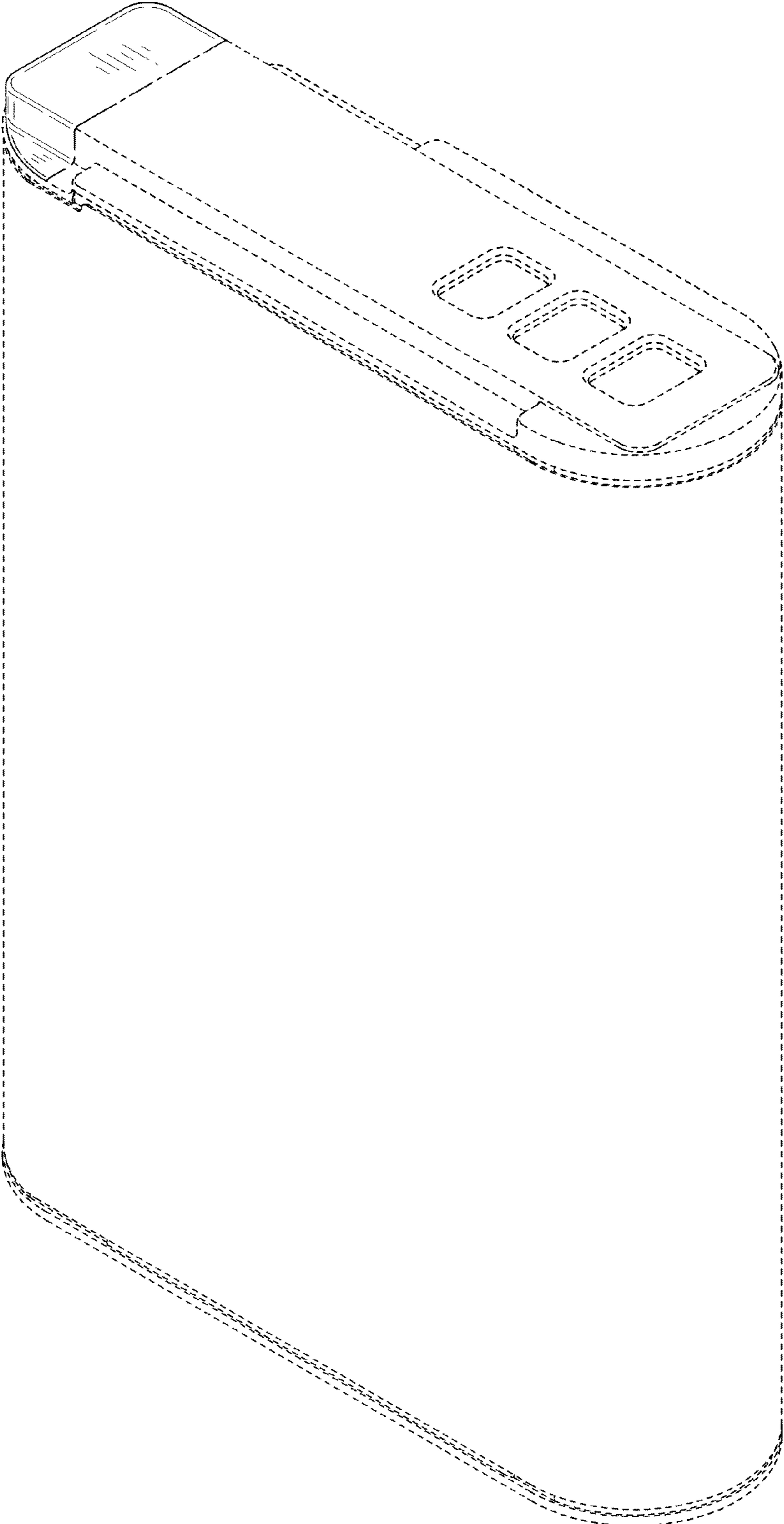

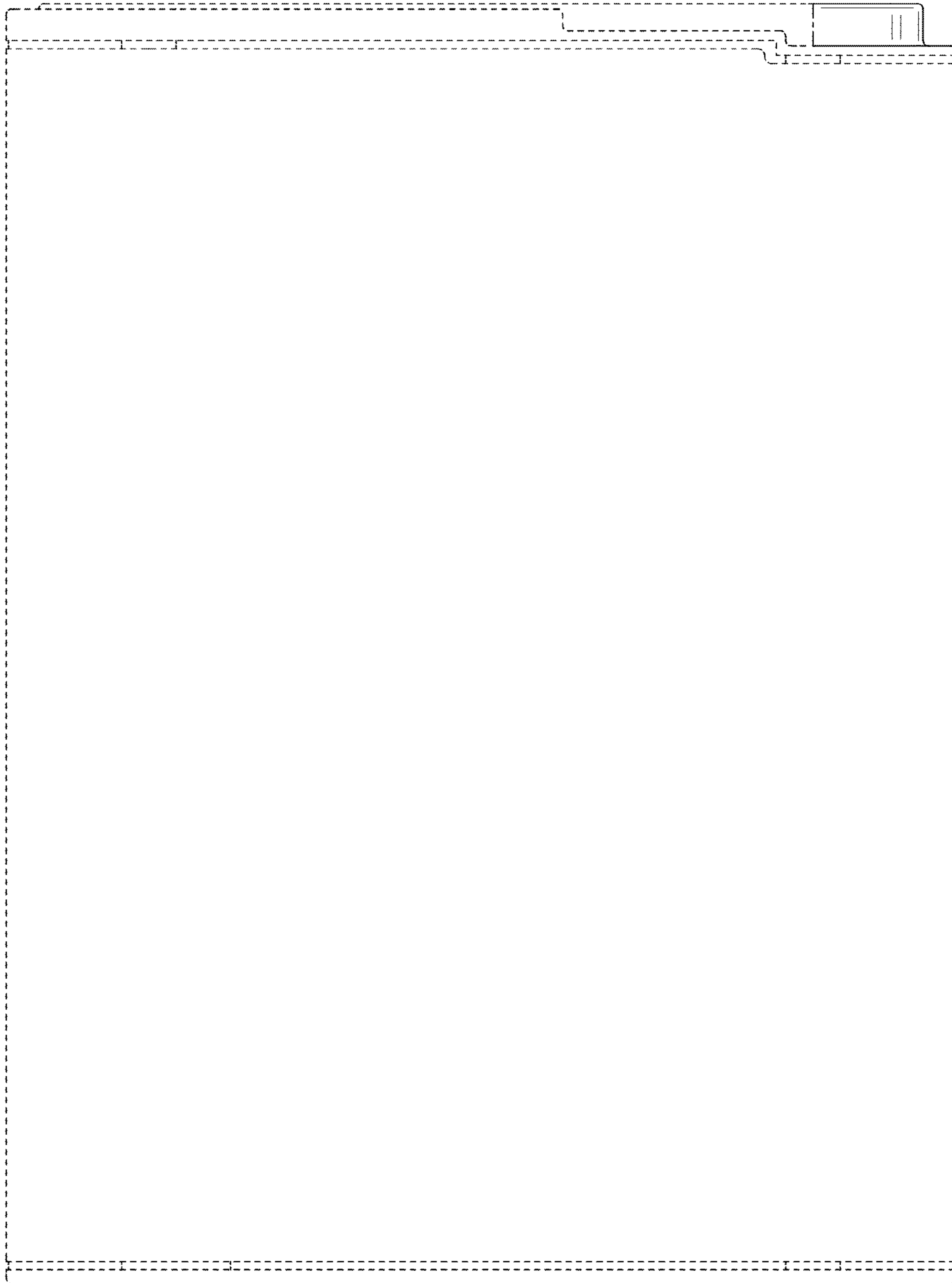

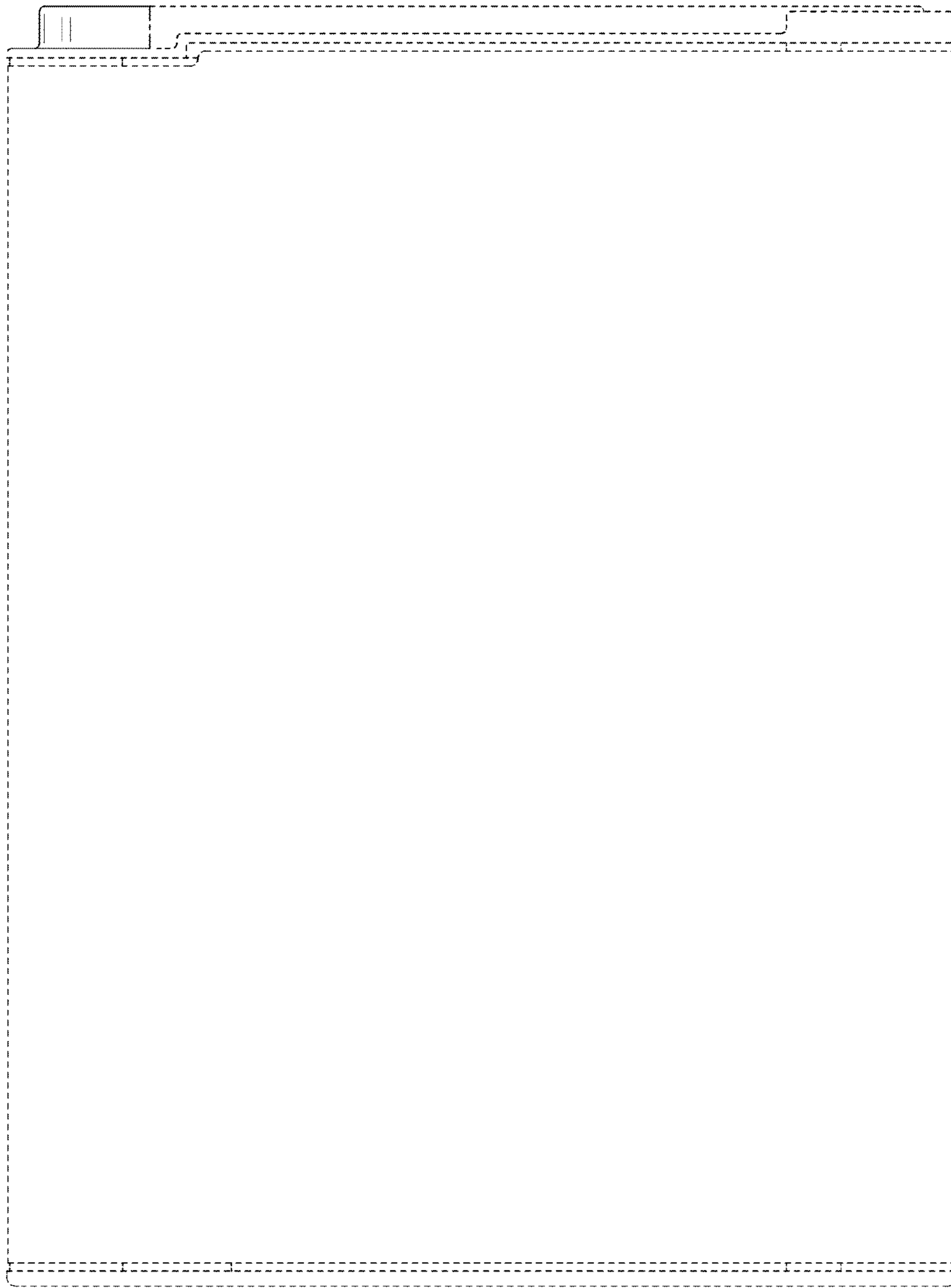

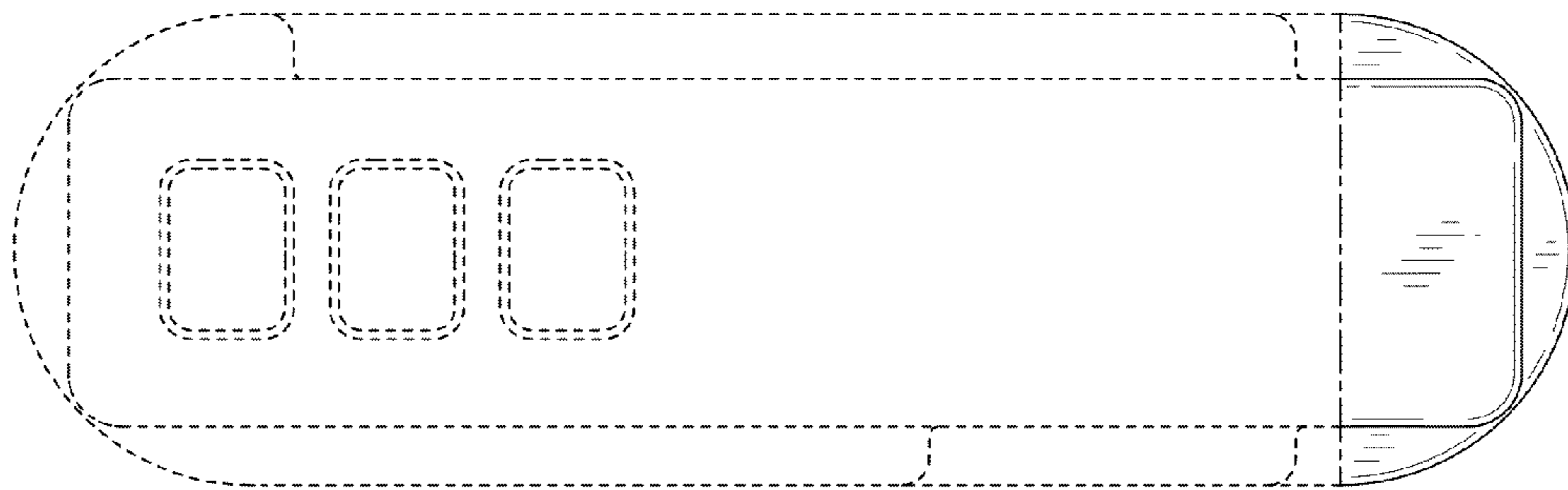
