FIG. 4 is a left side view thereof where the right side view is a mirror image;

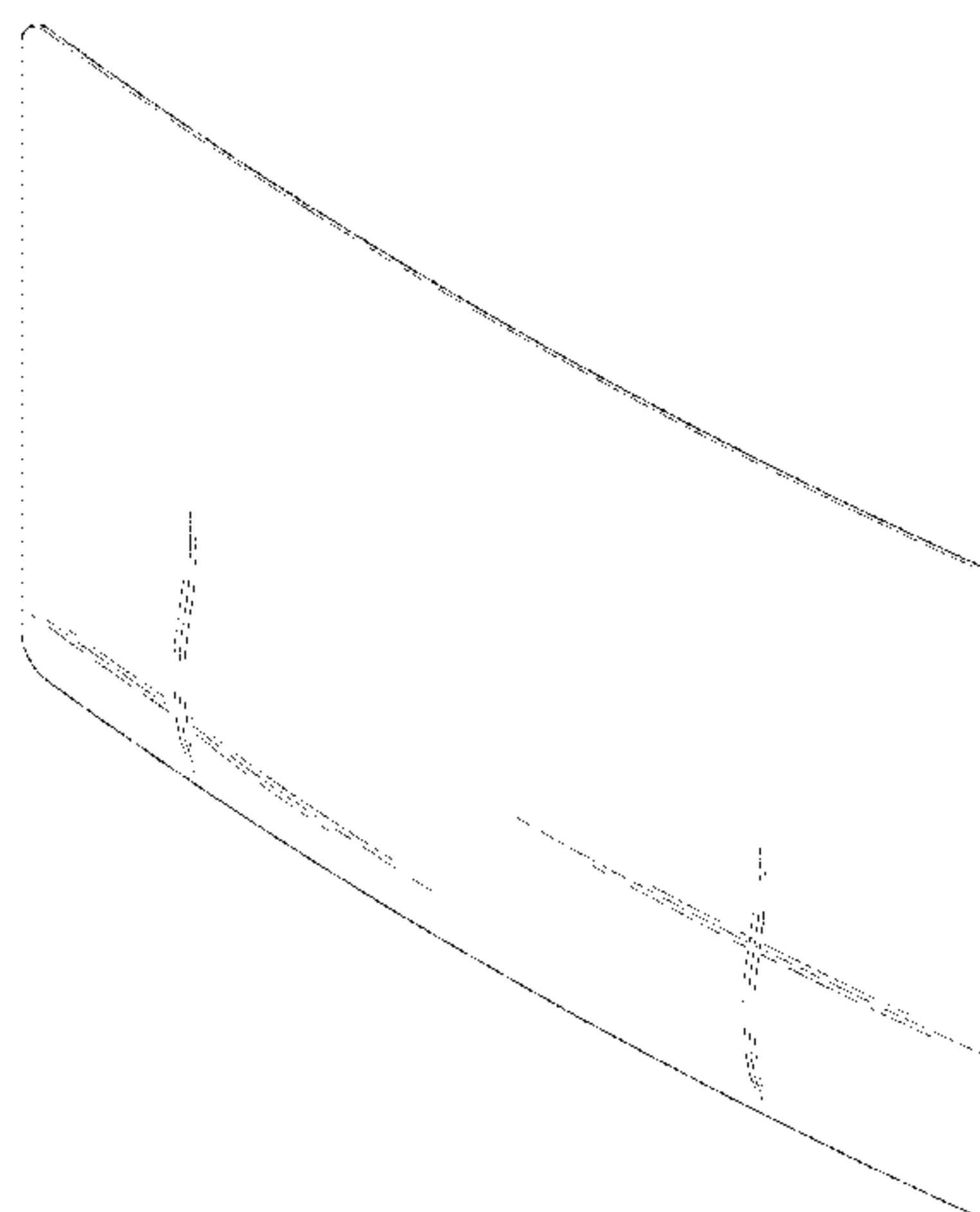
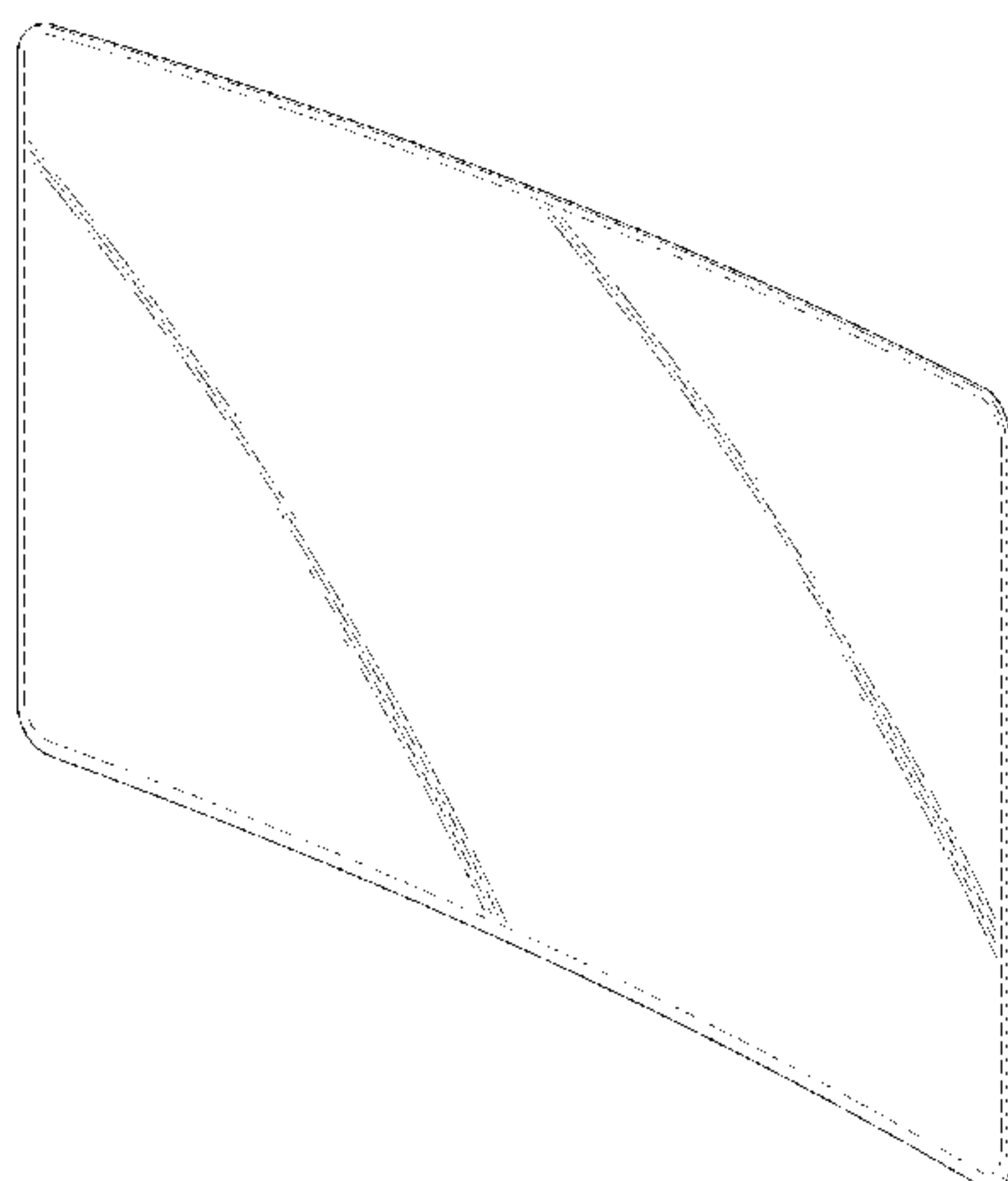
FIG. 5 is a top plan view thereof where the bottom plan view is a mirror image;

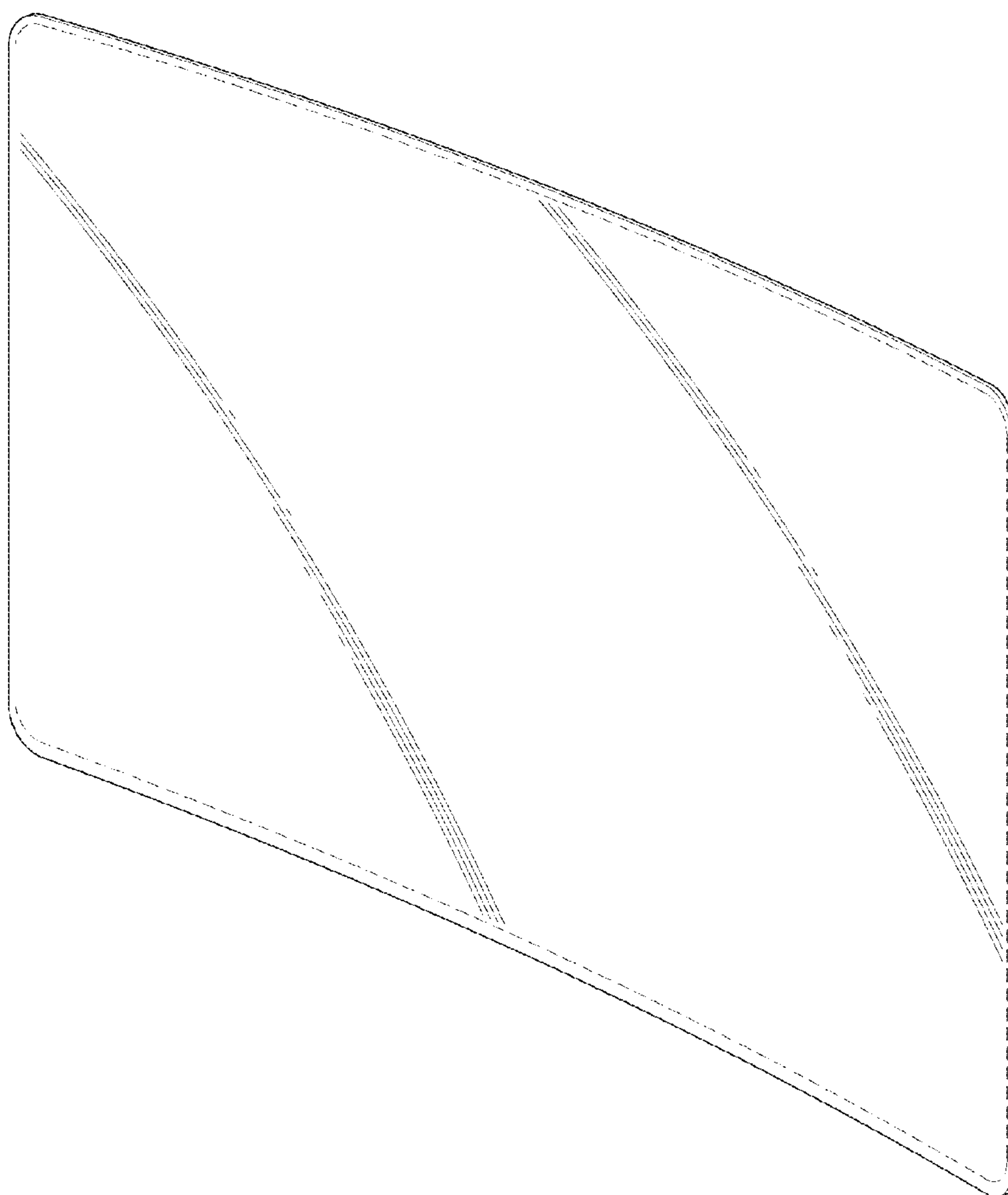

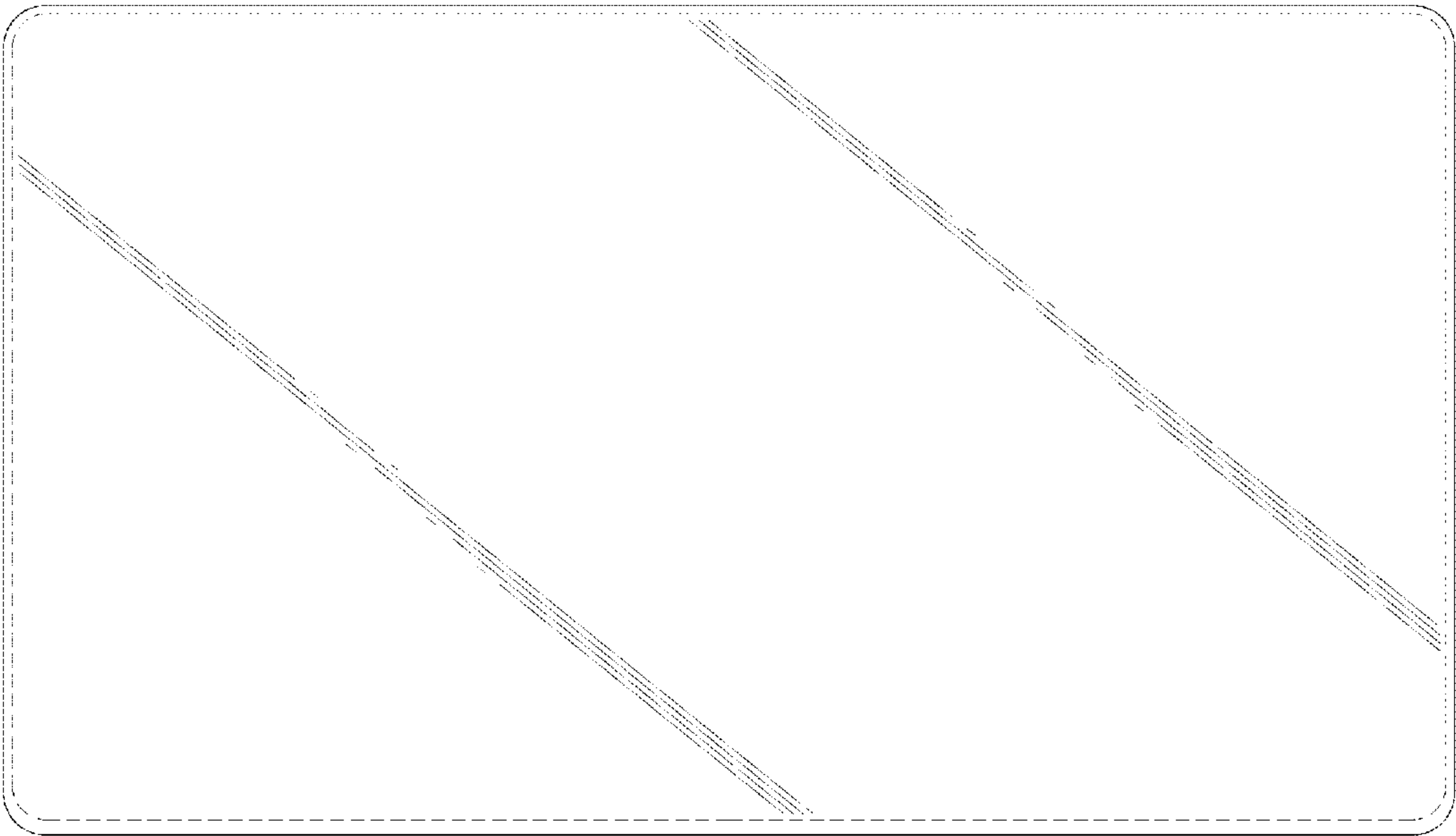

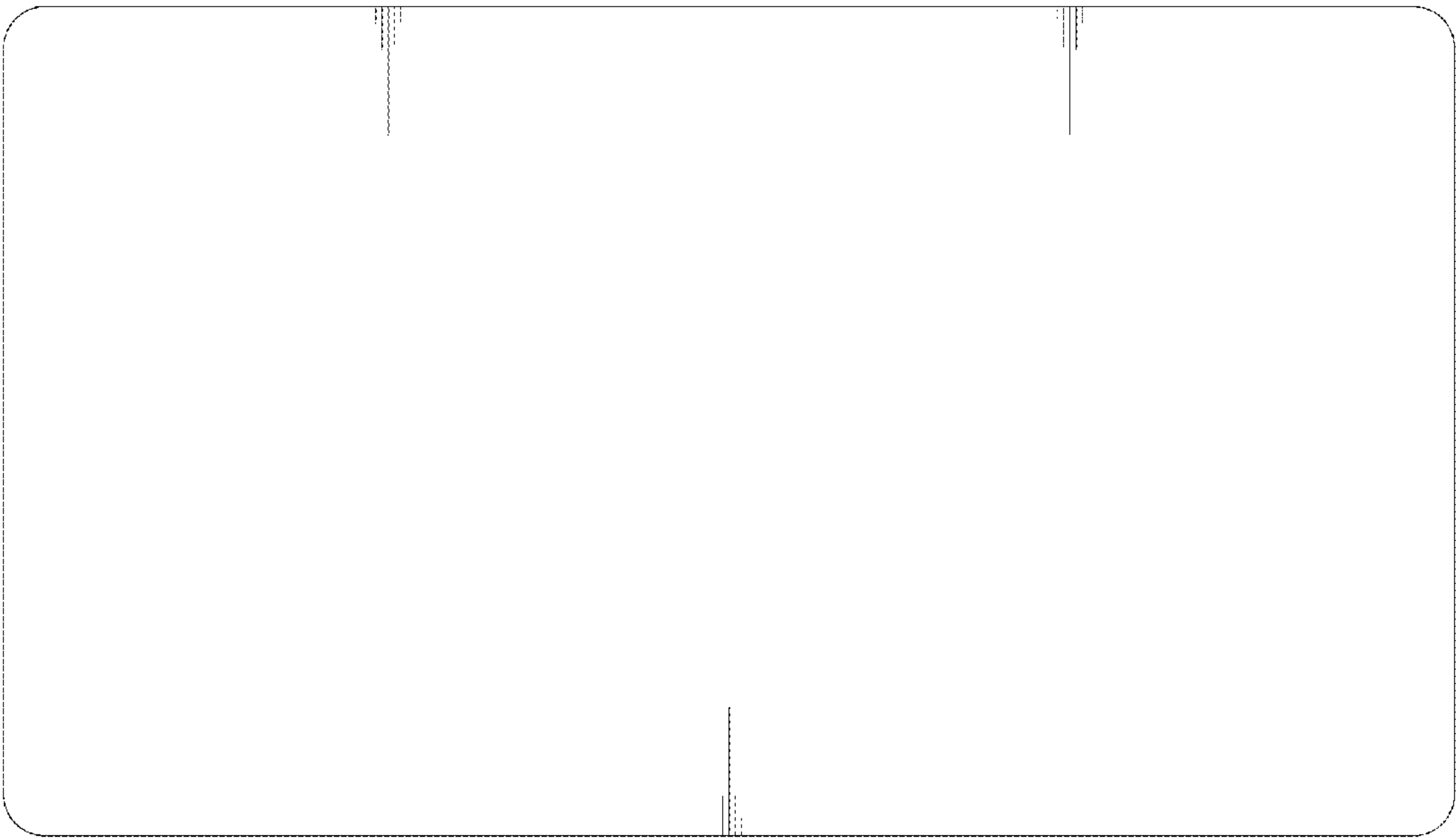

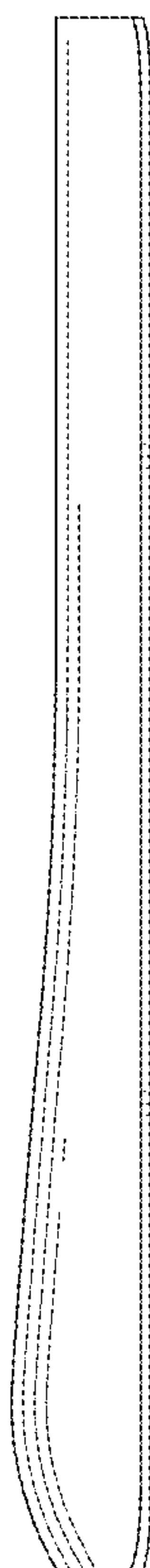

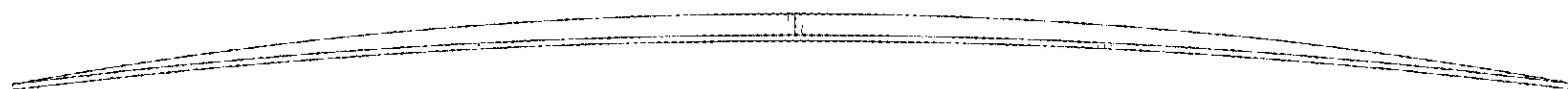

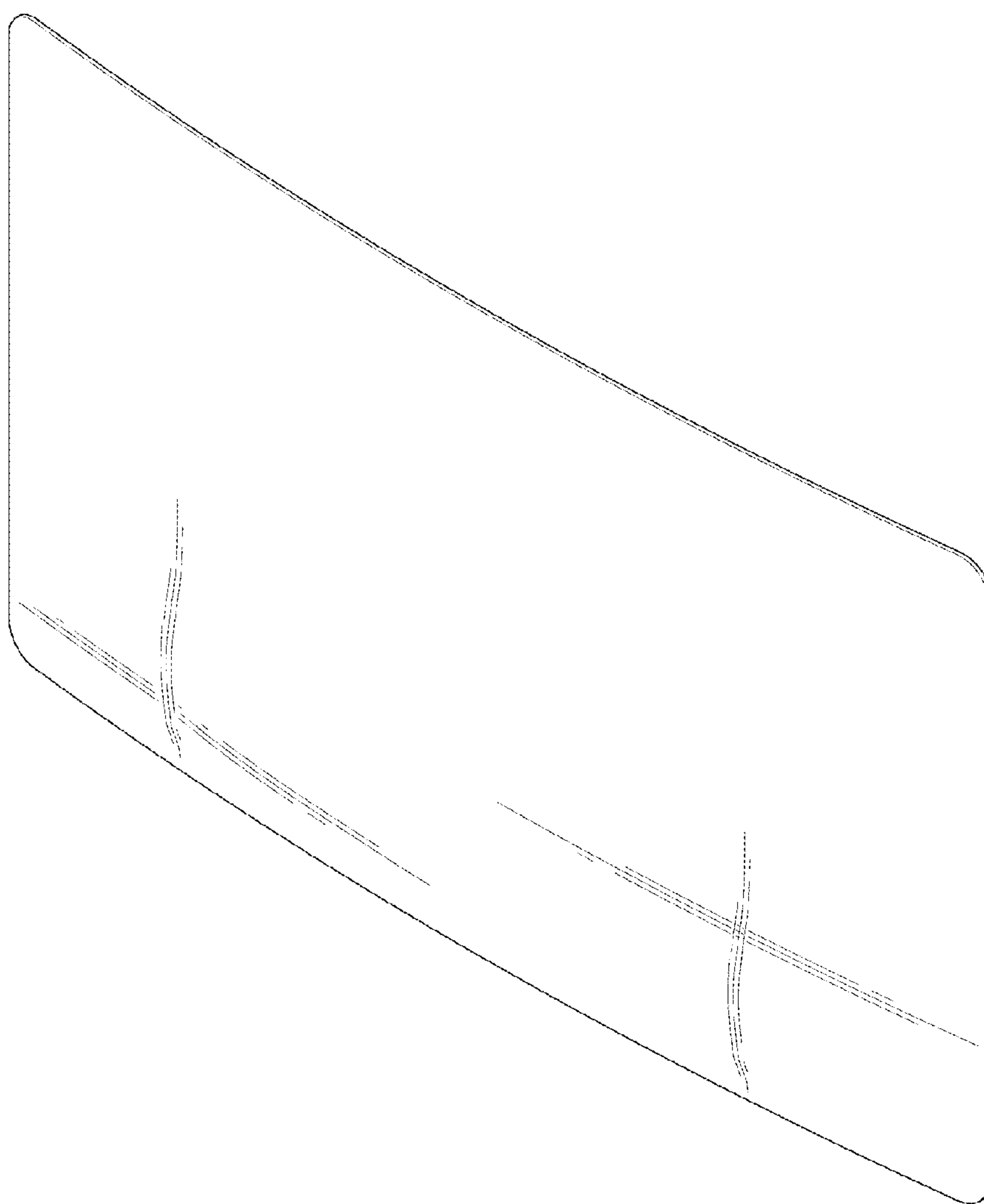
