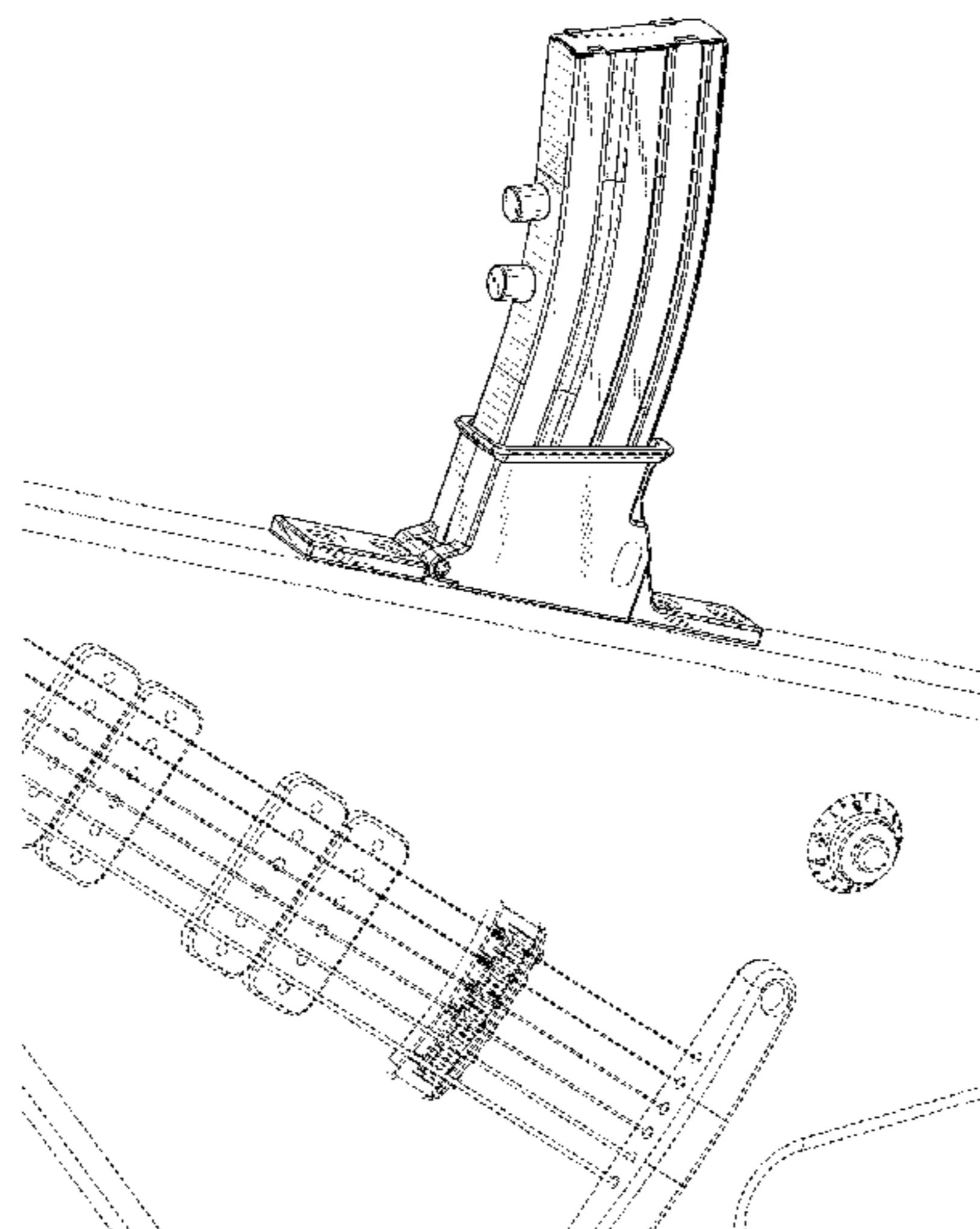
(57) **CLAIM**

The ornamental design for a tone effects pedal, as shown and described.

DESCRIPTION

FIG. 1 is an exploded perspective view of a tone effects pedal in detached position;
FIG. 2 is an exploded front elevational view thereof;
FIG. 3 is an exploded rear elevational view thereof;
FIG. 4 is an exploded left side elevational view thereof;

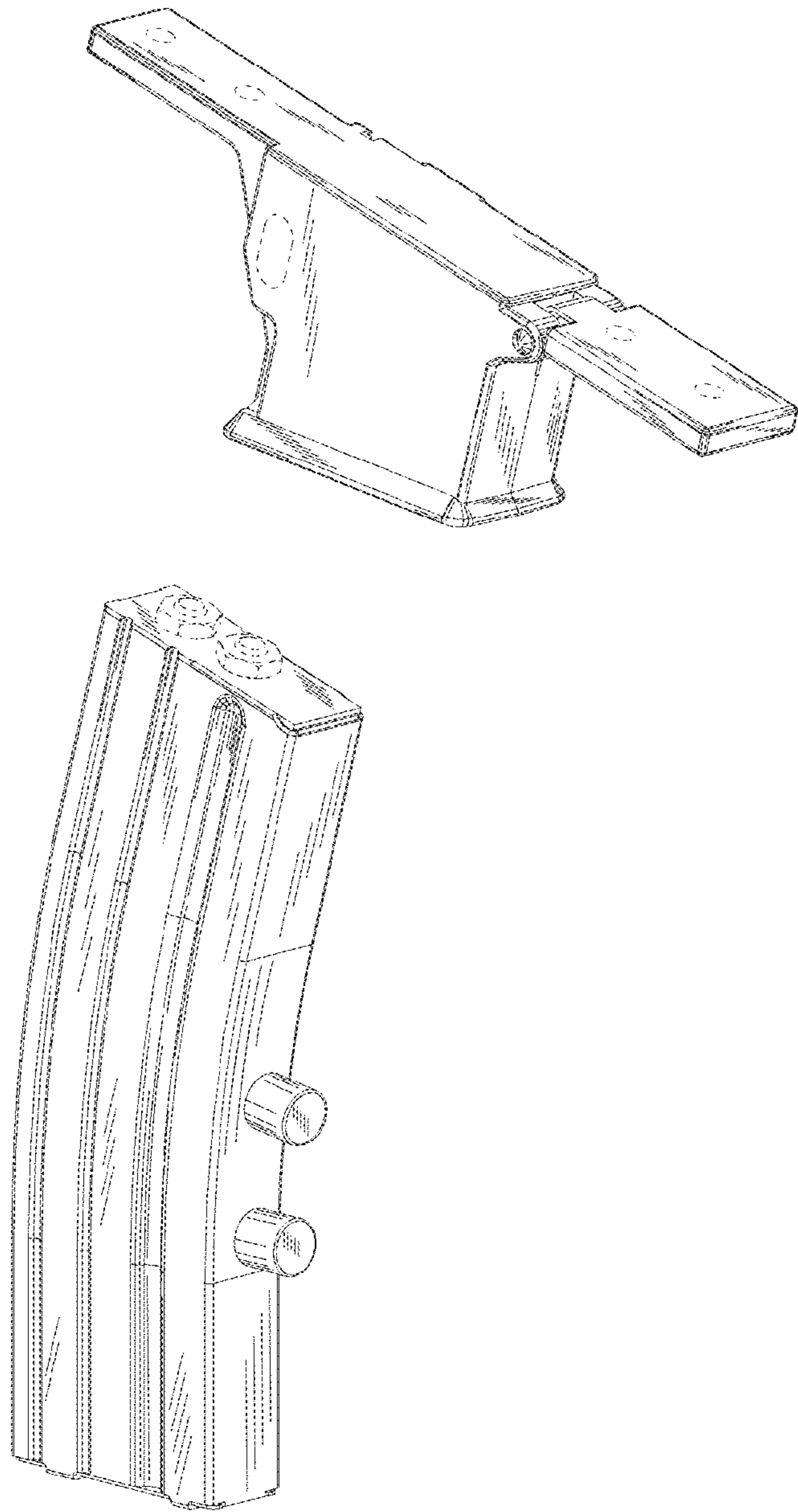

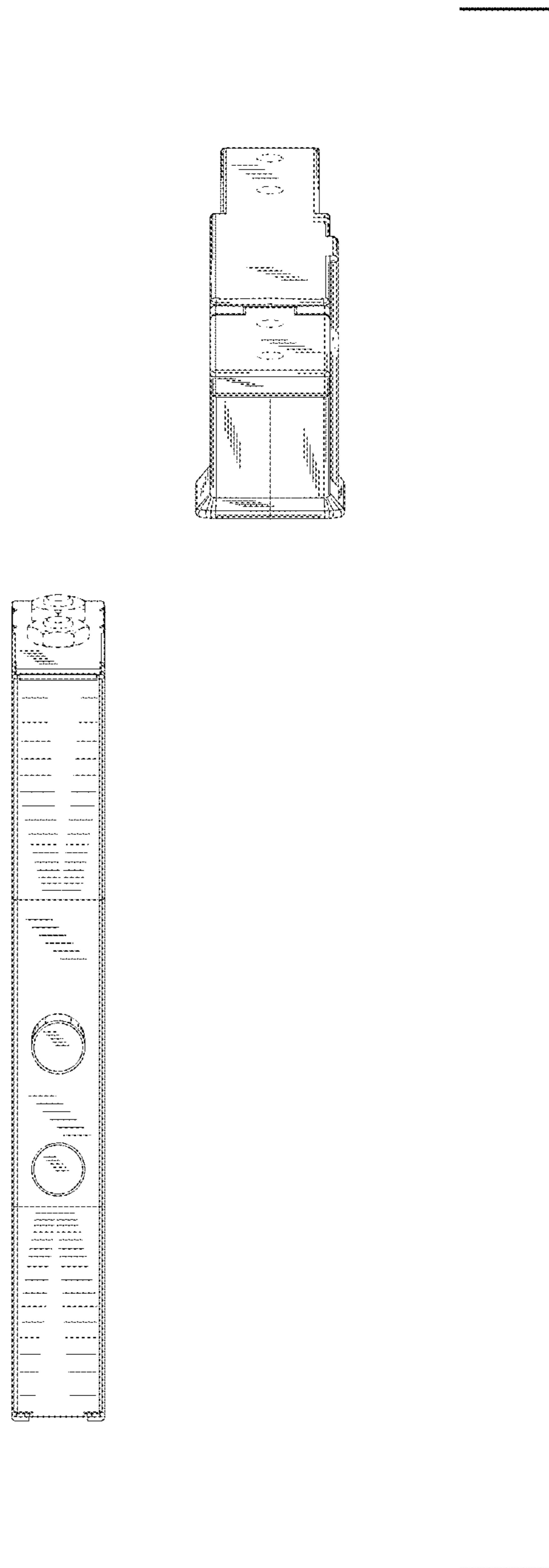

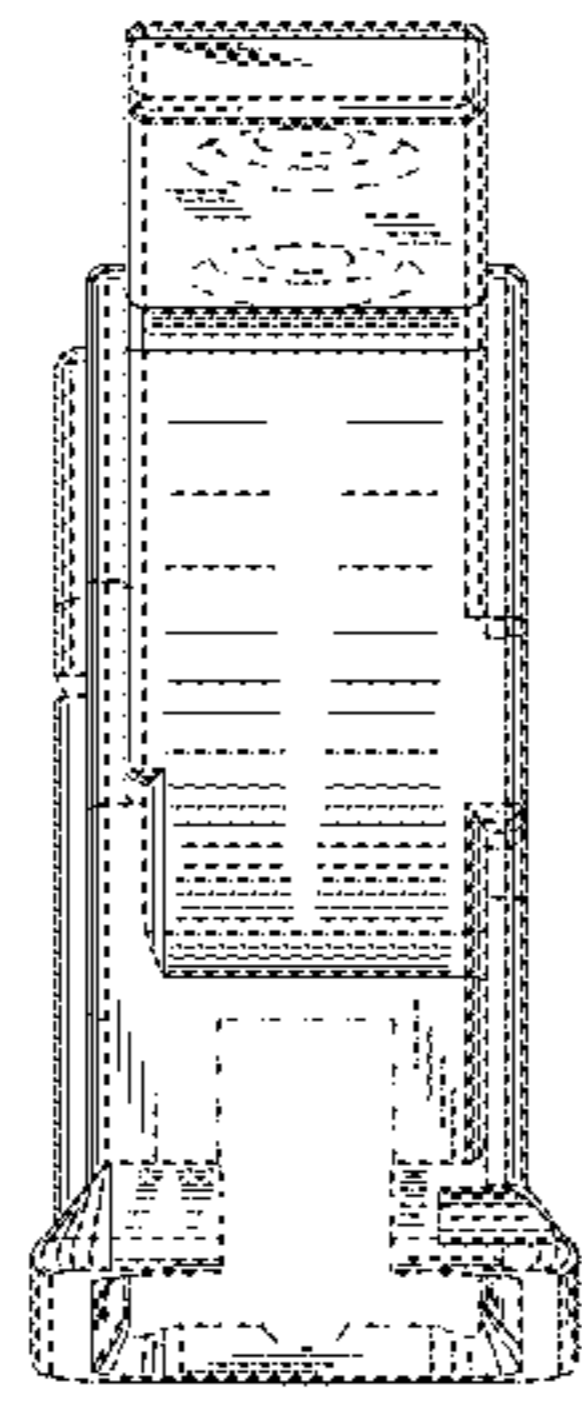

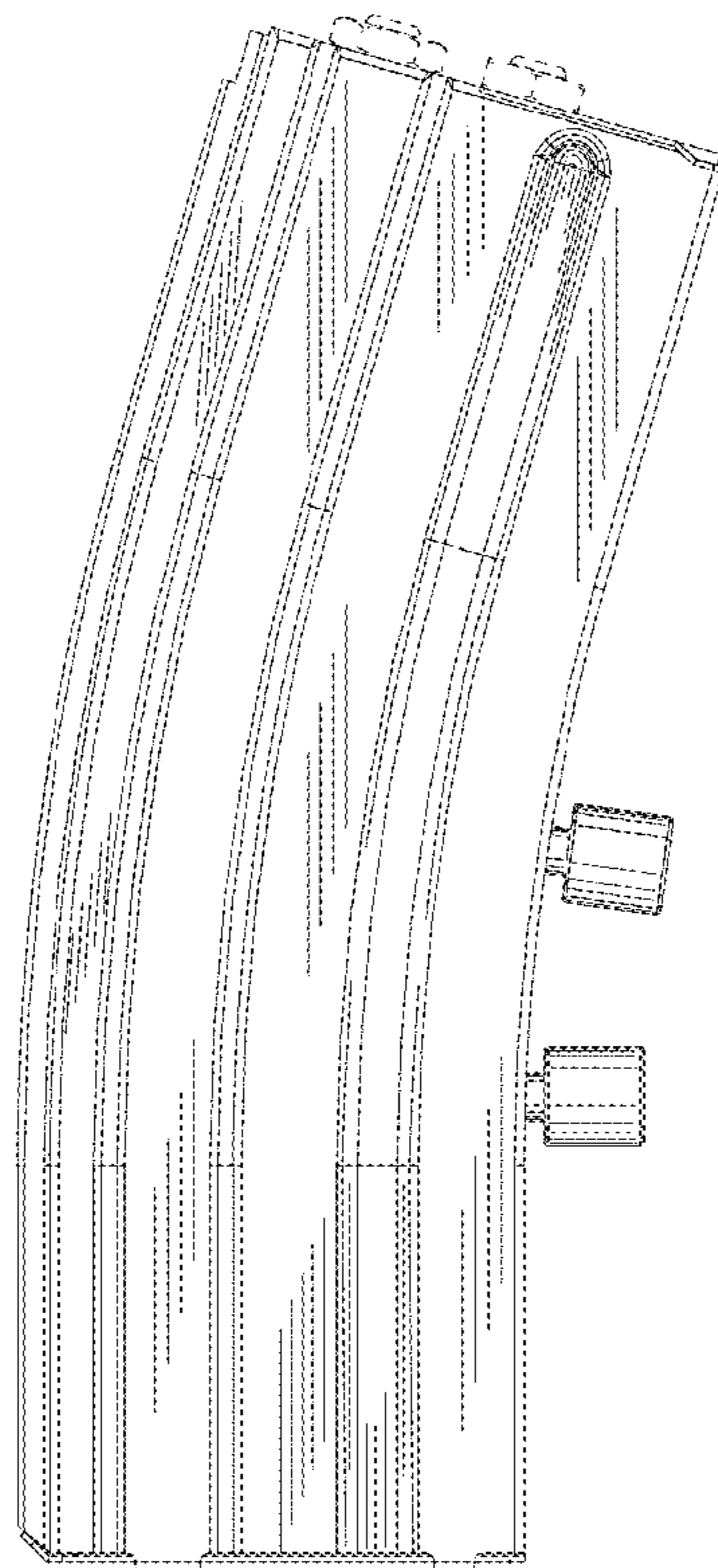
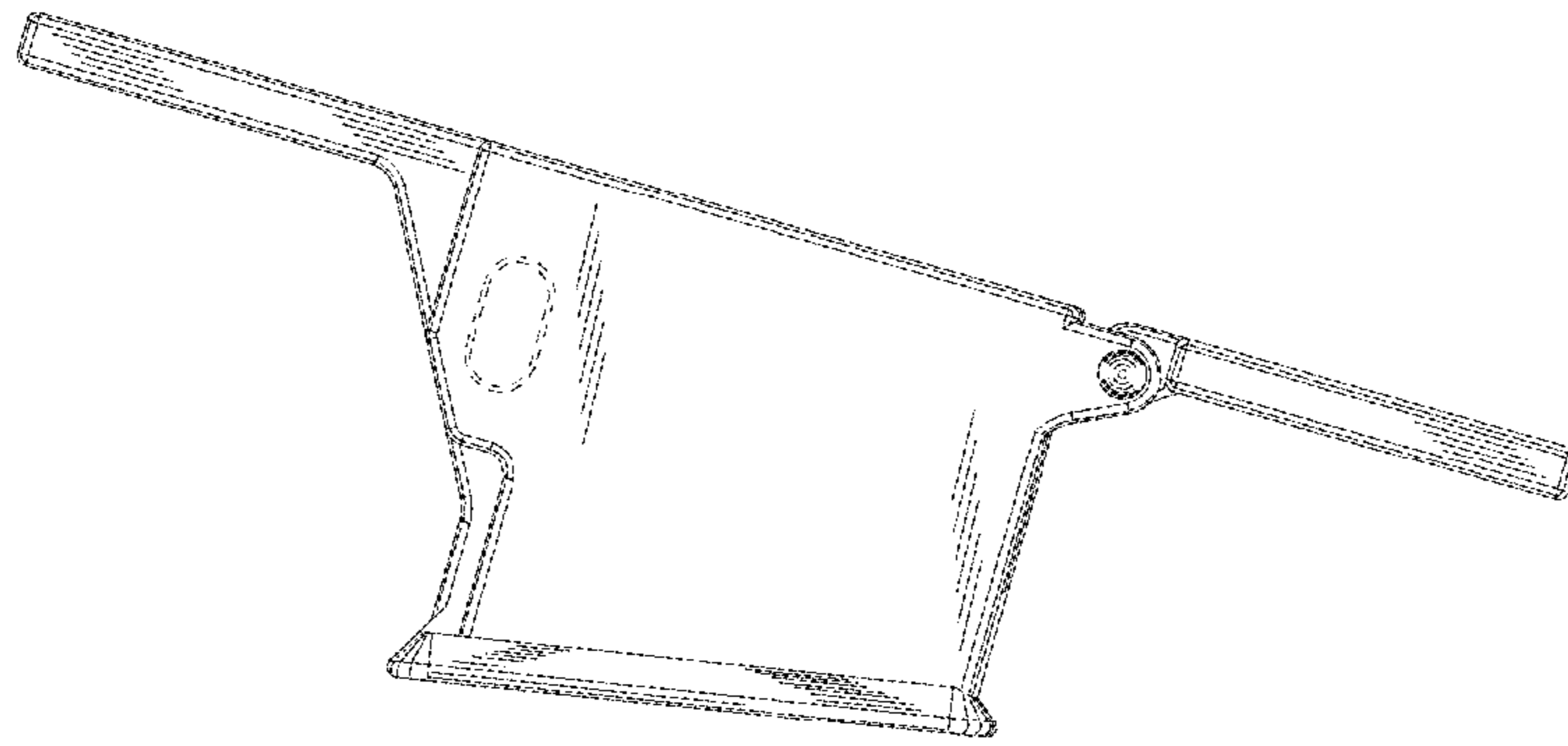

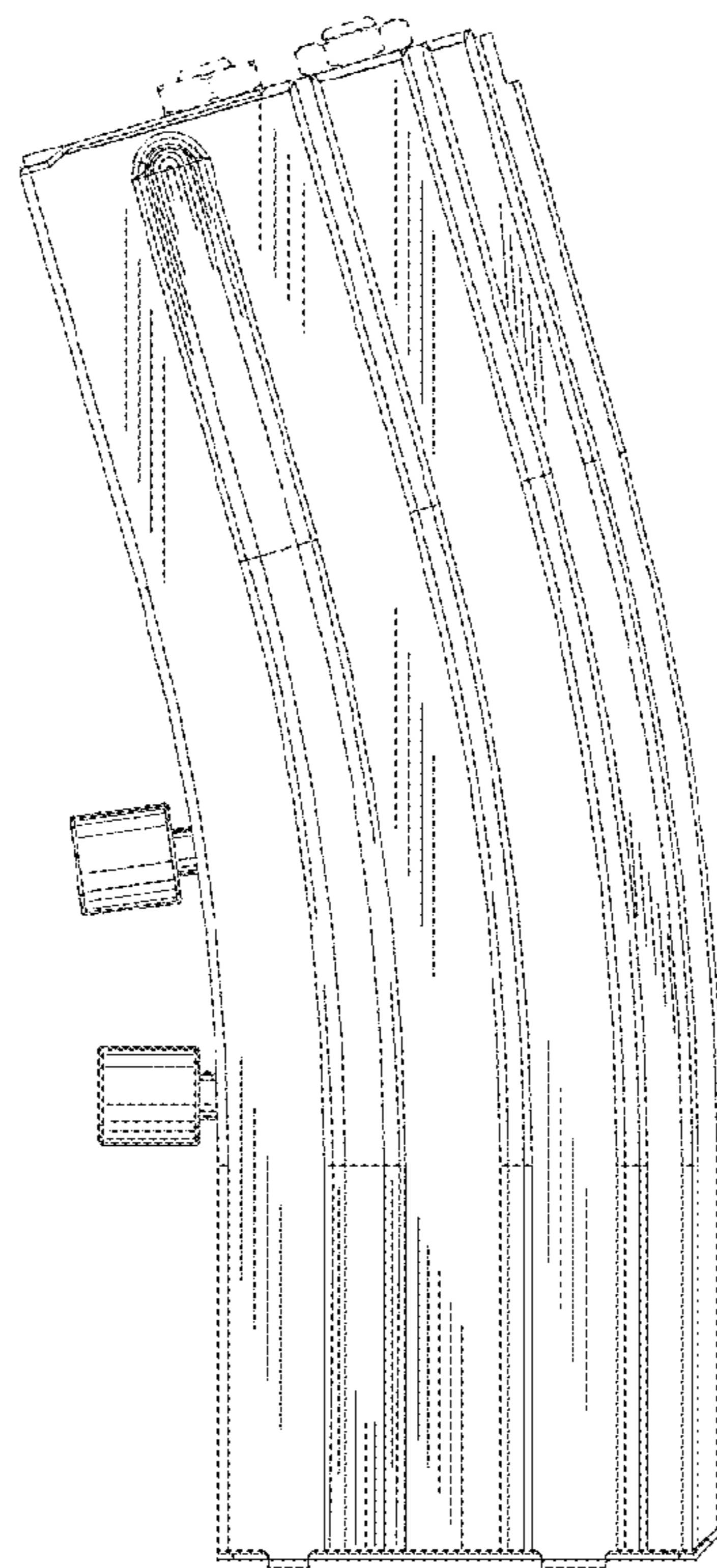
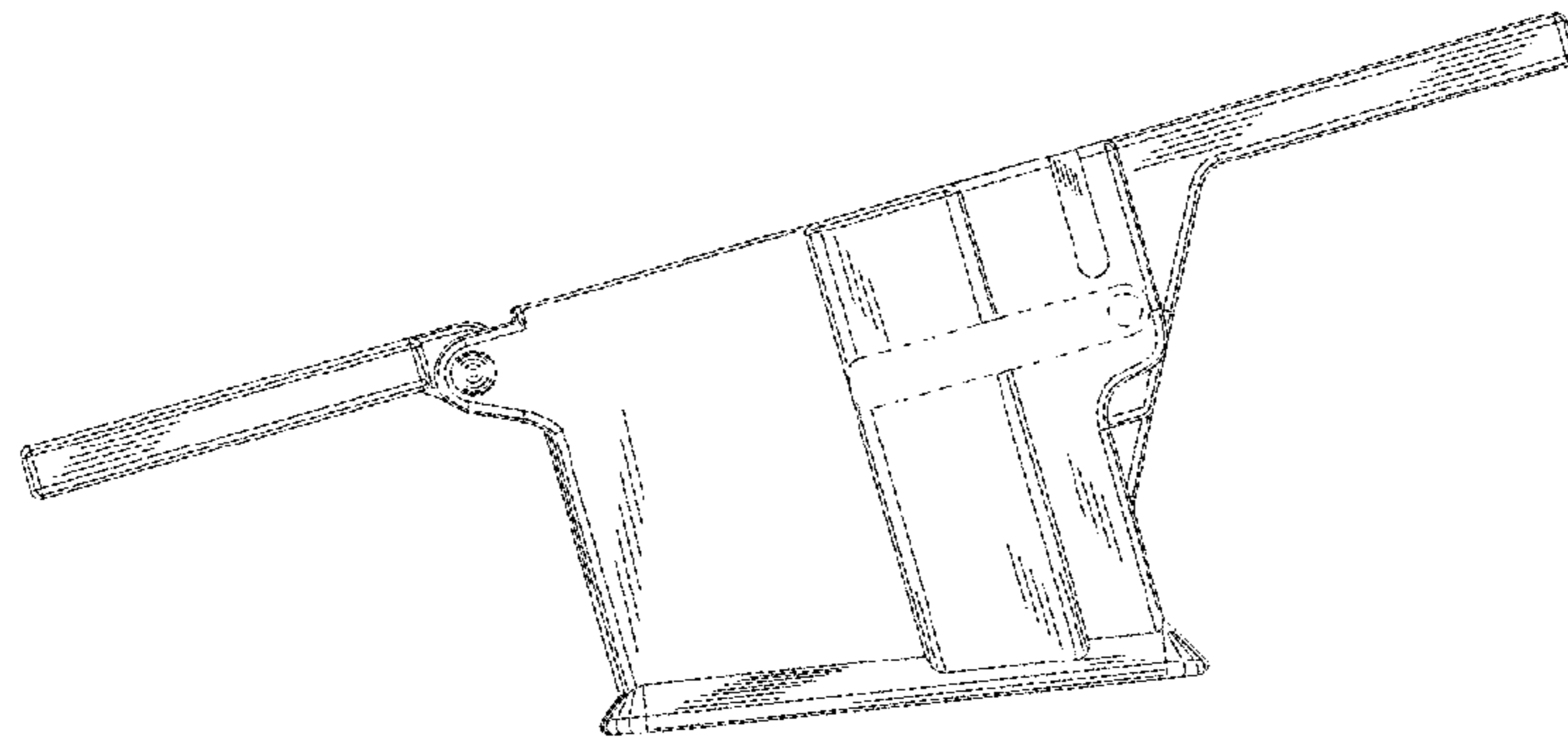

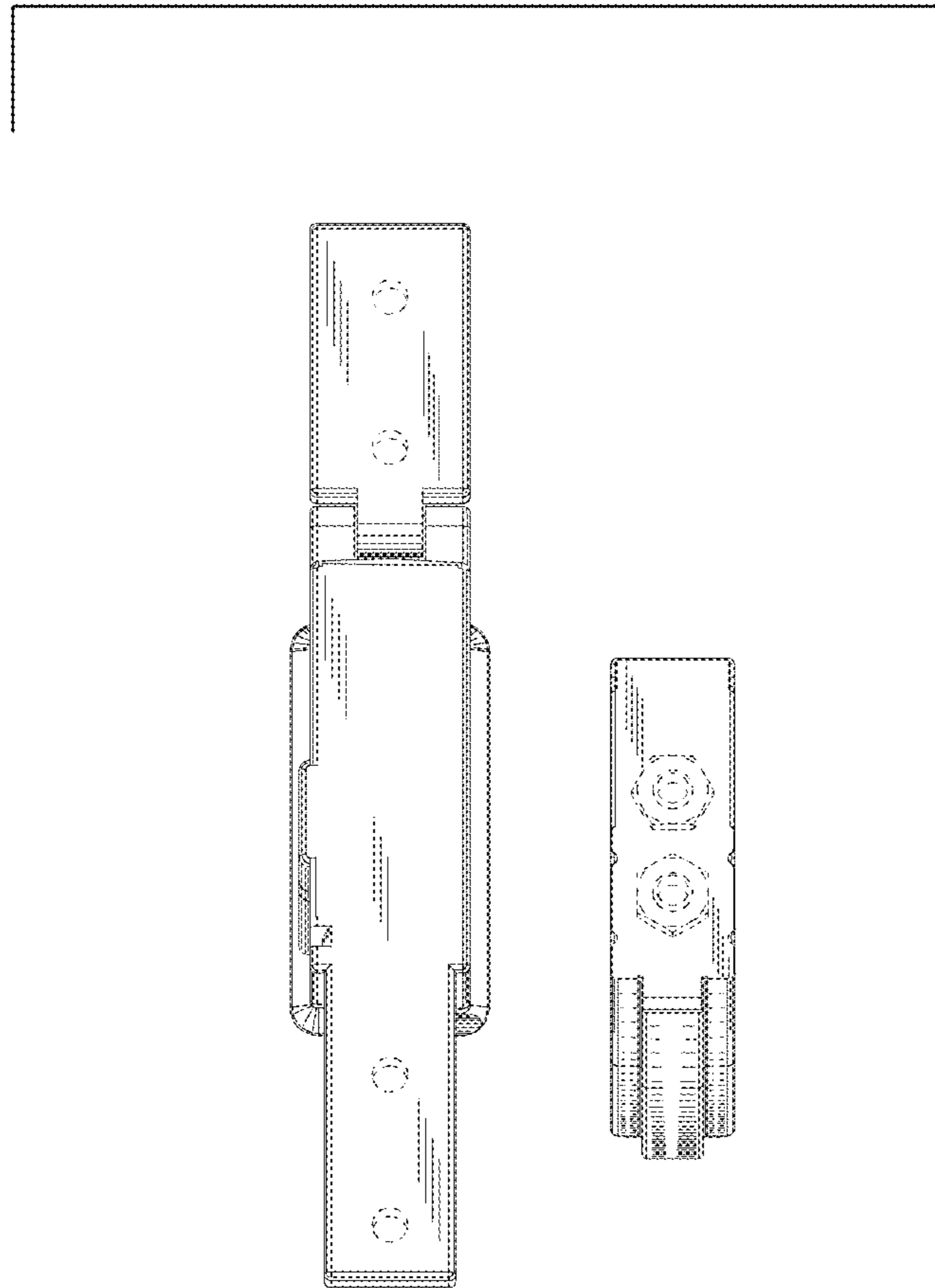

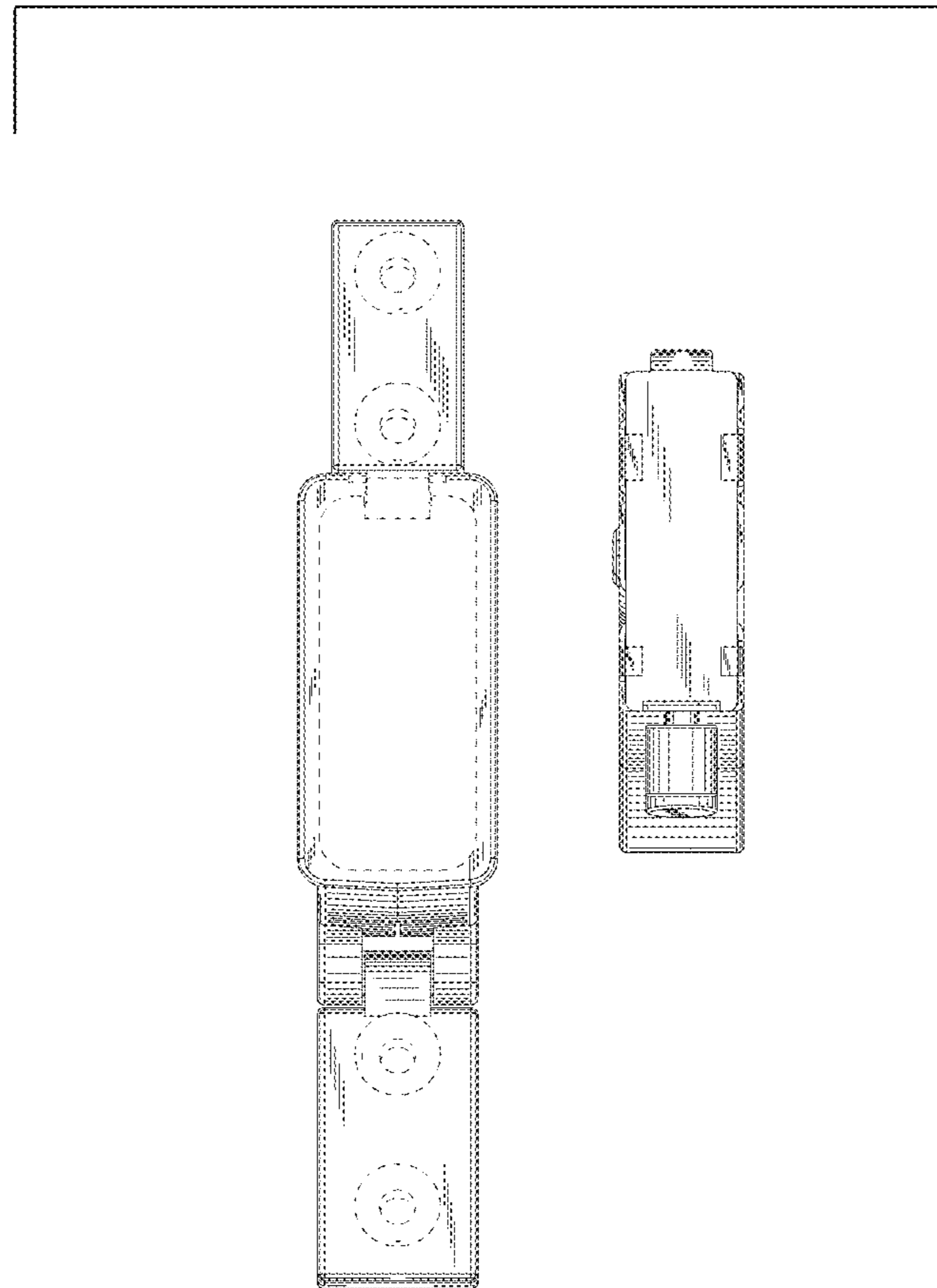

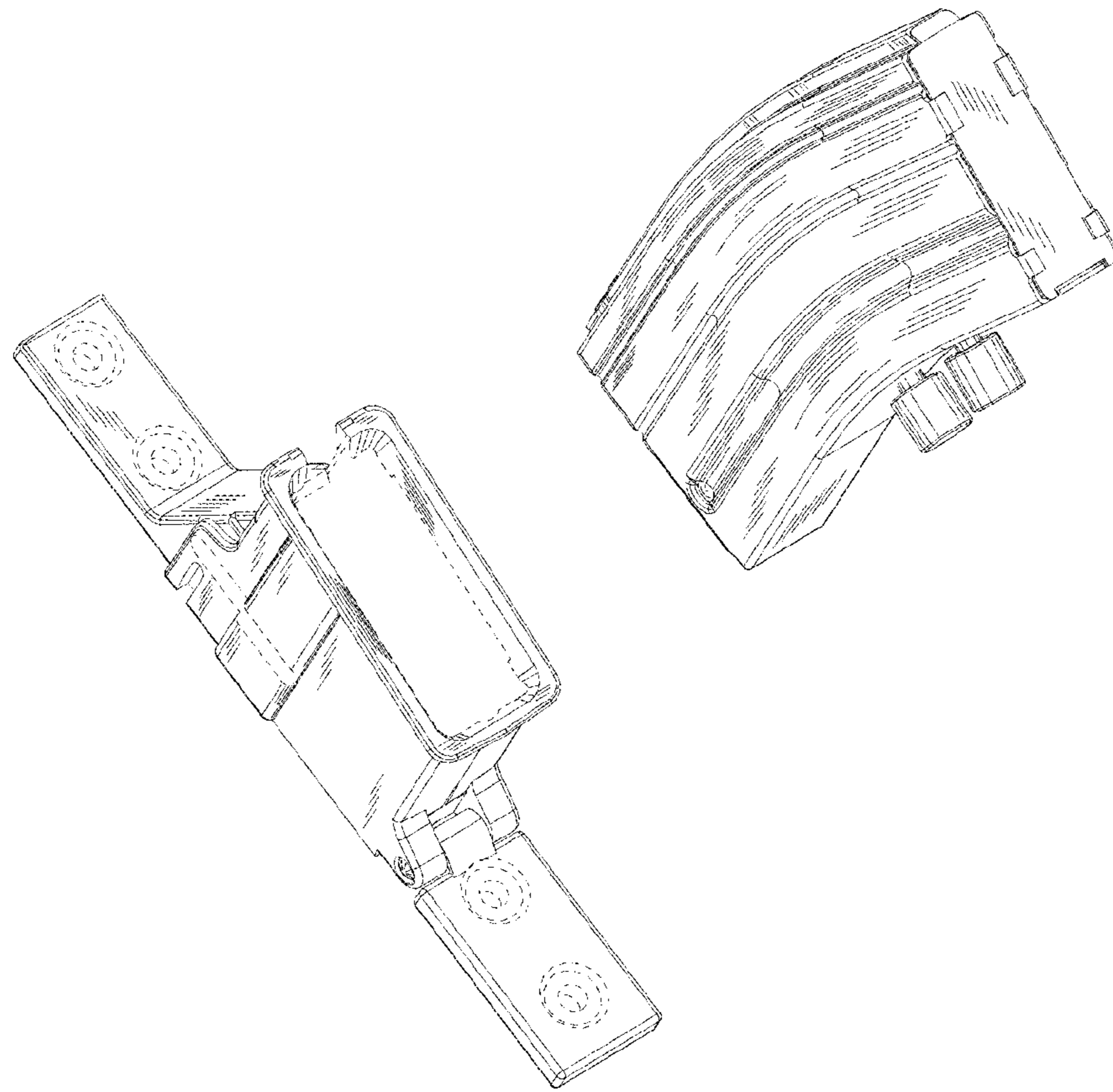

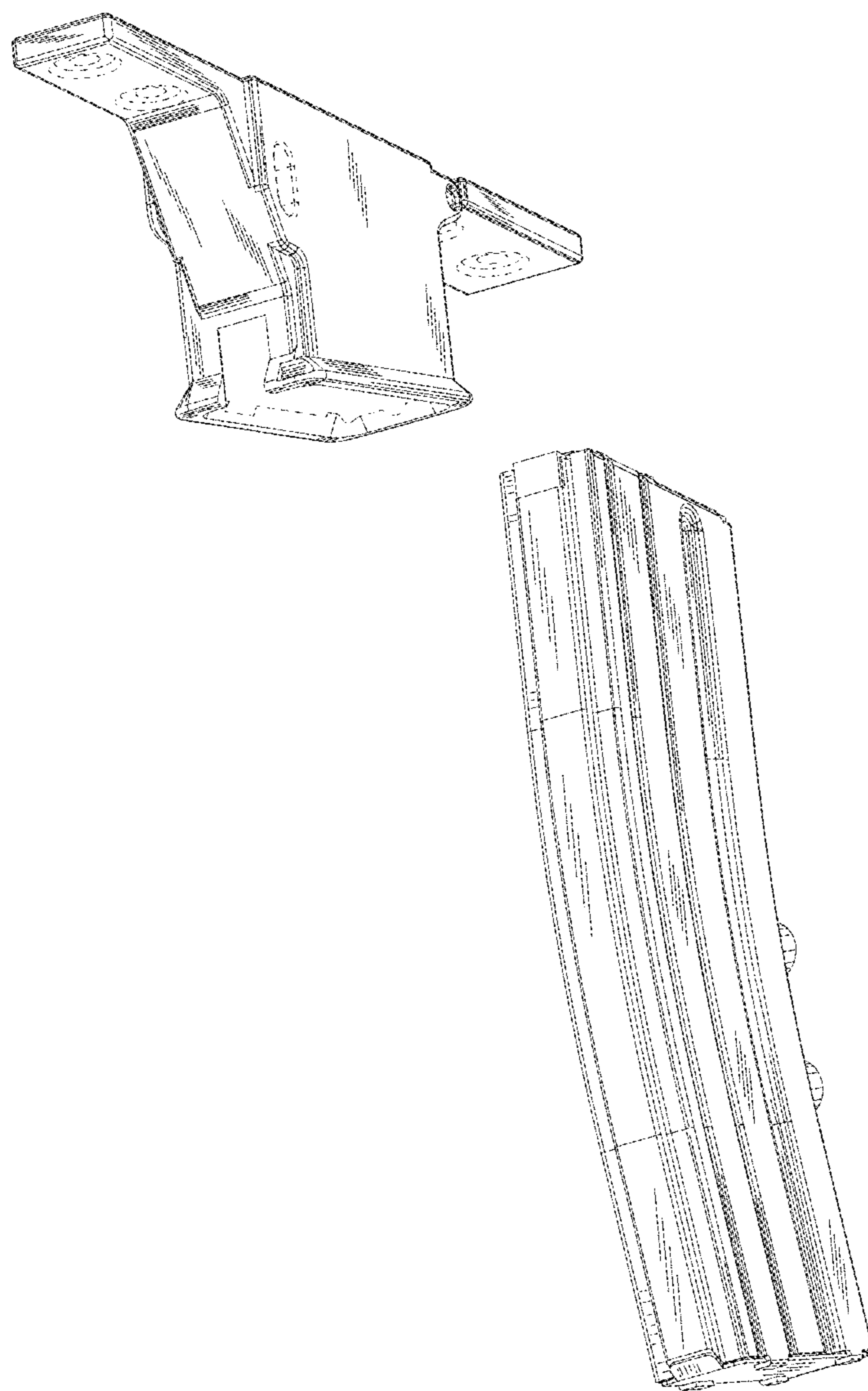

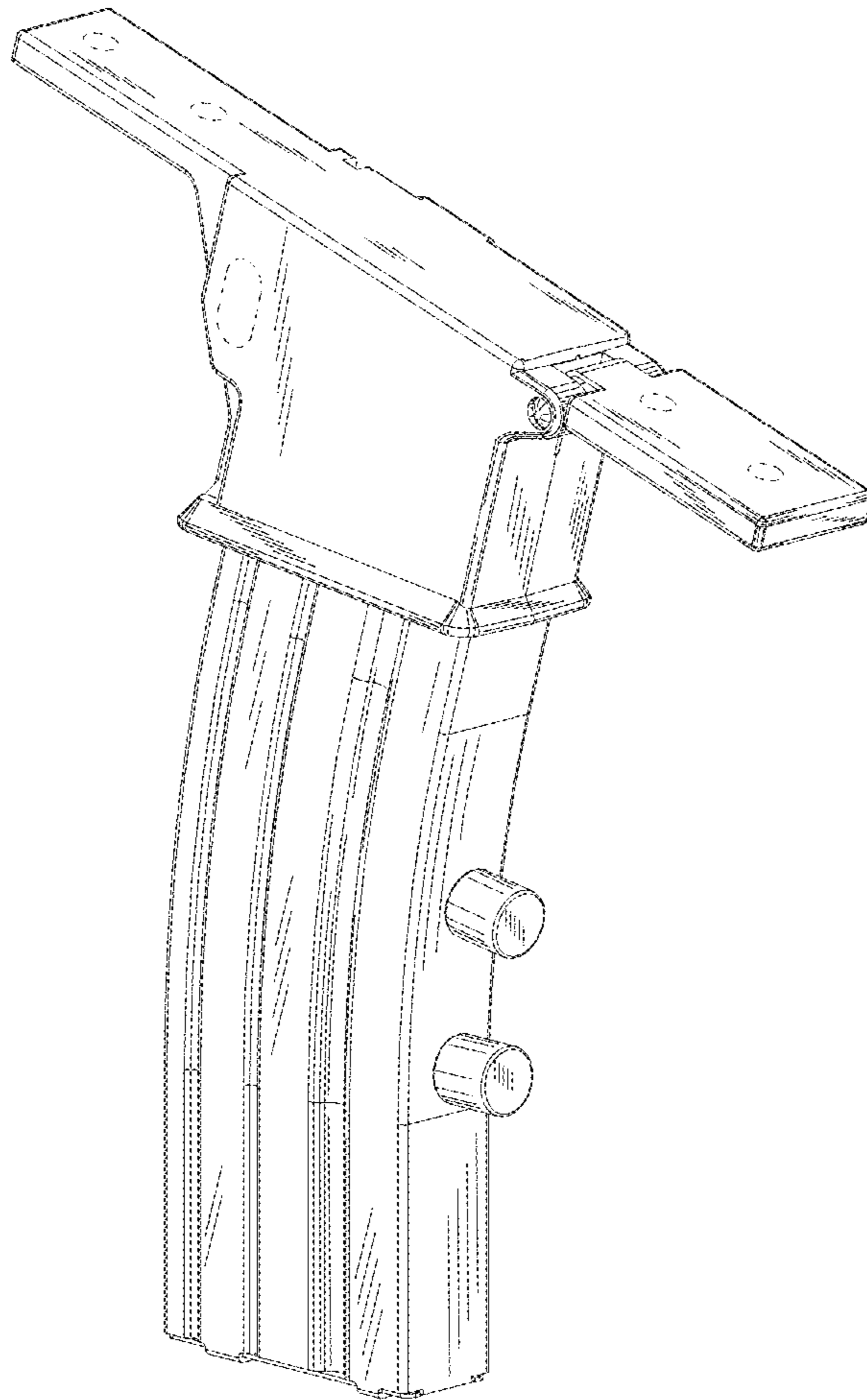

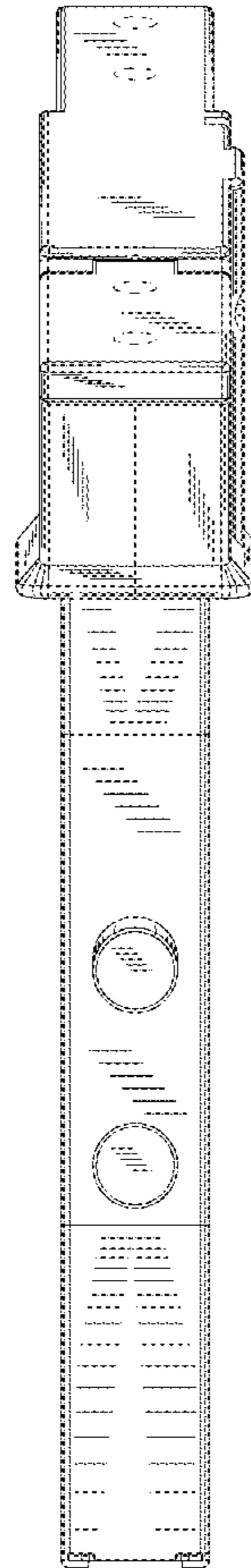

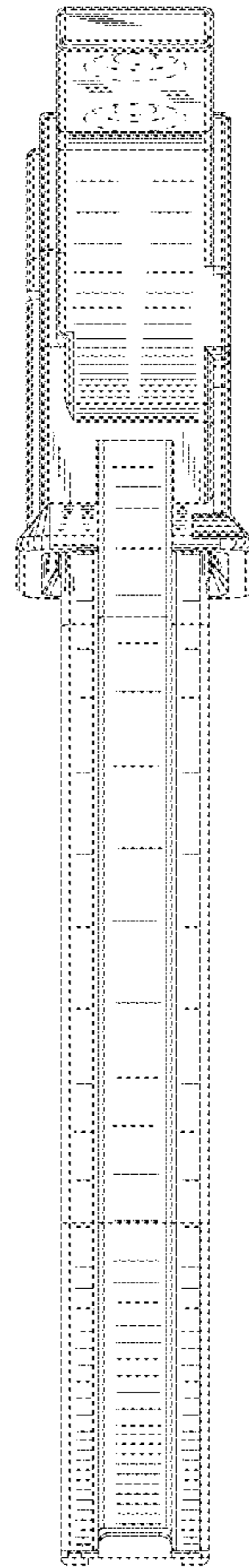

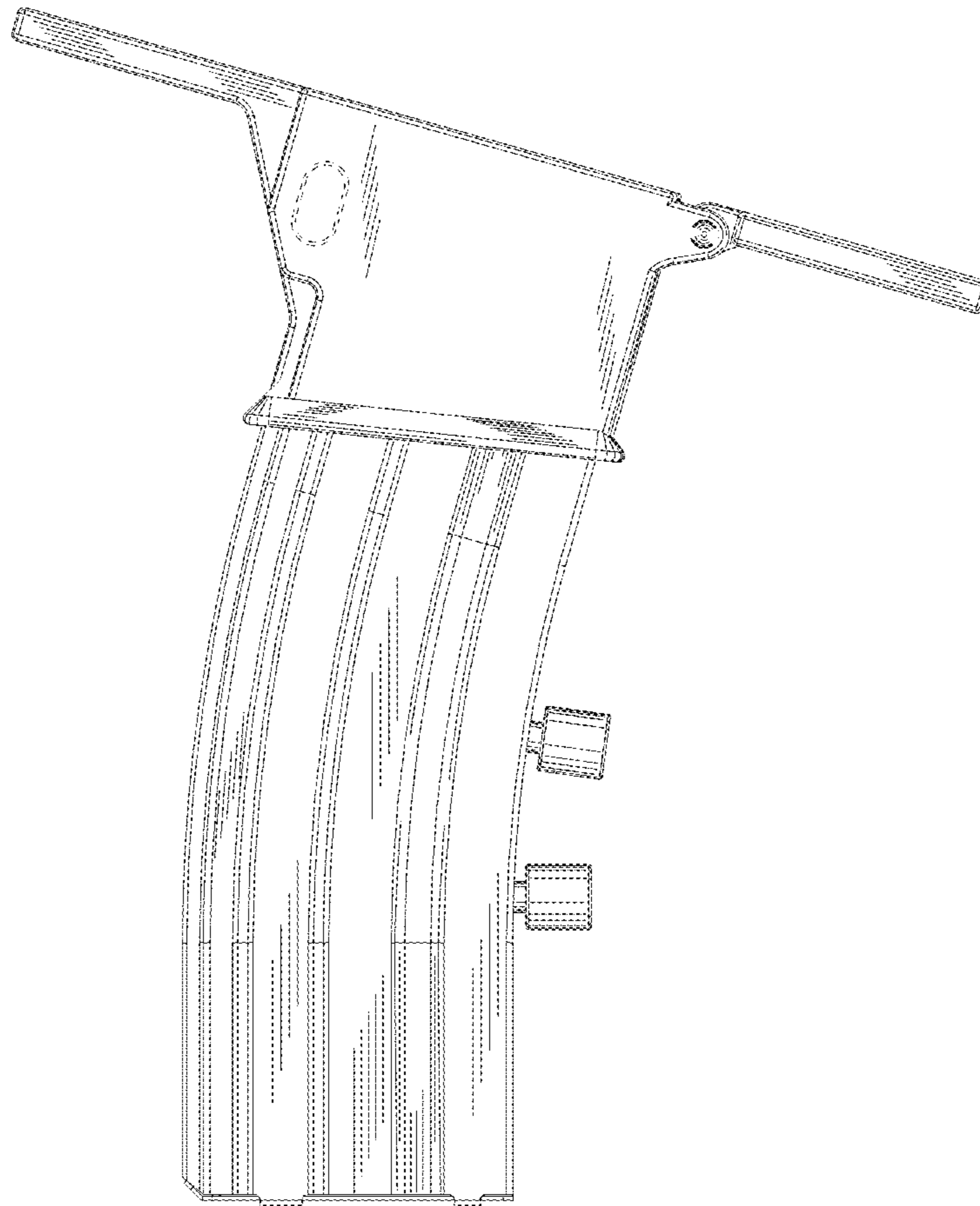

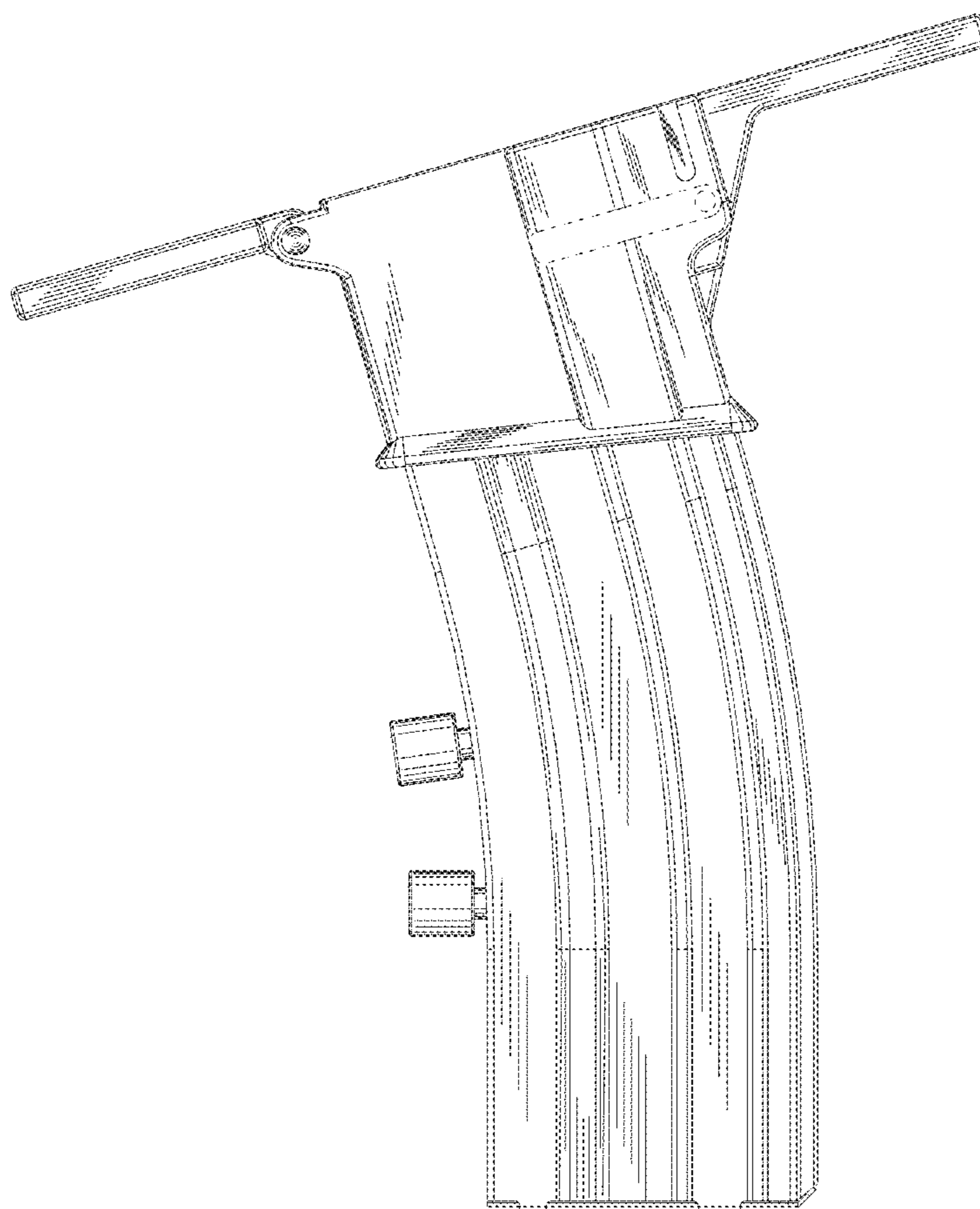

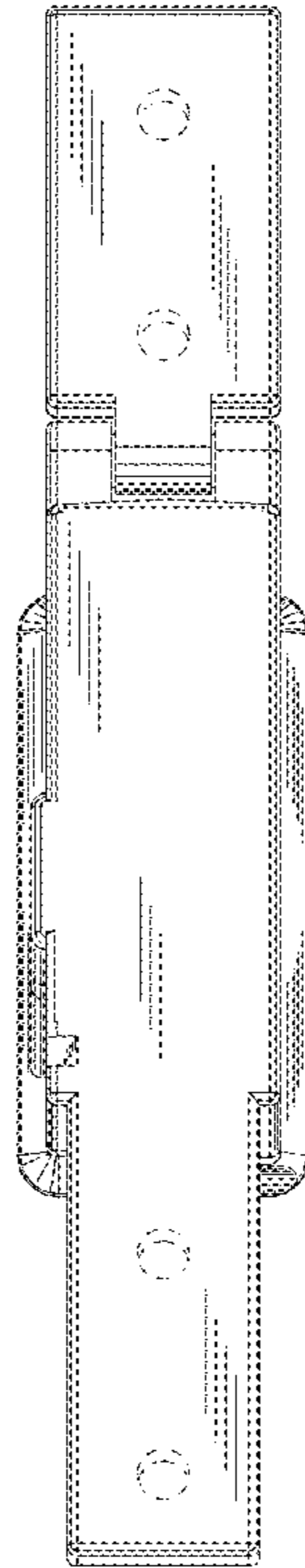

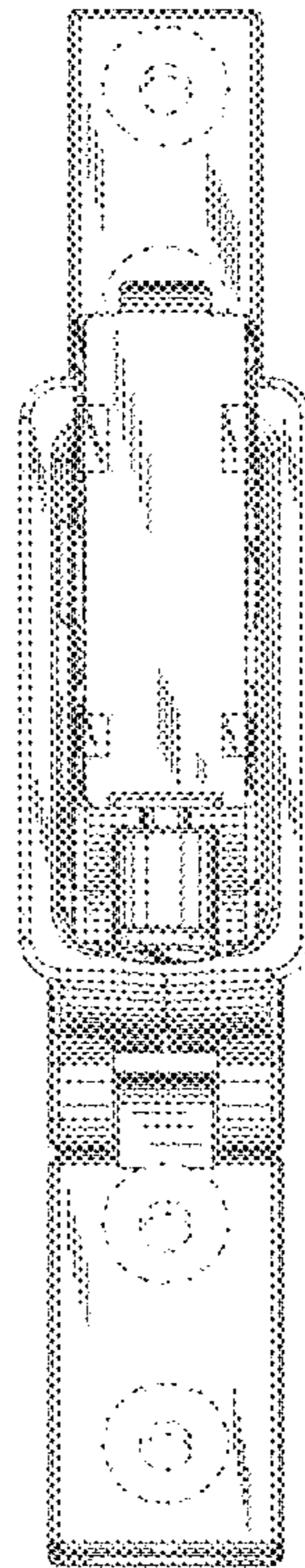

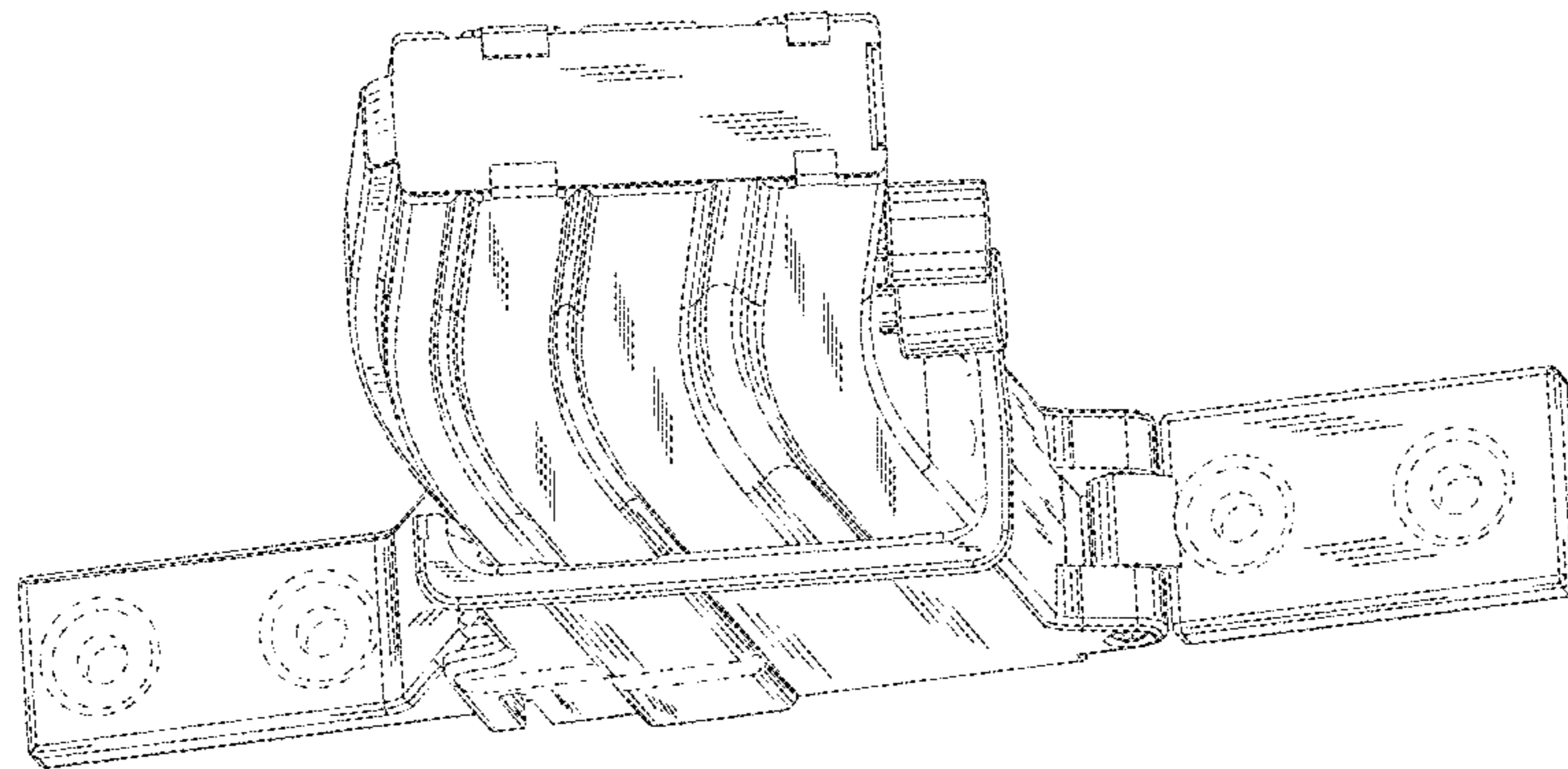

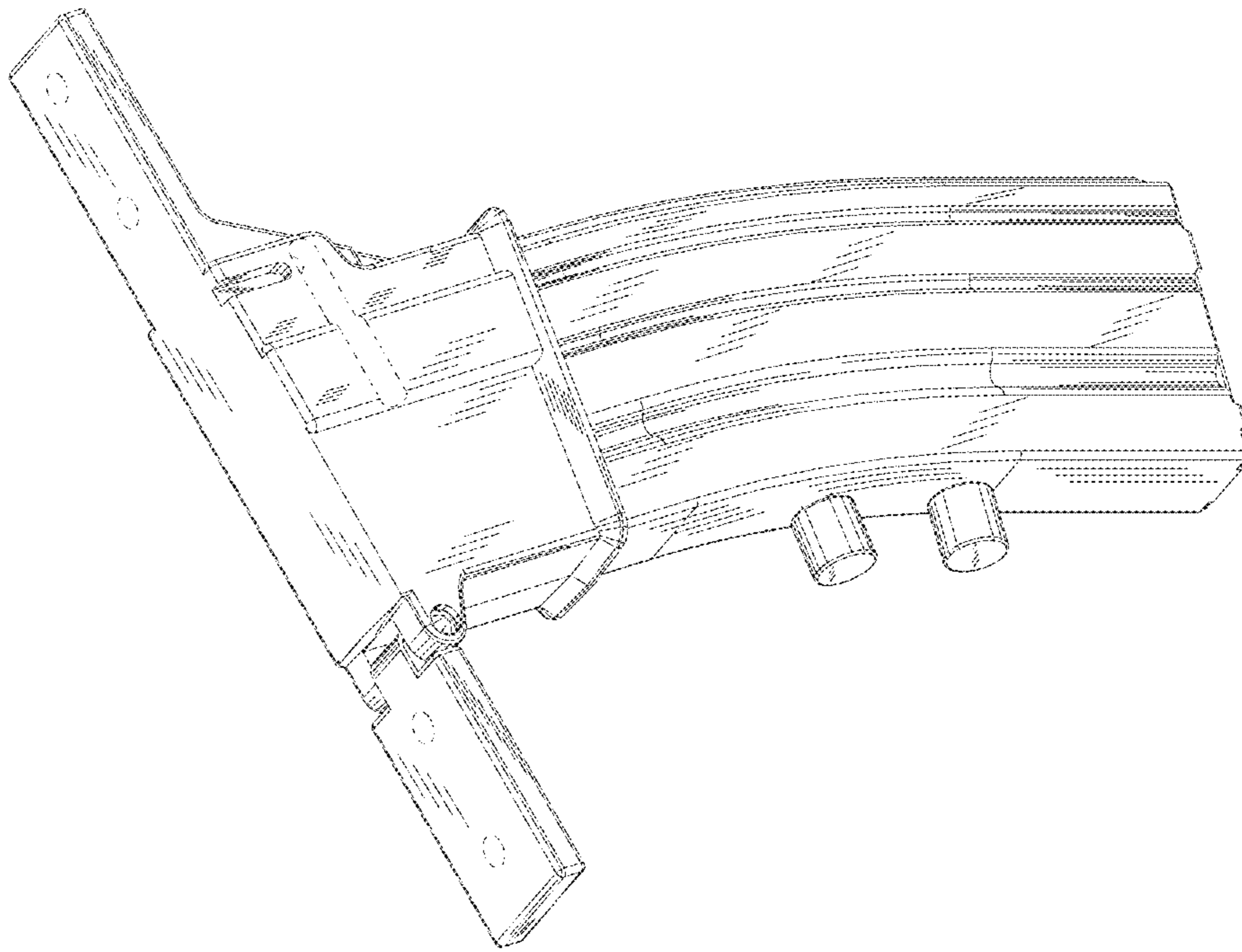

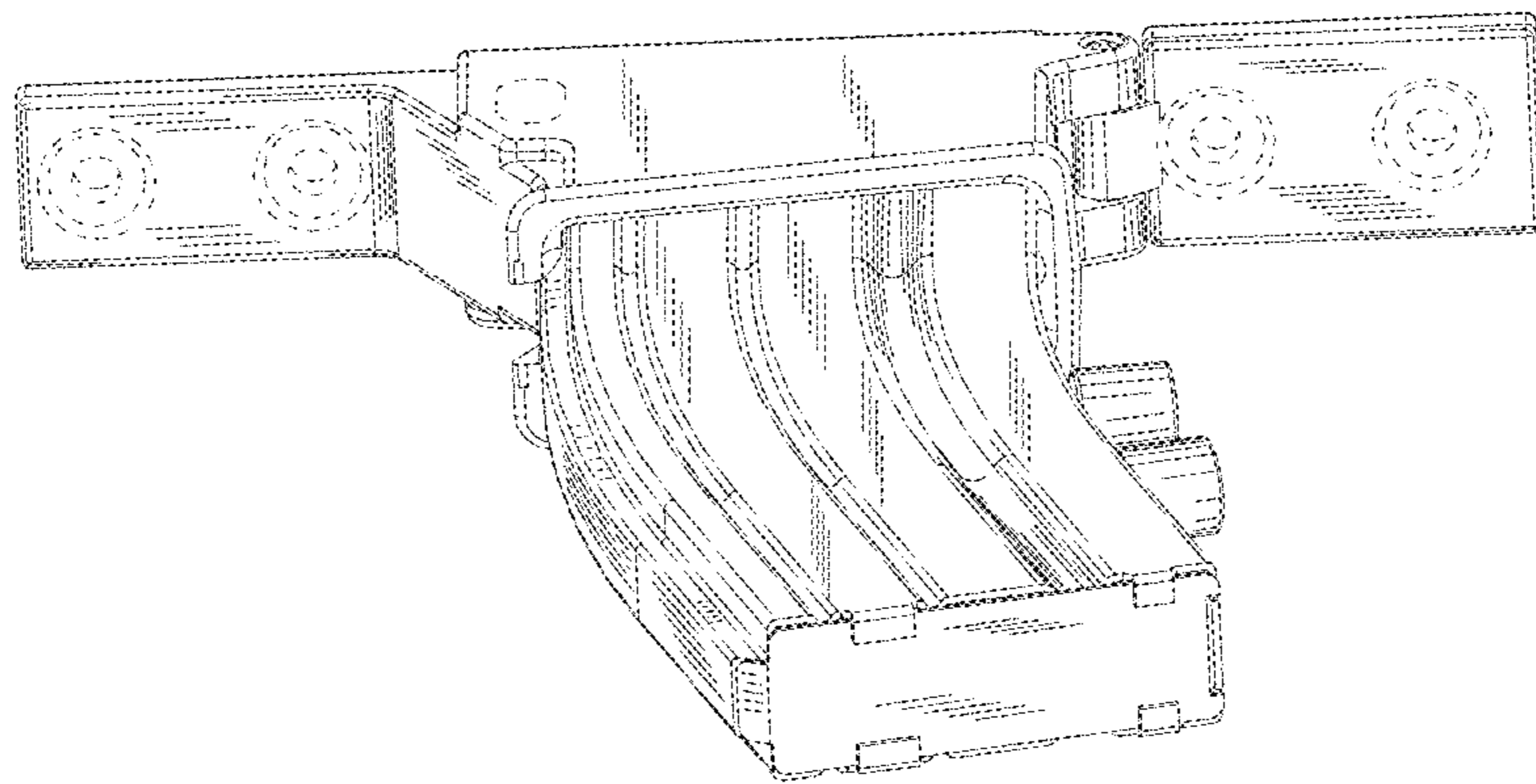

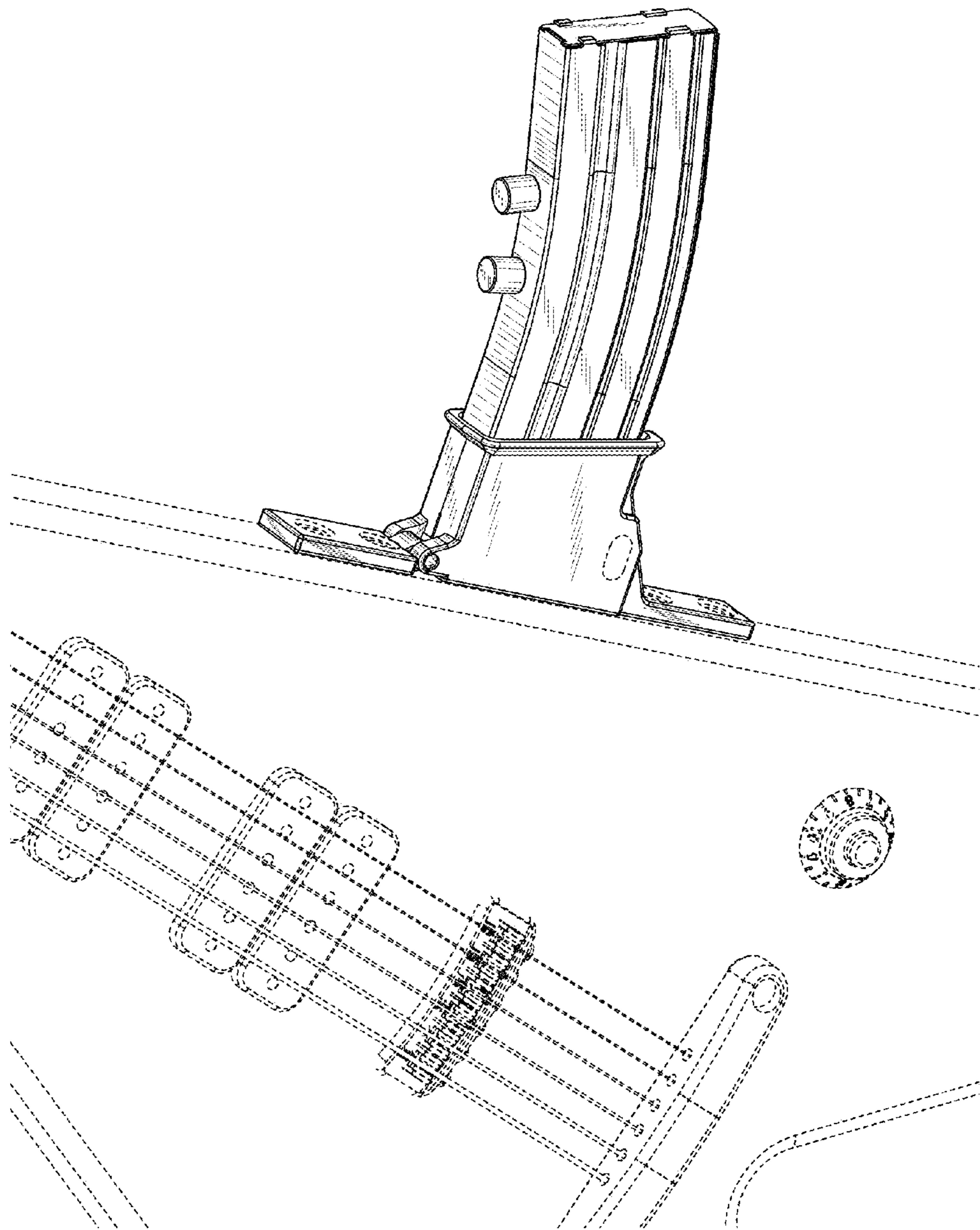
