DESCRIPTION

FIG. 4 depicts a right side view of the pen.

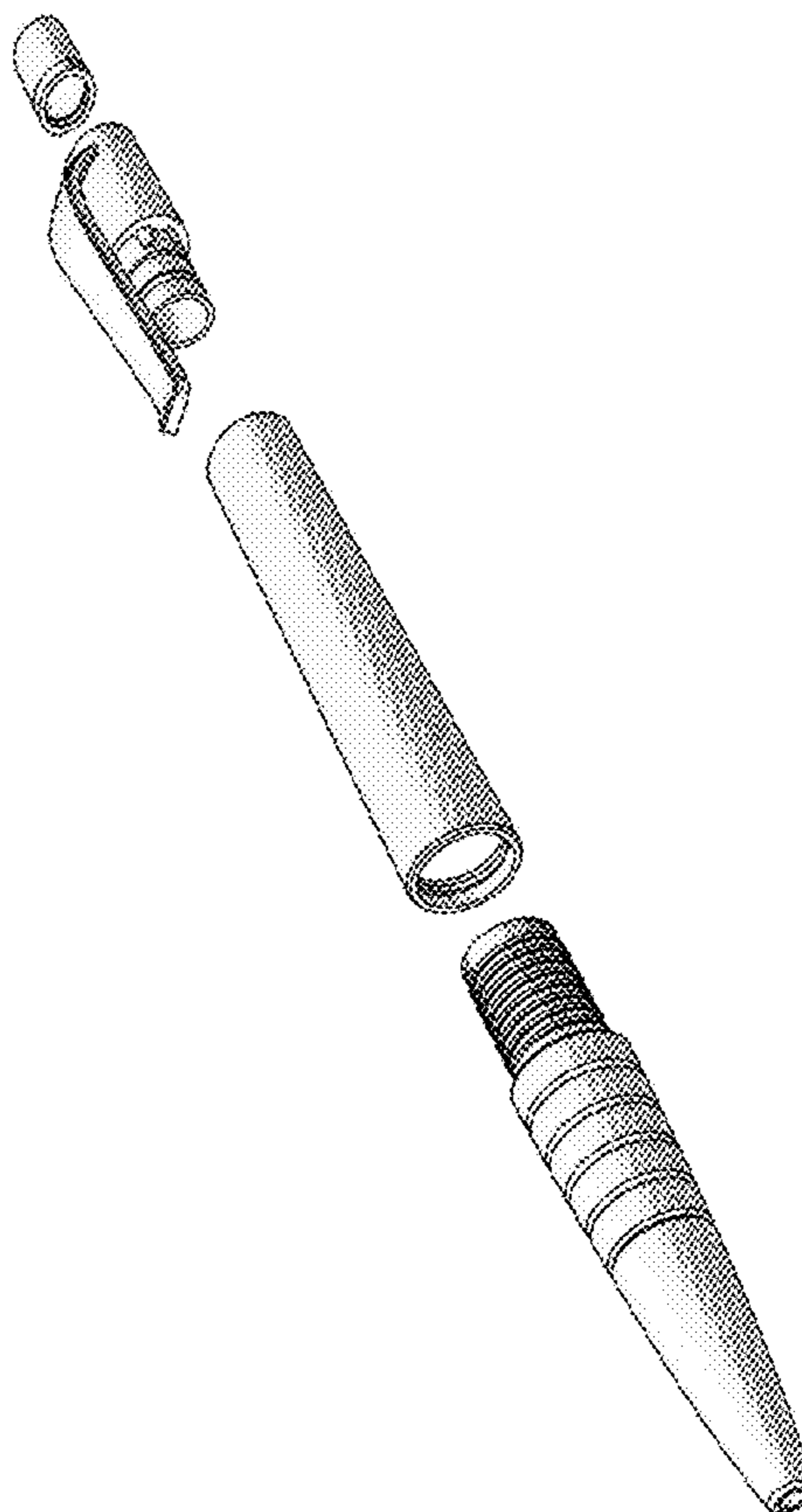
FIG. 5 depicts a right side view of the blind cap shown without the rest of the pen for convenience of illustration.

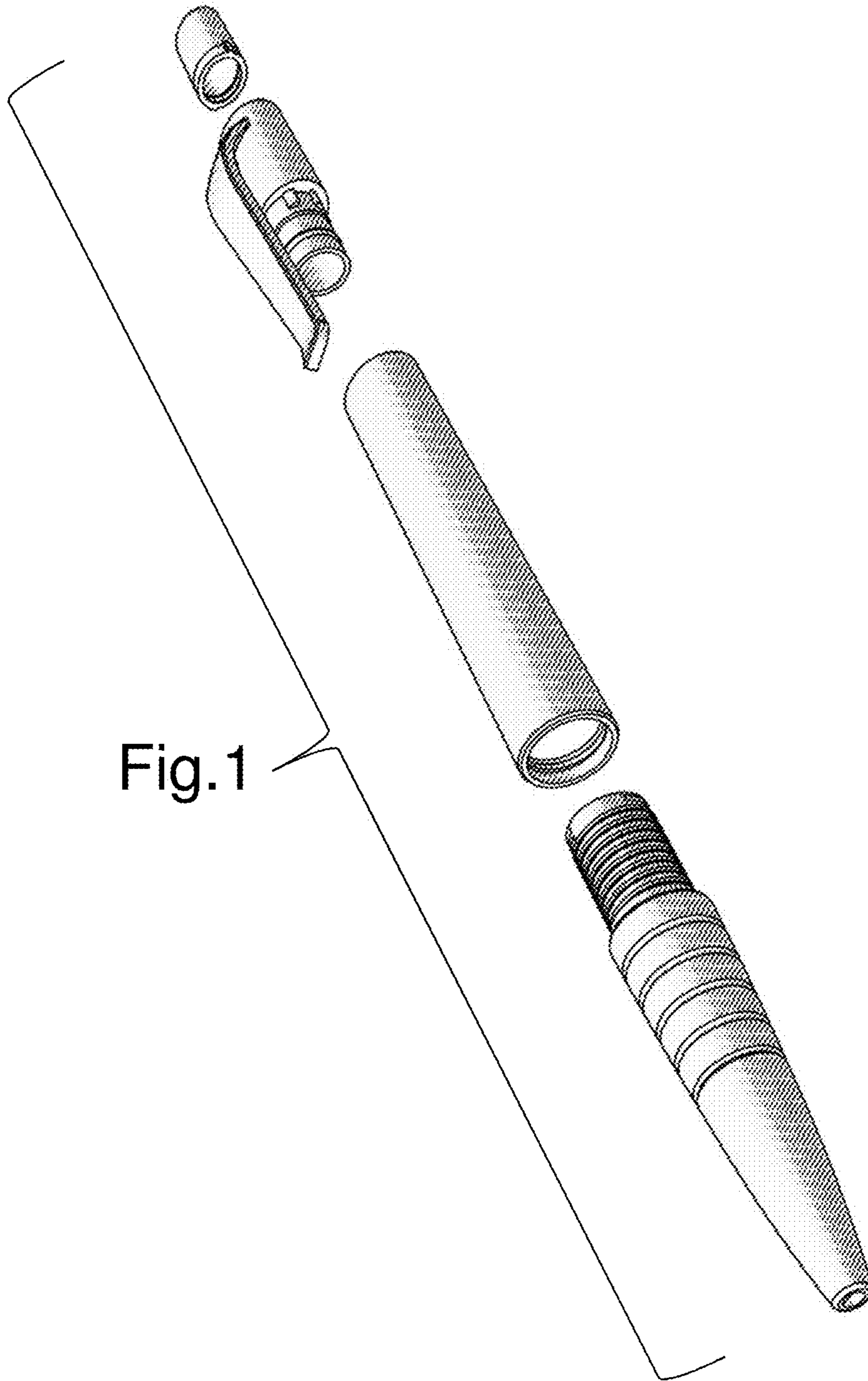

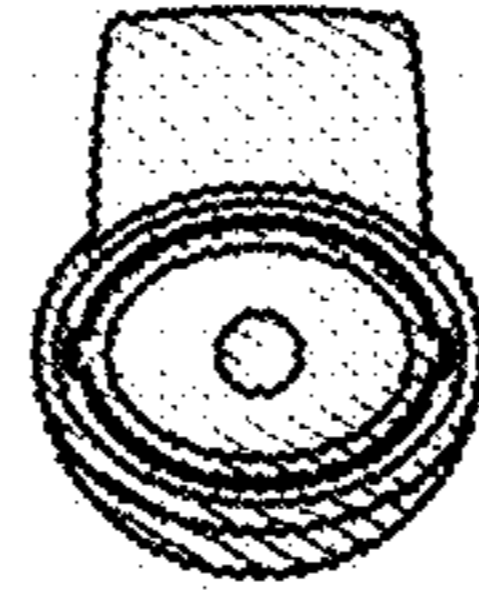
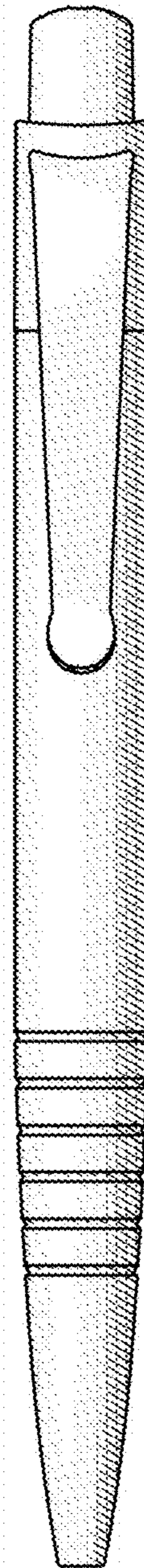

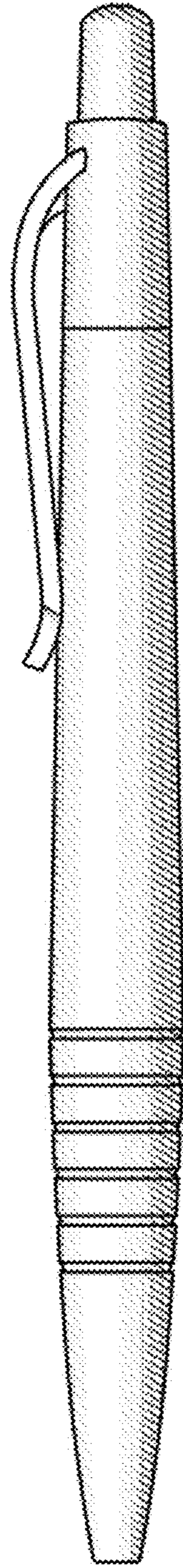

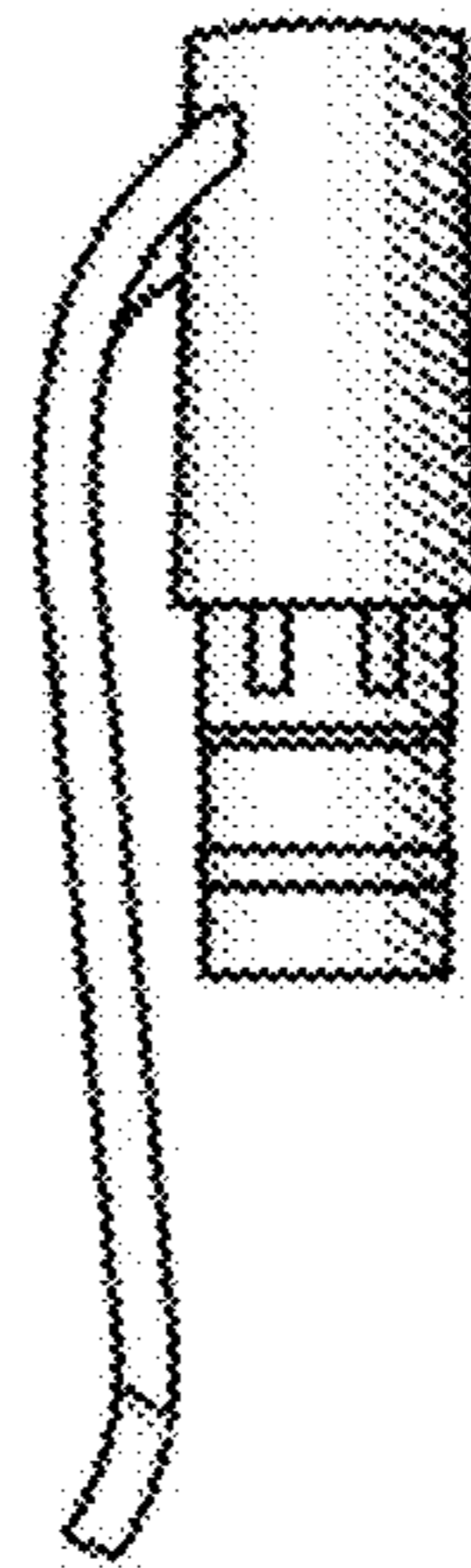

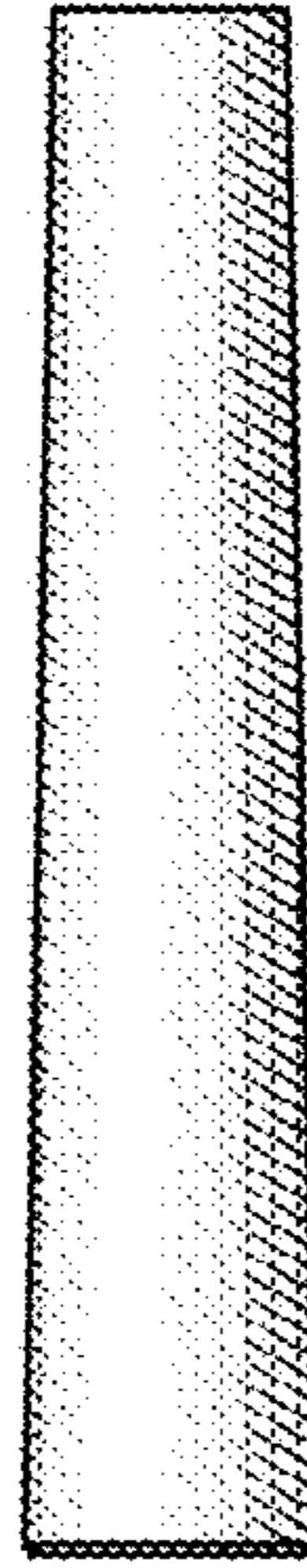
