The ornamental design for an electric vehicle for kids, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an electric vehicle for kids in accordance with the new design,

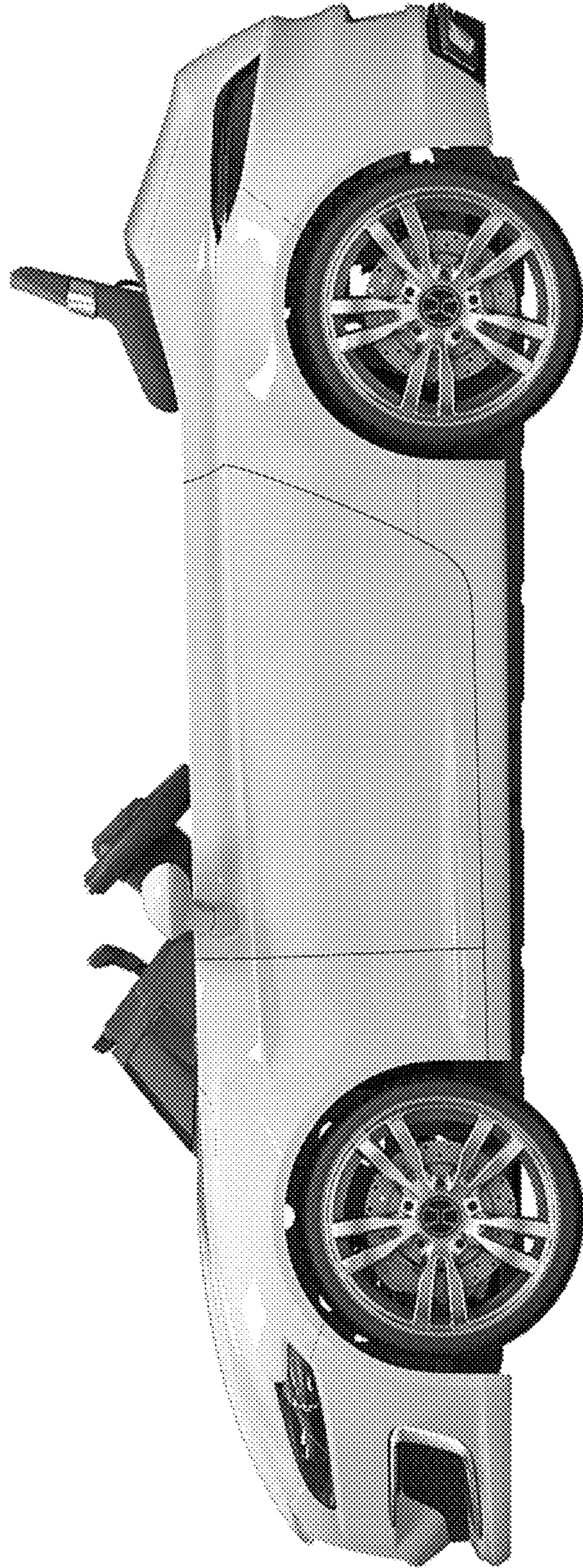

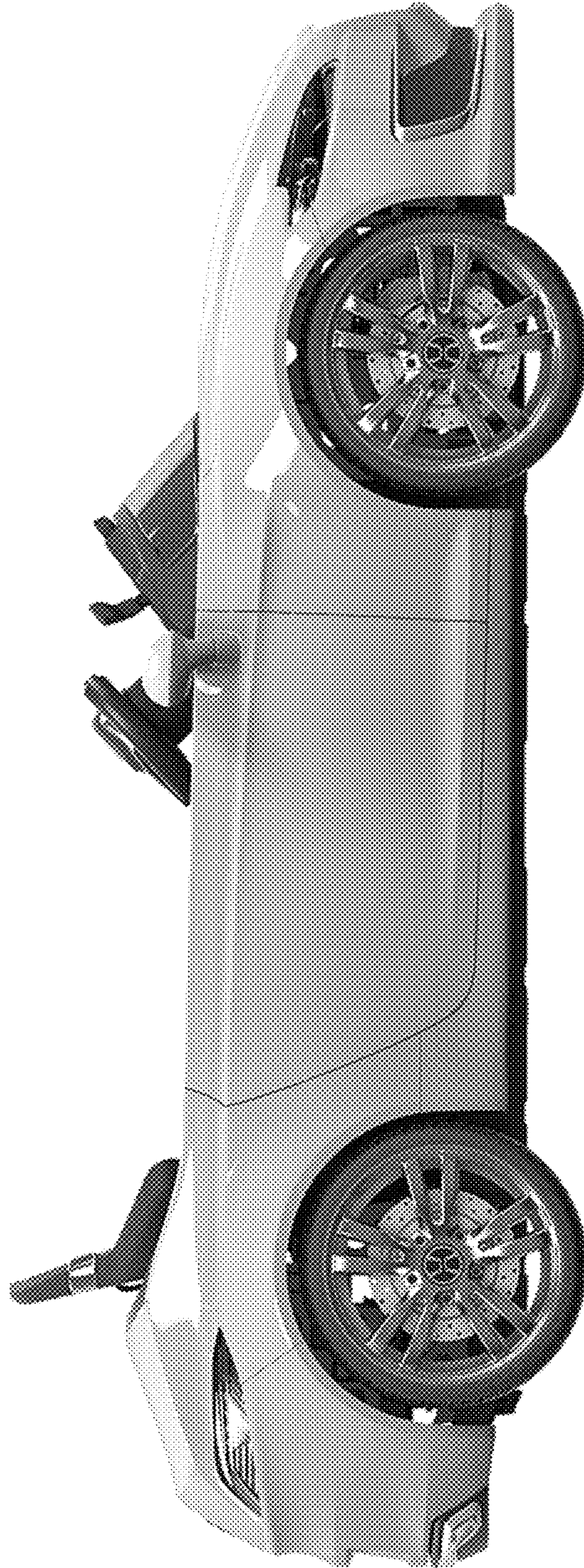

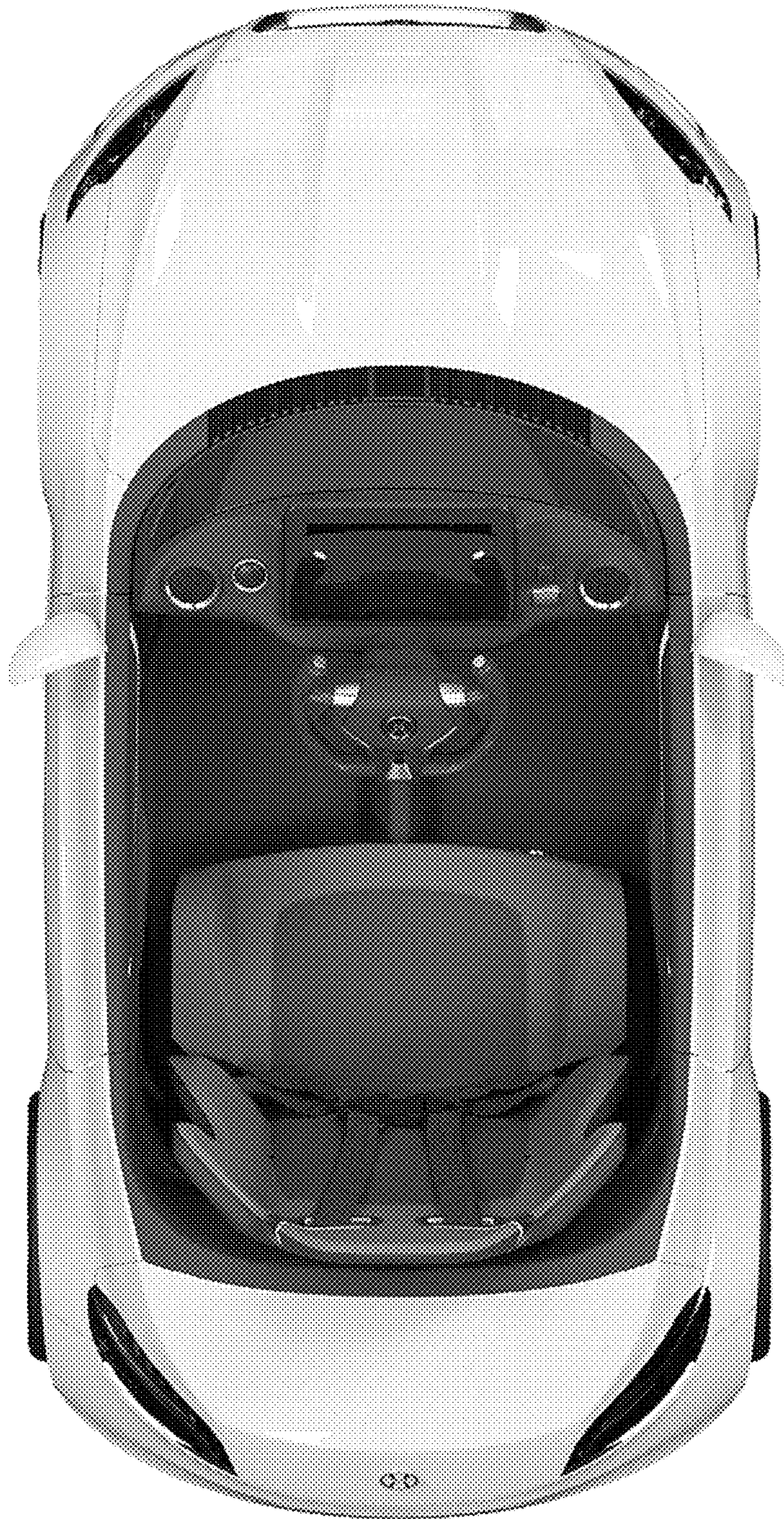
