for work while standing;

image;

FIG. 4 is a right side view, the left side being a mirror image;

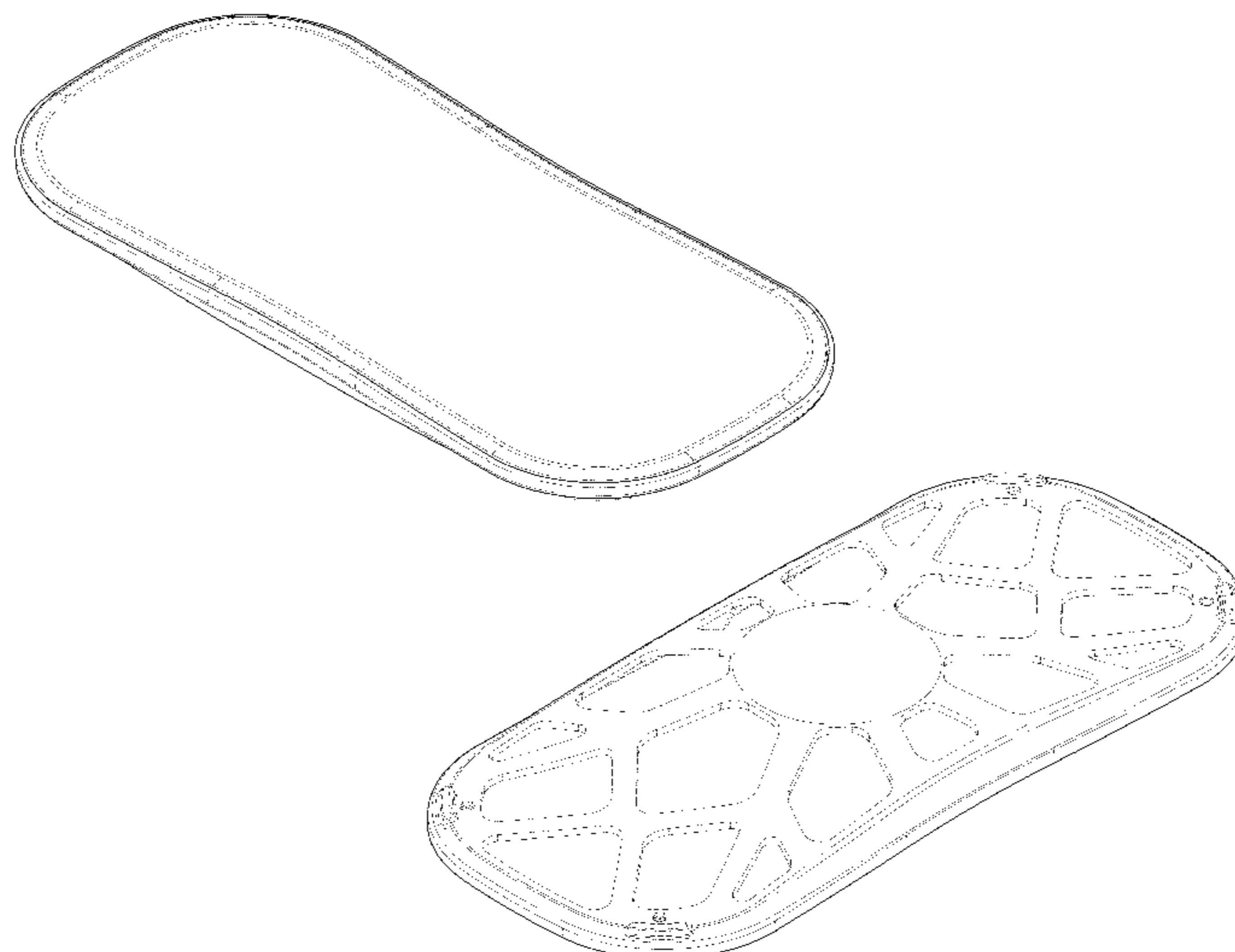
FIG. 5 is a top view thereof;

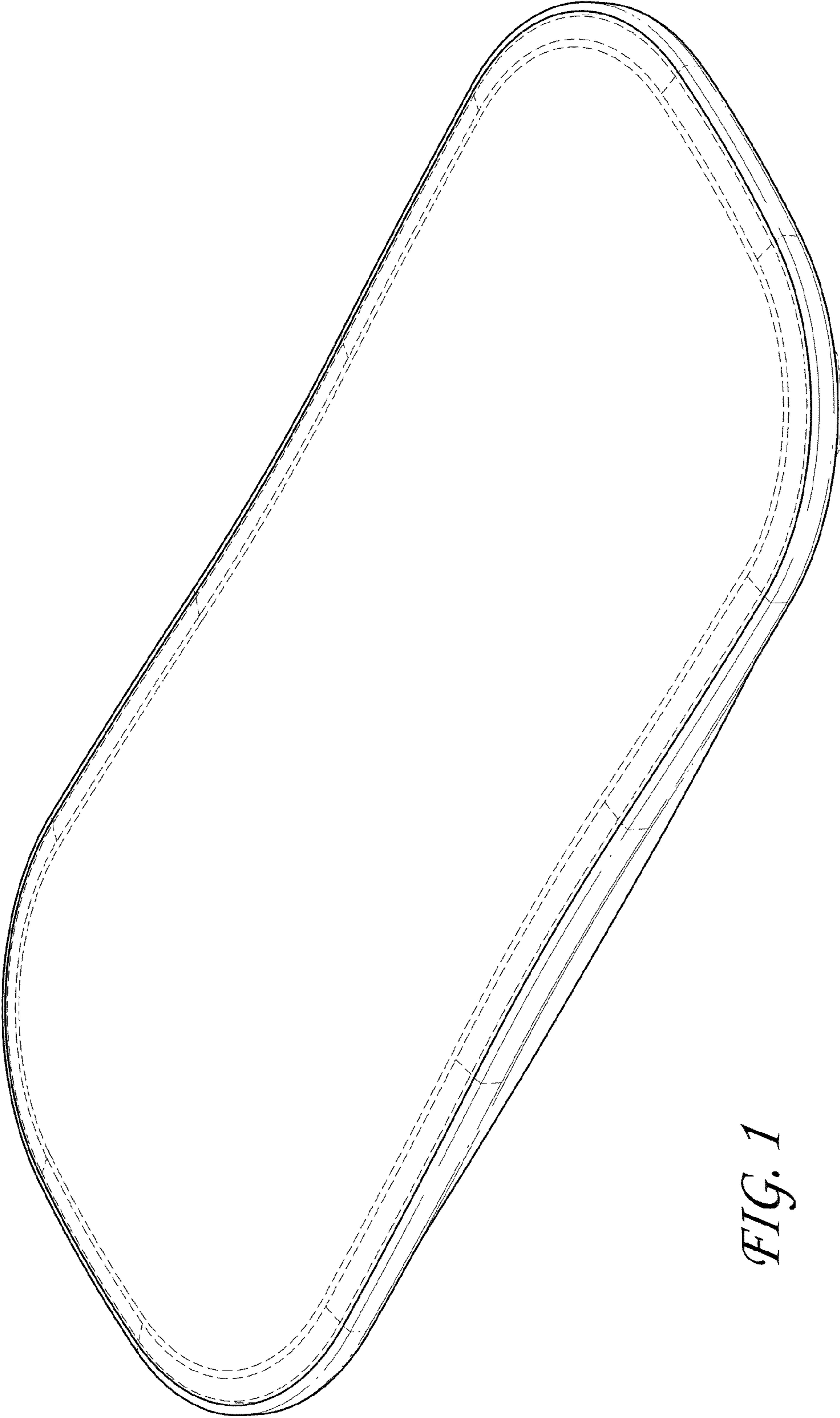

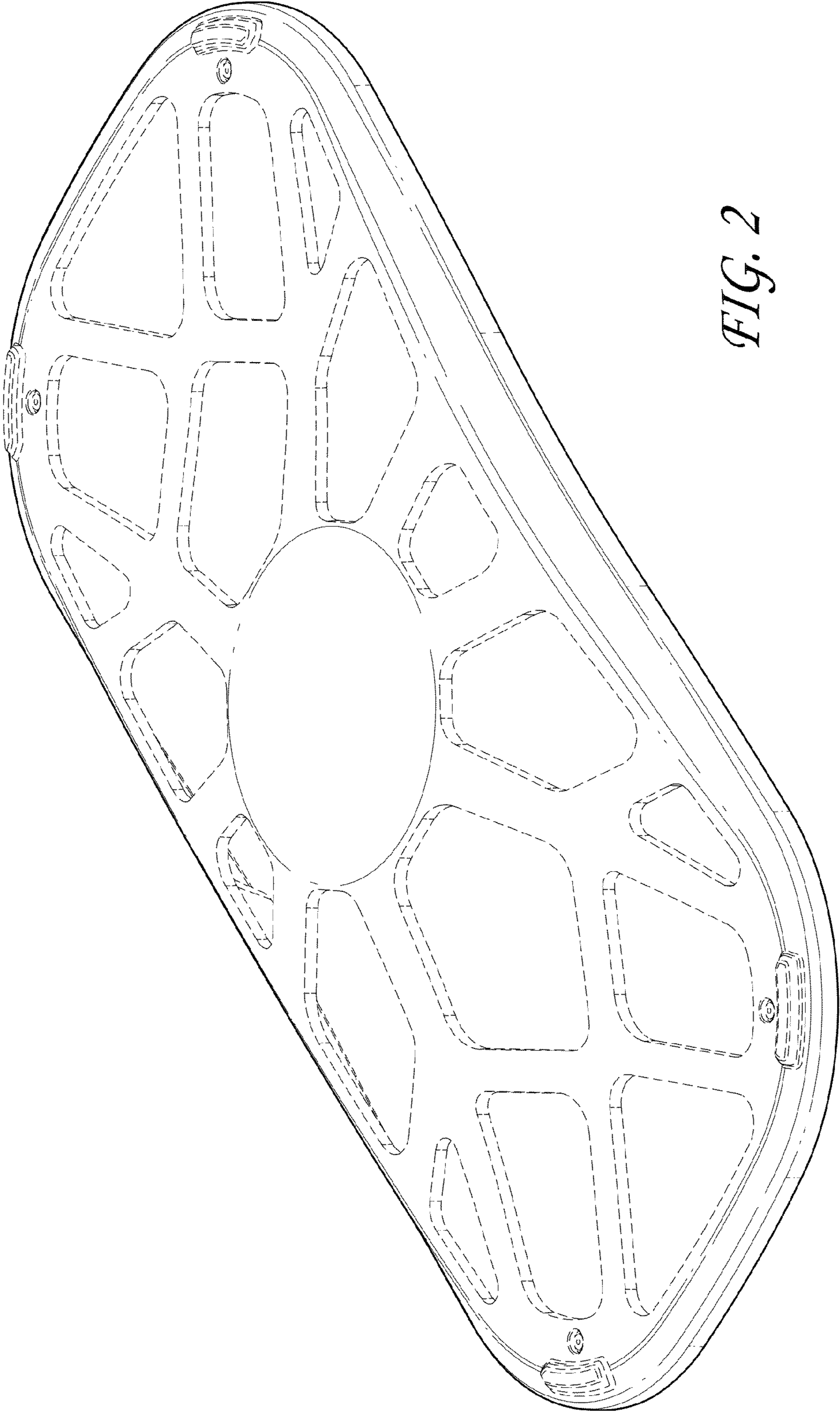
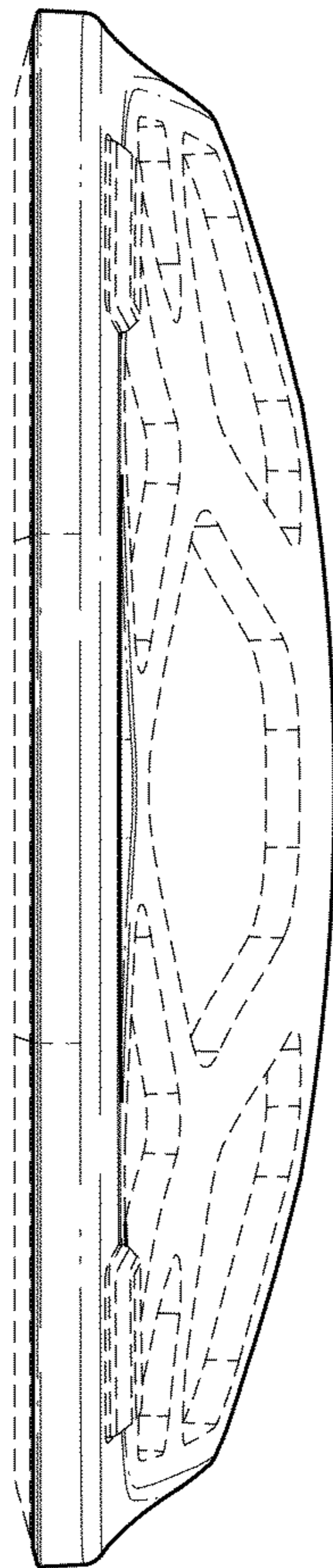
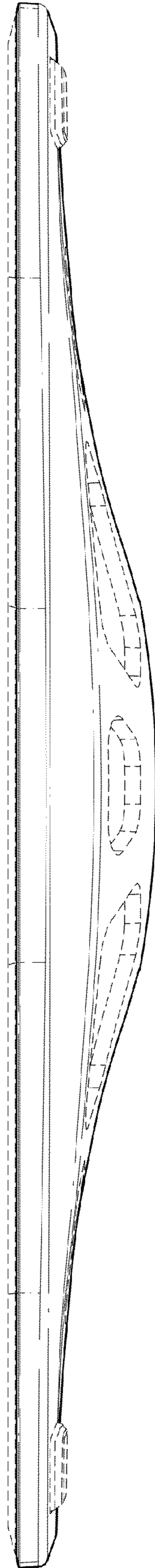


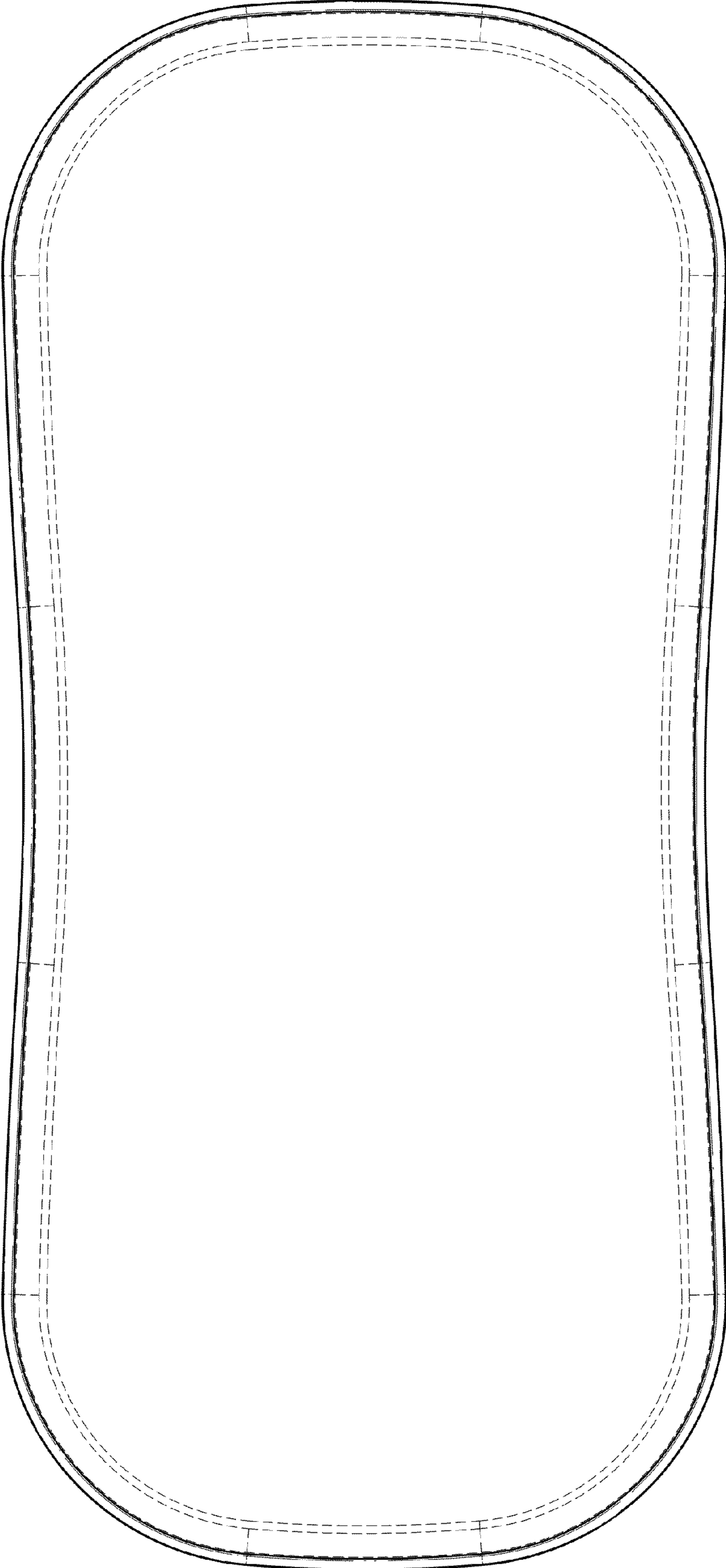

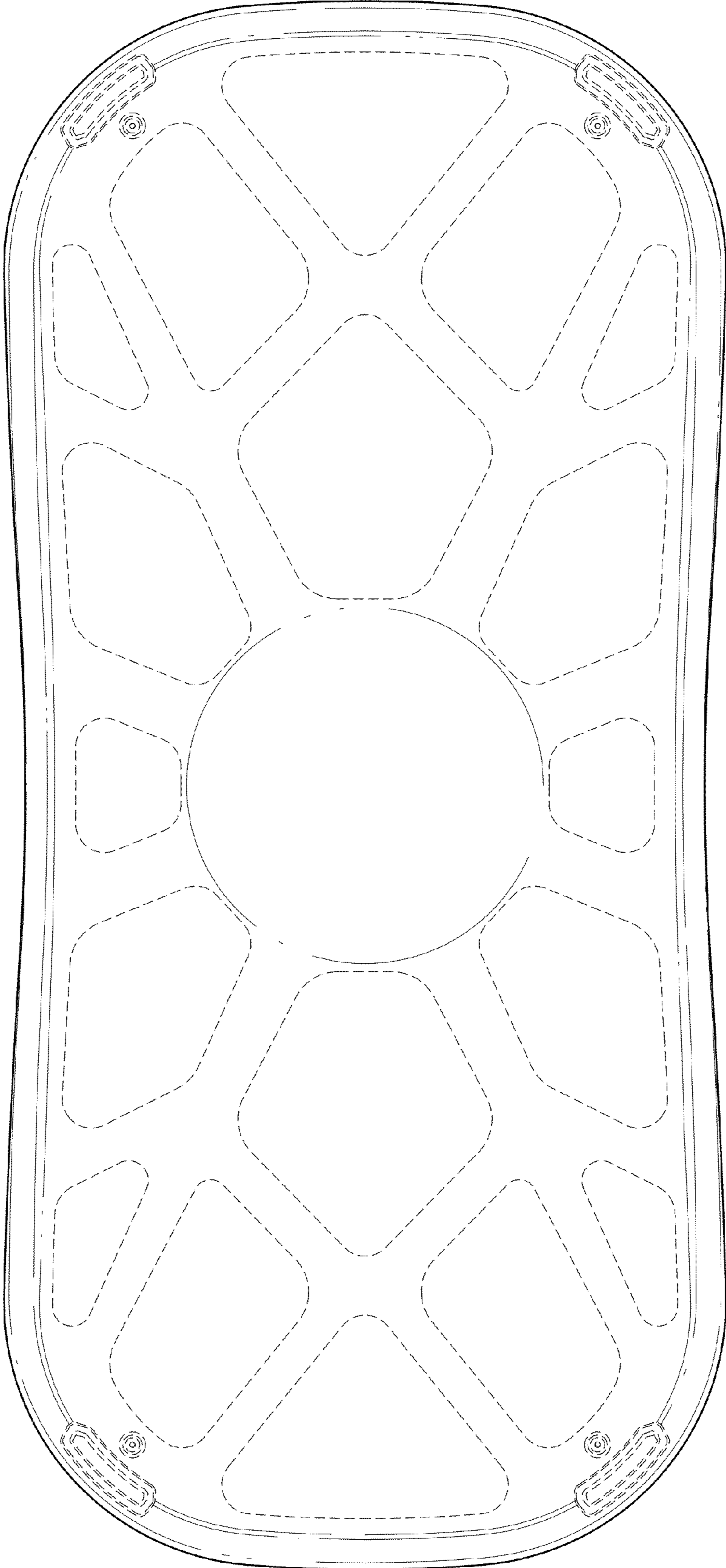

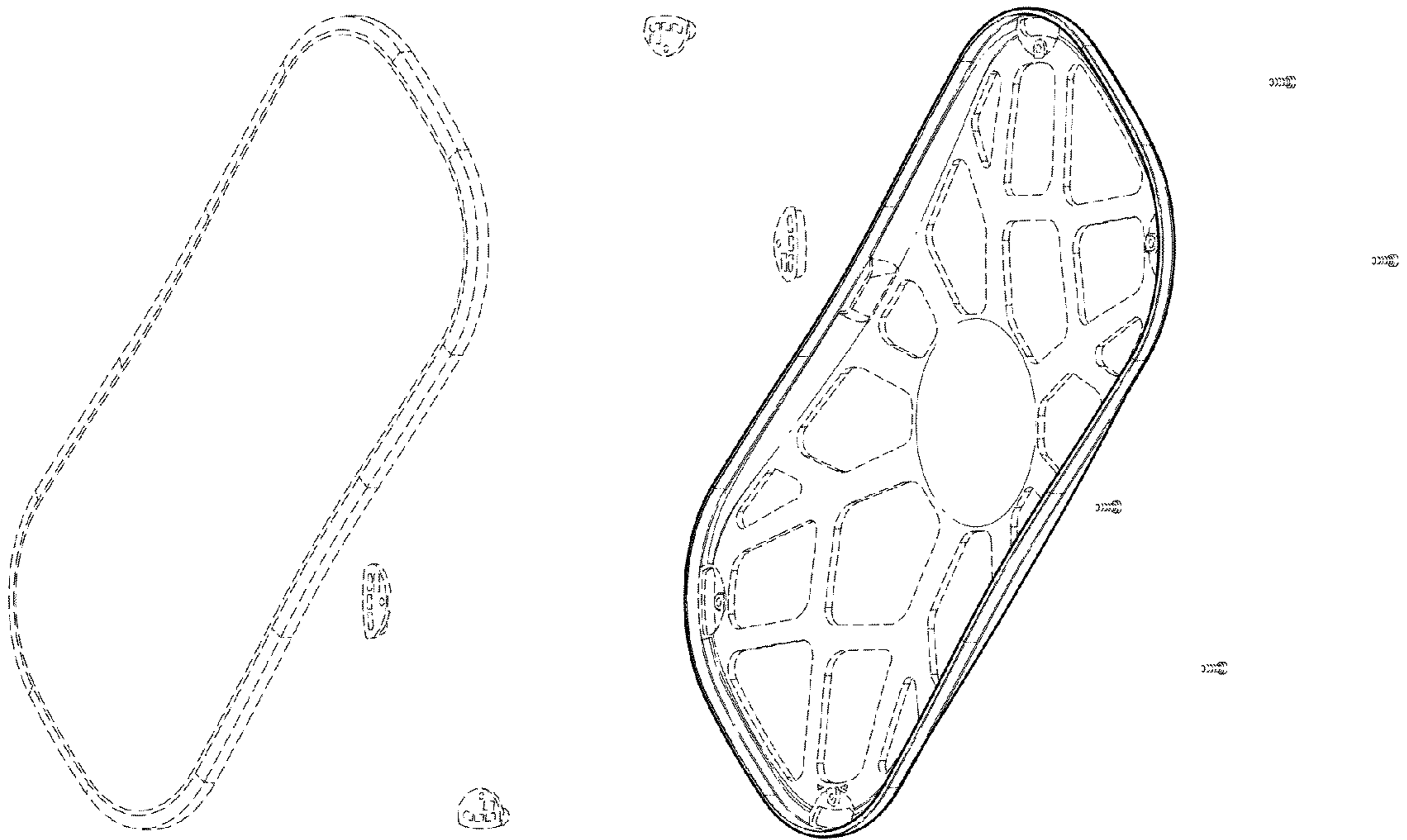
