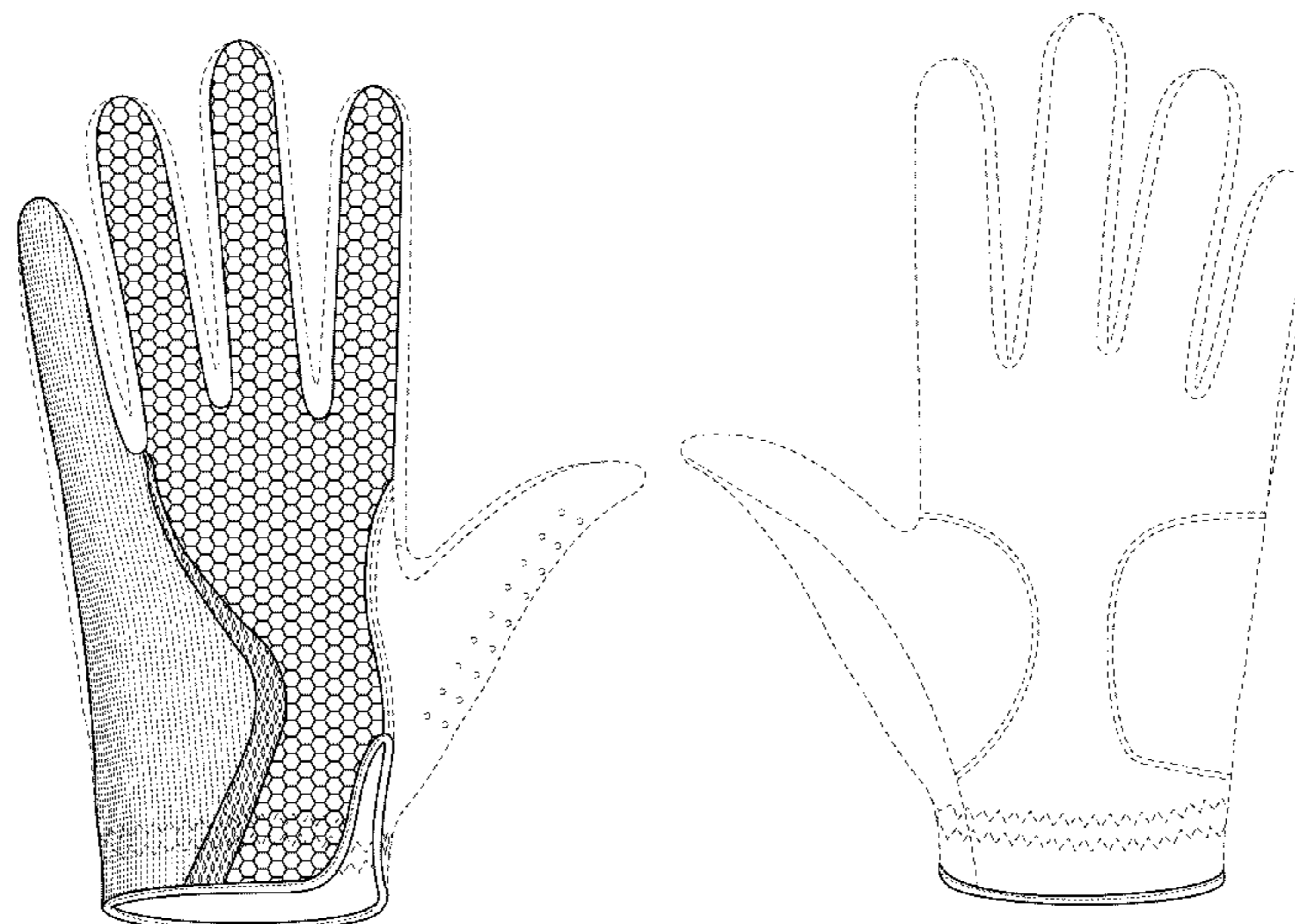
(57) **CLAIM**

The ornamental design for a golf glove, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear, plan view of a golf glove;  
FIG. 2 is a front, plan view thereof;  
FIG. 3 is a right side perspective view thereof;  
FIG. 4 is a left side perspective view thereof;  
FIG. 5 is a top perspective view thereof; and,

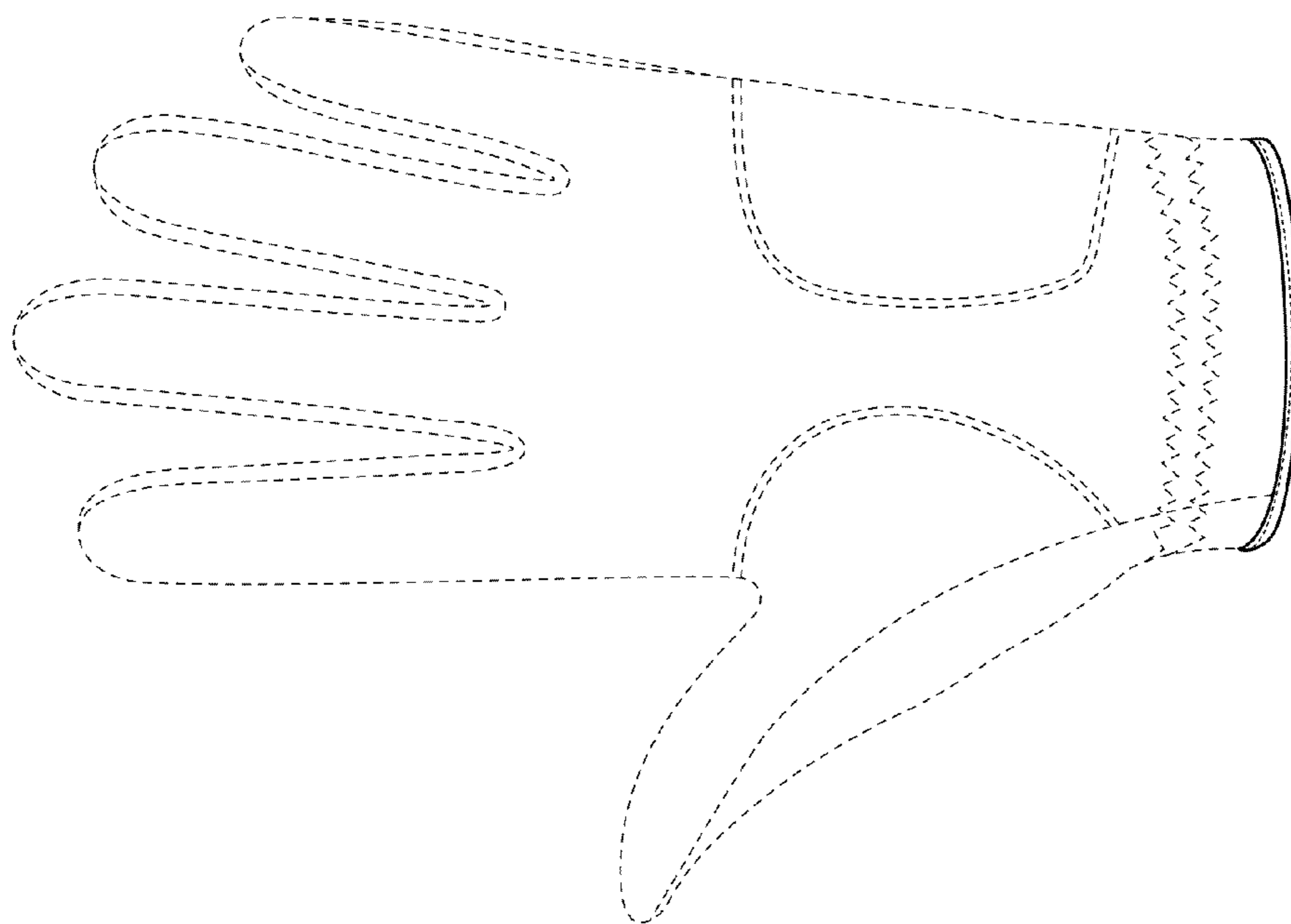

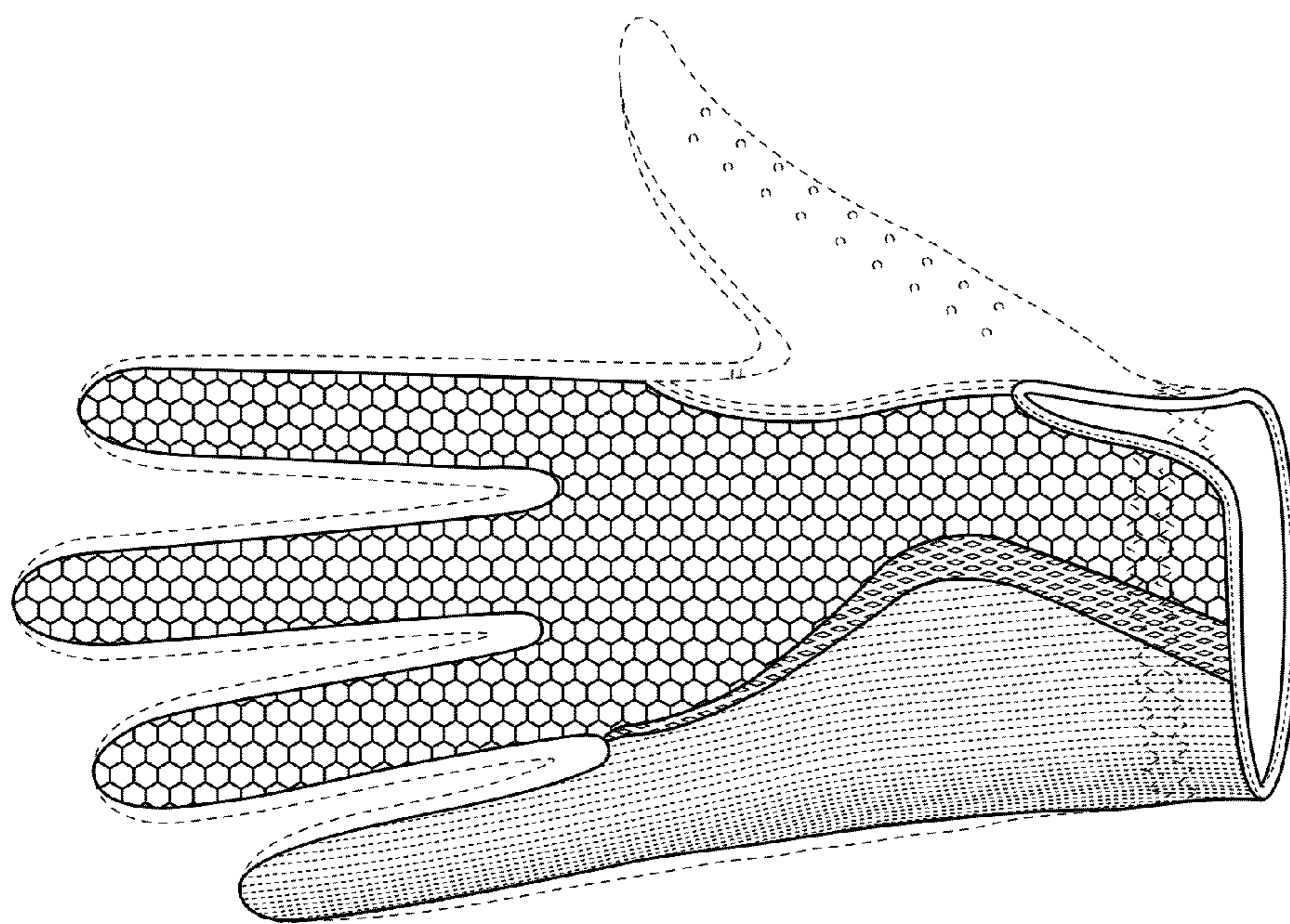

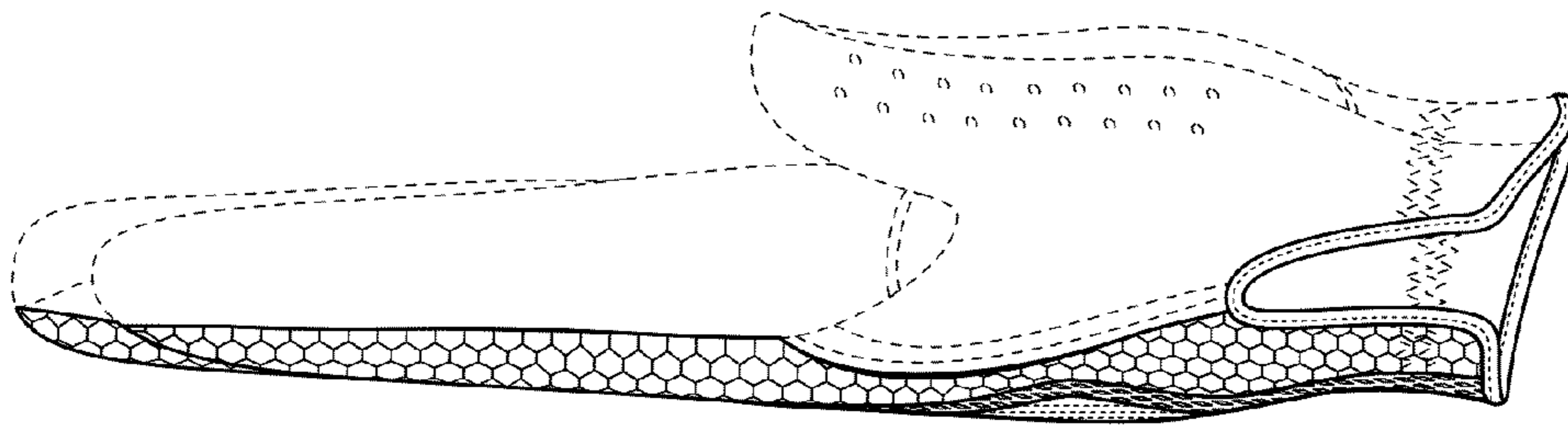

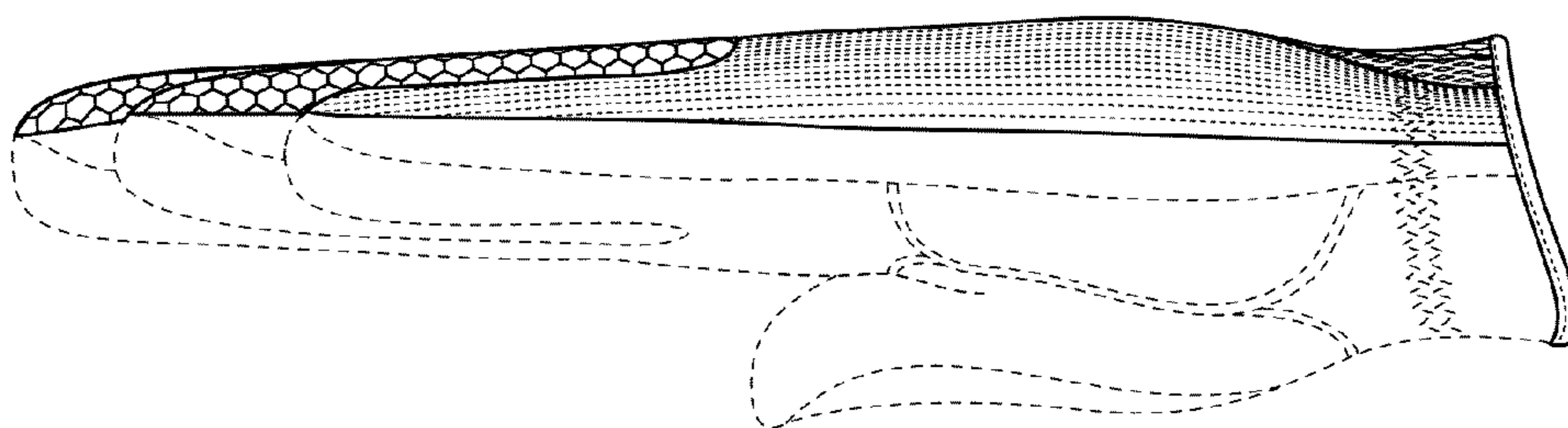

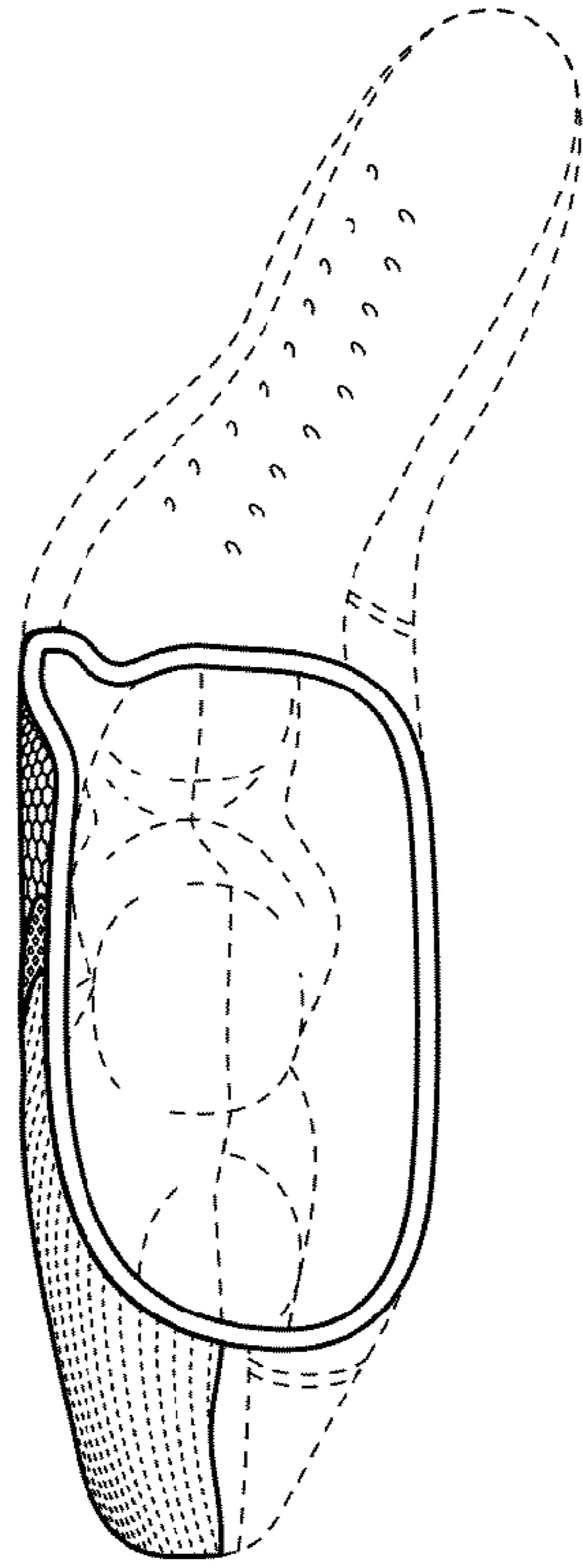

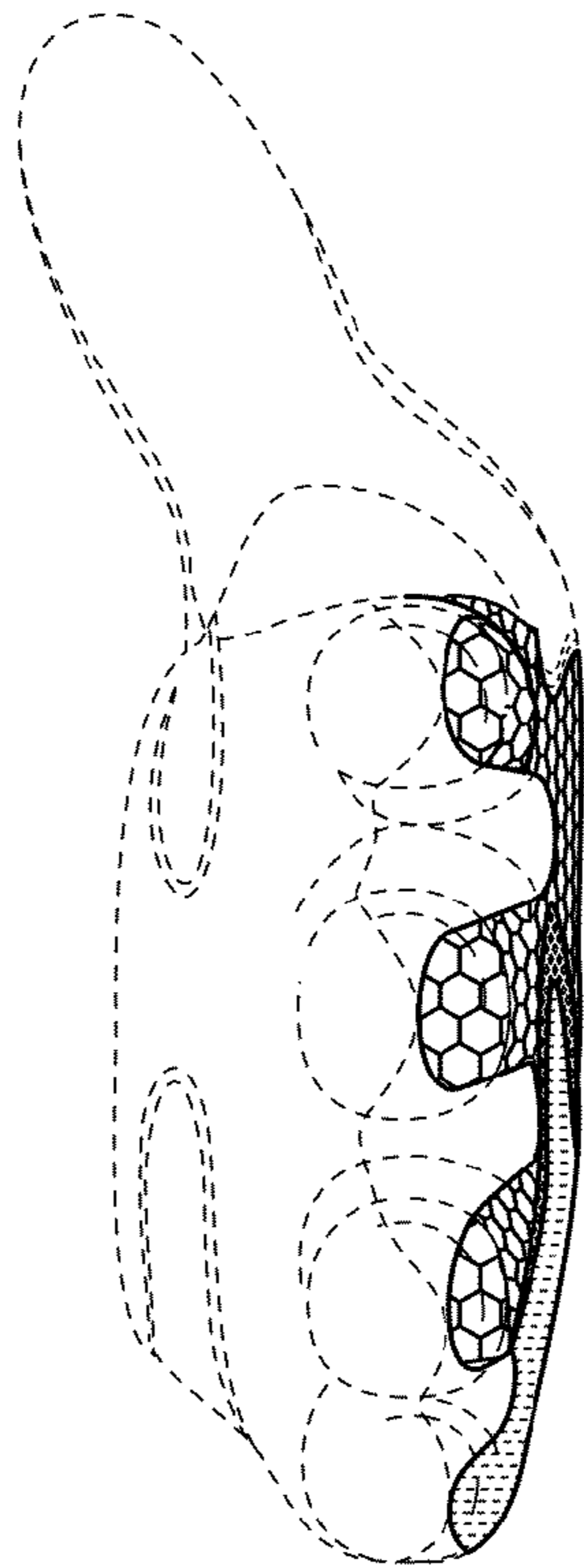
