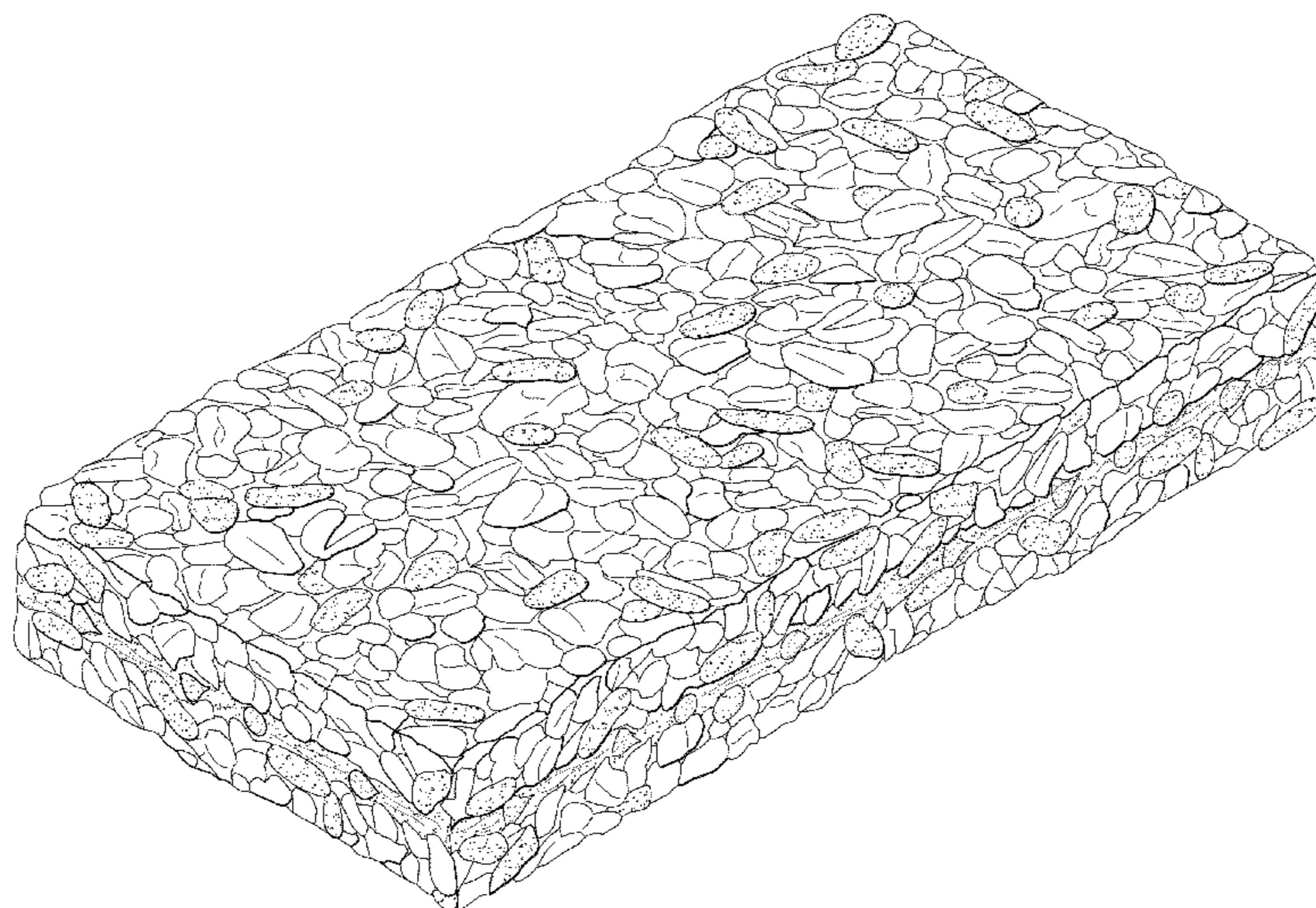
(57) **CLAIM**

The ornamental design for a multi-layered granola product with creamy filling with inclusions, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the multi-layered granola product with creamy filling with inclusions;
FIG. 2 is a side elevation view of the multi-layered granola product with creamy filling with inclusions;
FIG. 3 is an opposite side elevation view of the multi-layered granola product with creamy filling with inclusions;
FIG. 4 is a front elevation view of the multi-layered granola product with creamy filling with inclusions;
FIG. 5 is a rear elevation view of the multi-layered granola product with creamy filling with inclusions;
FIG. 6 is a top plan view of the multi-layered granola product with creamy filling with inclusions; and,
FIG. 7 is a bottom plan view of the multi-layered granola product with creamy filling with inclusions.

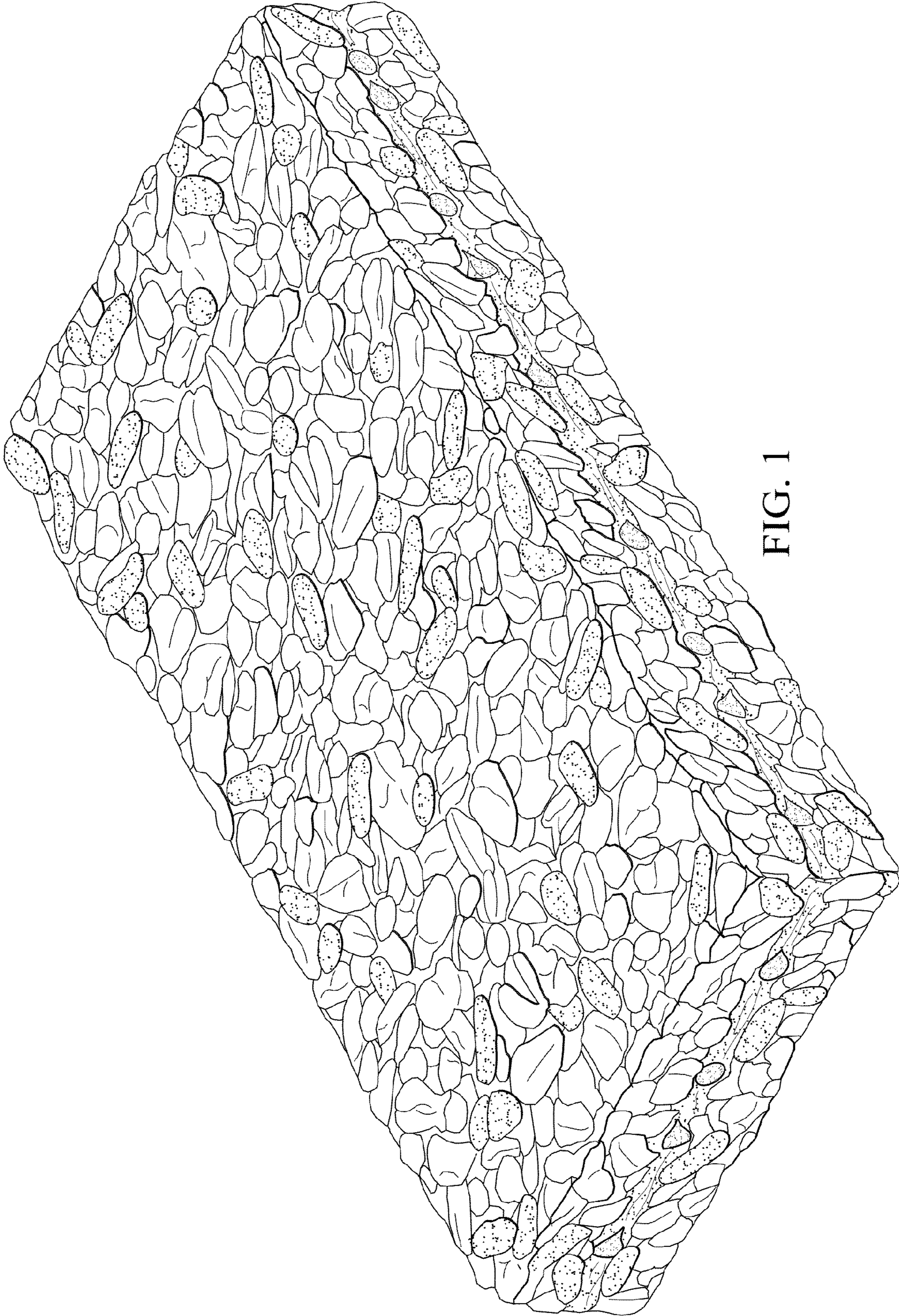

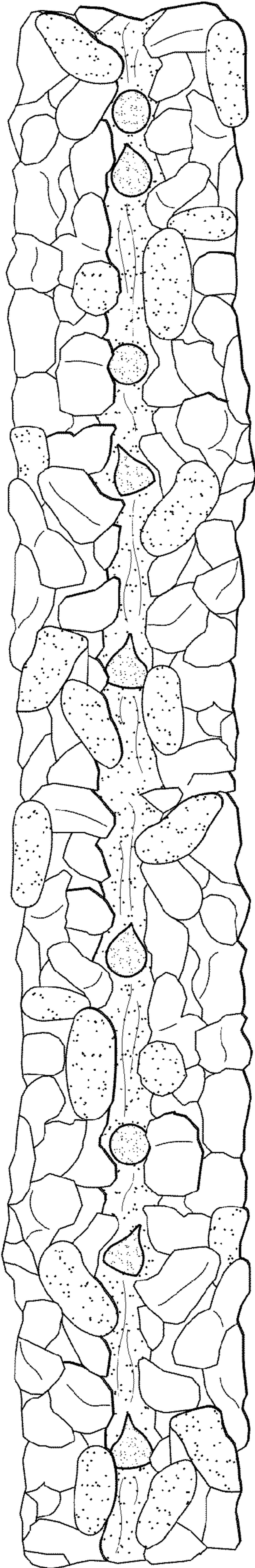

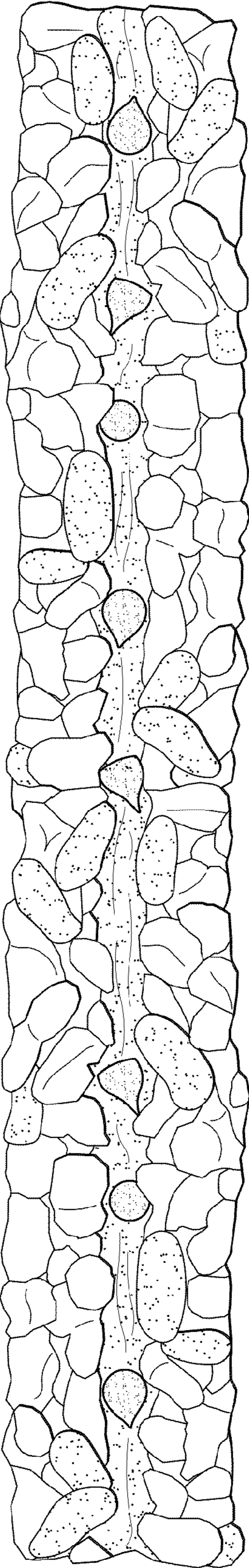

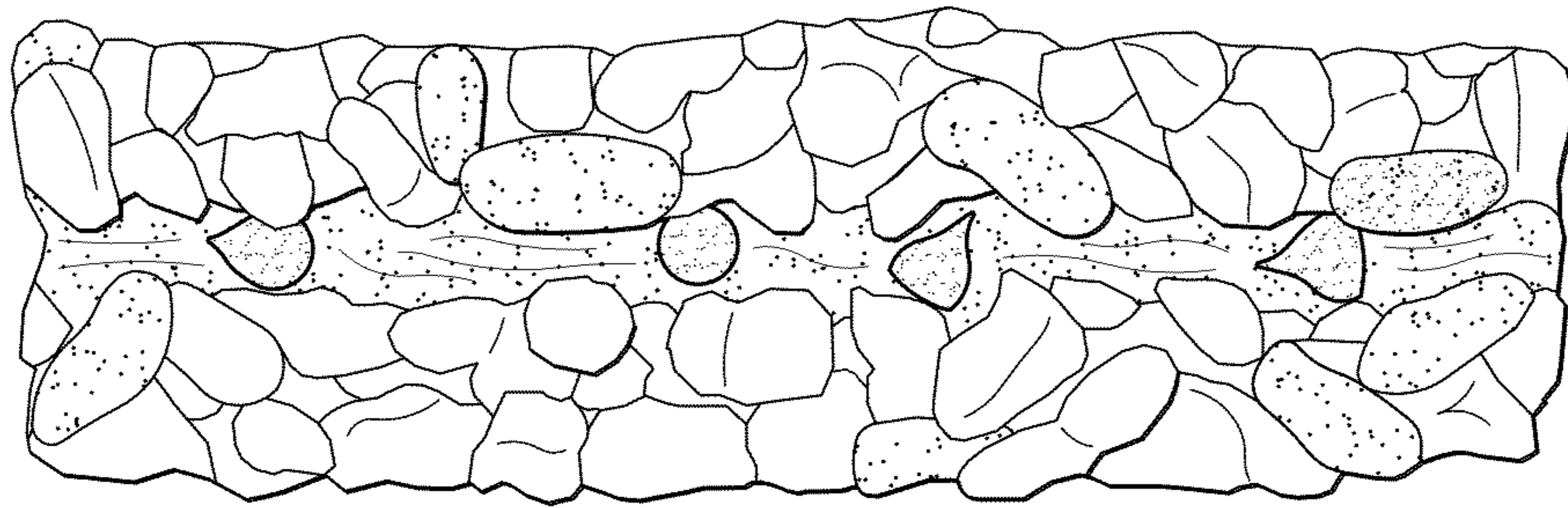

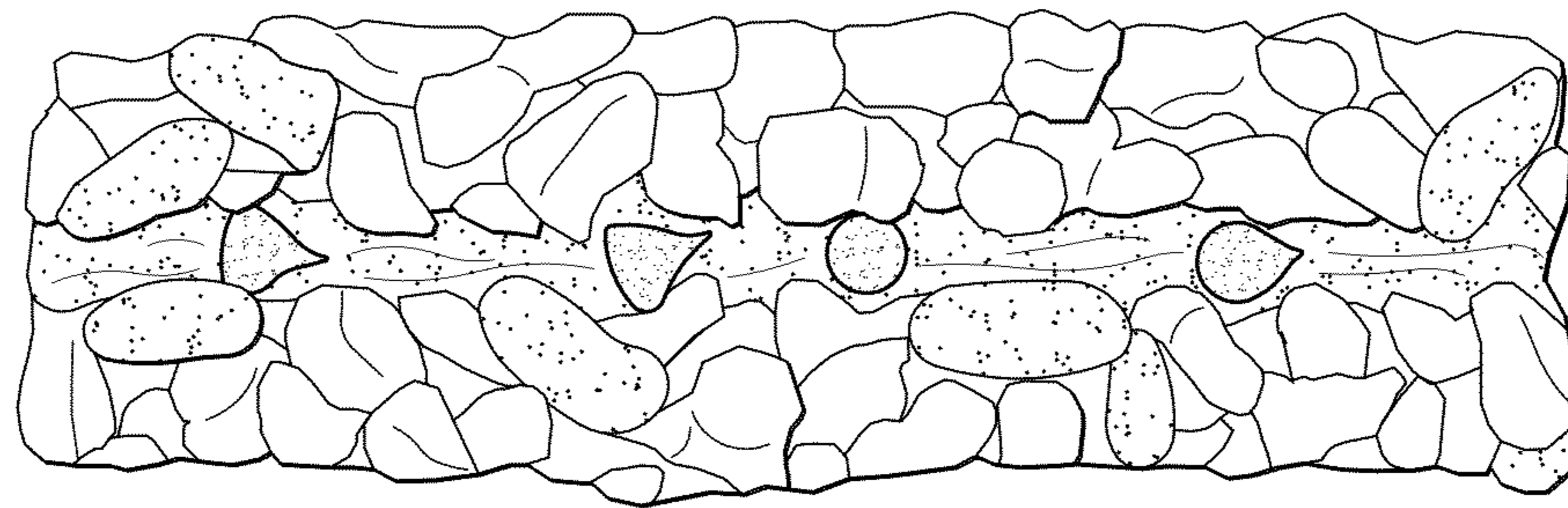

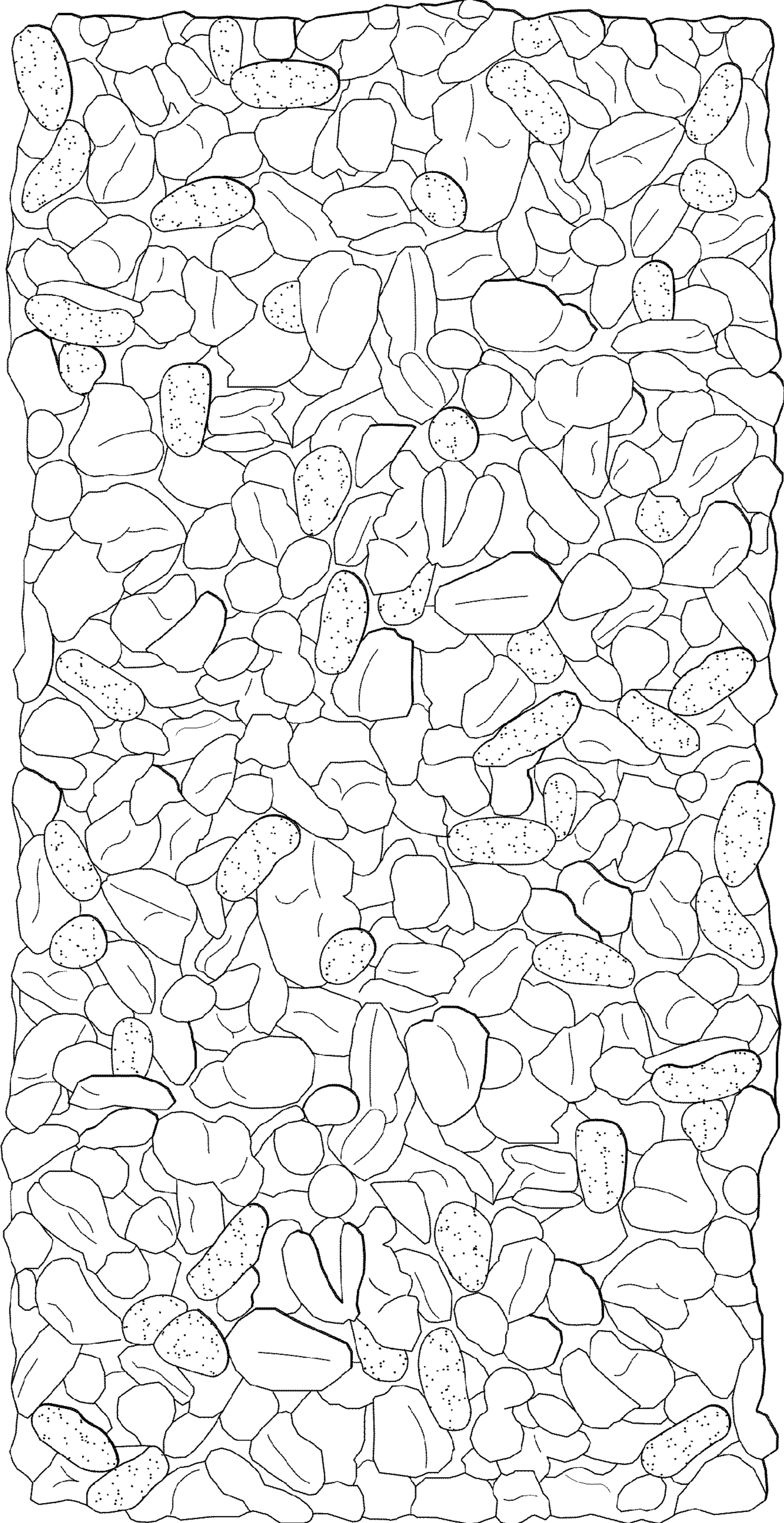

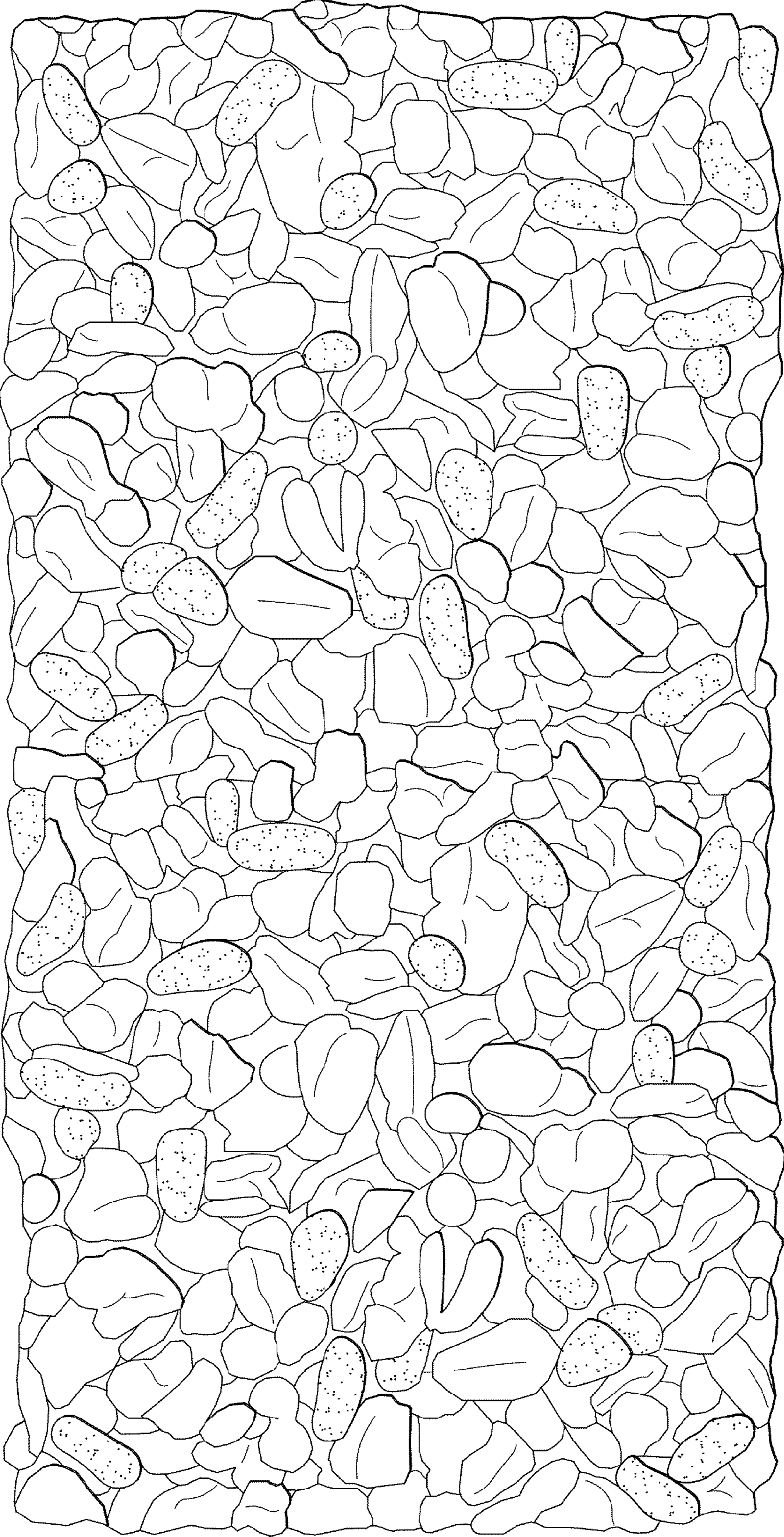
