(57) **CLAIM**

The ornamental design for a diving suit, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a diving suit showing my new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevational elevation view thereof;

FIG. 4 is a left side elevational elevation view thereof;

FIG. 5 is a right side elevational elevation view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a front elevation view thereof, shown in an alternate configuration as appears on a diver, with the partial belt section hidden under the upper part of the suit; and,

FIG. 9 is a rear elevation view thereof, shown in an alternate configuration as appears on a diver, with the partial belt section hidden under the upper part of the suit.

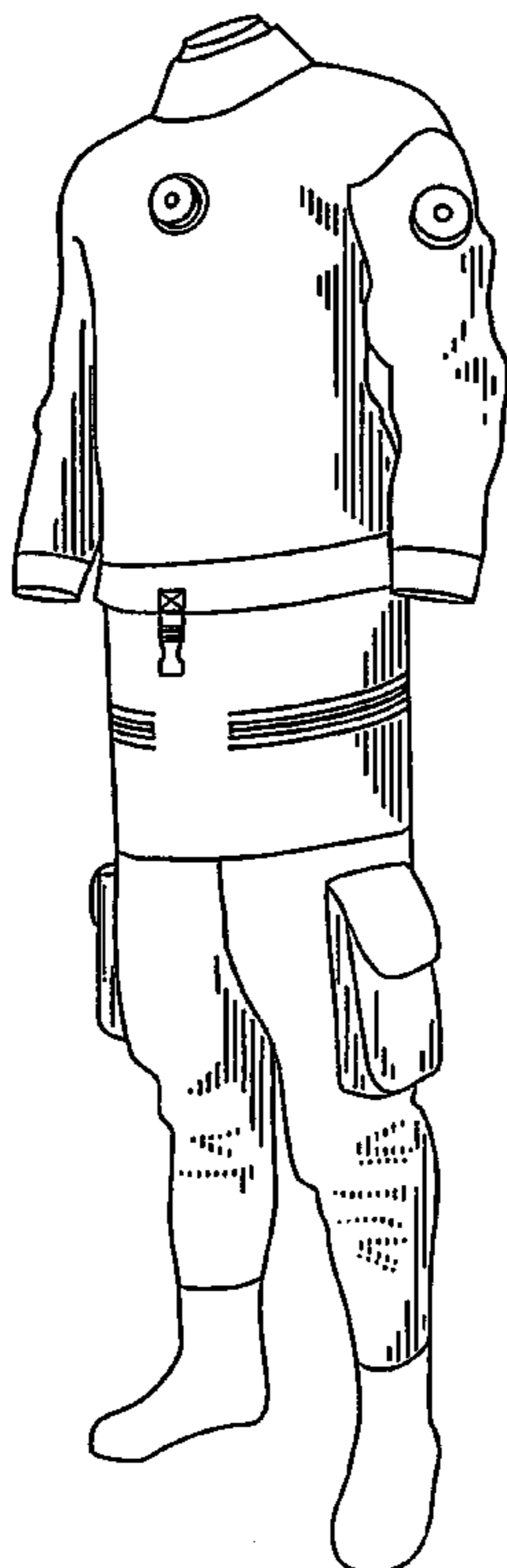

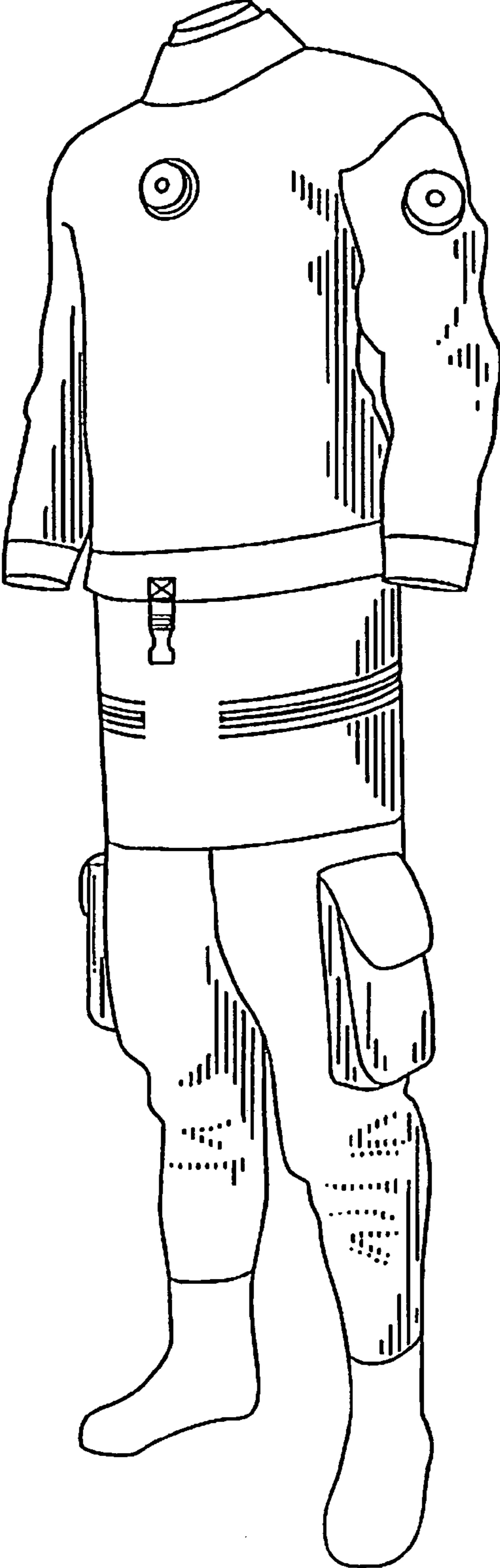

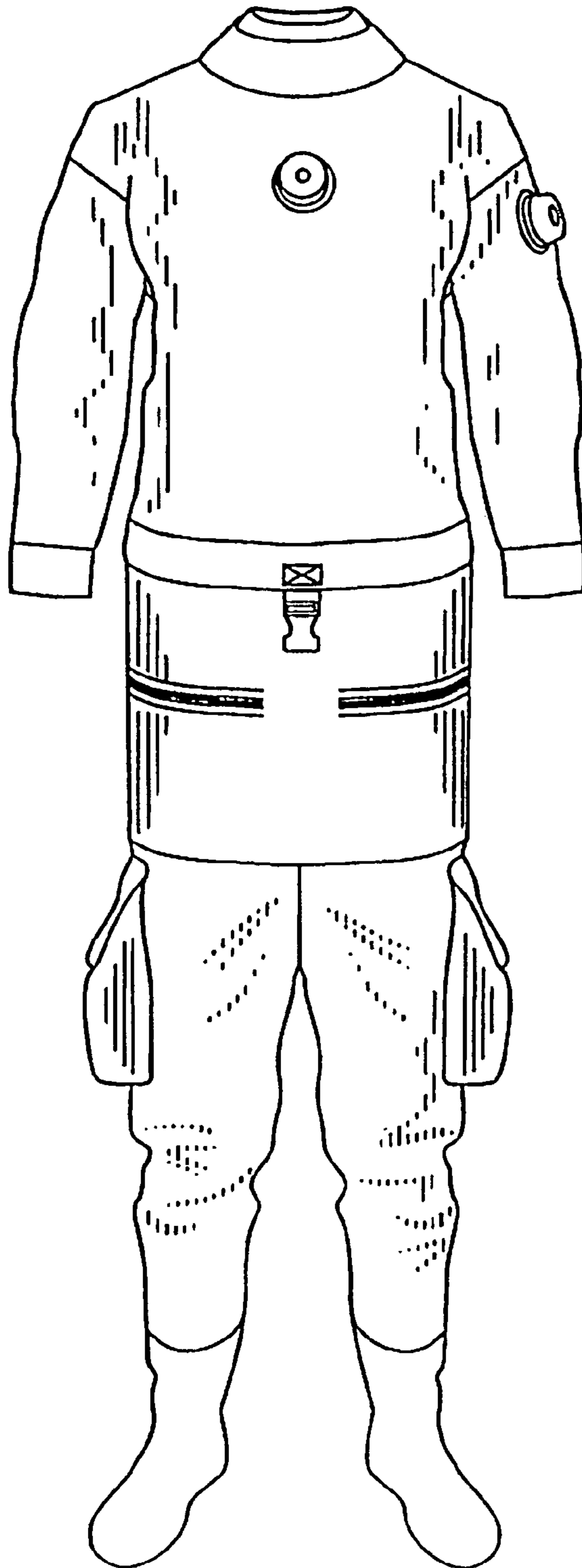

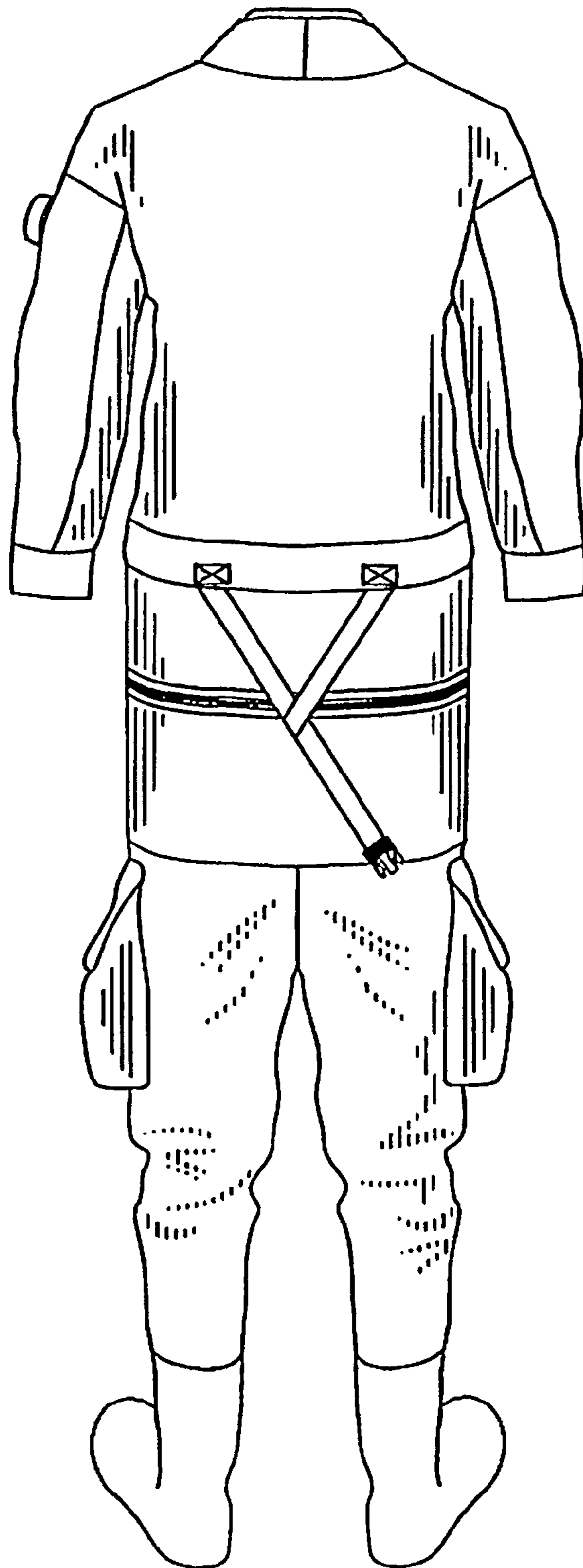

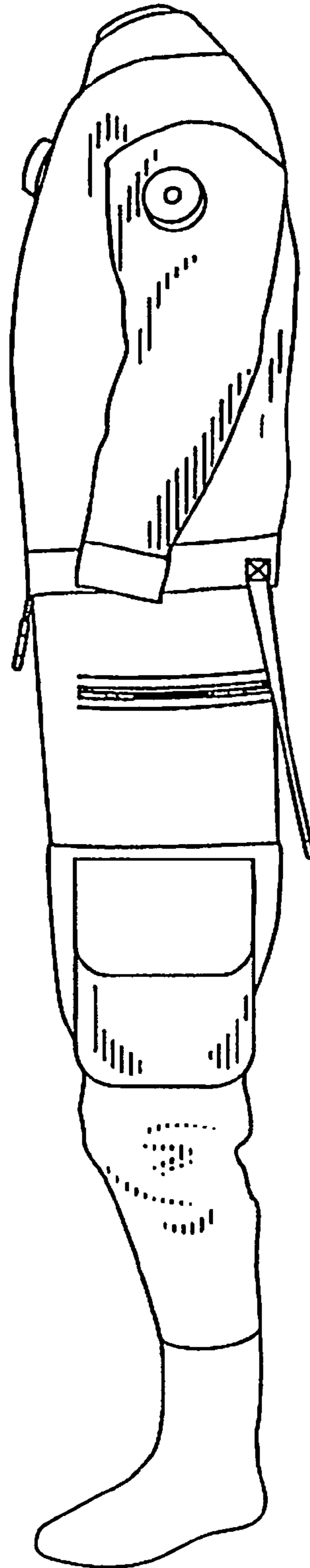

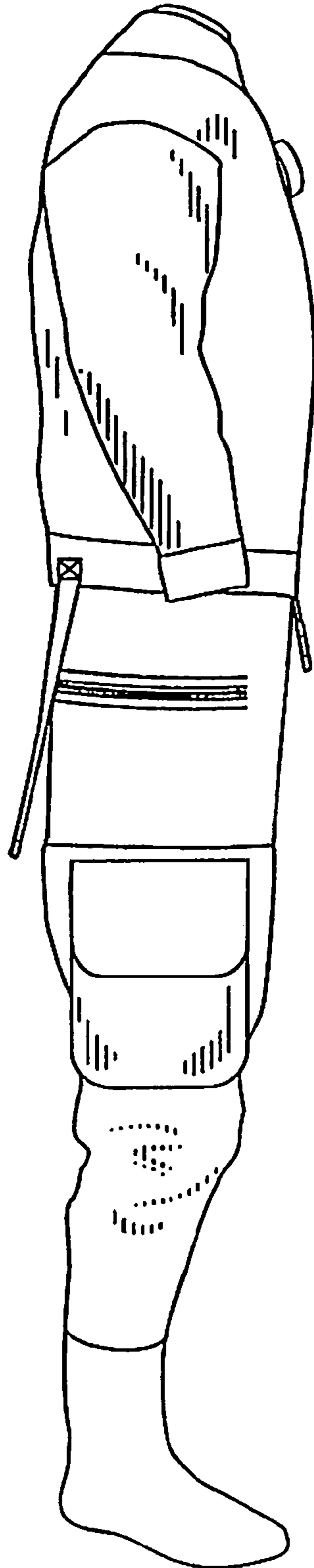

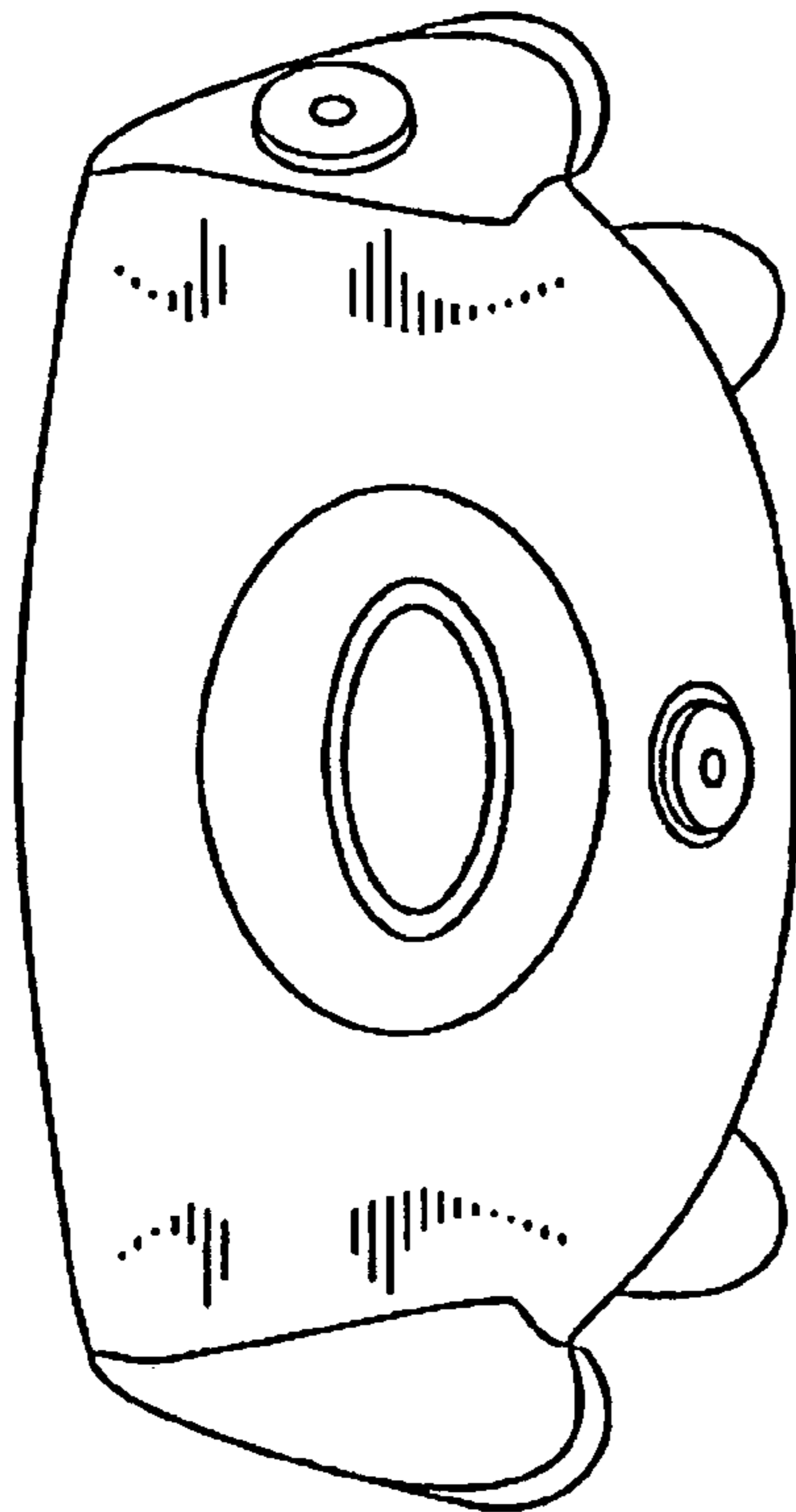

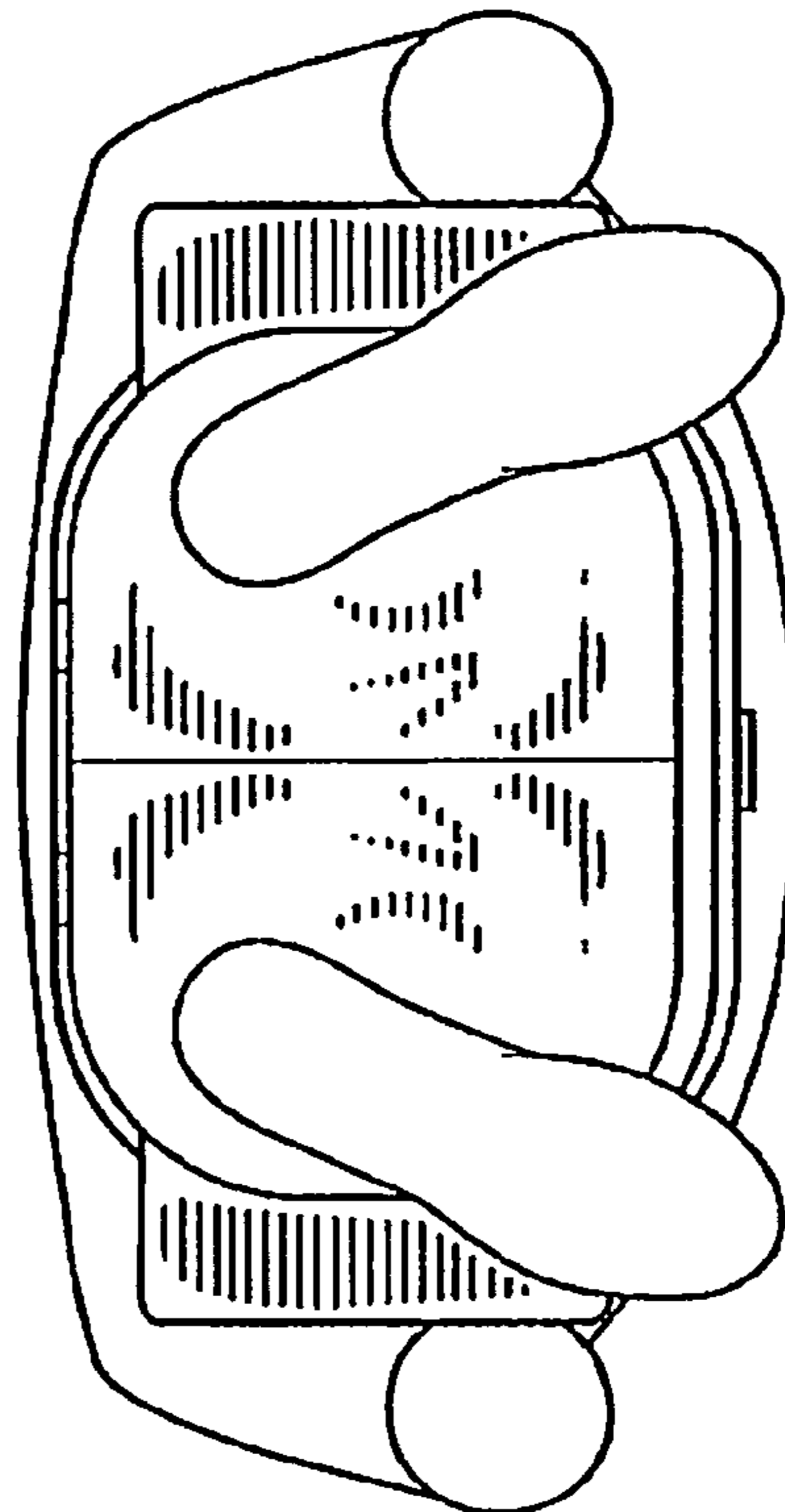

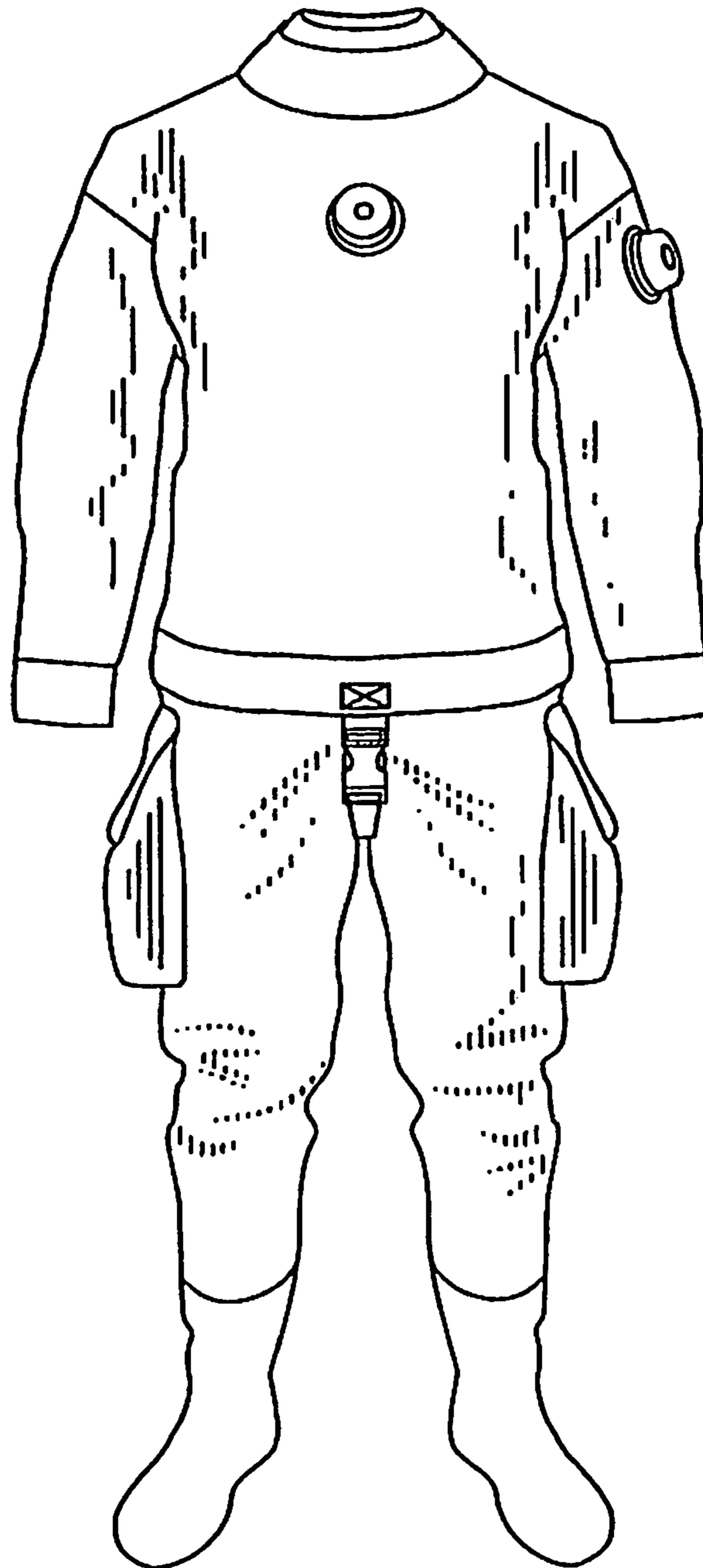
