(57) **CLAIM**

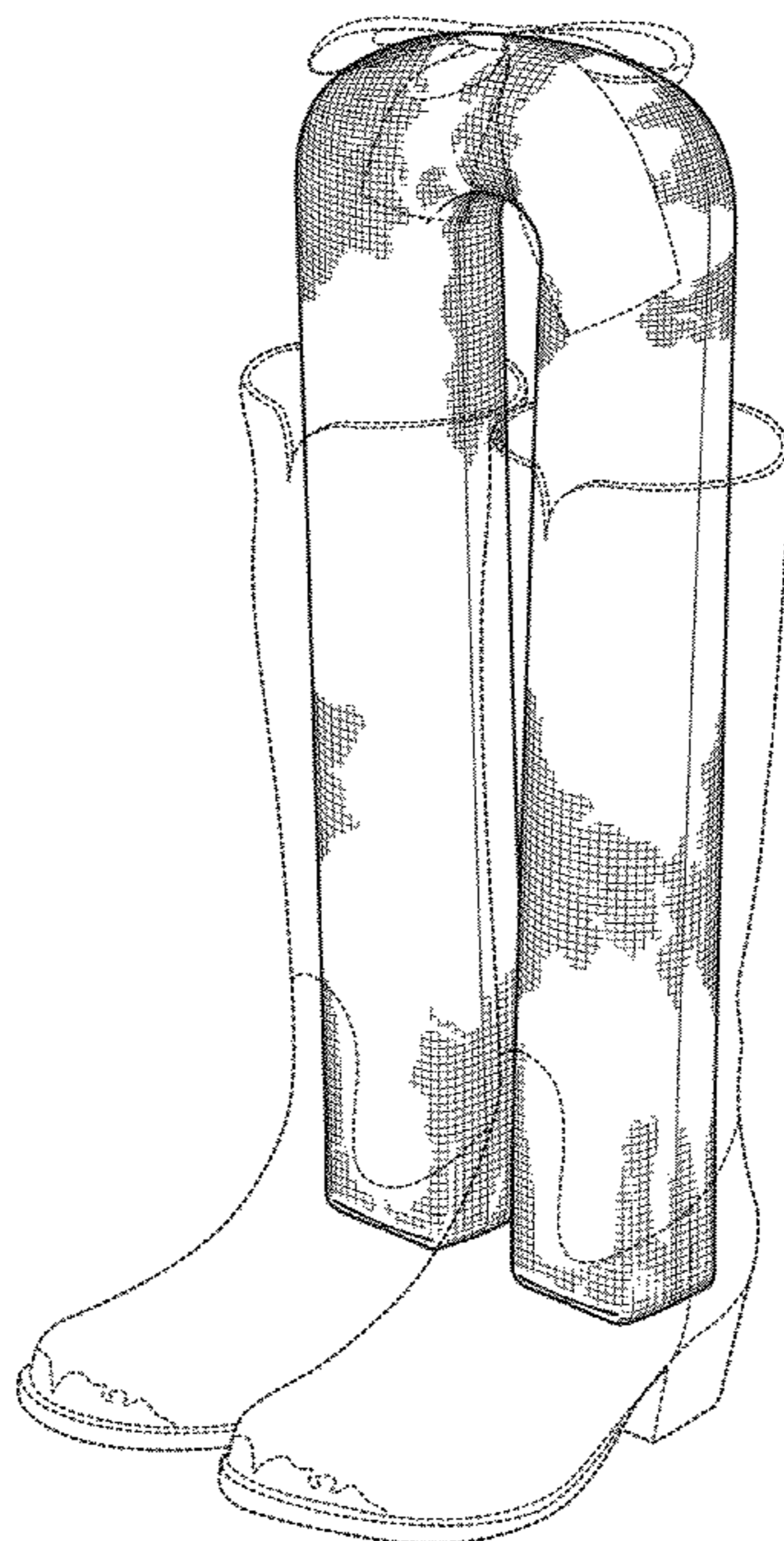
I claim the ornamental design for a boot footwear preserver, as shown and described.

DESCRIPTION

FIG. 1 is a front, side perspective view of a boot footwear preserver showing my new design;
 FIG. 2 is a front elevation view thereof;
 FIG. 3 is a rear elevation view thereof;
 FIG. 4 is a right side elevation view thereof;
 FIG. 5 is a left side elevation view thereof;
 FIG. 6 is a top plan view thereof; and,
 FIG. 7 is a bottom plan view thereof.
 The broken lines of the boots and bow form no part of the claimed design.

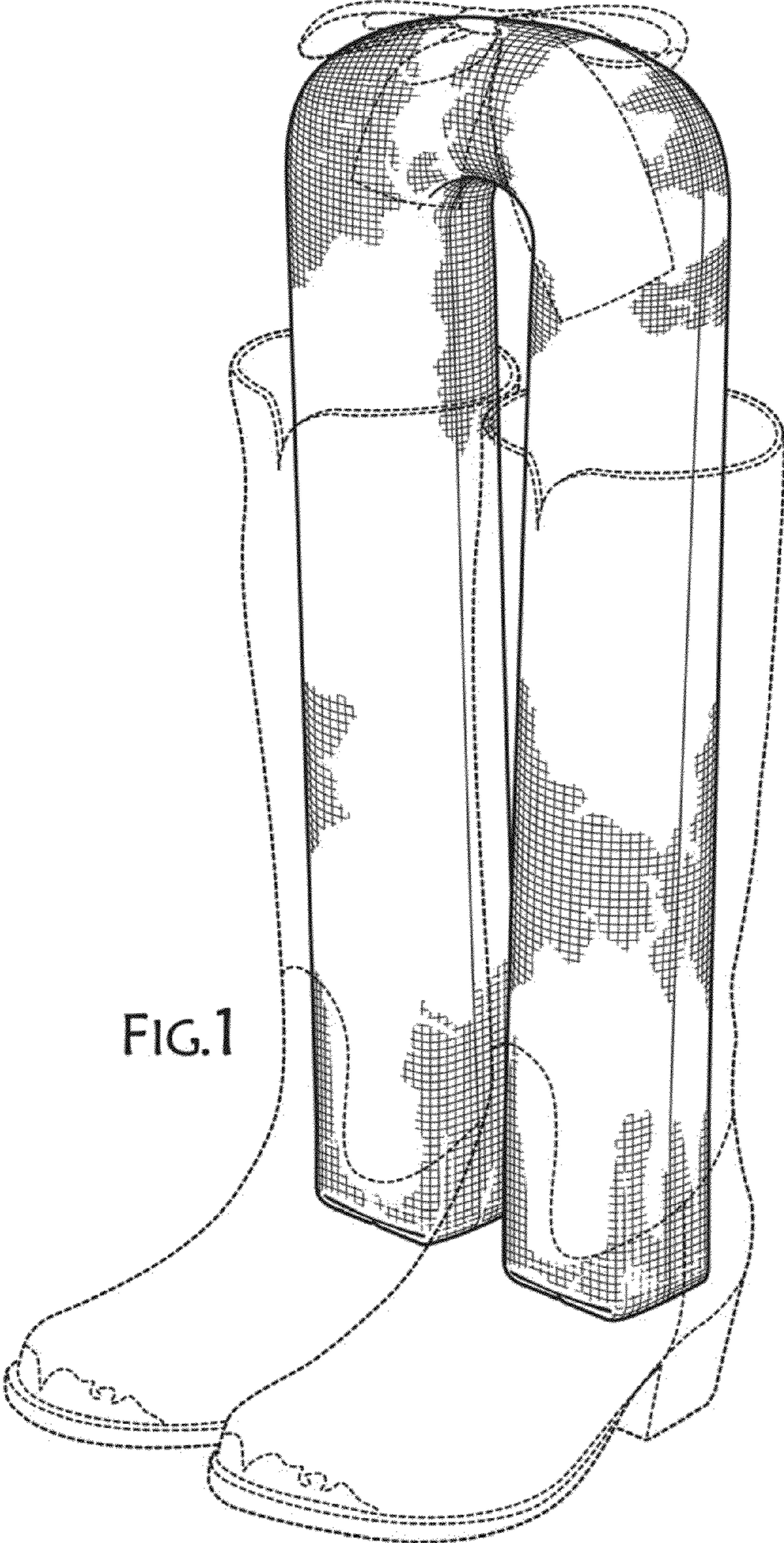

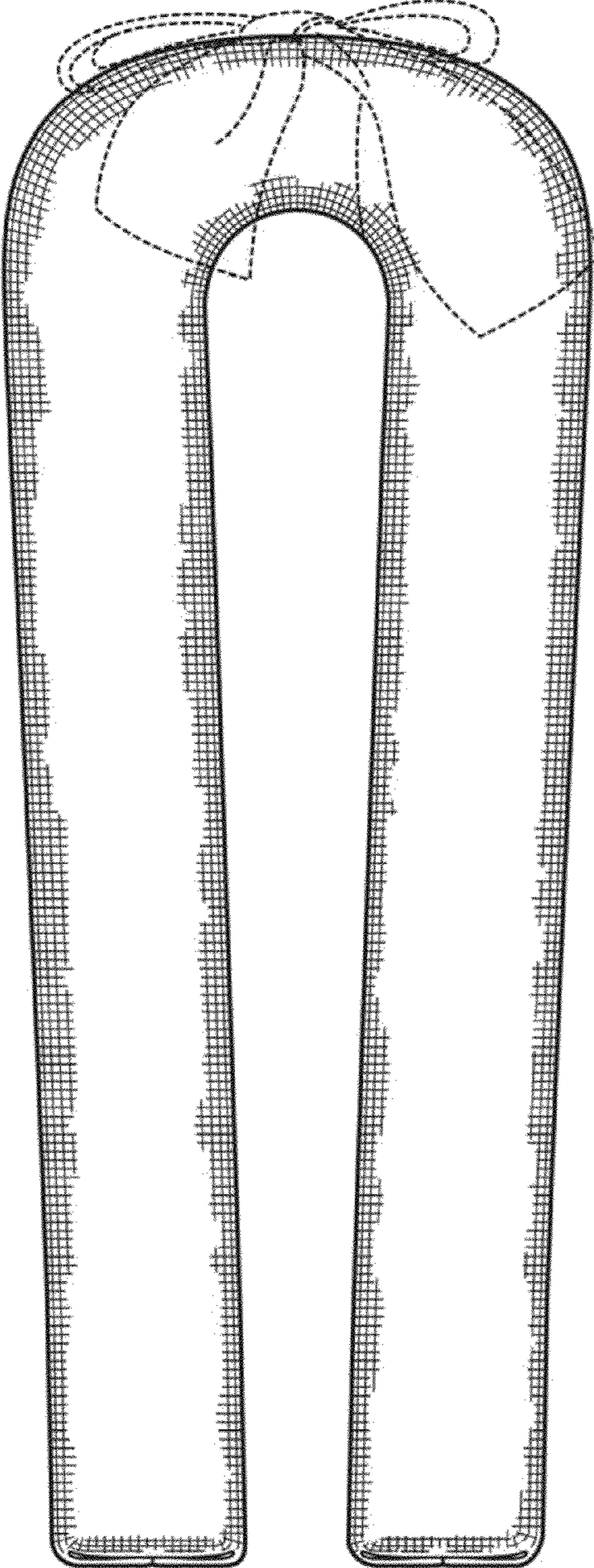

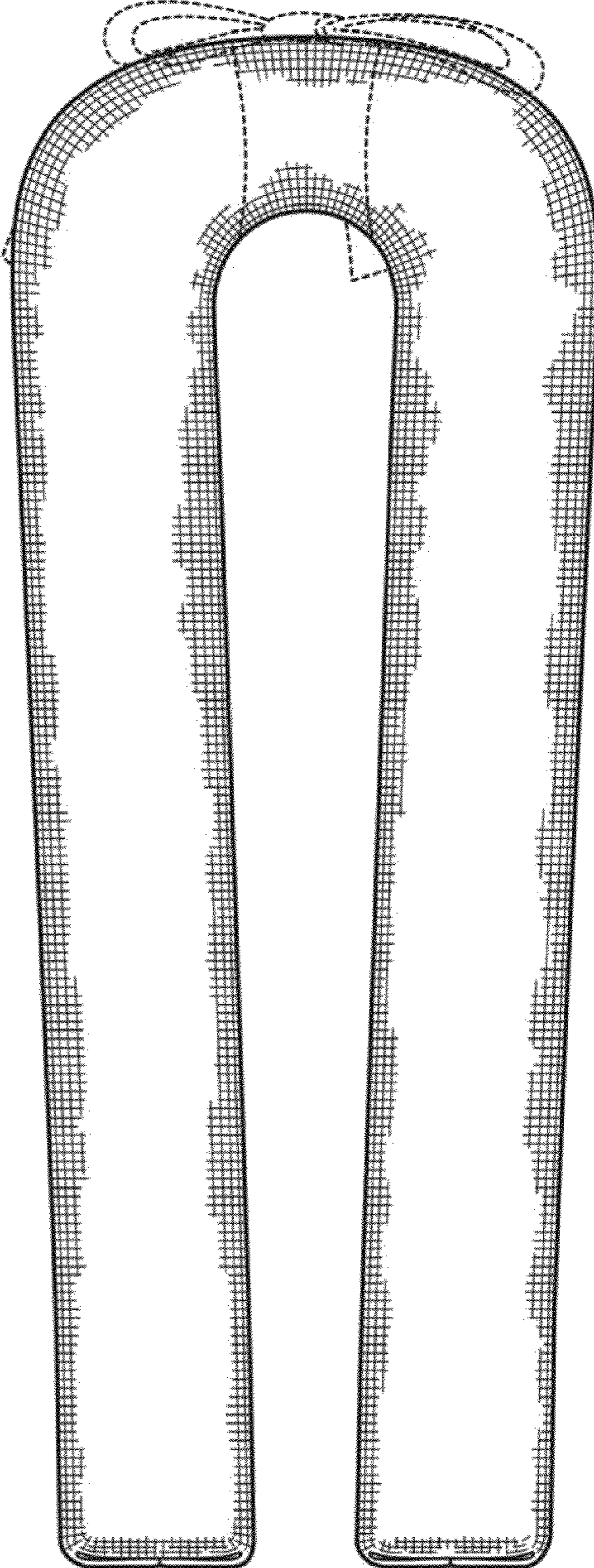

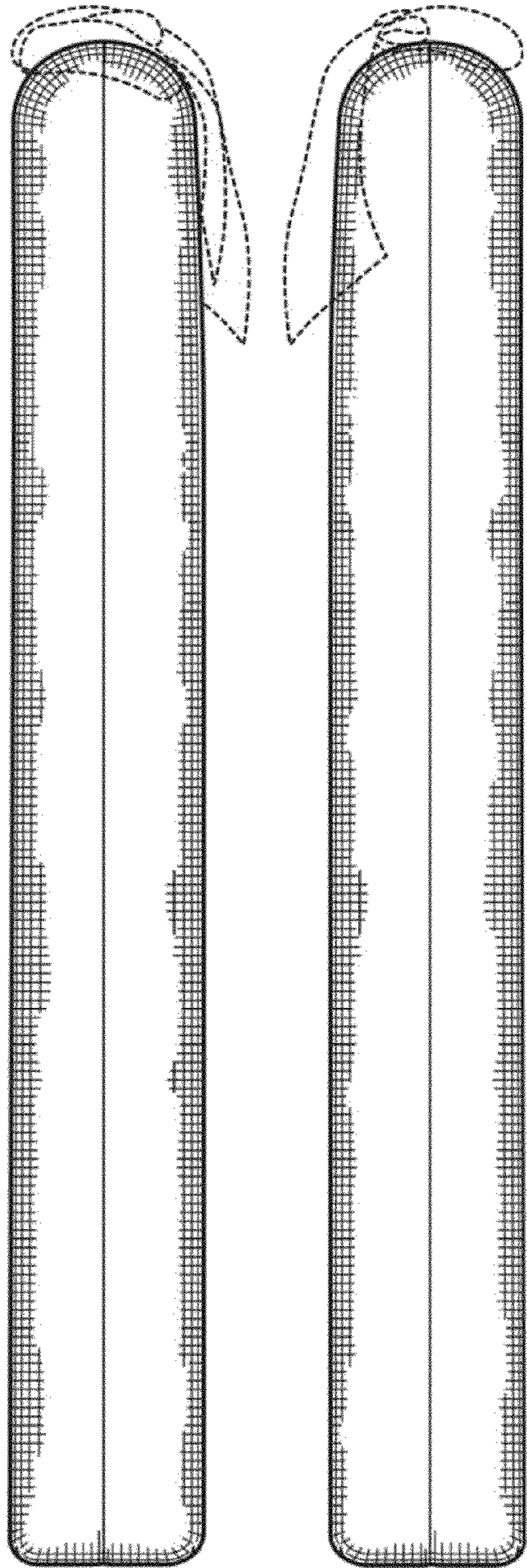

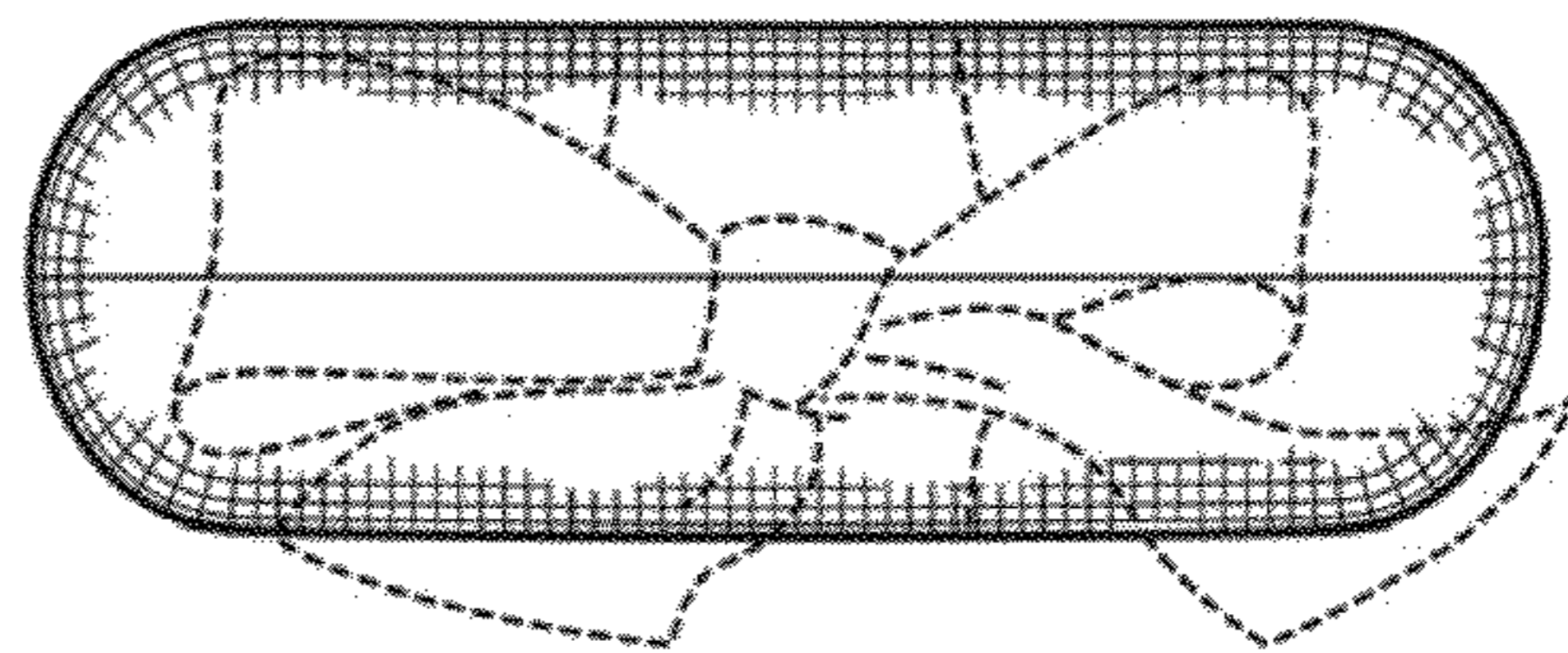

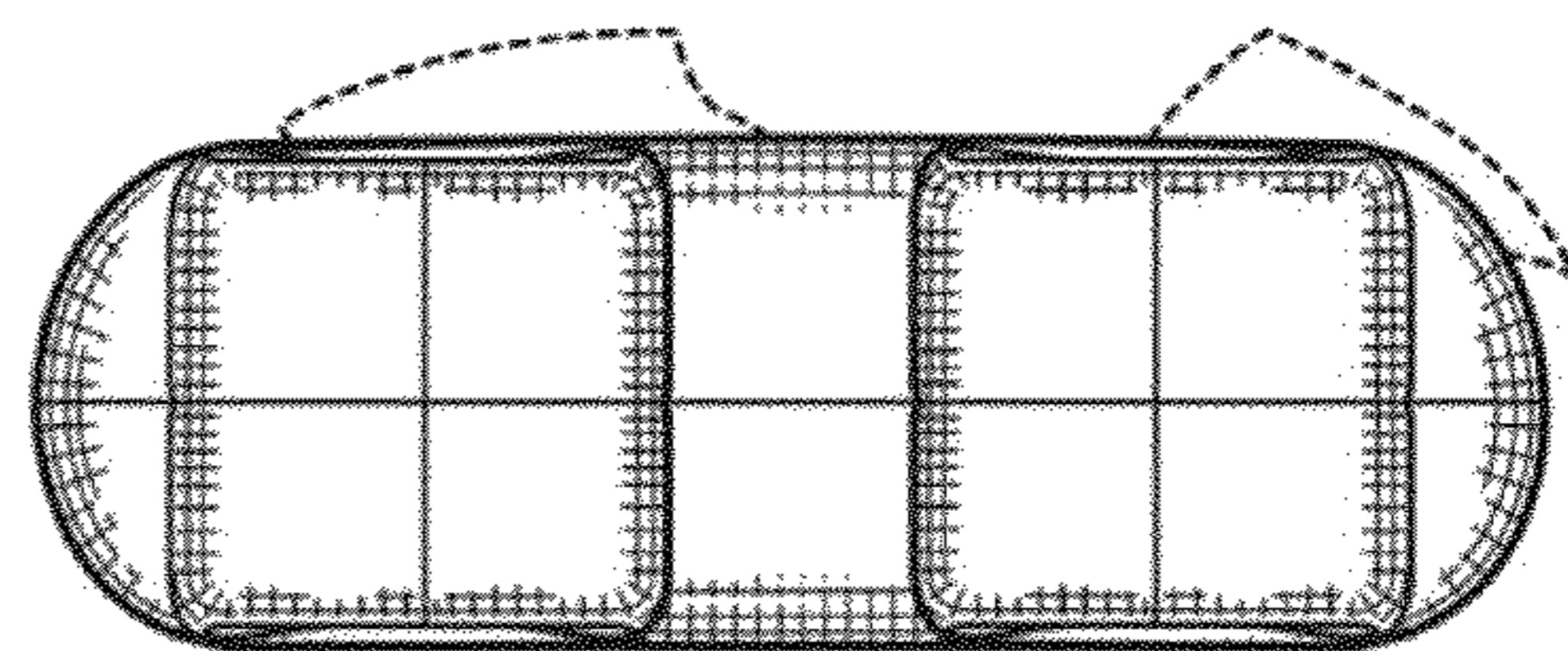
