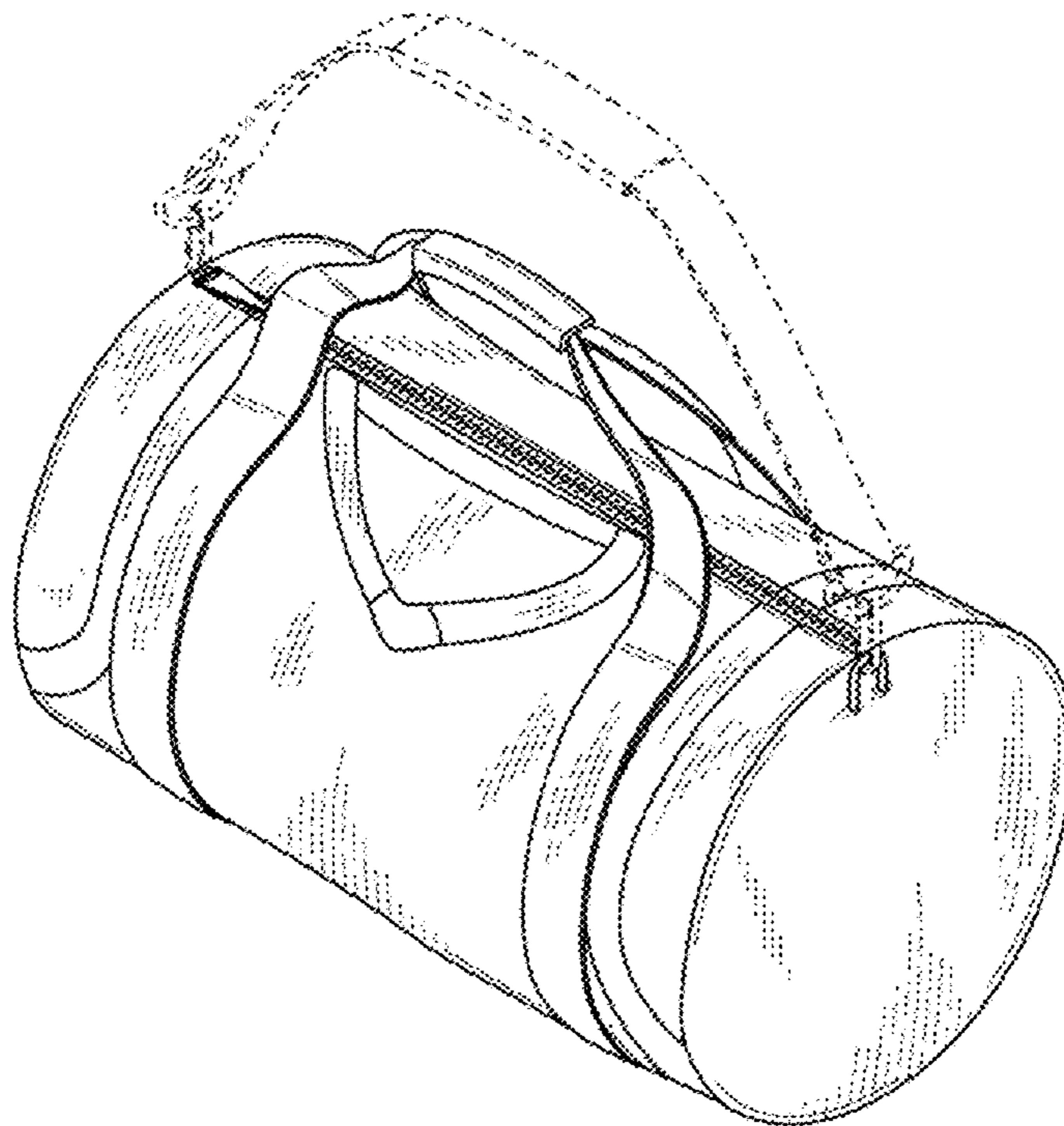
(57) **CLAIM**

The ornamental design for a duffel bag, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a duffel bag showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a back view thereof;
FIG. 4 is a side view thereof, the opposite side view is a mirror-image thereof;
FIG. 5 is a top view thereof; and,
FIG. 6 is a bottom view thereof.
The dash-dot-dot broken lines illustrate portions of the duffel bag and form no part of the claimed design.

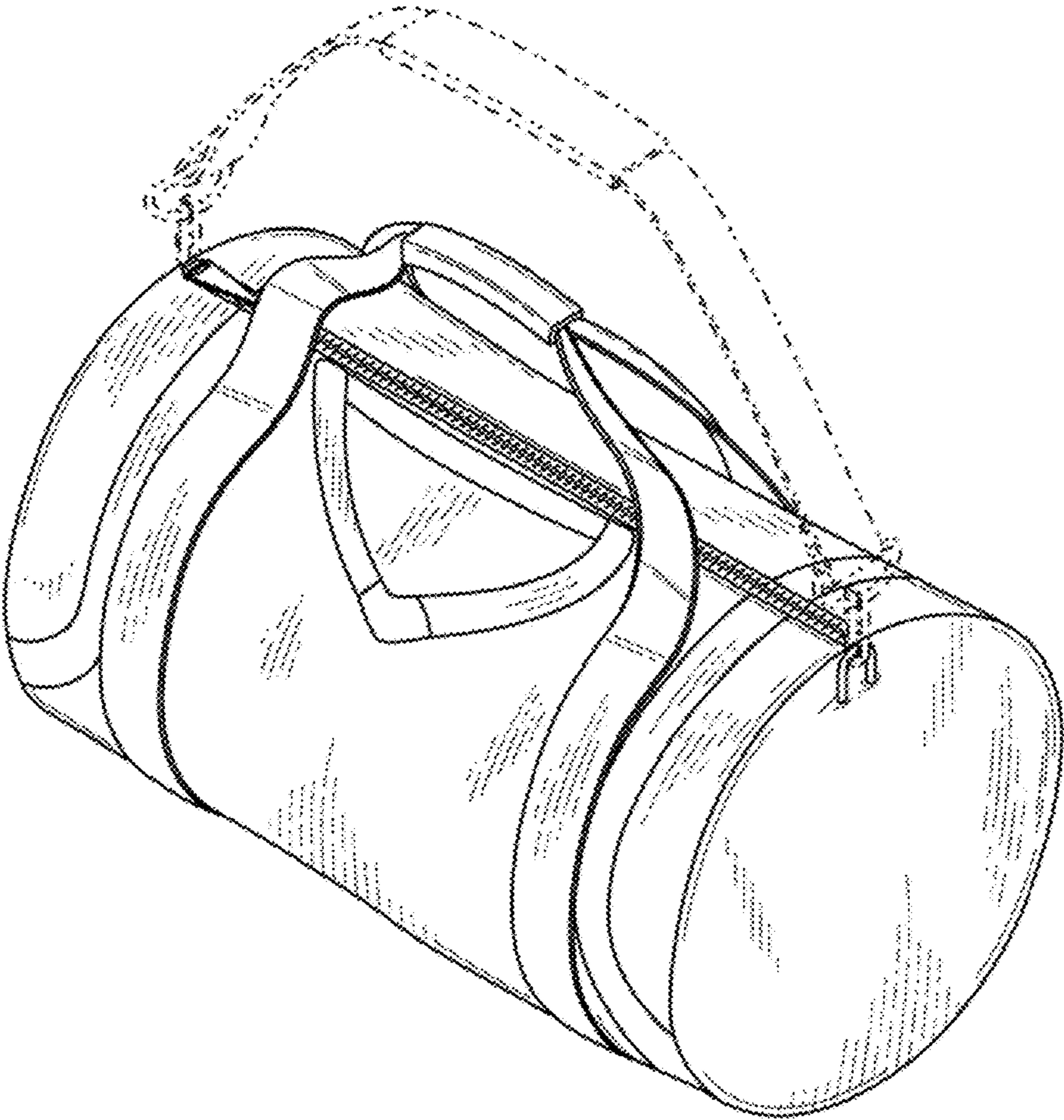

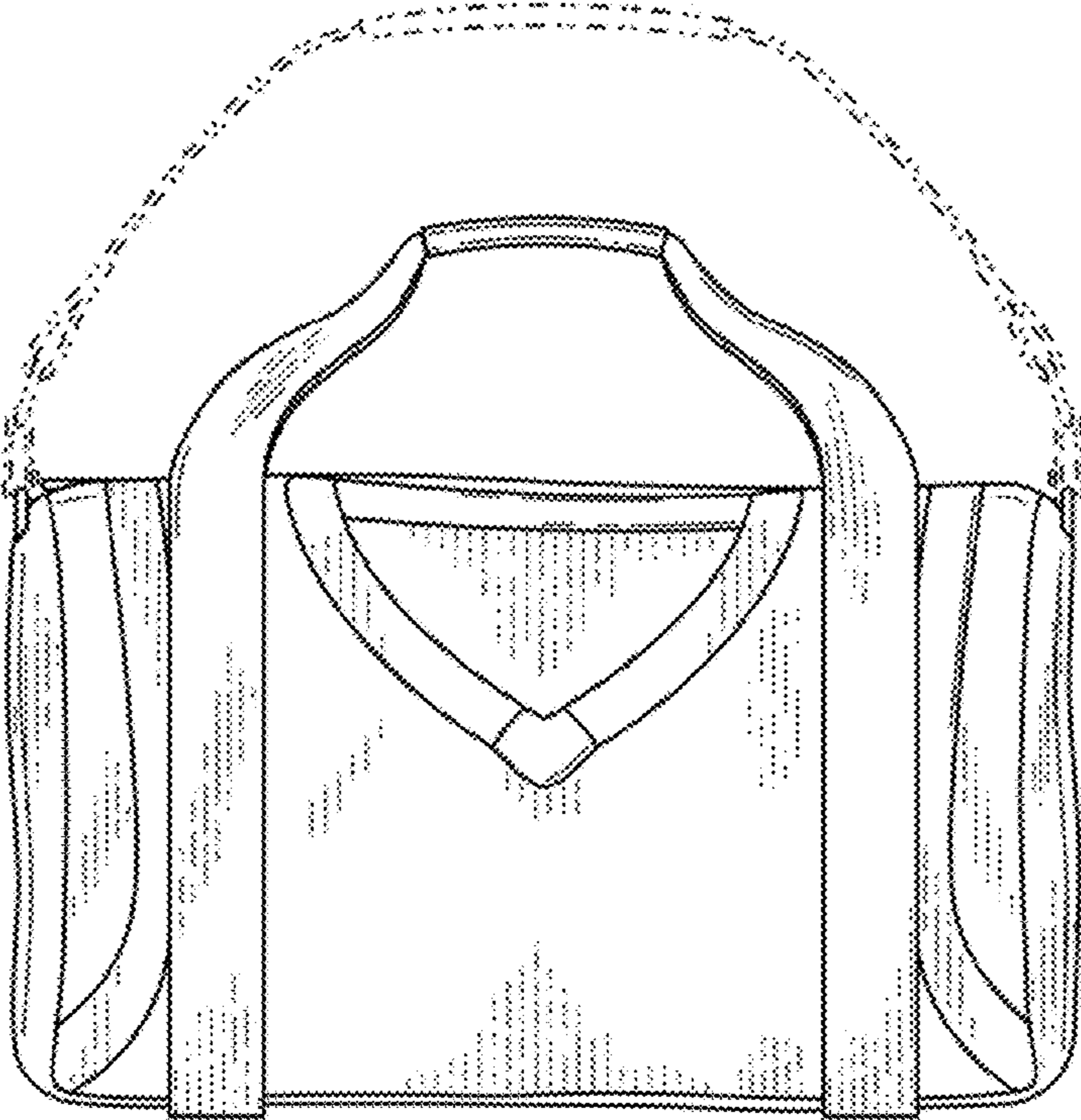

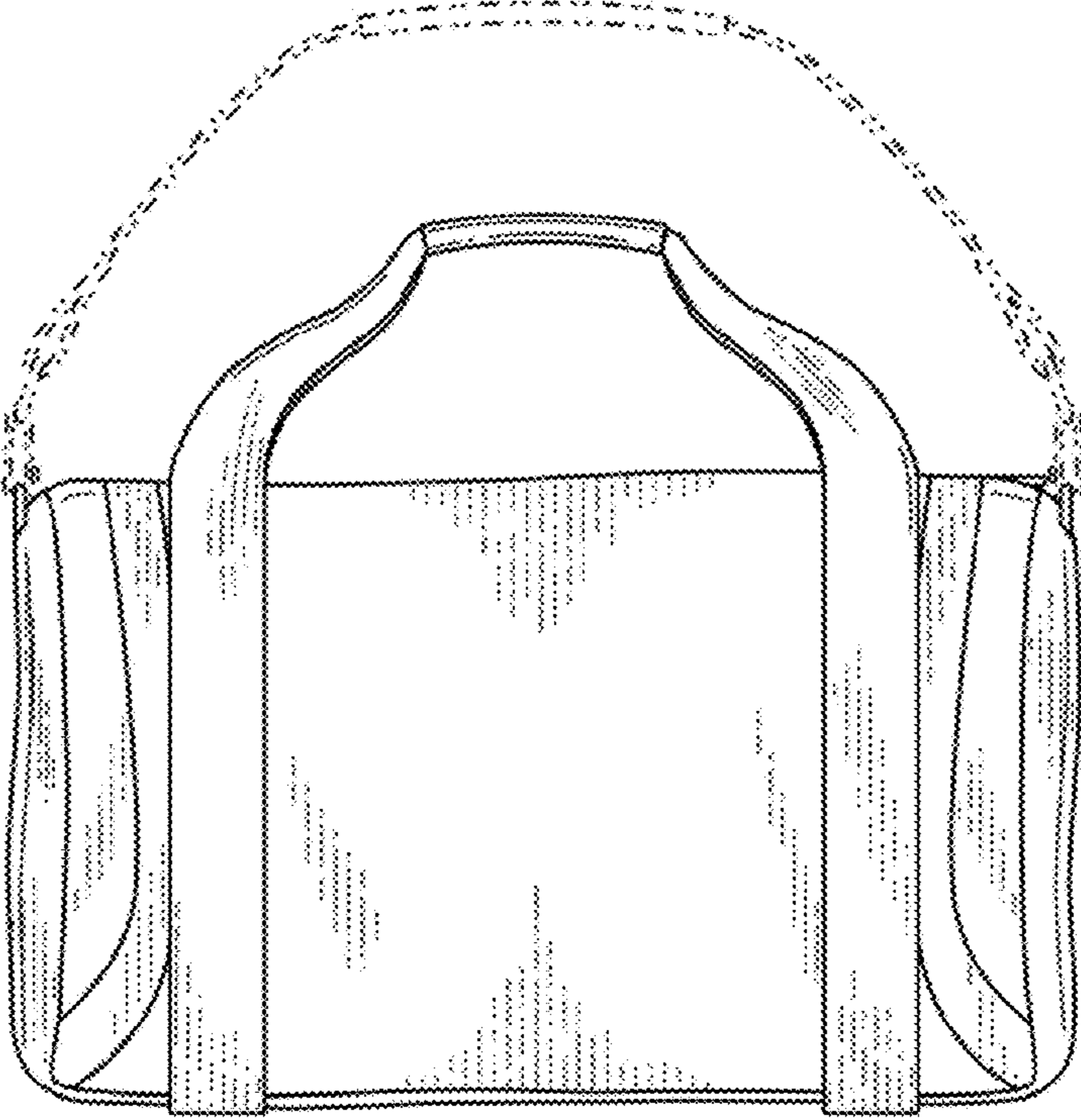

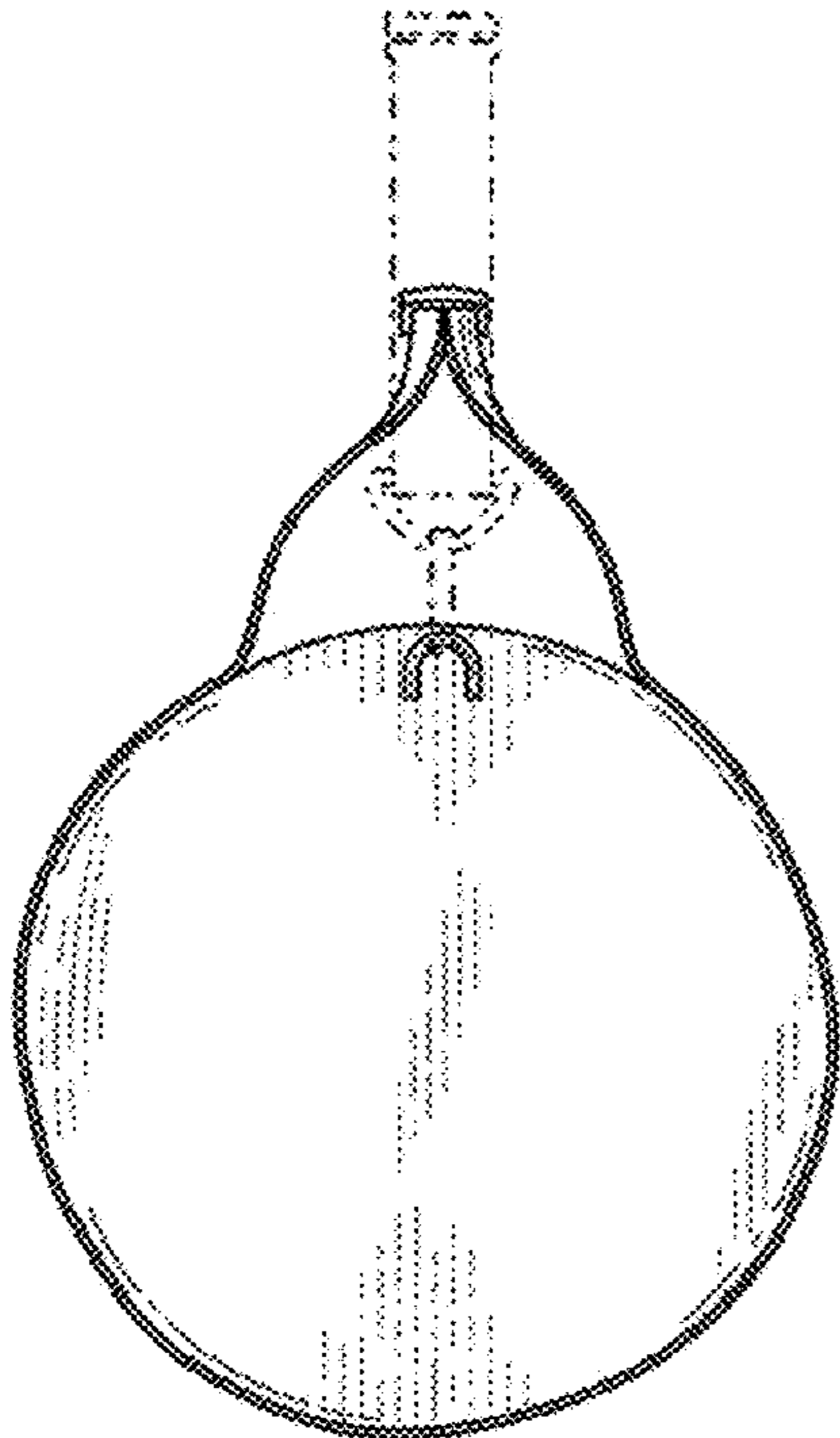

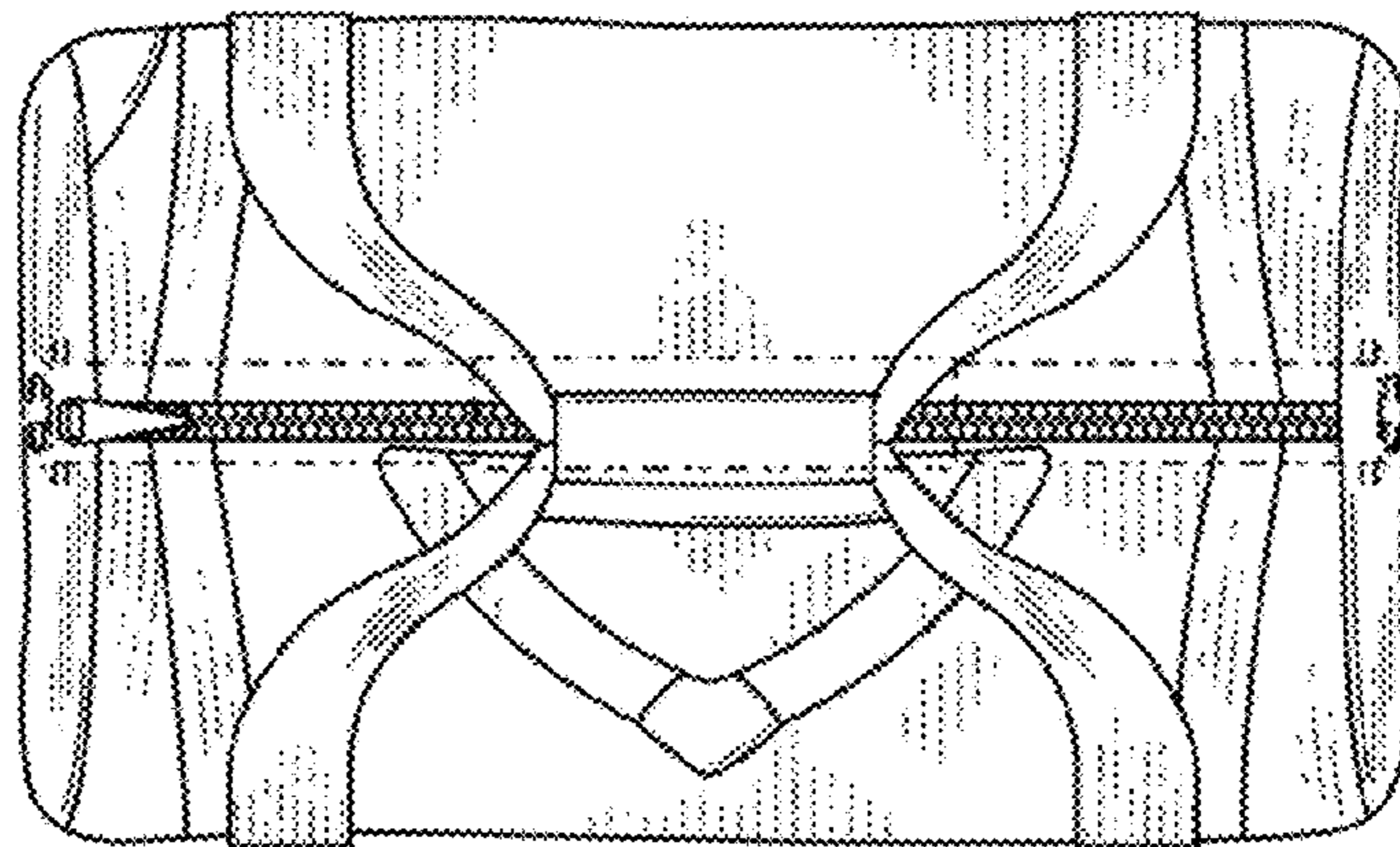

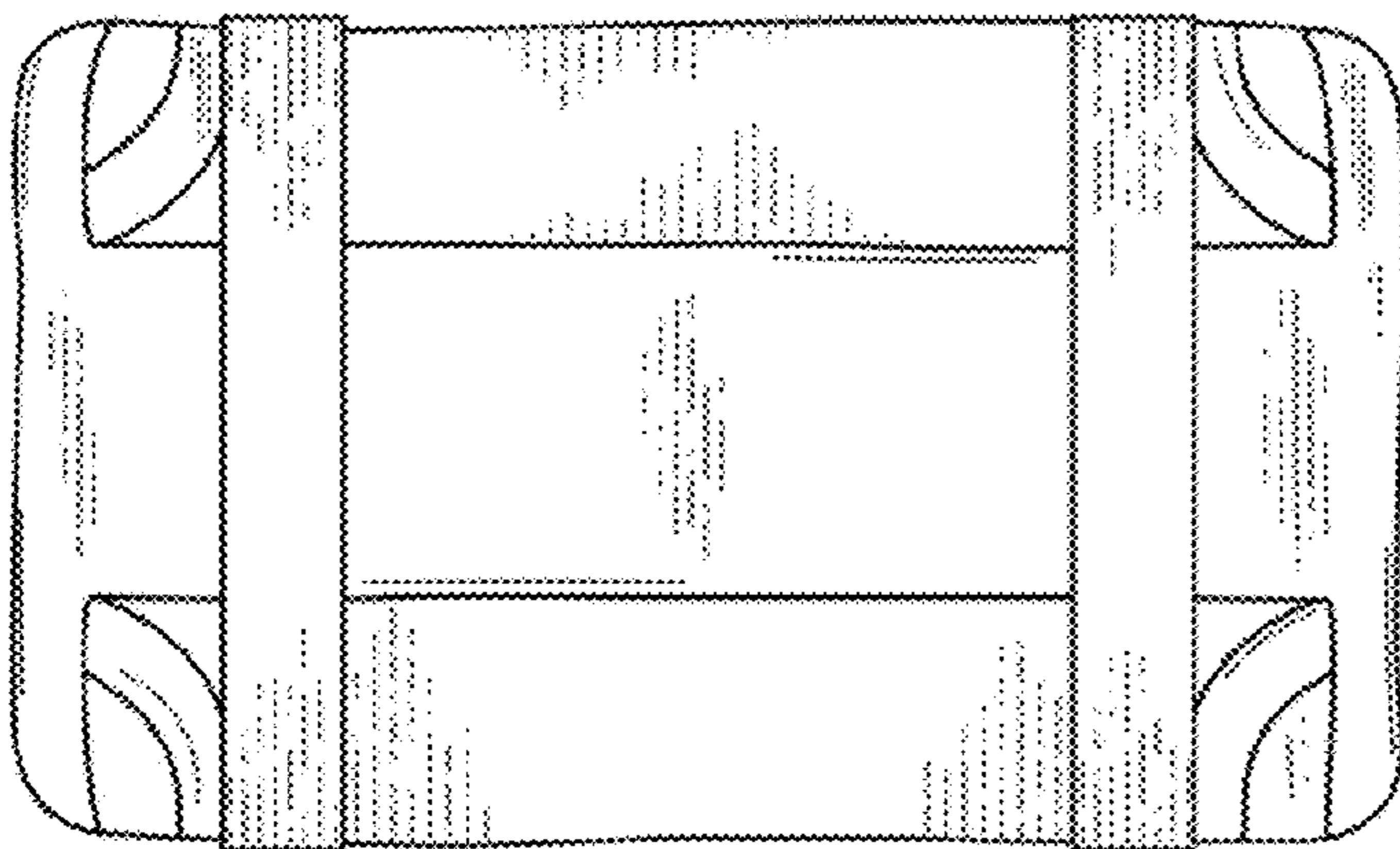
