The ornamental design for a jersey-shaped towel, as shown and described.

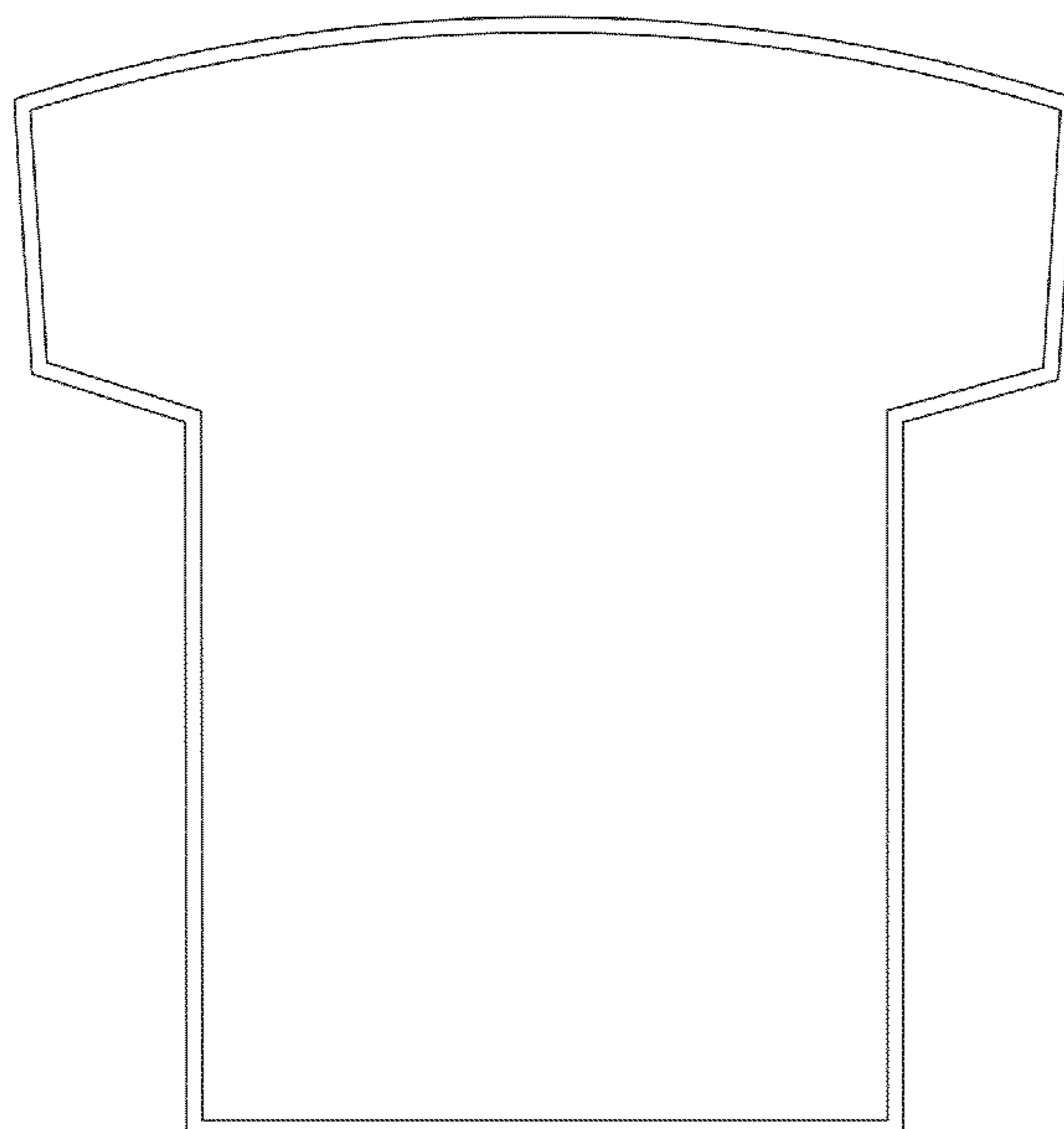
DESCRIPTION

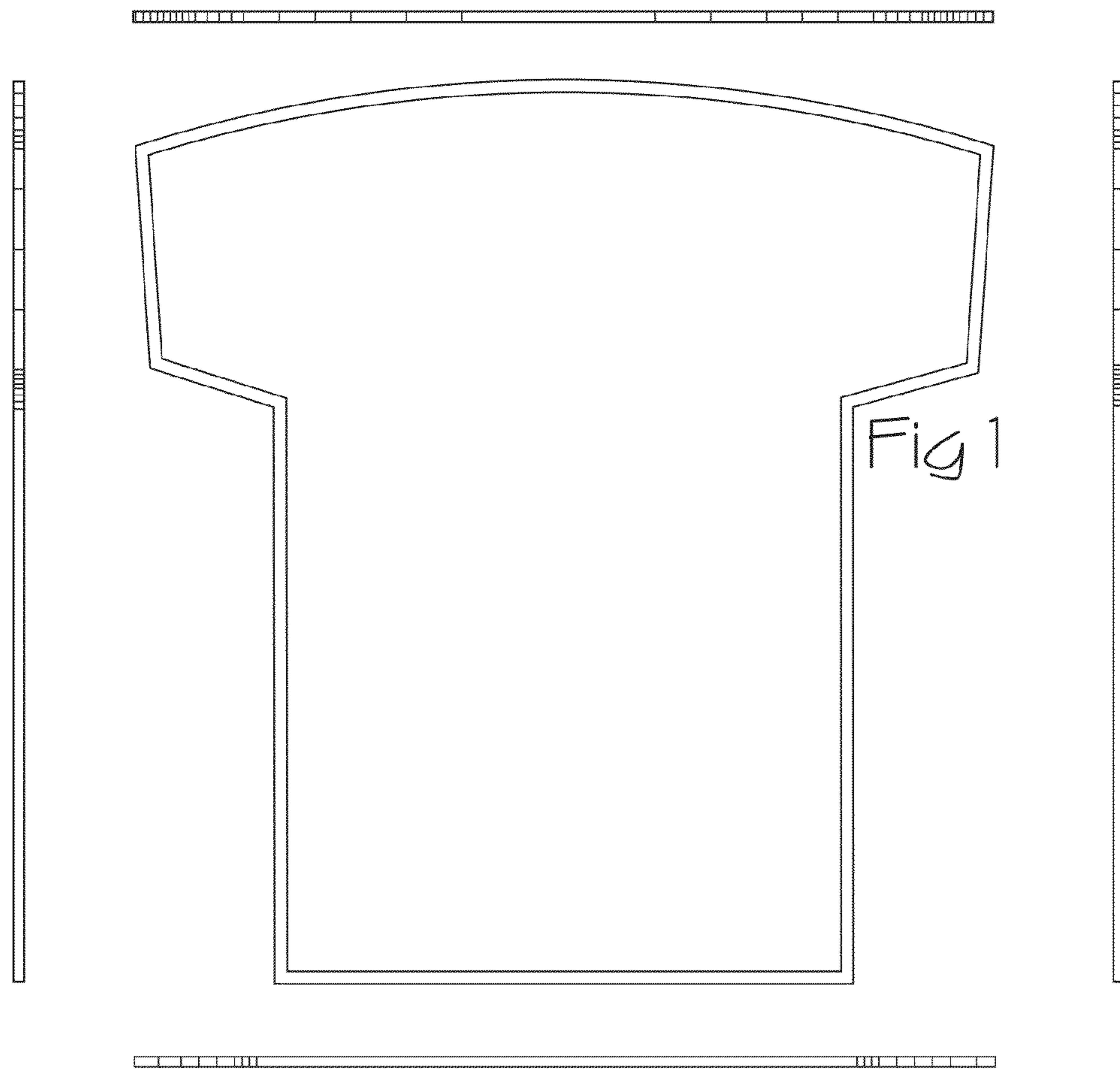

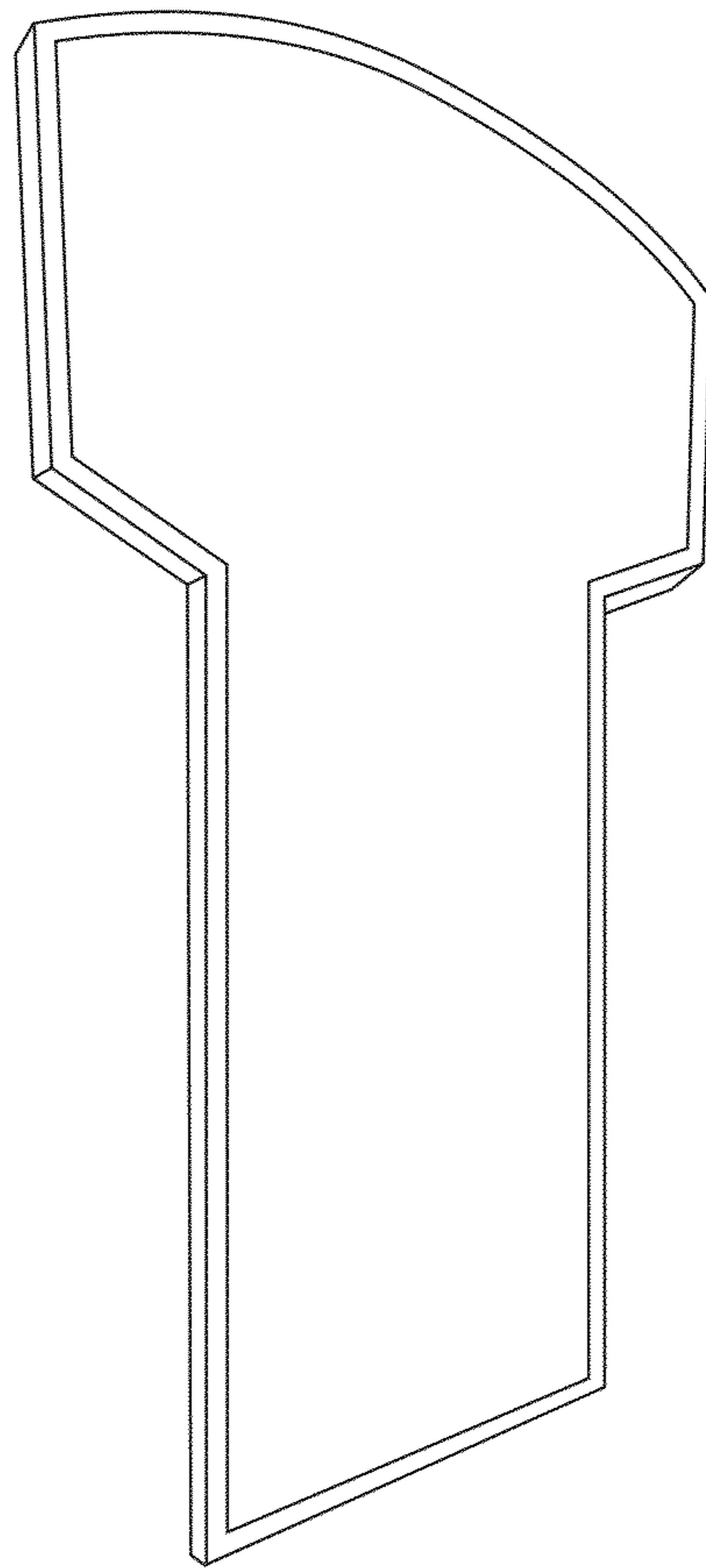
