The ornamental design for a beverage container, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a beverage container showing my new design;

FIG. 2 is a front view thereof, the rear view being a mirror image;

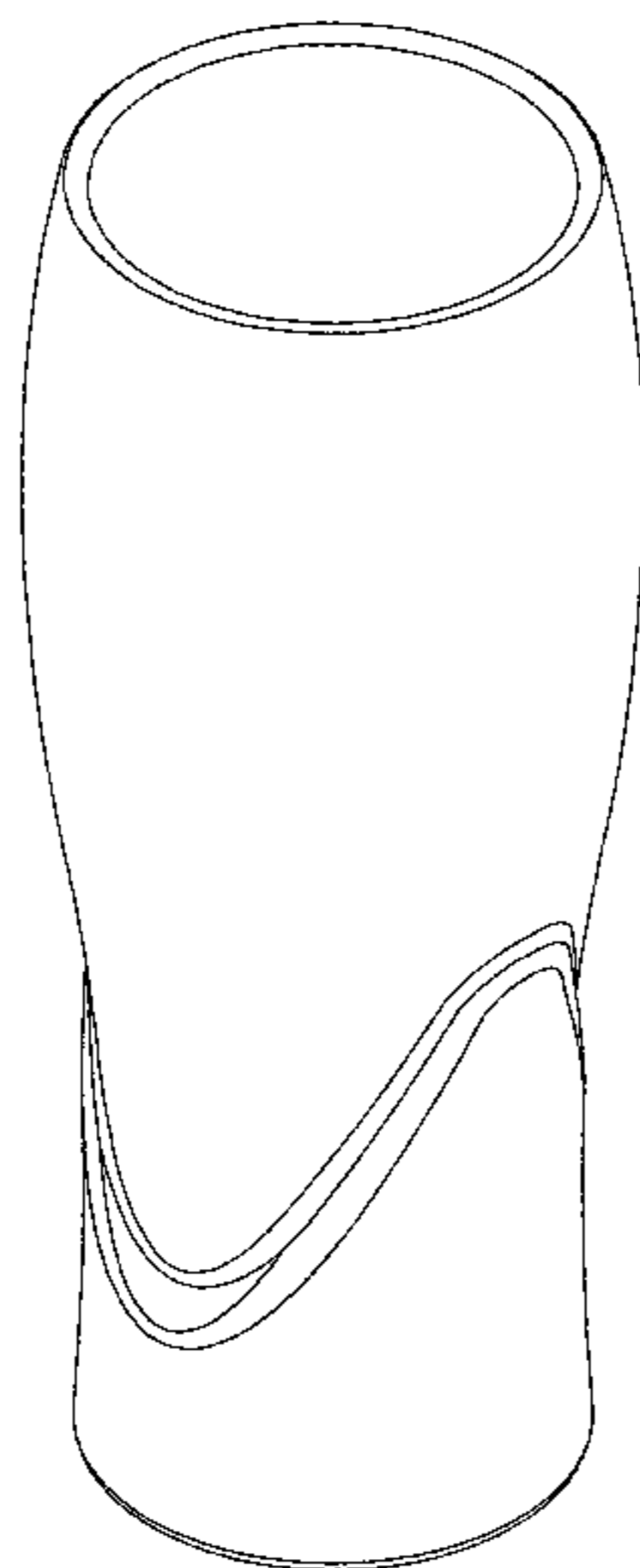
FIG. 3 is a right side view of the beverage container of FIG. 1, the left side being a mirror image;

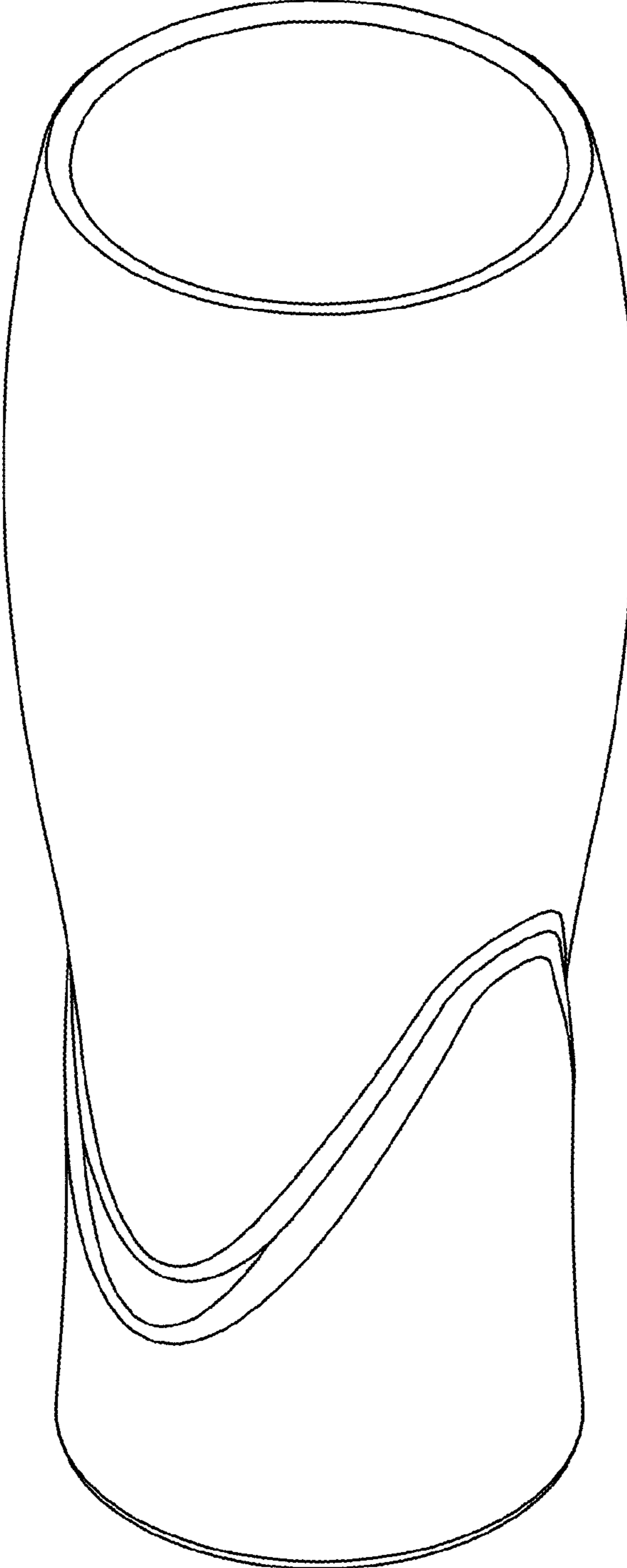

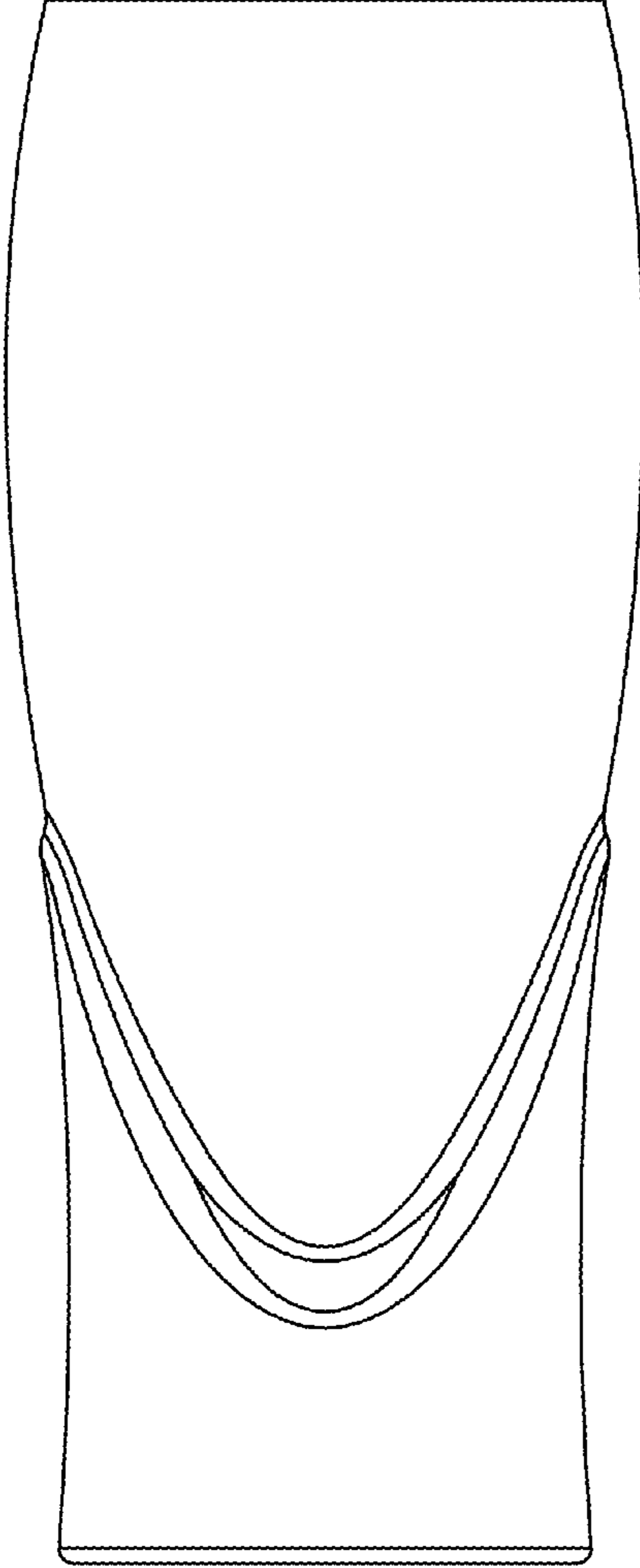

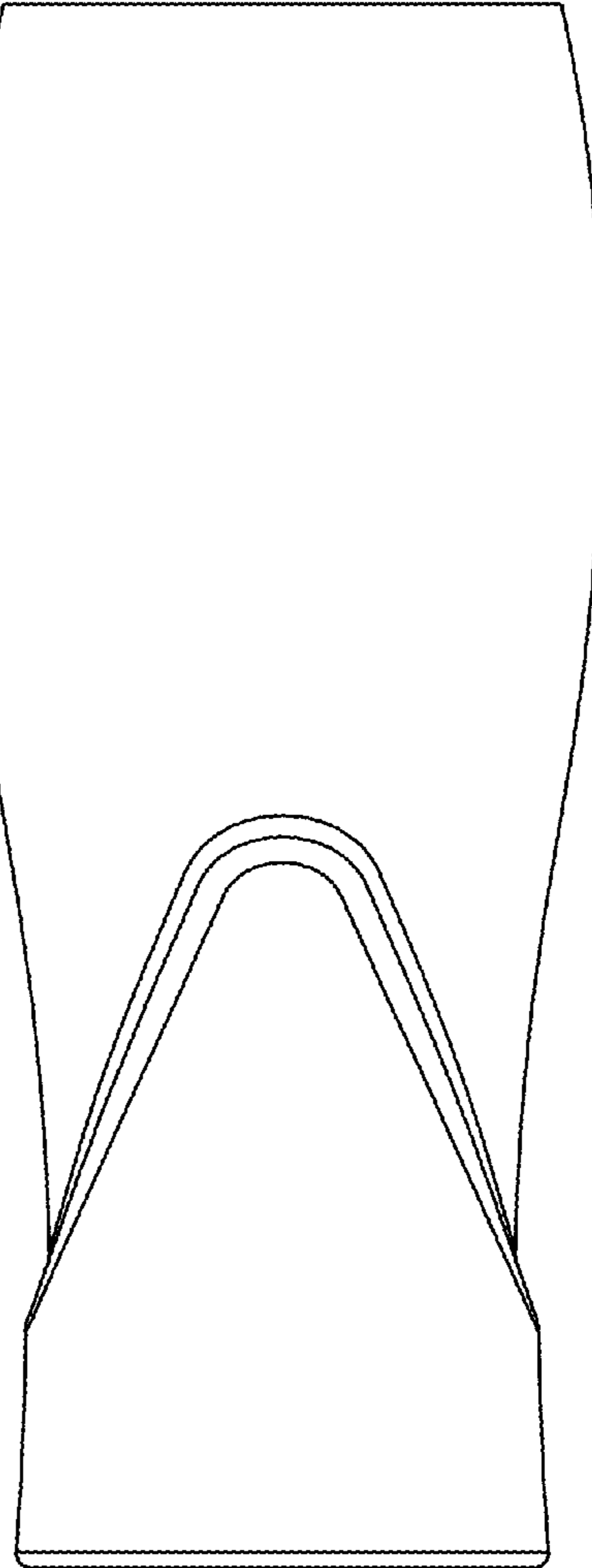
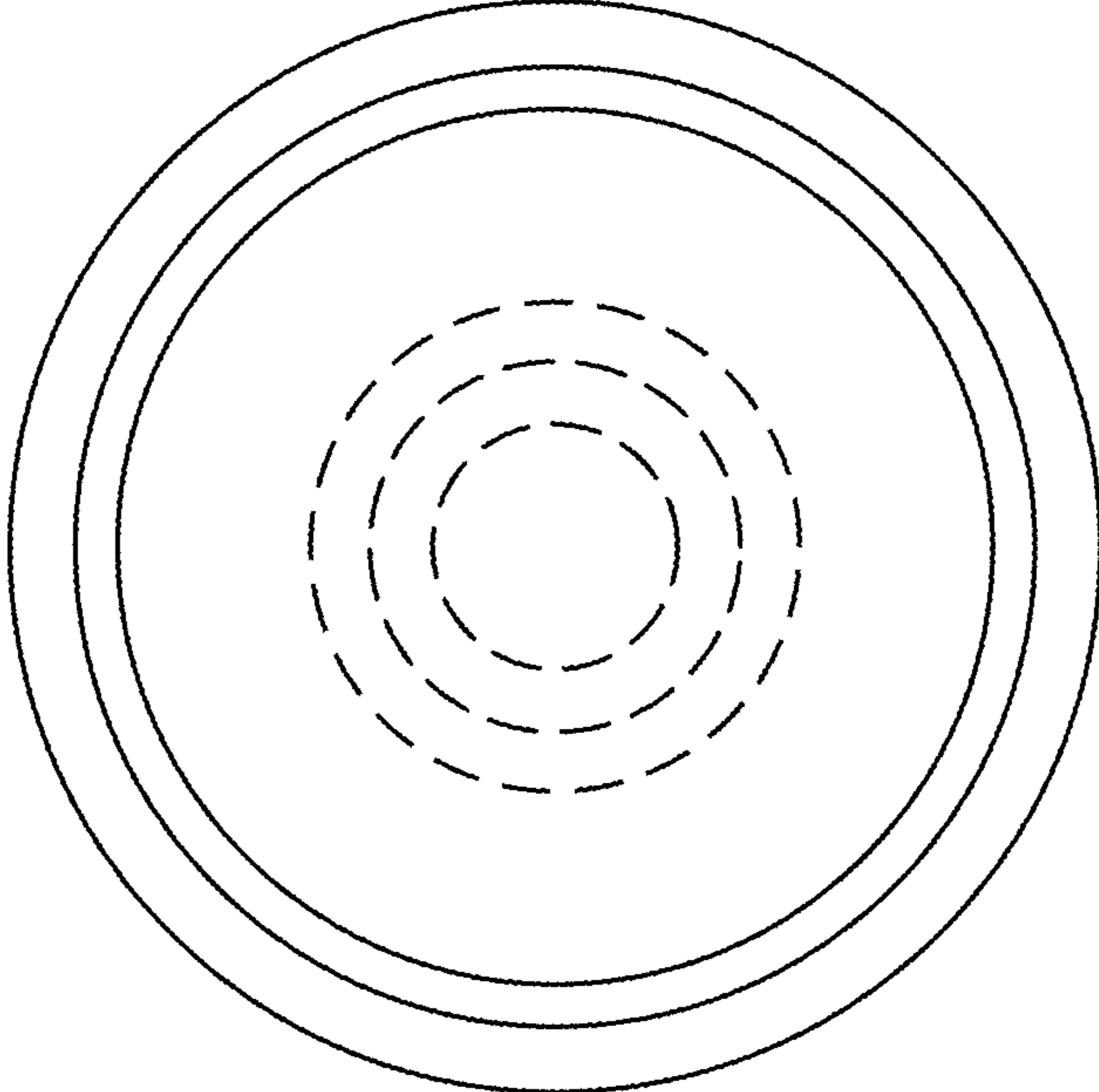
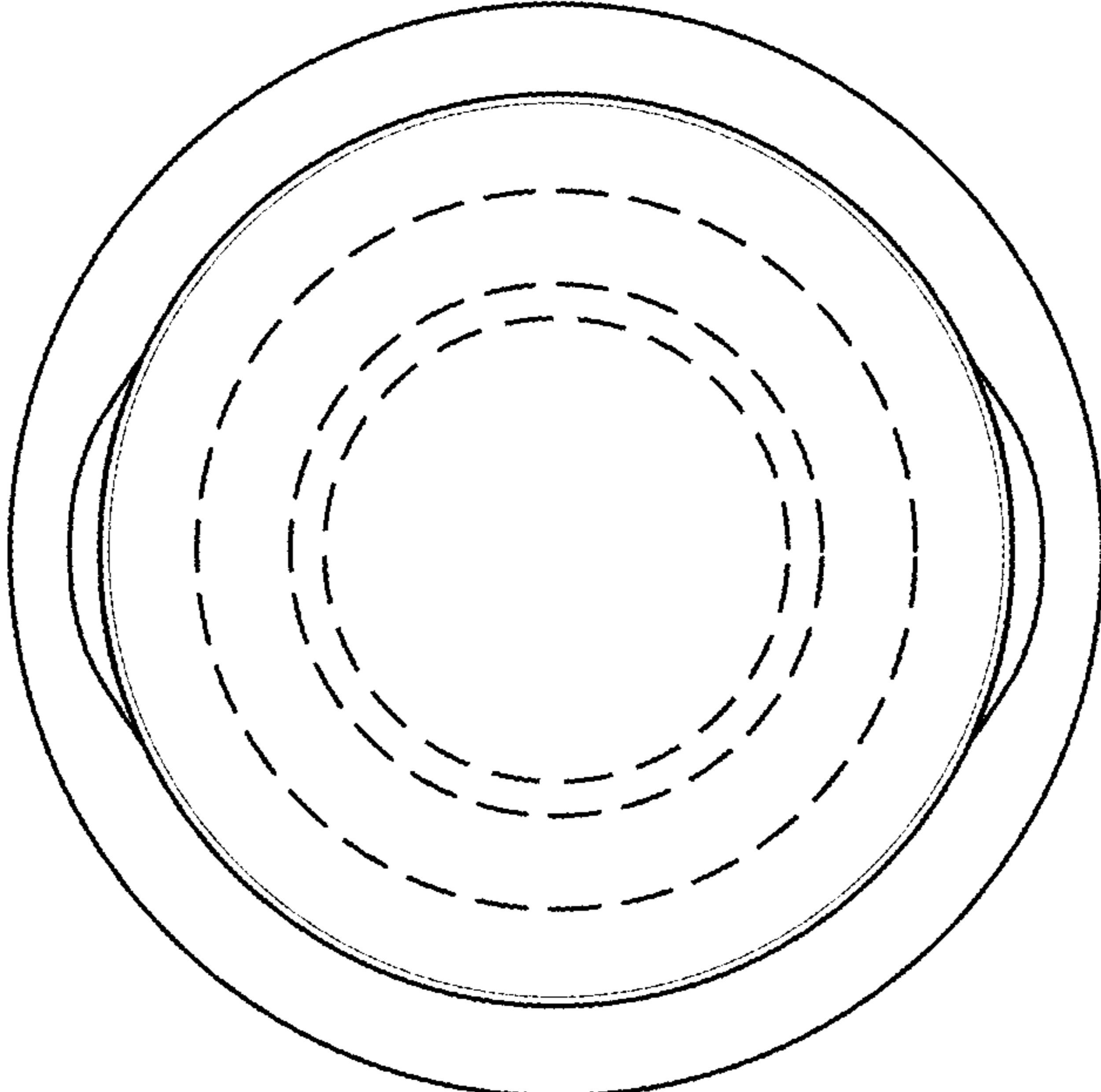
