**DESCRIPTION**

FIG. 1 is a top, front, left perspective view of a container showing our new design;

FIG. 3 is a right side view thereof;

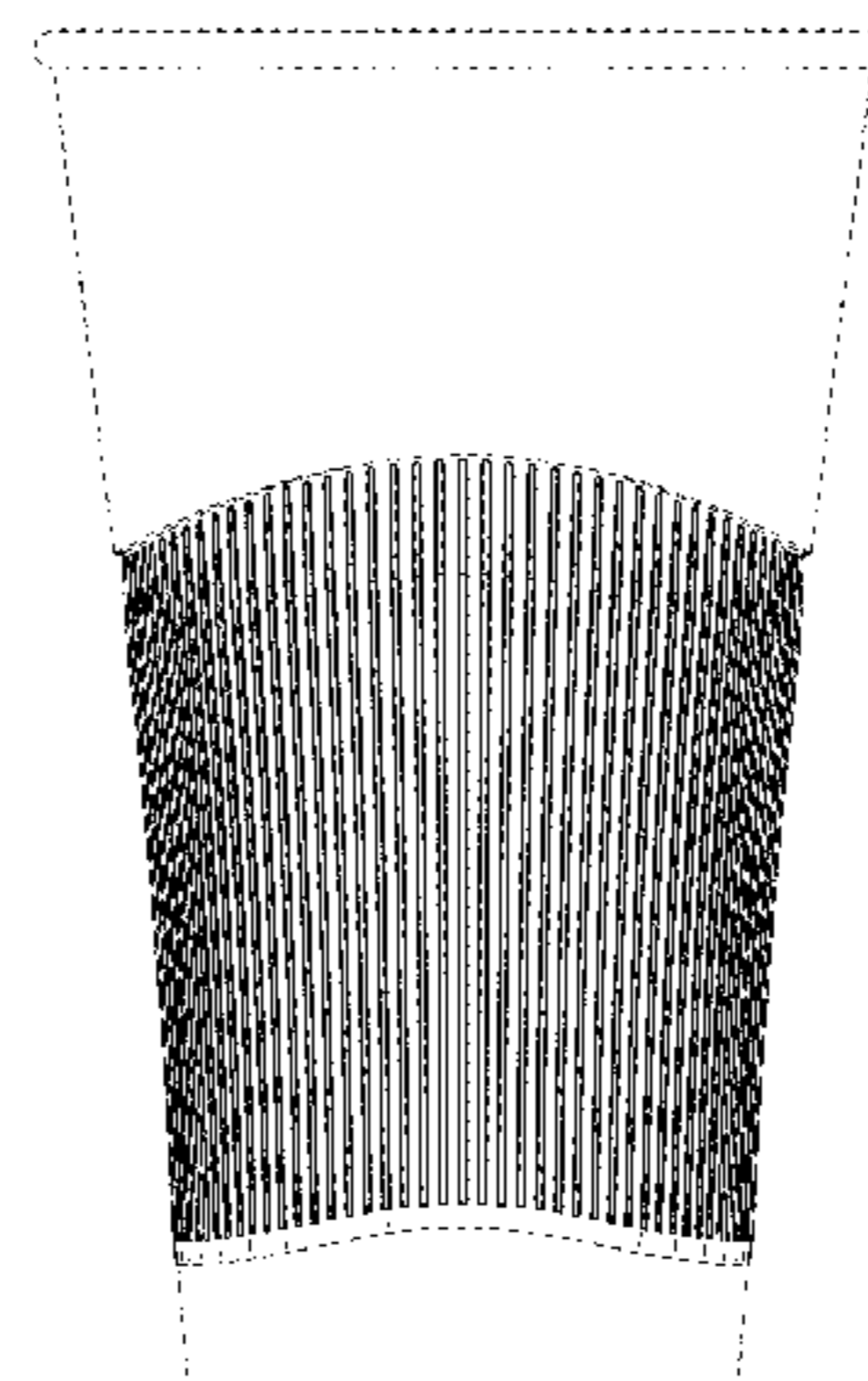
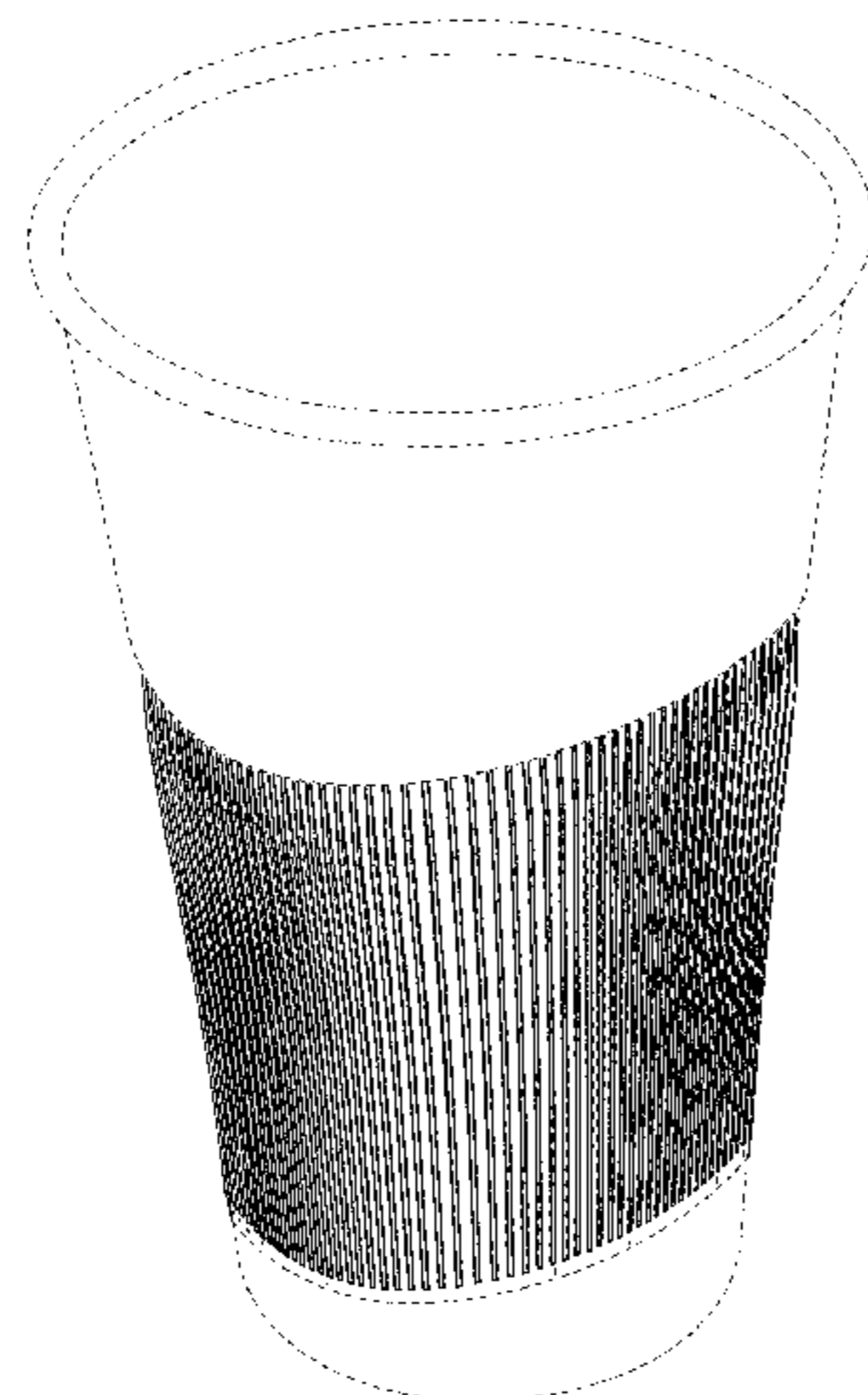
FIG. 4 is a rear view thereof;

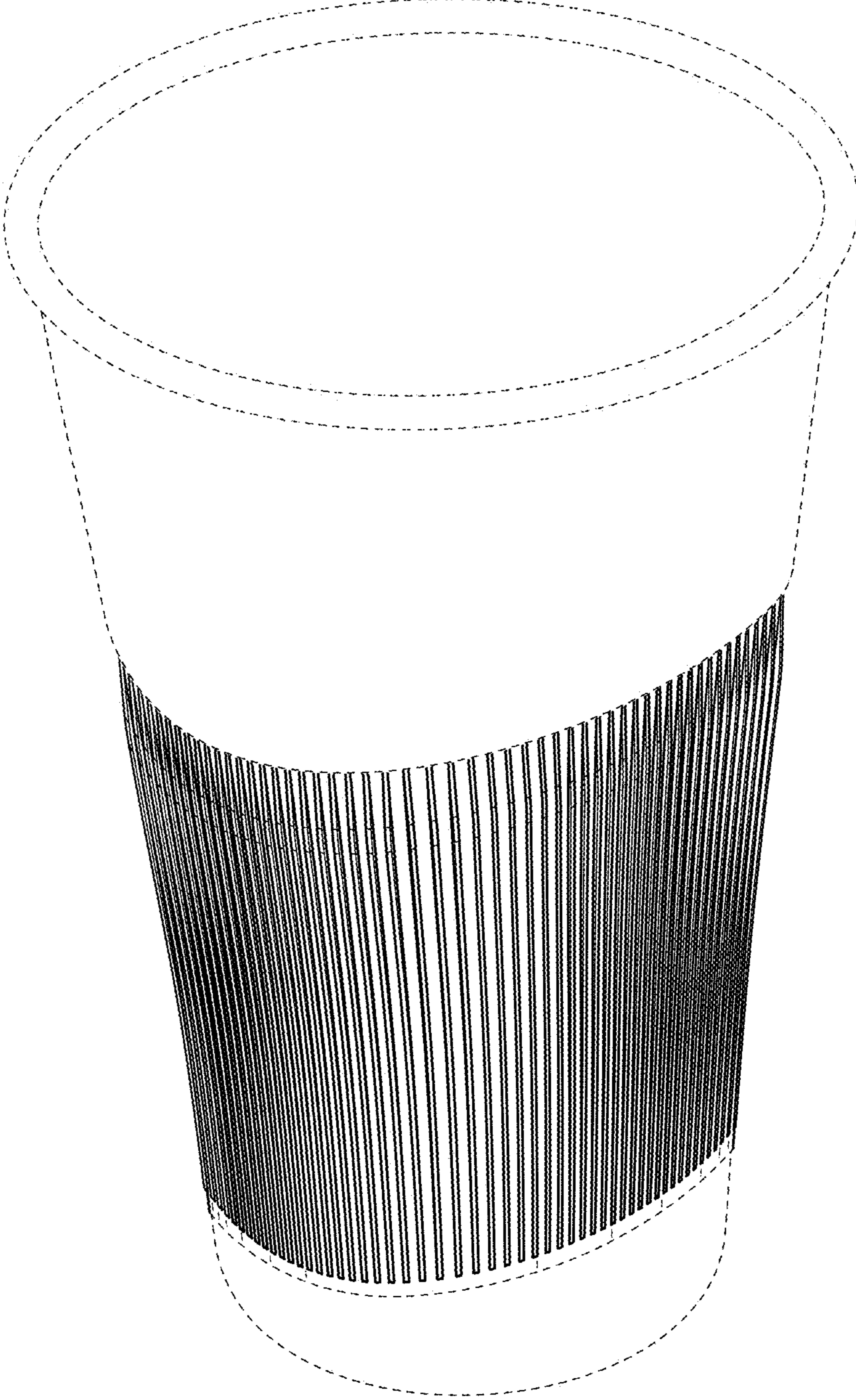

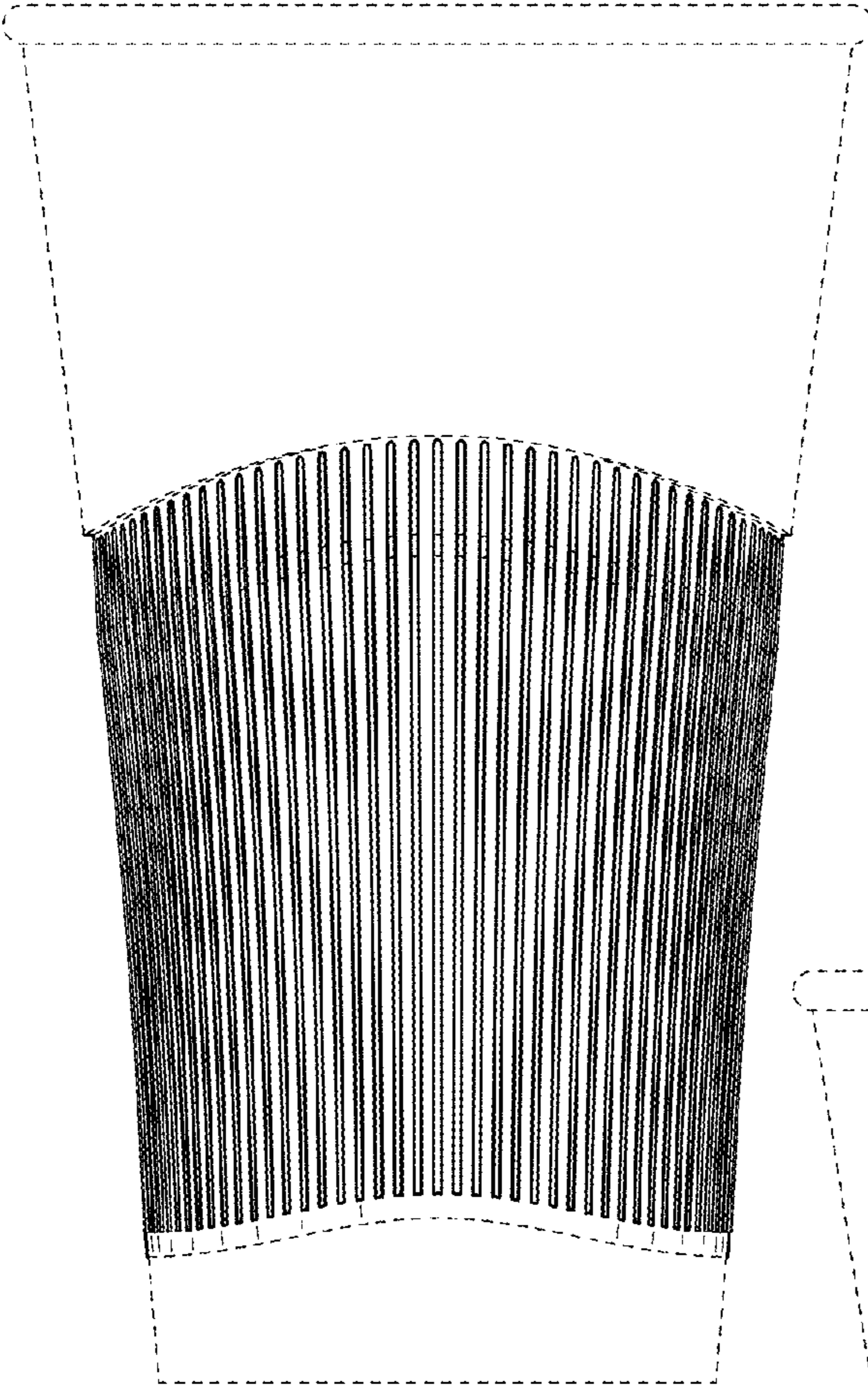

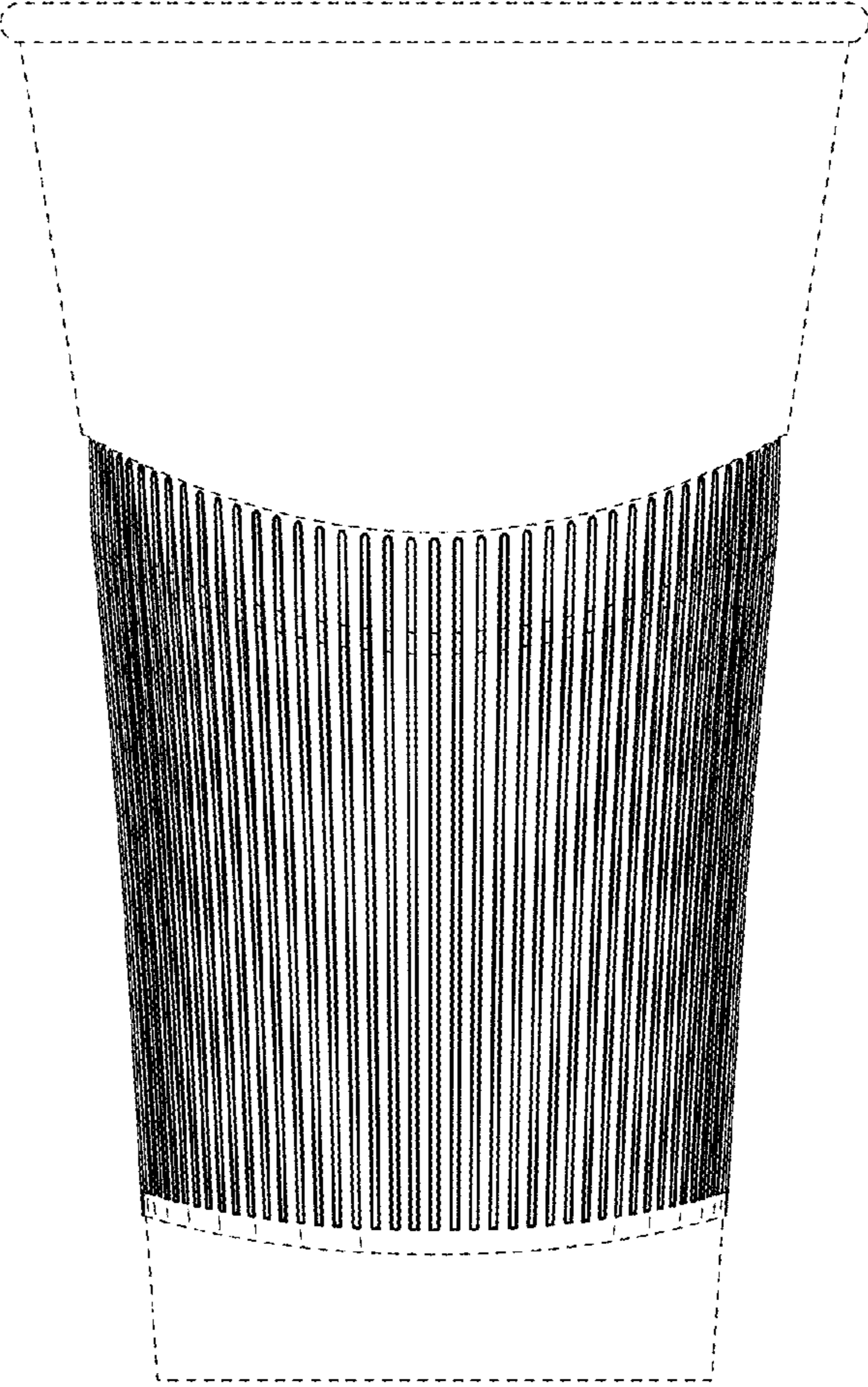

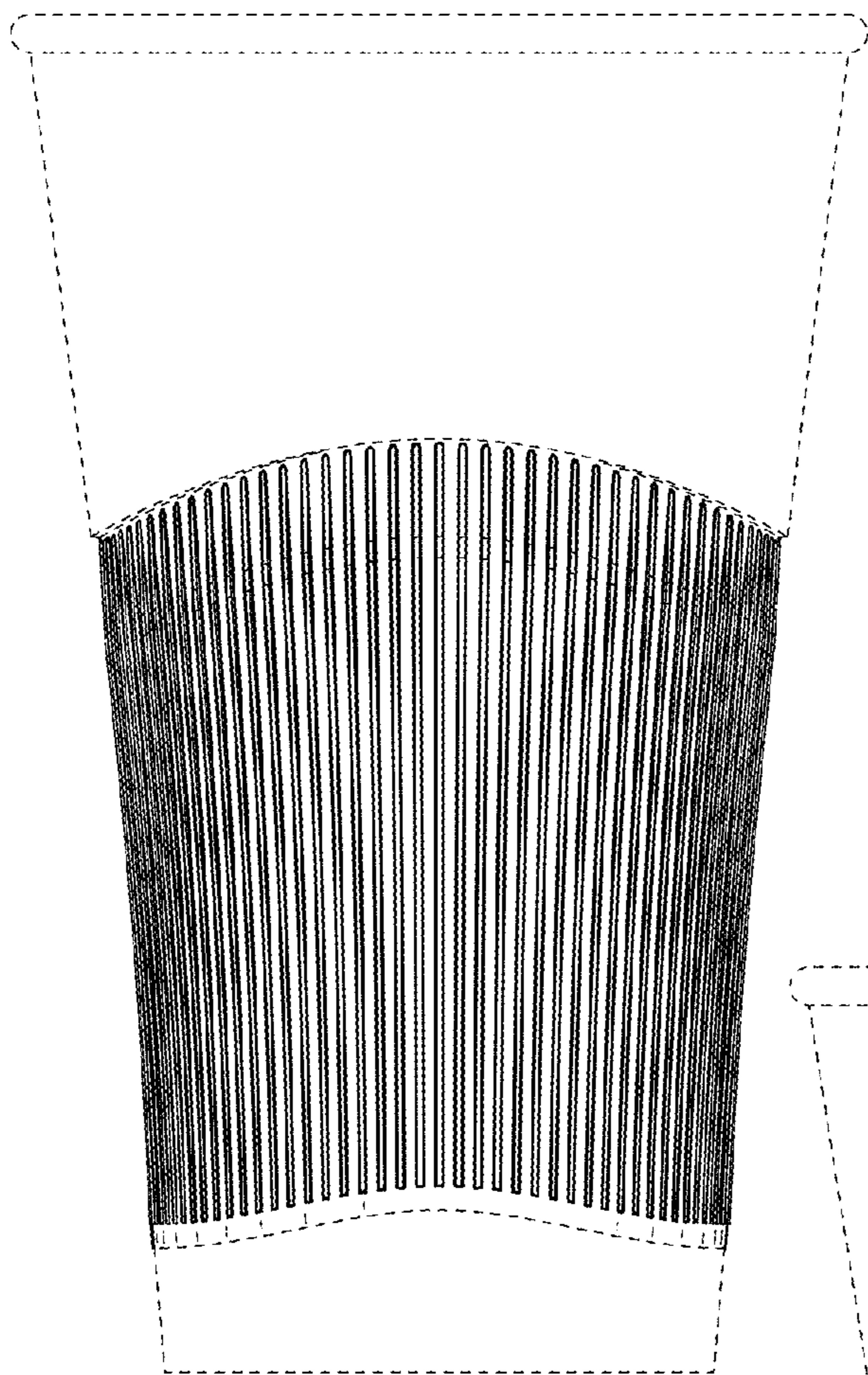

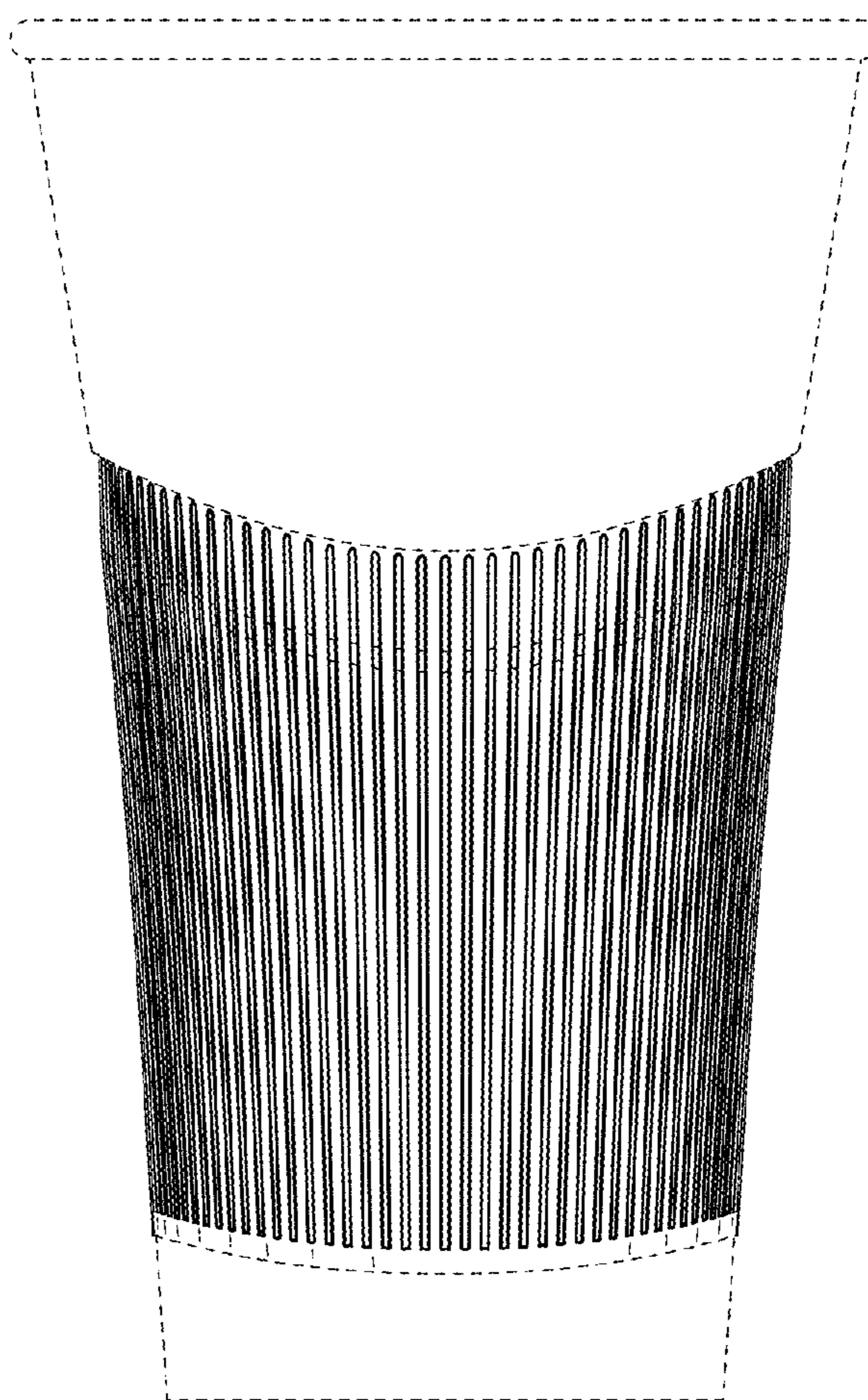
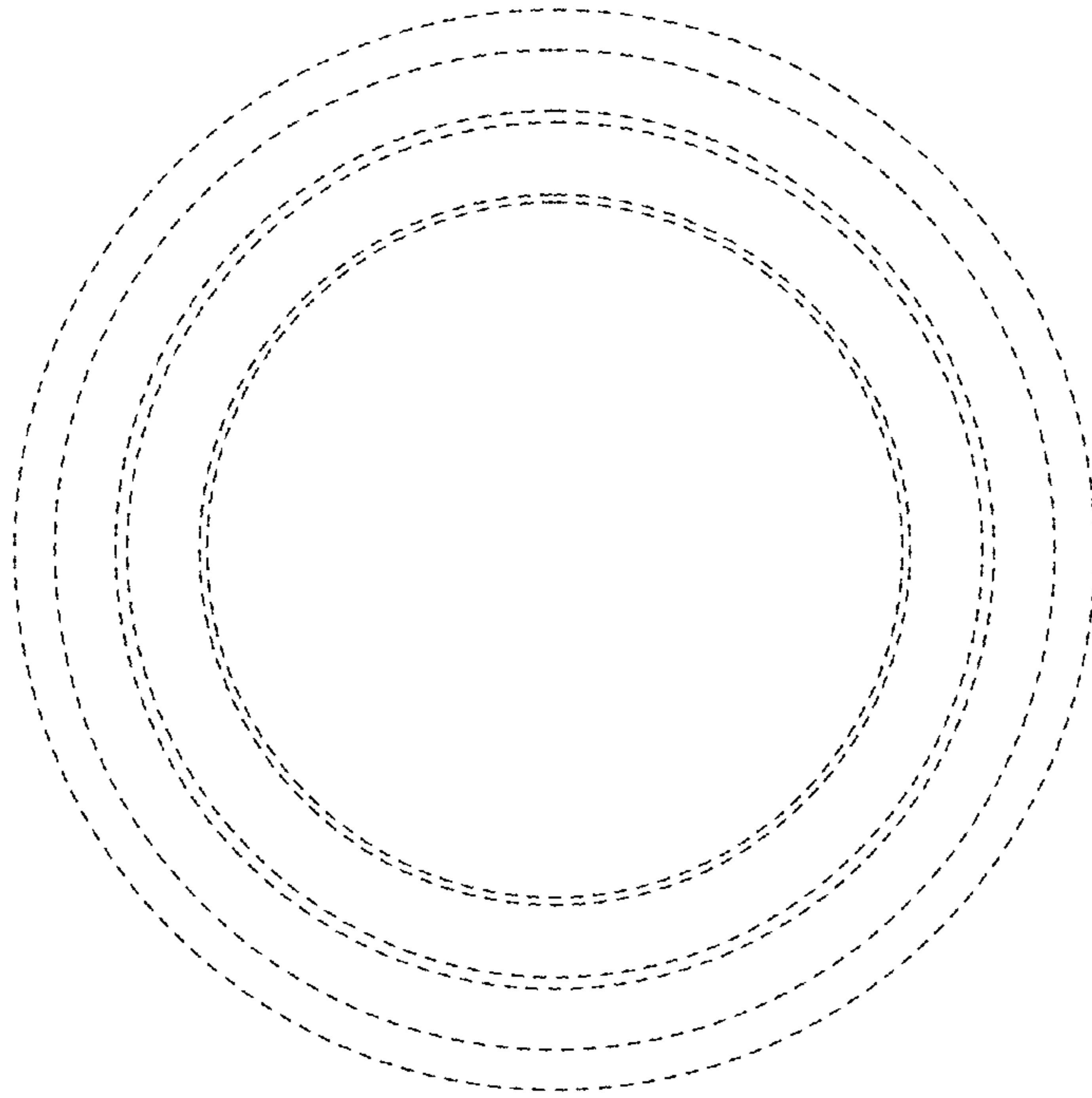
