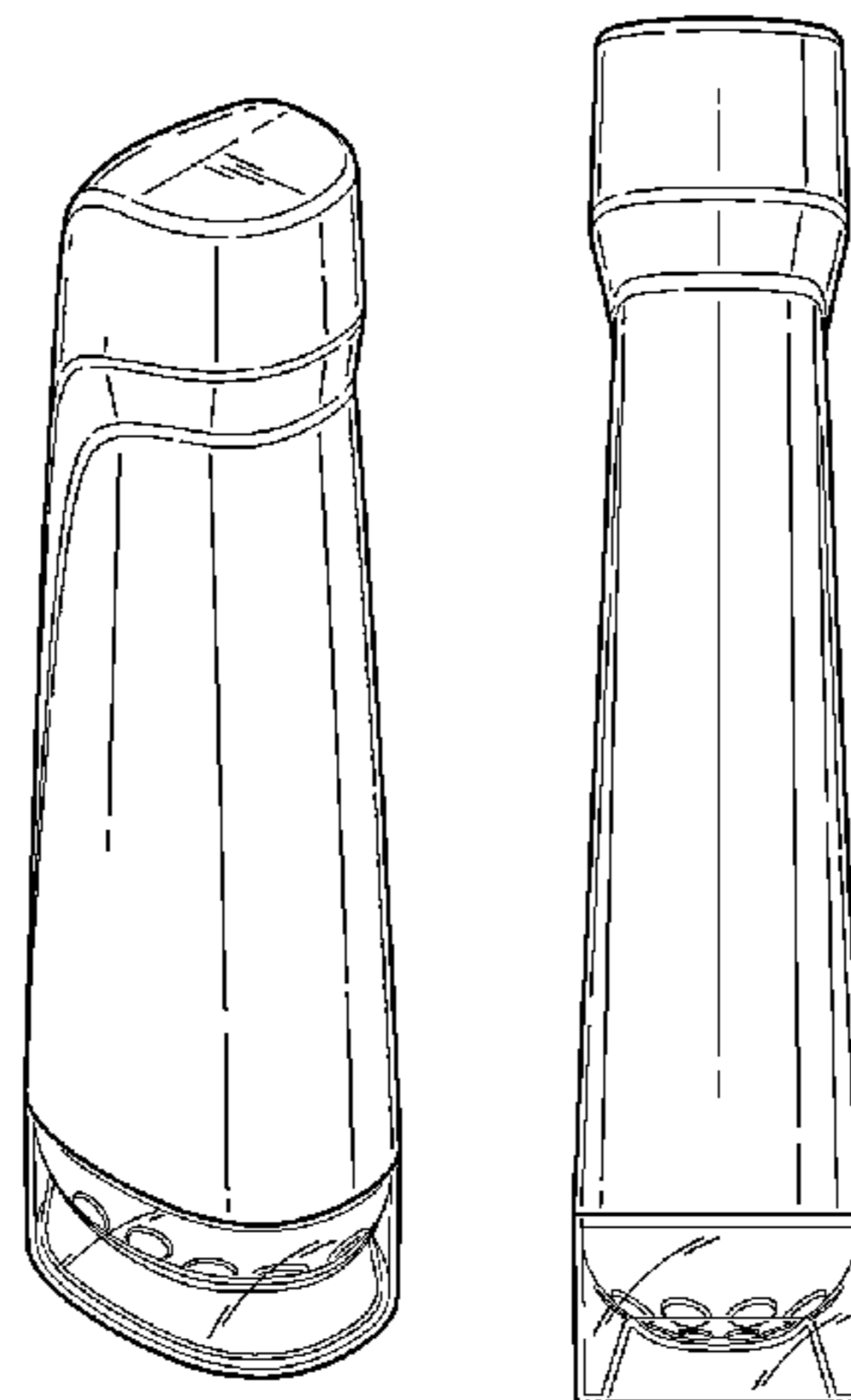
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front and side perspective view of a bottle with cap;

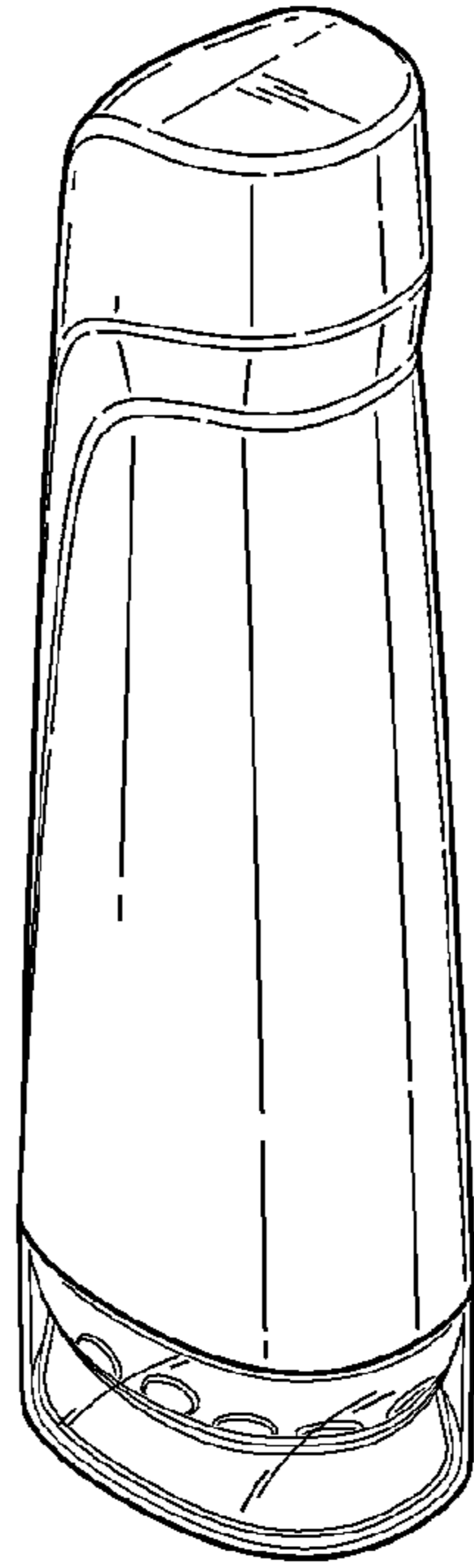

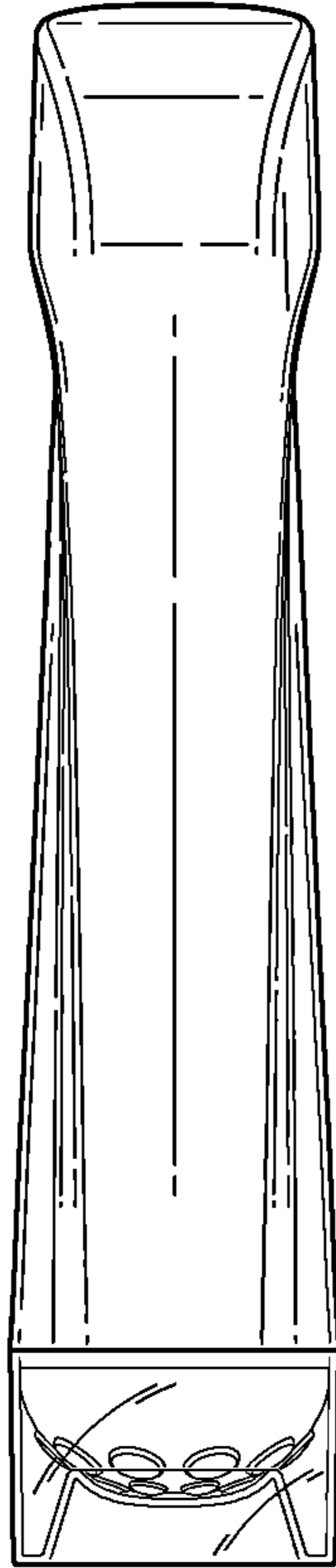

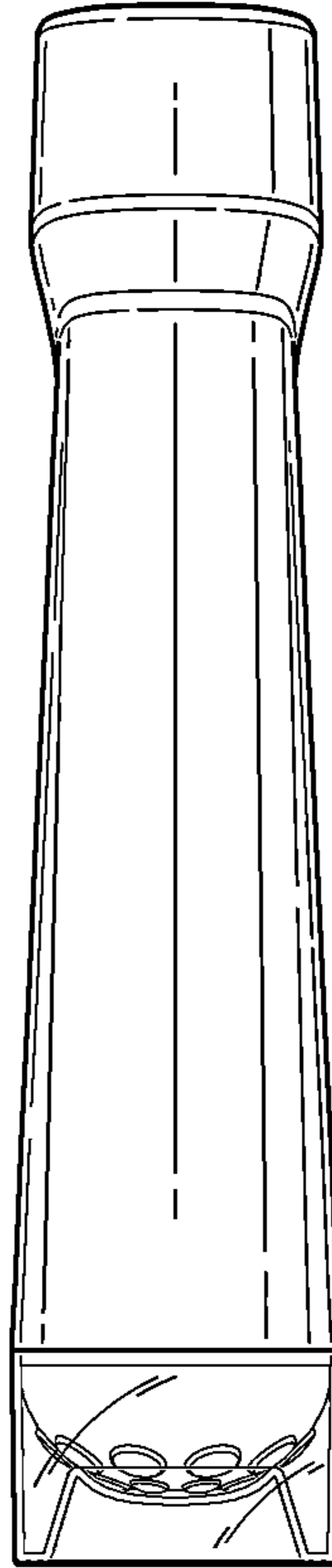

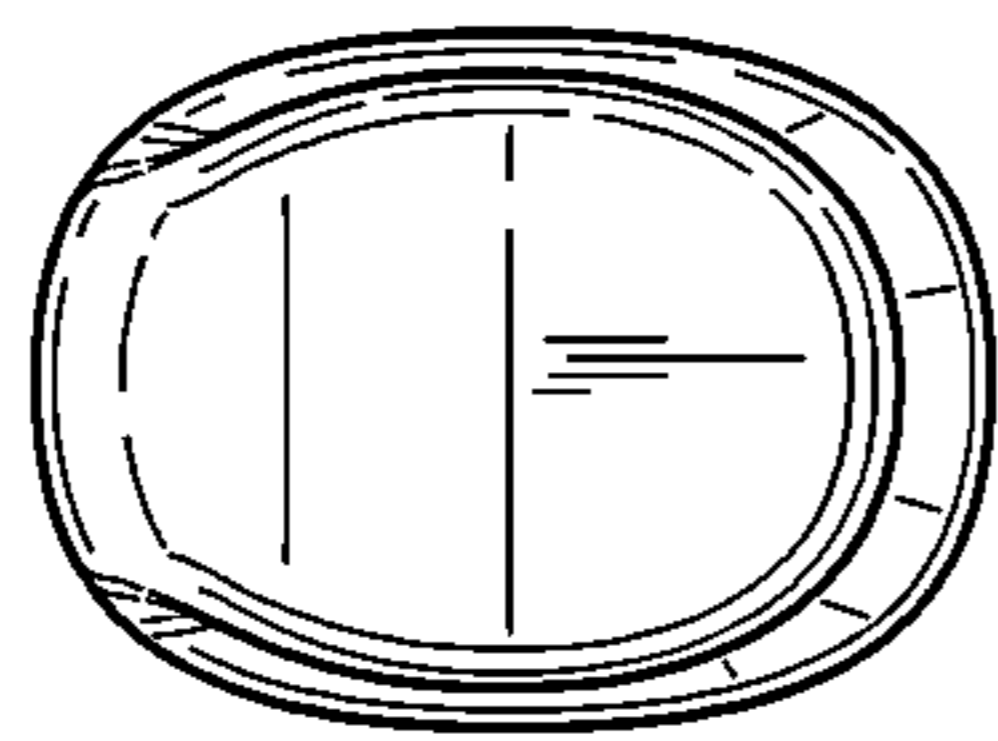

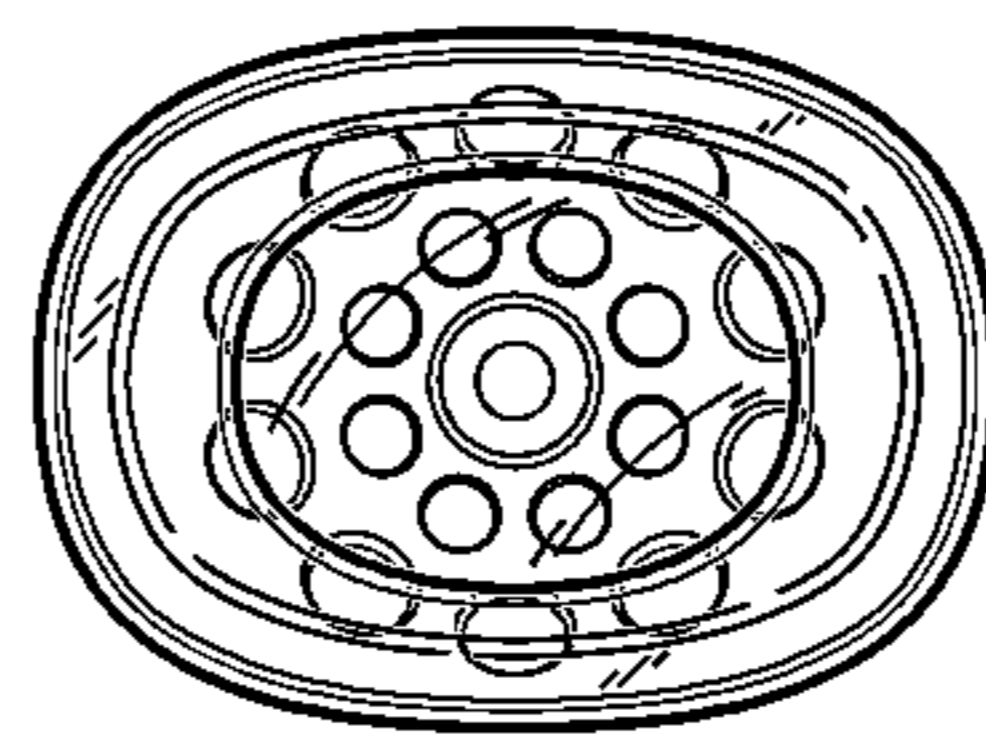
