(57) **CLAIM**

The ornamental design for the decorative container for ice melting materials, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a decorative container for ice melting materials in accordance with the present invention, shown with the container closed;  
FIG. 2 is a front plan view thereof;  
FIG. 3 is a rear plan view thereof;  
FIG. 4 is a right plan view thereof;  
FIG. 5 is a left plan view thereof;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a bottom plan view thereof;

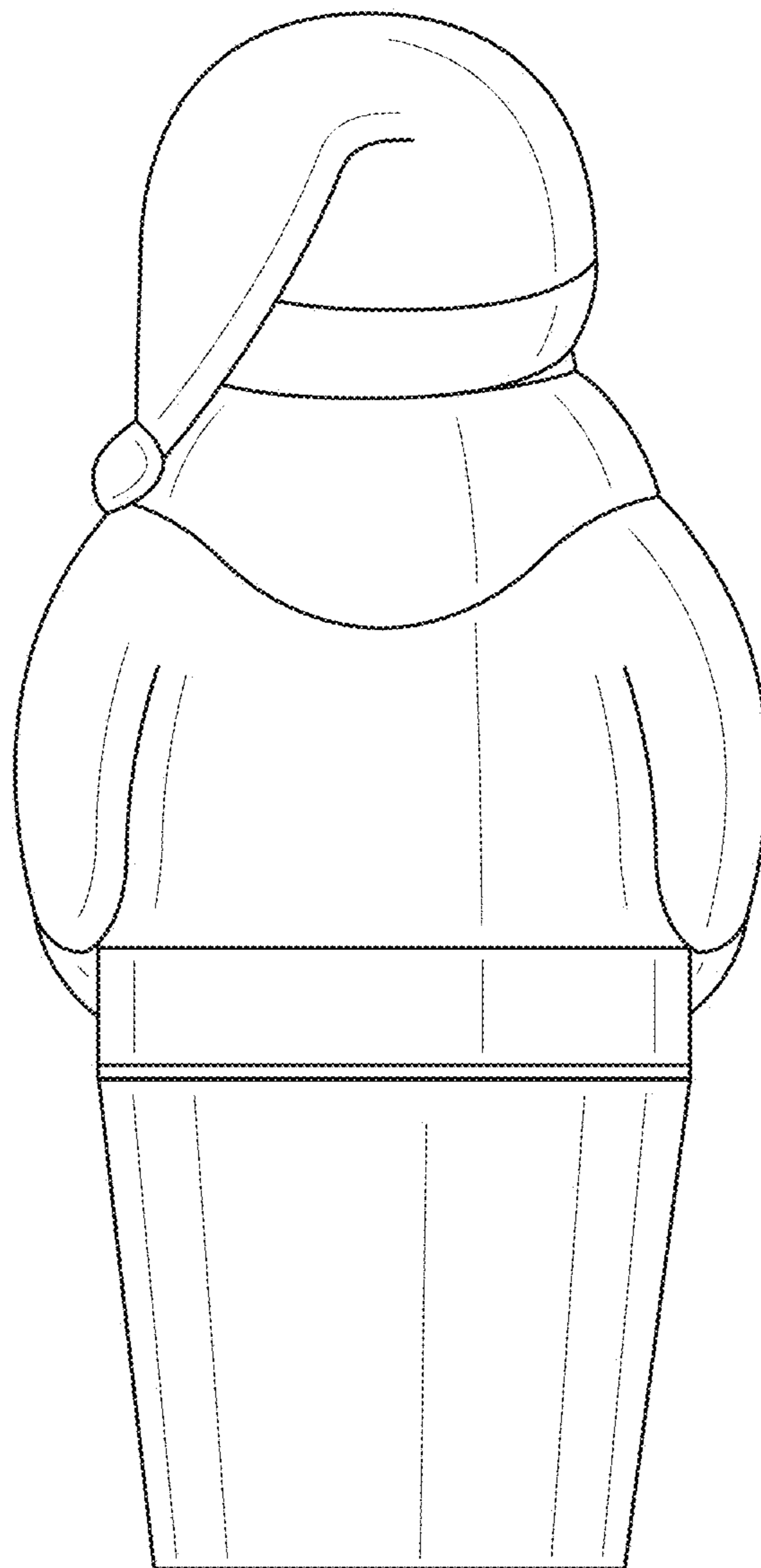

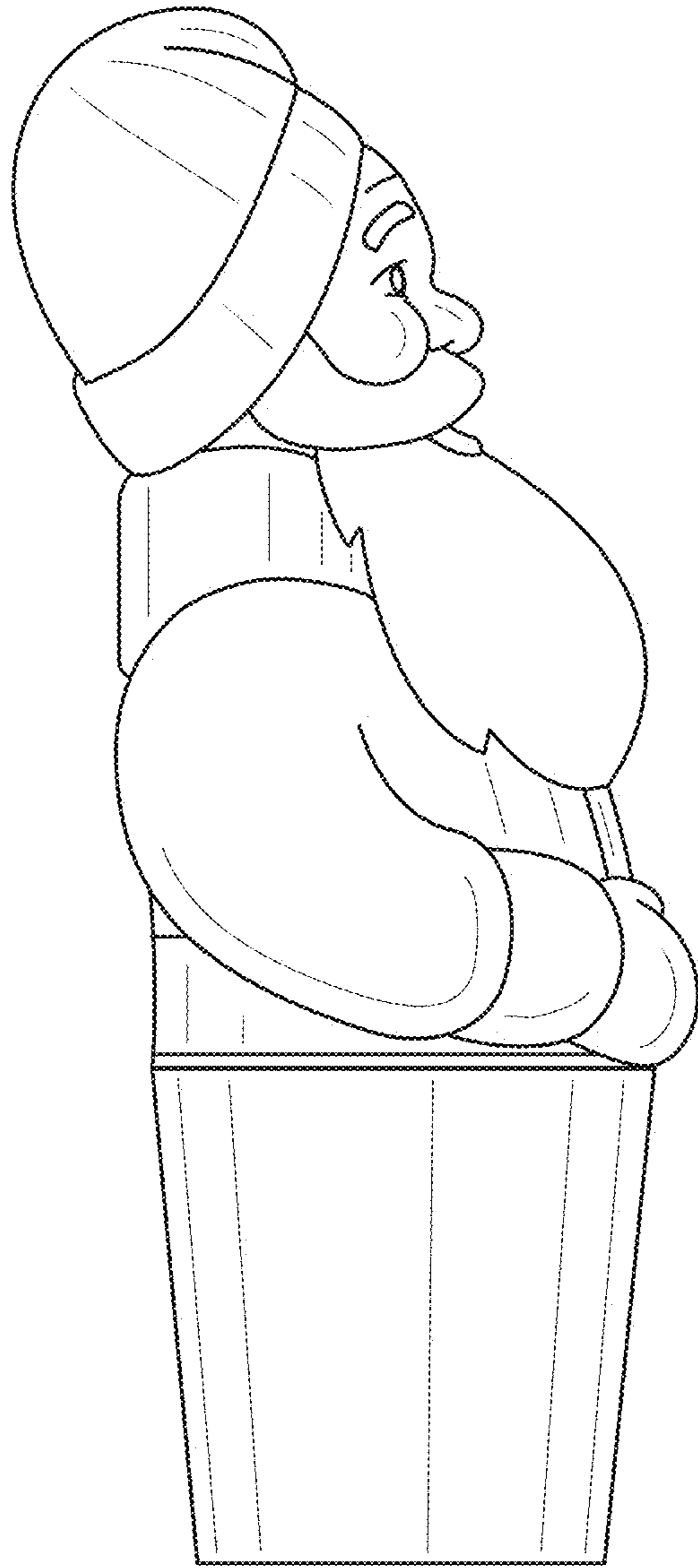

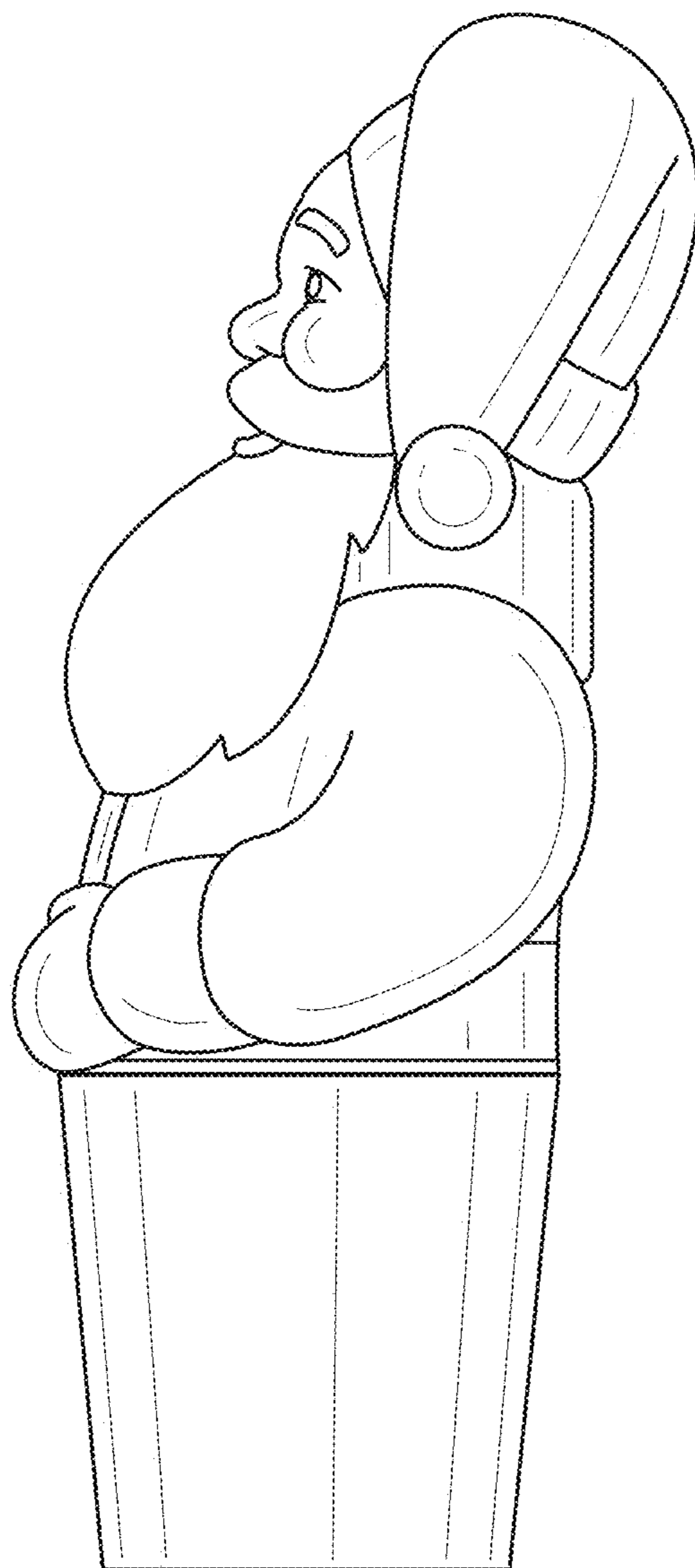

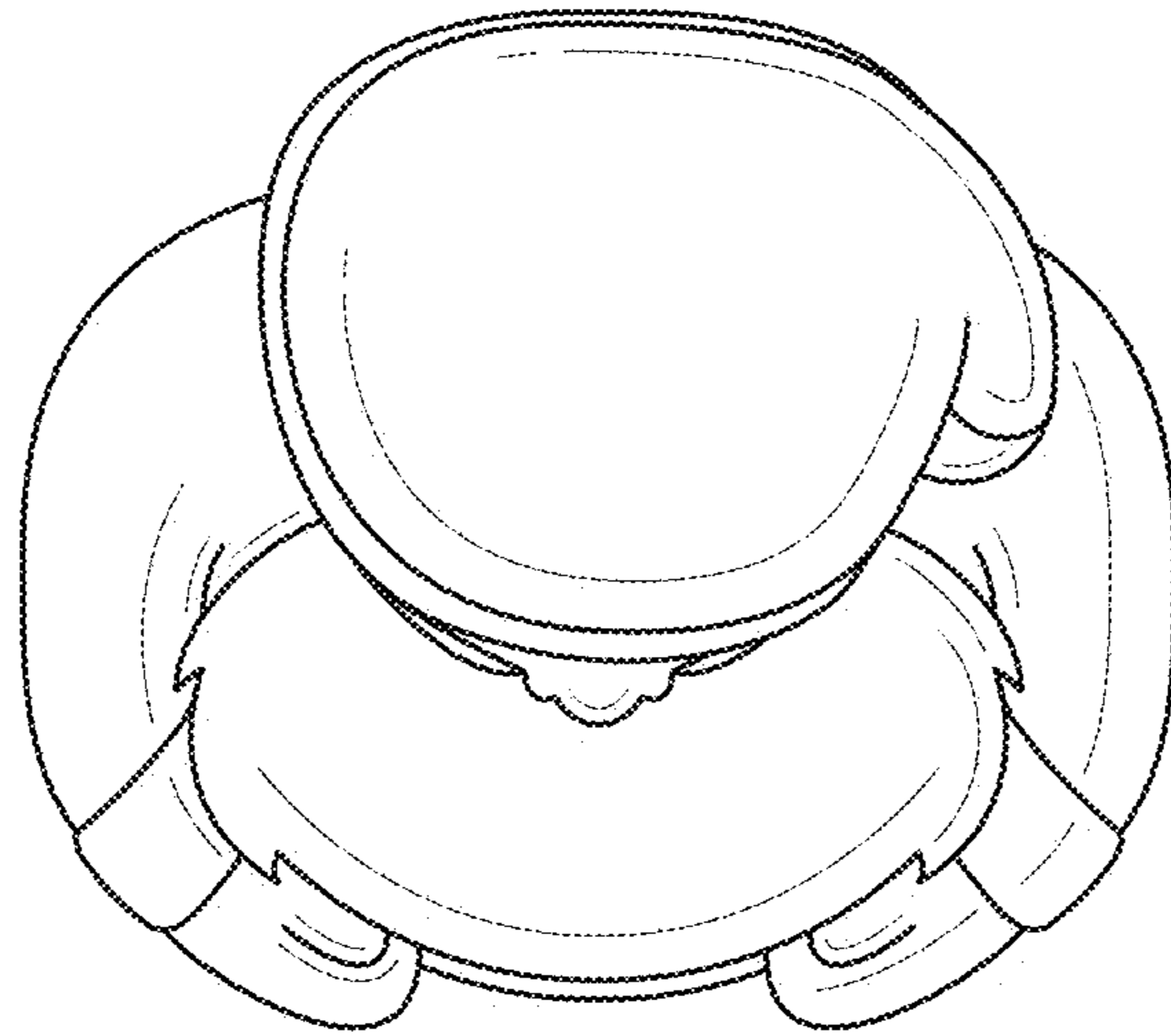

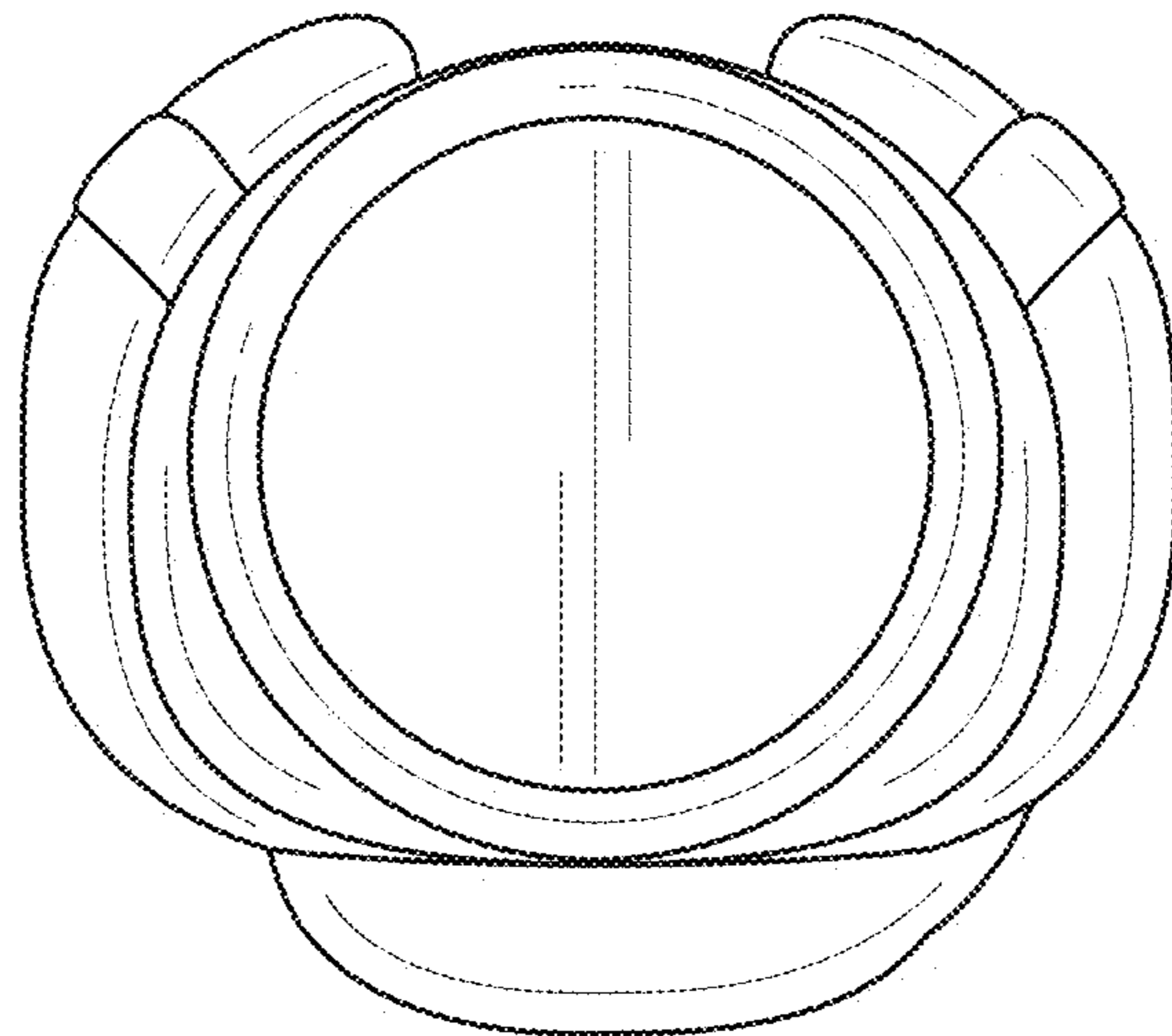

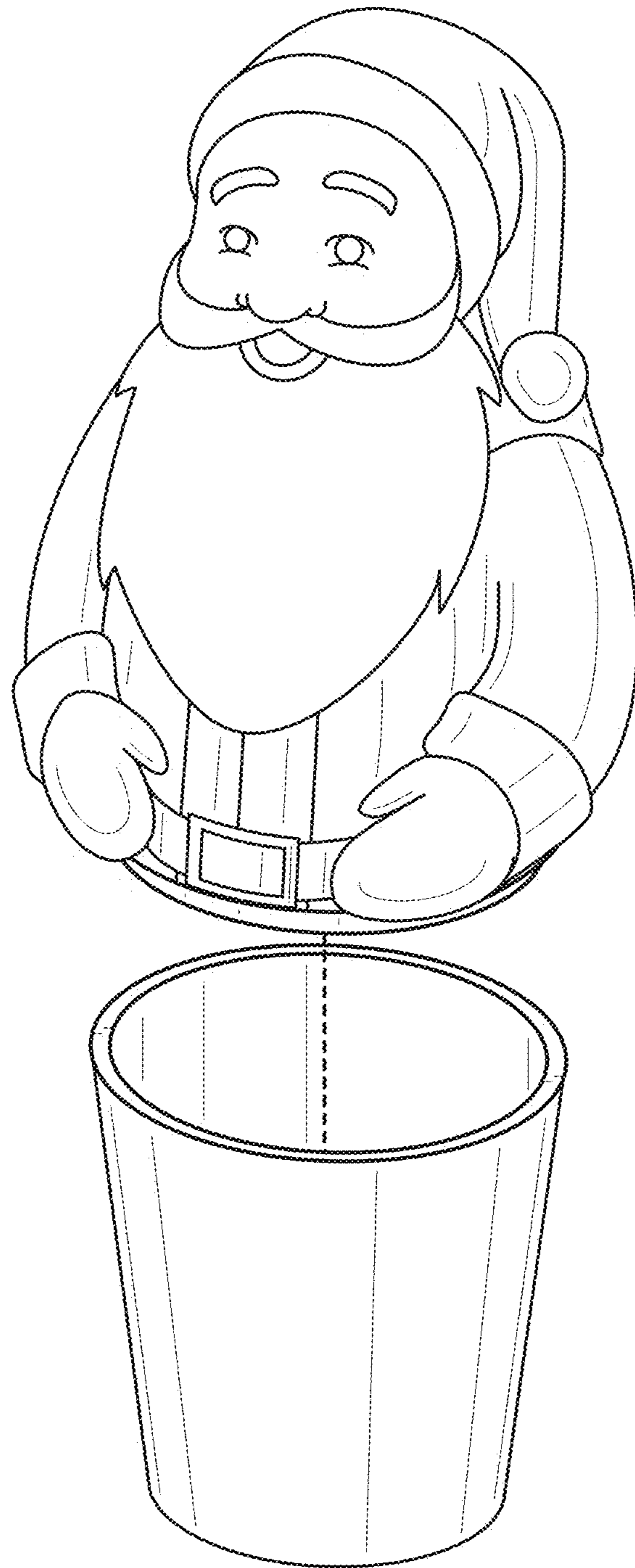

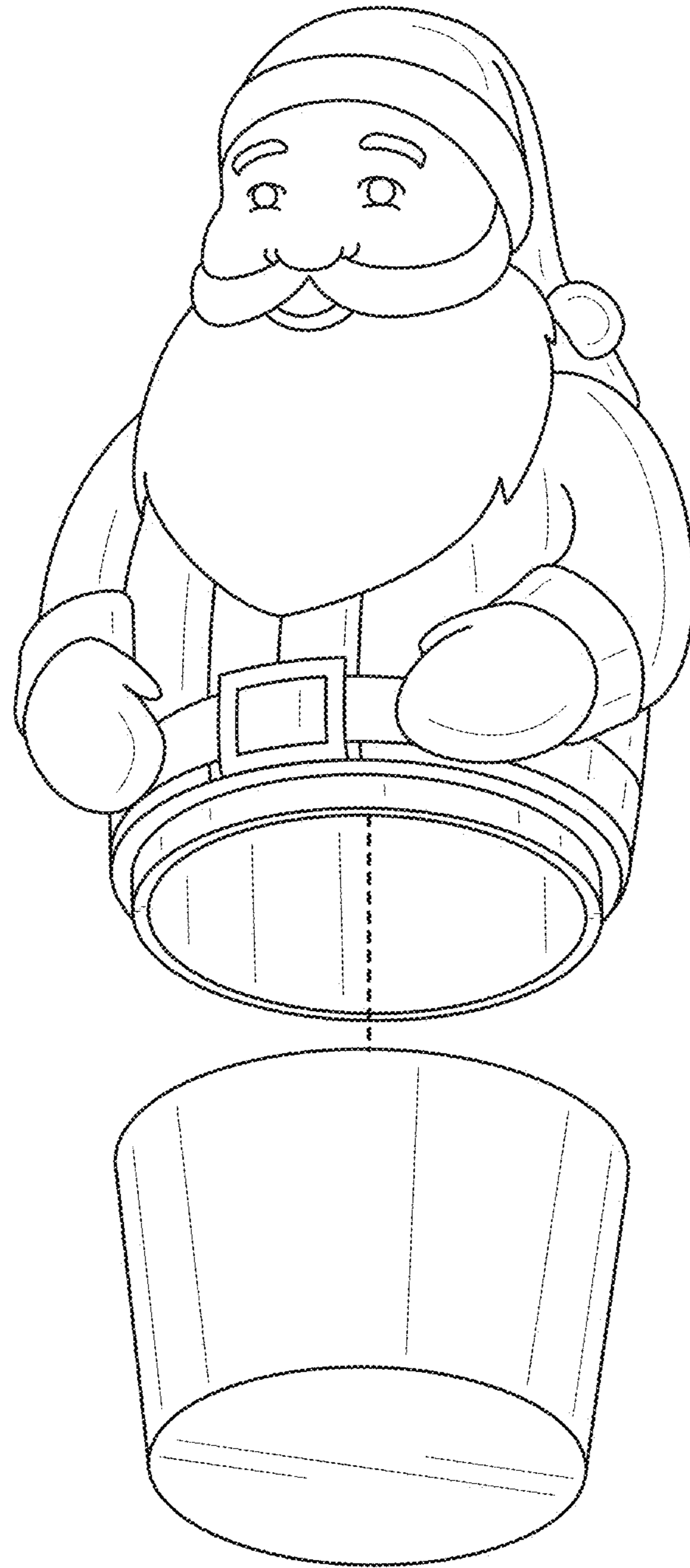
