FIG. 1 is a front perspective view of a bracelet showing my new design thereof;

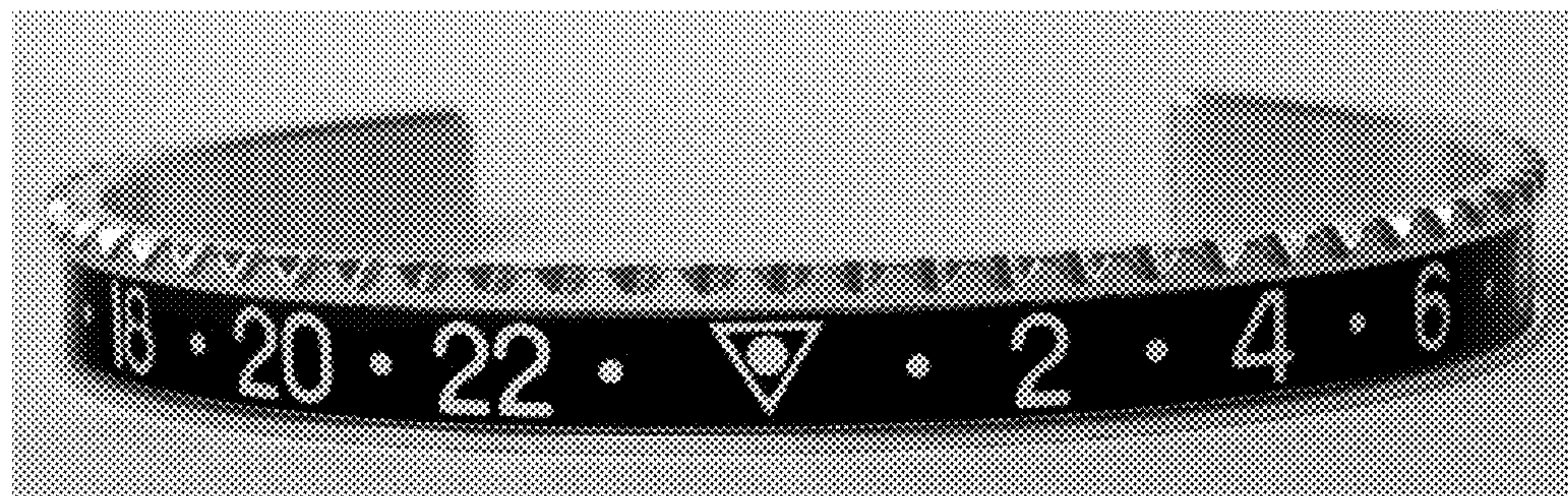
FIG. 2 is a back perspective view thereof;

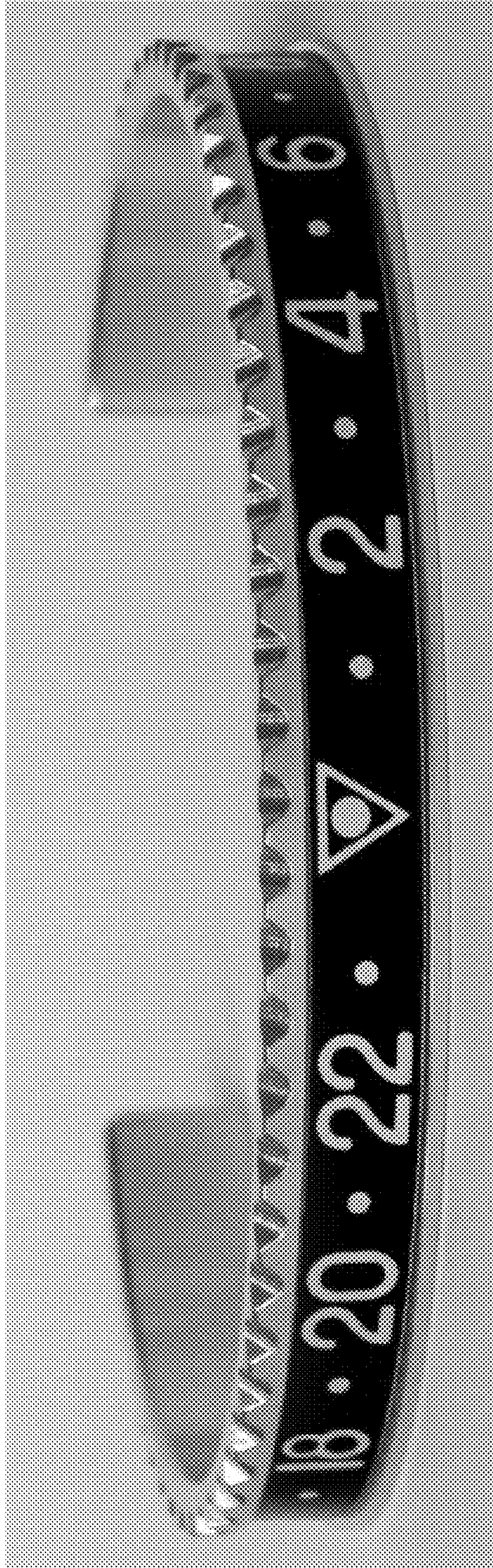

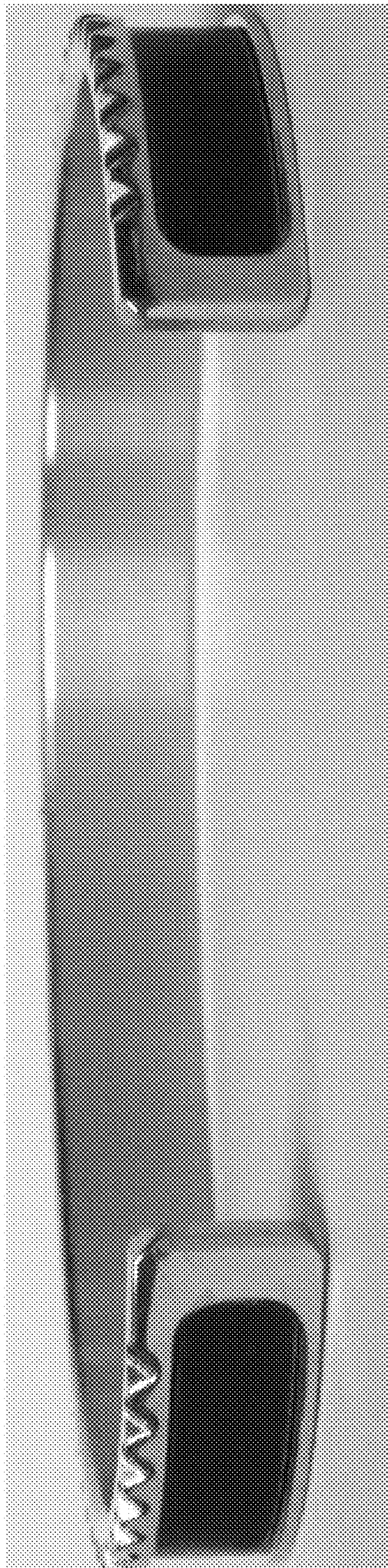

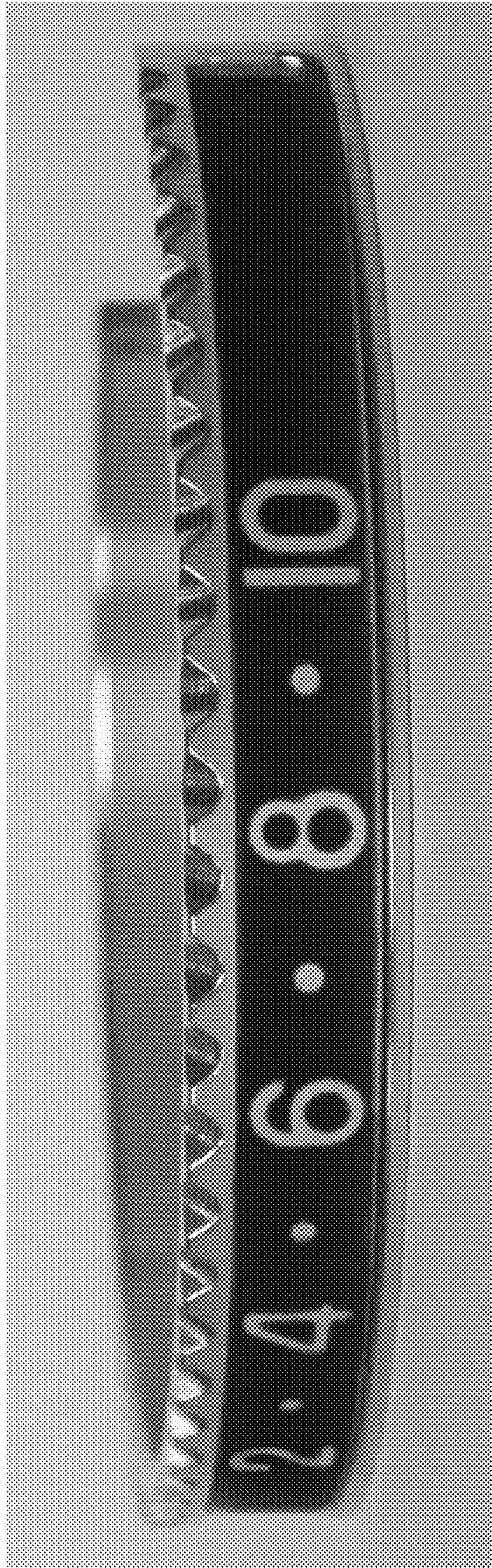

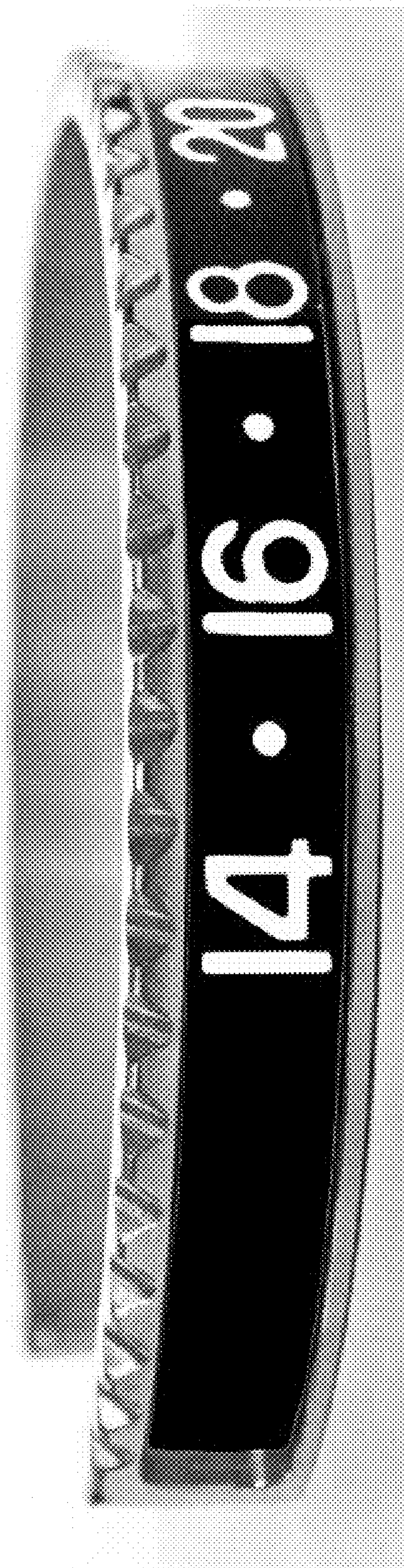
