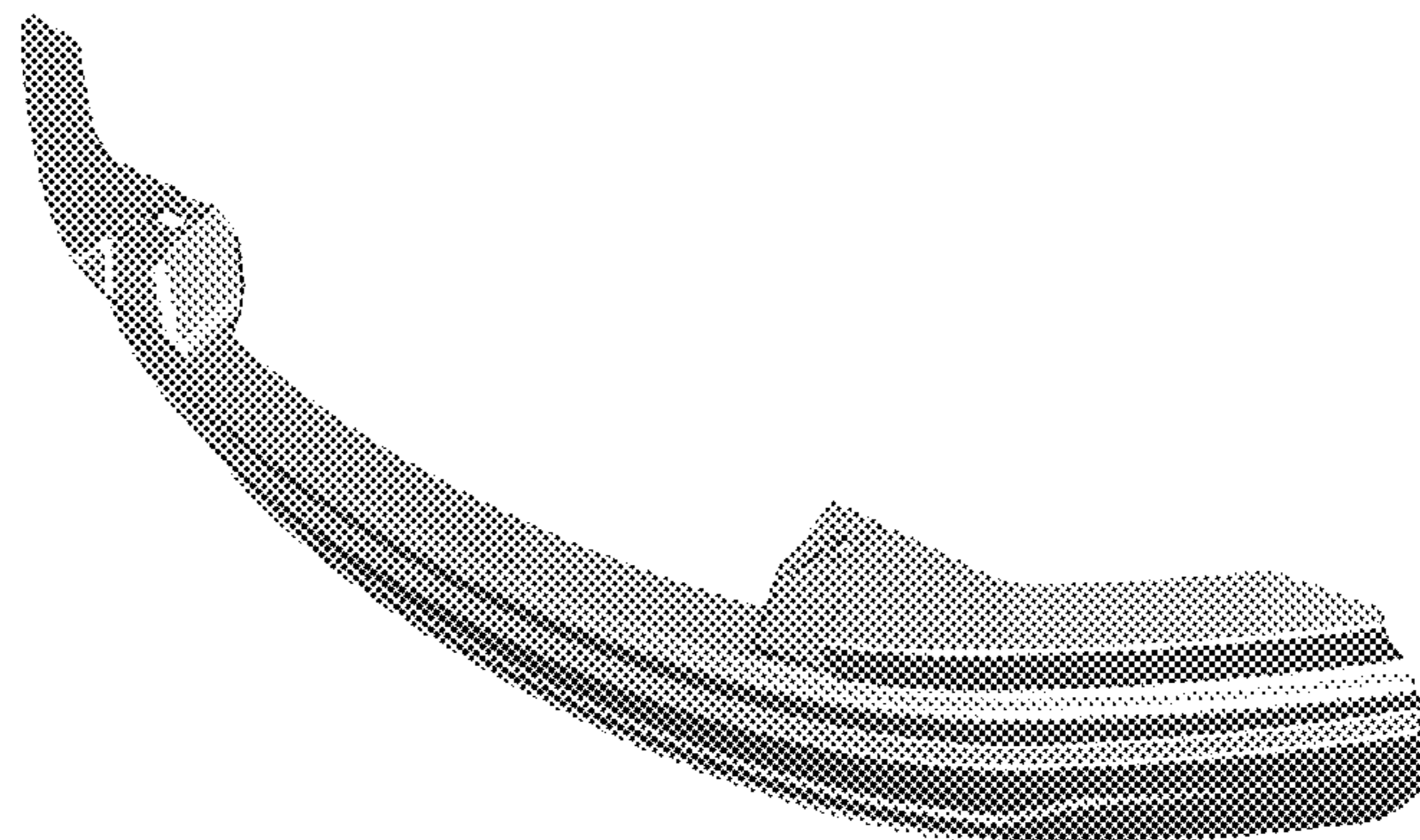
(57) **CLAIM**

The ornamental design for a vehicle front bumper valance, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a vehicle front bumper valance; FIG. 2 is a bottom plan view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a bottom left side perspective view thereof; FIG. 7 is bottom right side perspective view thereof; FIG. 8 is a top left side perspective view thereof; and, FIG. 9 is a top right side perspective view thereof.

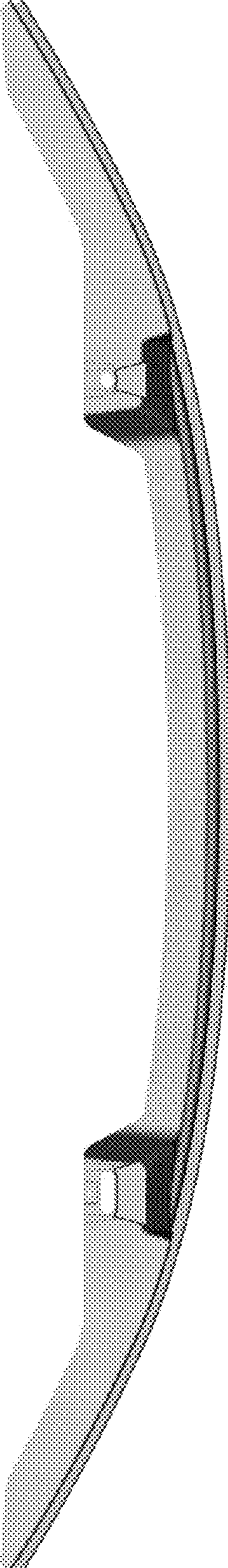
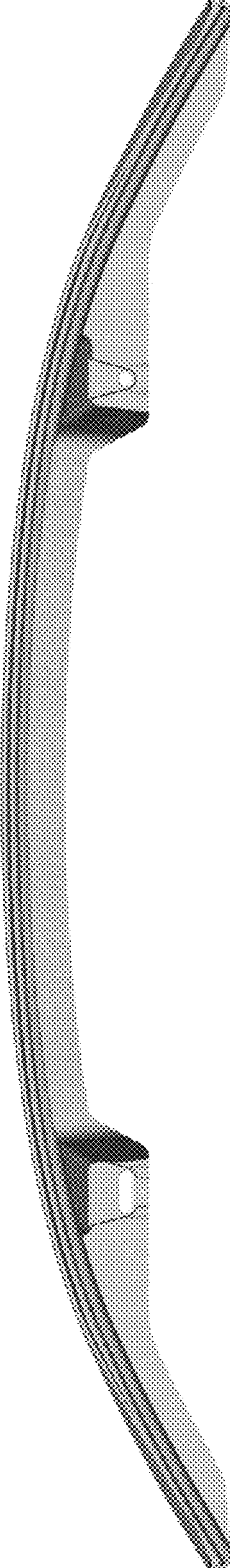

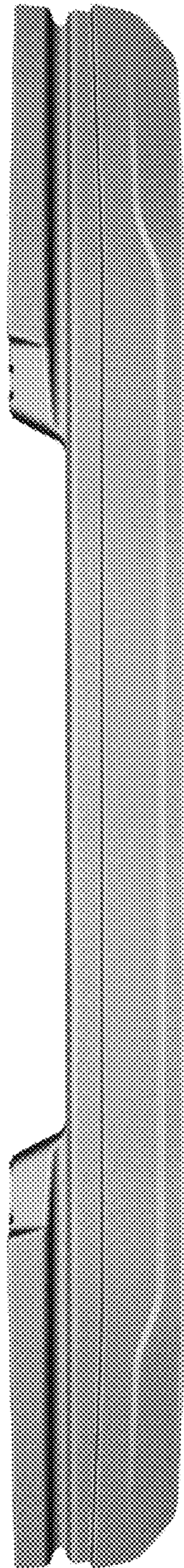

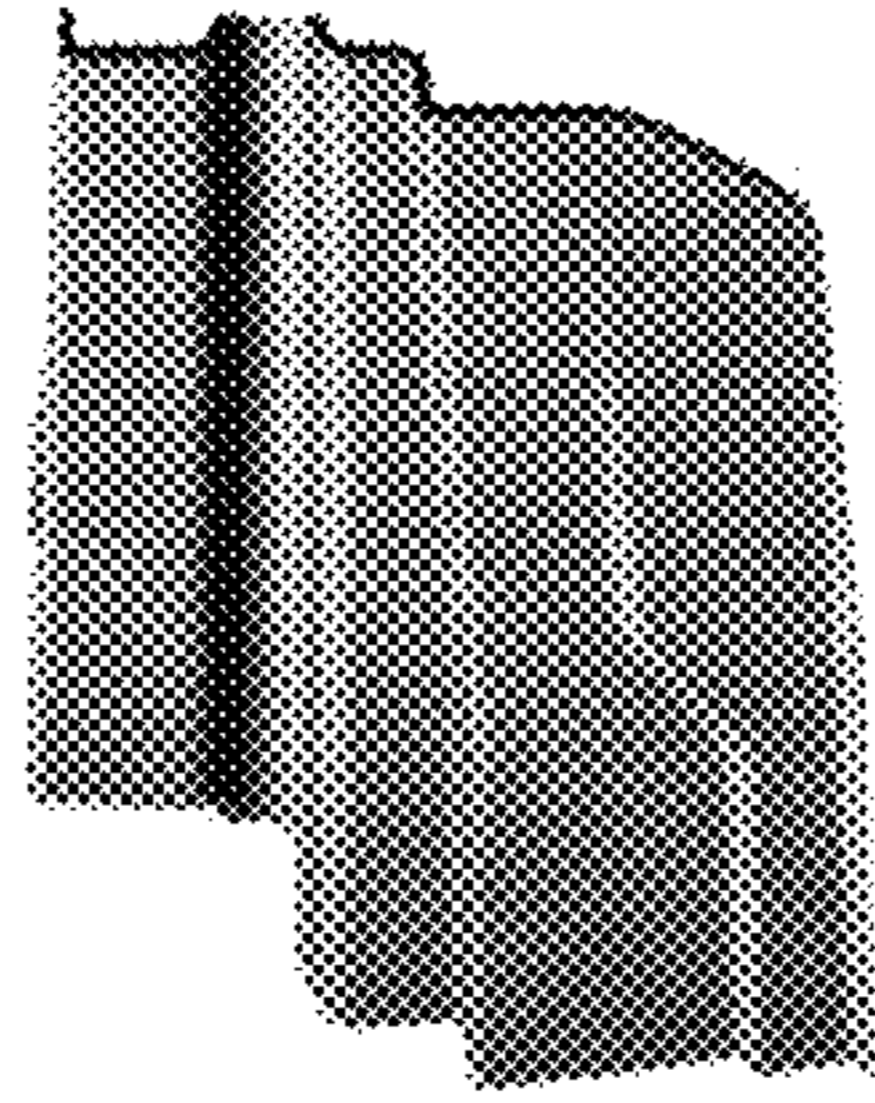
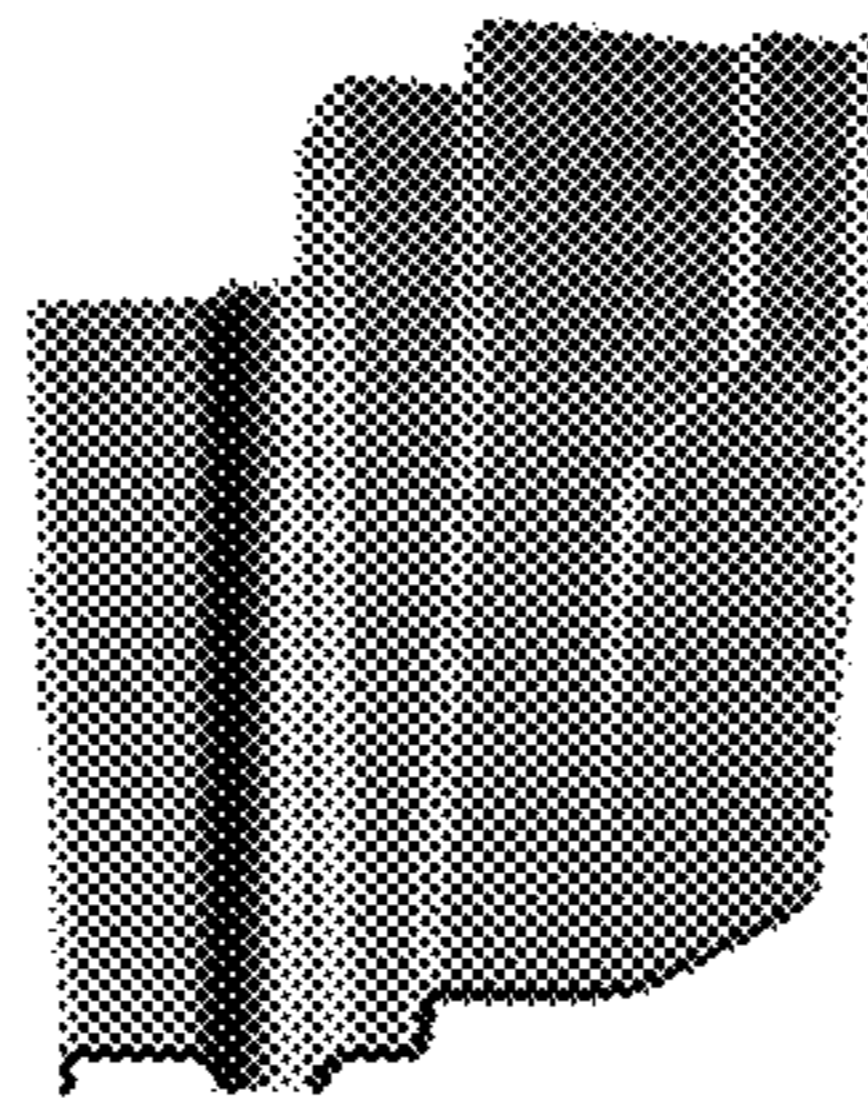

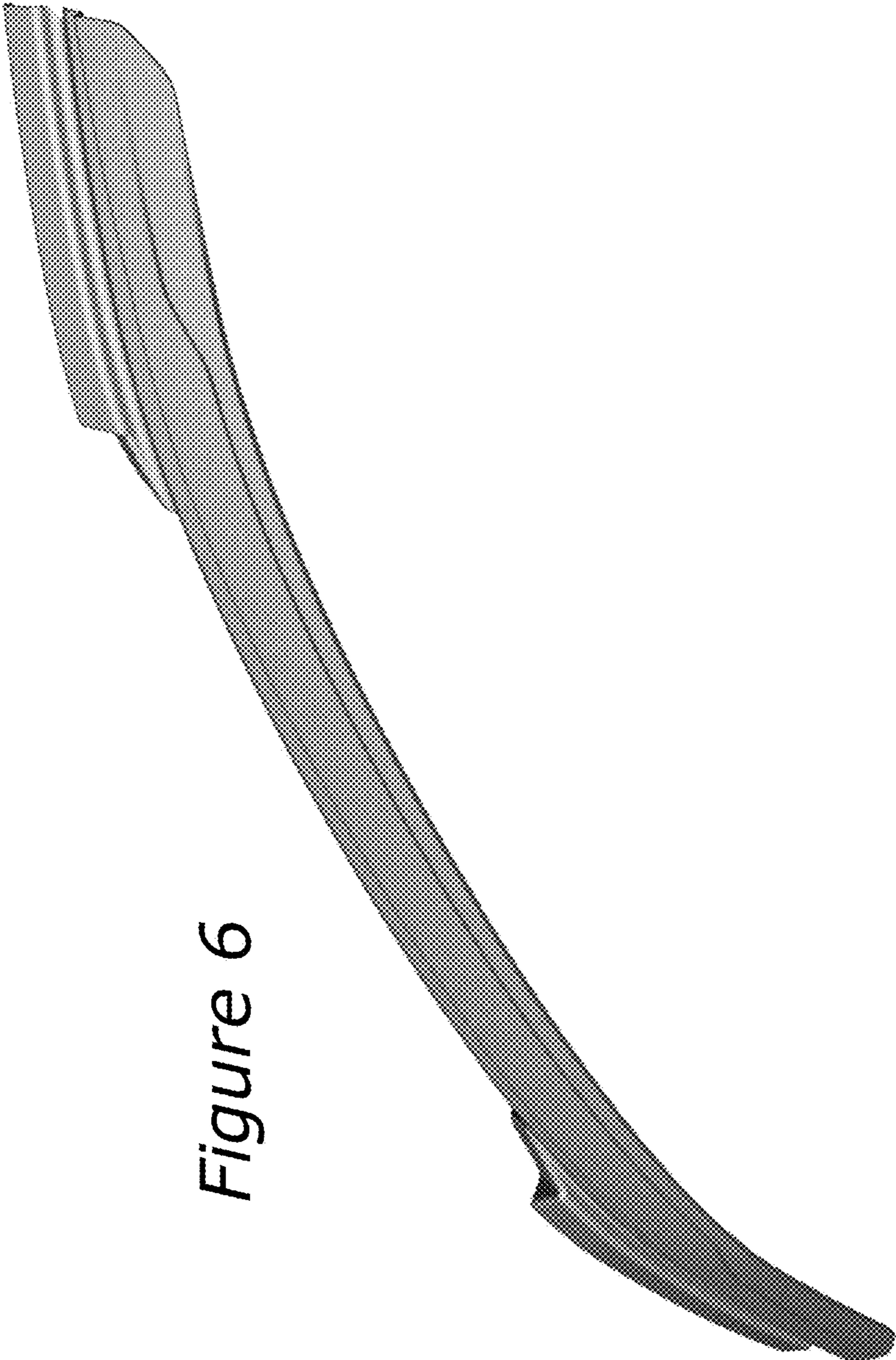

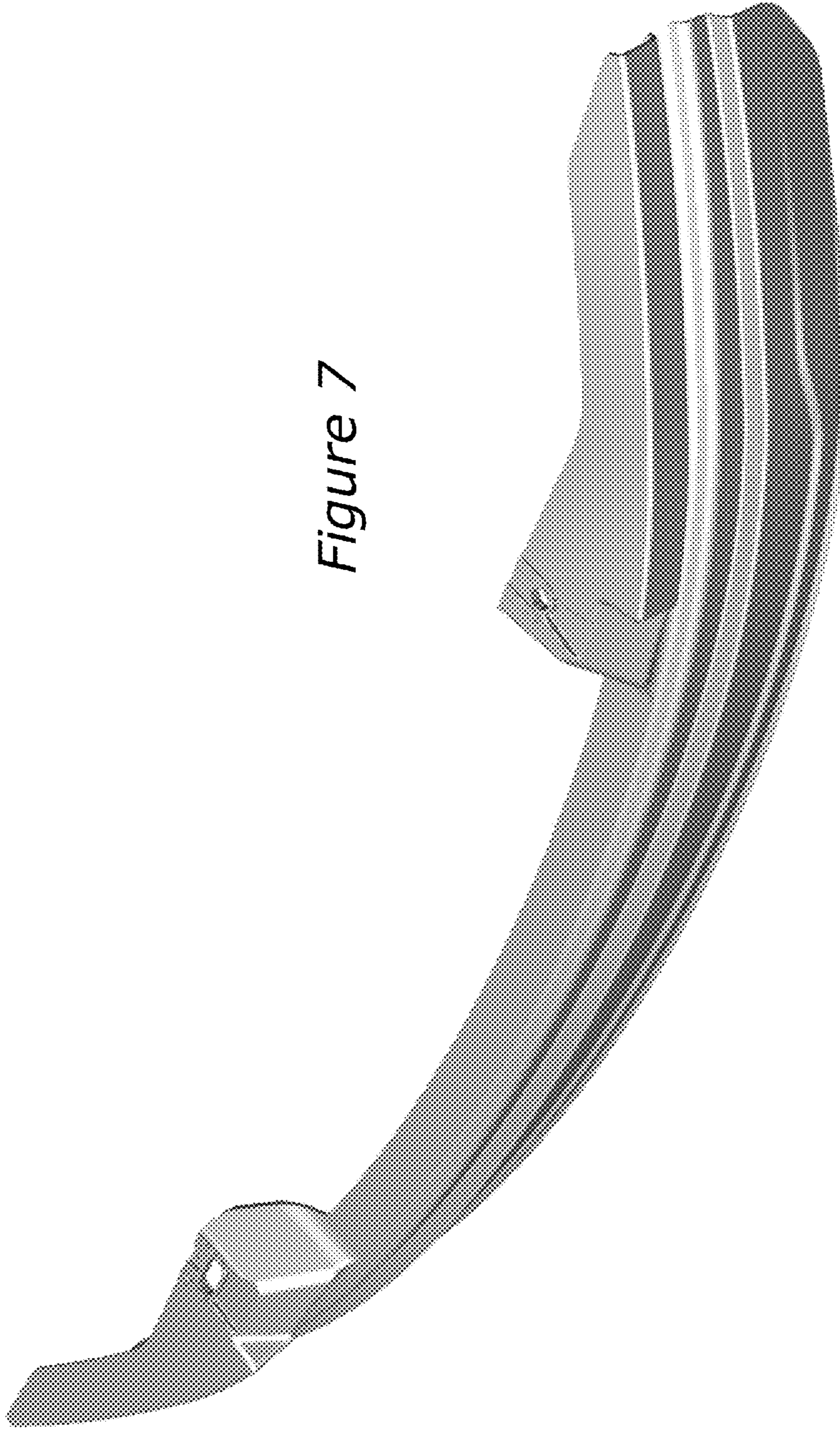

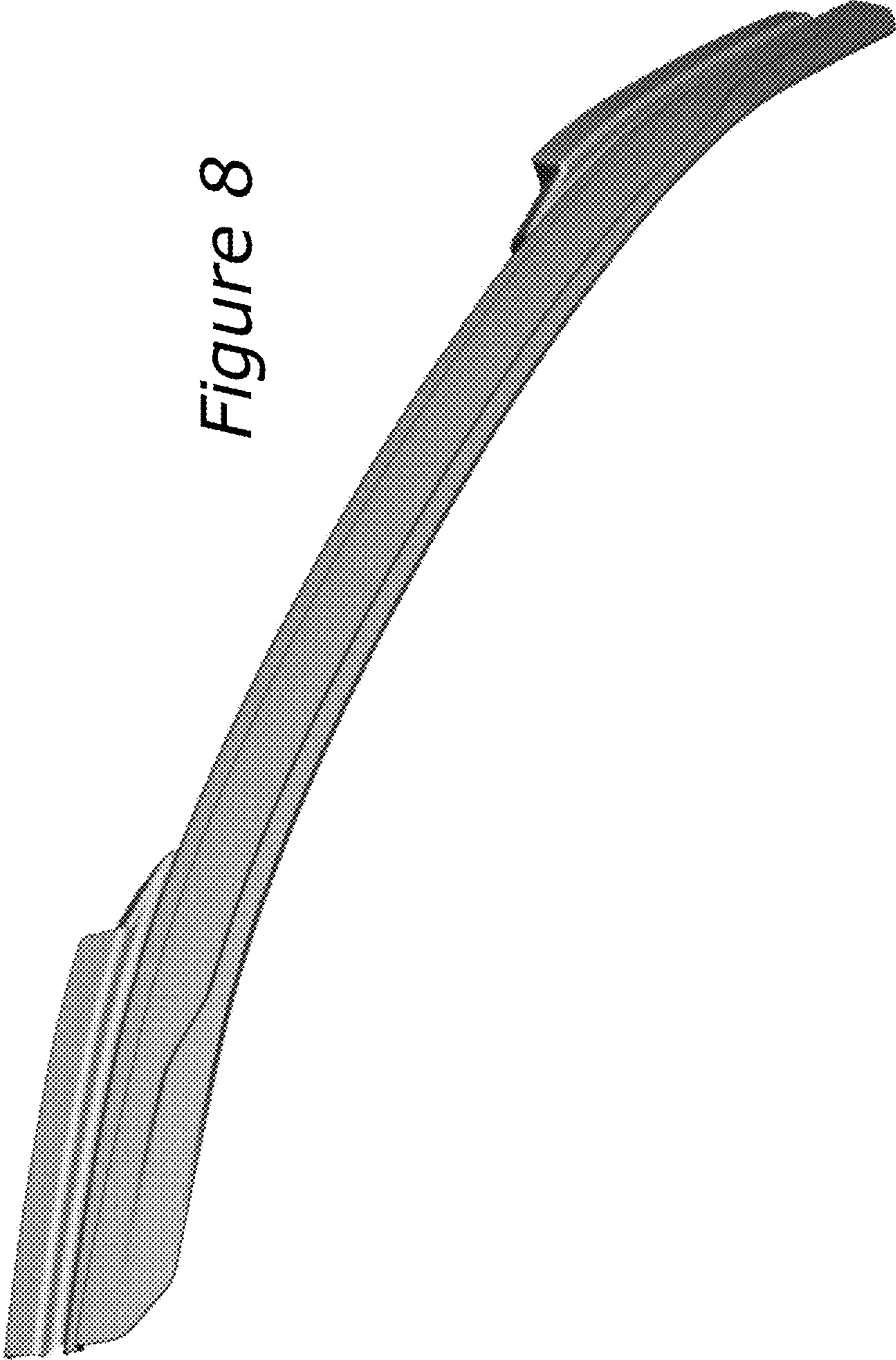
