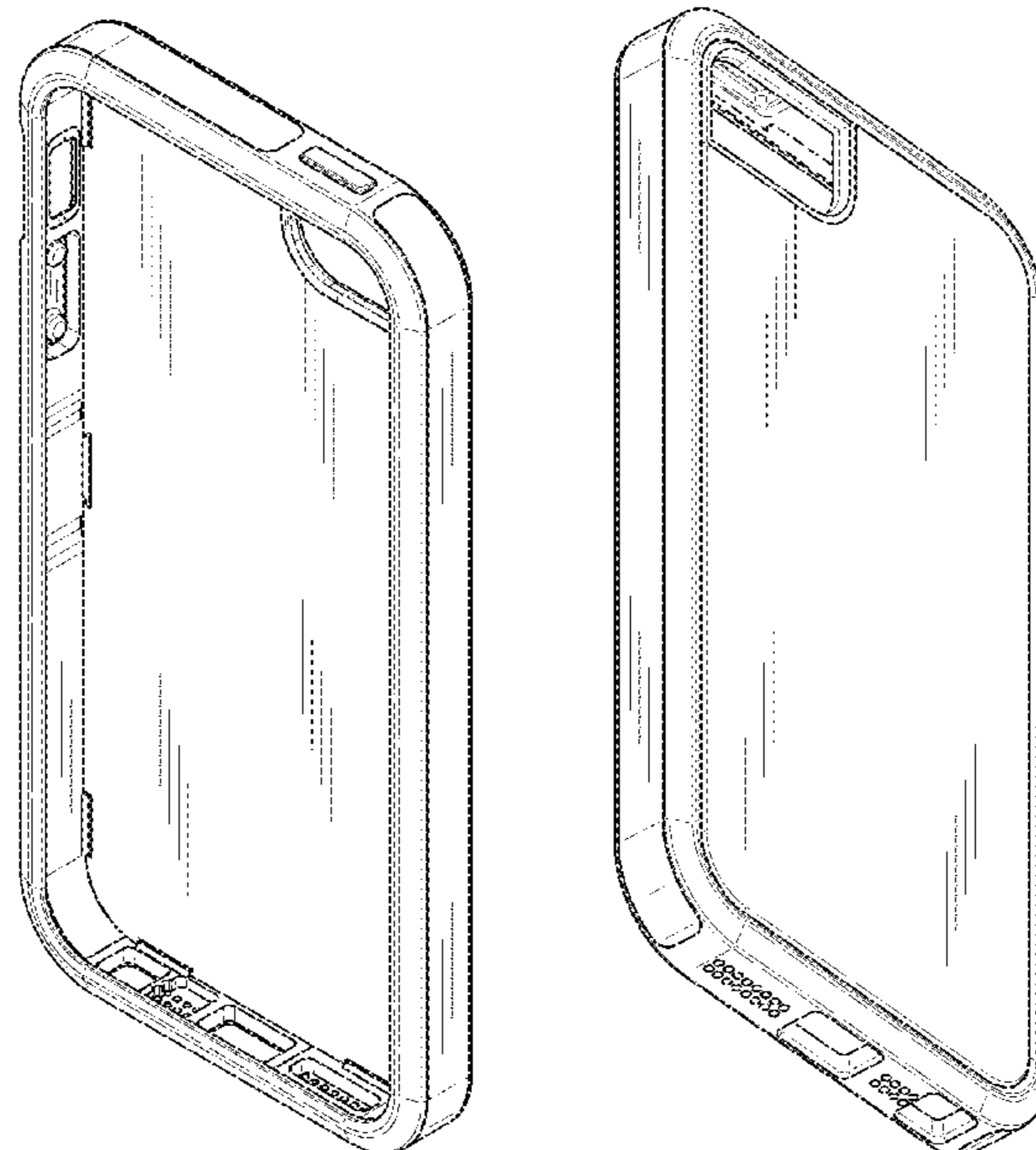
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front isometric view of the electronic device case showing our new design;

 FIG. 4 is a left side view of the electronic device case;

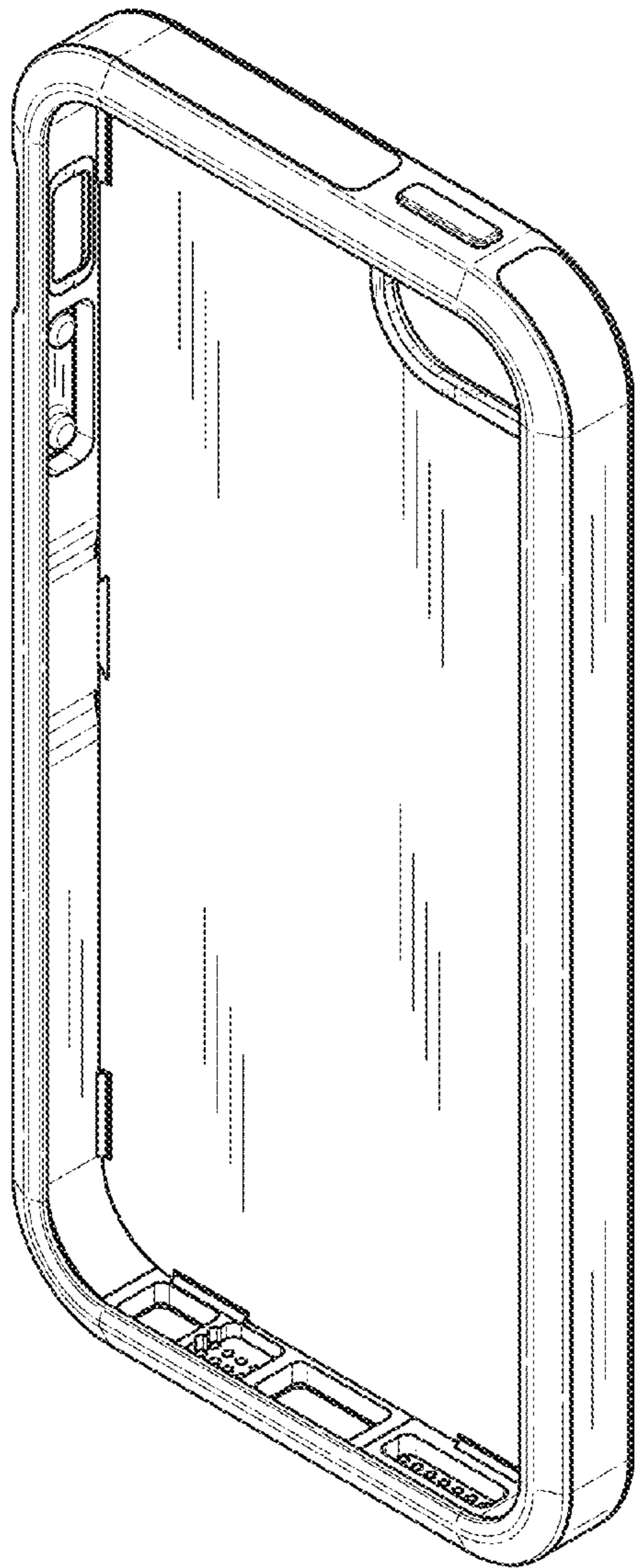

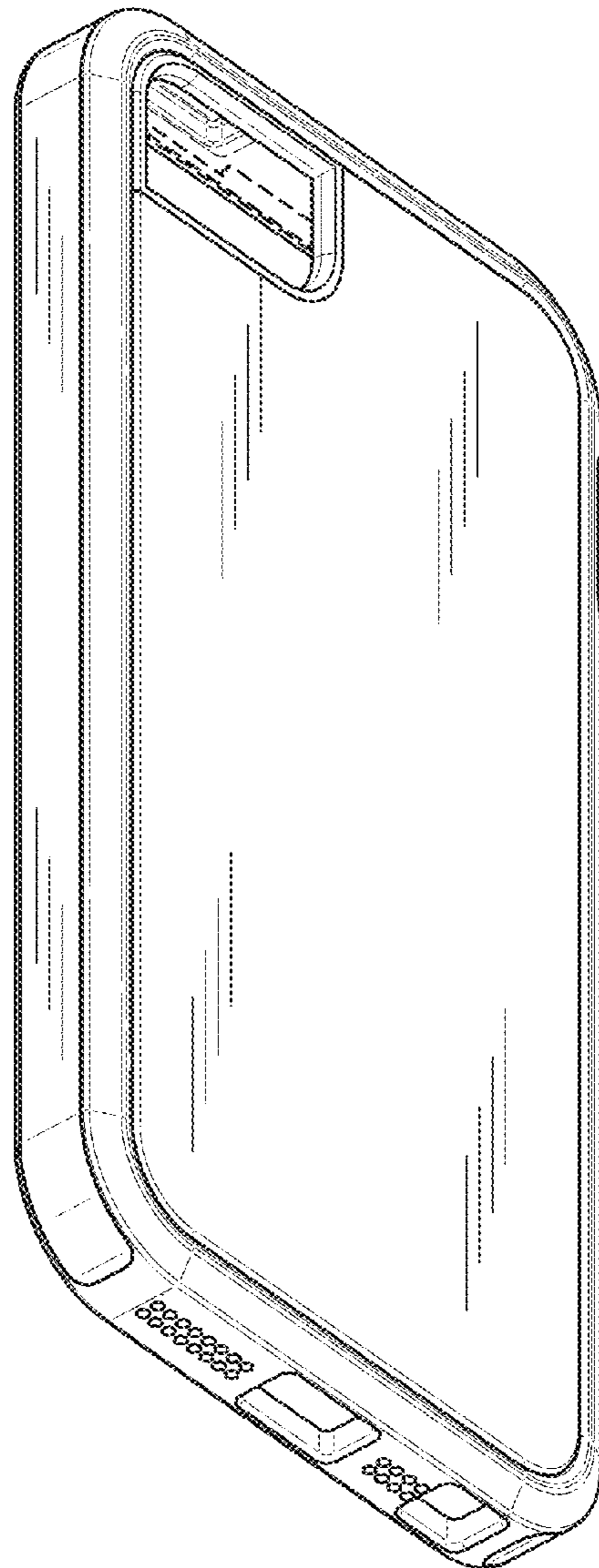

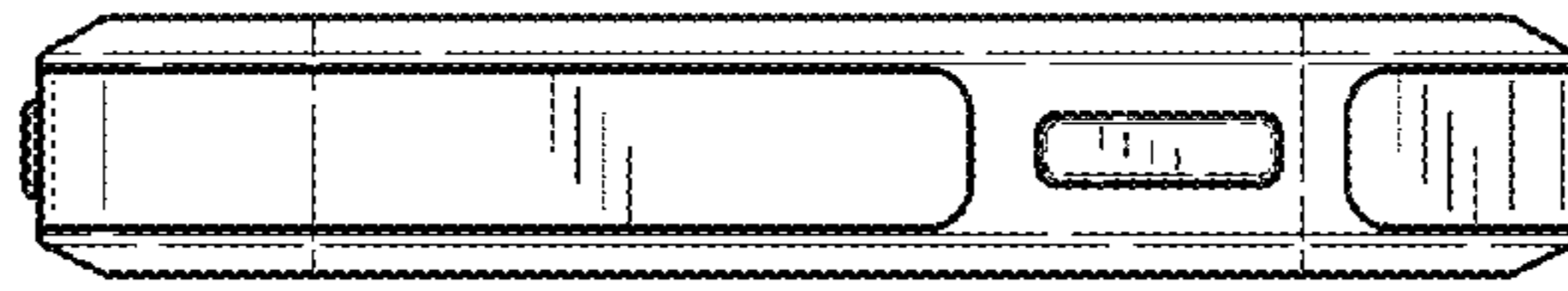

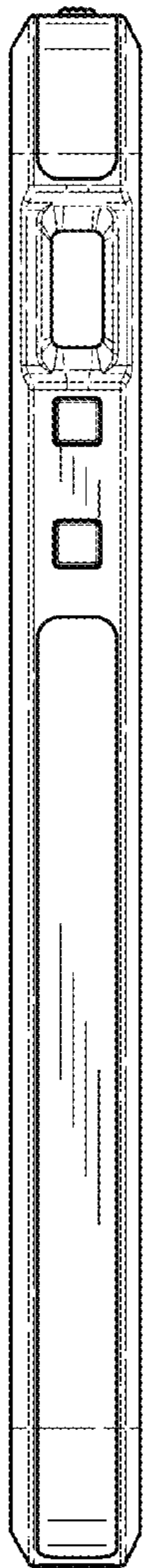

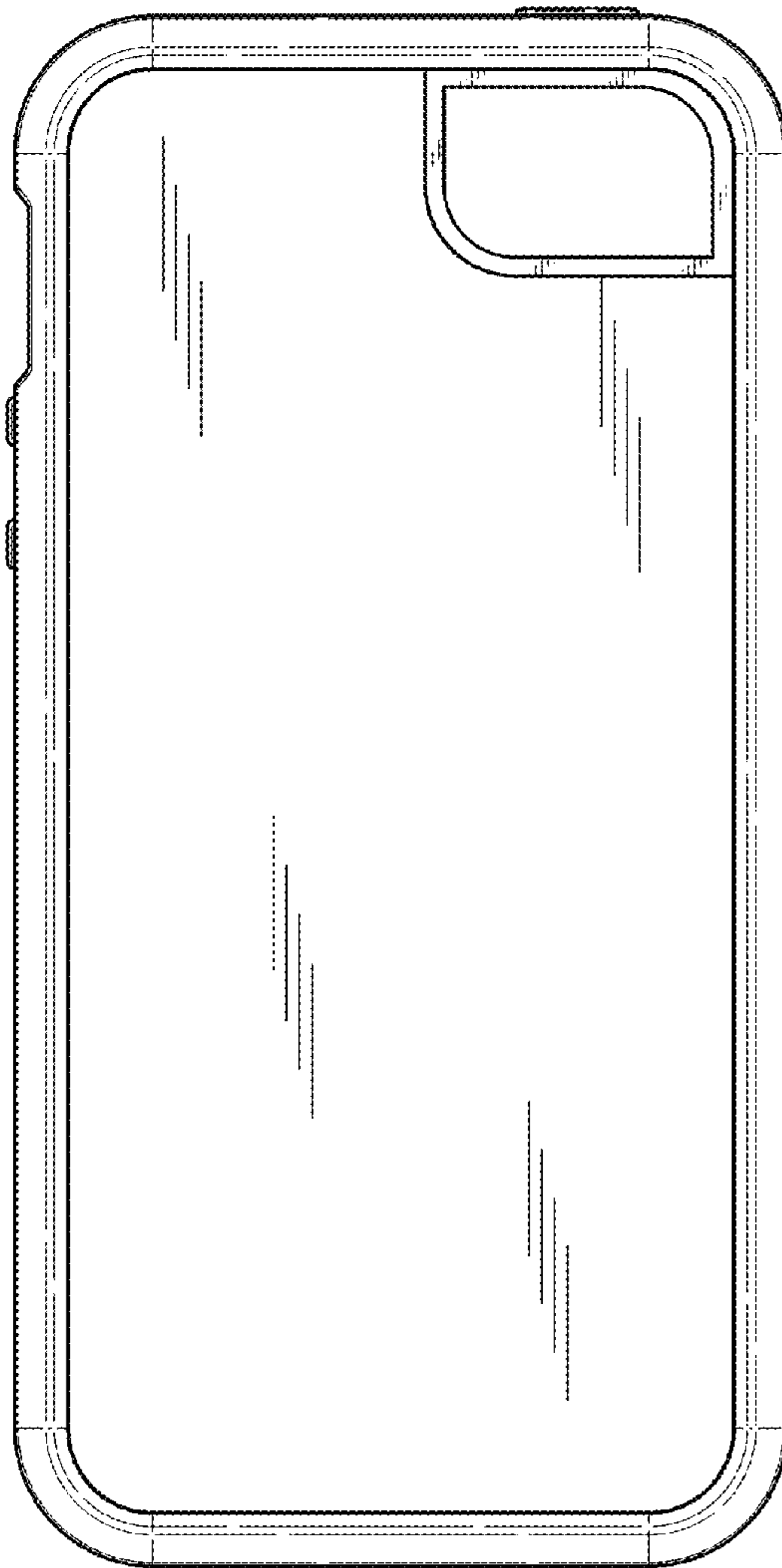

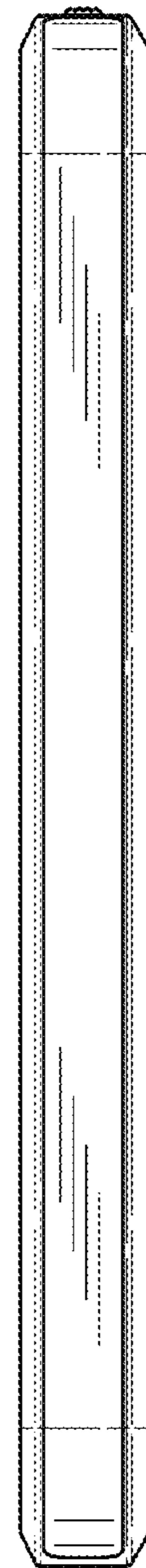

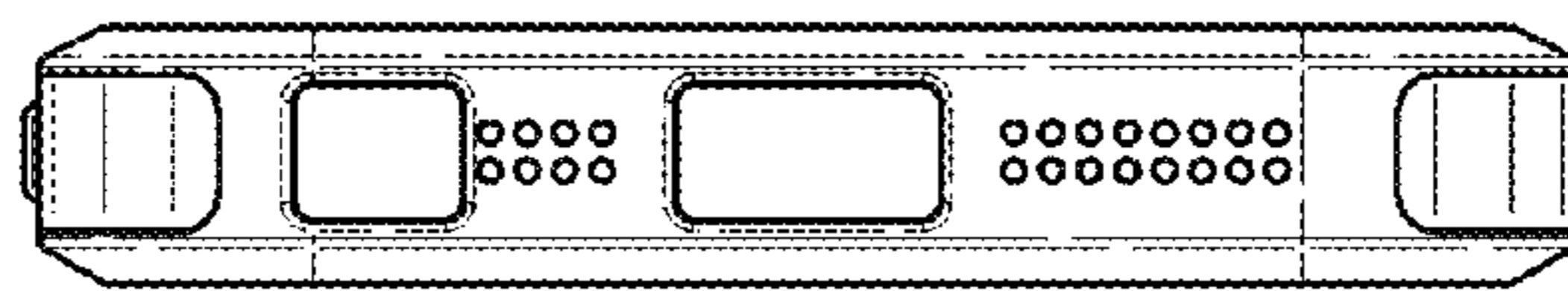
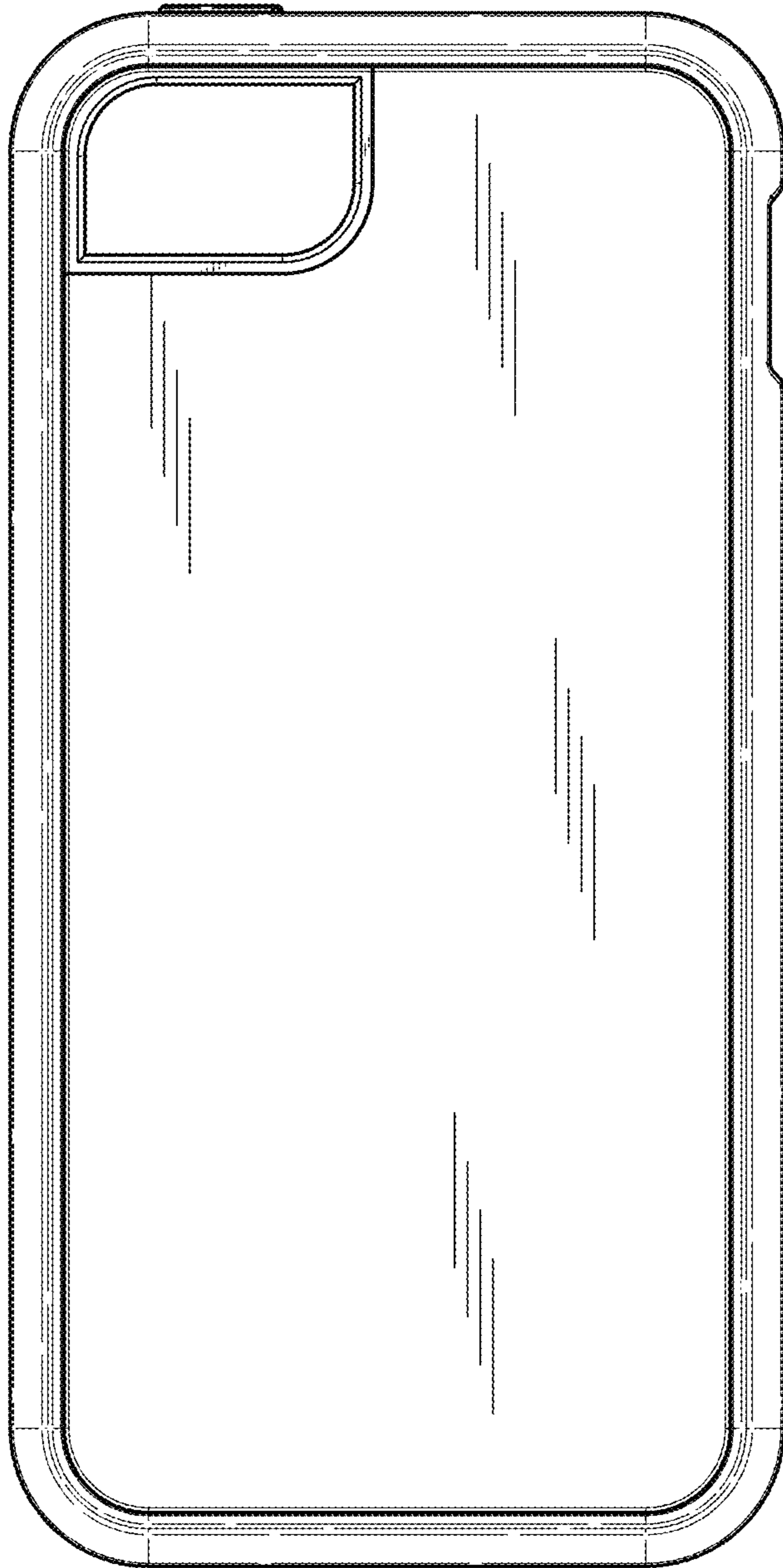
