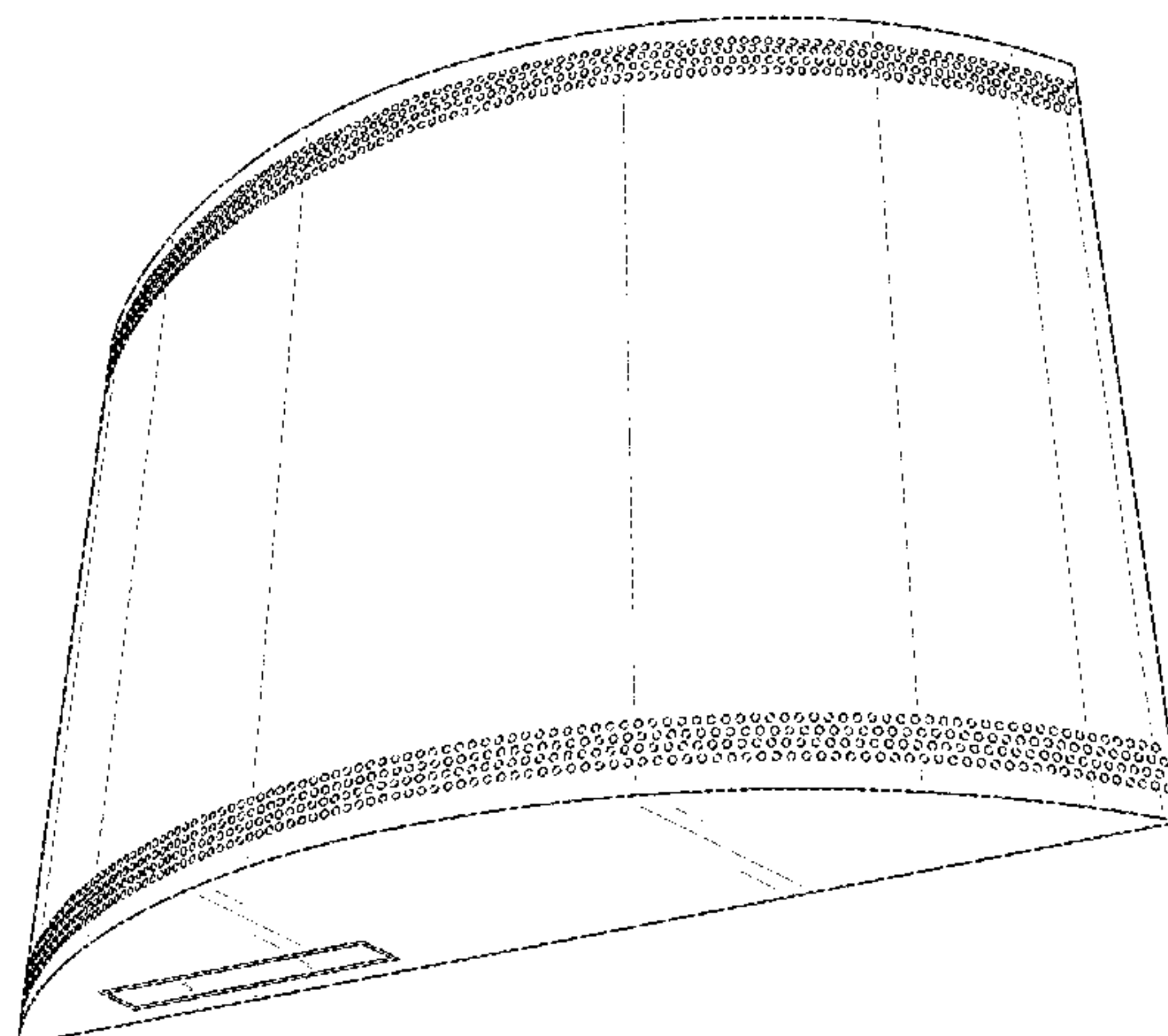
(57) **CLAIM**

The ornamental design for a wall mounted personal computer case, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a new wall mounted personal computer case showing my new design;
FIG. 2 is a rear view of the wall mounted personal computer case of FIG. 1;
FIG. 3 is a front view of the wall mounted personal computer case of FIG. 1;

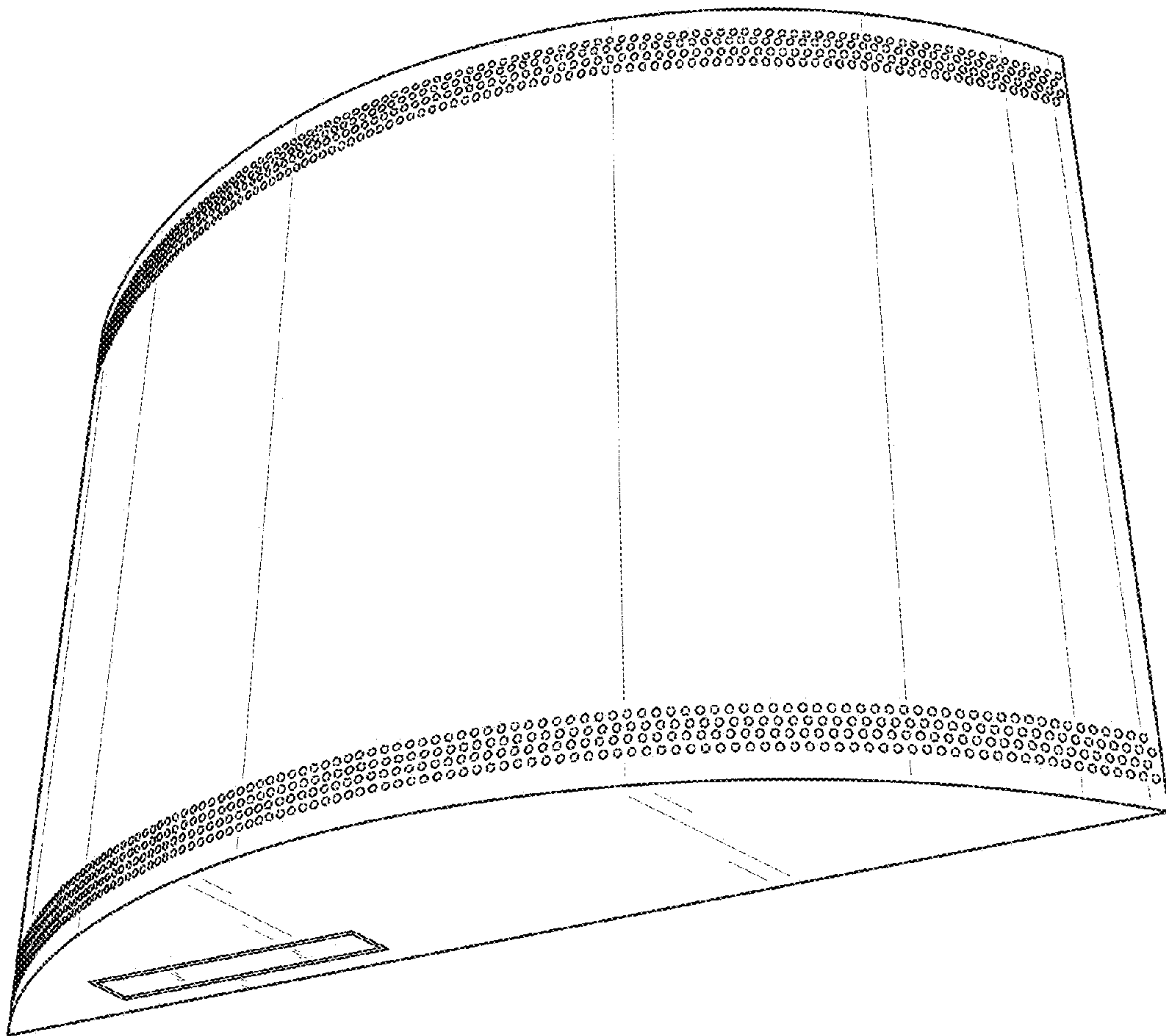

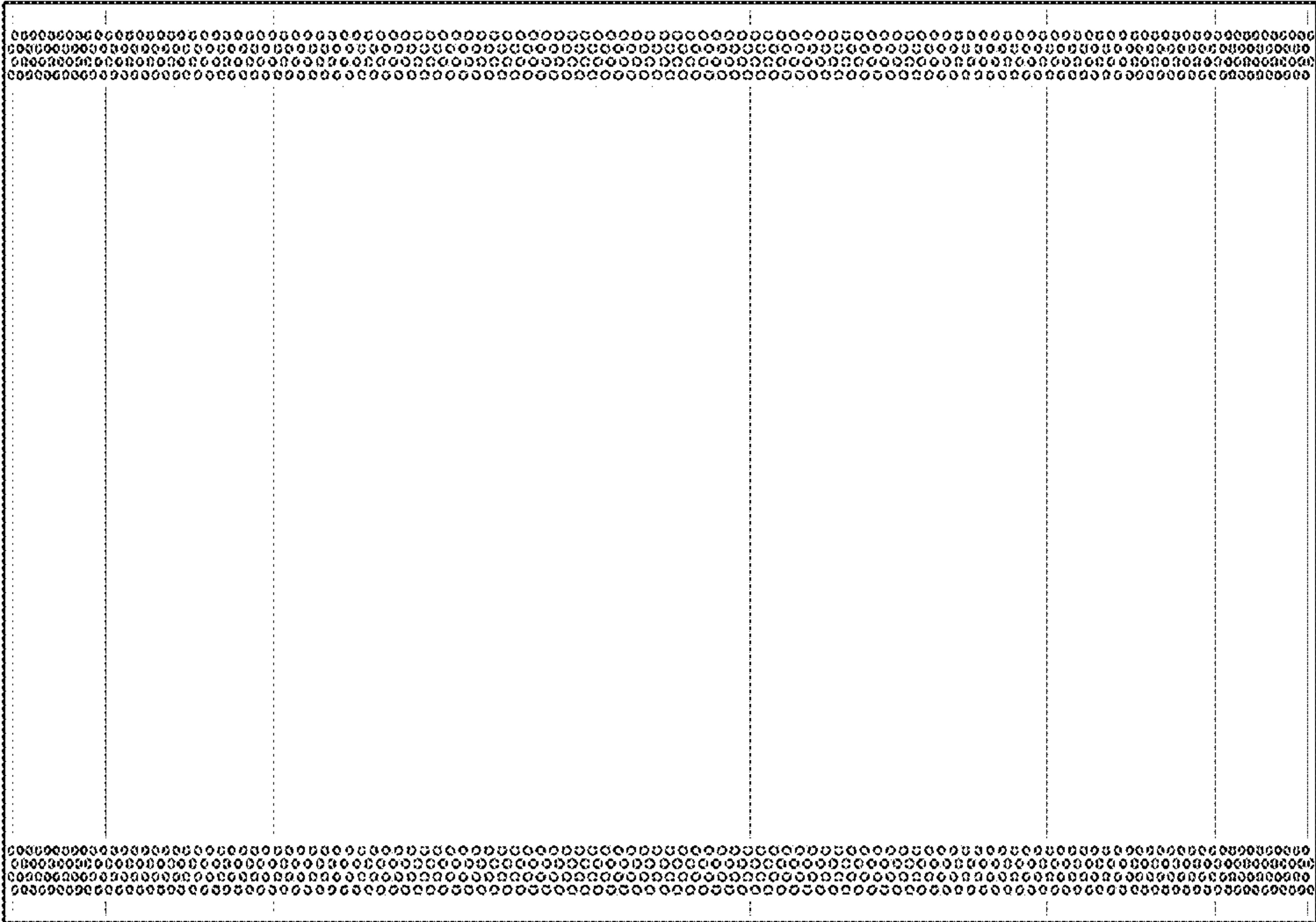

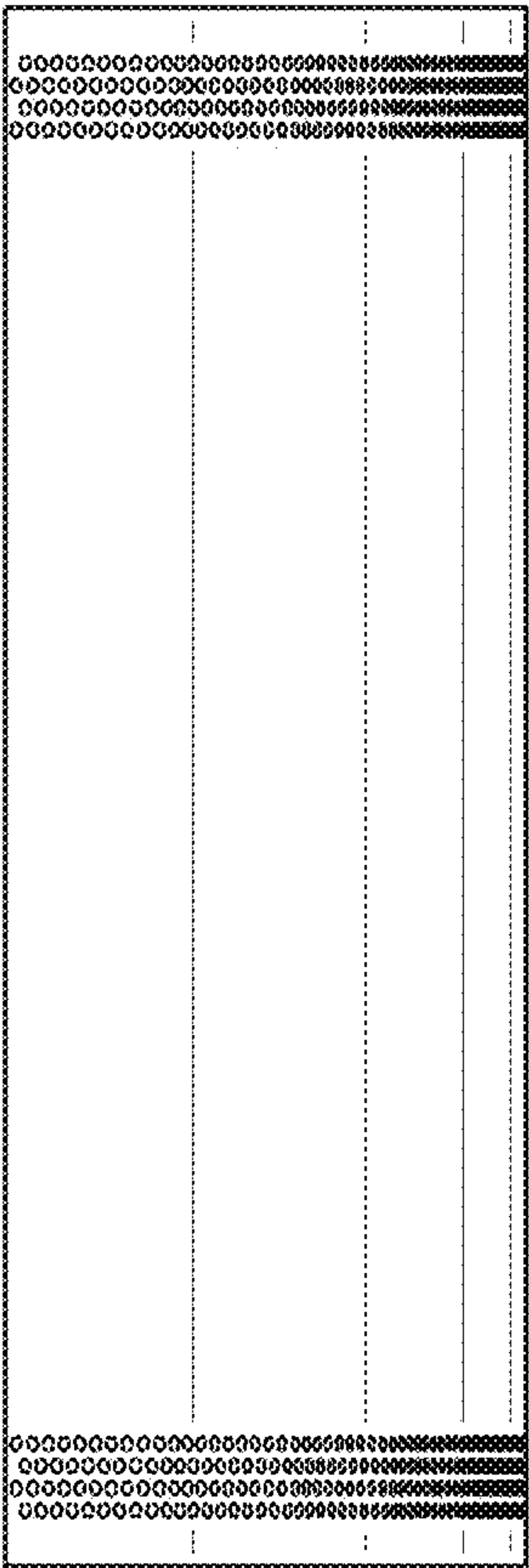

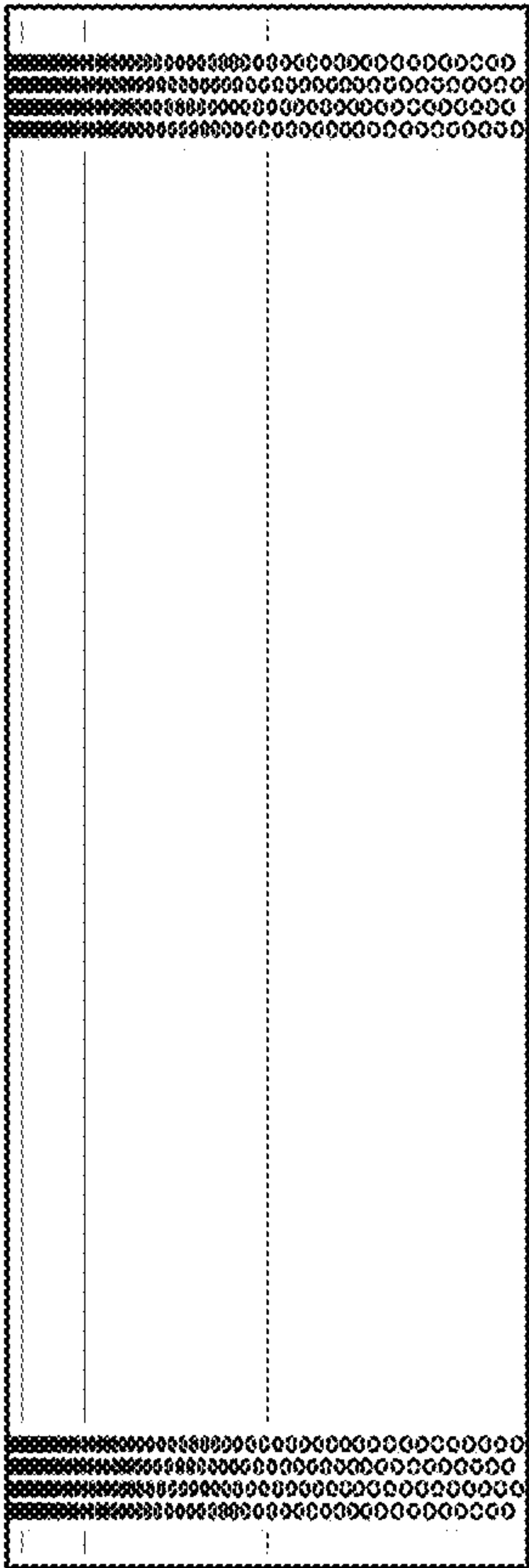

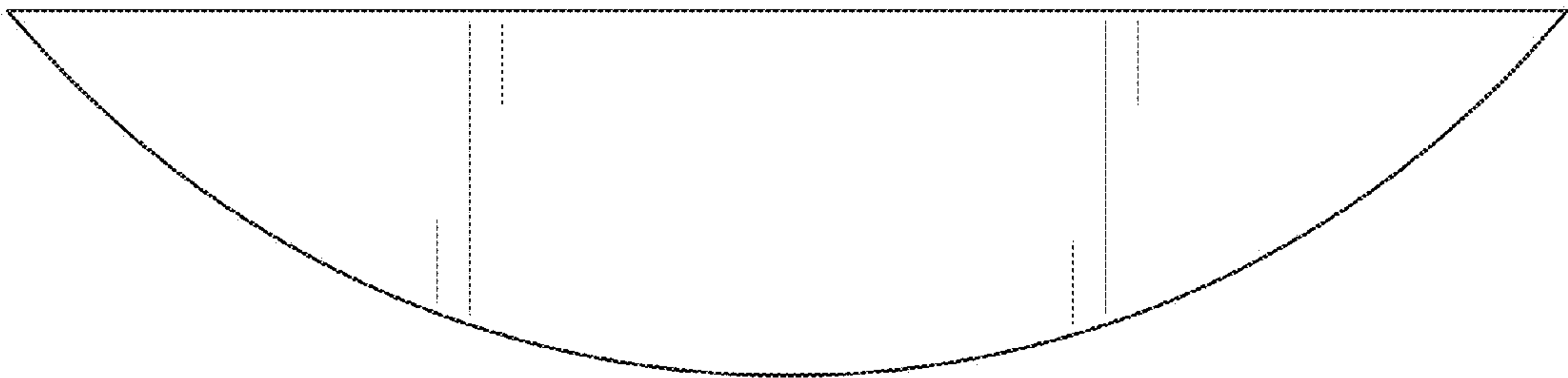

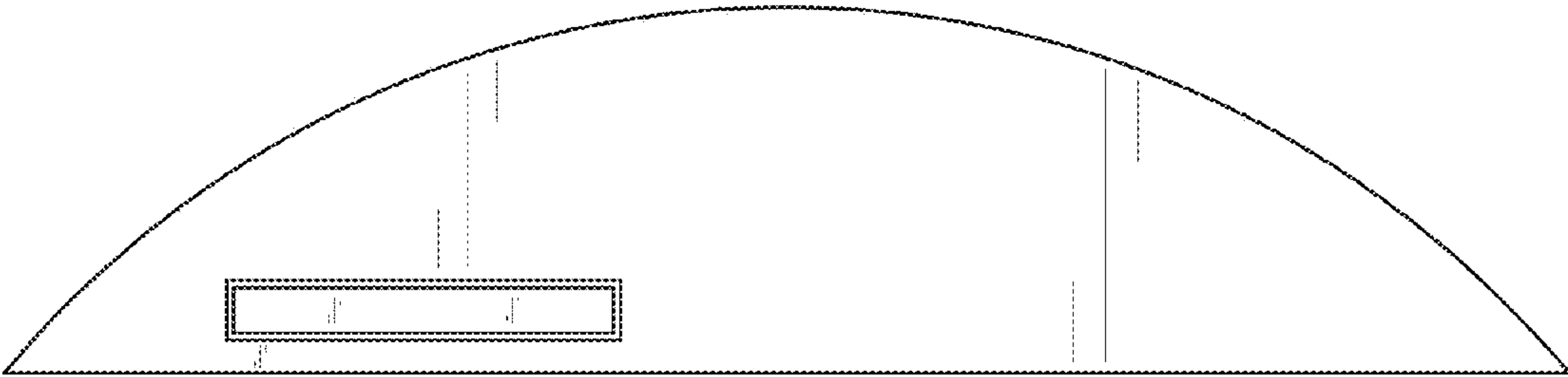
