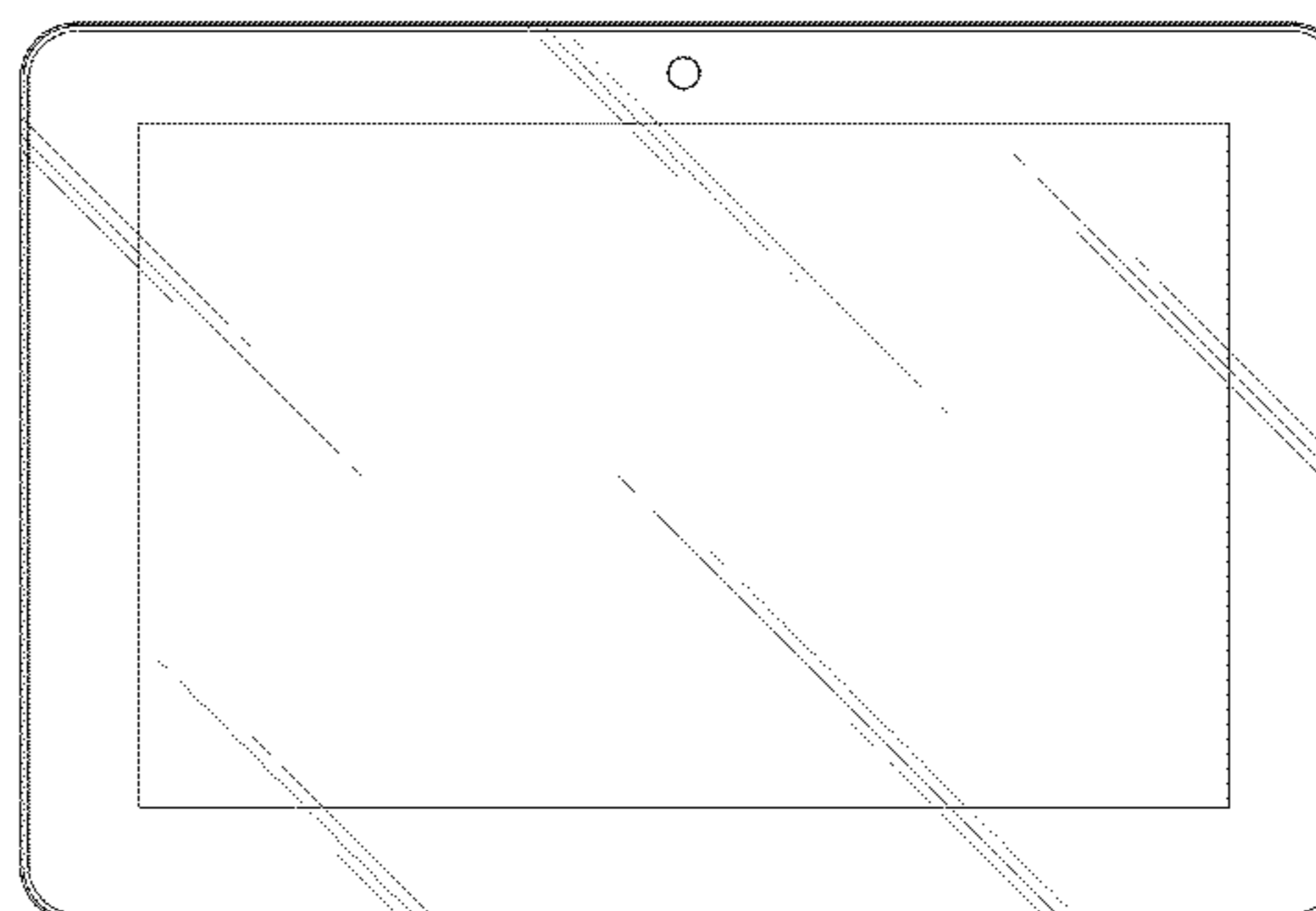
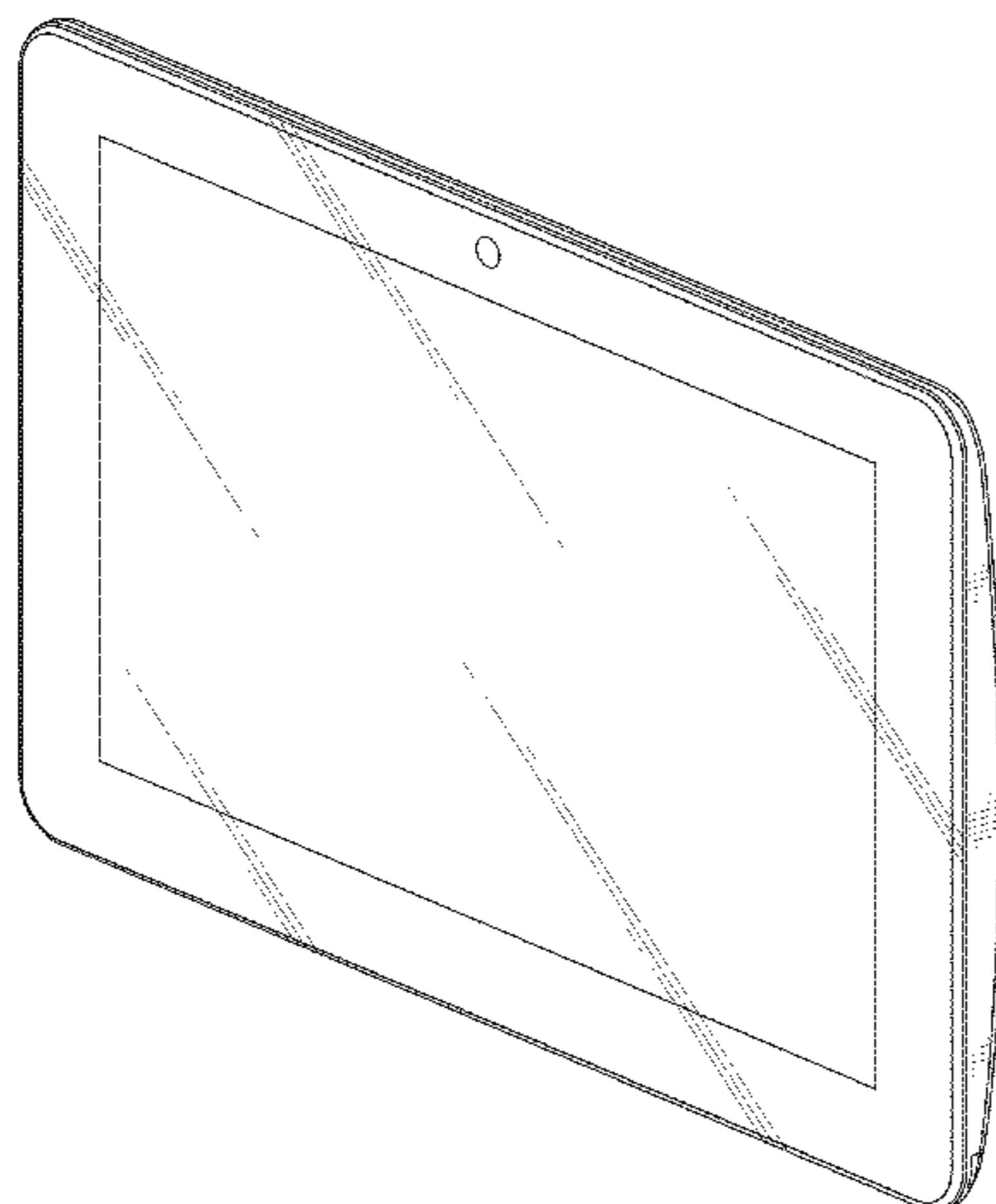
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of front, top and right side of a personal computer showing our new design;

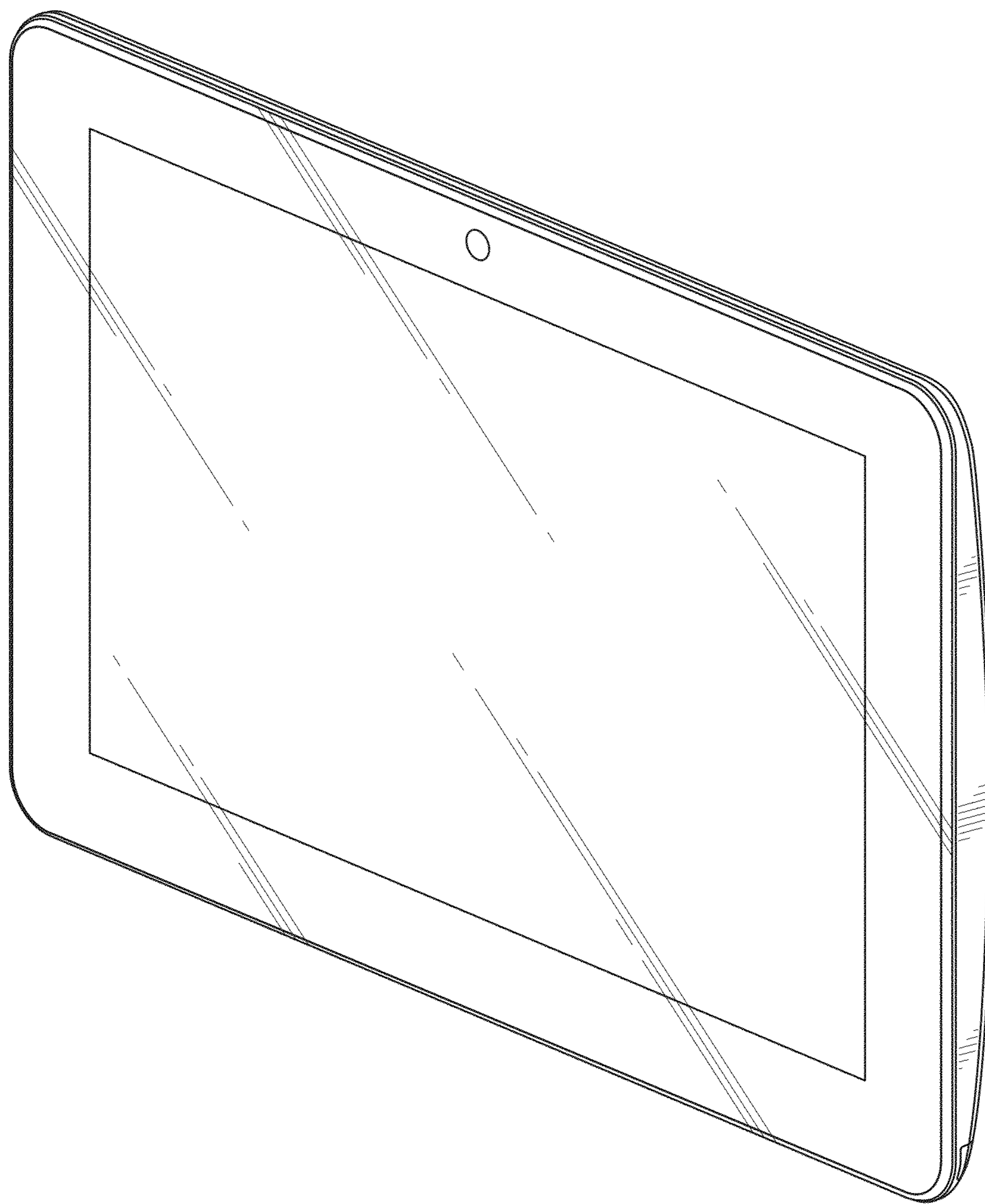

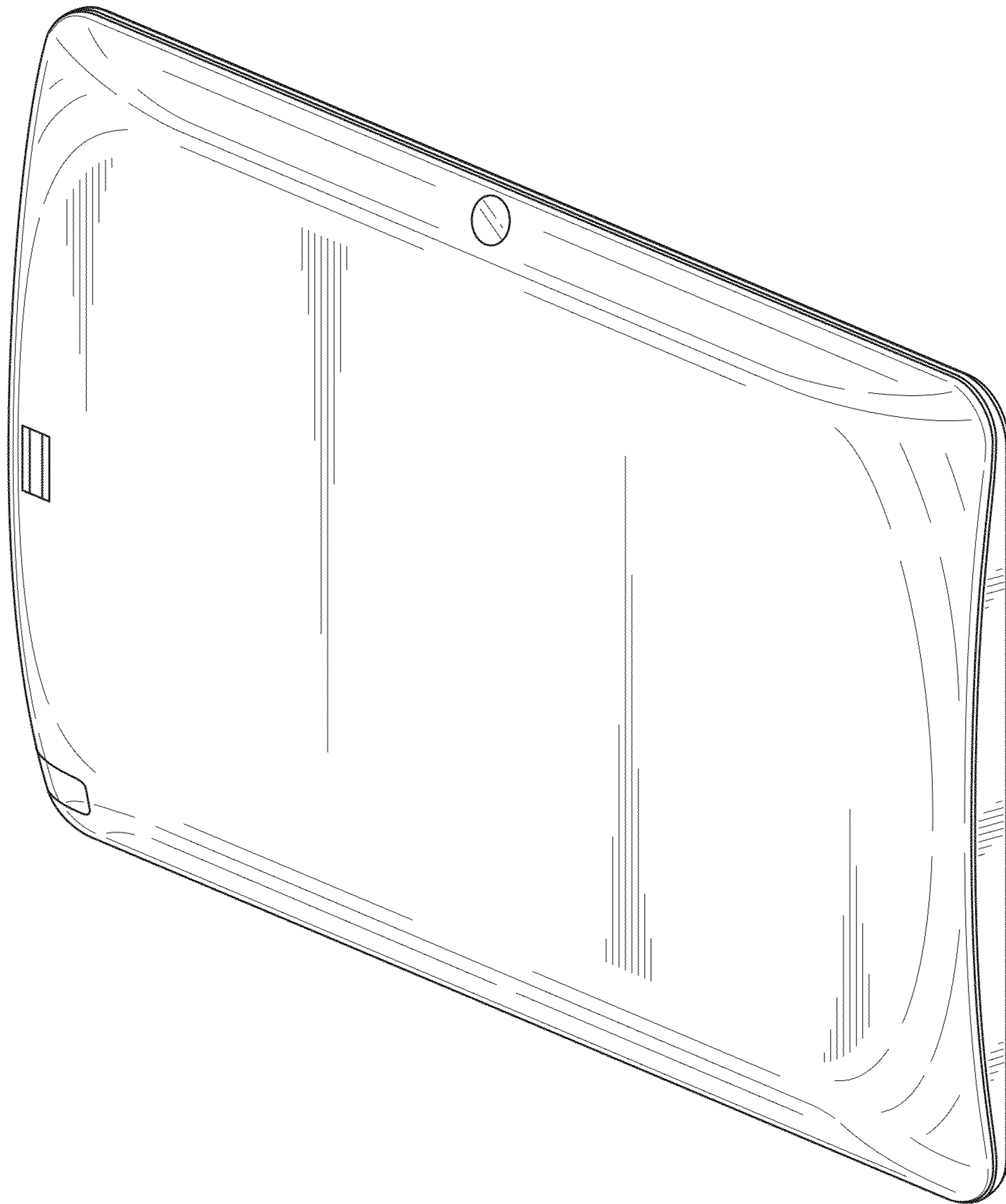

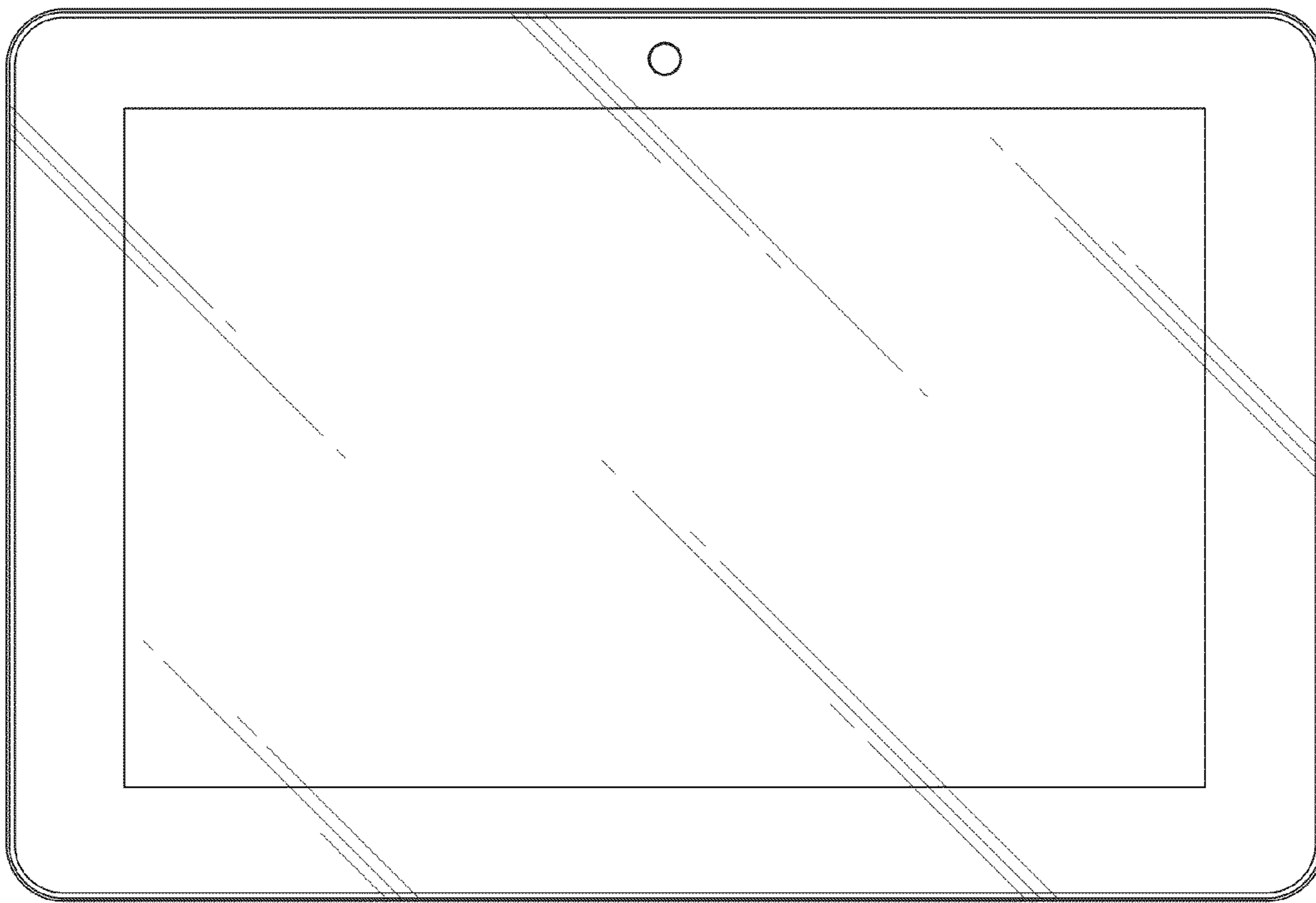

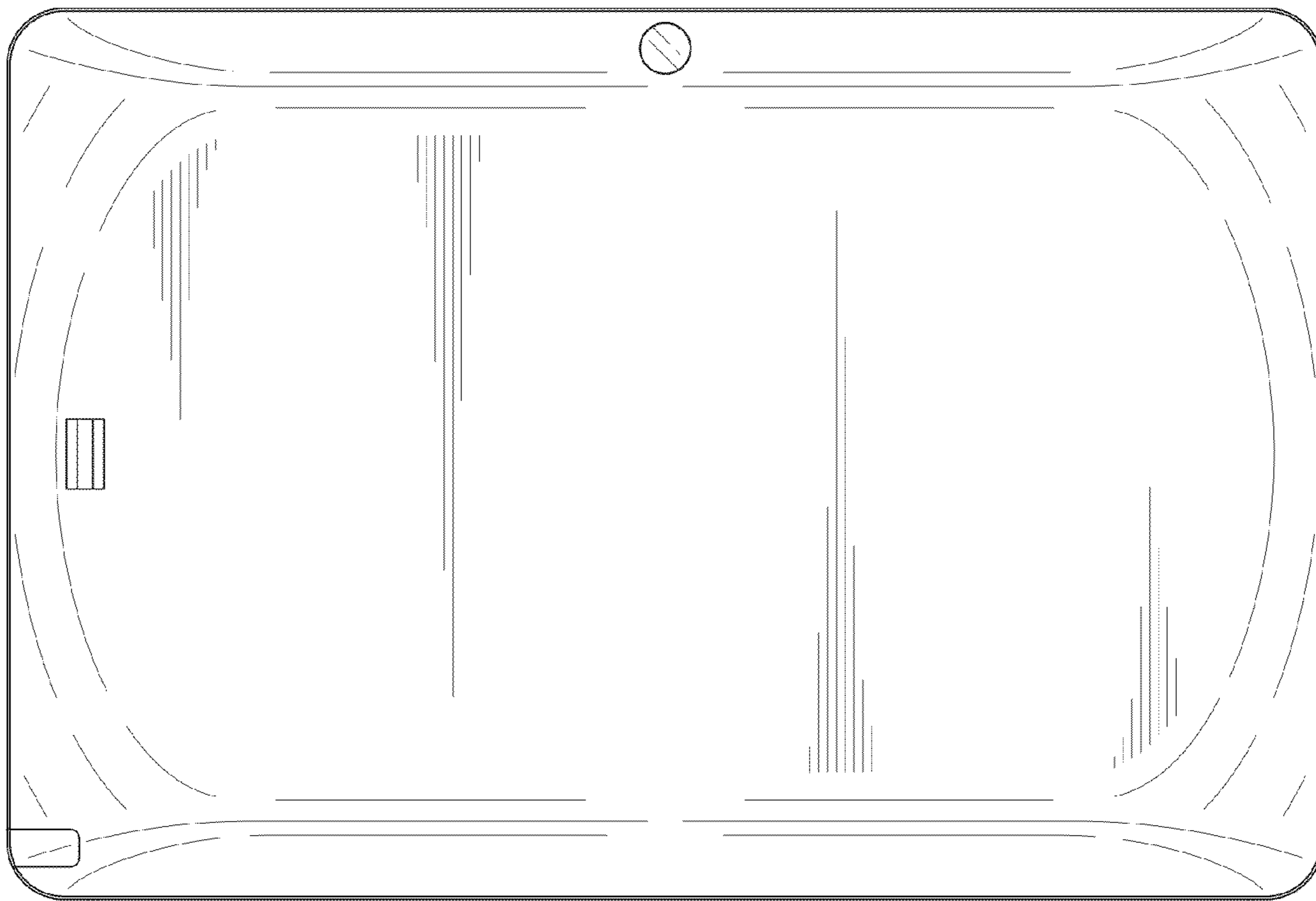

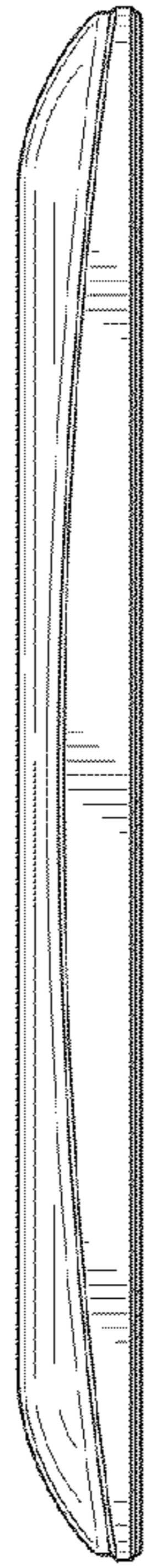

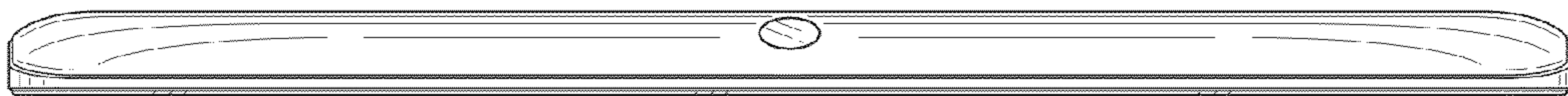
