(57) **CLAIM**

The ornamental design for a portion of a display screen with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first image of a first embodiment of a portion of a display screen with animated graphical user interface showing our new design;

FIG. 2 is a front view of a second image thereof;

FIG. 3 is a front view of a third image thereof;

FIG. 4 is a front view of a first image of a second embodiment of a portion of a display screen with animated graphical user interface showing our new design;

FIG. 5 is a front view of a second image thereof;

FIG. 6 is a front view of a third image thereof;

FIG. 7 is a front view of a first image of a third embodiment of a portion of a display screen with animated graphical user interface showing our new design;

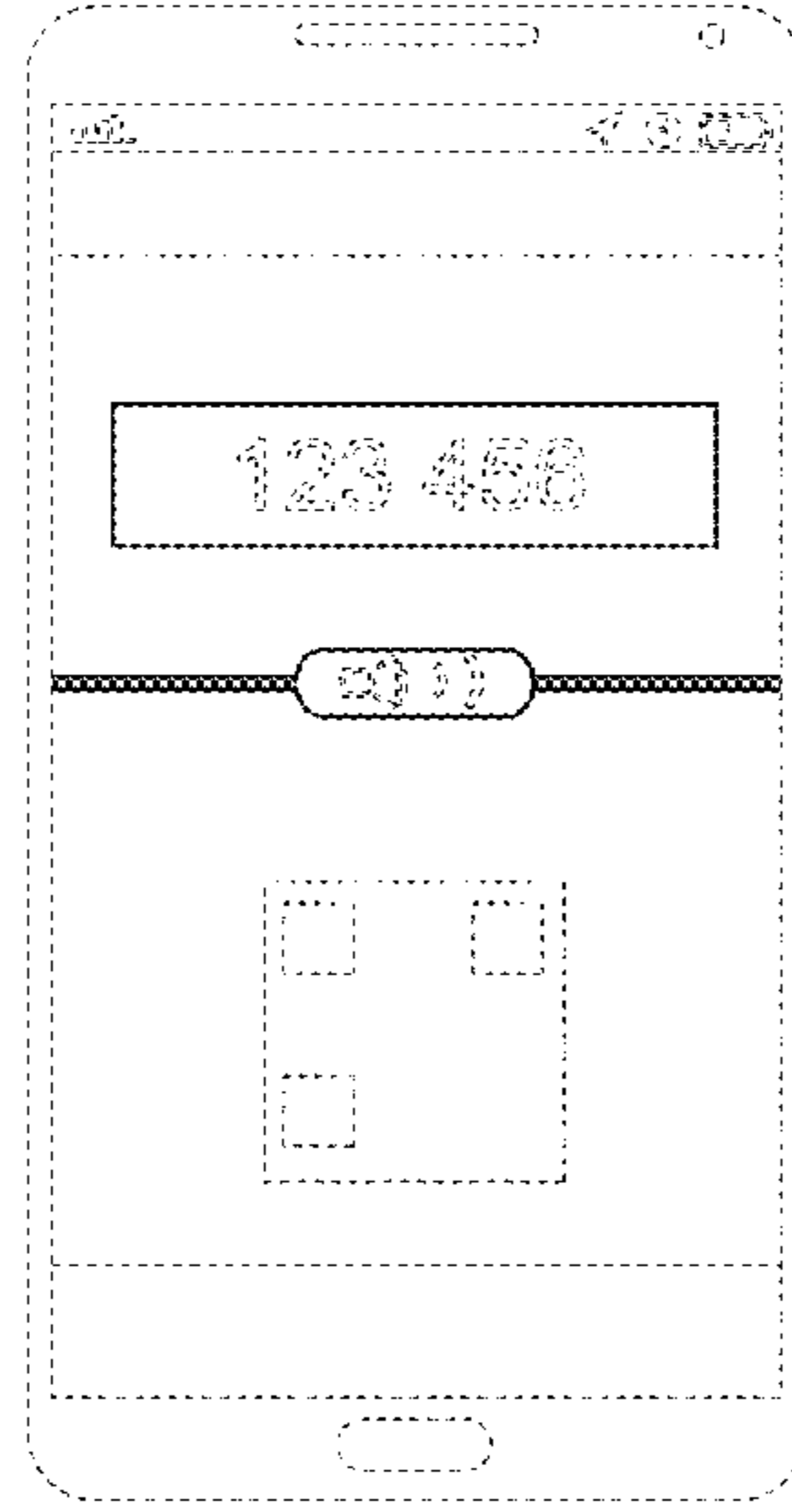
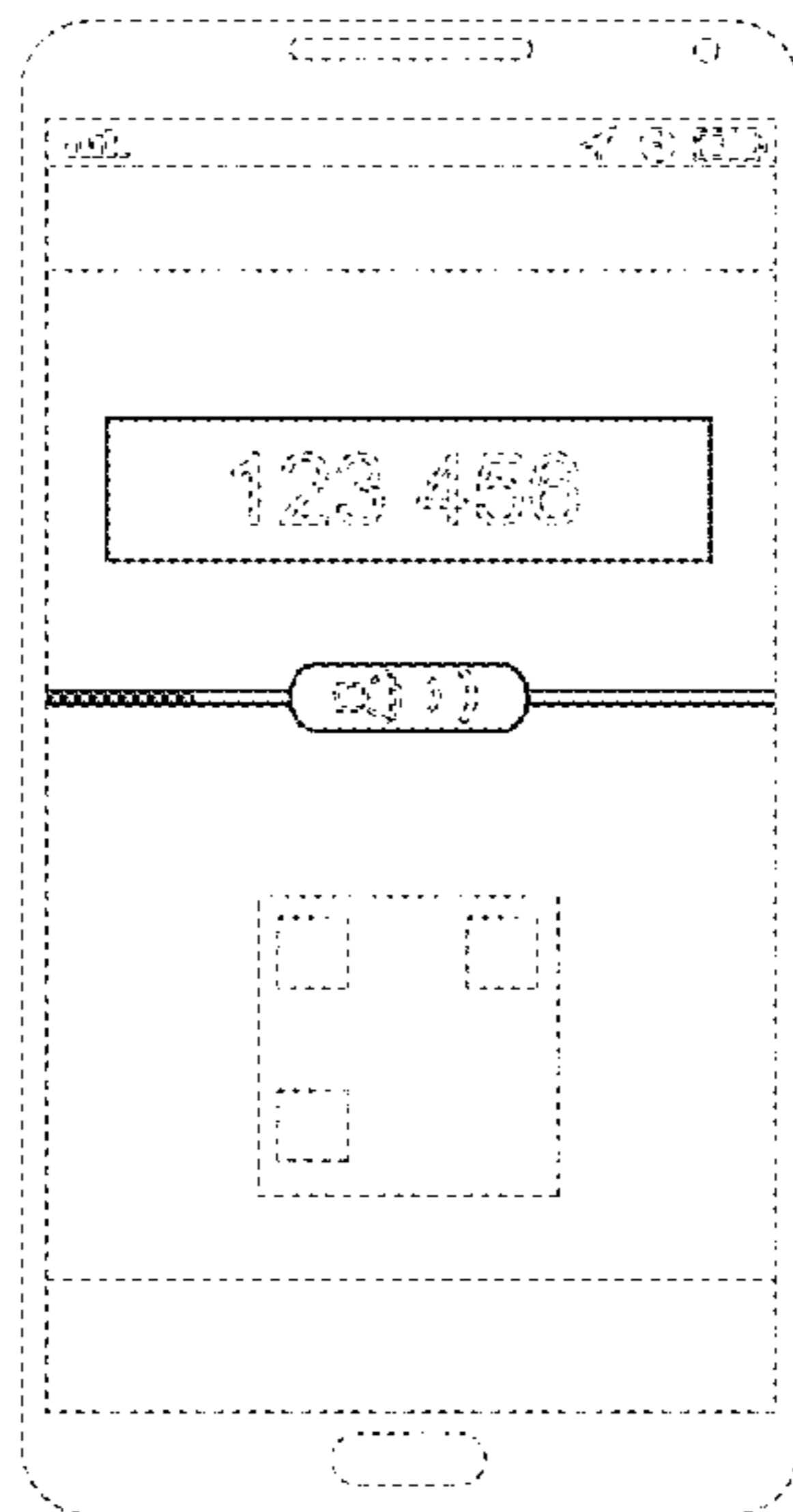
FIG. 8 is a front view of a second image thereof; and,

FIG. 9 is a front view of a third image thereof.

In the first embodiment, the appearance of the transitional image sequentially transitions between the images shown in FIGS. 1 through 3. In the second embodiment, the appearance of the transitional image sequentially transitions between the images shown in FIGS. 4 through 6. In the third embodiment, the appearance of the transitional image sequentially transitions between the images shown in FIGS. 7 through 9. The process or period in which one image transitions to another image forms no part of the claimed design. The broken line showing of a portion of a display screen in FIGS. 1 through 9 forms no part of the claimed design. The broken line showing of text and portions of the graphical user interface in FIGS. 1 through 9 represents environmental subject matter and forms no part of the claimed design.

The greyscale fill appearing in the progress bar in FIGS. 1-2, 4-5 and 7-8 represents a portion of the progress bar that is a different color and/or is darker than the color appearing in any portion of the progress bar that does not have greyscale fill.

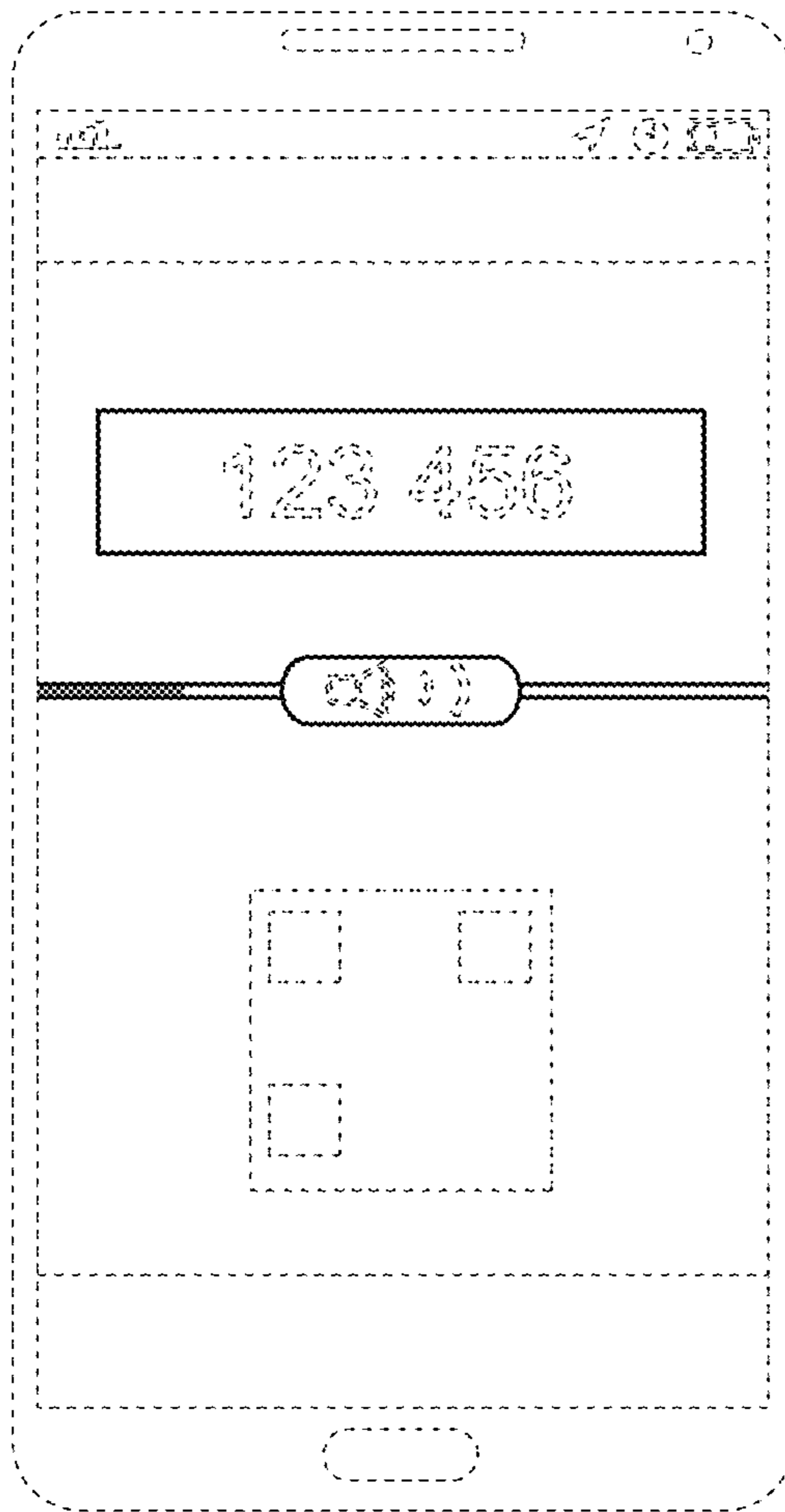

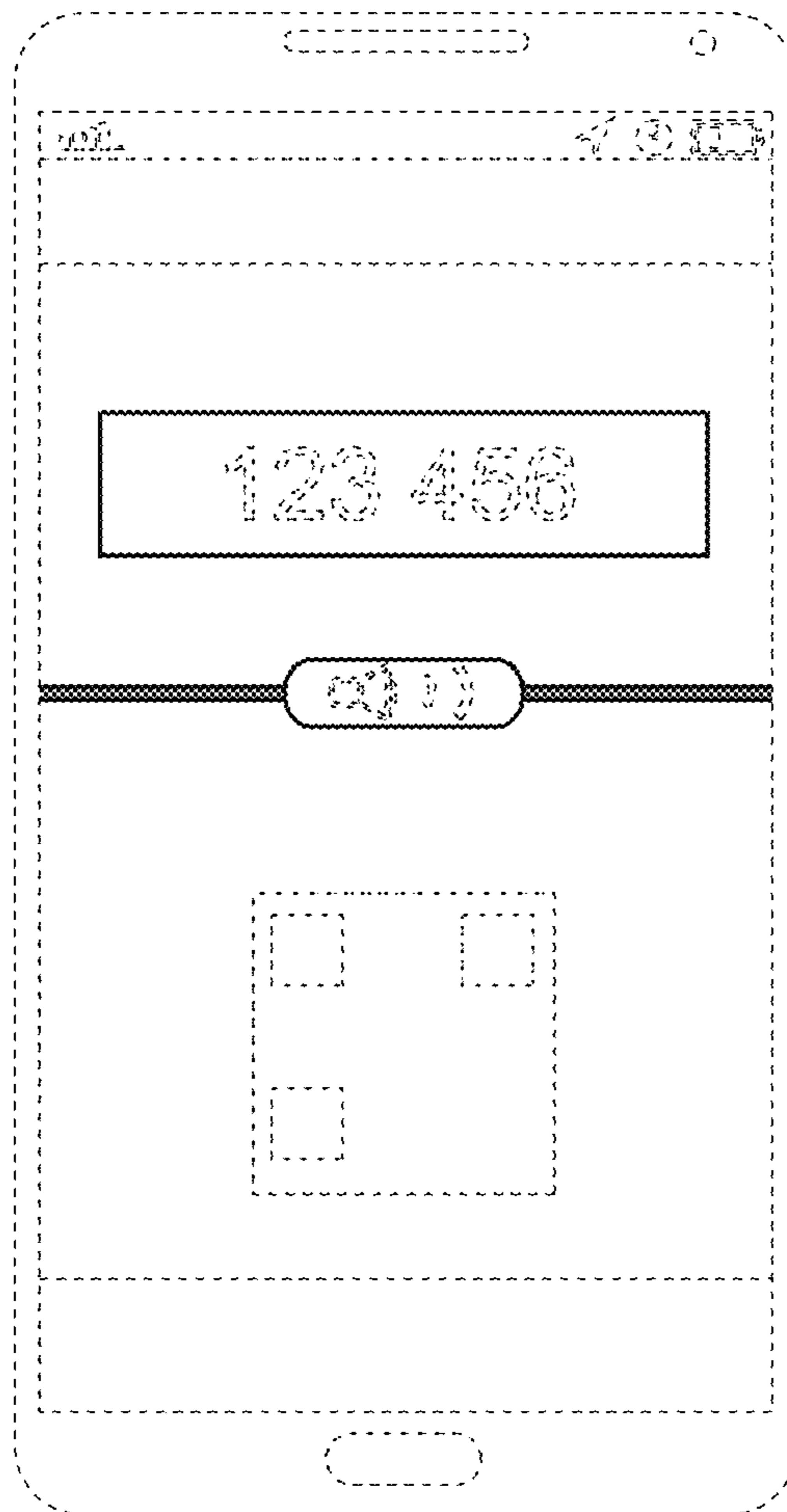

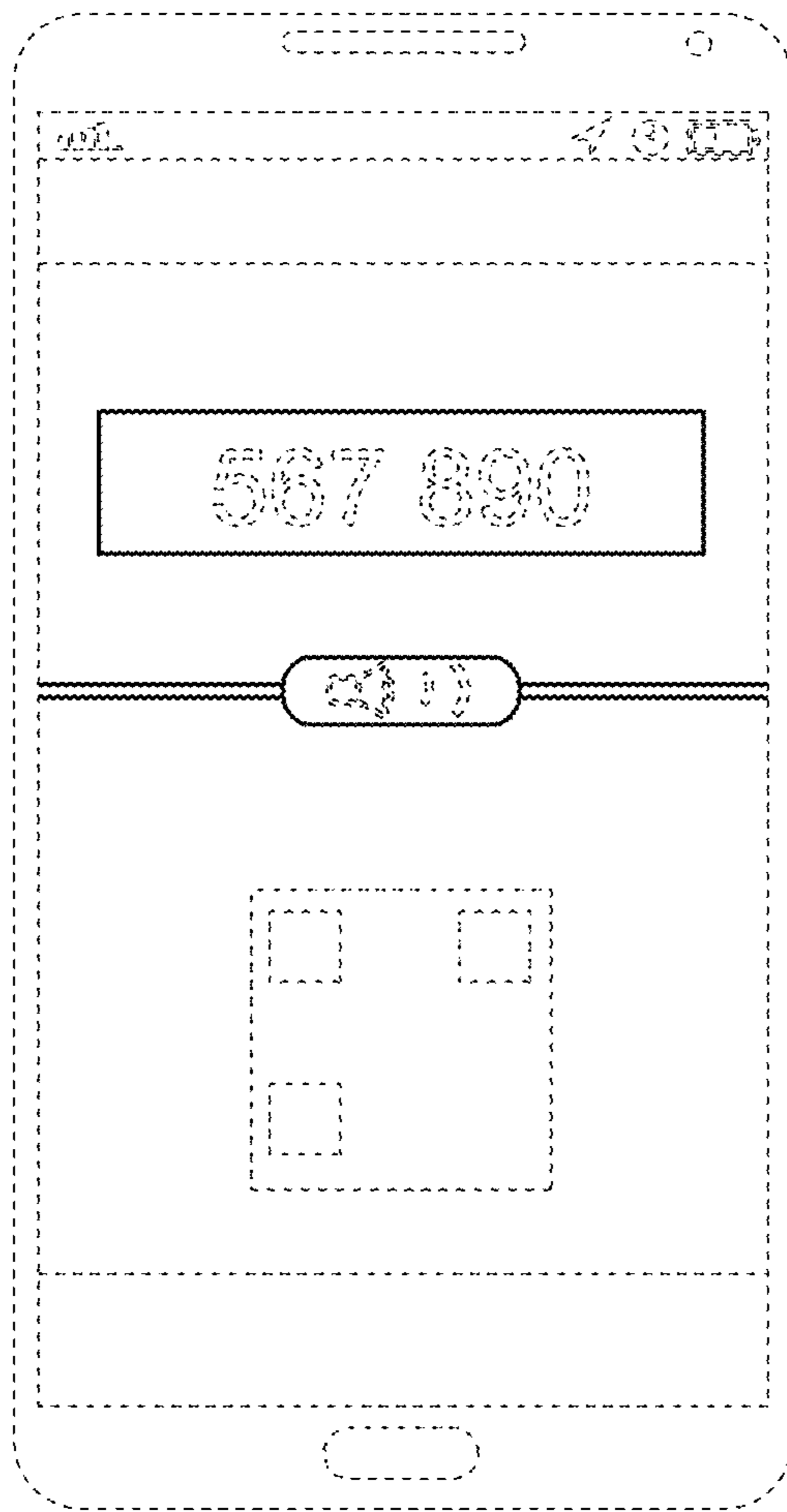

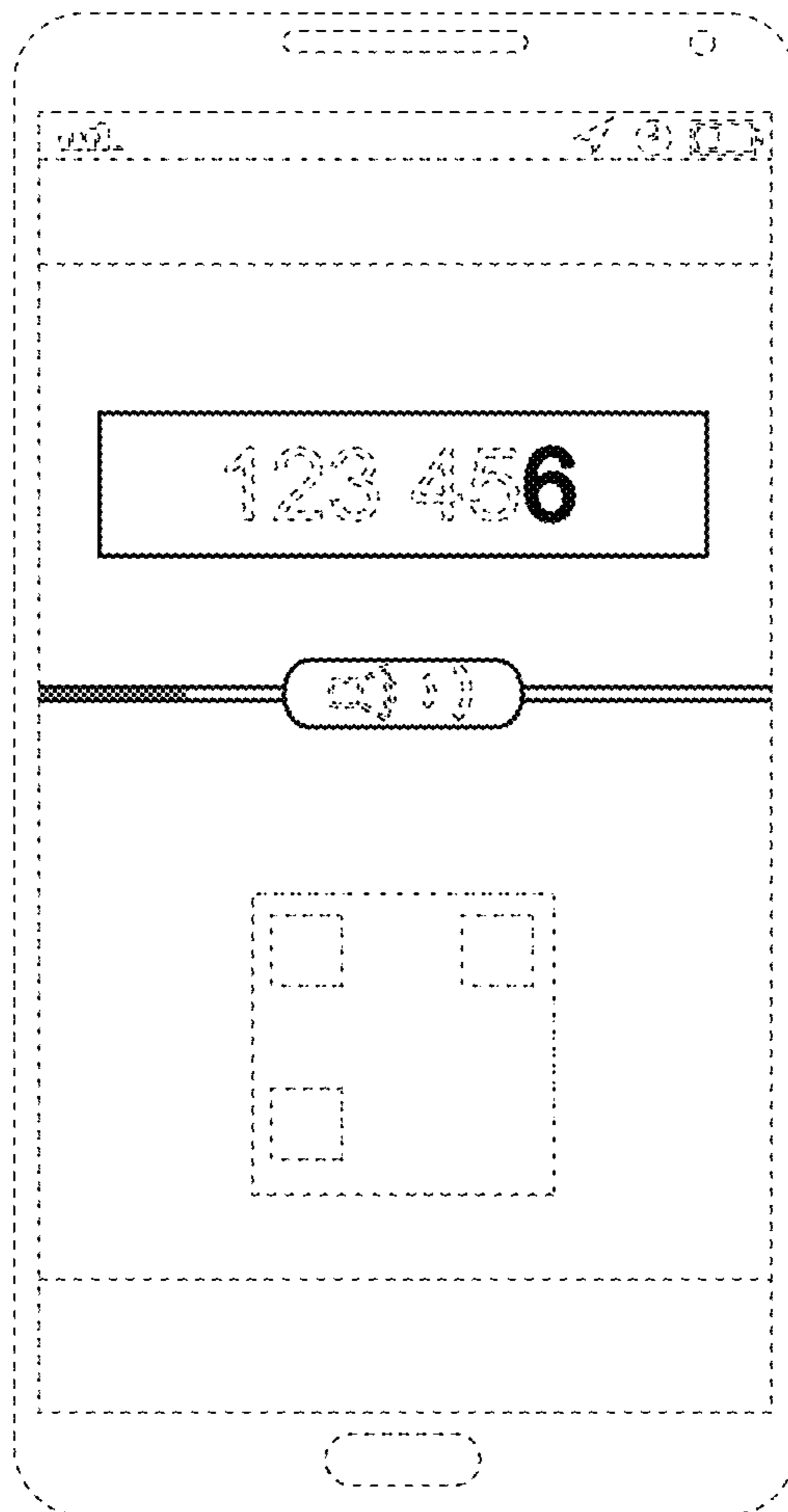

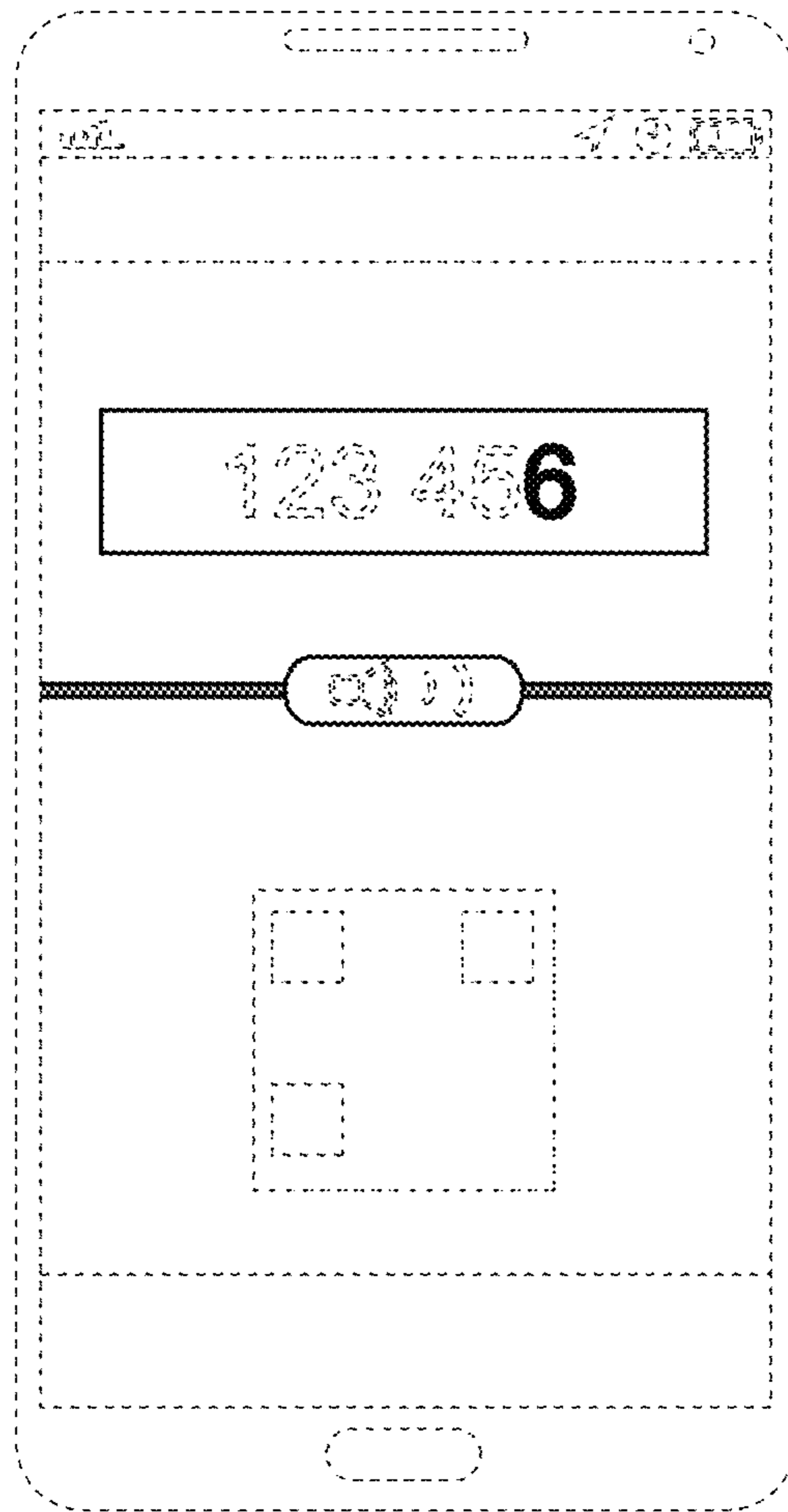

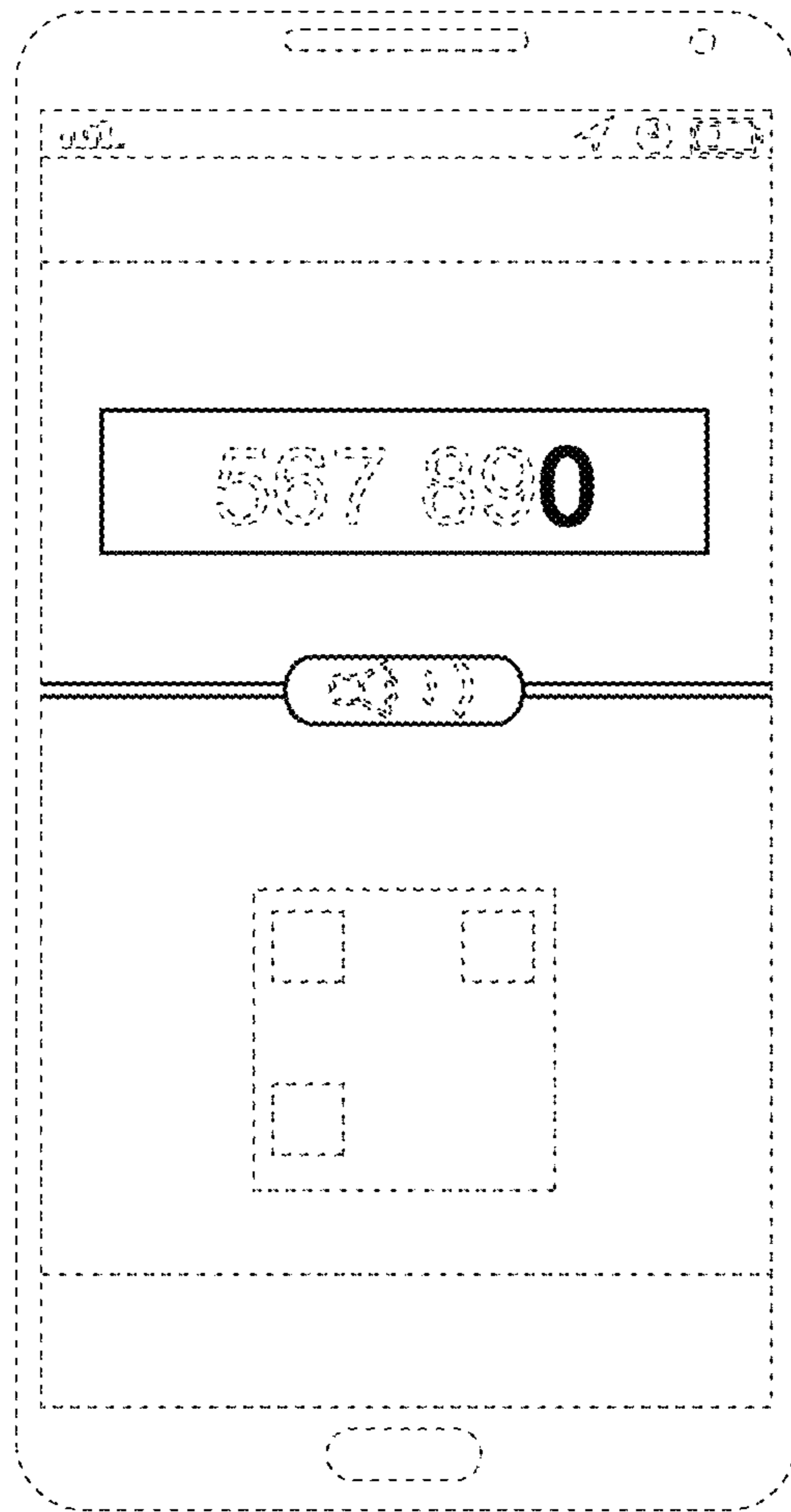

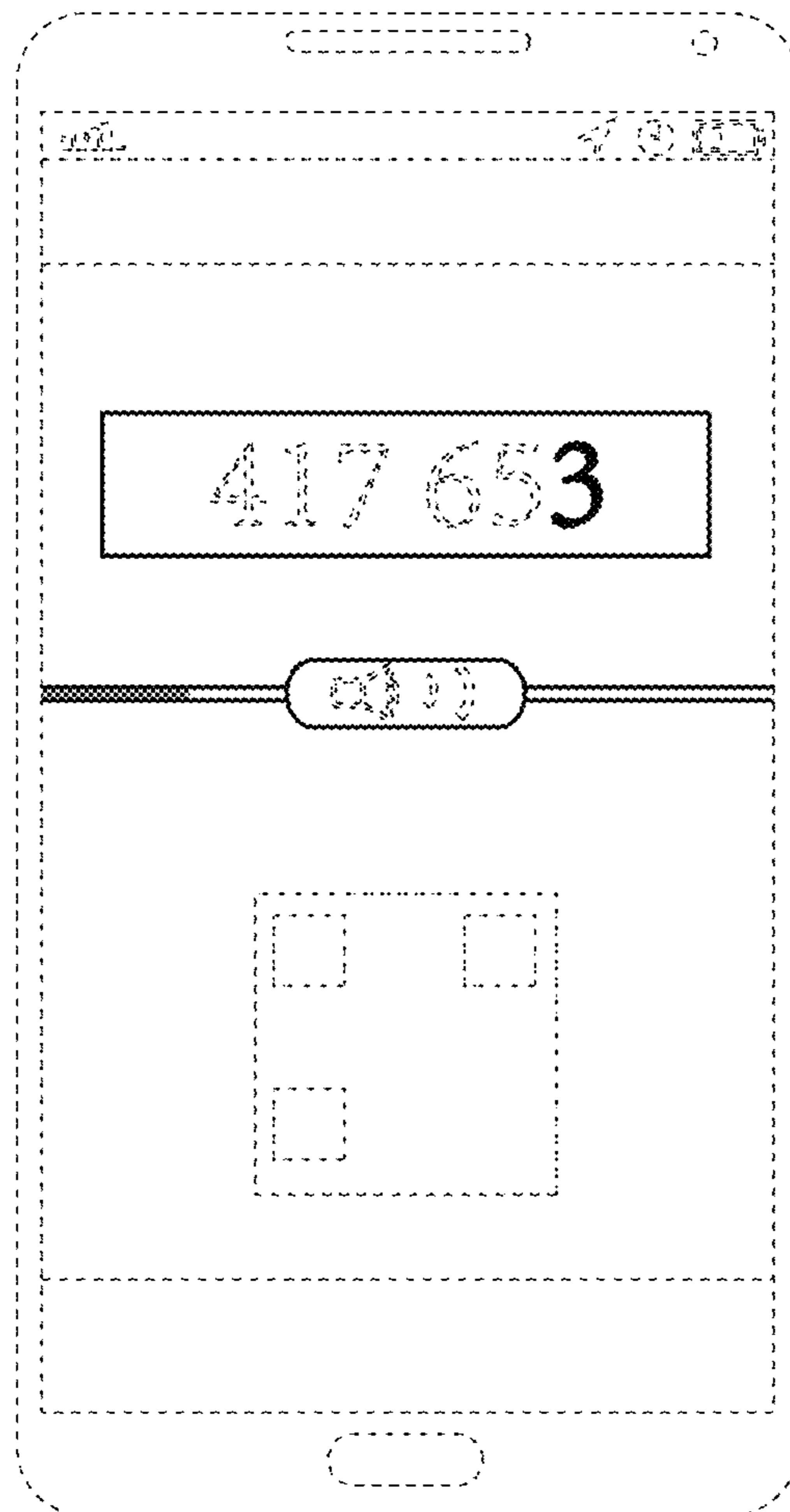

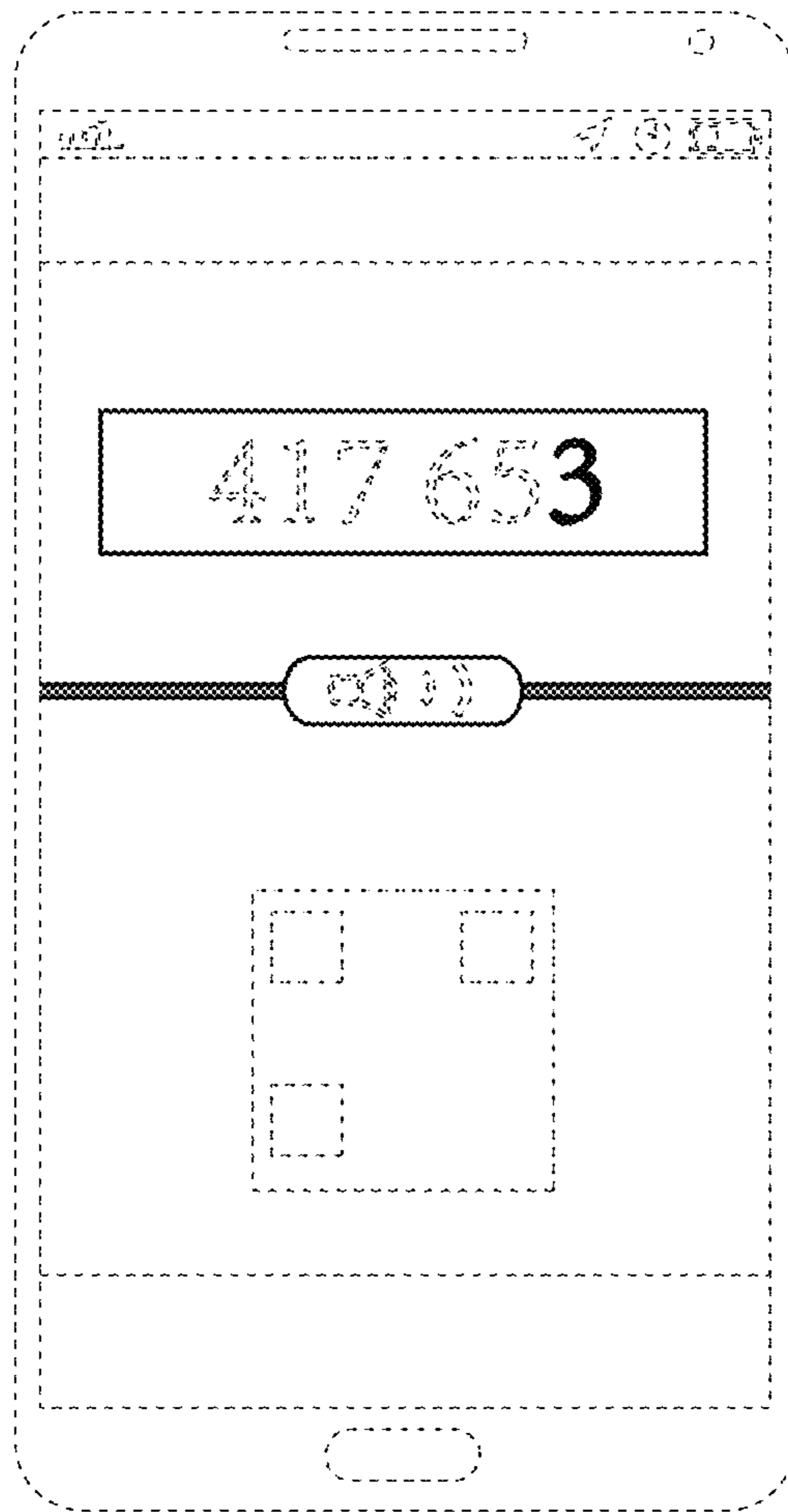

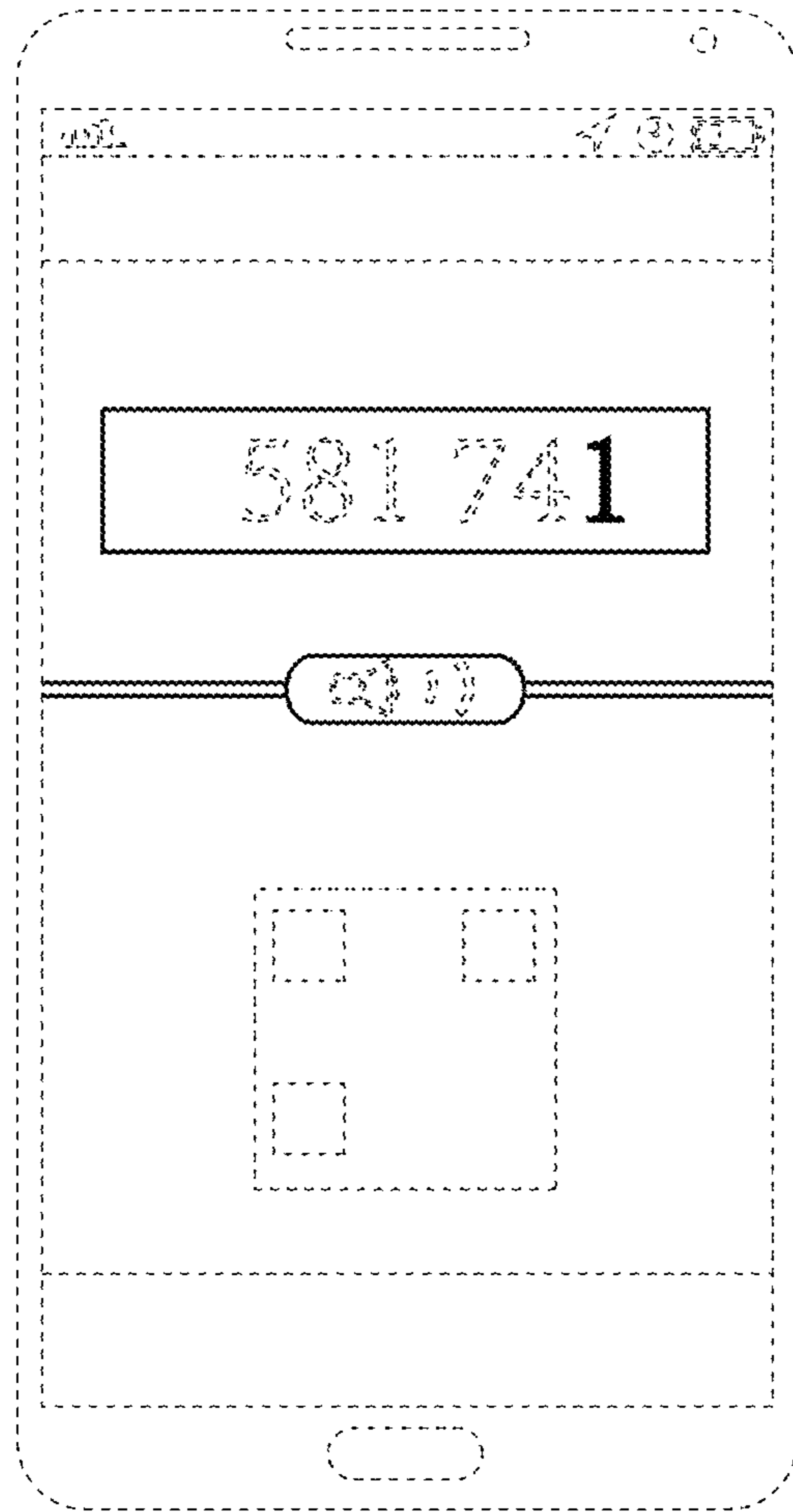
