(57) **CLAIM**

I claim the ornamental design for a training bag cover with fighter and buckle, as shown and as described.

DESCRIPTION

FIG. 1 is a perspective view of the front of the training bag cover with fighter and buckle.

FIG. 2 is the front view of the training bag cover with fighter and buckle.

FIG. 3 is a back view of the training bag cover with fighter and buckle.

FIG. 4 is a side view of the training bag cover with fighter and buckle.

FIG. 5 is the other side view of the training bag cover with fighter and buckle.

FIG. 6 is a top view of the training bag cover with fighter and buckle.

FIG. 7 is the bottom view of the training bag cover with fighter and buckle.

FIG. 8 is a perspective front view of the training bag cover with fighter and buckle, shown attached to a punching bag.

FIG. 9 is a perspective back view of the training bag cover with fighter and buckle, shown attached to a punching bag.

FIG. 10 is a back perspective view of the training bag cover with fighter and buckle with straps and buckle in an alternate position.

FIG. 11 is a perspective view of the training bag cover with fighter and buckle shown rolled-up with carrying straps in broken lines; and,

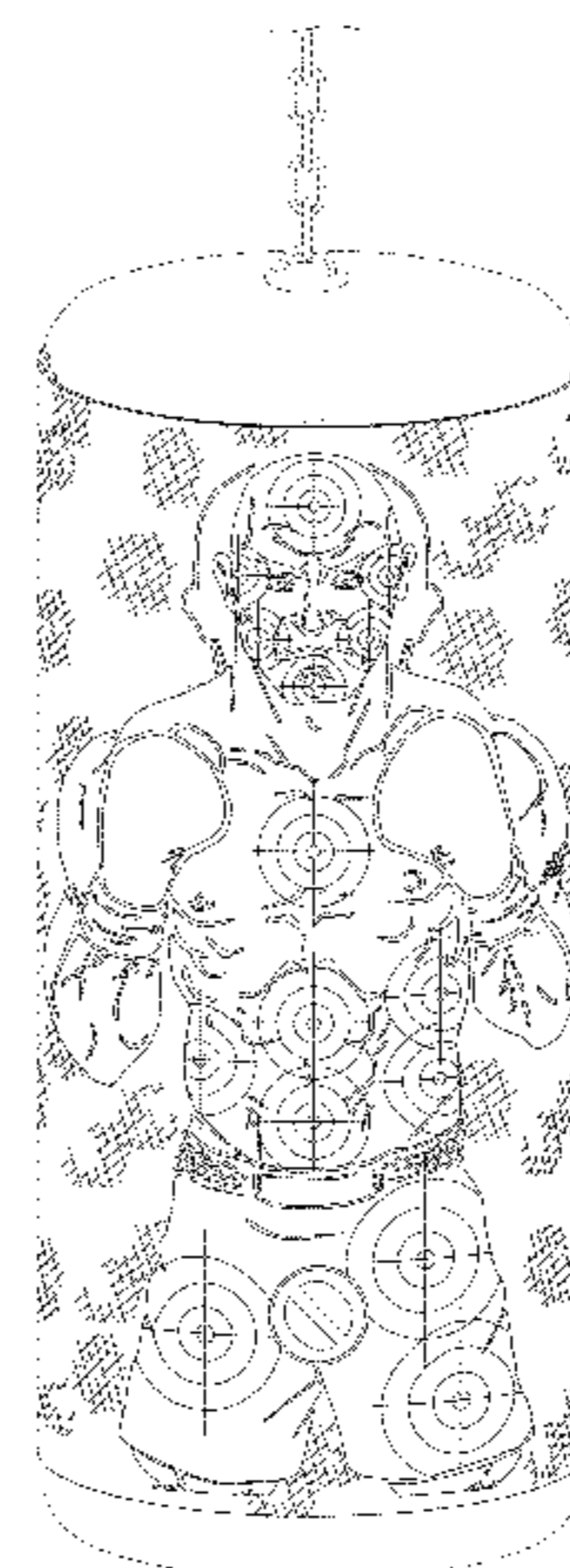
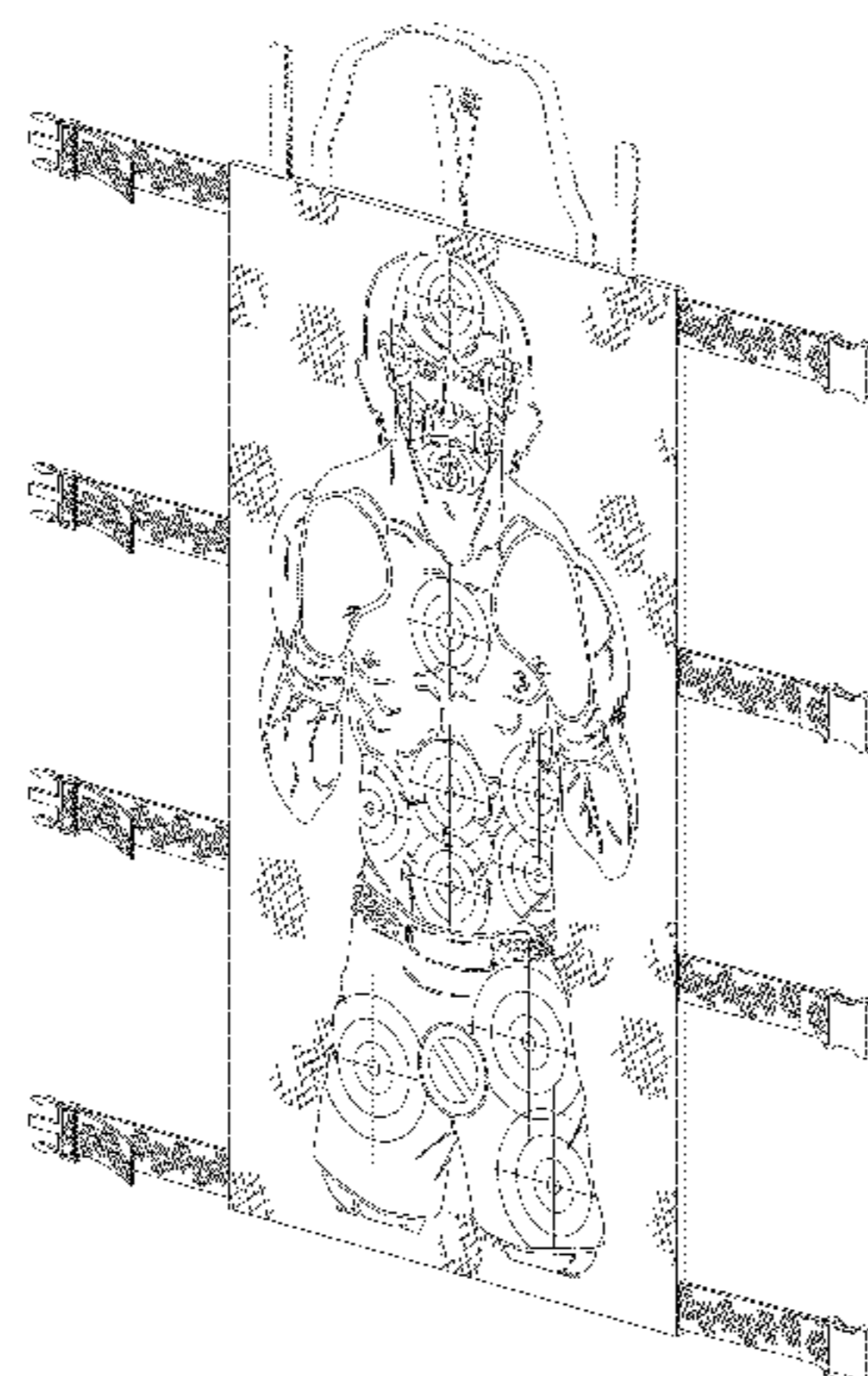
FIG. 12 is a perspective view of the training bag cover with fighter and buckle shown rolled-up with carrying straps and user in broken lines.

In FIGS. 8 and 9 the training bag and chains are shown in broken lines to represent unclaimed subject matter only and do not form part of the claimed design.

In FIGS. 1-10, 11, and 12 carrying straps are shown in broken lines to represent unclaimed subject matter only and do not form part of the claimed design.

In FIG. 12 a user is shown in broken lines to represent unclaimed subject matter only and do not form part of the claimed design.

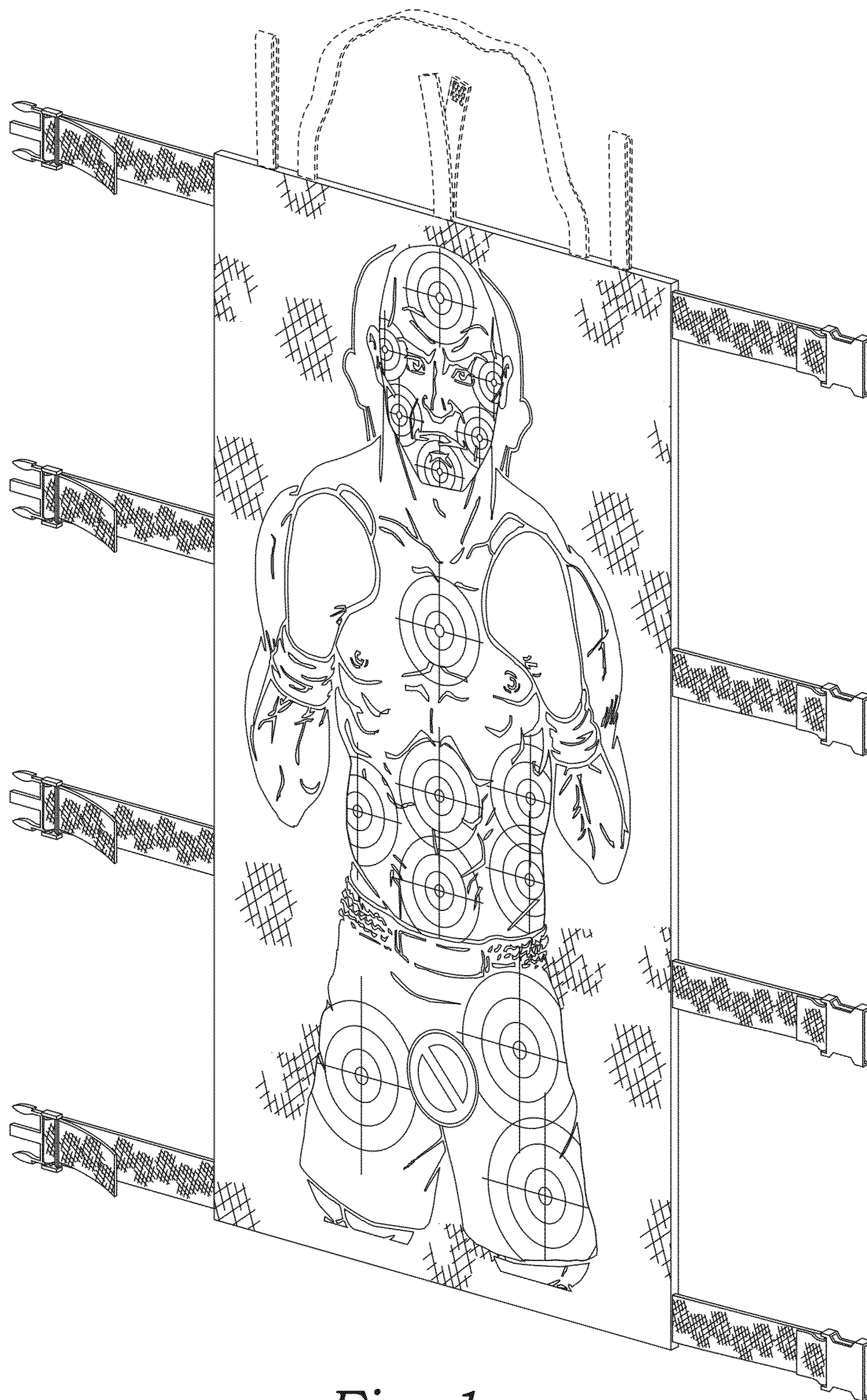

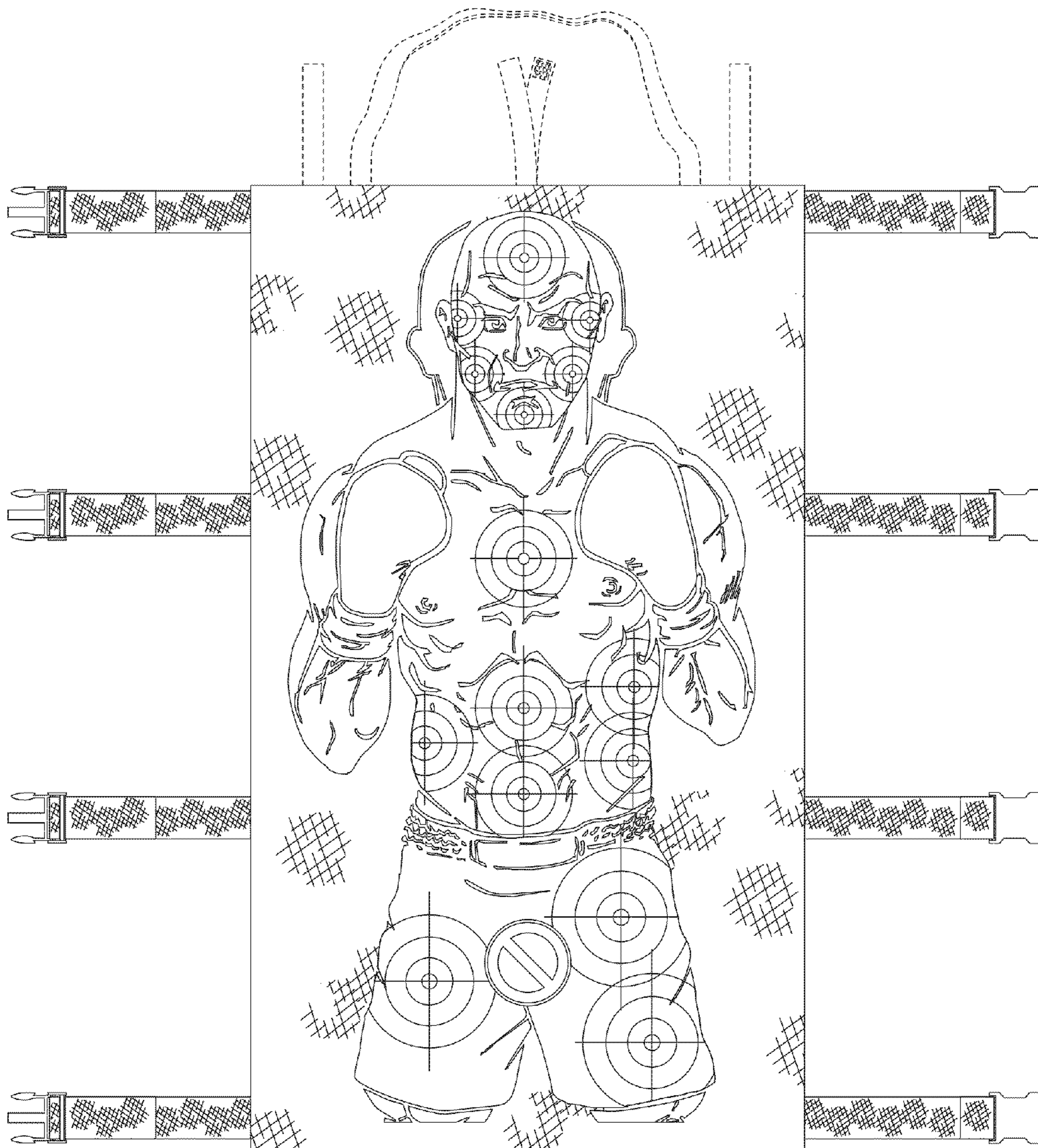

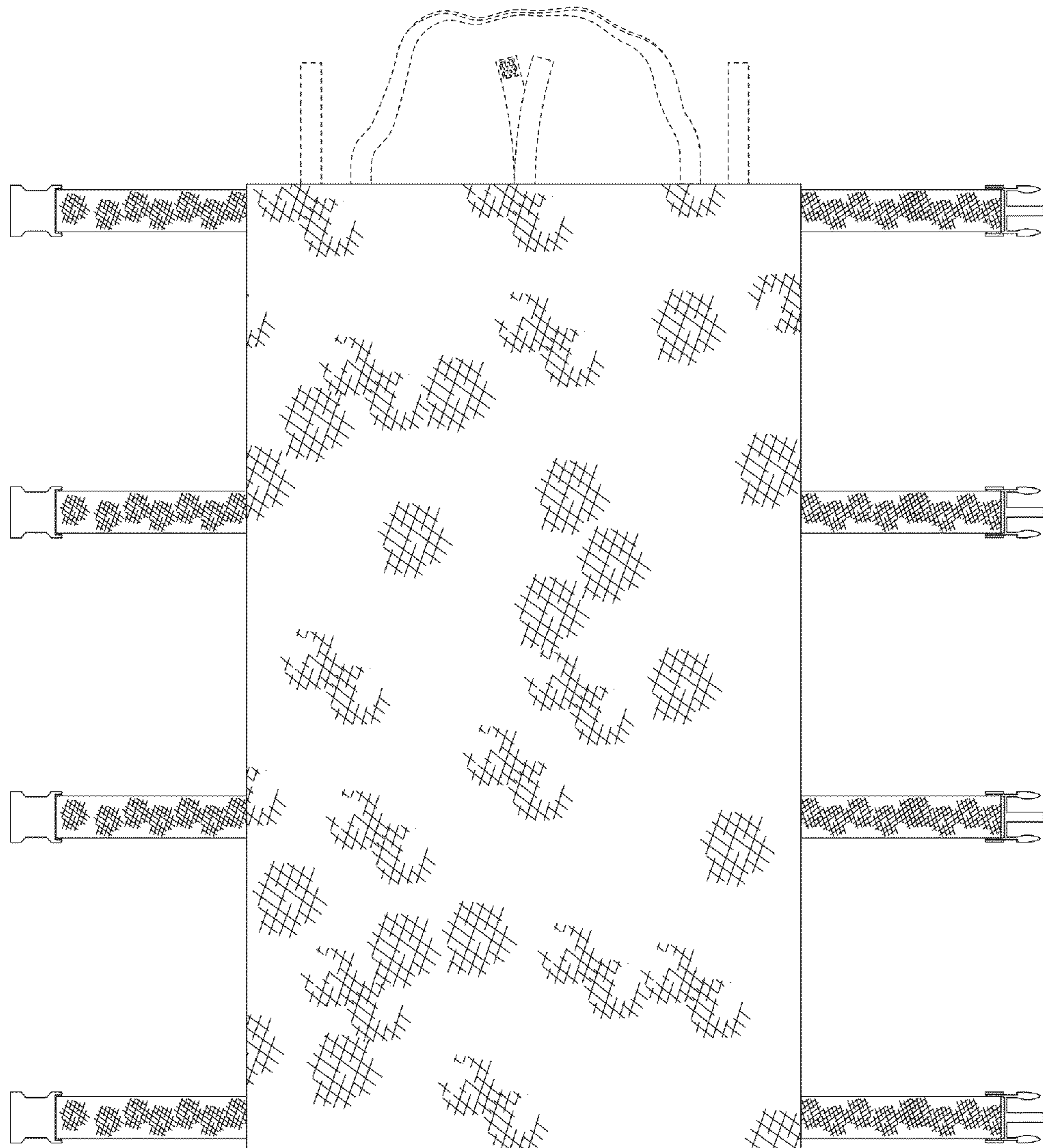
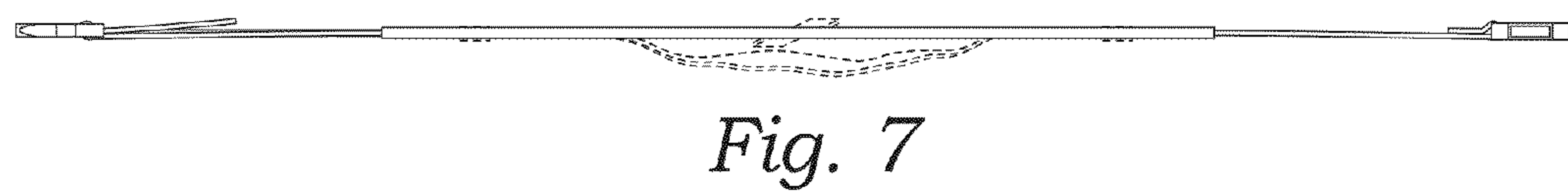
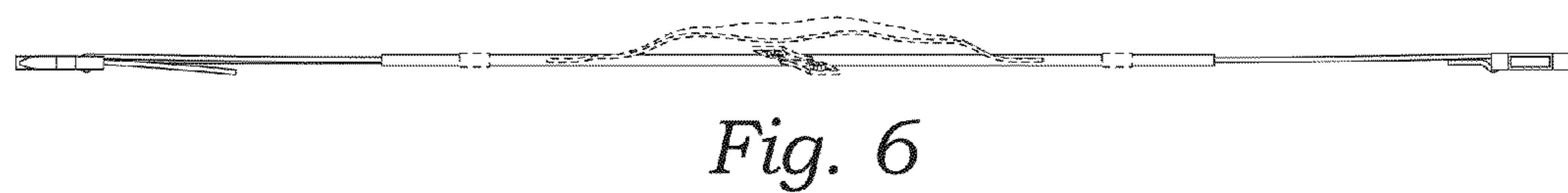
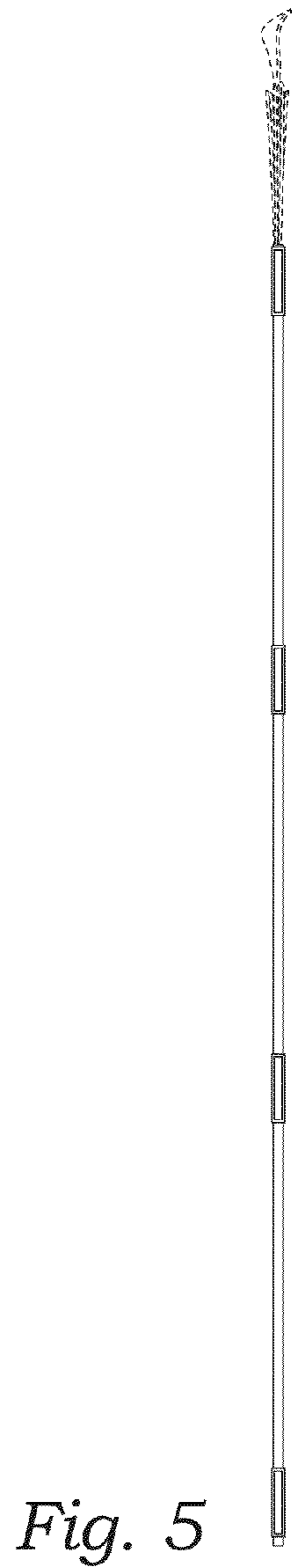
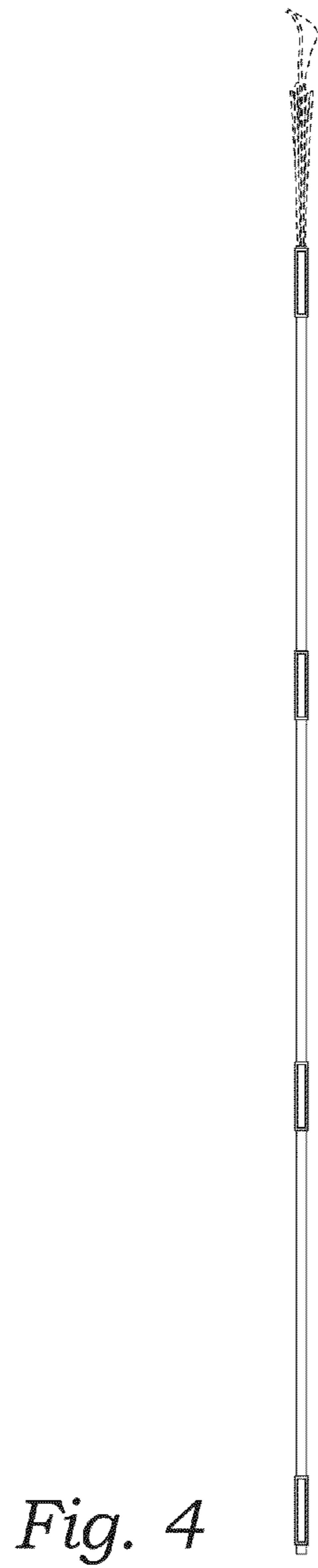

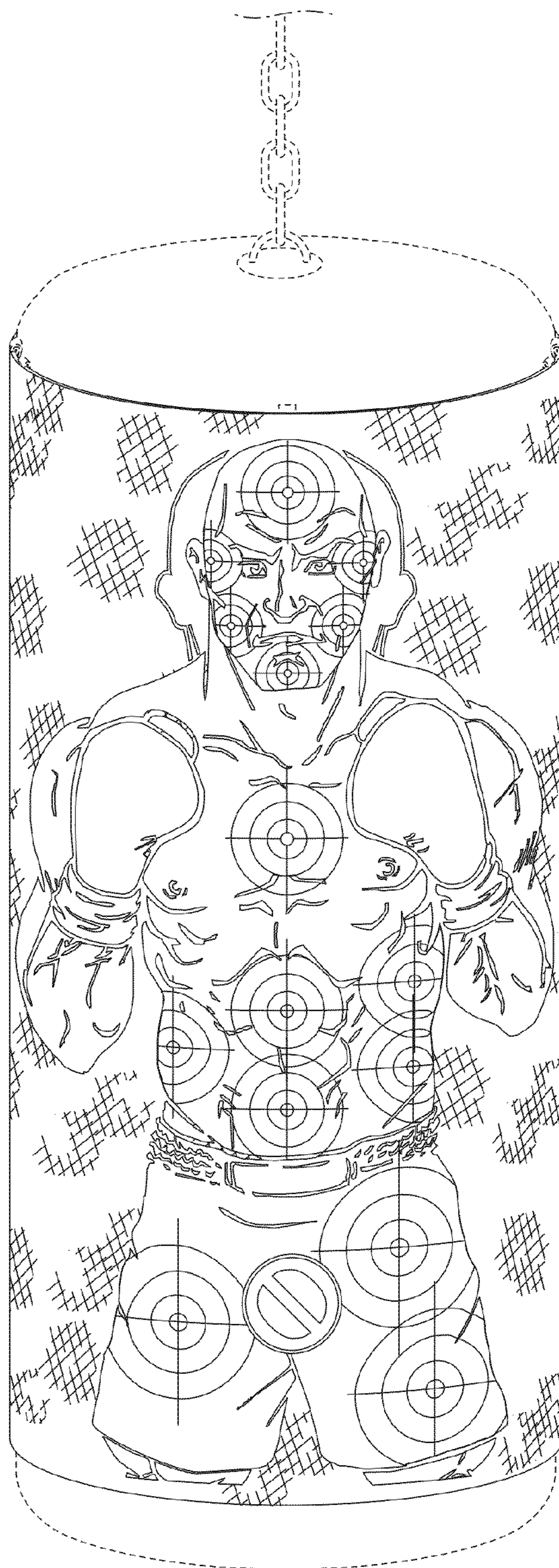

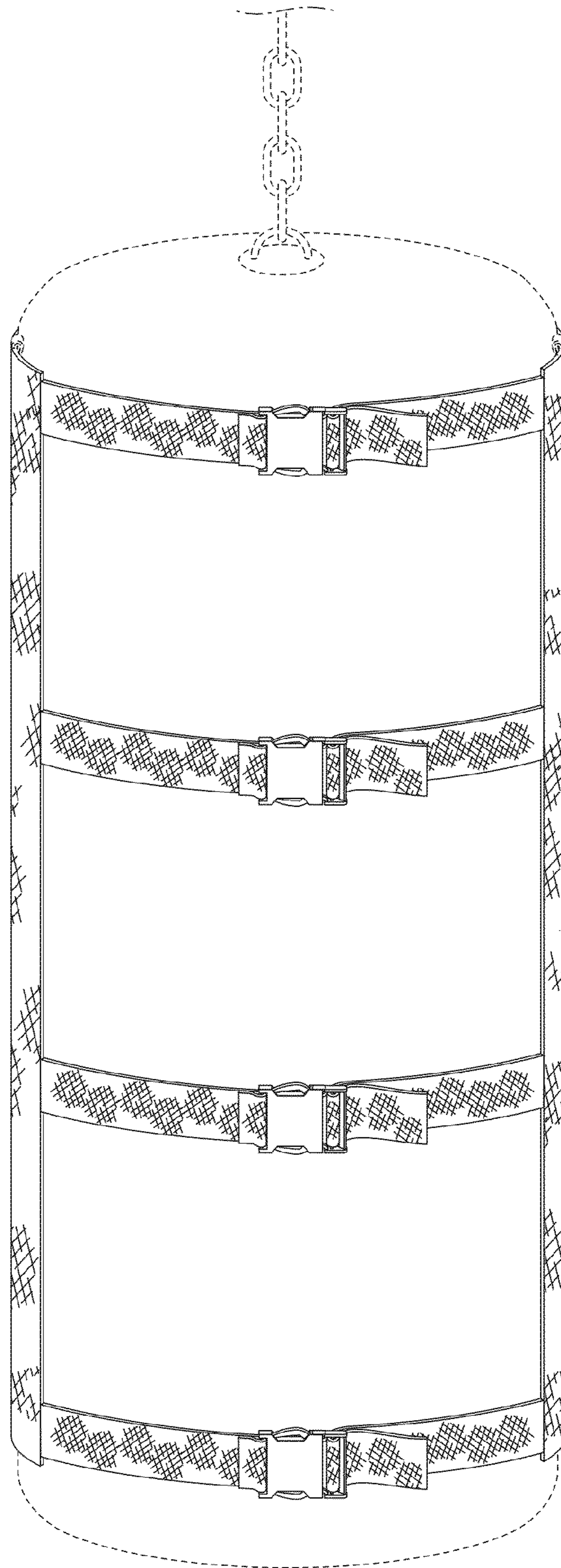

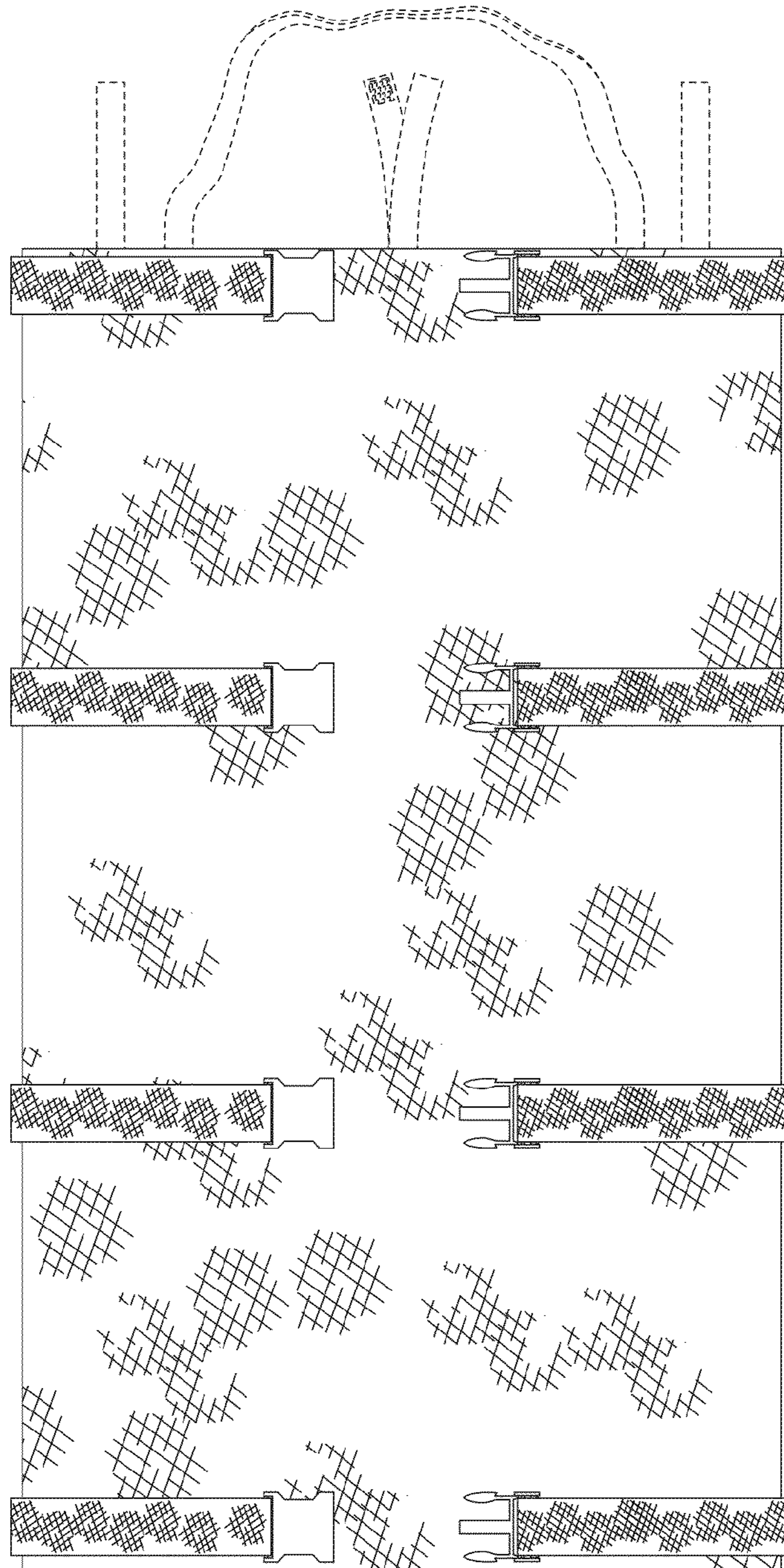

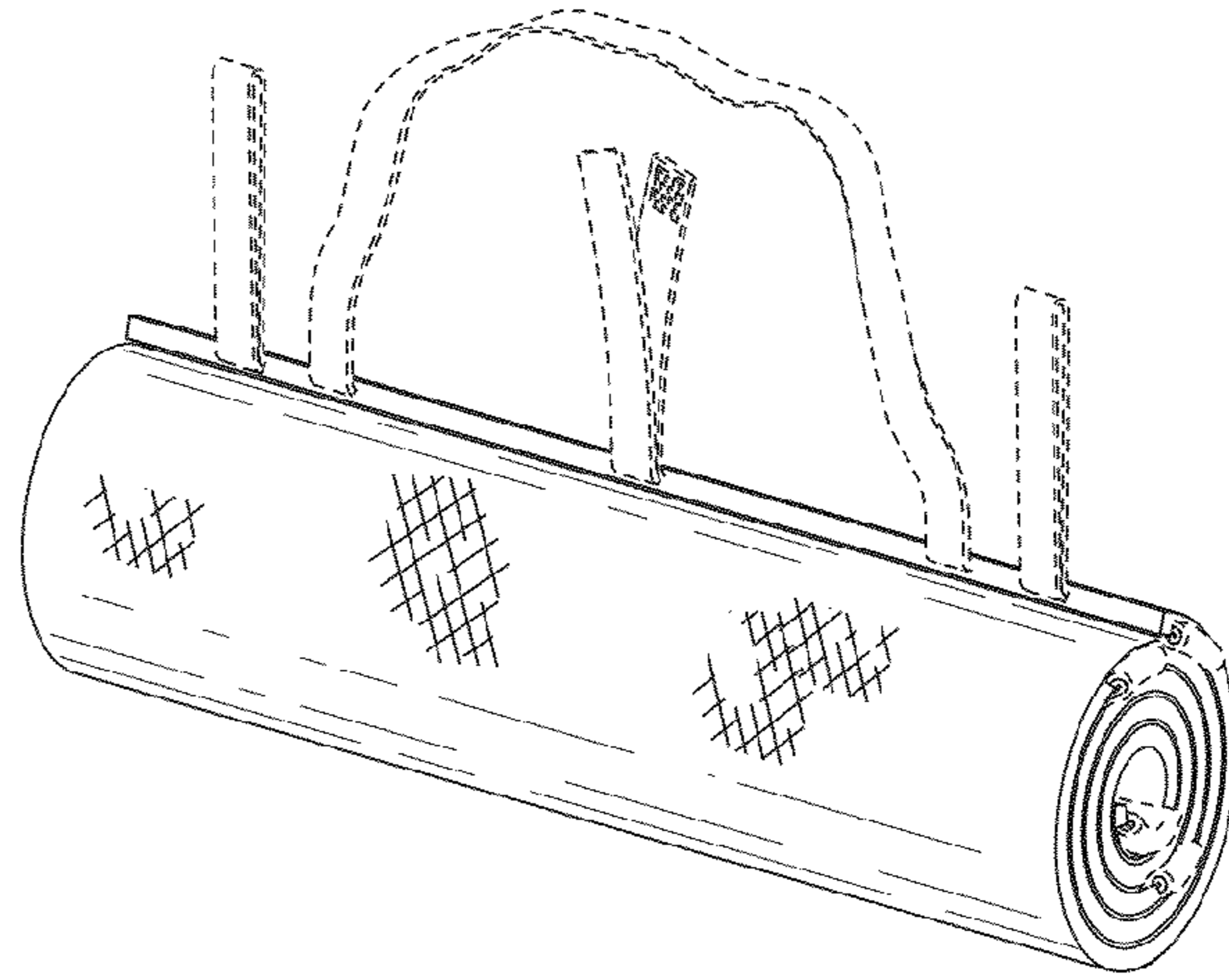

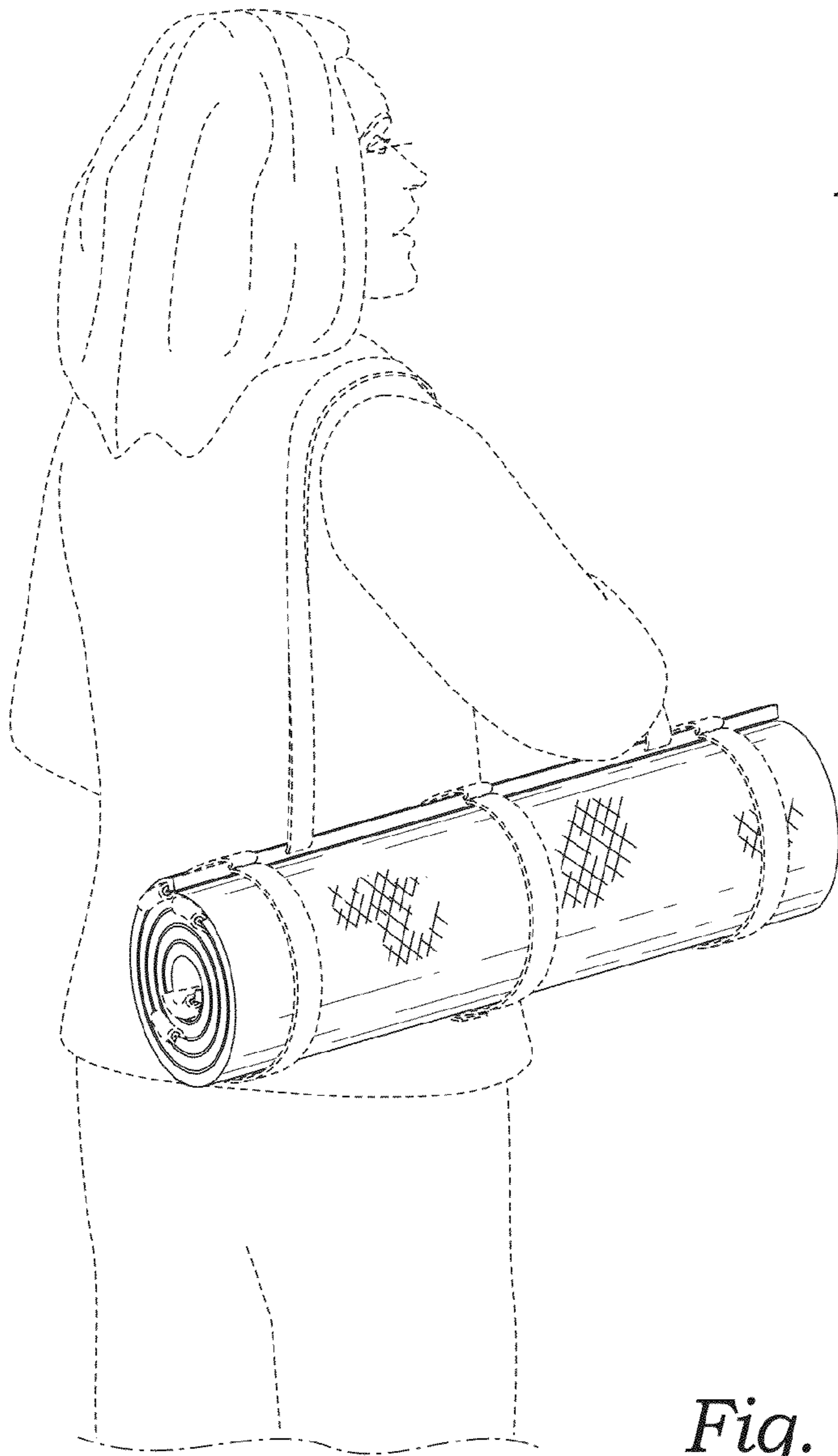
