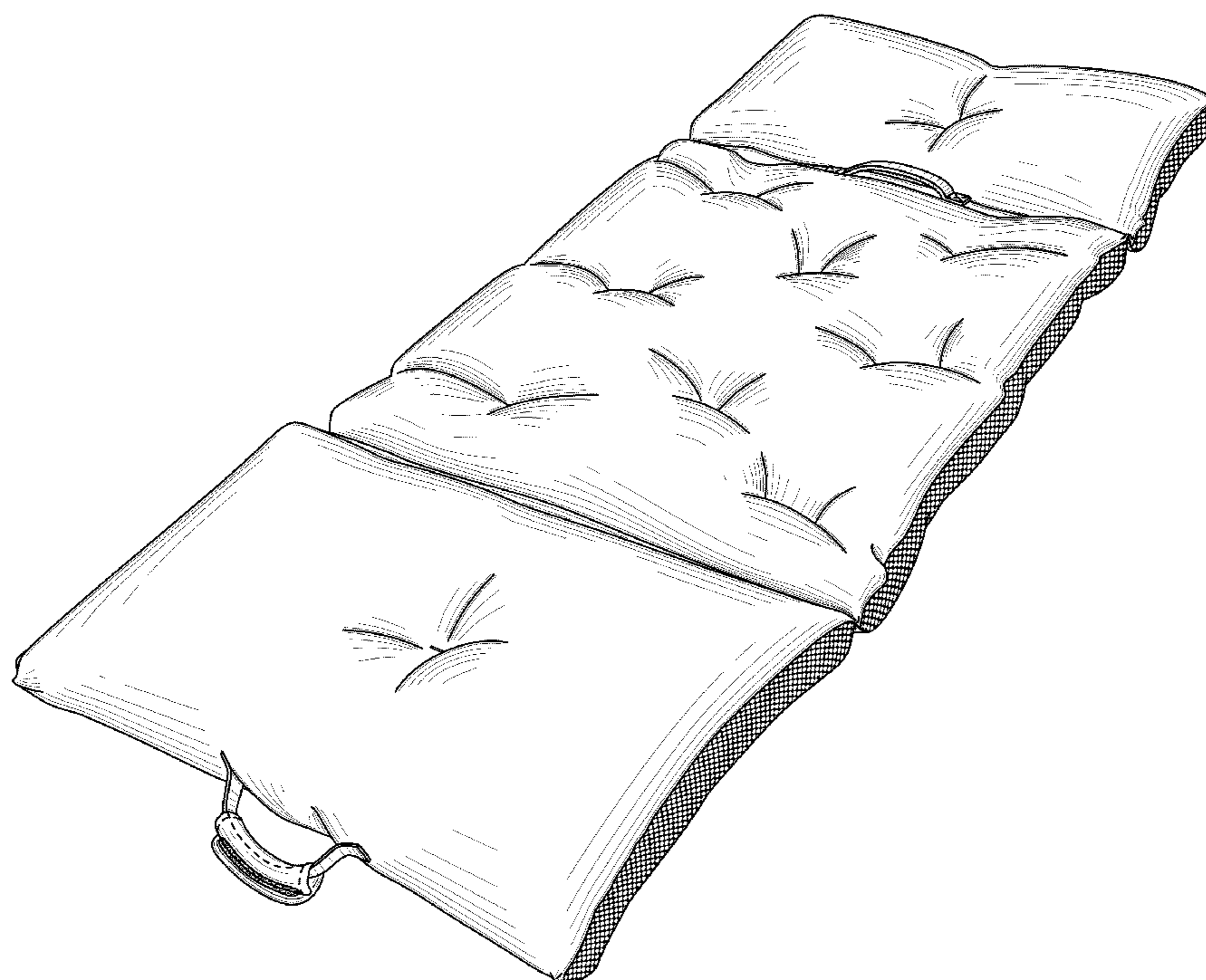
(57) **CLAIM**

The ornamental design for a floating mattress, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a floating mattress in accordance with our new design.
FIG. 2 is a top plan view of the floating mattress of FIG. 1.
FIG. 3 is an elevational view as seen from the lower side of FIG. 2.
FIG. 4 is an elevational view as seen from the upper side of FIG. 2.

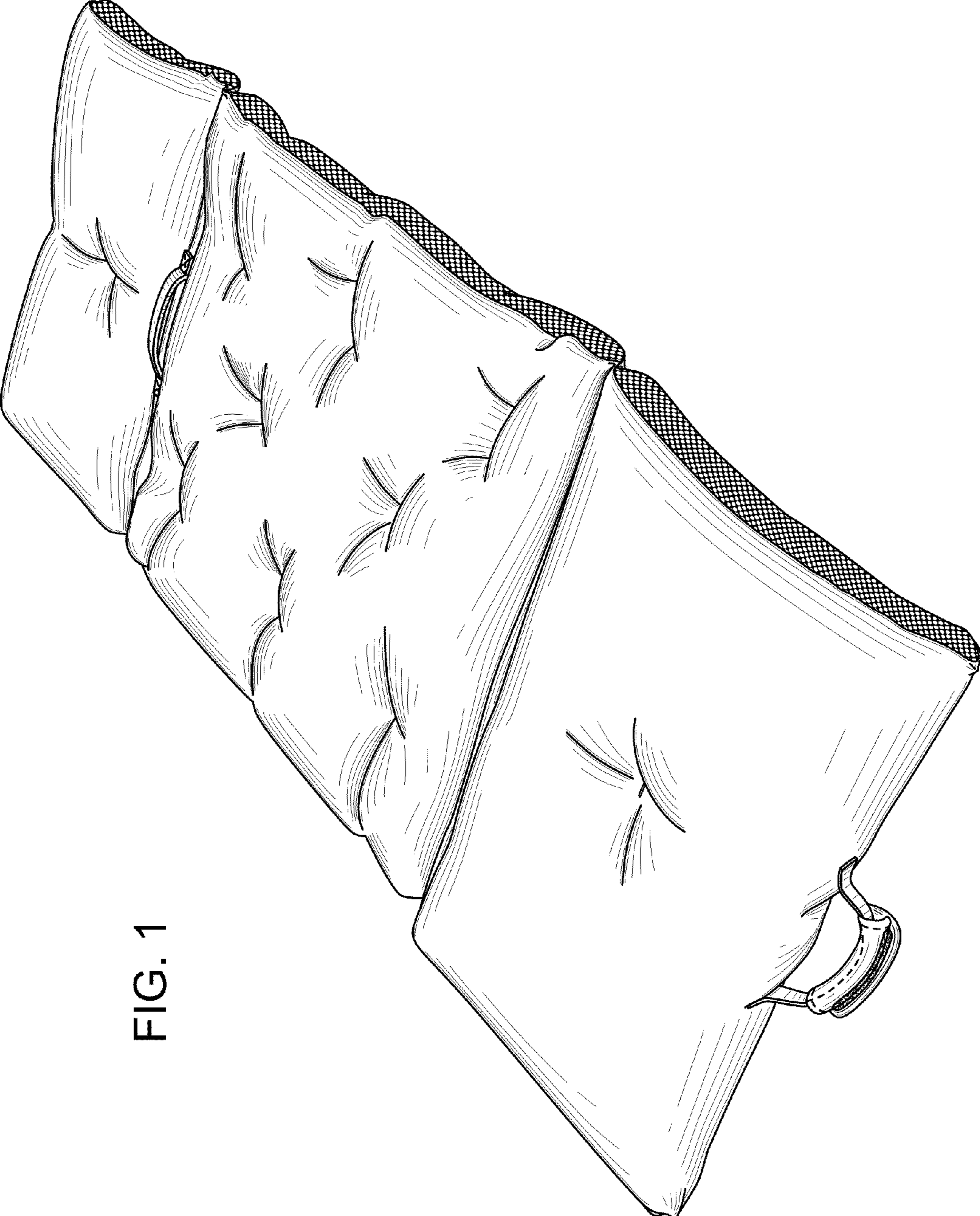

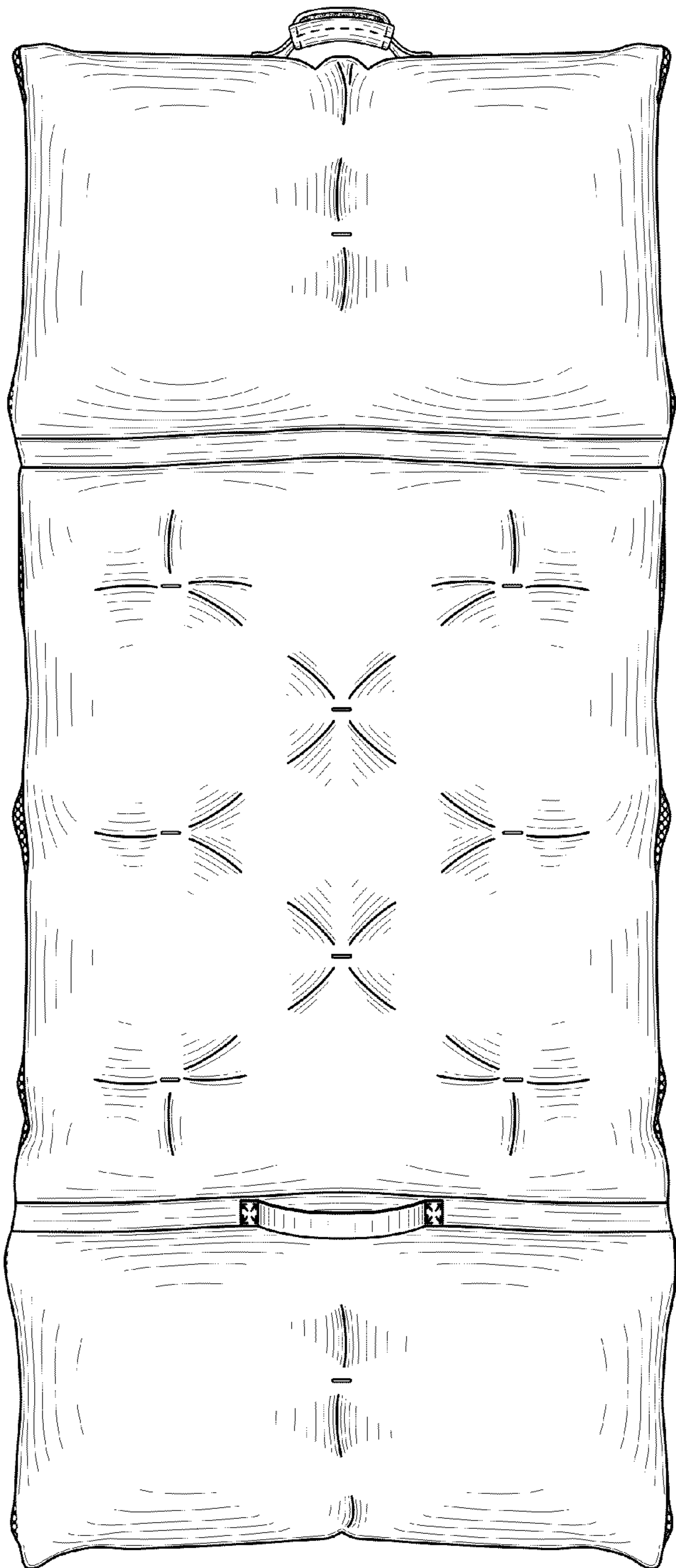

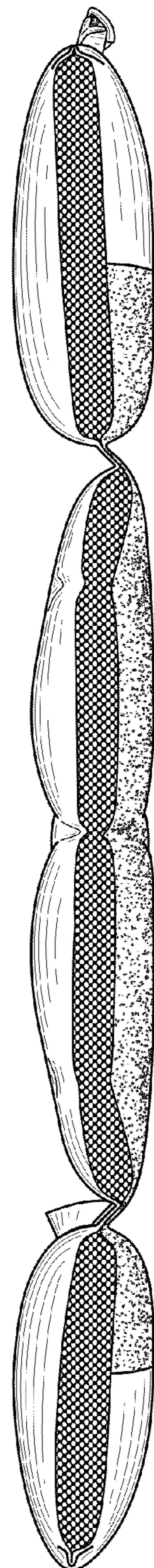

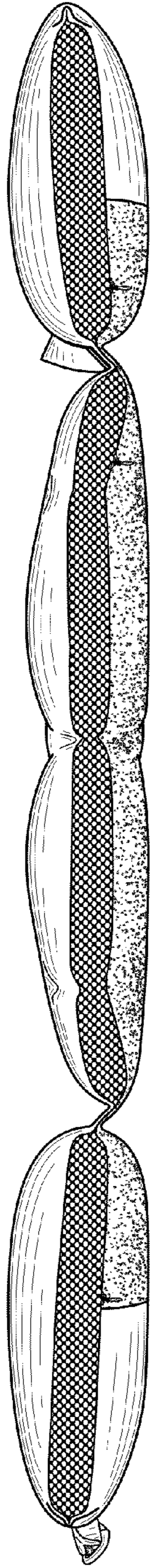

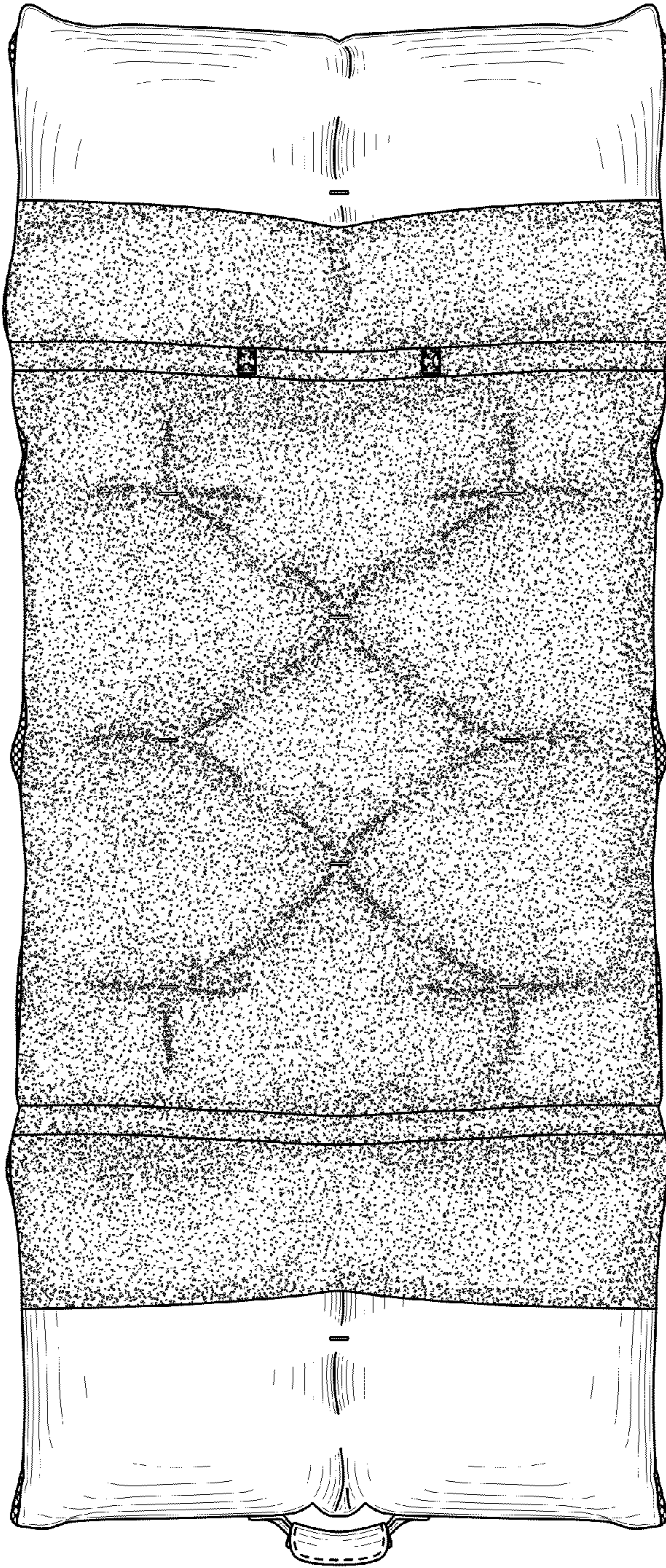

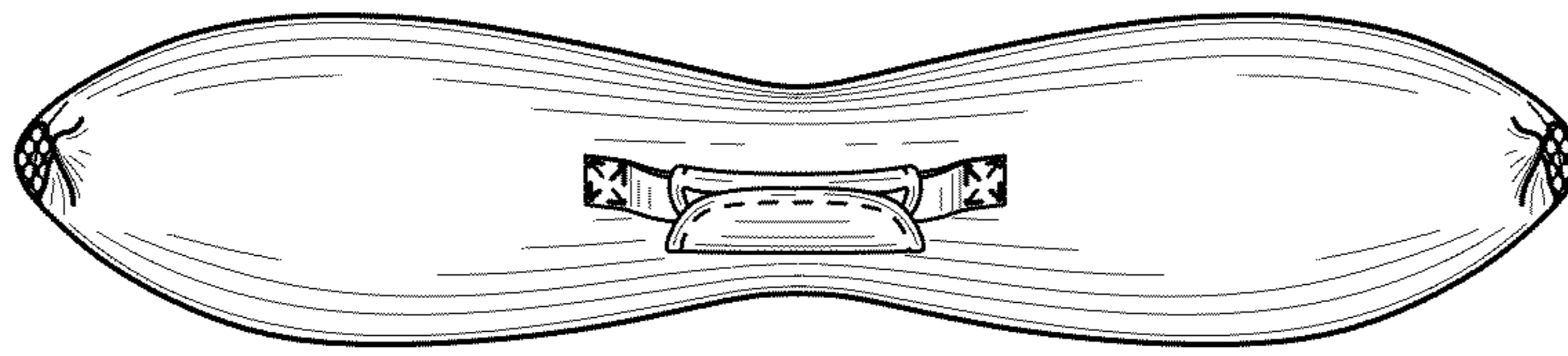

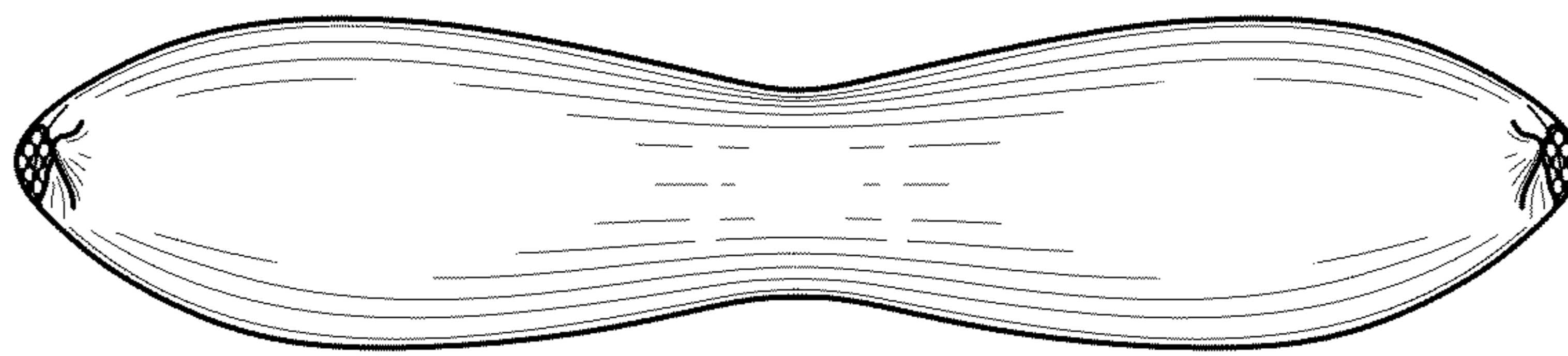
